FIG. 2 is a top, right side perspective view thereof;

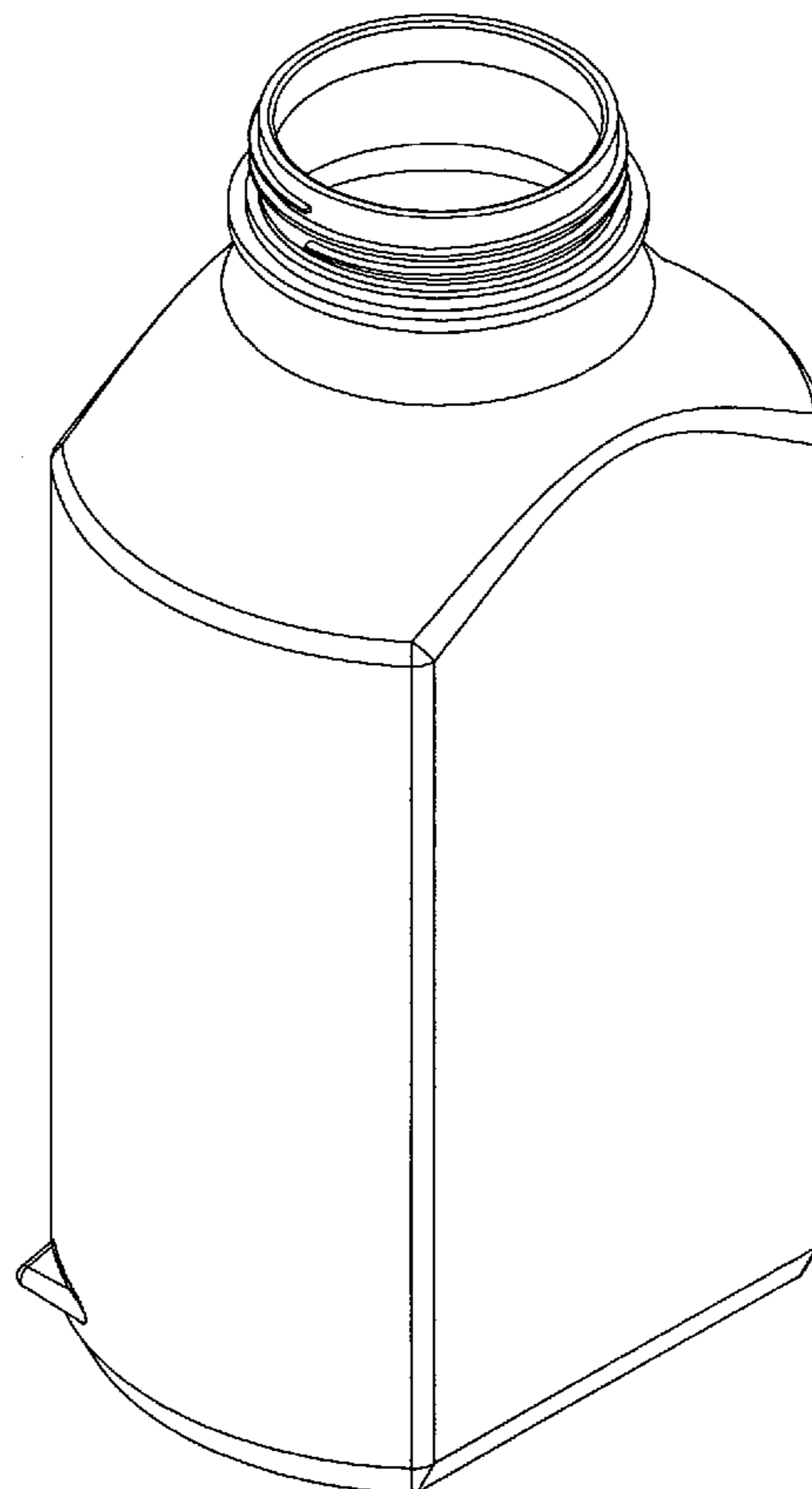
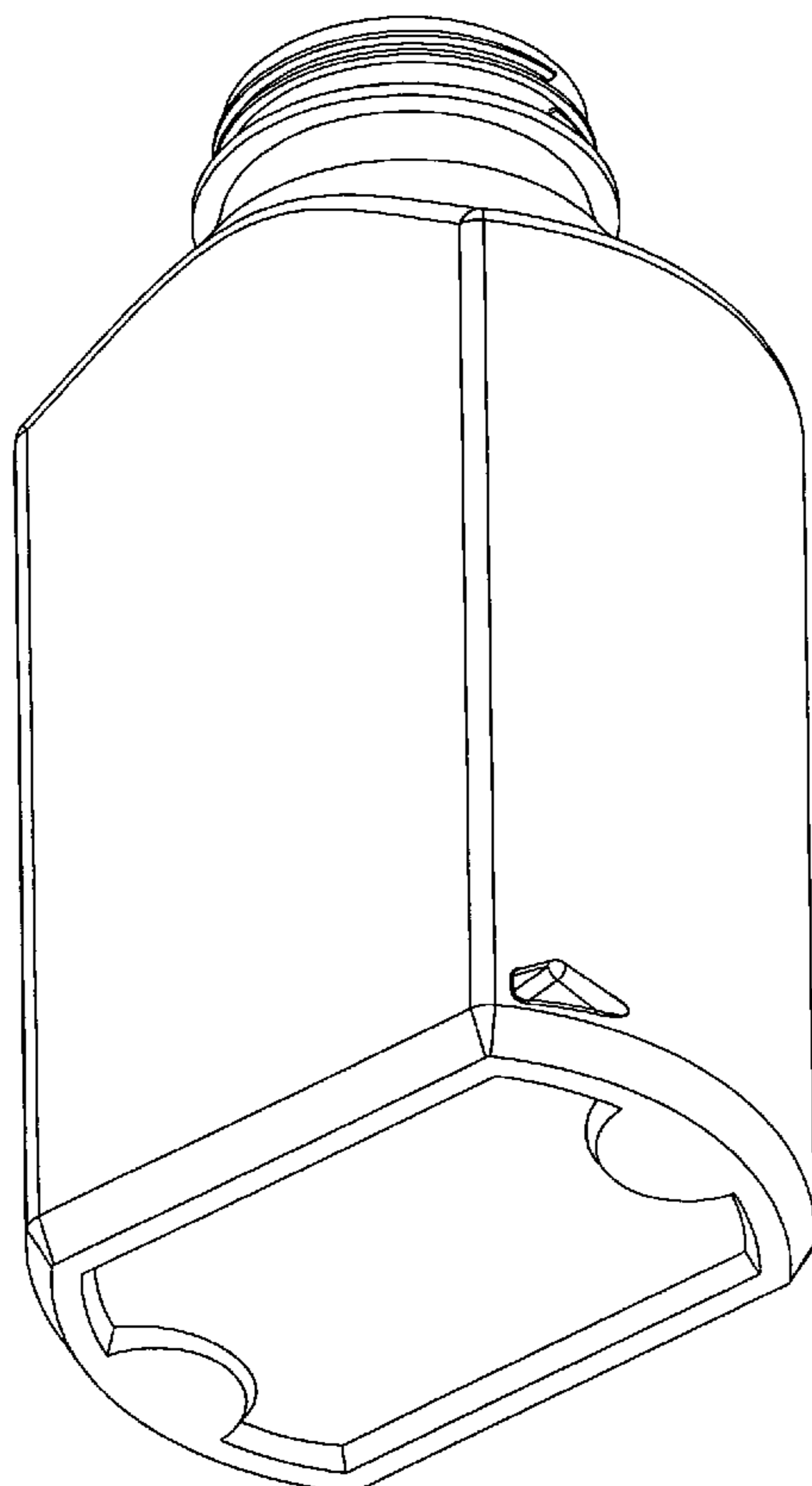
FIG. 3 is a bottom, left side perspective view thereof;

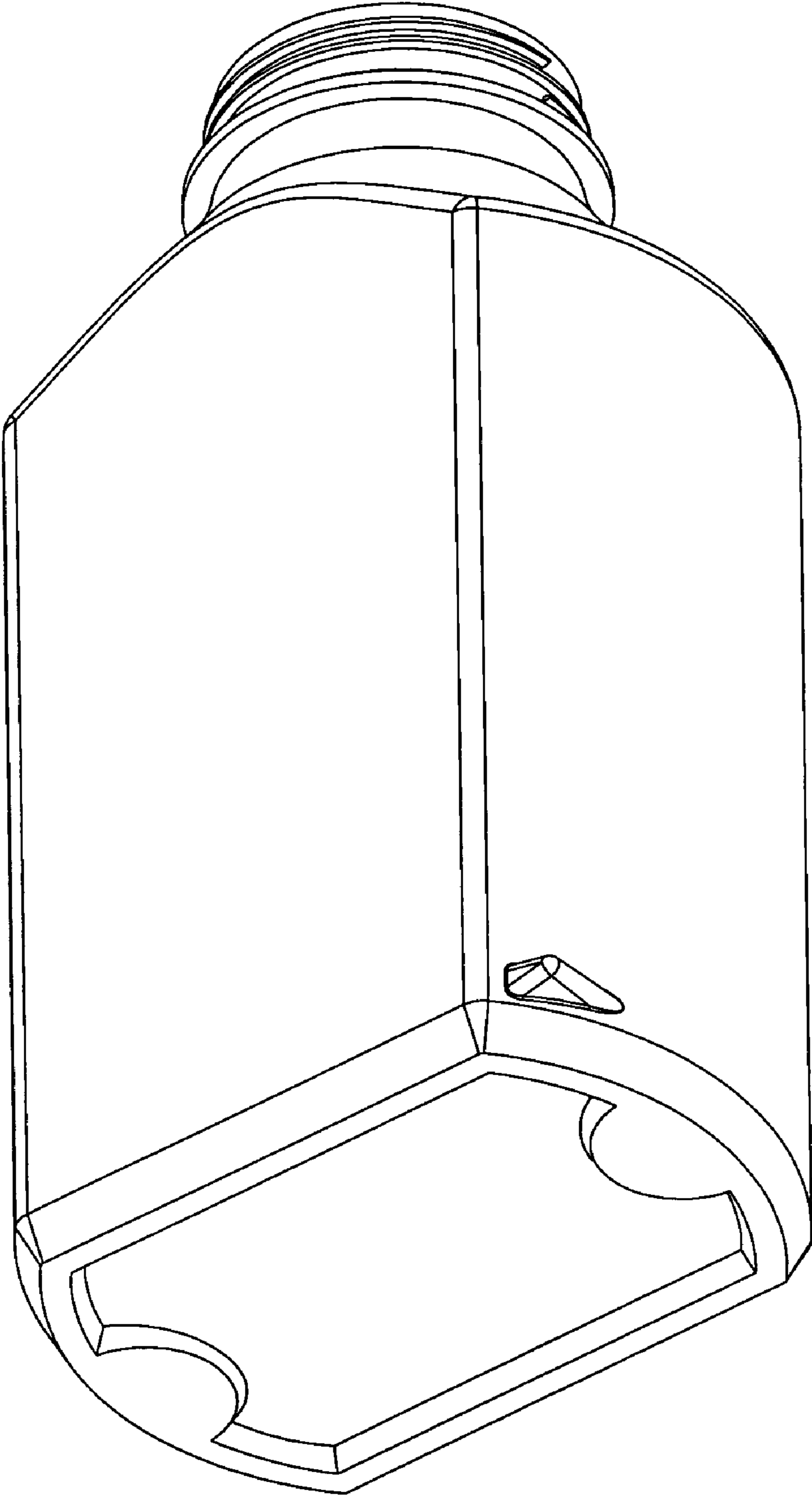

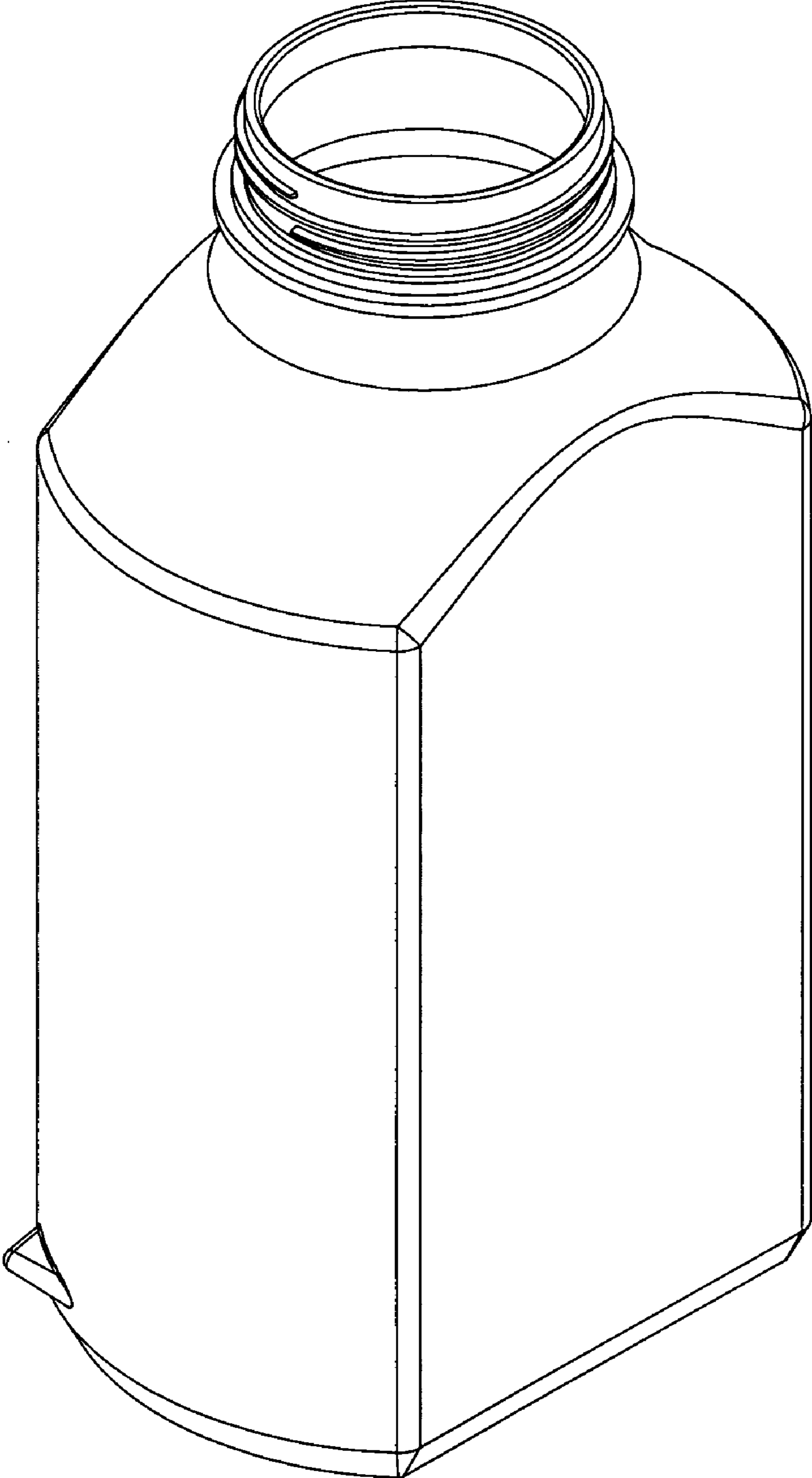

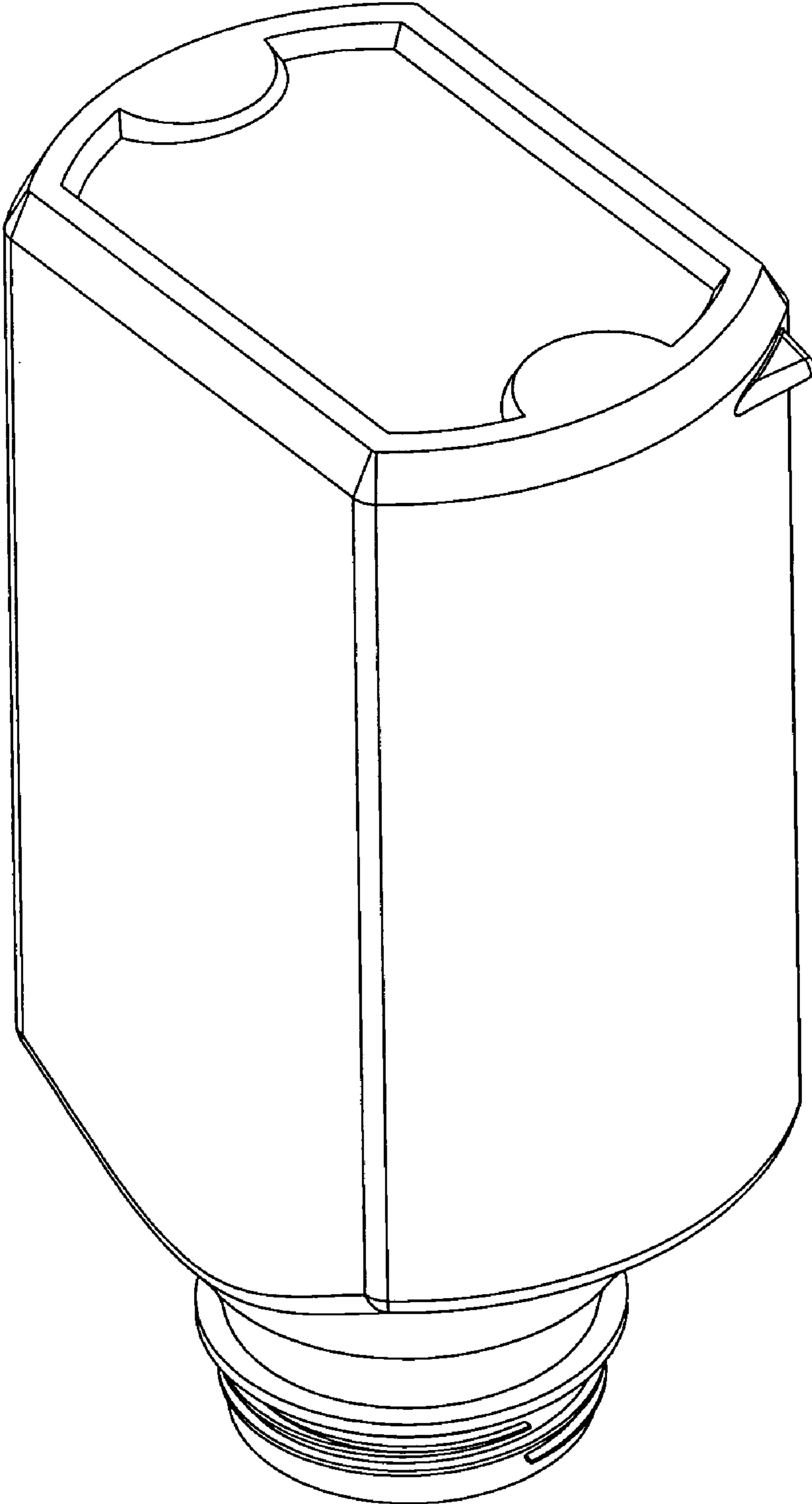

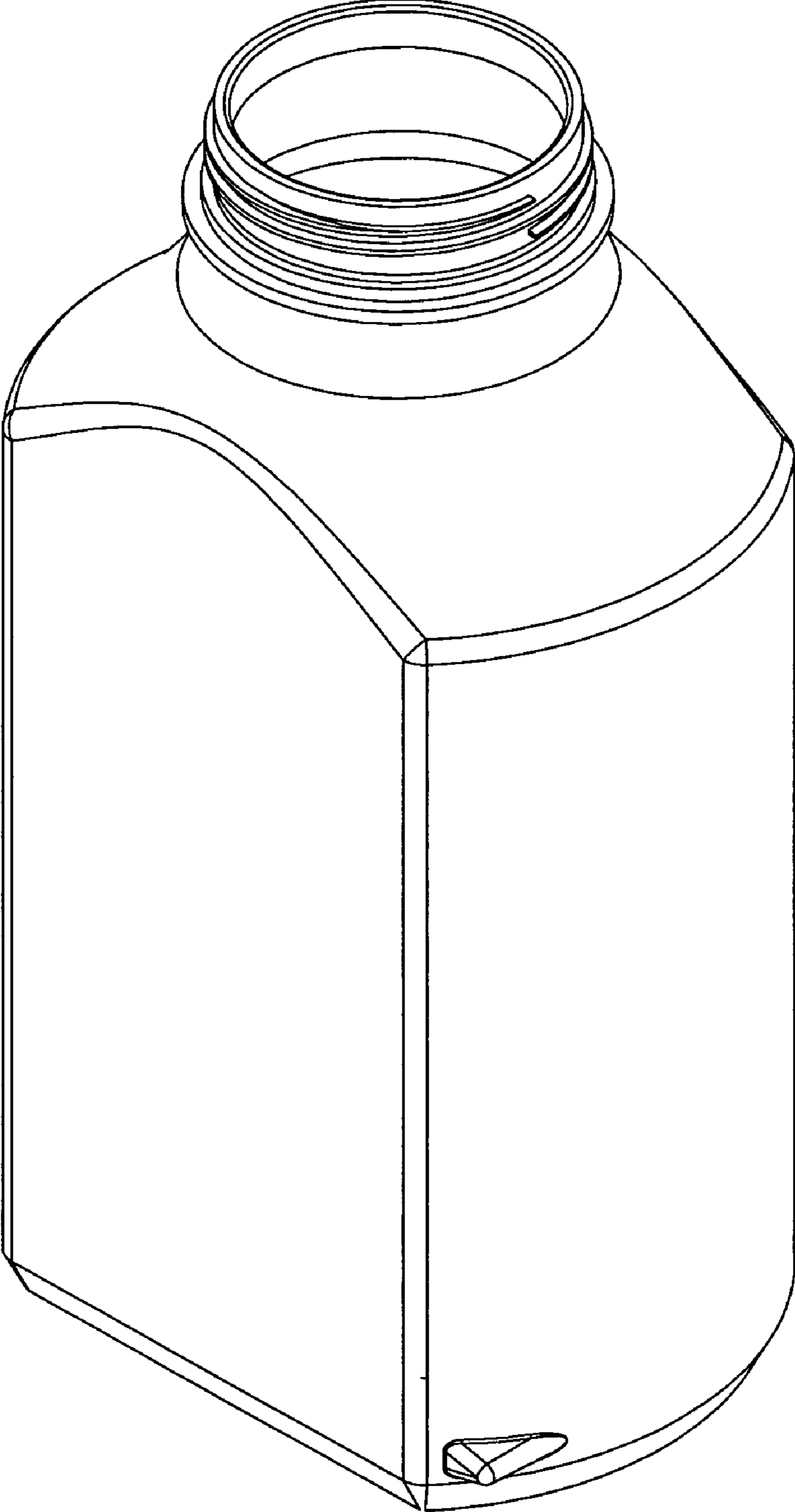

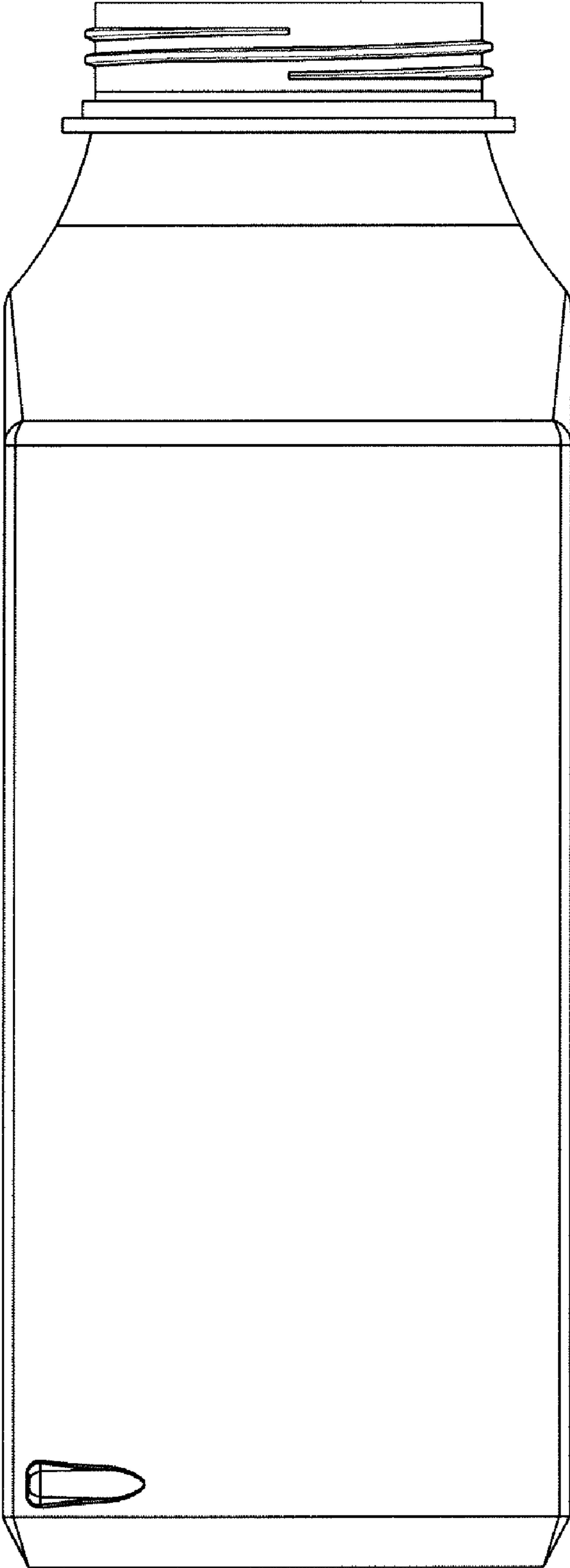

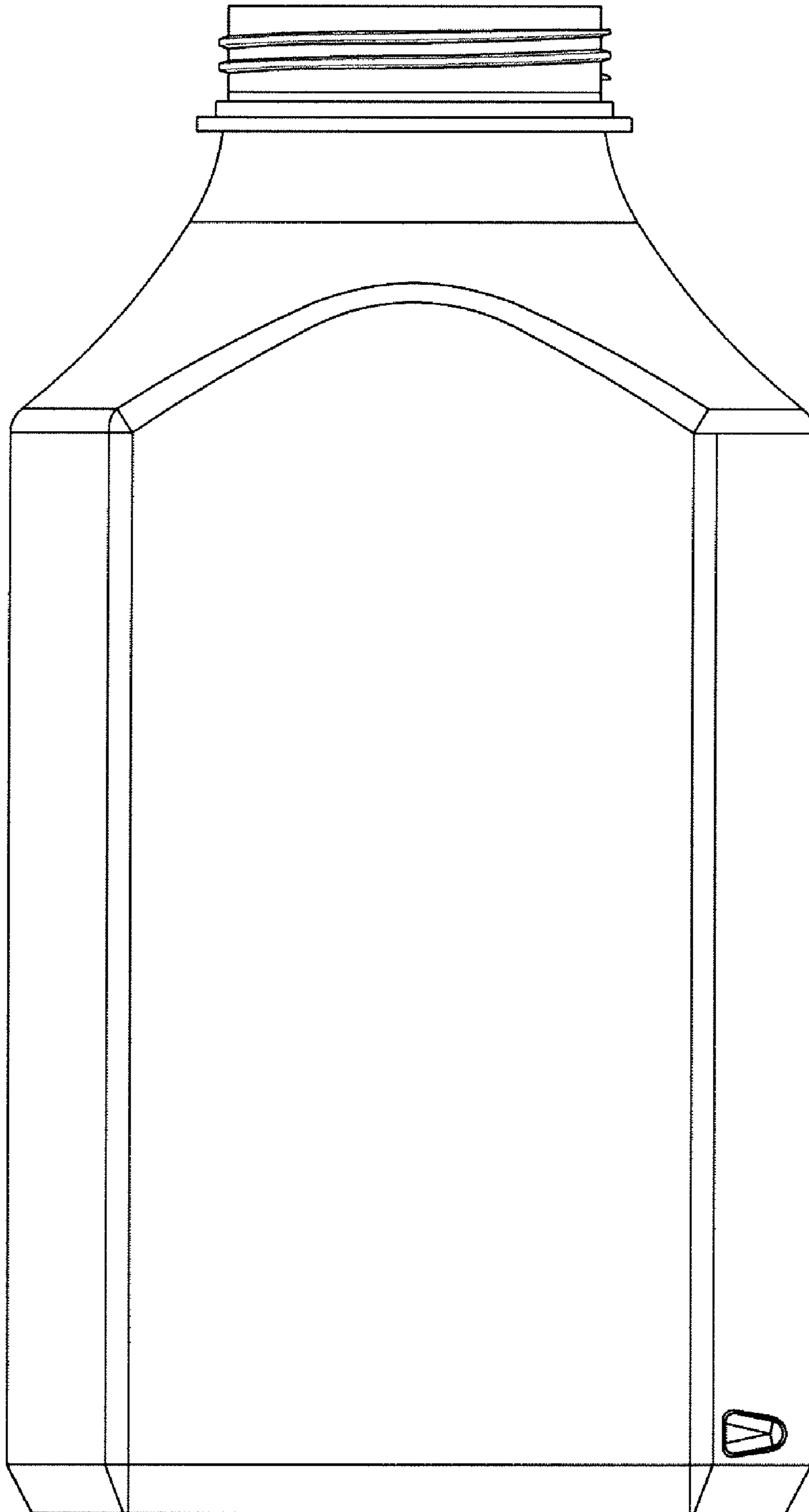
