**DESCRIPTION**

FIG. 1 is a perspective view of the invention;

FIG. 3 is a bottom view of the invention;

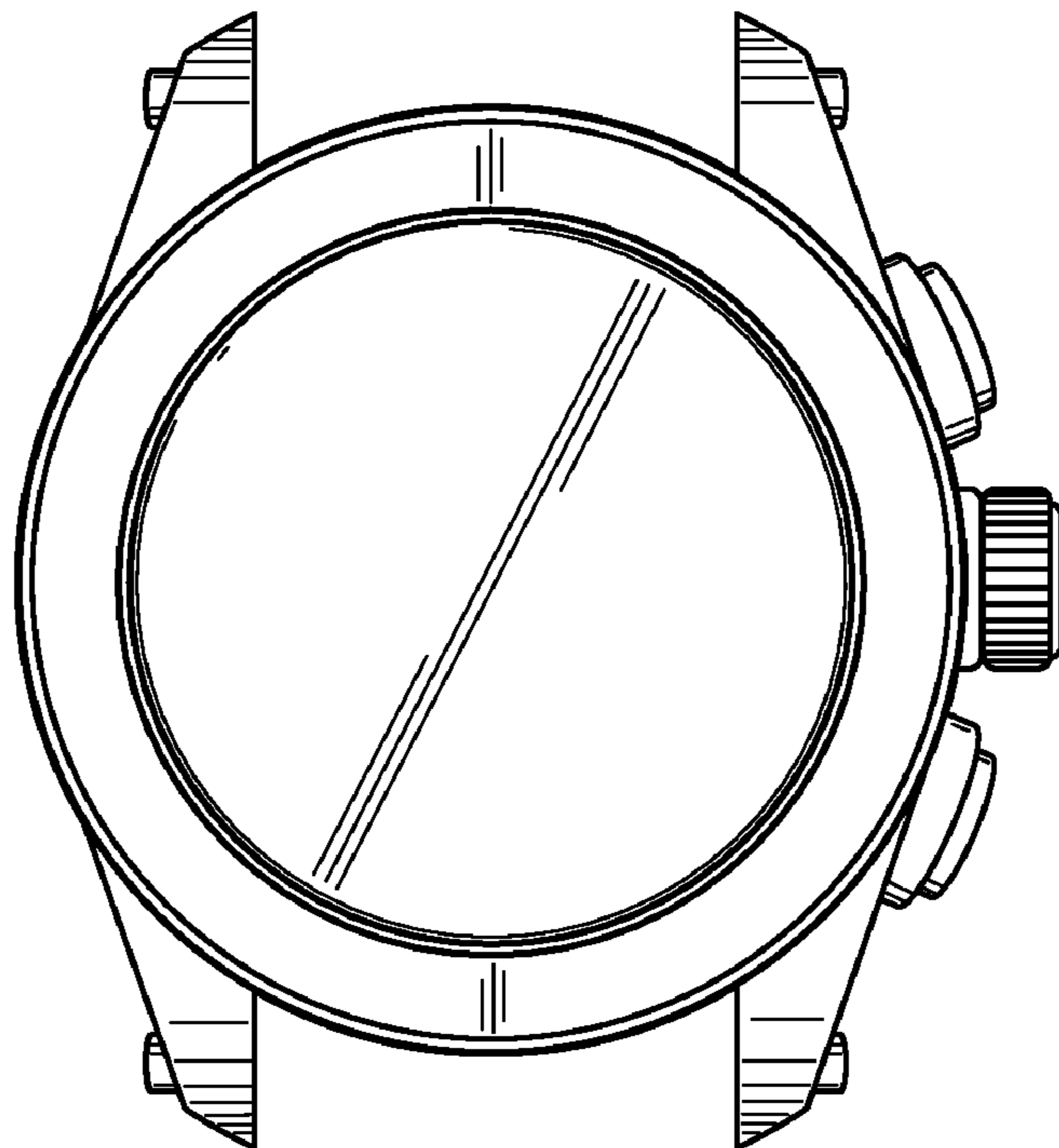
FIG. 4 is a front view of the invention;

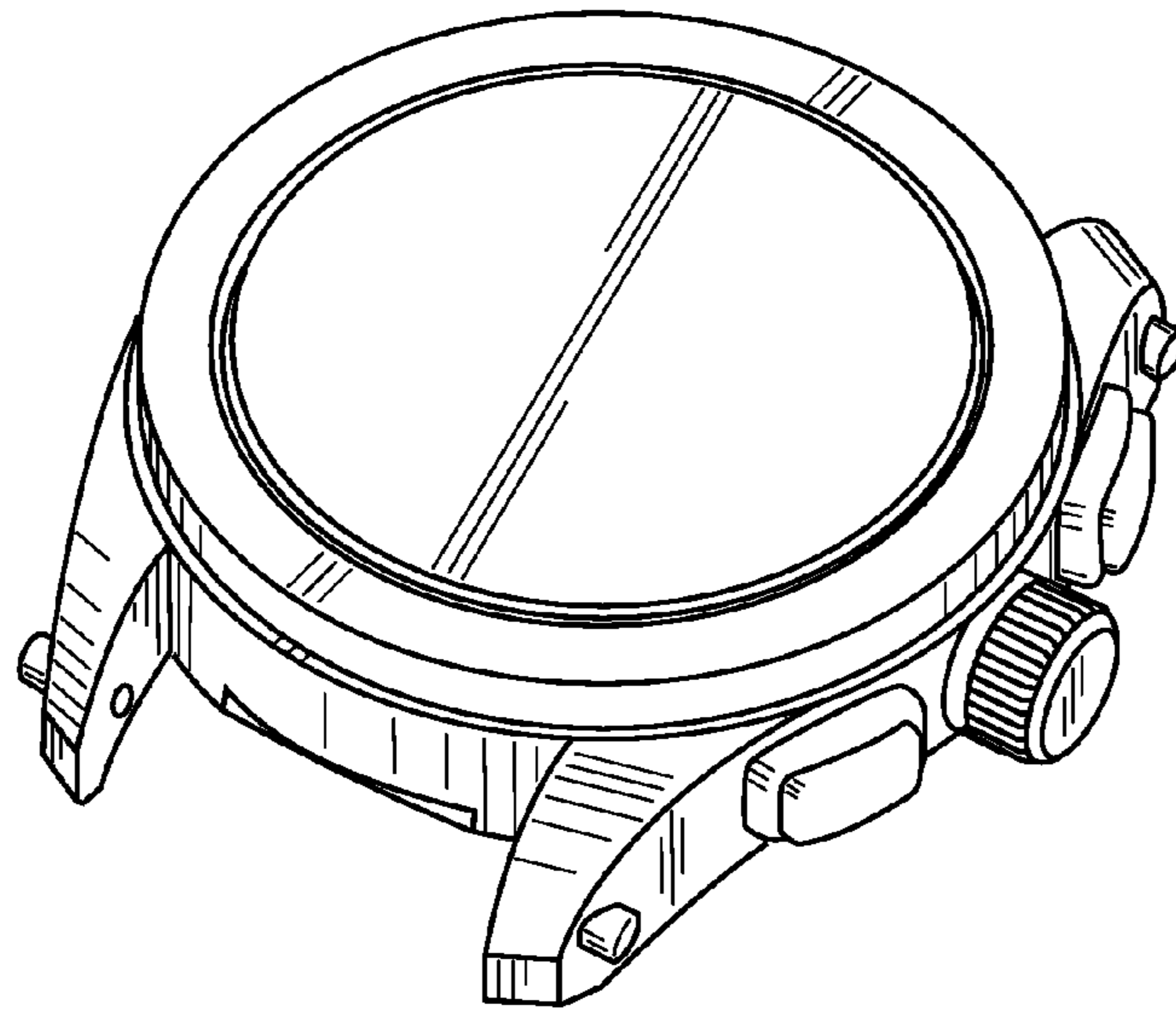

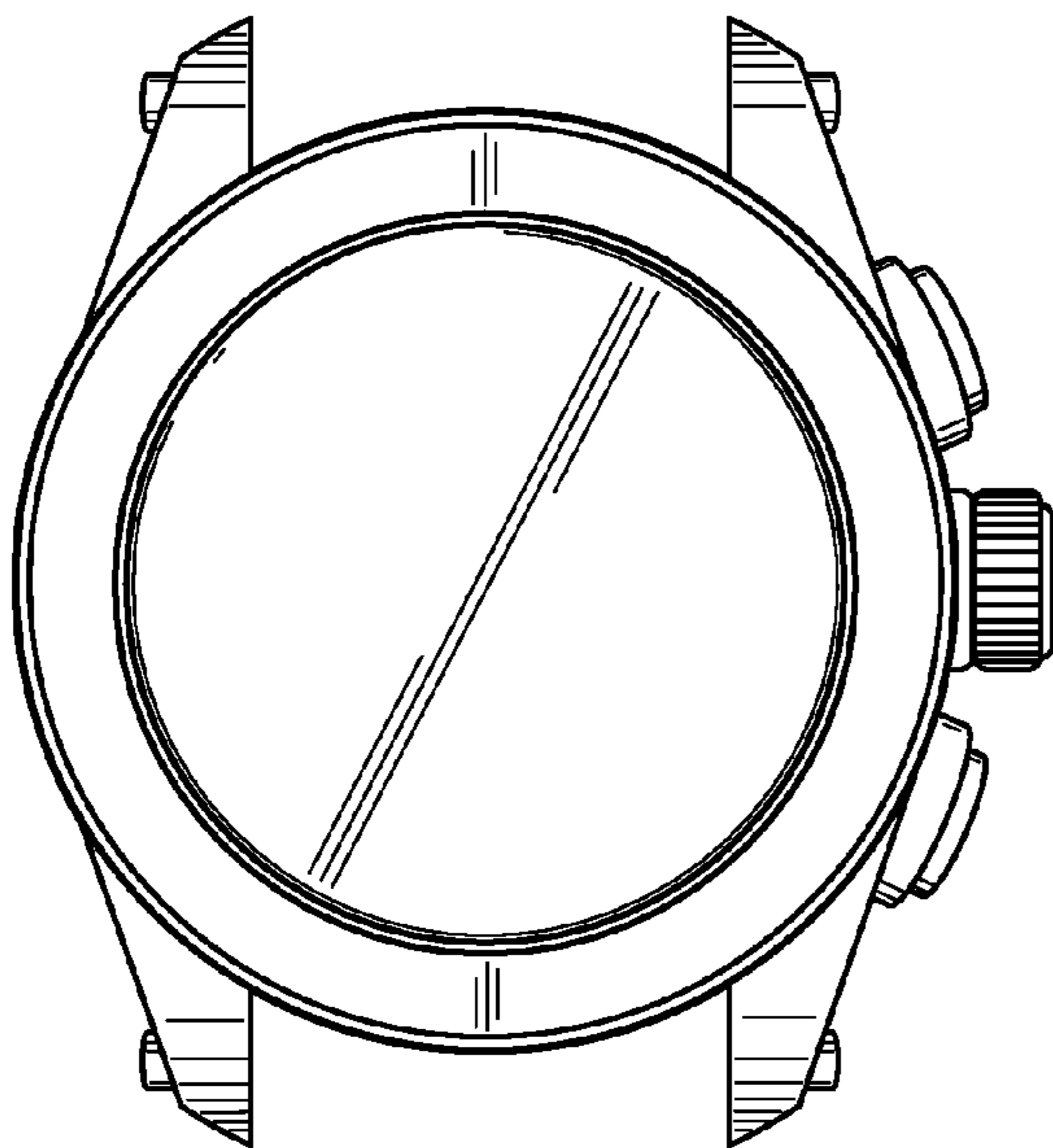

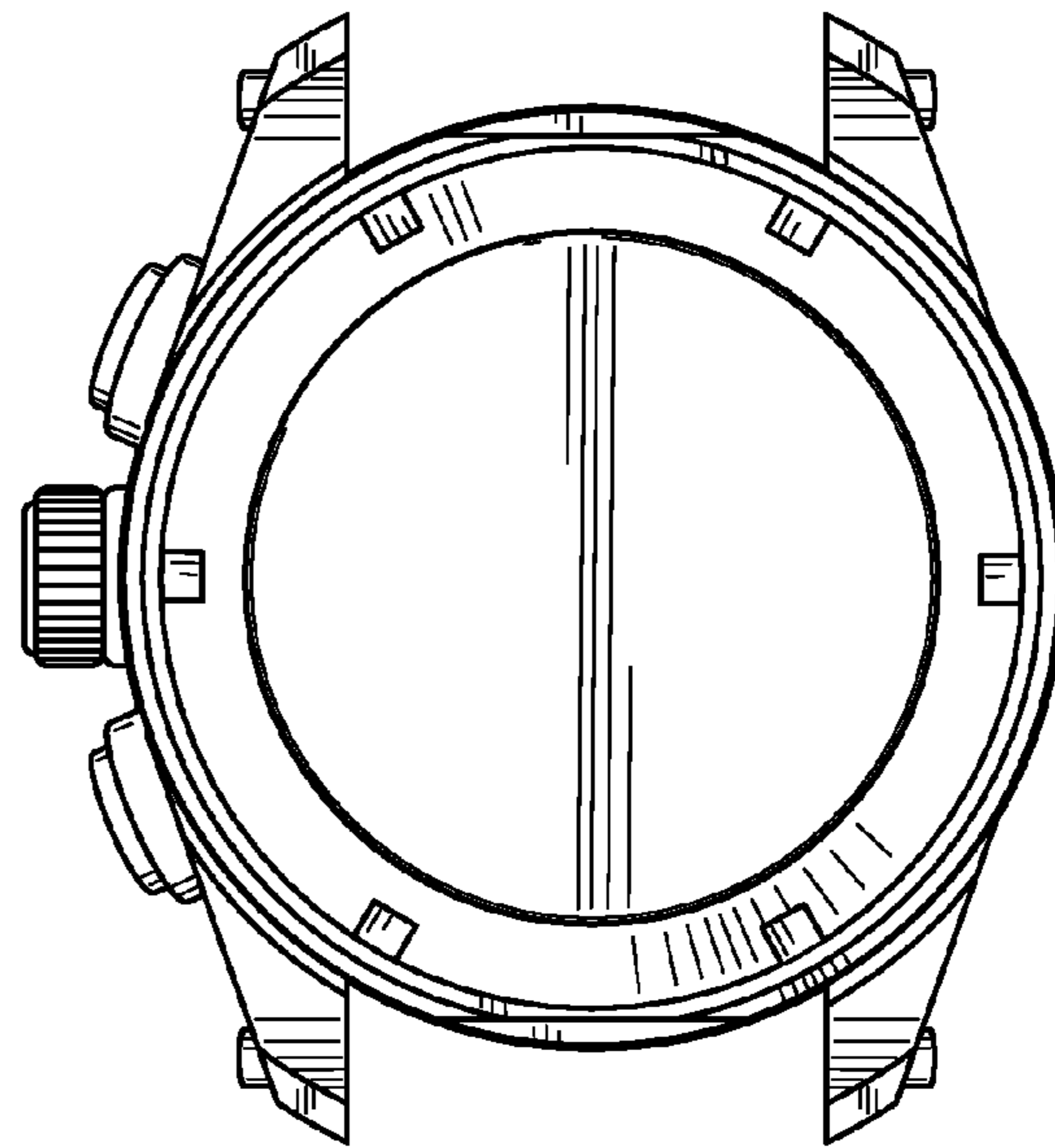

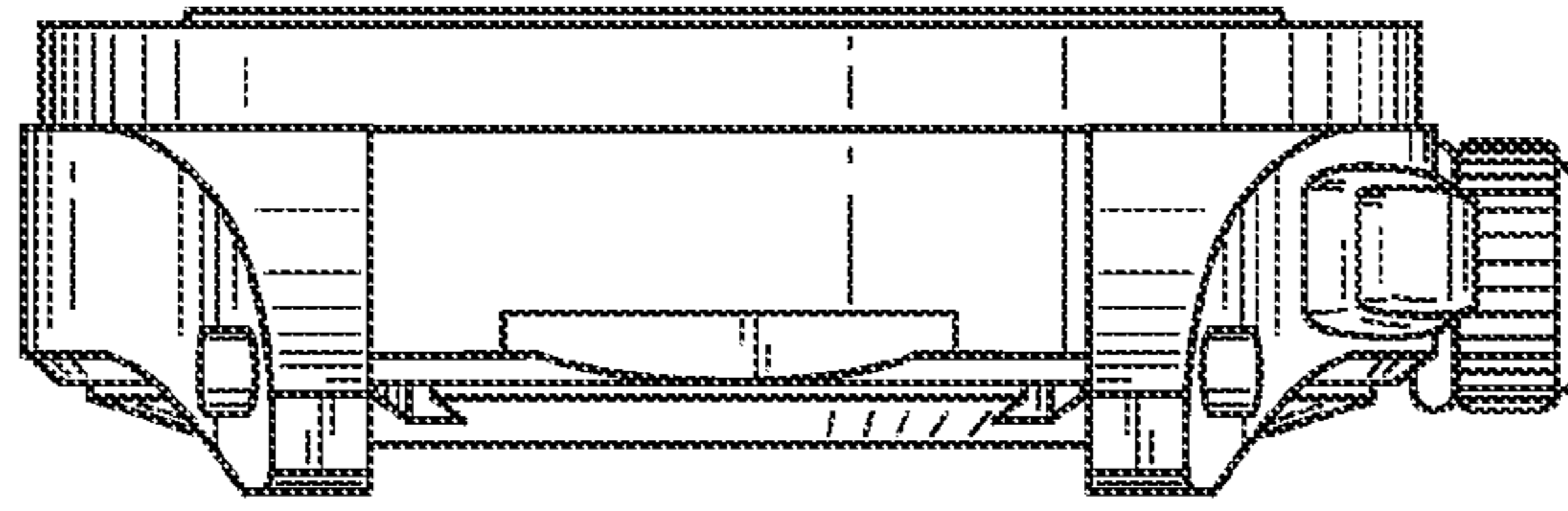

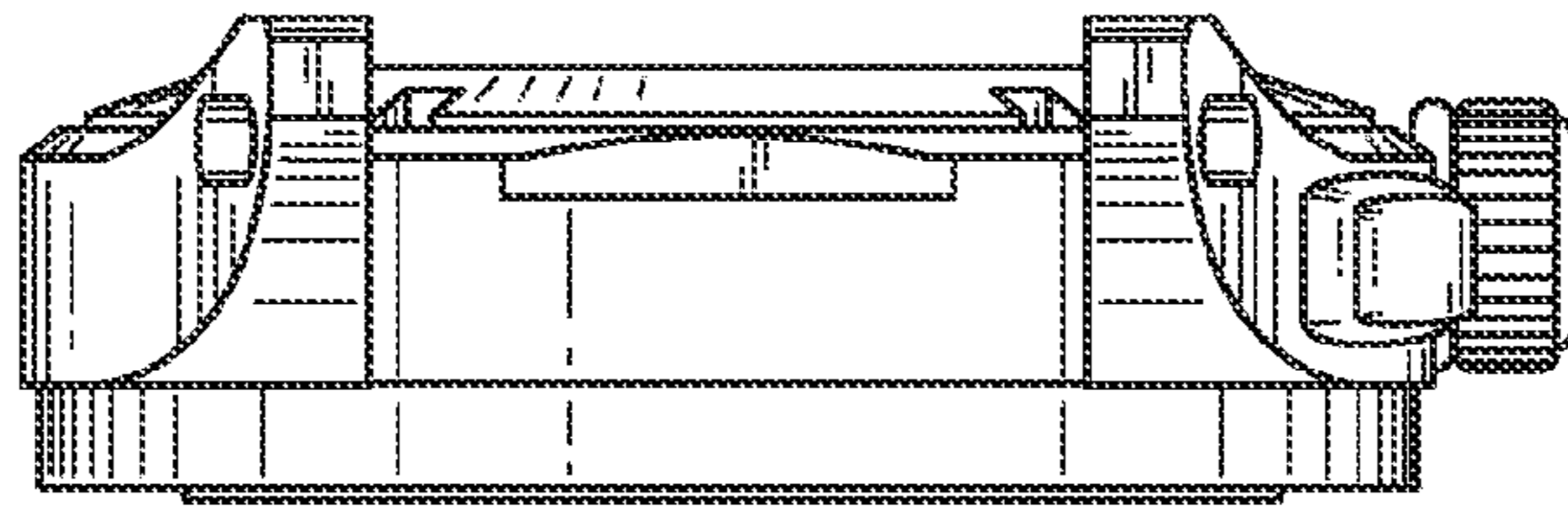

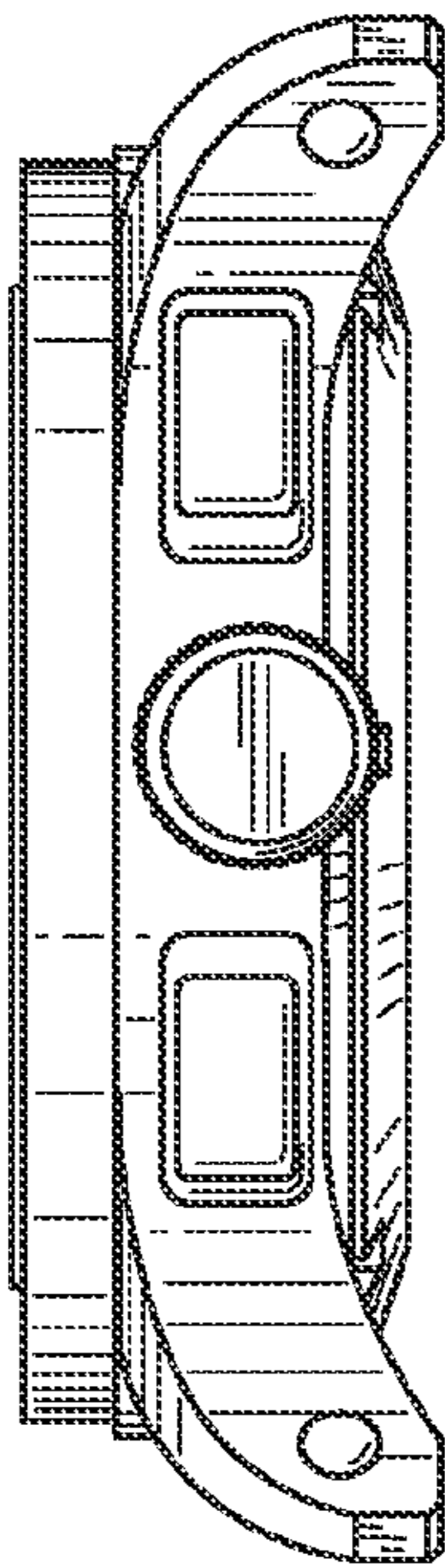

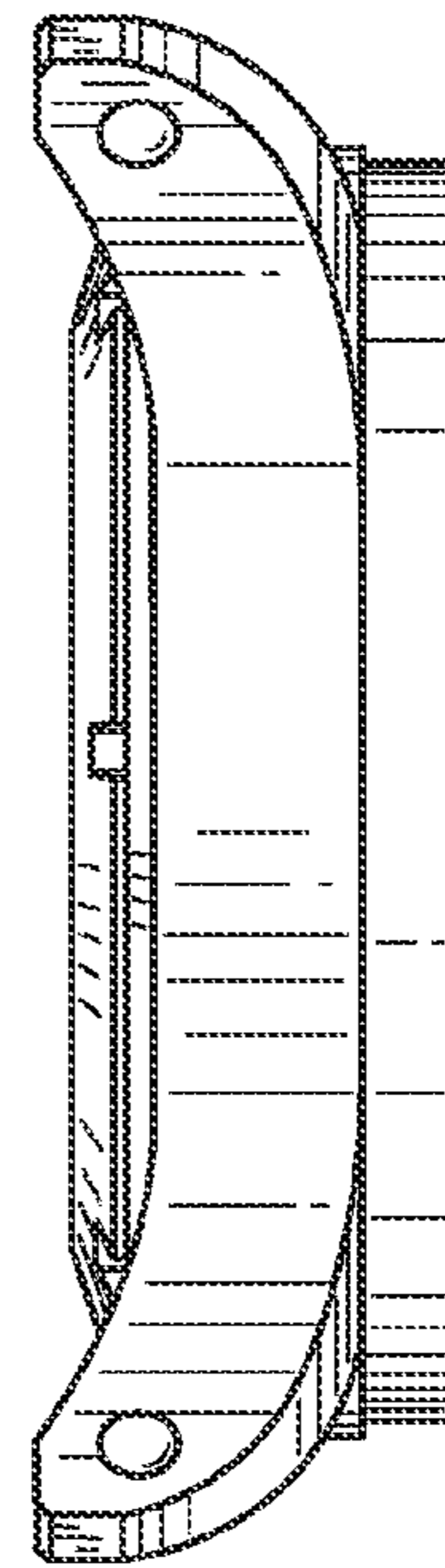
