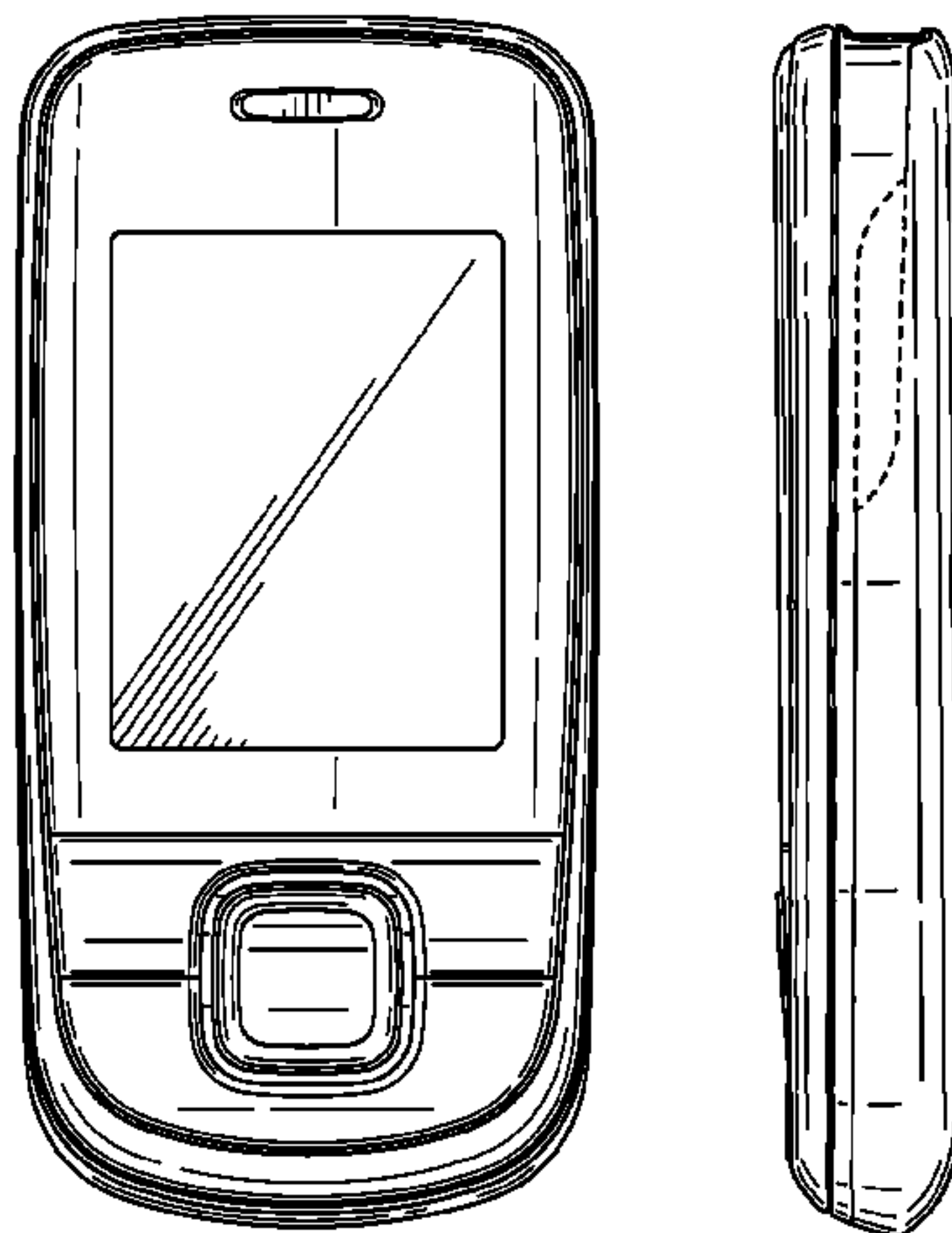
The ornamental design for a handset, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handset showing my new design;

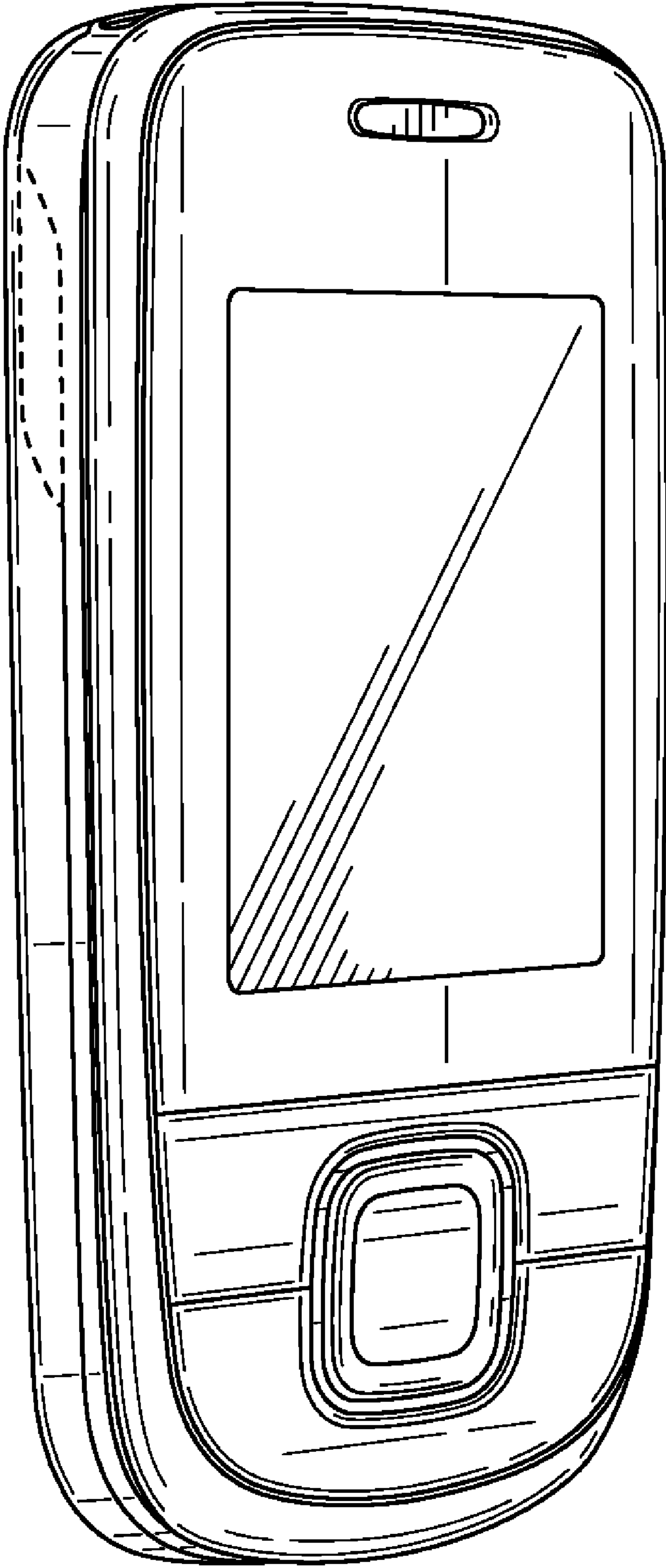

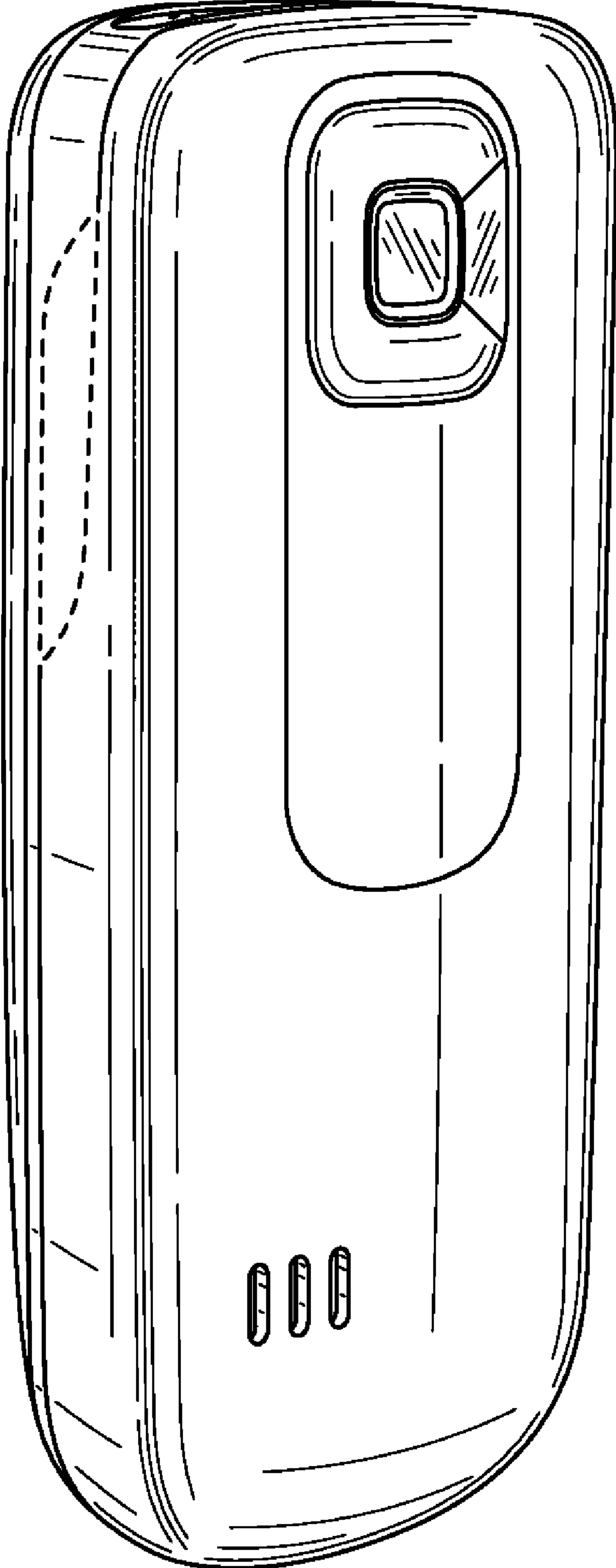

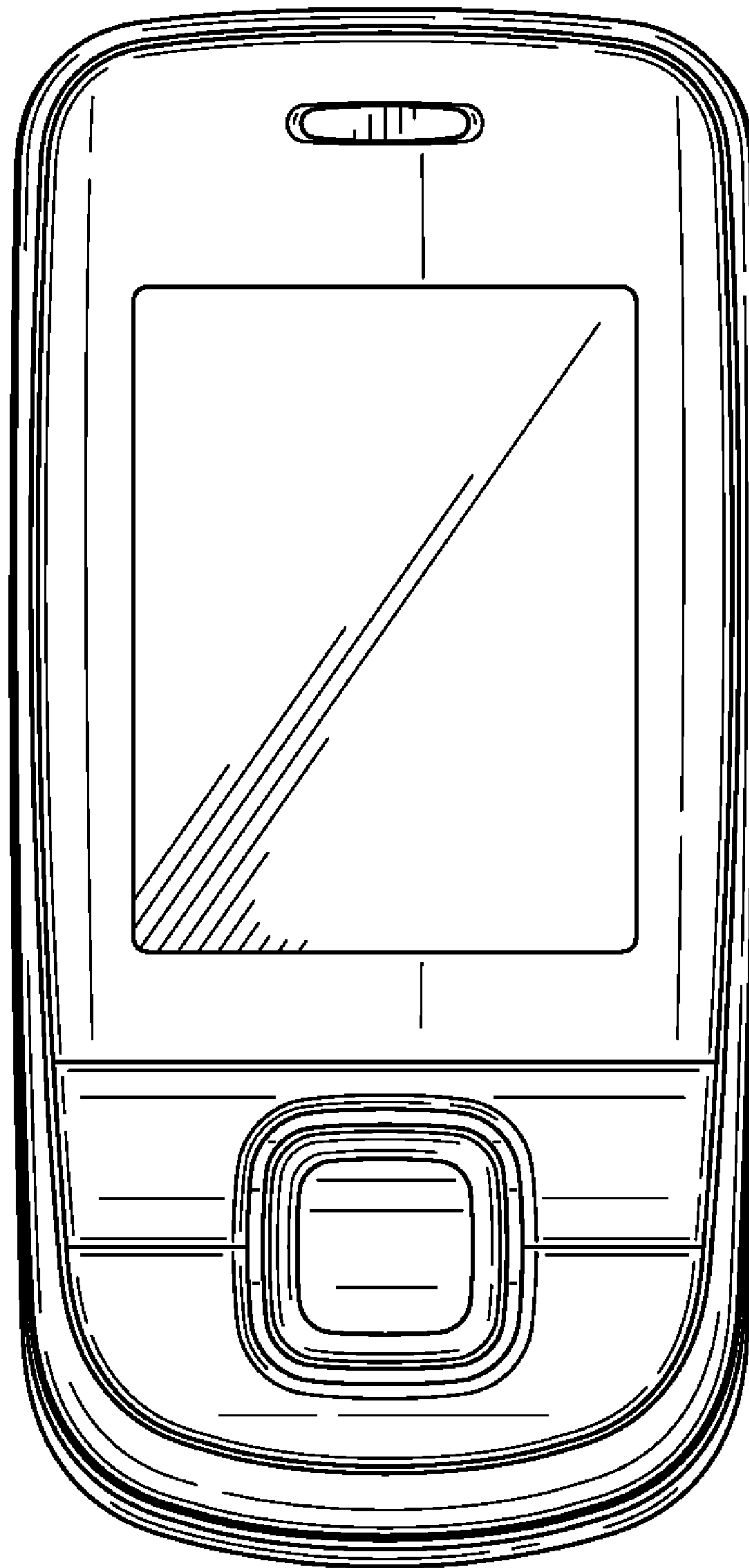

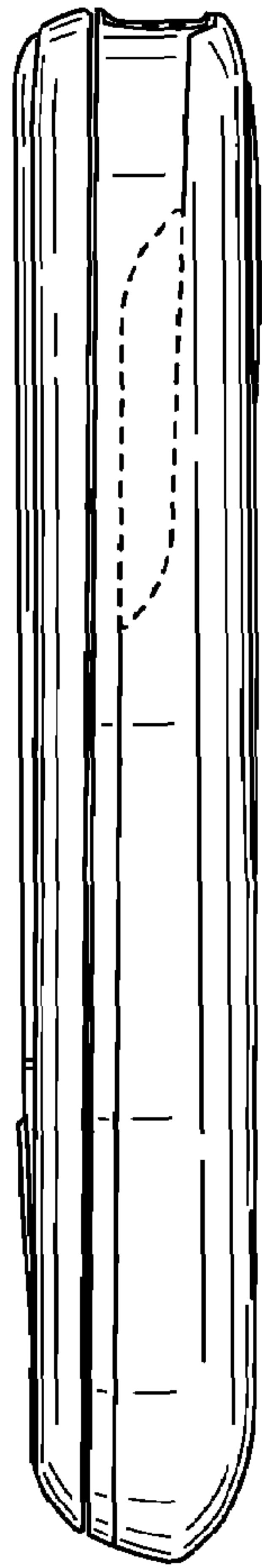

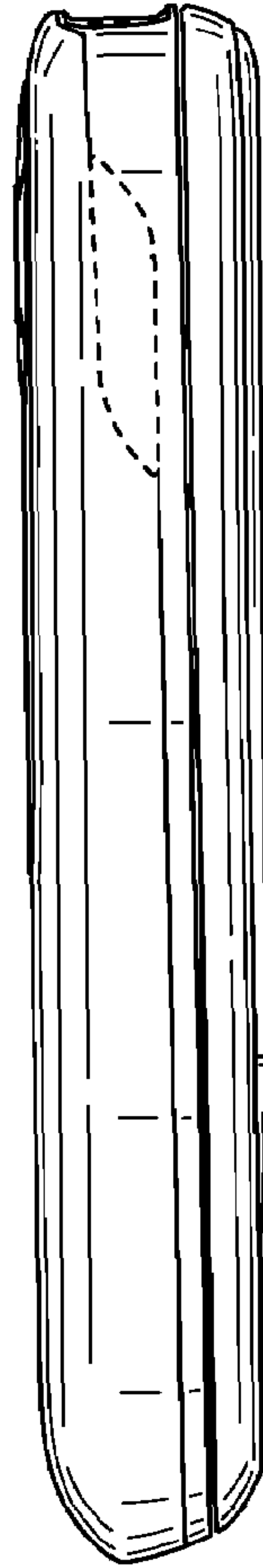

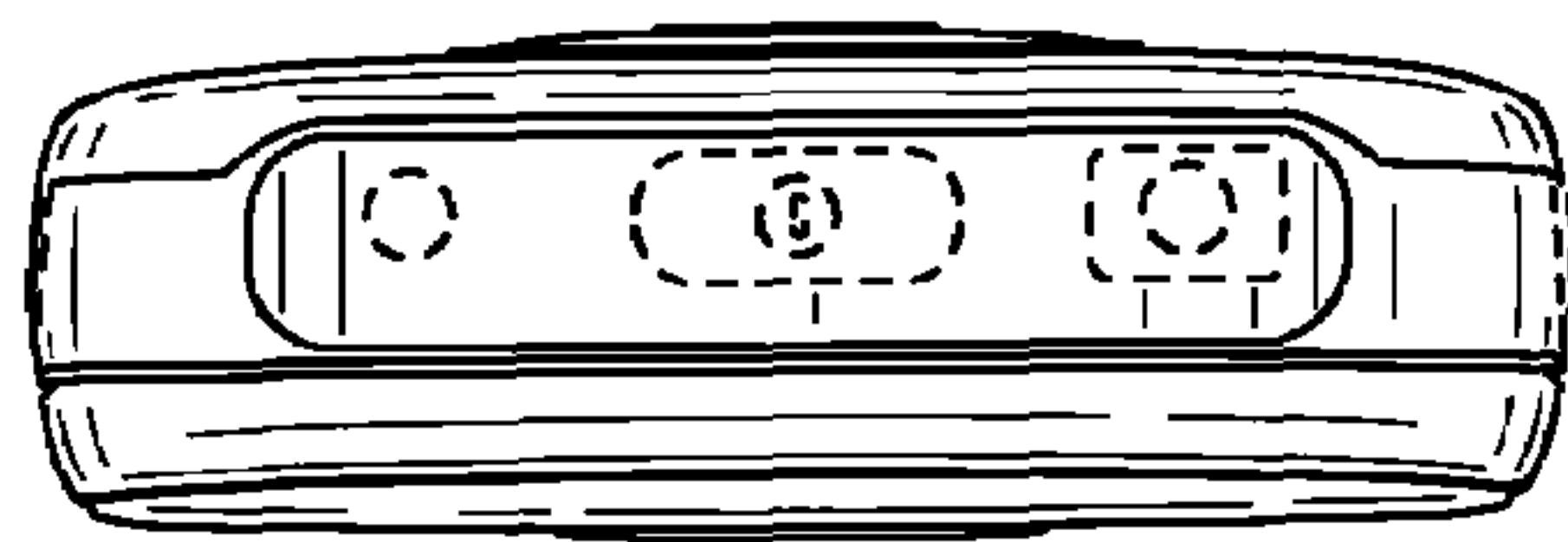

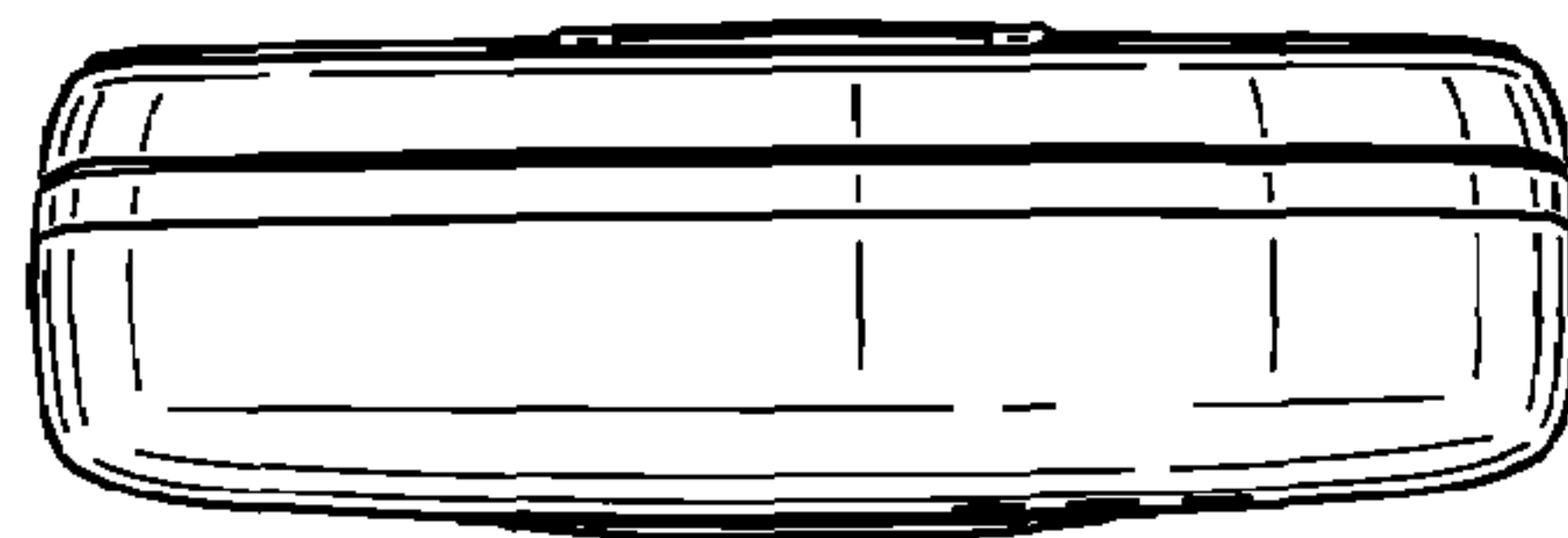

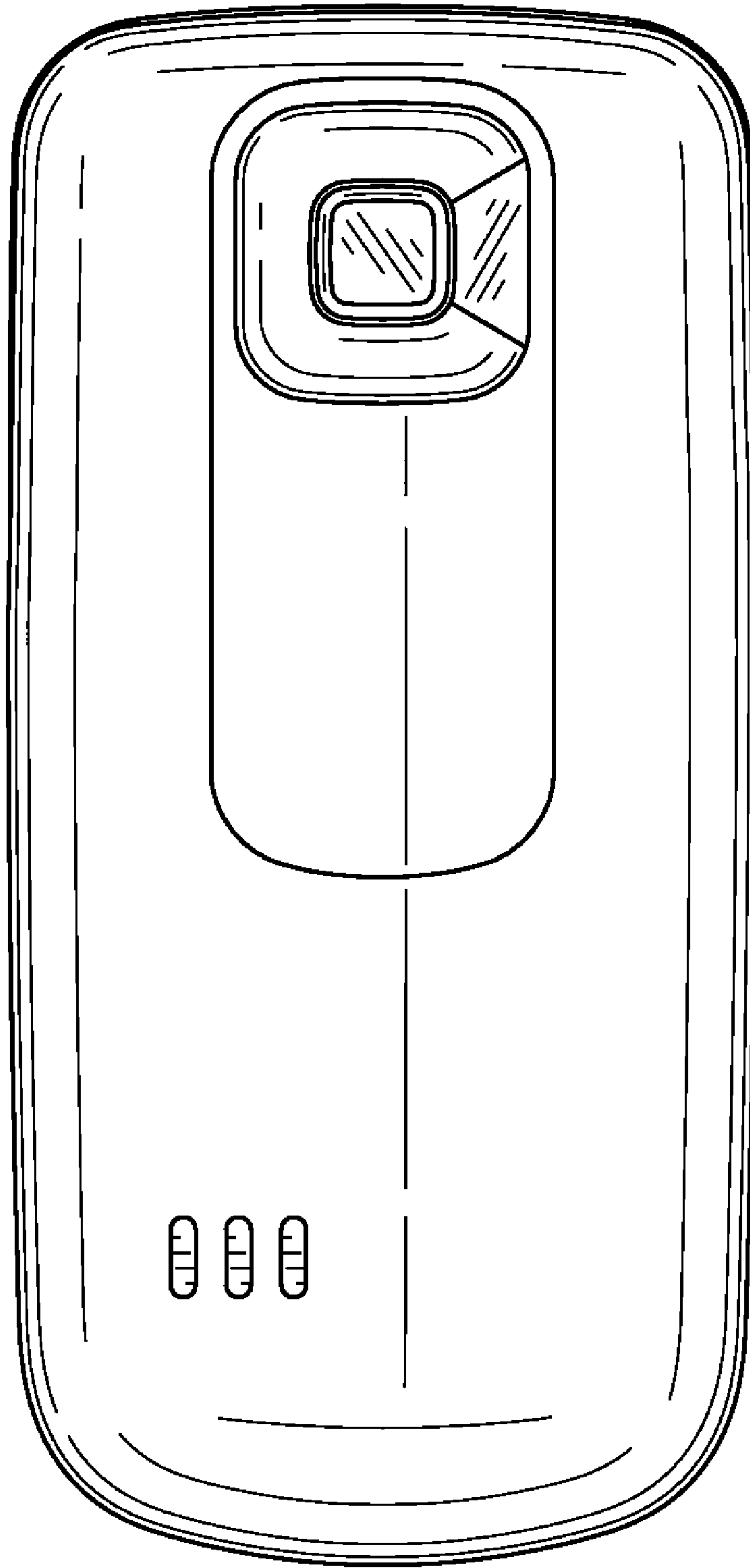
