We claim the ornamental design for a cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cellular phone showing the new design:

FIG. 2 is a front elevation view thereof;

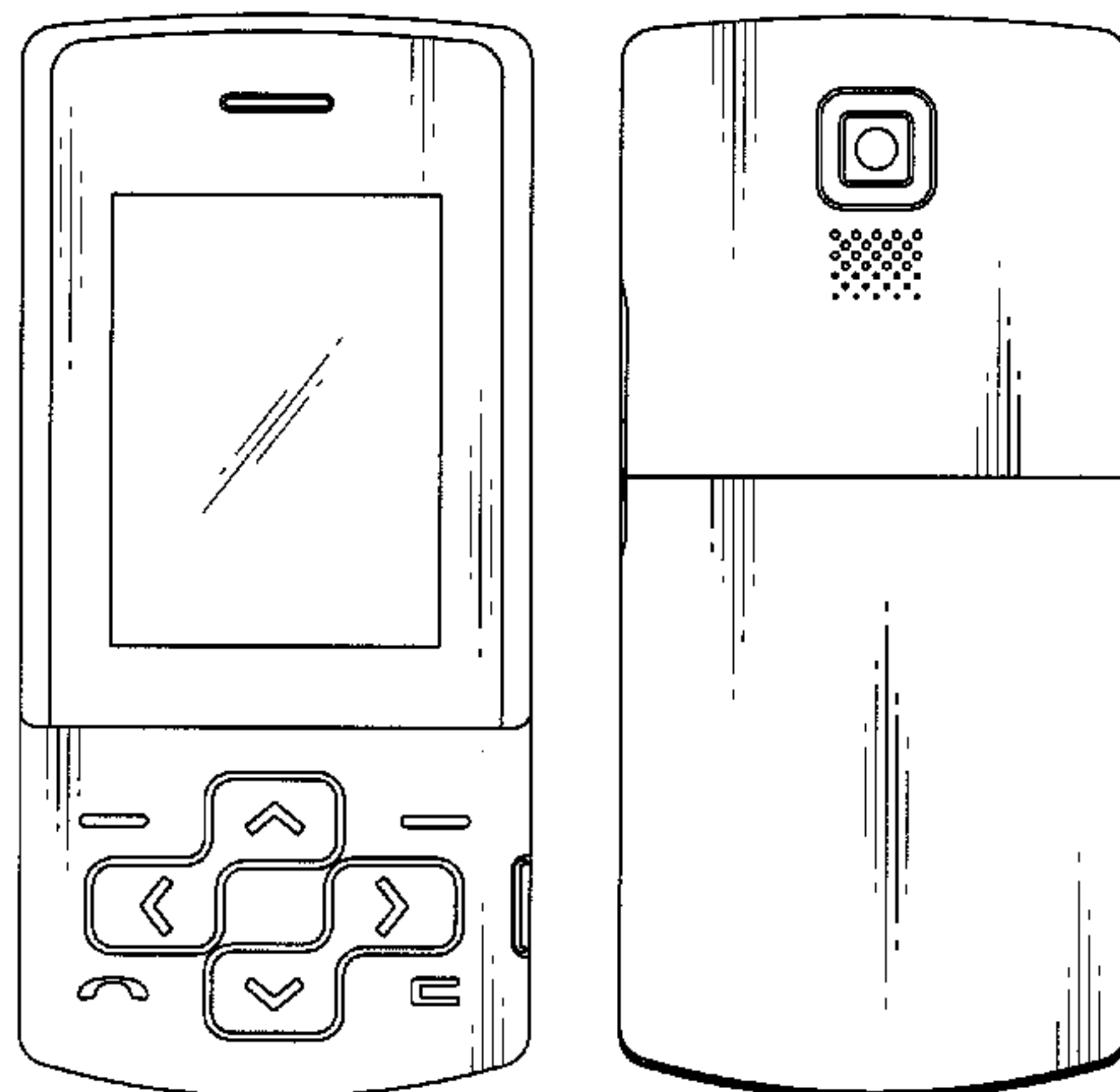

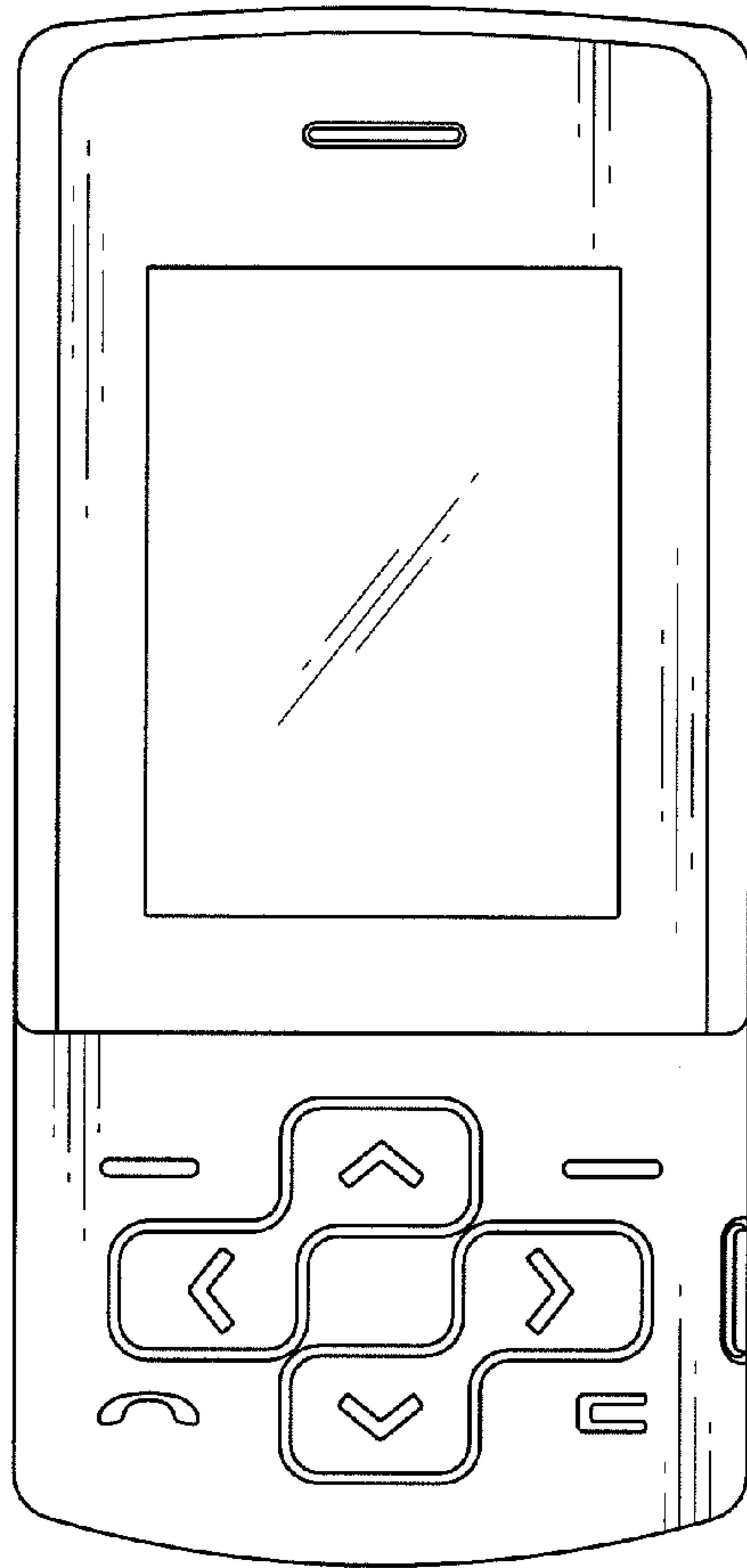

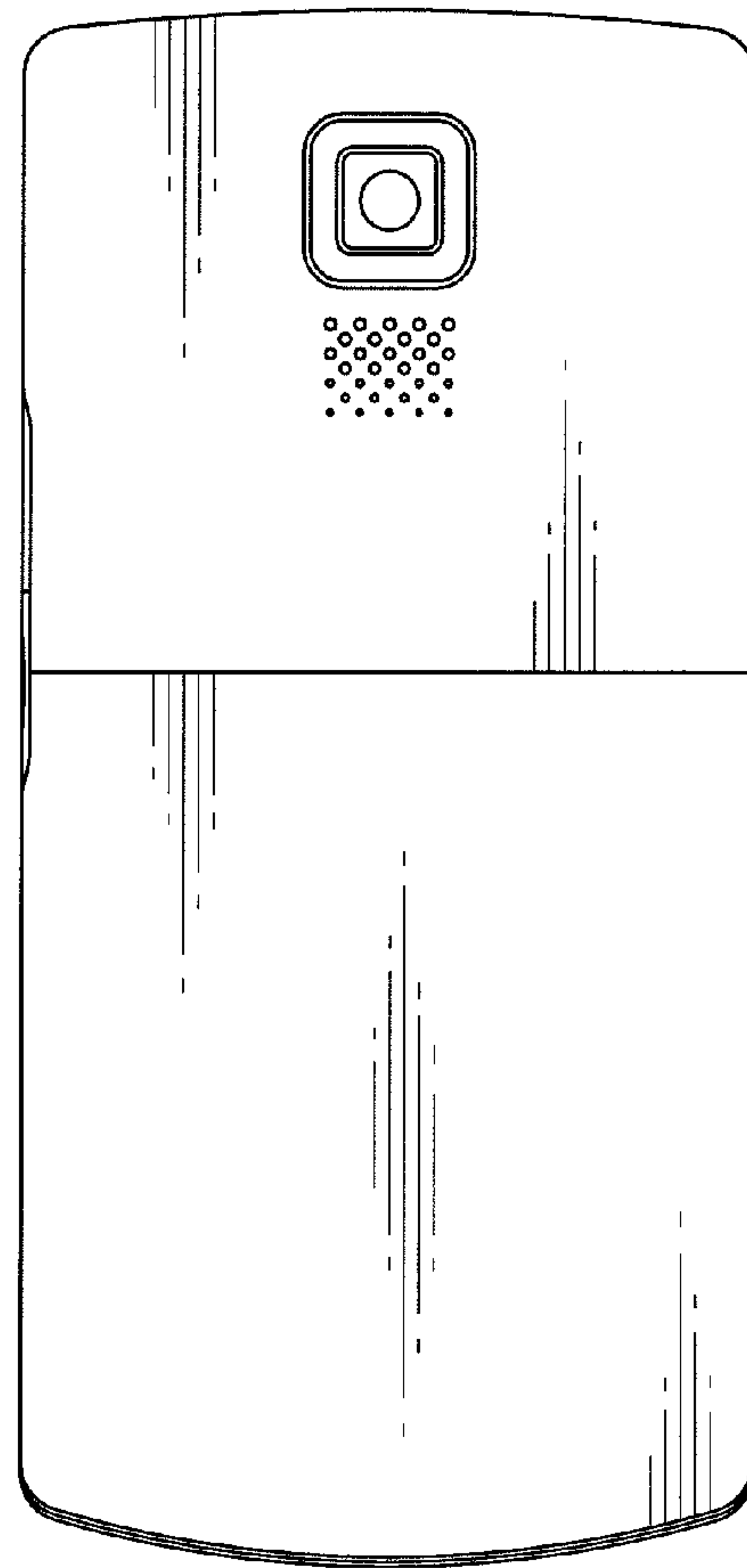

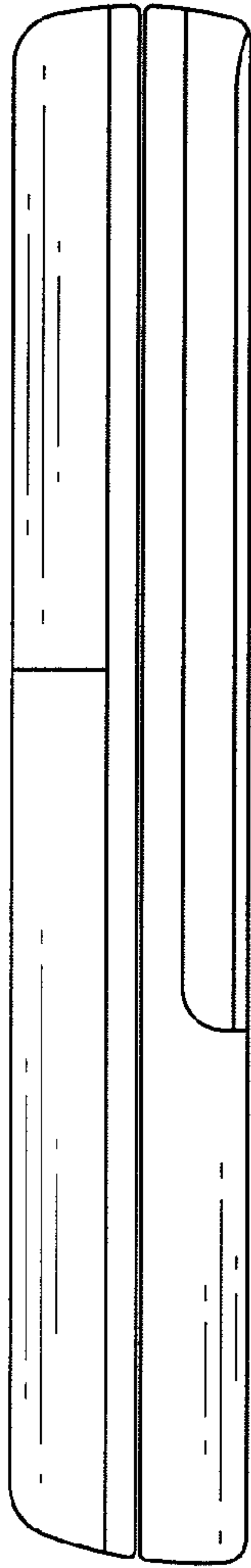

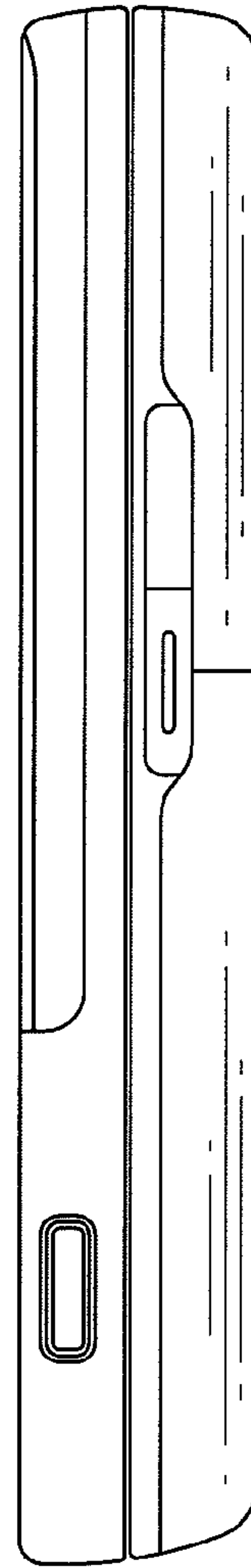

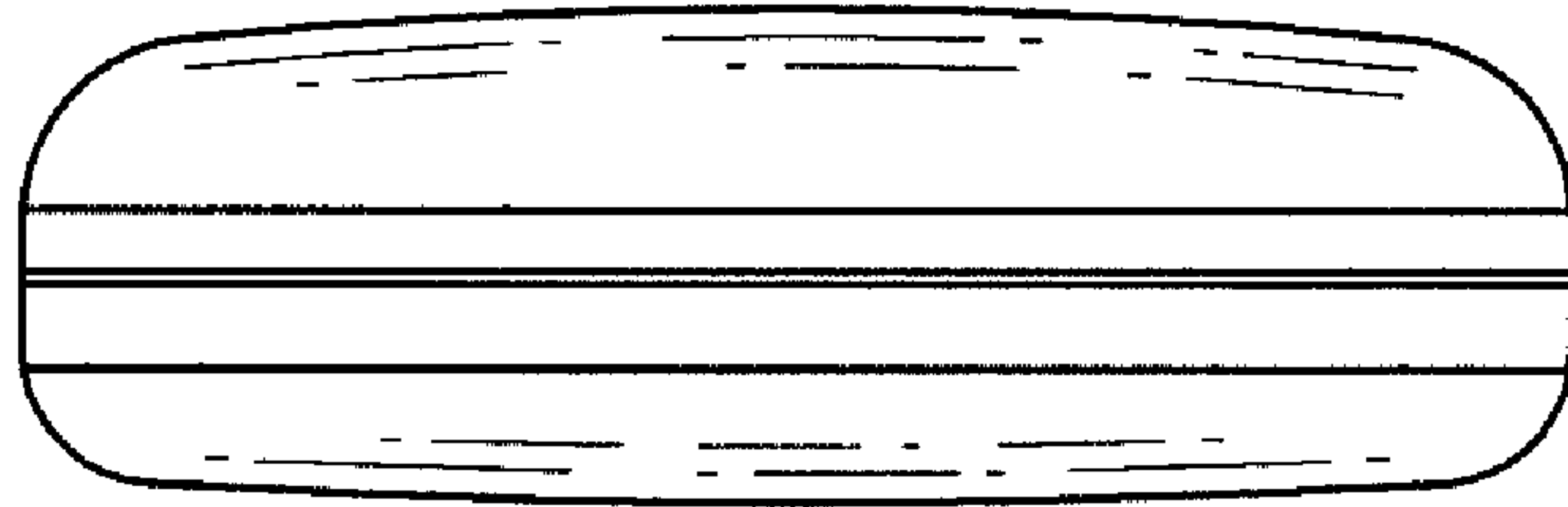

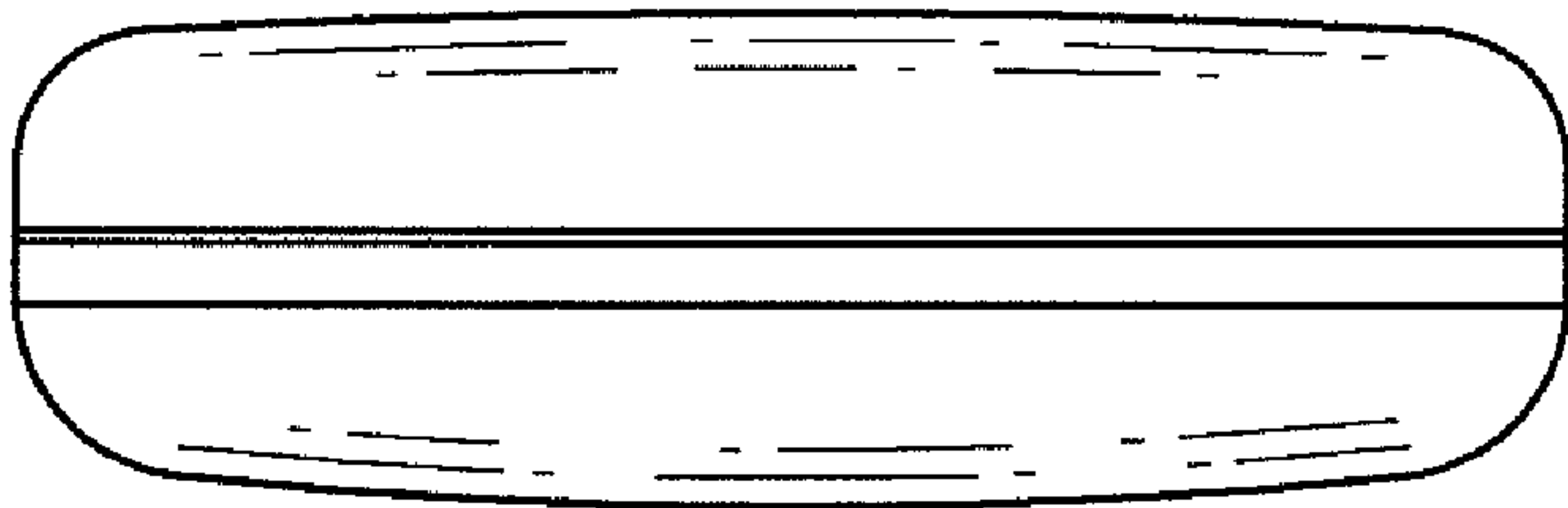
