FIG. 2 is a side view with the opposite side view being a mirror image thereof;

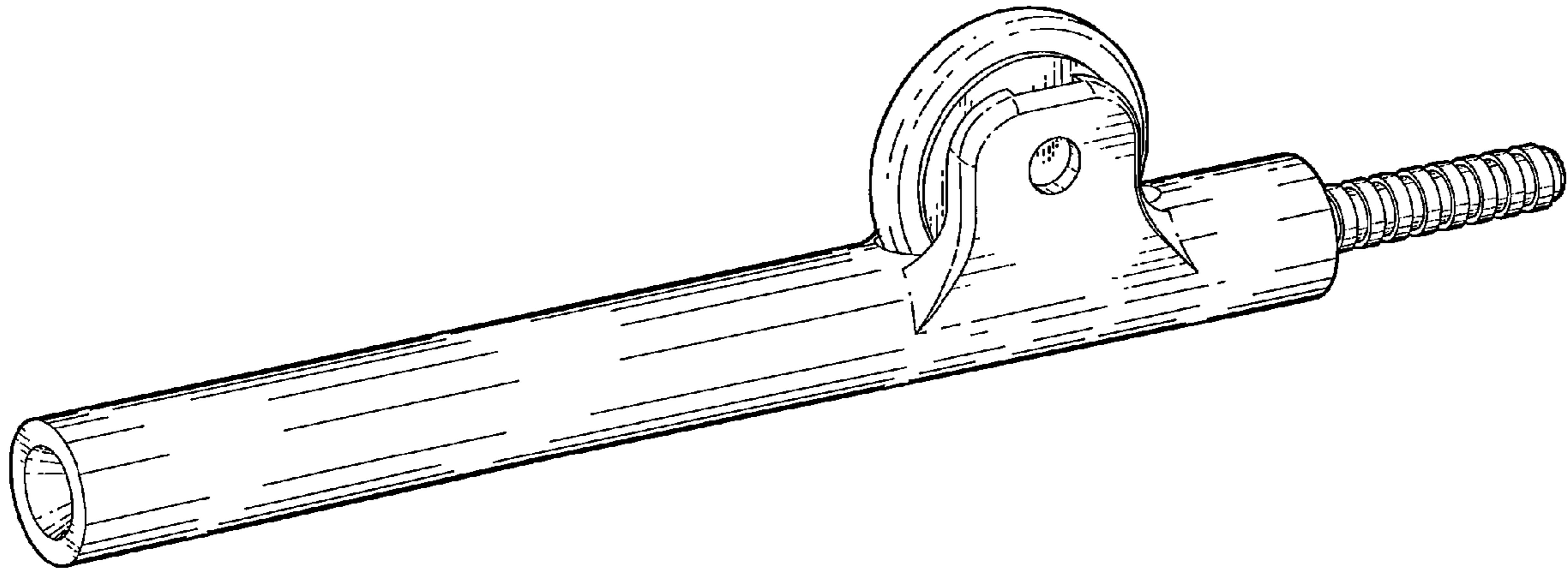
FIG. 3 is a top view thereof;

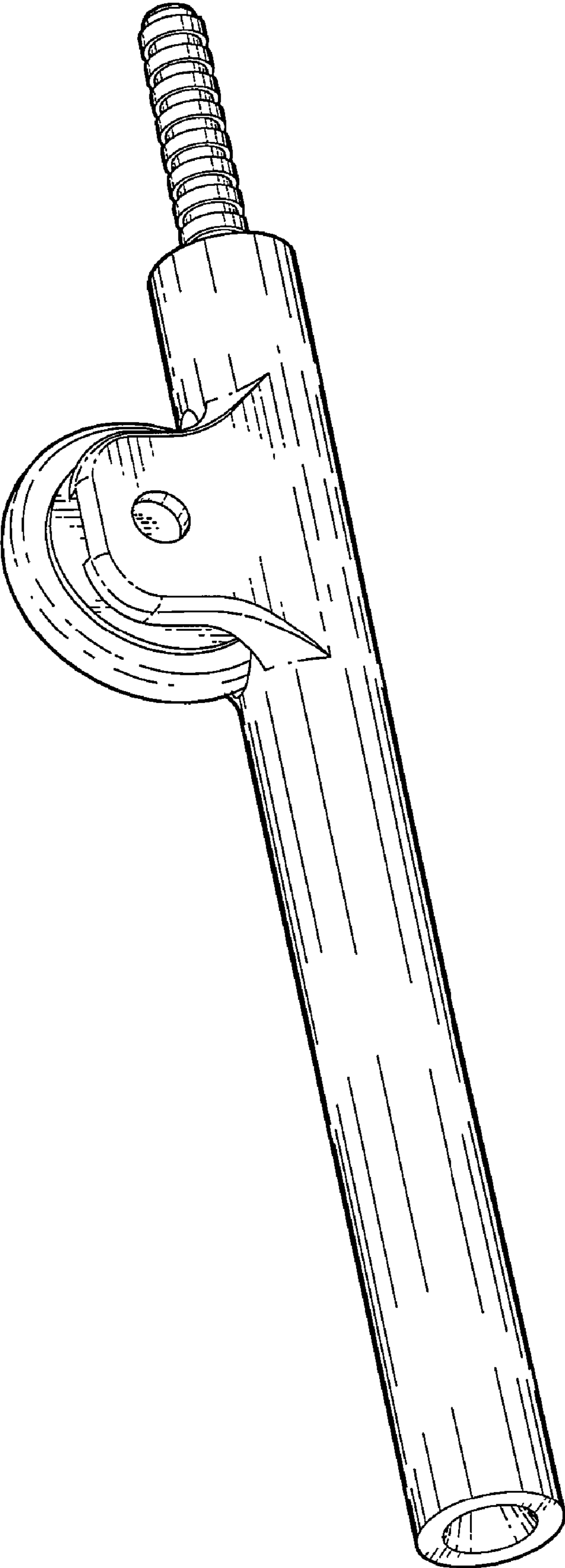
FIG. 4 is a right end view thereof;

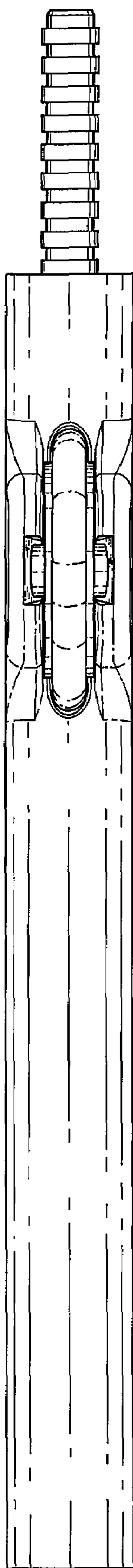

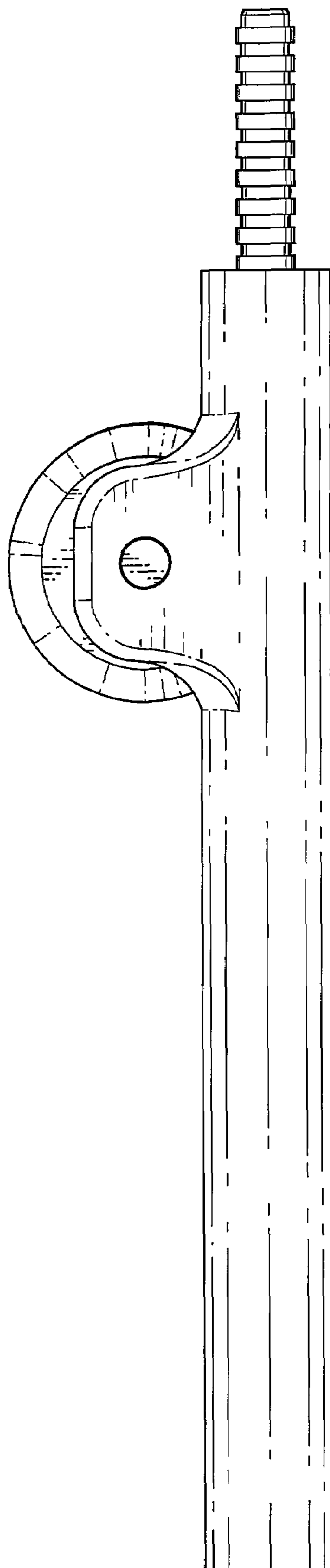
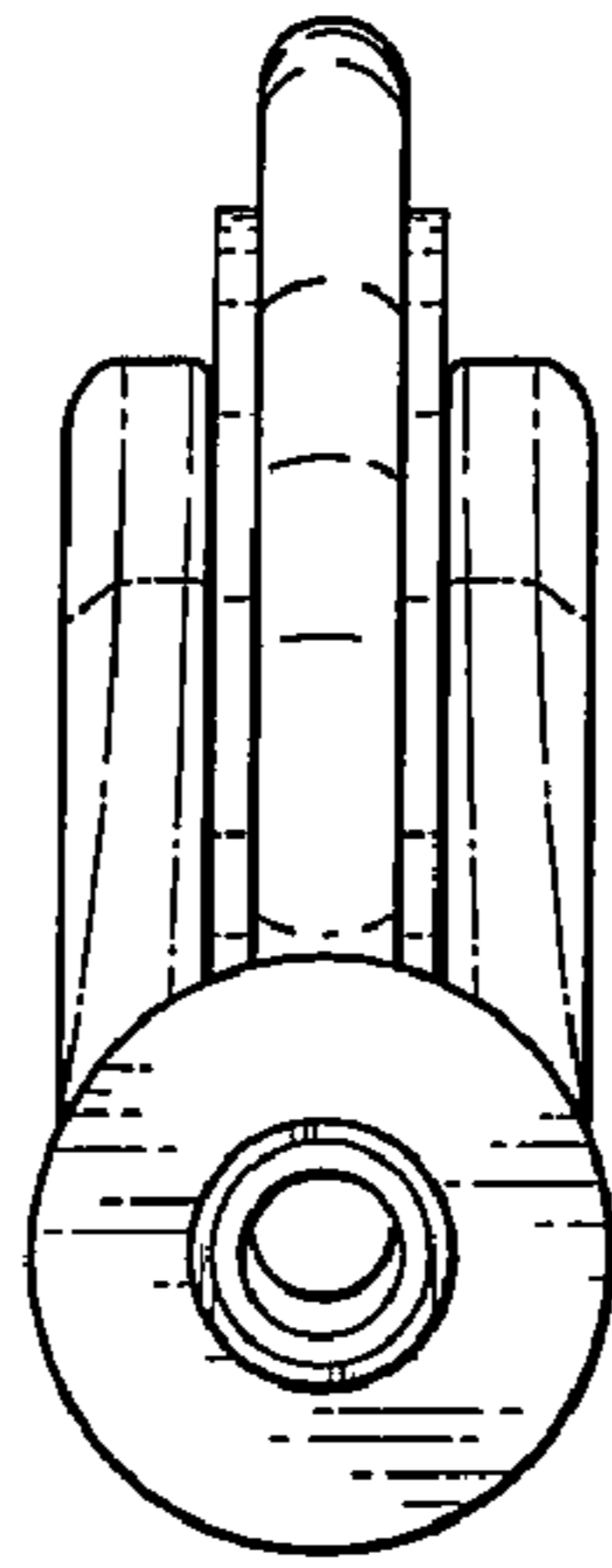
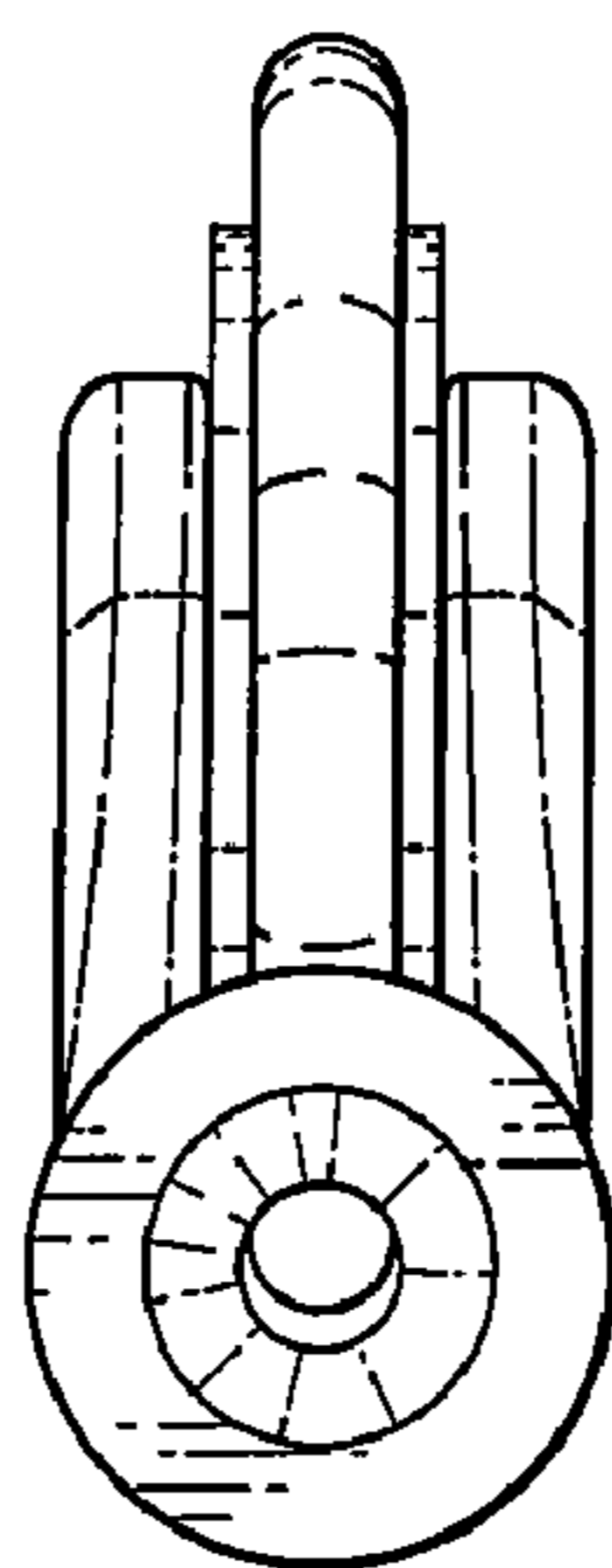
