(57) **CLAIM**

The ornamental design for a golf club head cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective front view of an example golf club head cover;

FIG. 2 is a top view of the golf club head cover of FIG. 1;

FIG. 3 is a bottom view of the golf club head cover of FIG. 1;

FIG. 4 is a right side view of the golf club head cover of FIG. 1; the left side view being a mirror image thereof;

FIG. 5 is a front view of the golf club head cover of FIG. 1;

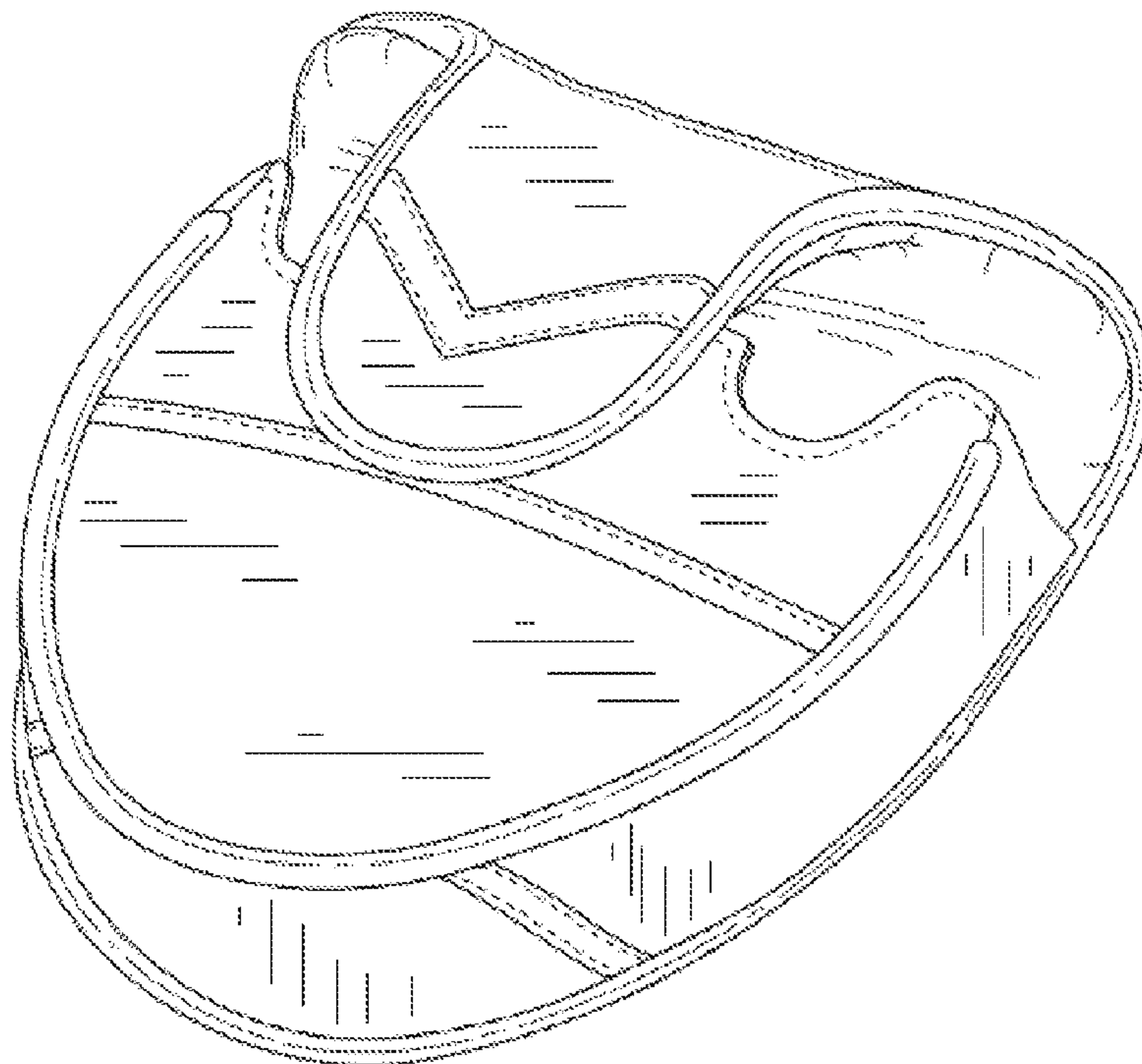
FIG. 6 is a rear view of the golf club head cover of FIG. 1;

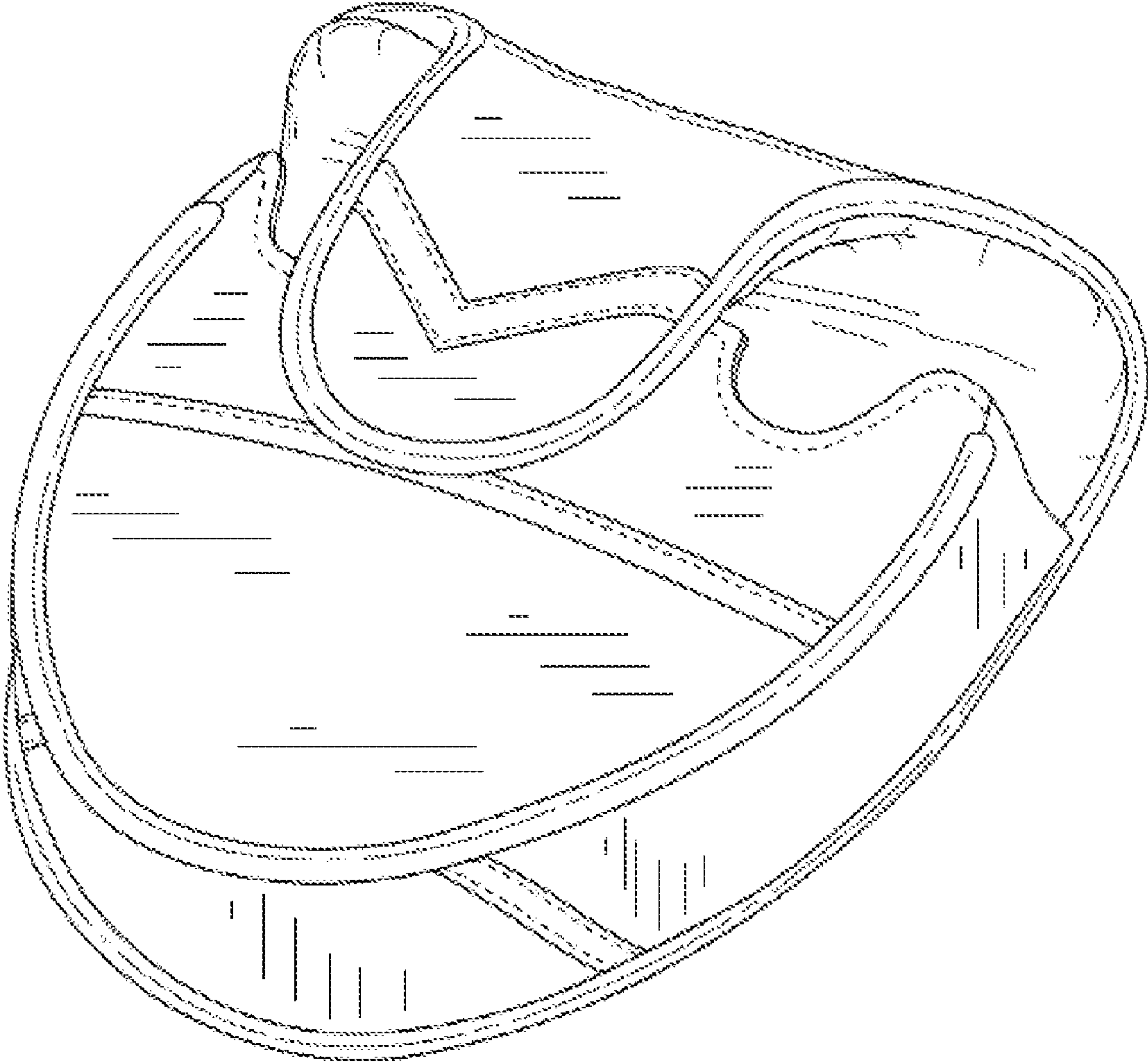

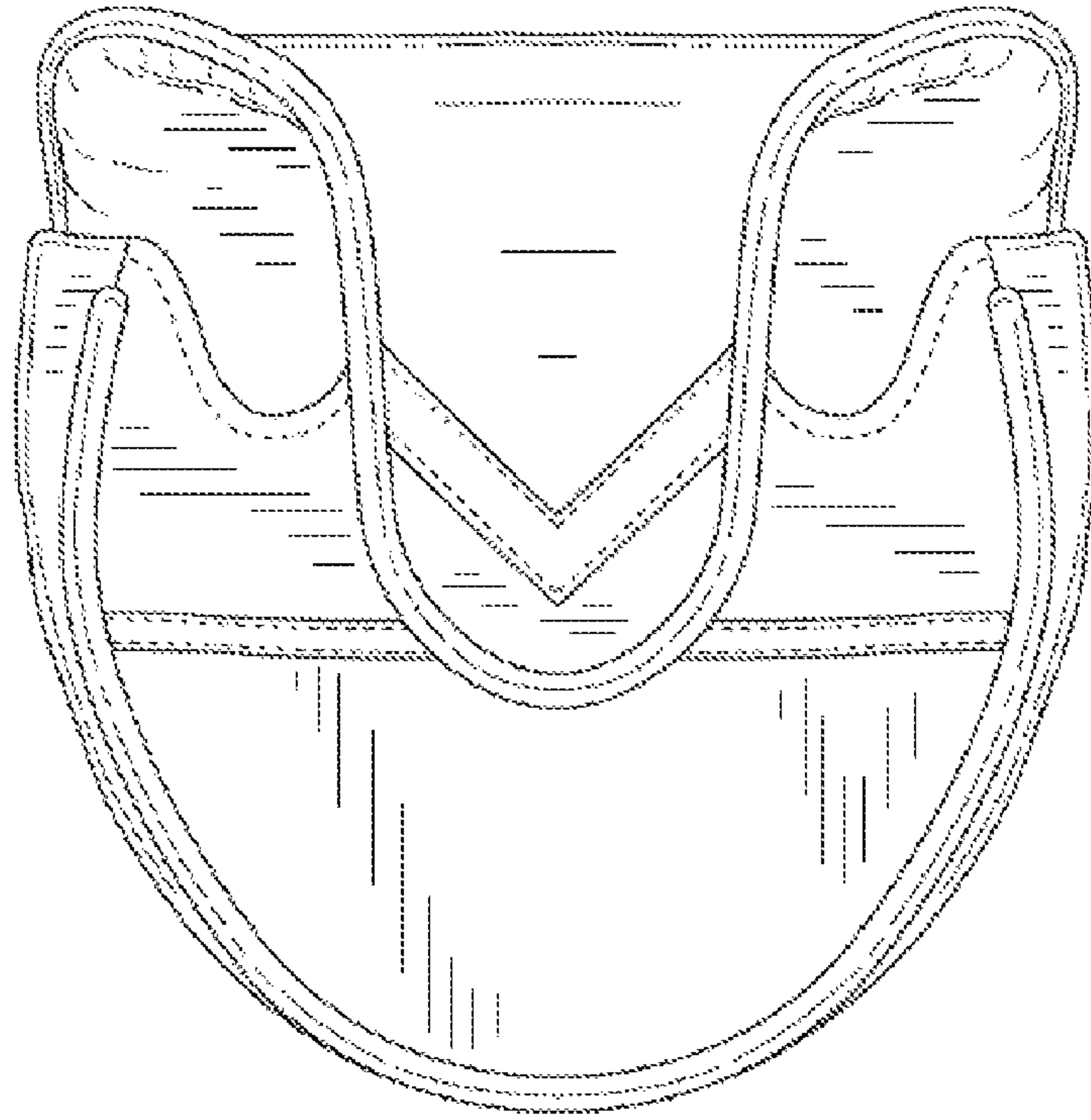

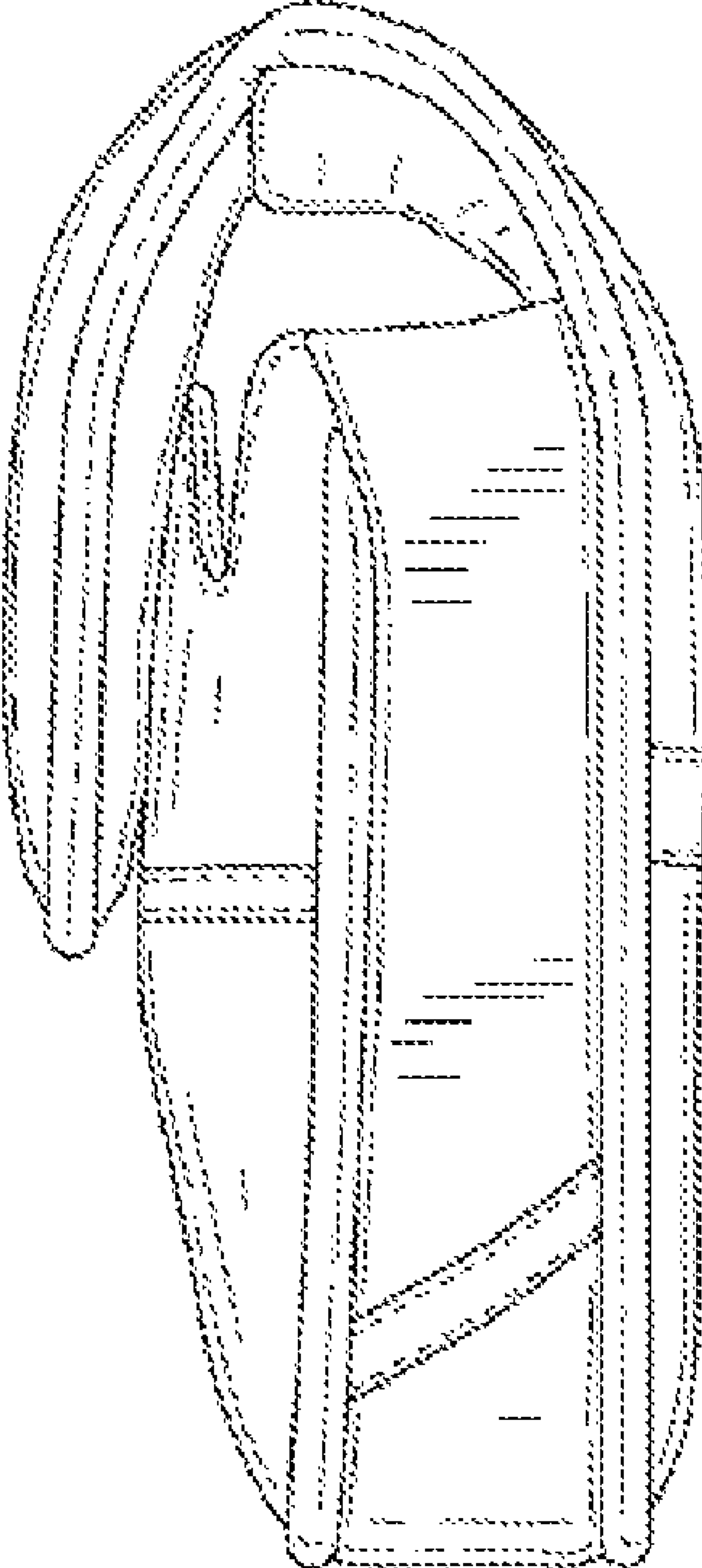

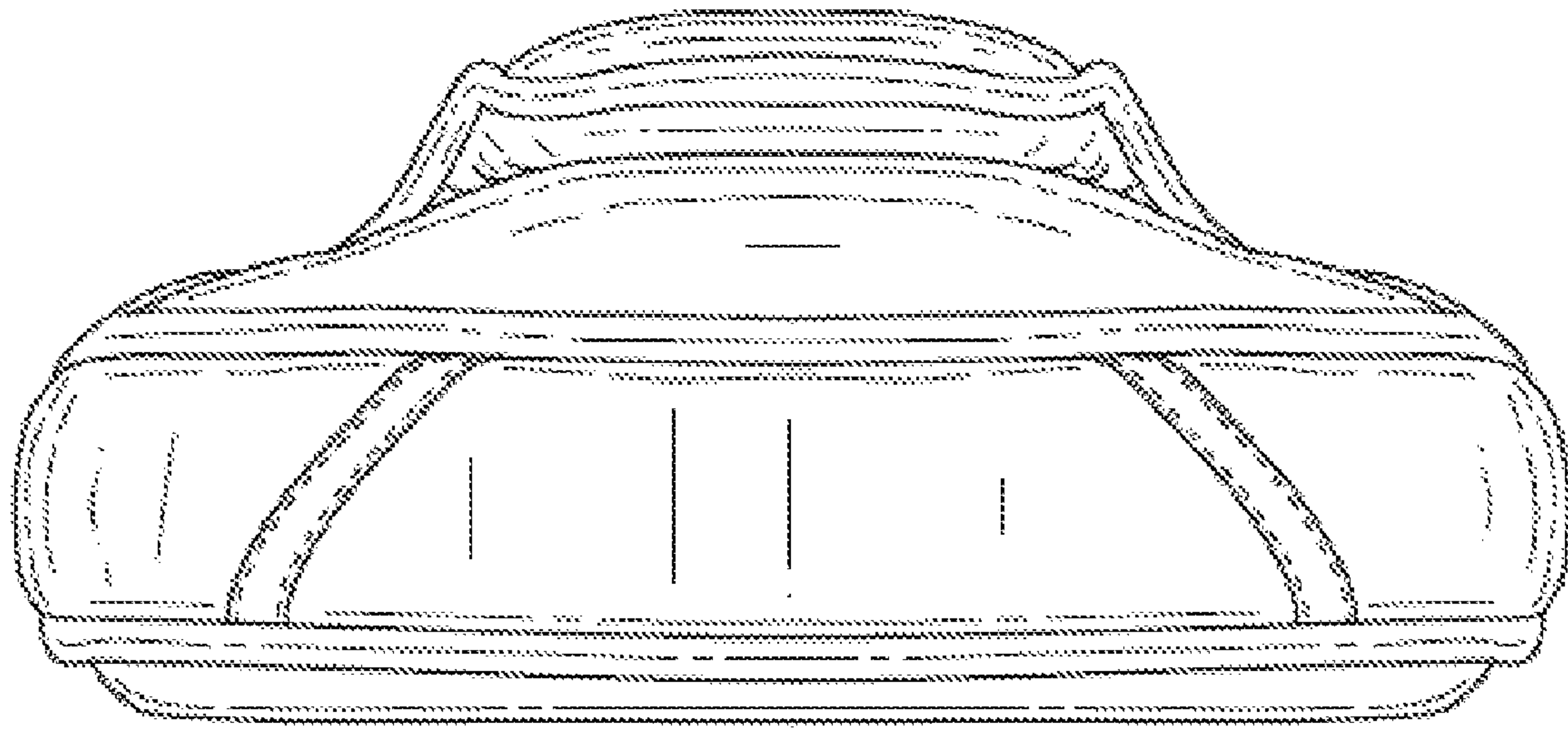

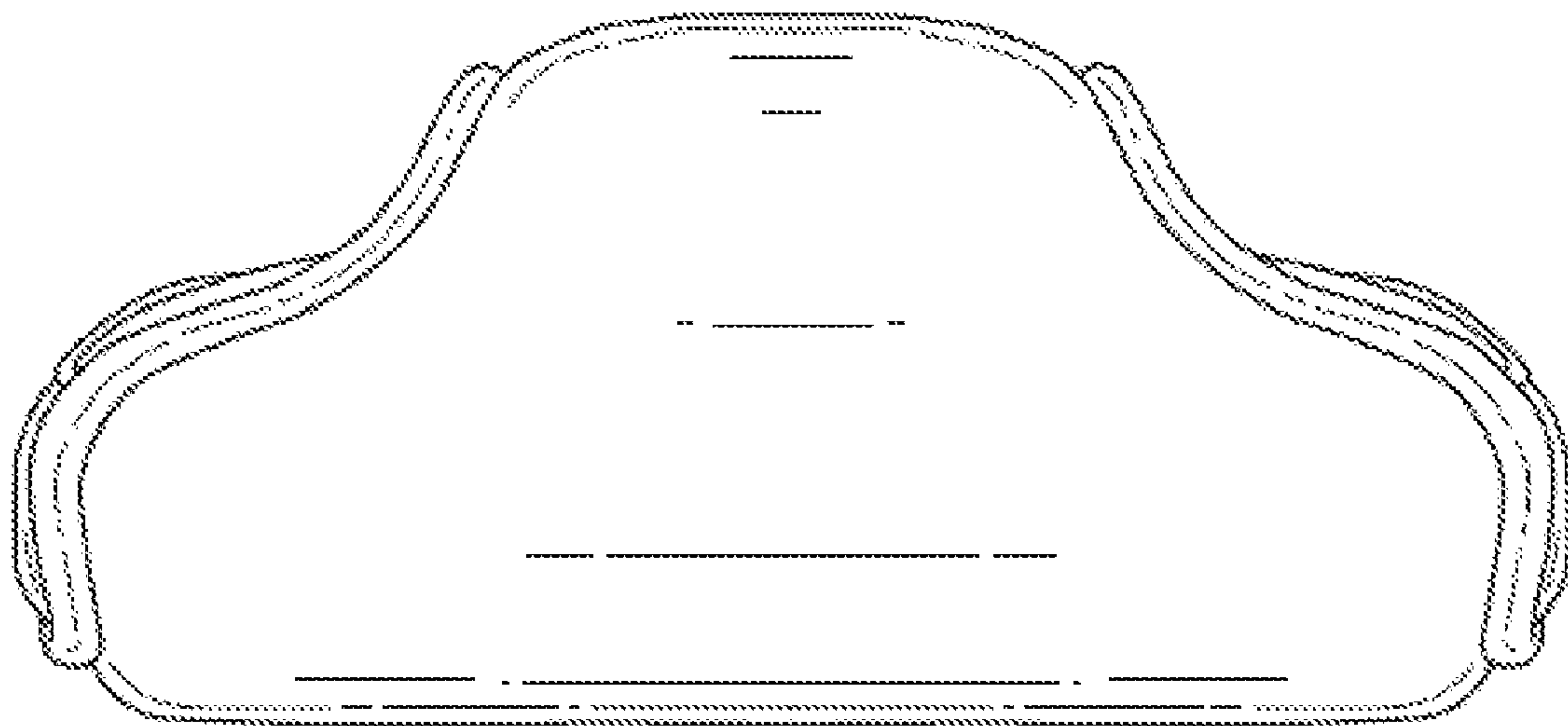

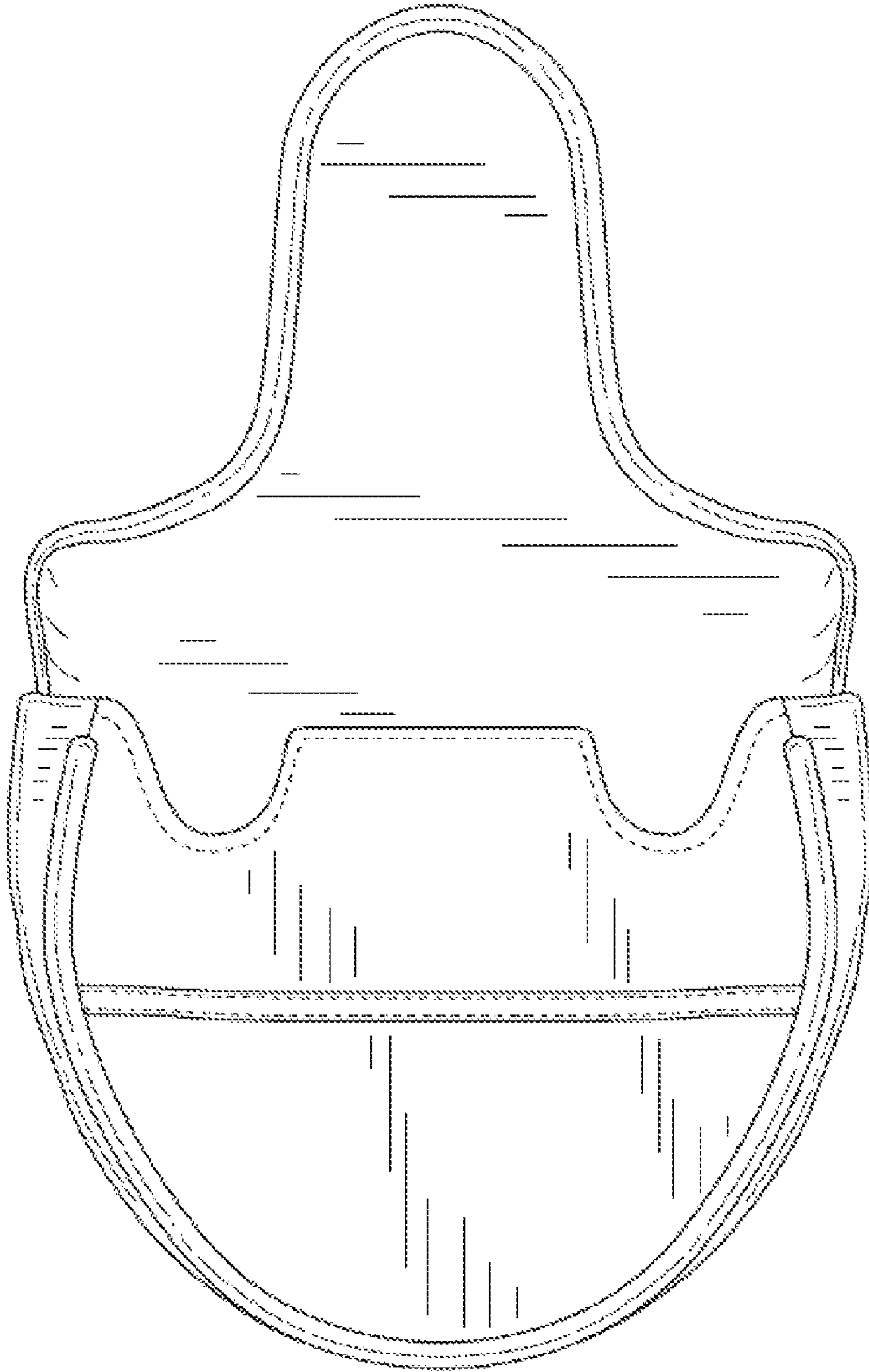

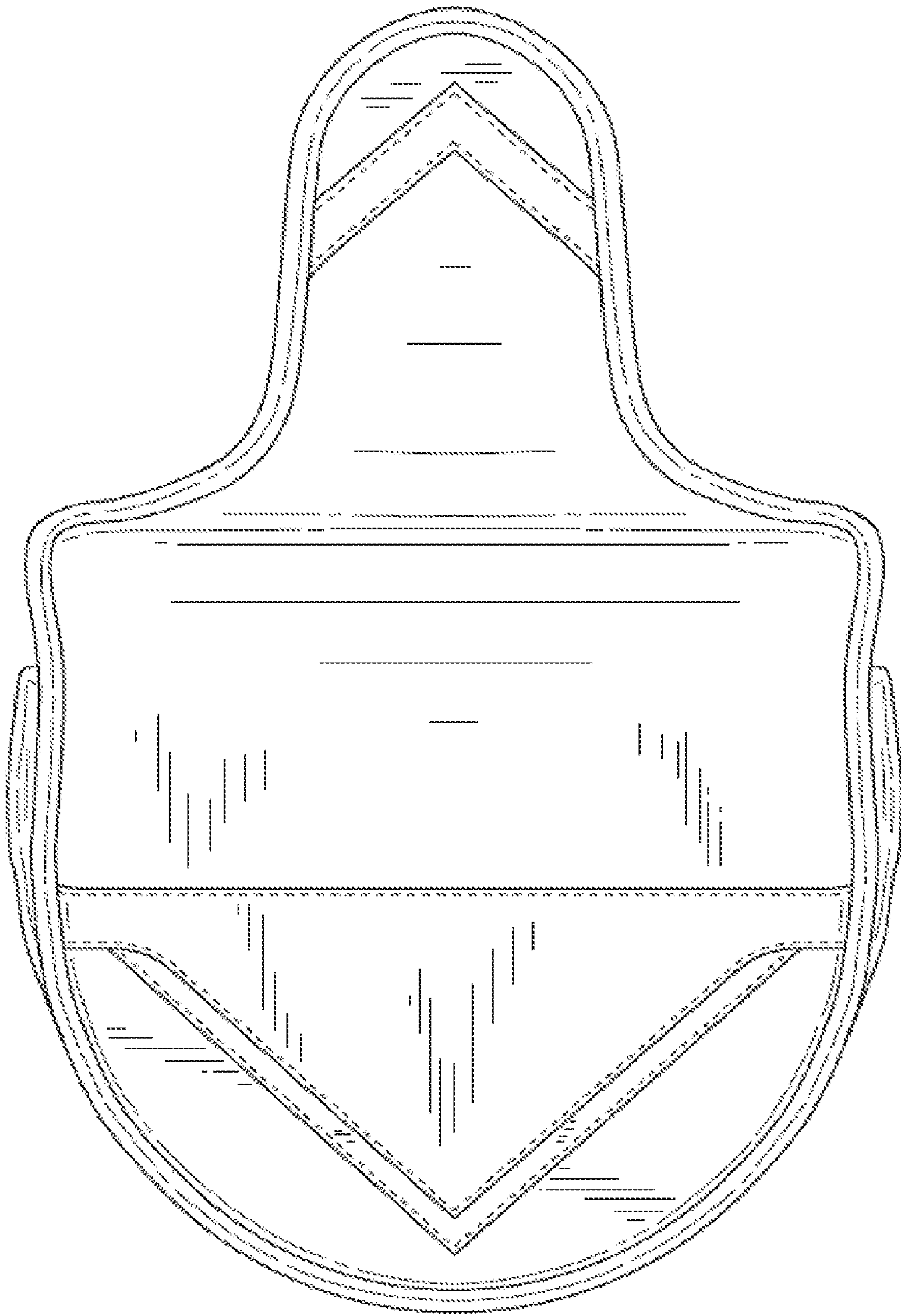
