FIG. 1 is a perspective view depicting the heater embodying my new design;

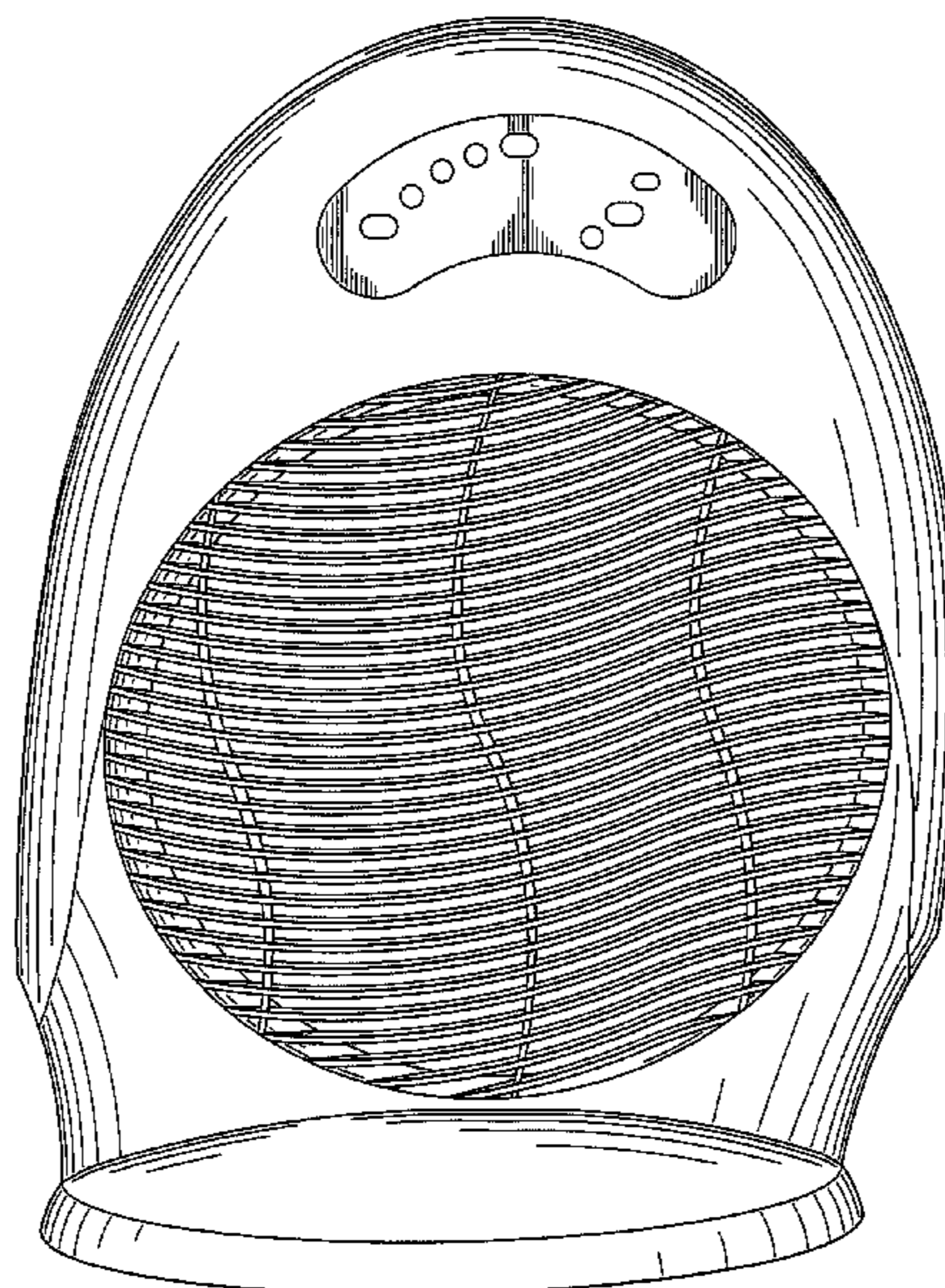
FIG. 2 is a front elevational view depicting the embodiment of FIG. 1;

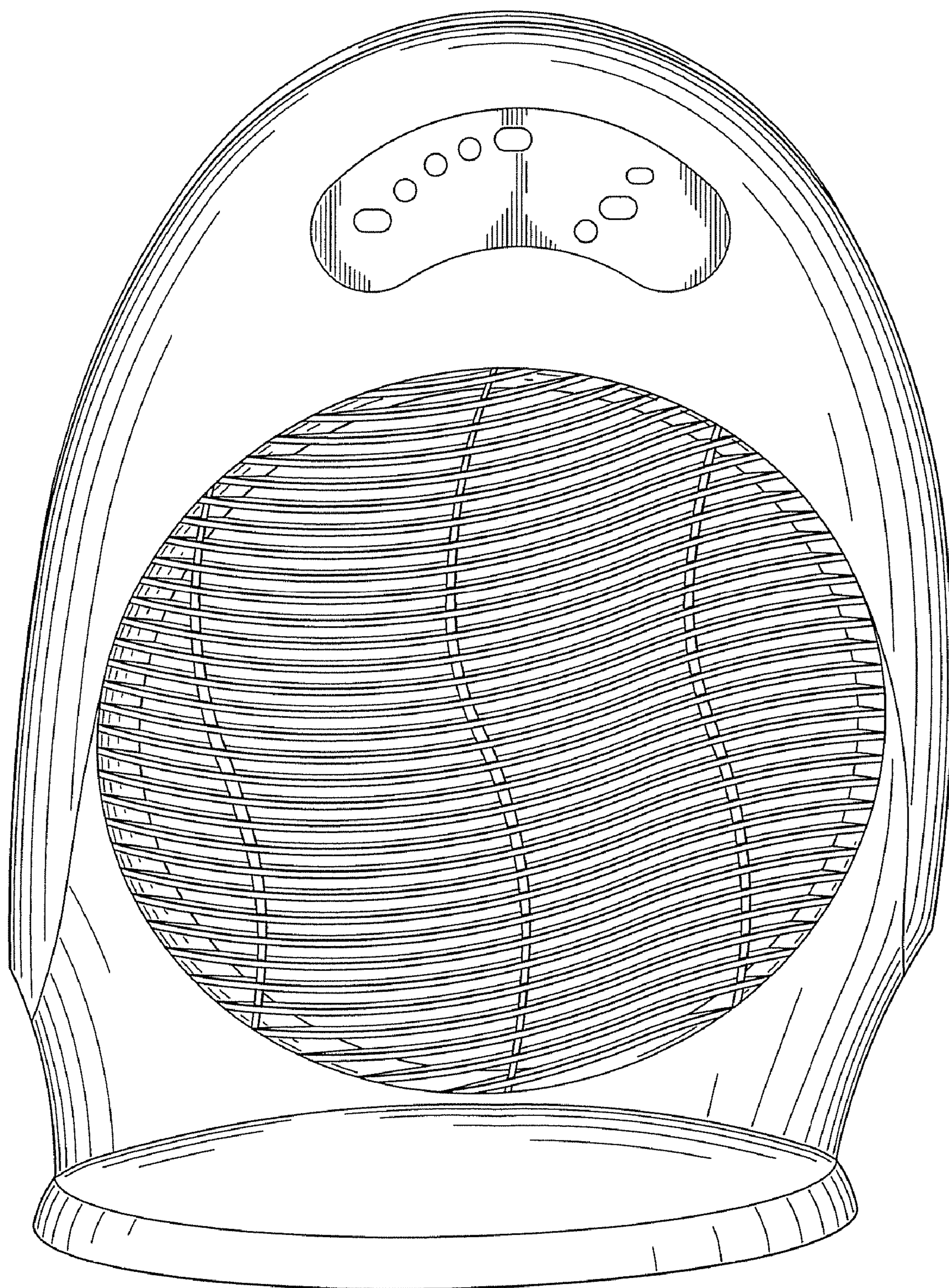

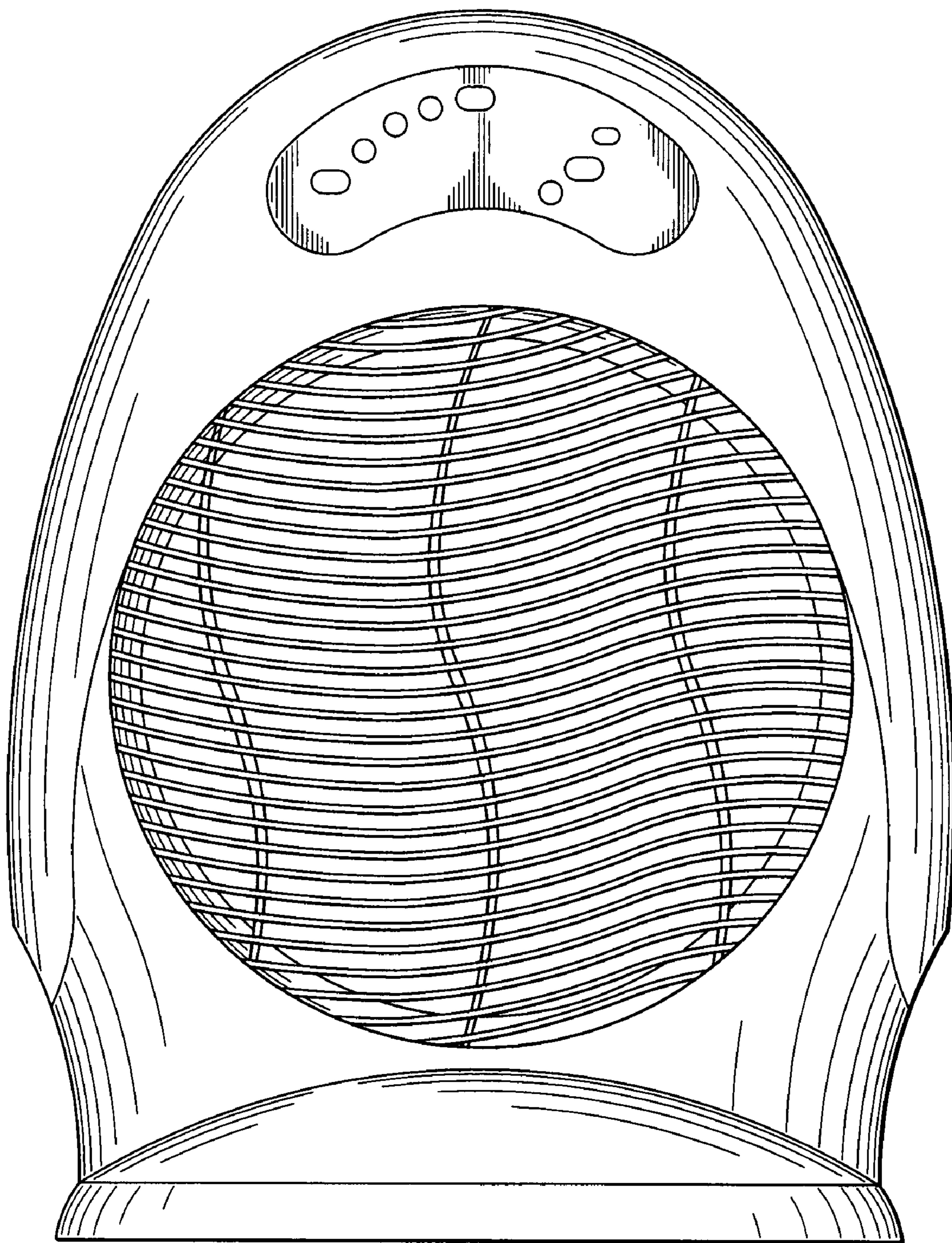

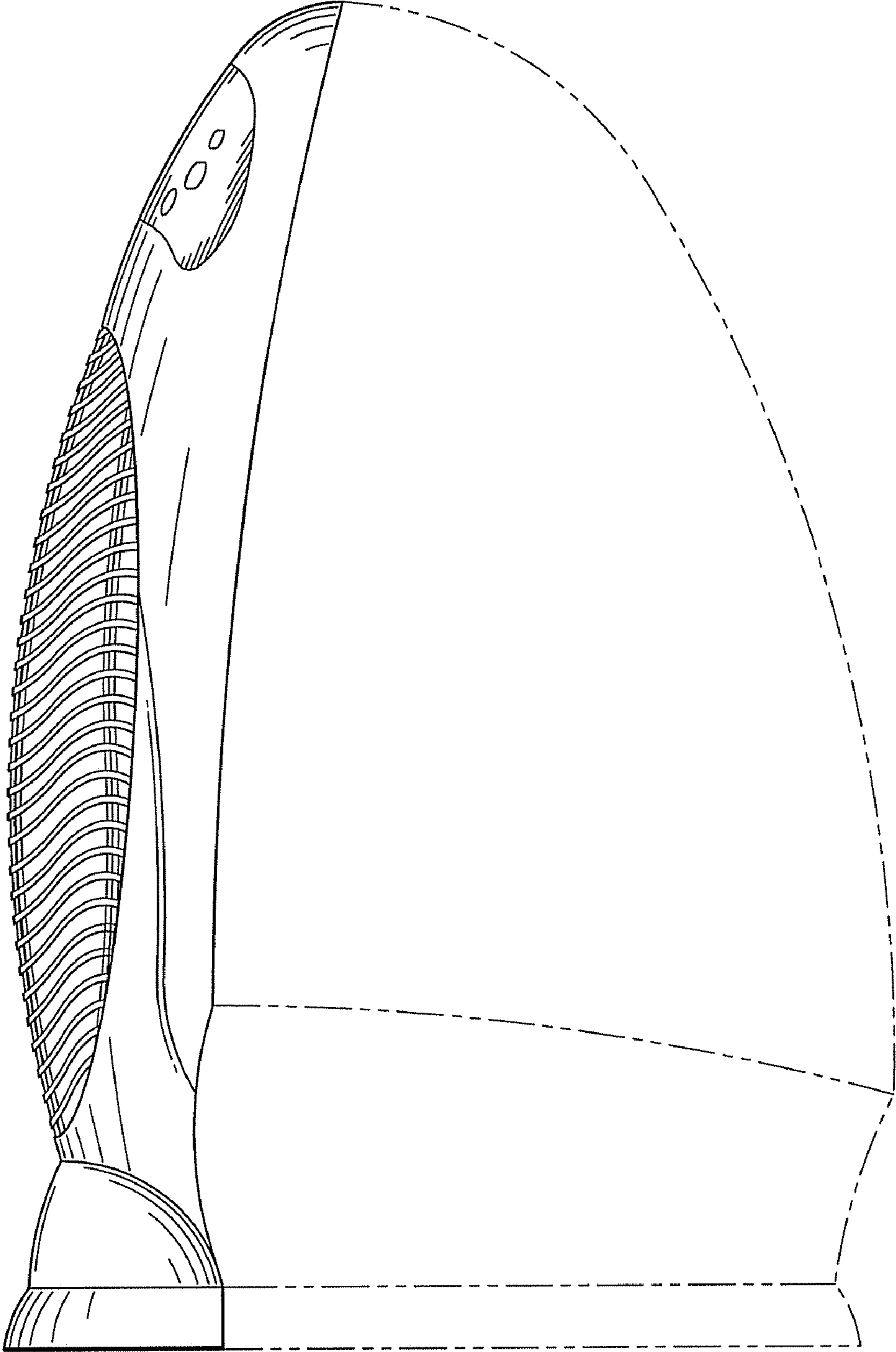

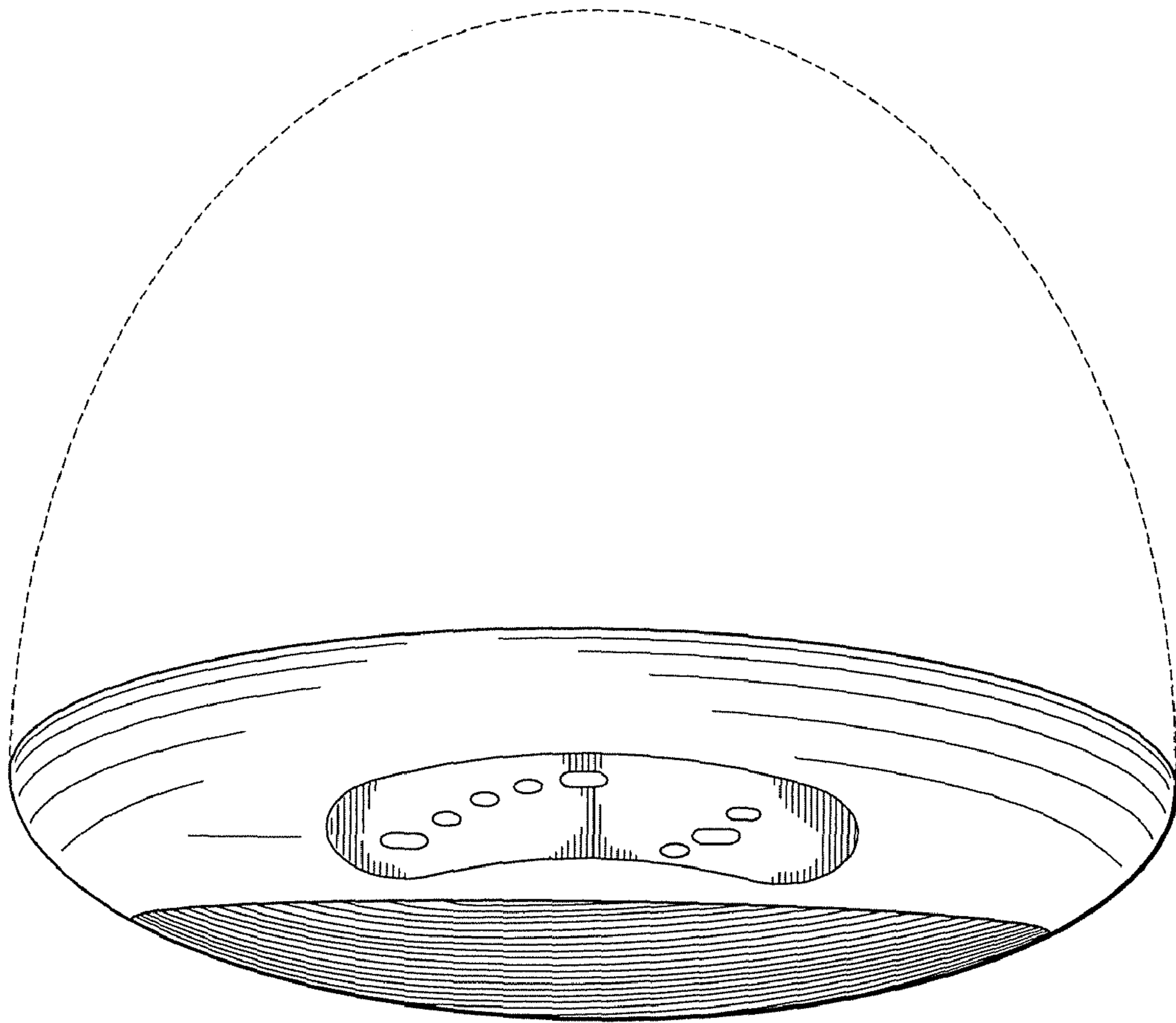
