The ornamental design for a body armour plate, as shown and described.

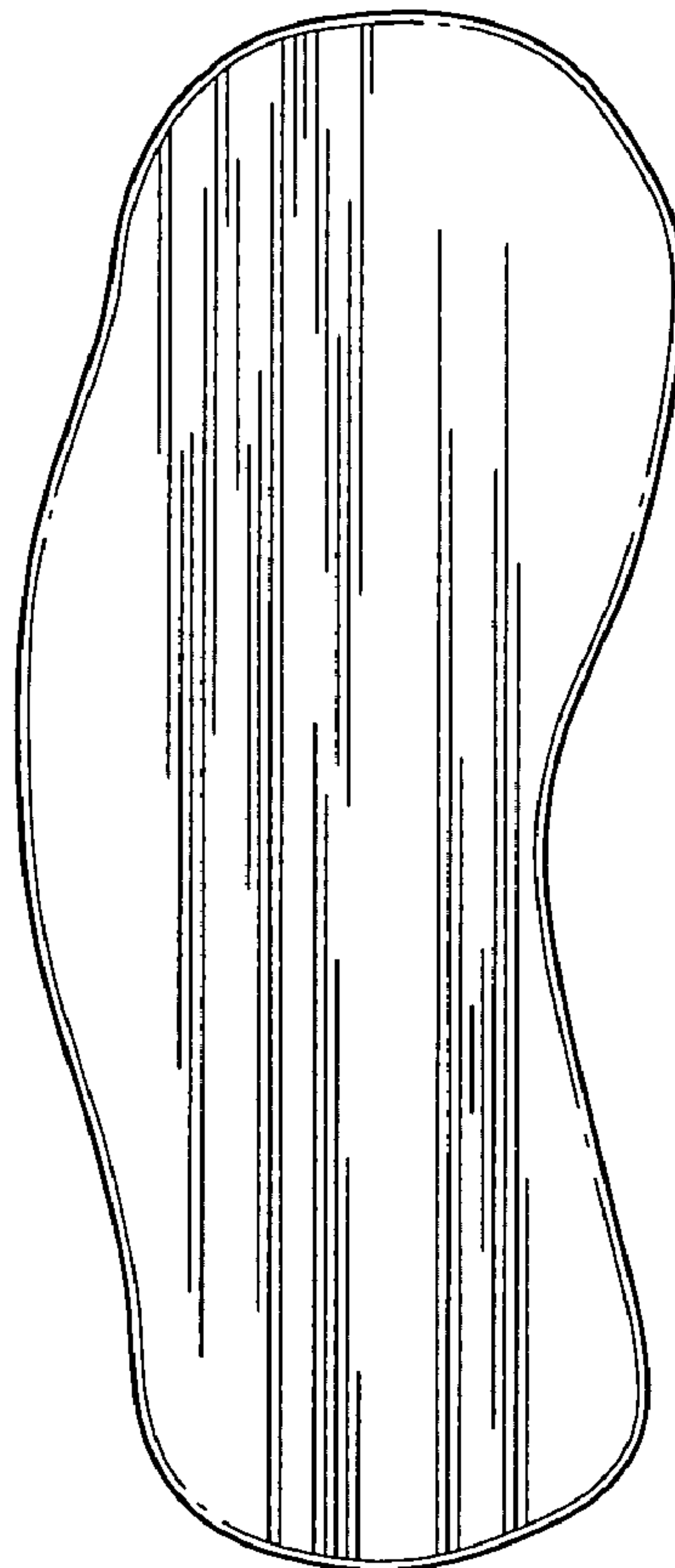
DESCRIPTION

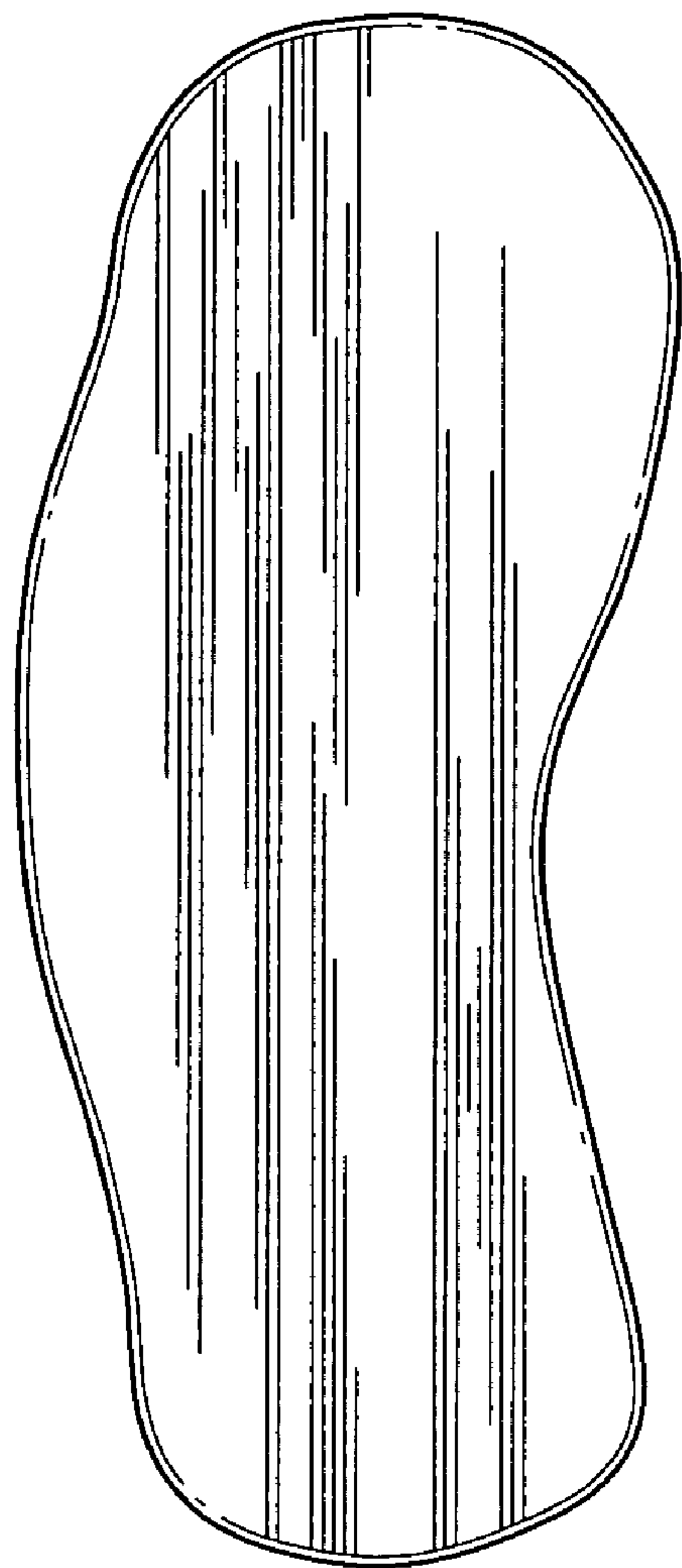

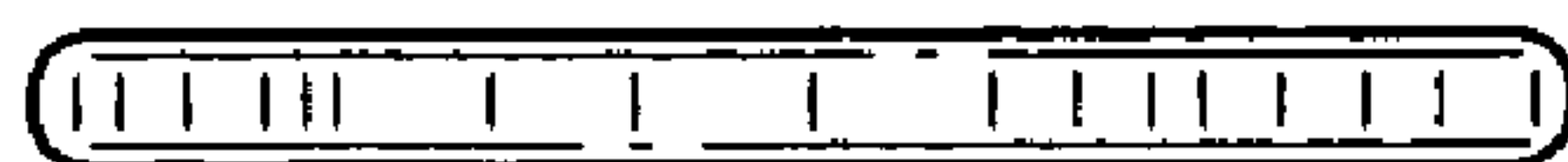
