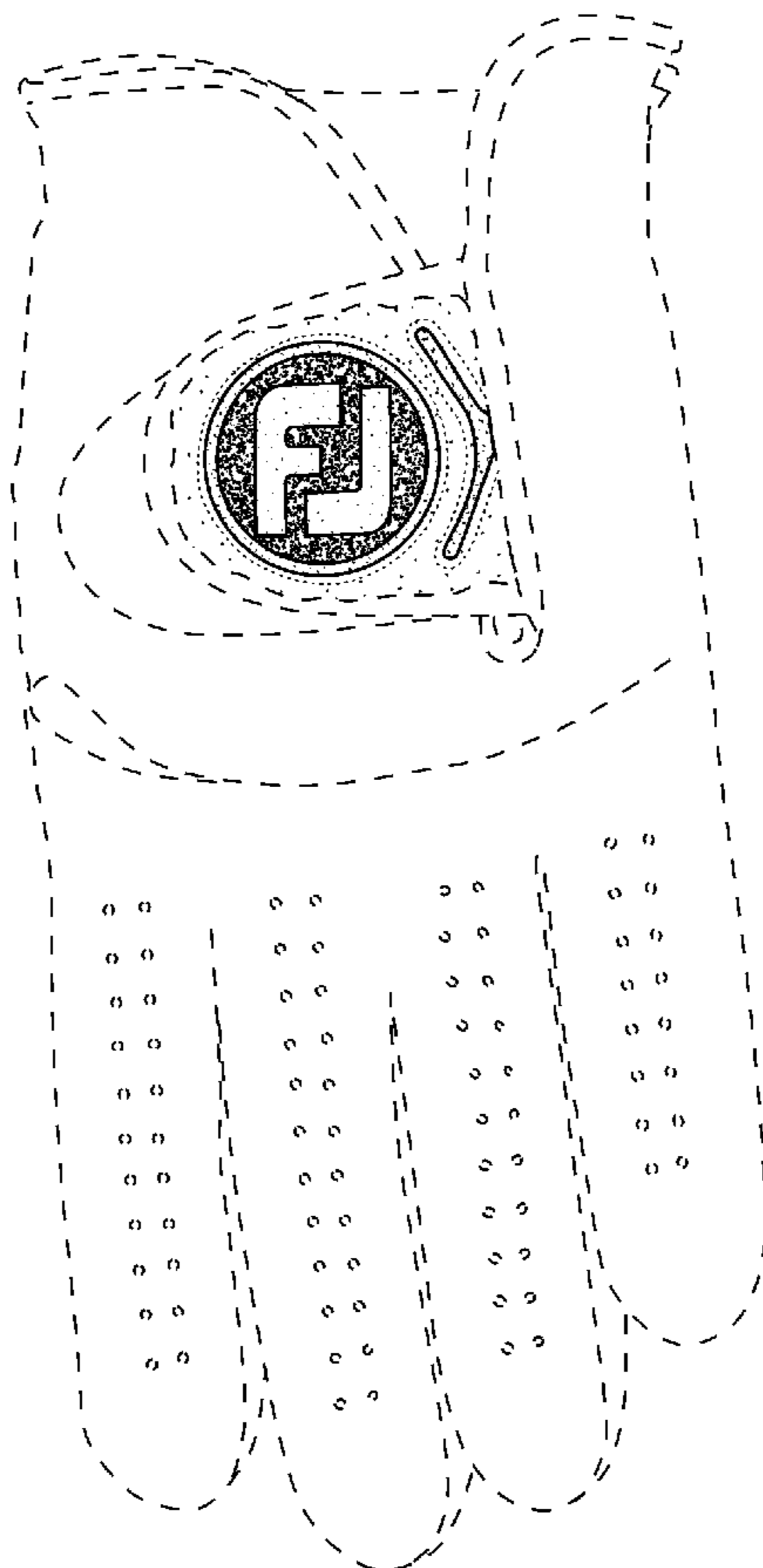
(57) **CLAIM**

The ornamental design for a back portion of a golf glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a plan view of the back portion of the glove; and, FIG. 2 is a perspective view of the back portion of the glove. The broken lines of FIGS. 1 and 2 showing the glove body and finger casings are for illustrative purposes only and form no part of the claimed design.

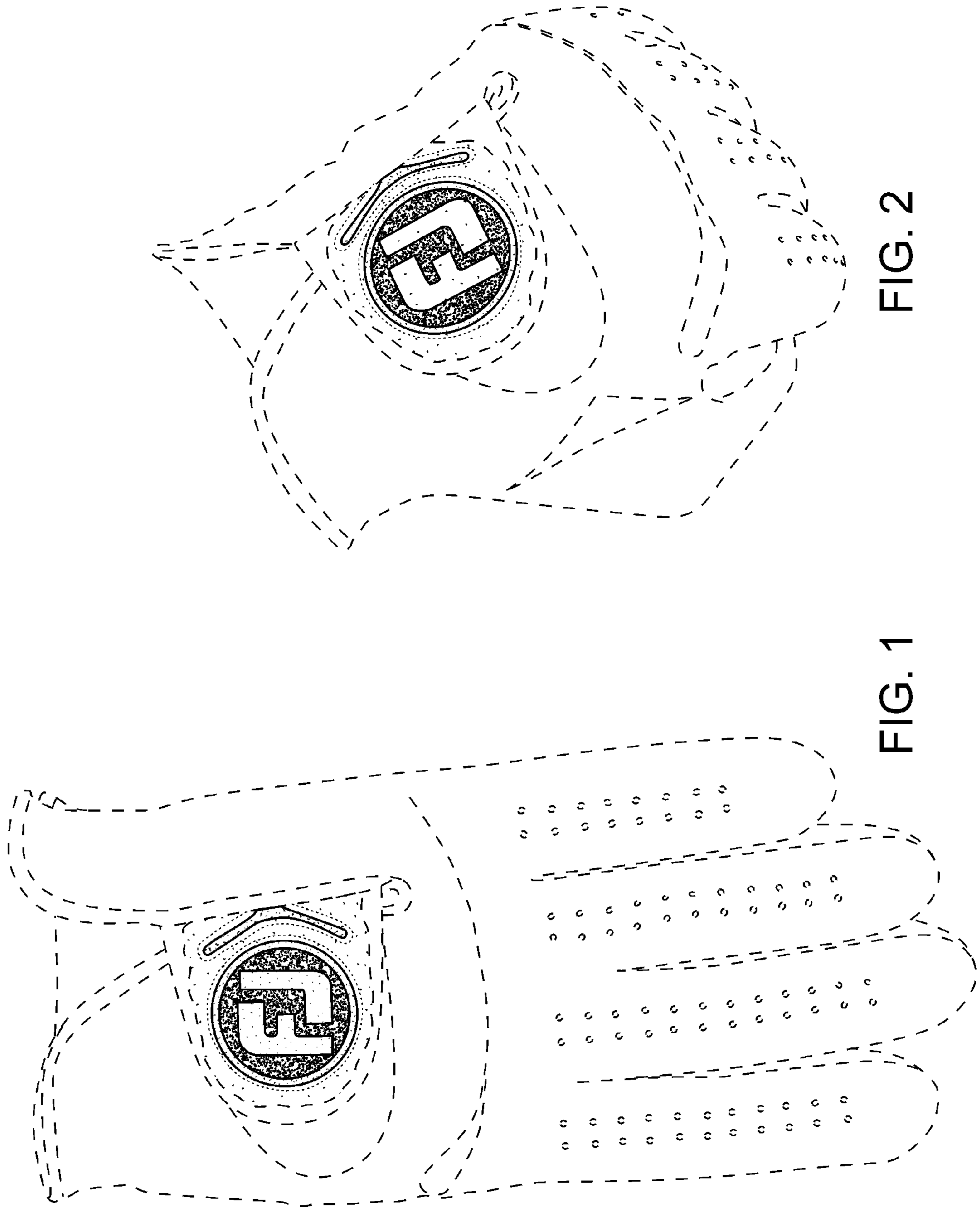
