DESCRIPTION

FIG. 1 is a perspective view of a cleaning sheet showing our new design;

FIG. 2 is a top view of the cleaning sheet;

FIG. 3 is a front view of the cleaning sheet;

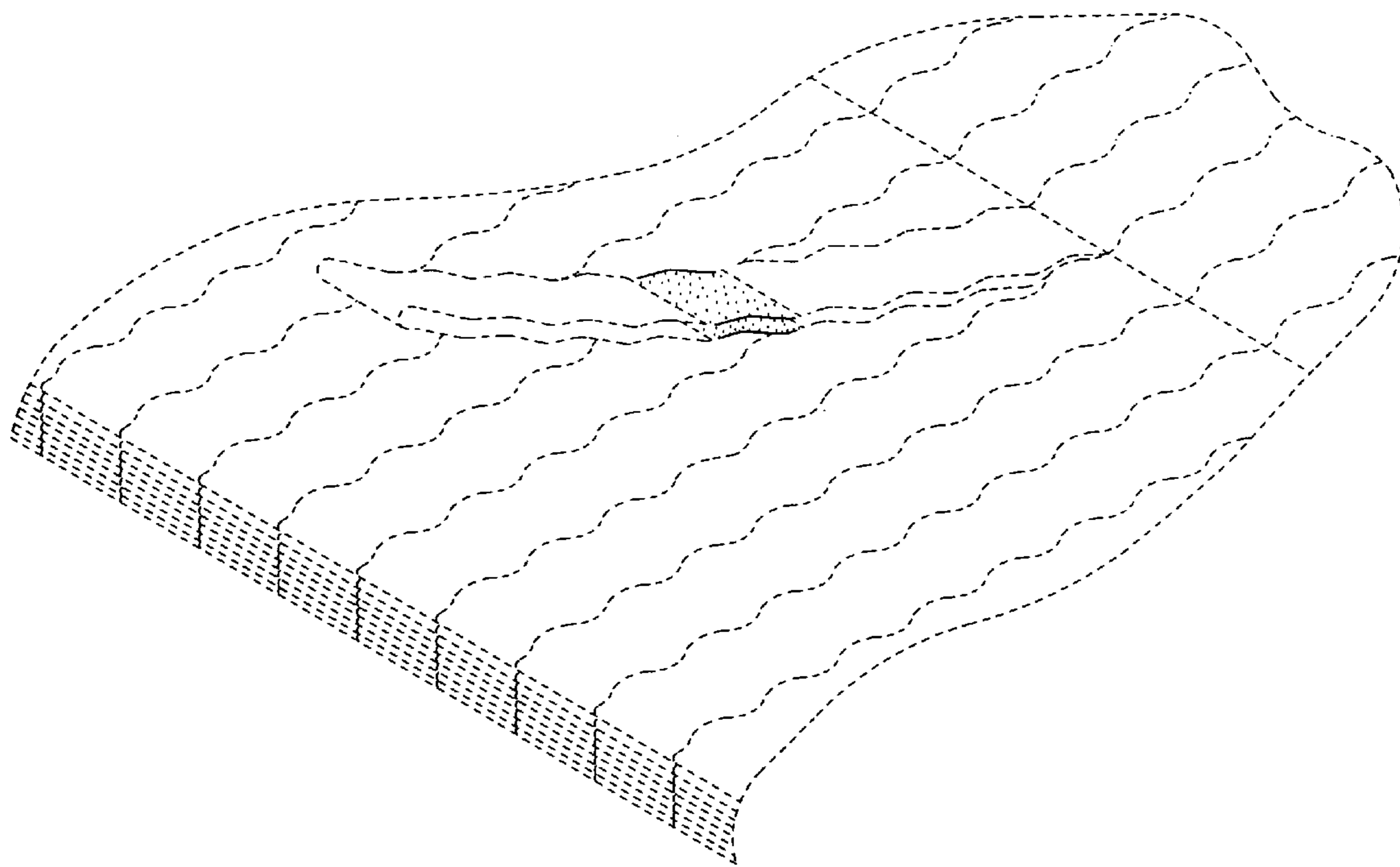
FIG. 4 is a right view of the cleaning sheet;

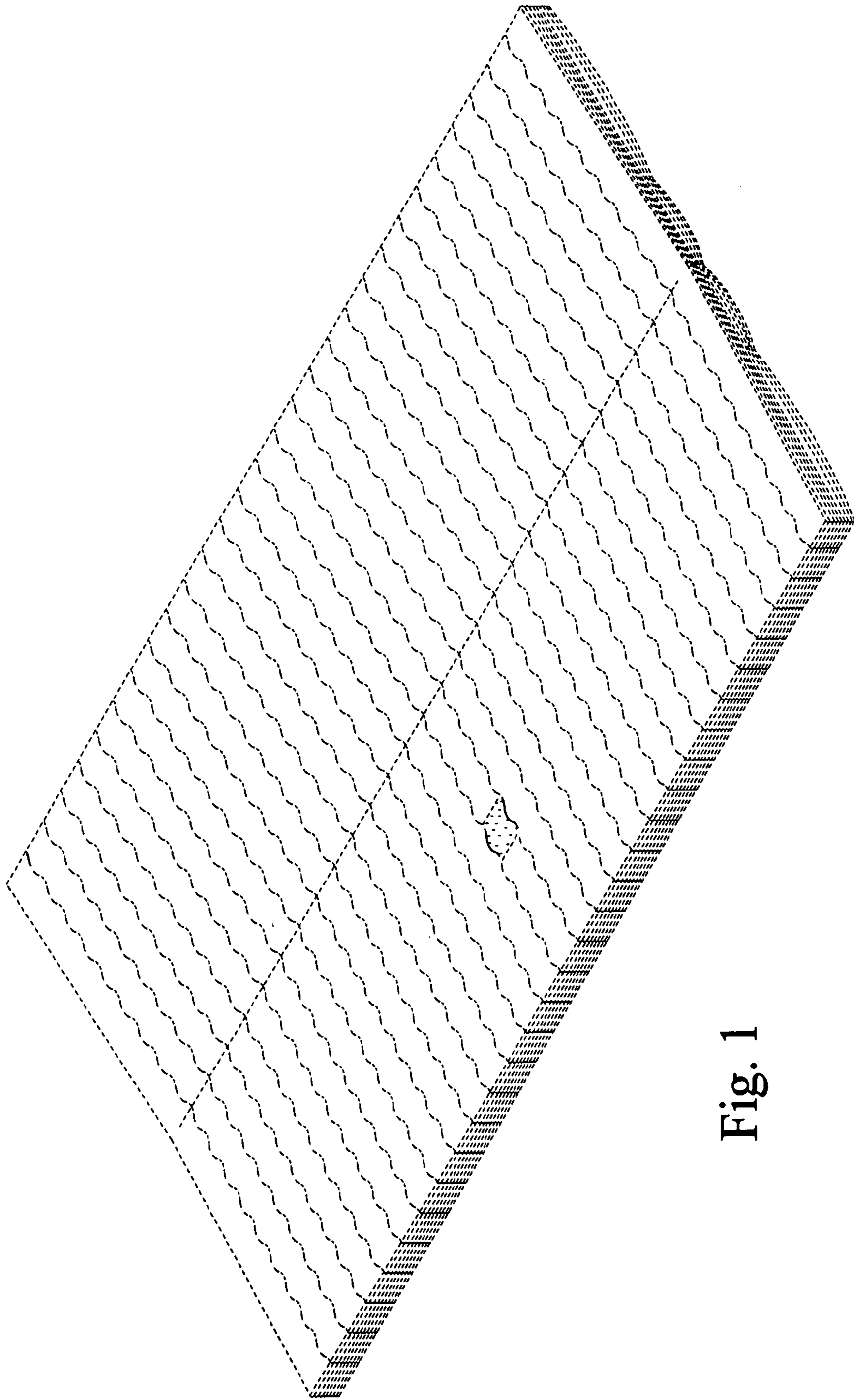

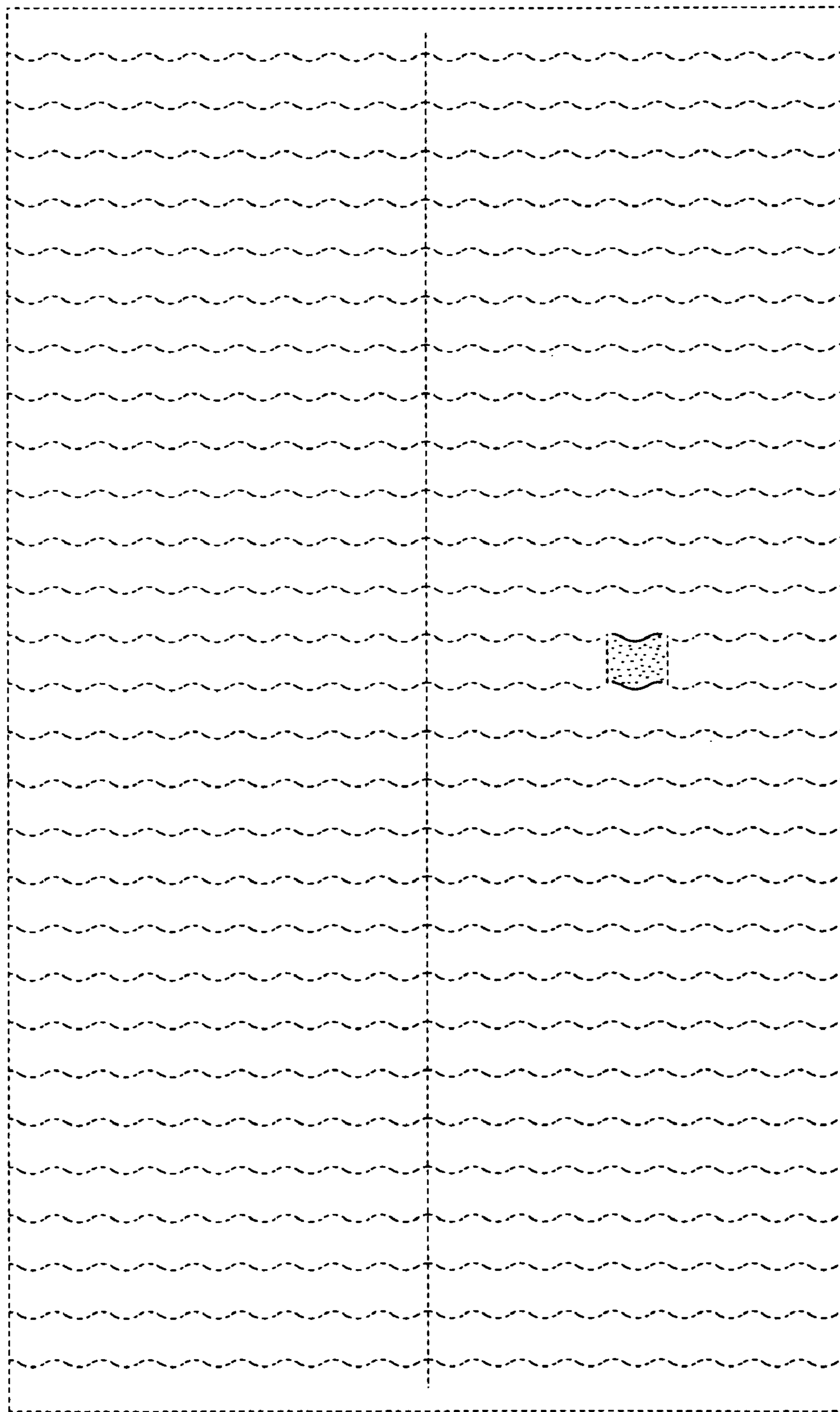

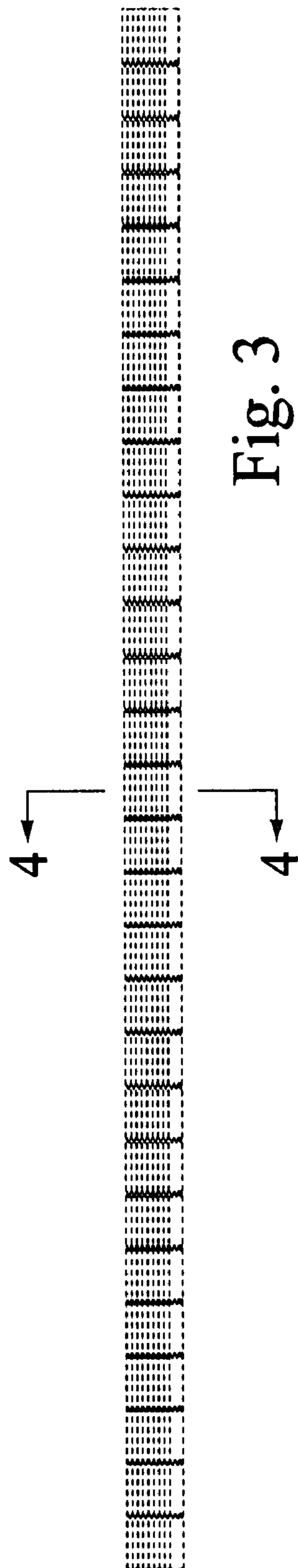

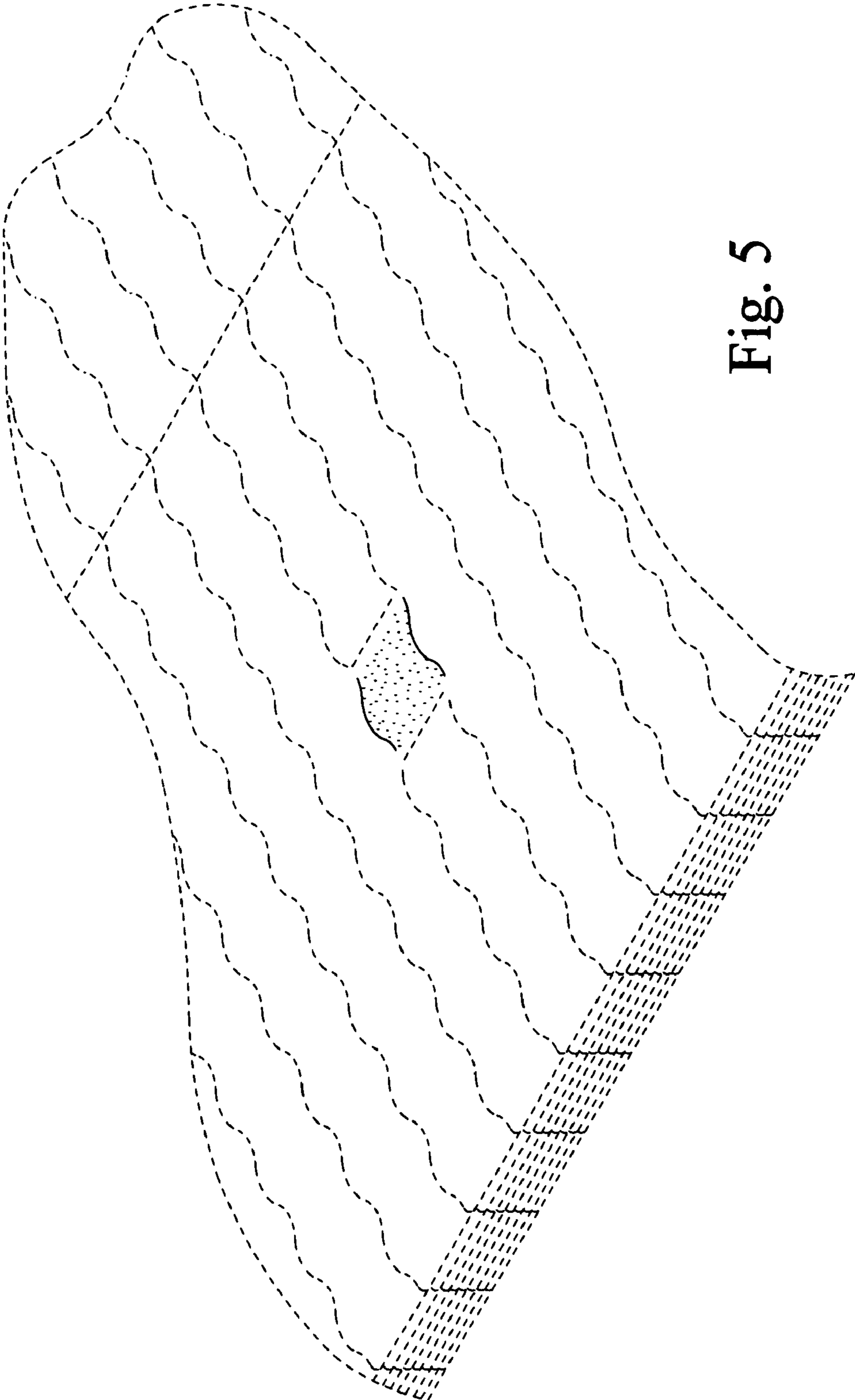

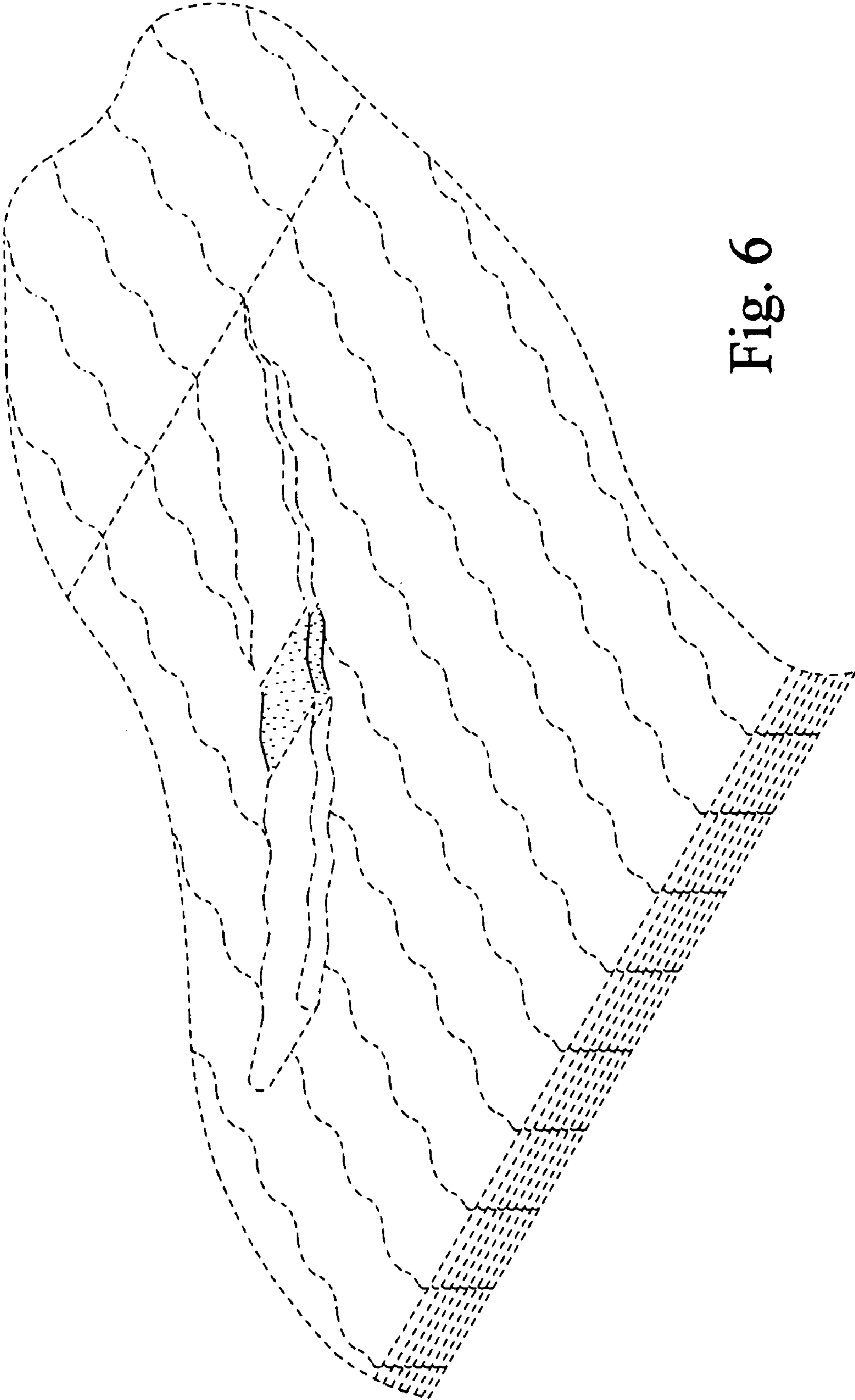
