DESCRIPTION

FIG. 1 is a side elevational view of a wheelbarrow extension showing our new design;
 FIG. 2 is a right side perspective view thereof;
 FIG. 3 is a side elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a rear elevational view thereof; and,
 FIG. 7 is a bottom plan view thereof.

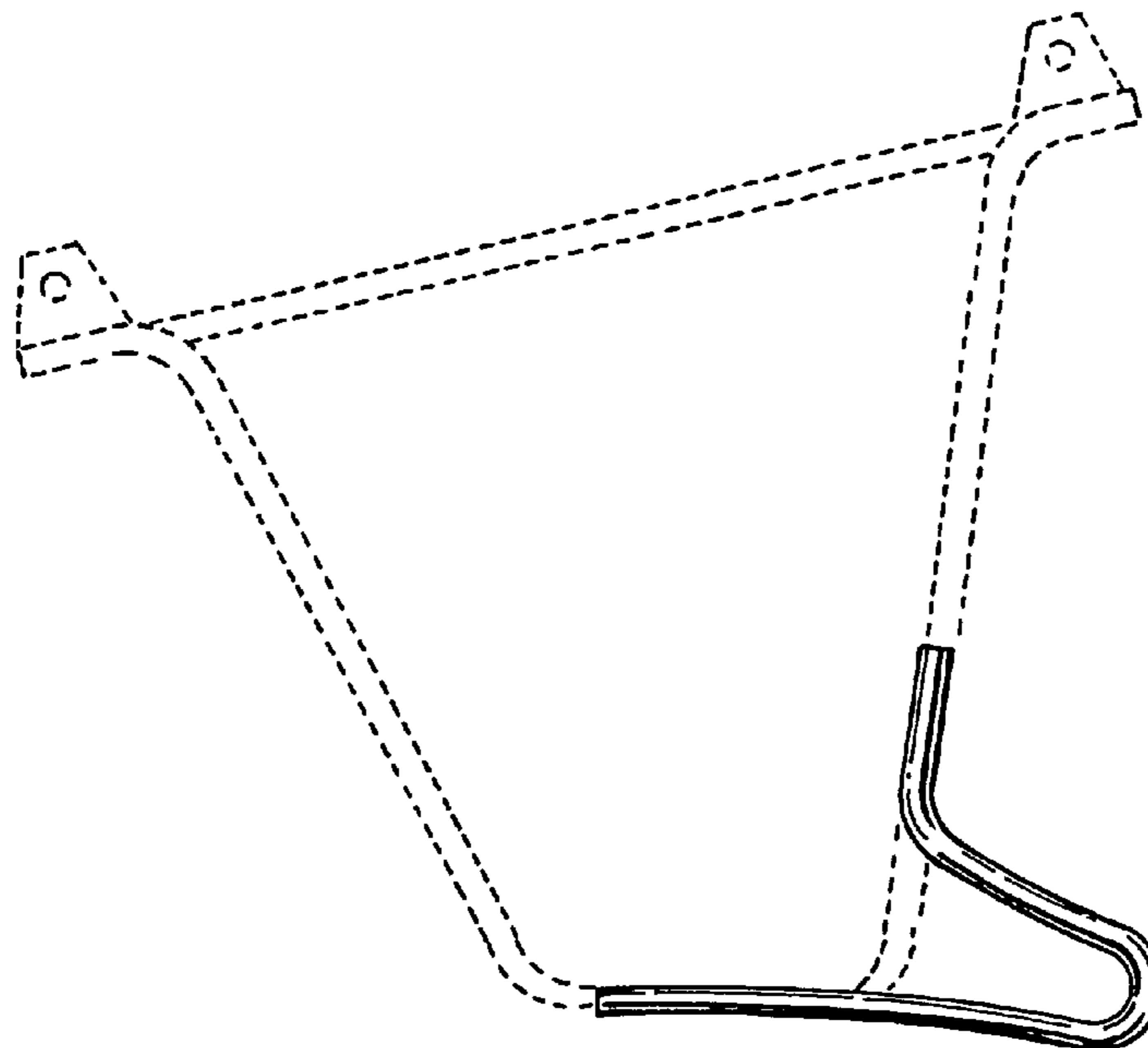

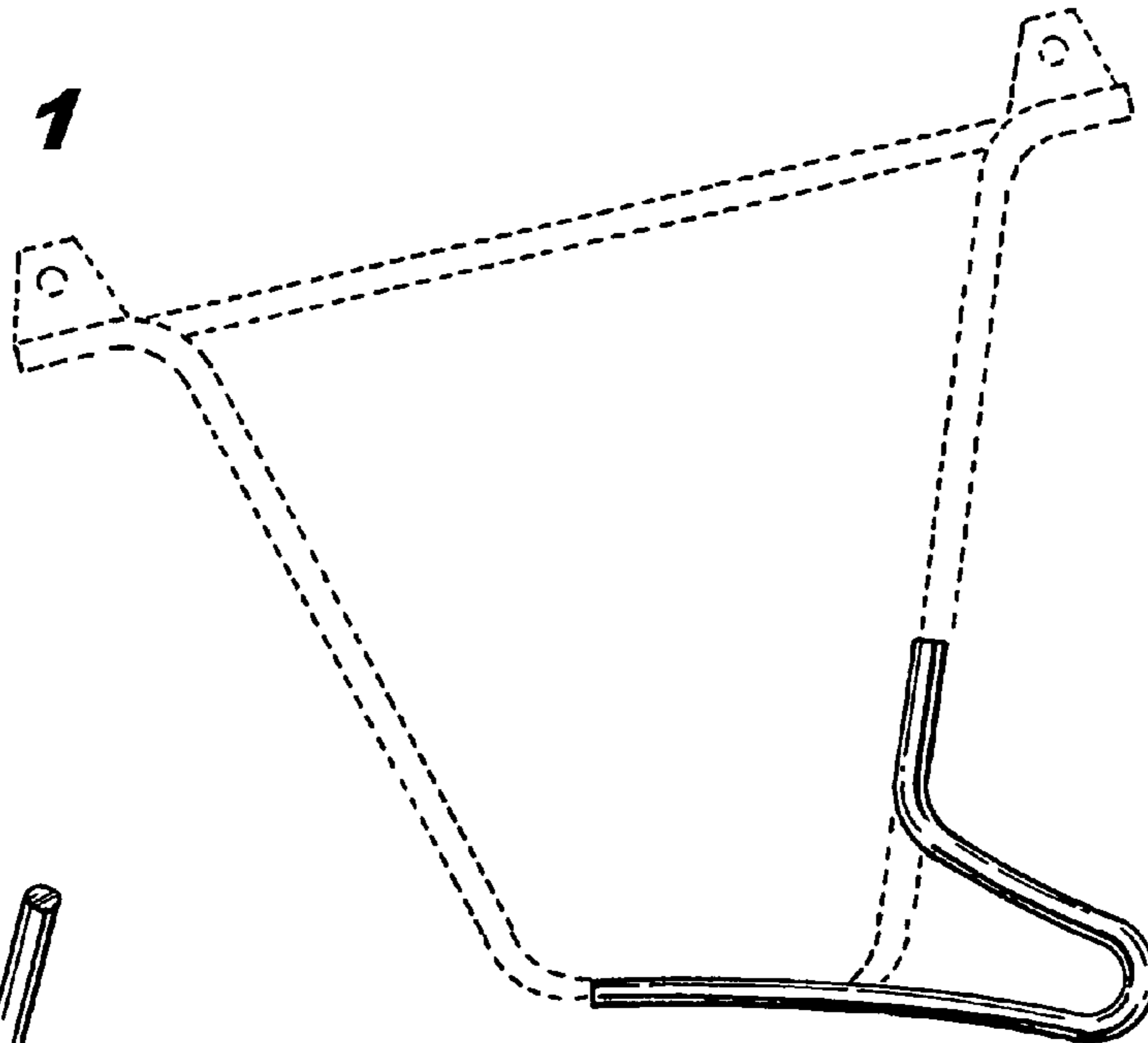

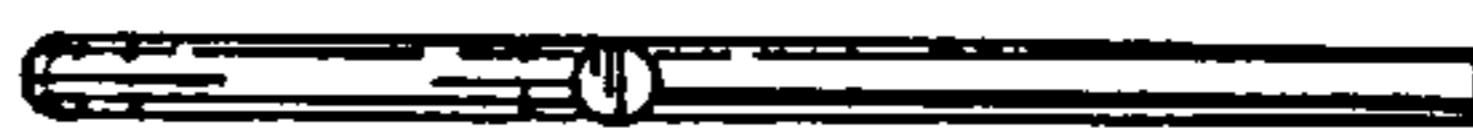
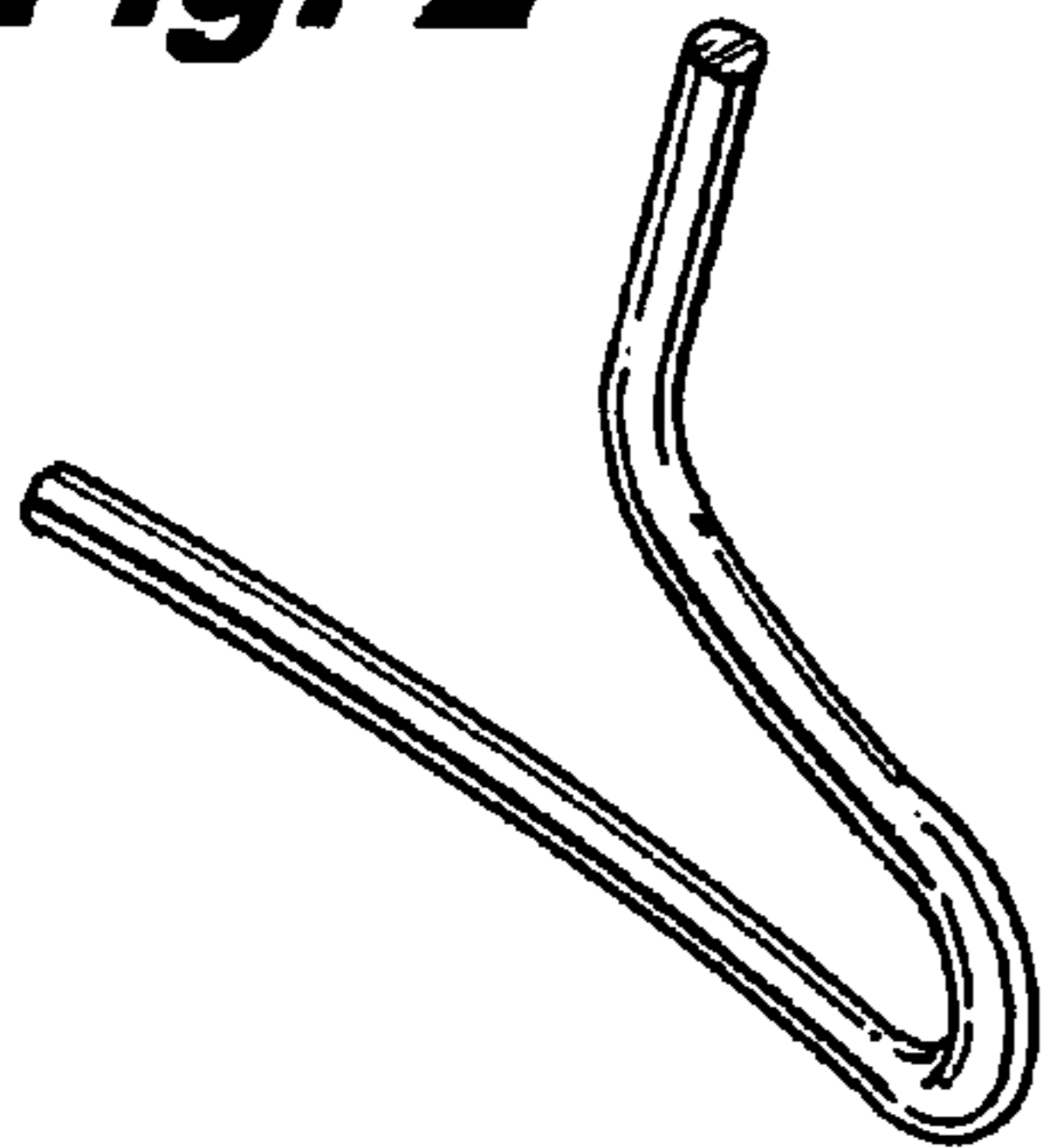

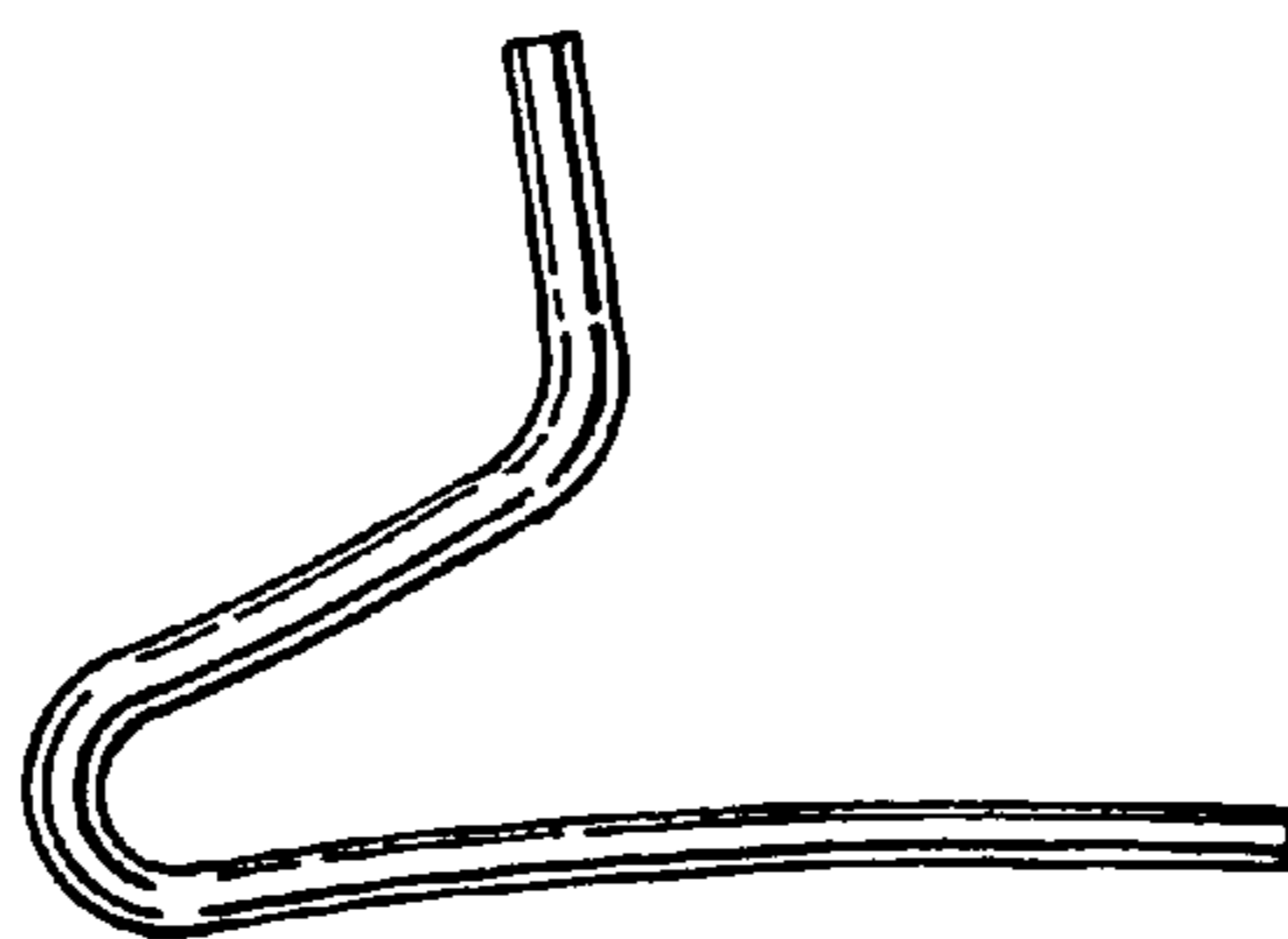

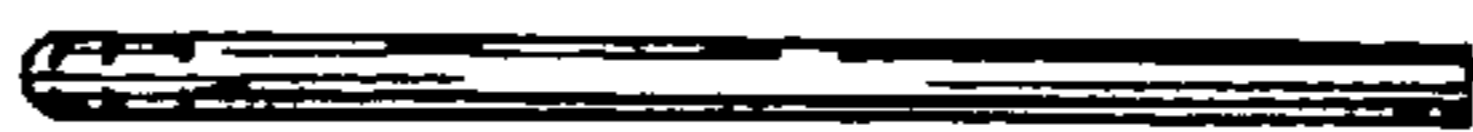
