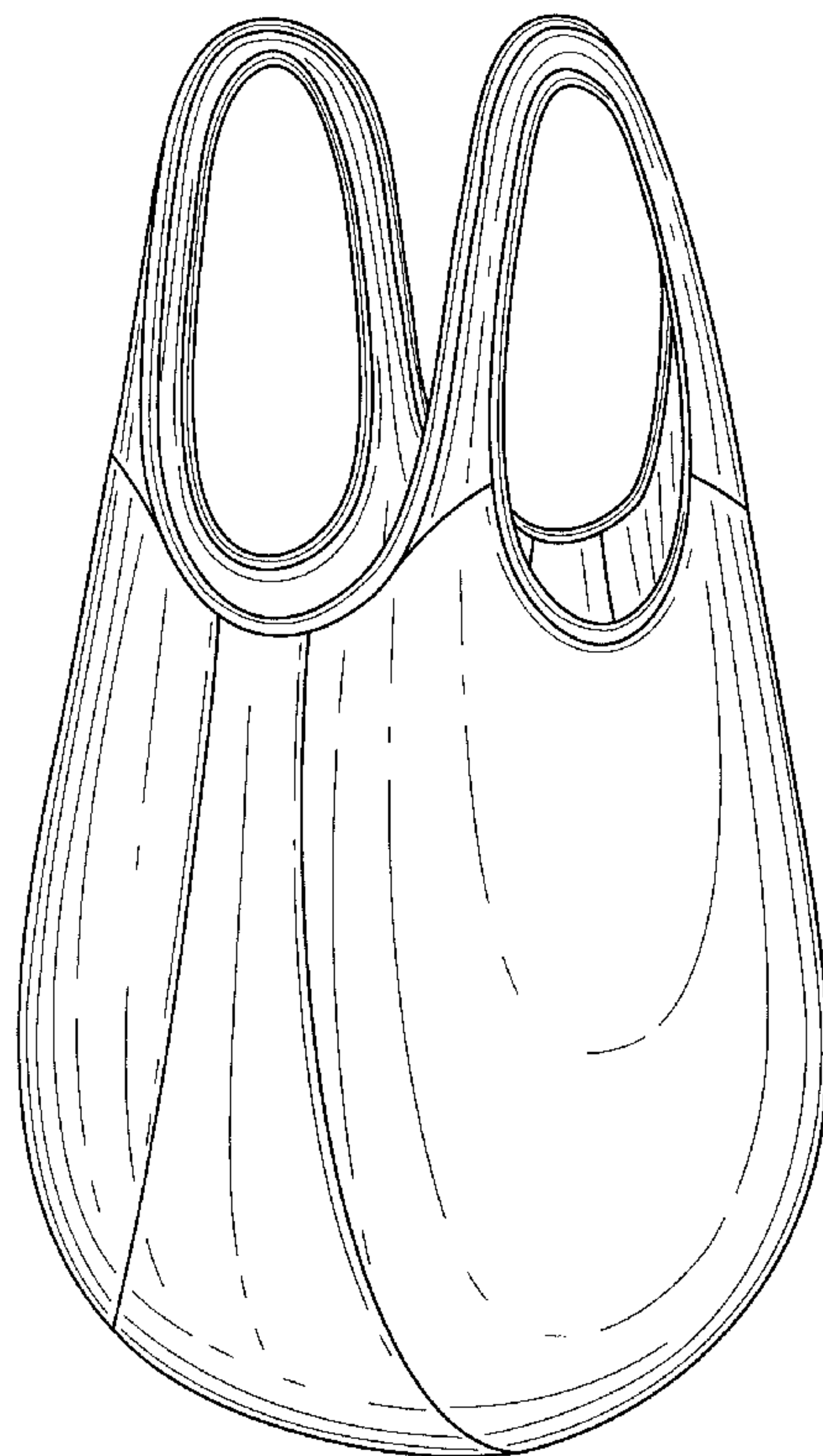
FIG. 1 is a perspective view of the bag according to my invention;

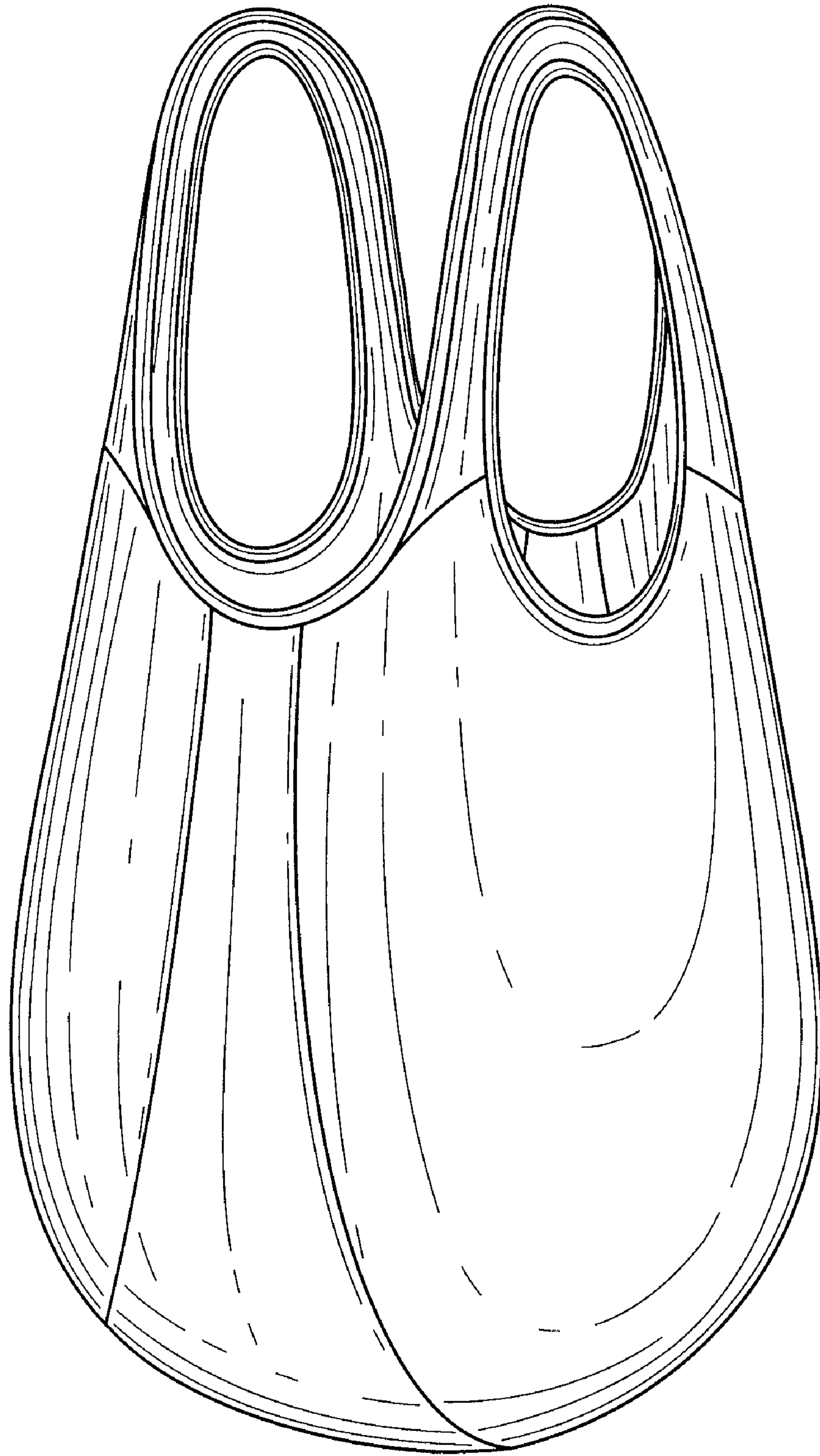

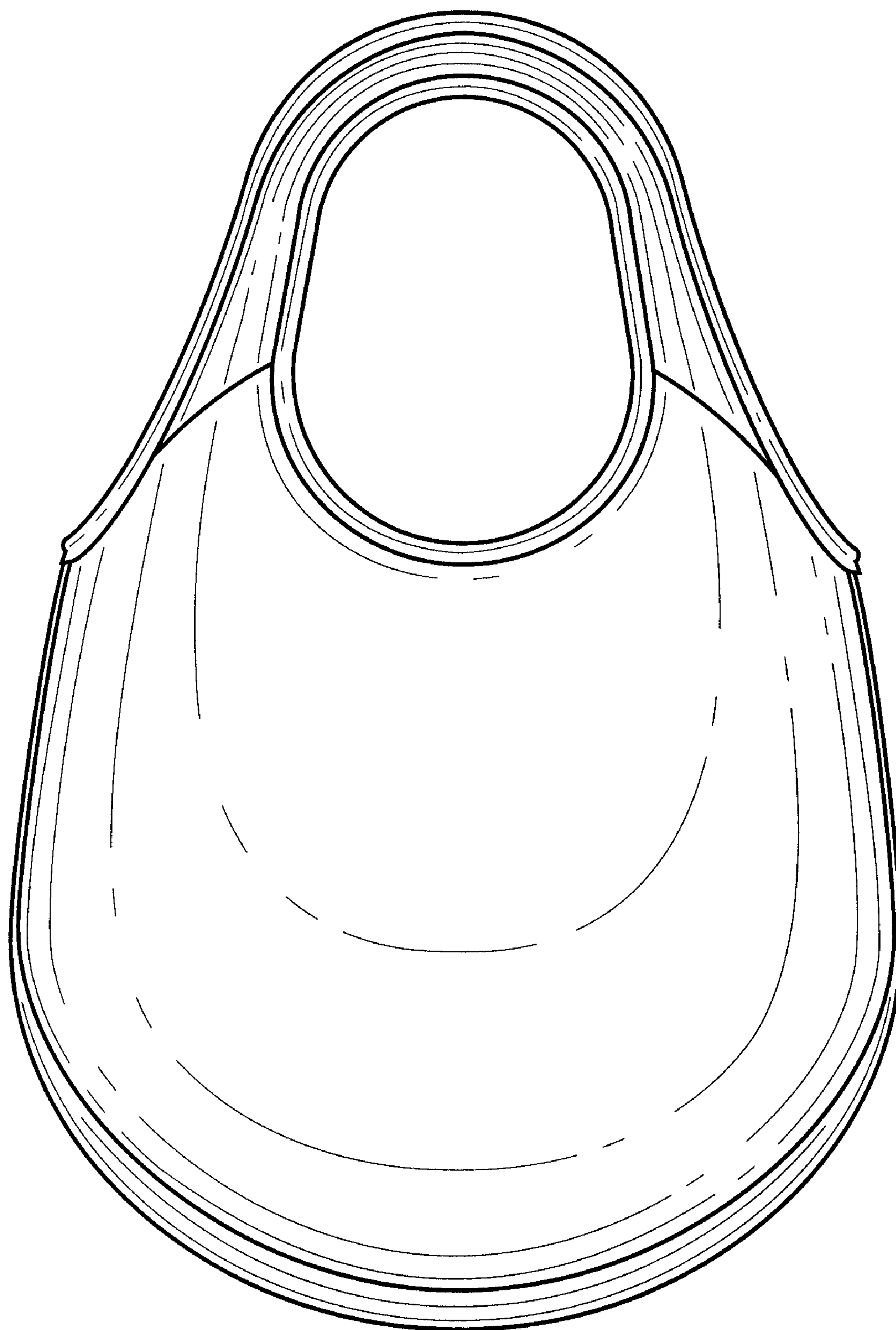

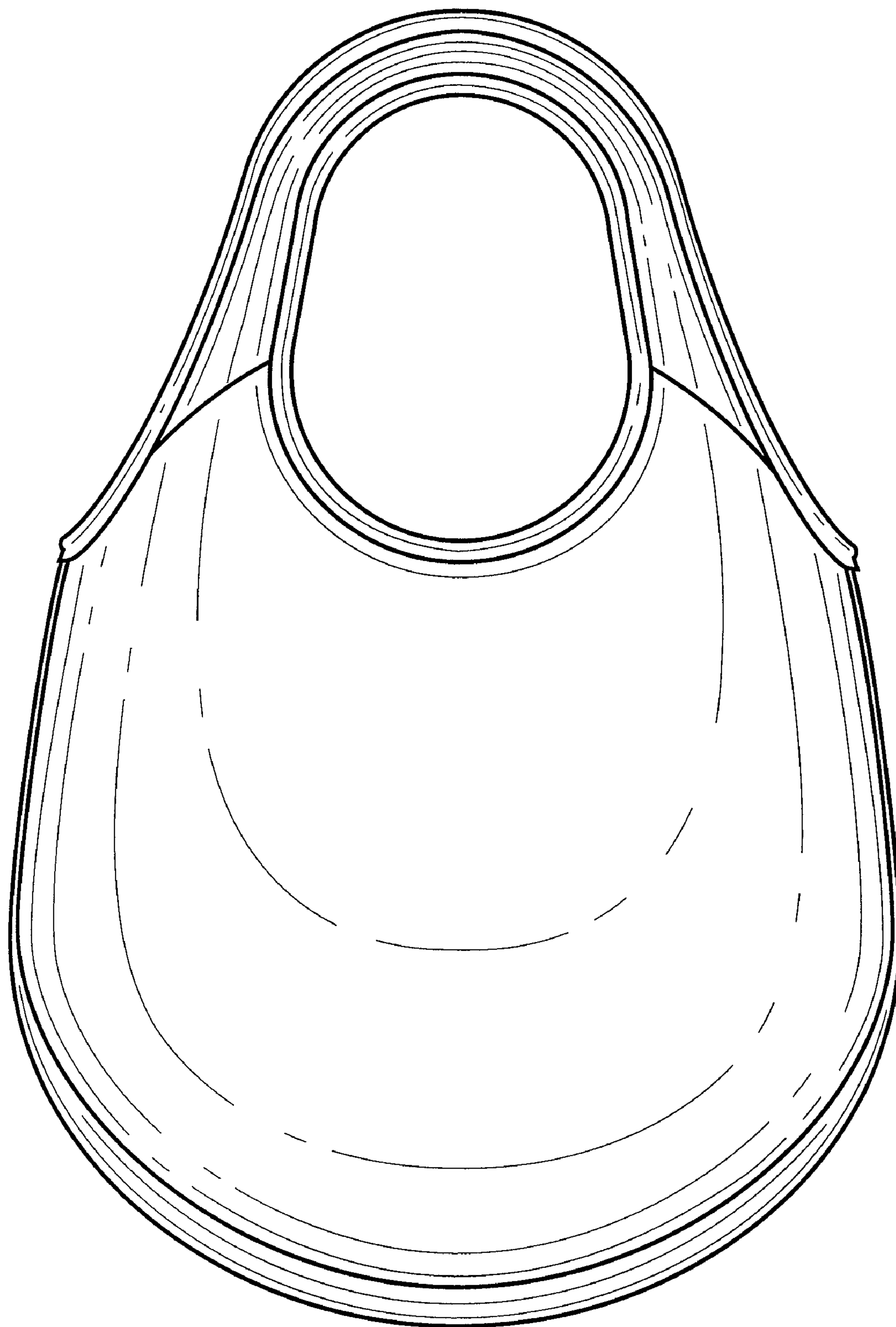

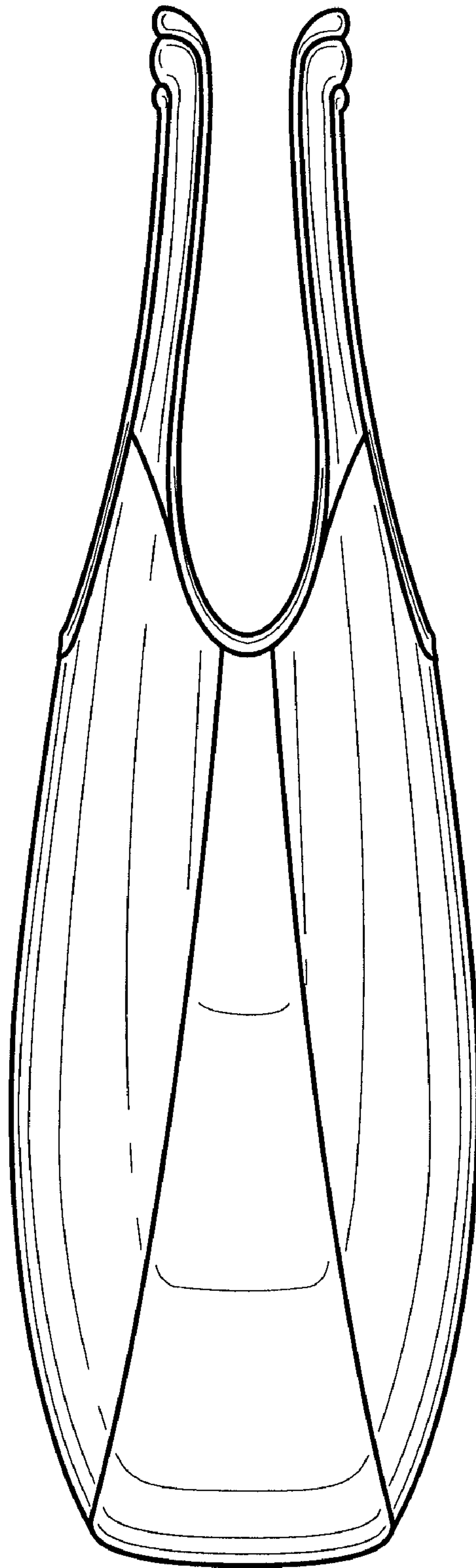

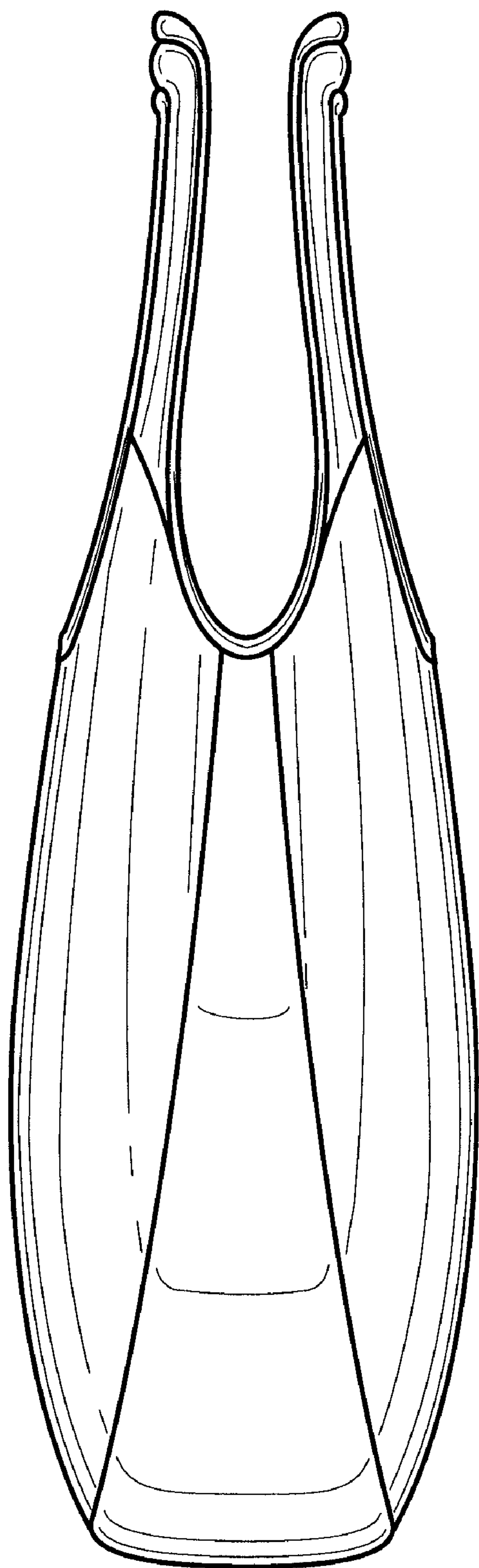

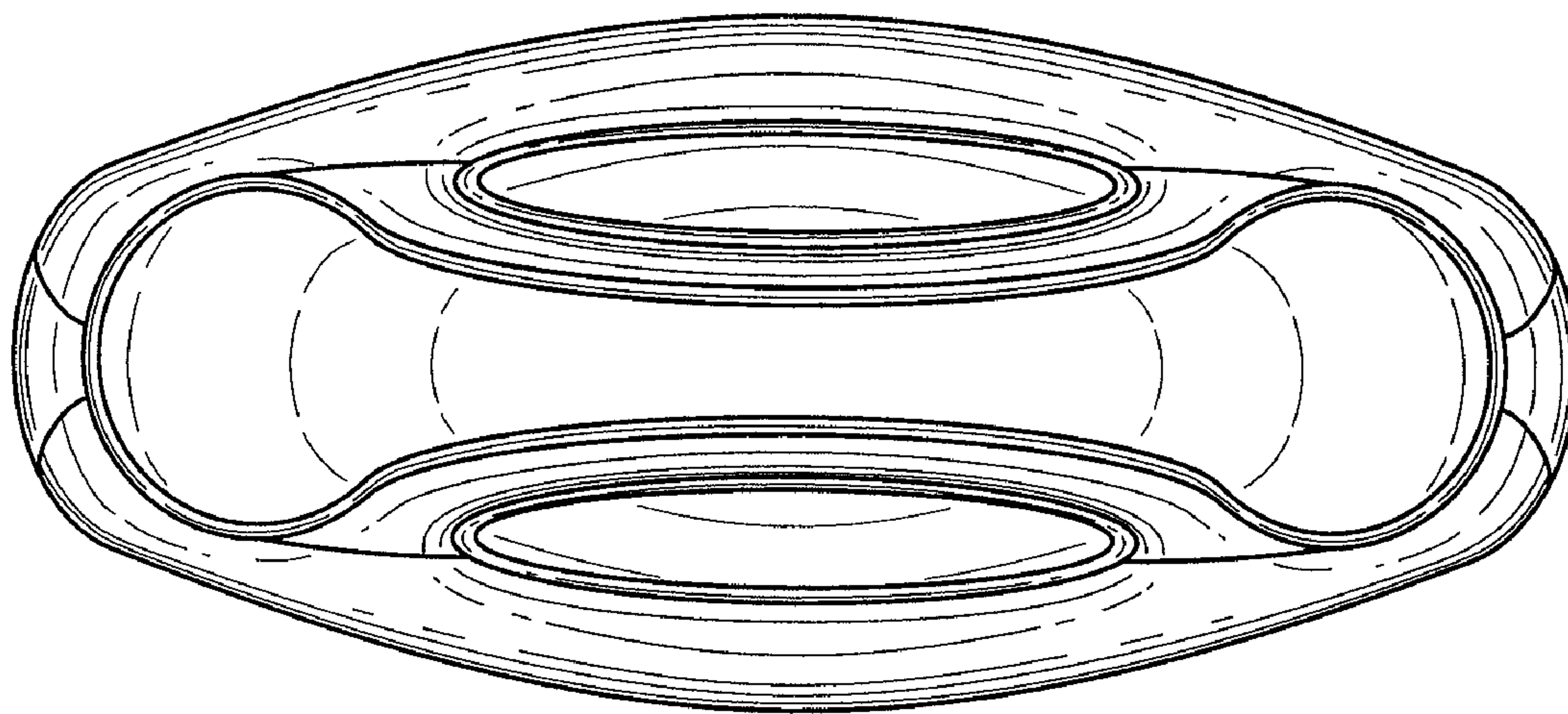

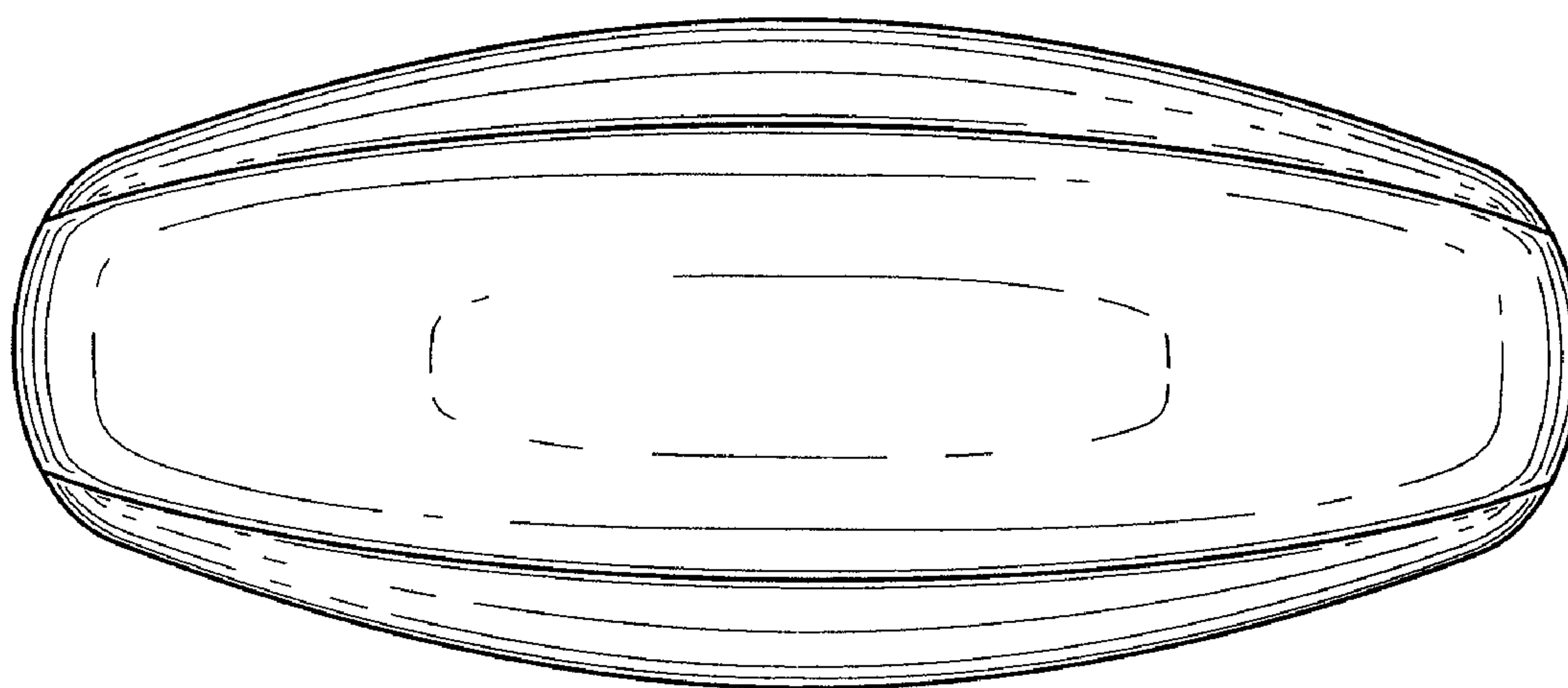
