The ornamental design for an aircraft seat, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an aircraft seat showing our new design;

FIG. 2 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

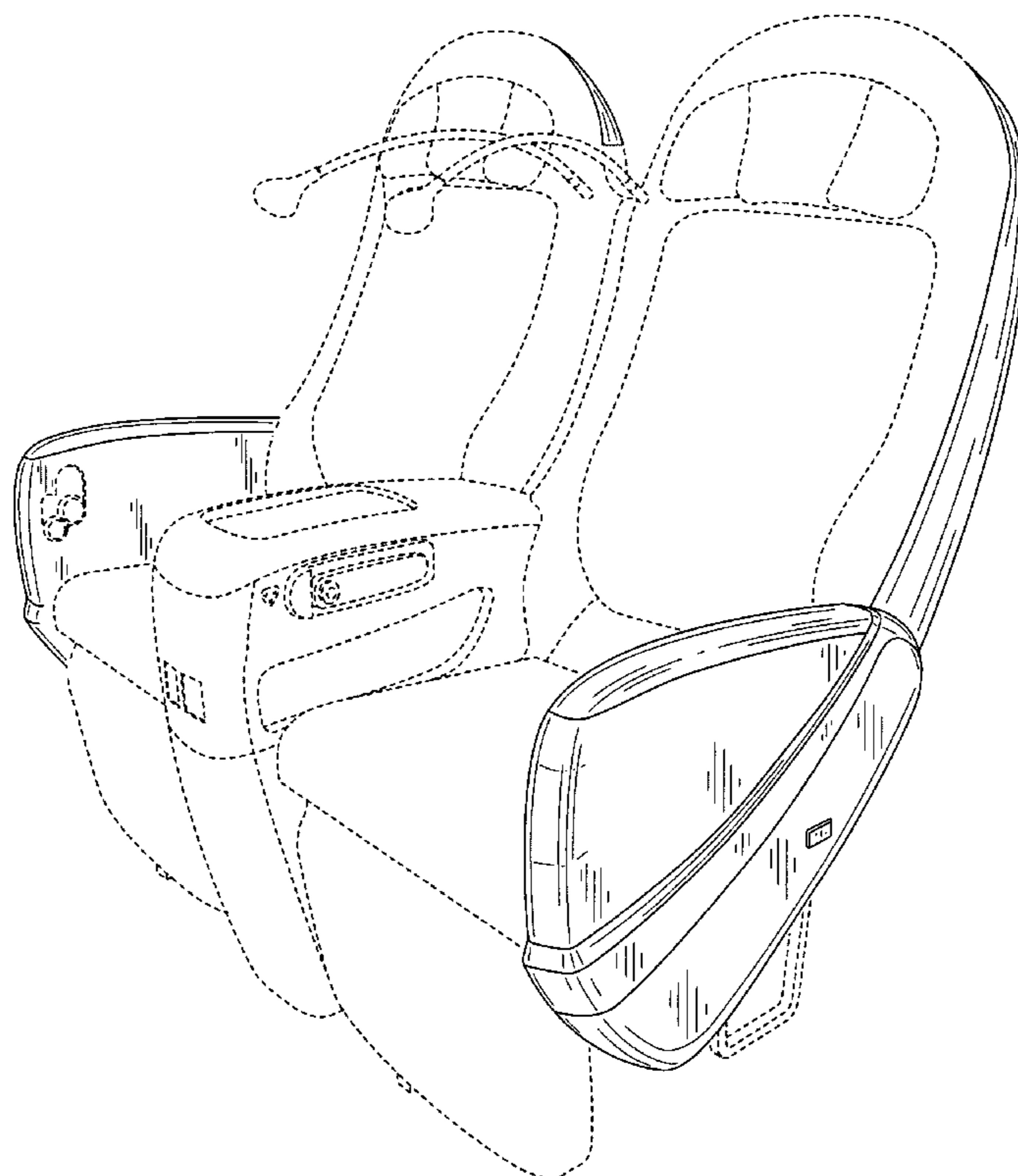

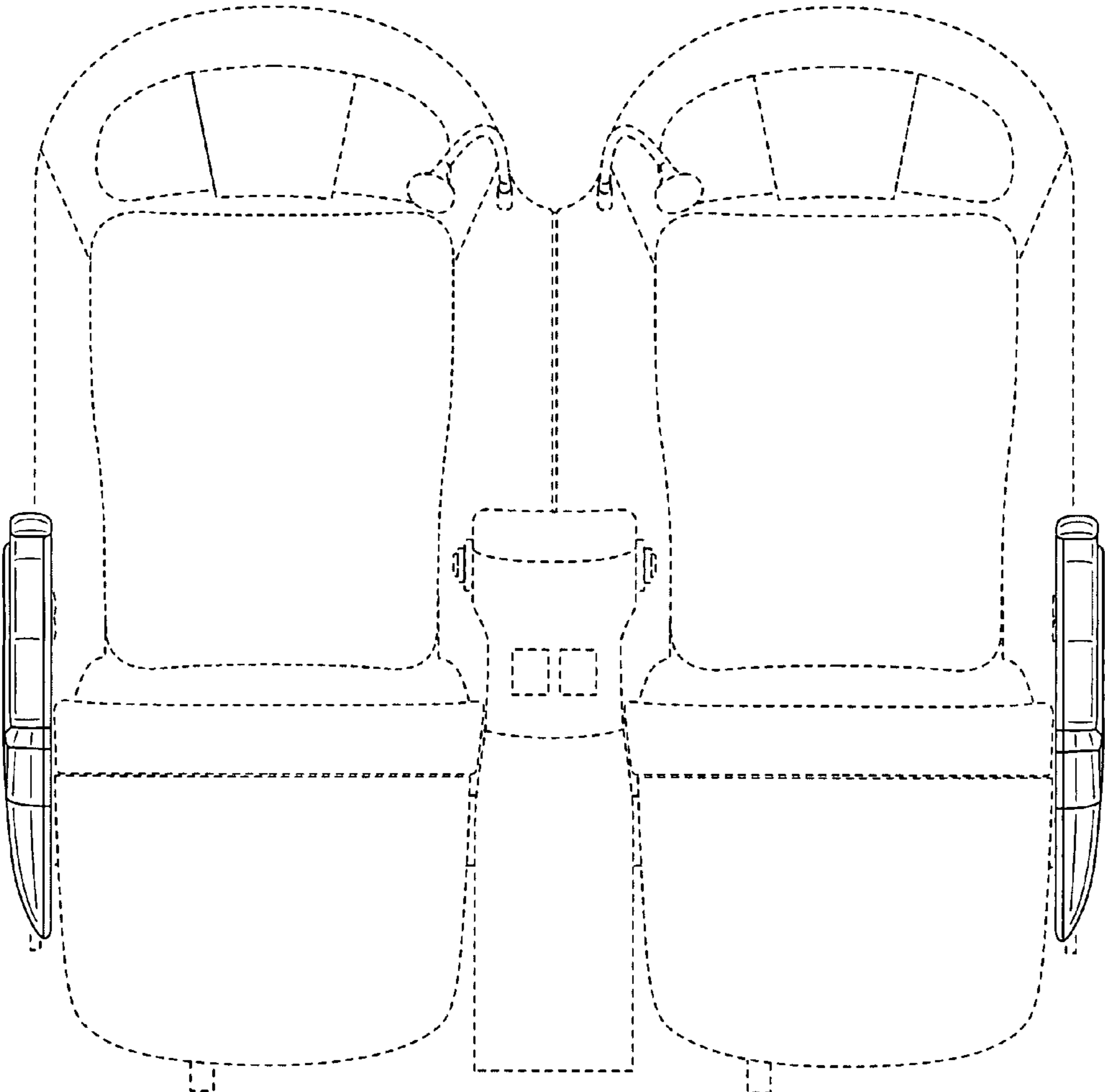

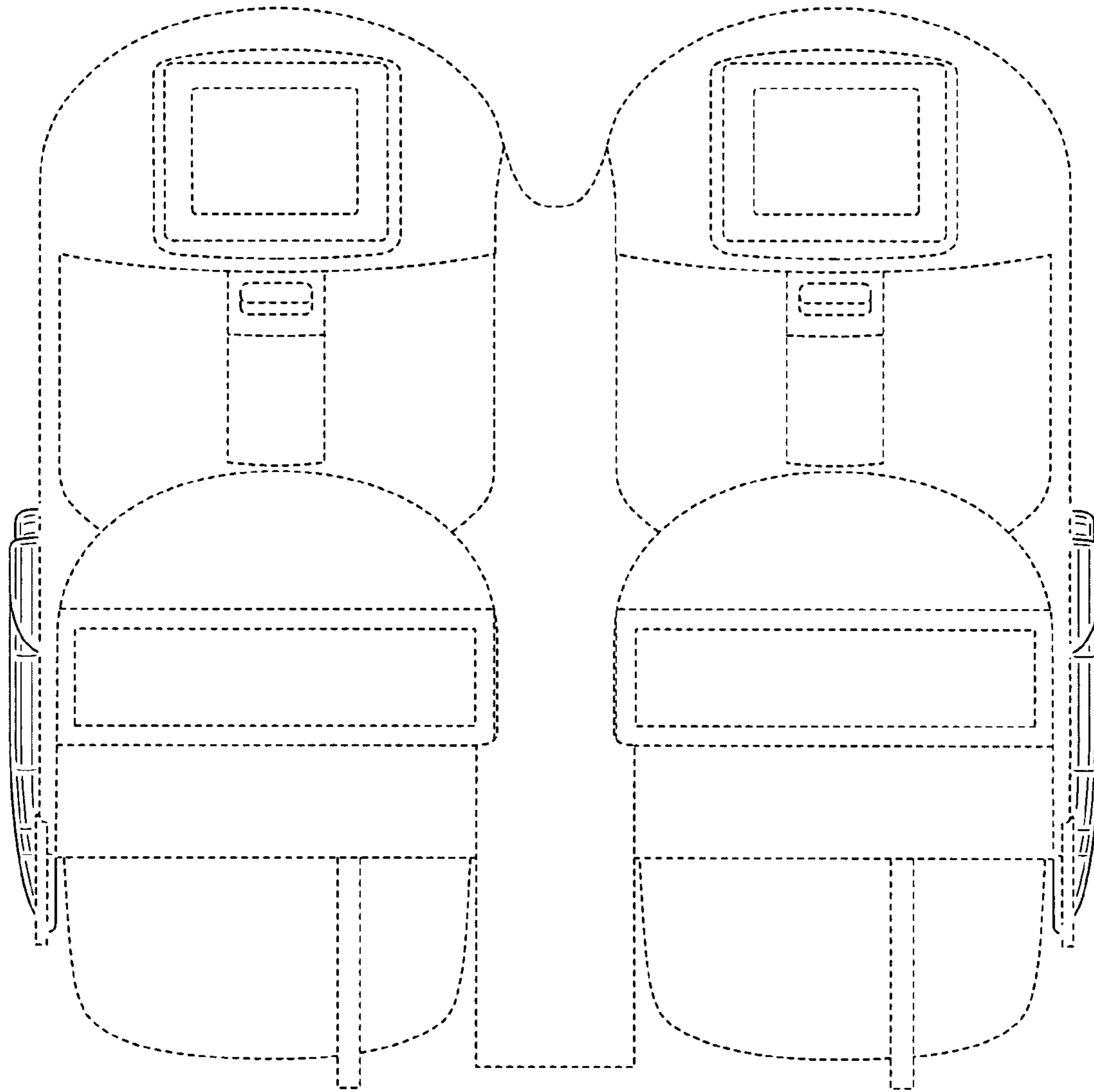

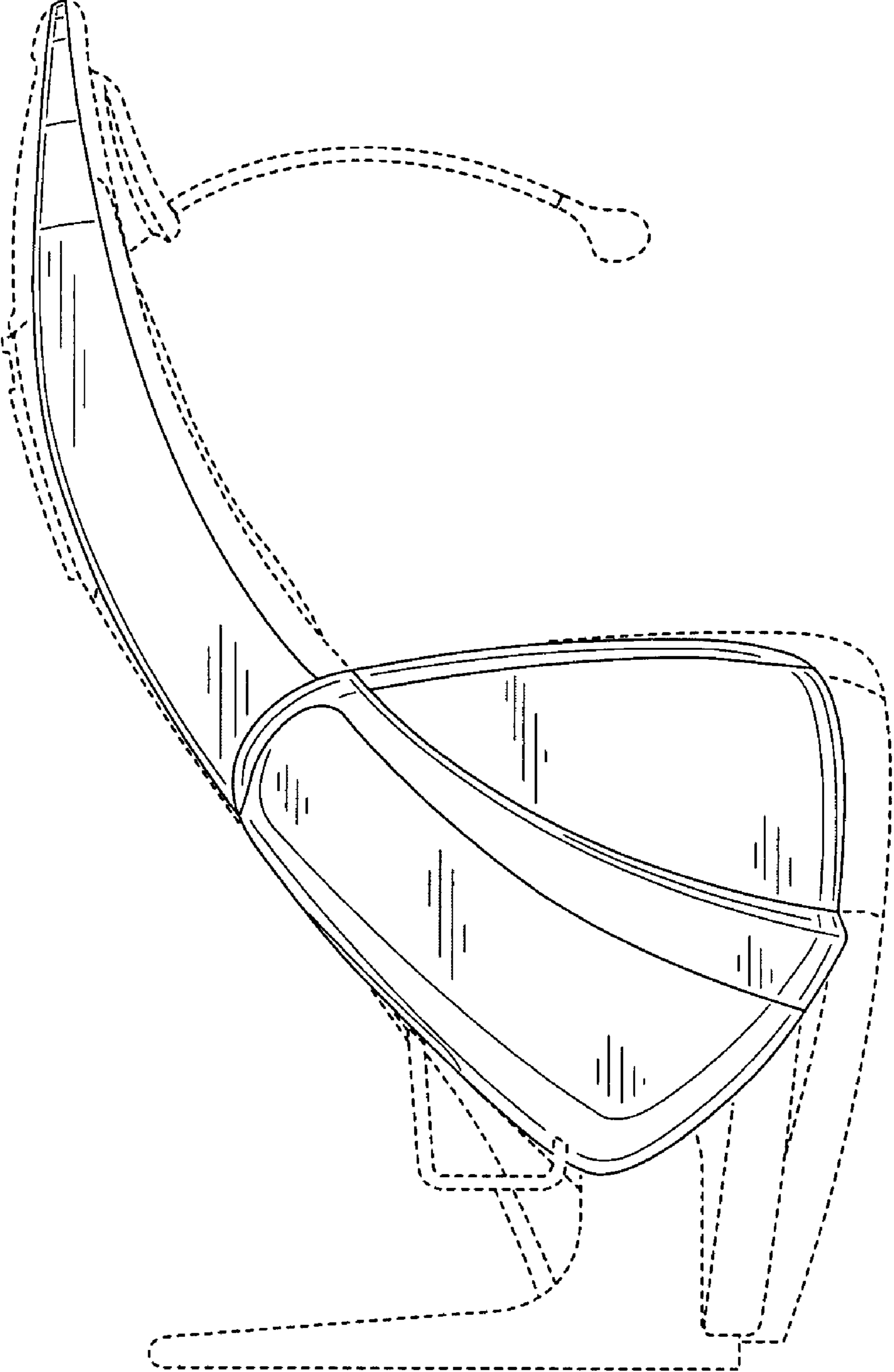

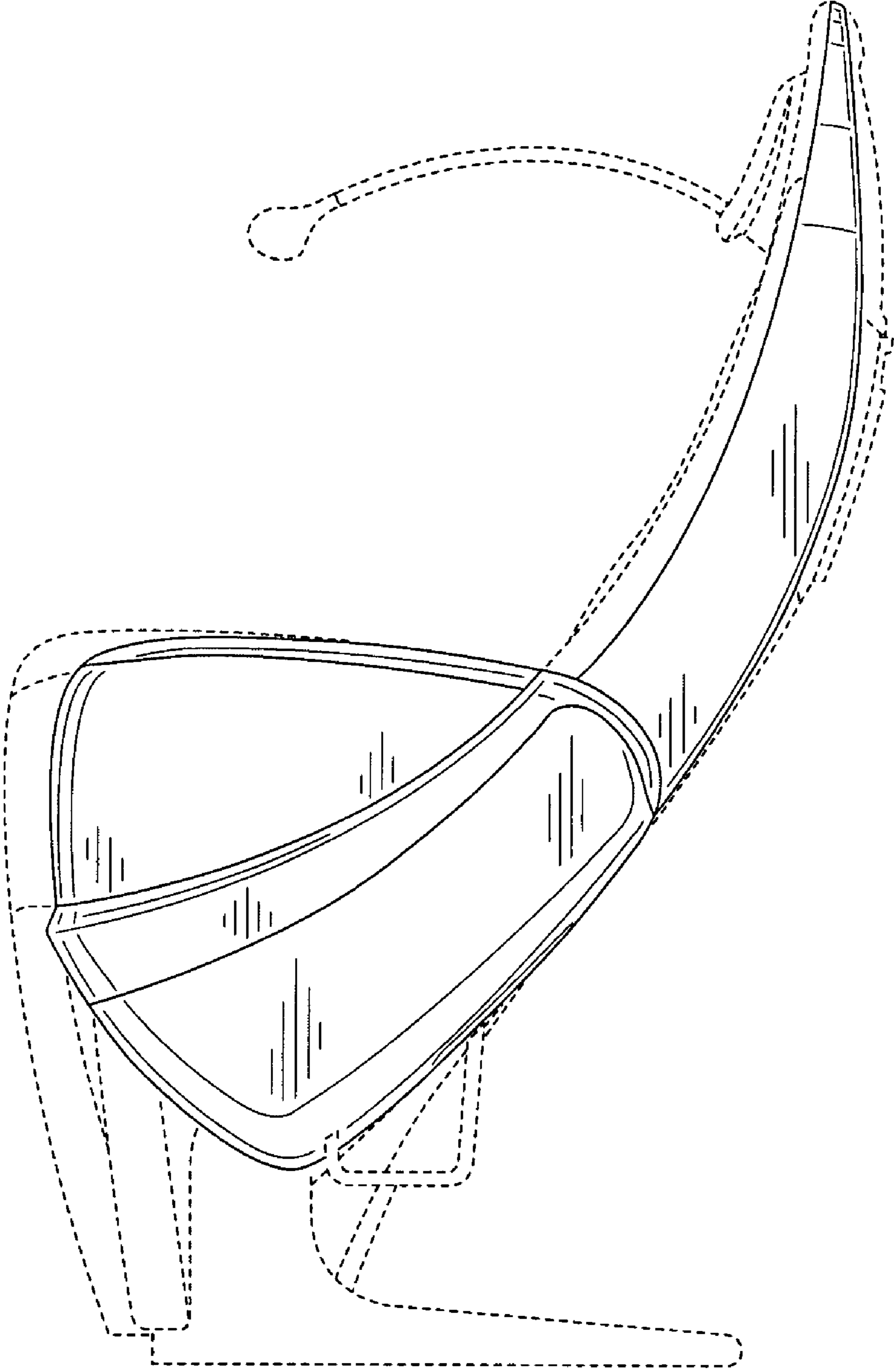

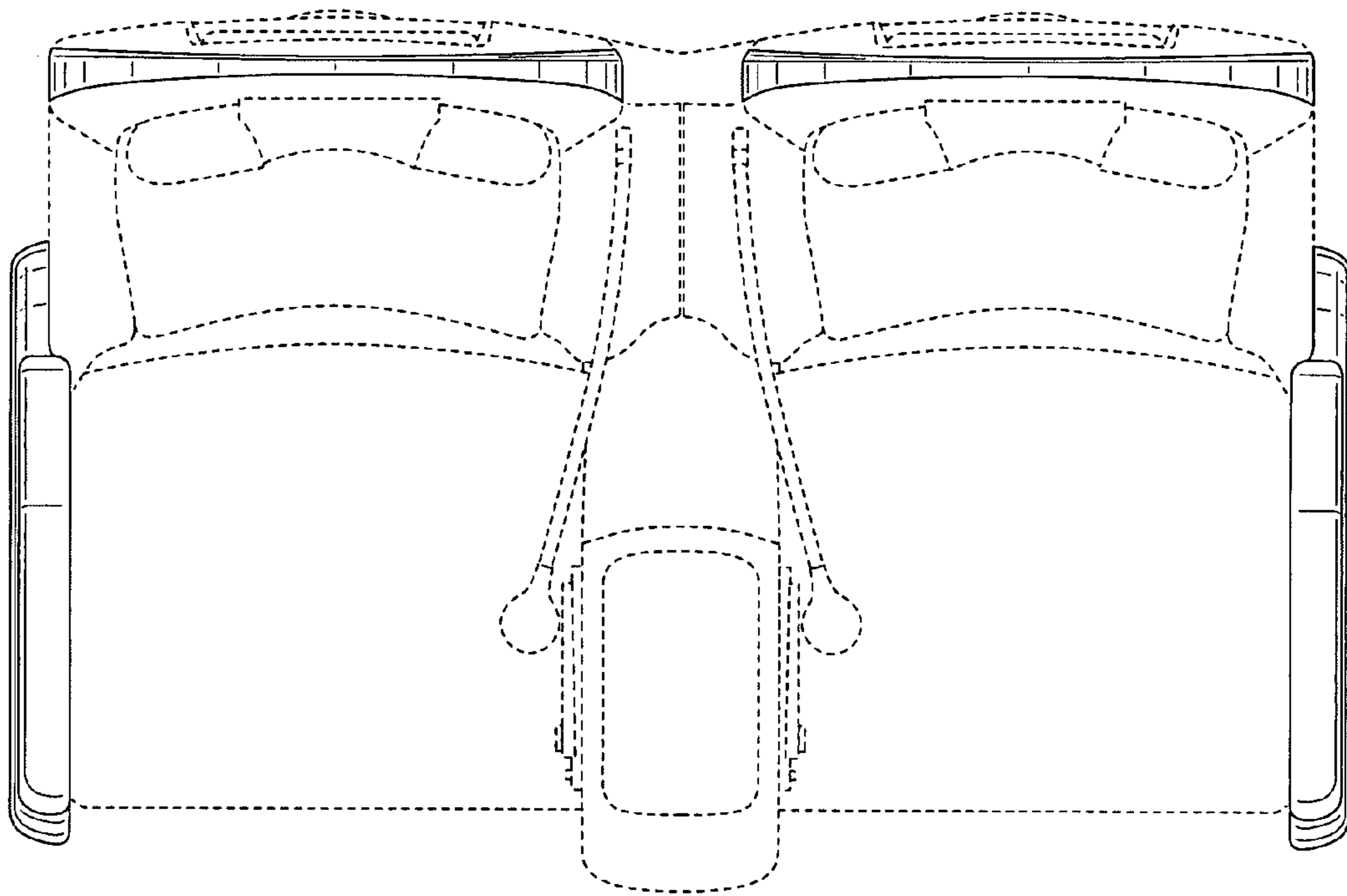

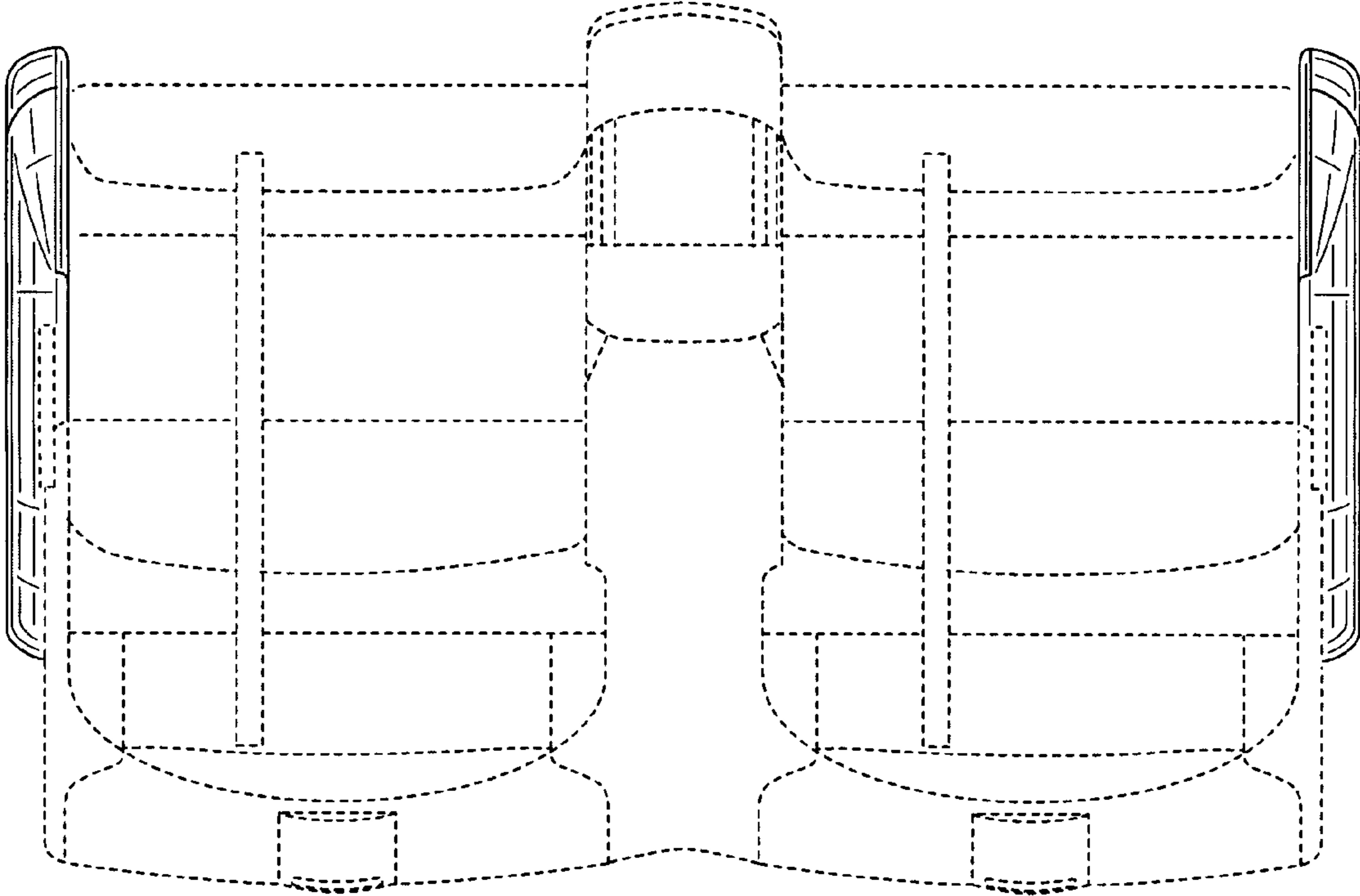
