FIG. 7 is a bottom plan view of the swing rack flip book, in a closed position;

FIG. 8 is a bottom plan view of the swing rack flip book, in an open position;

FIG. 9 is a top plan view of the swing rack flip book, in a closed position; and,

FIG. 10 is a top plan view of the swing rack flip book, in an open position.

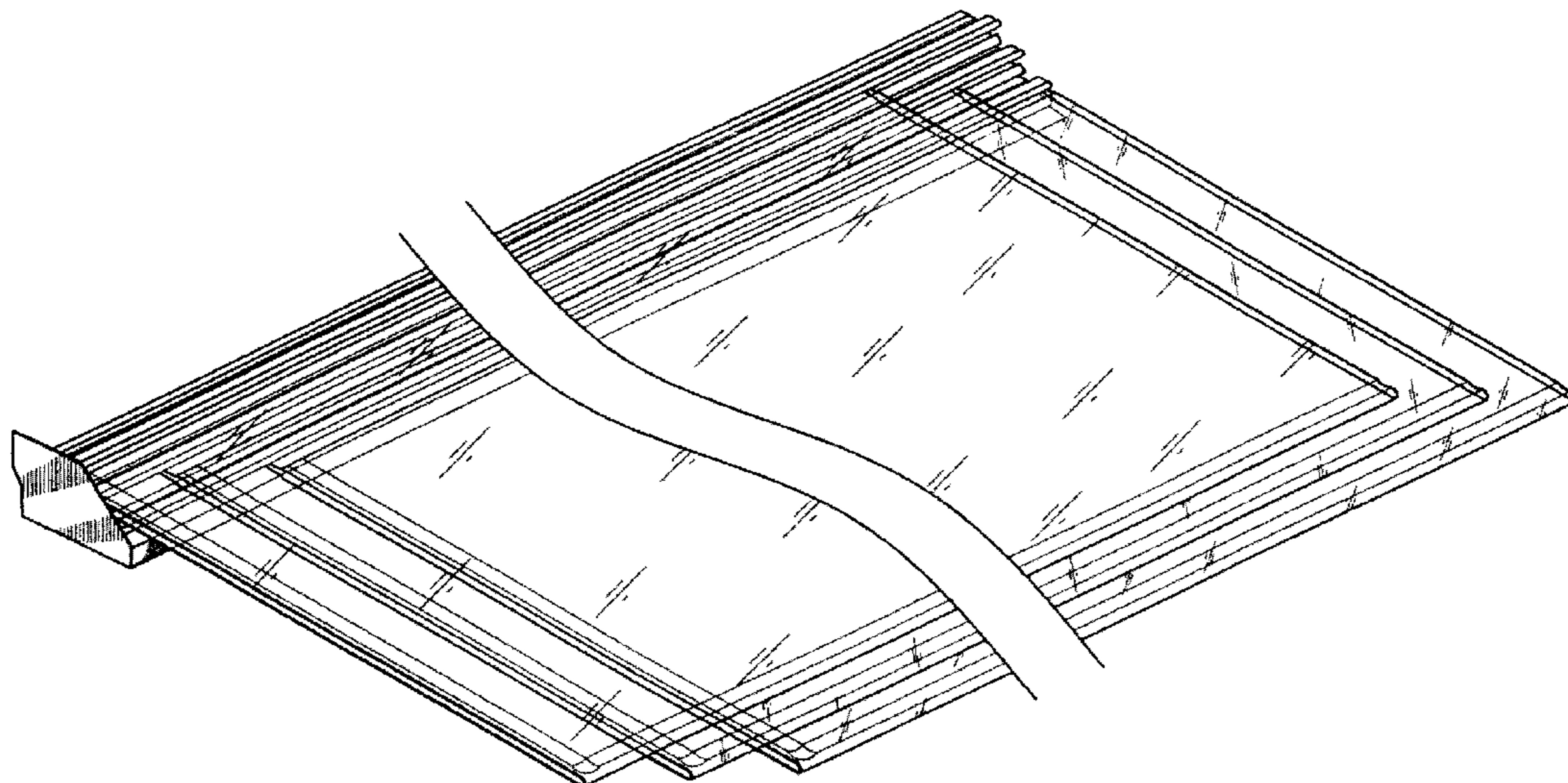

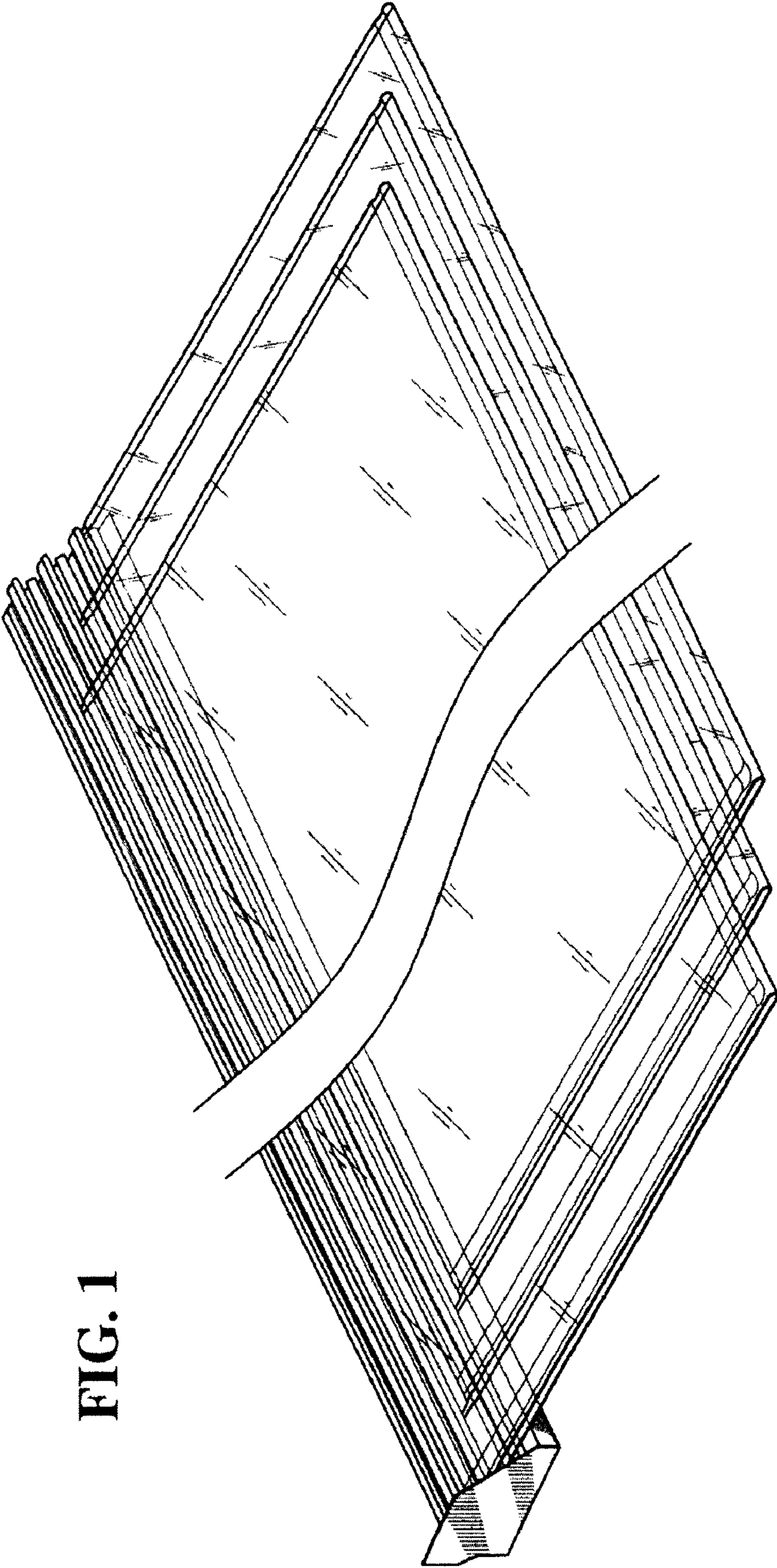

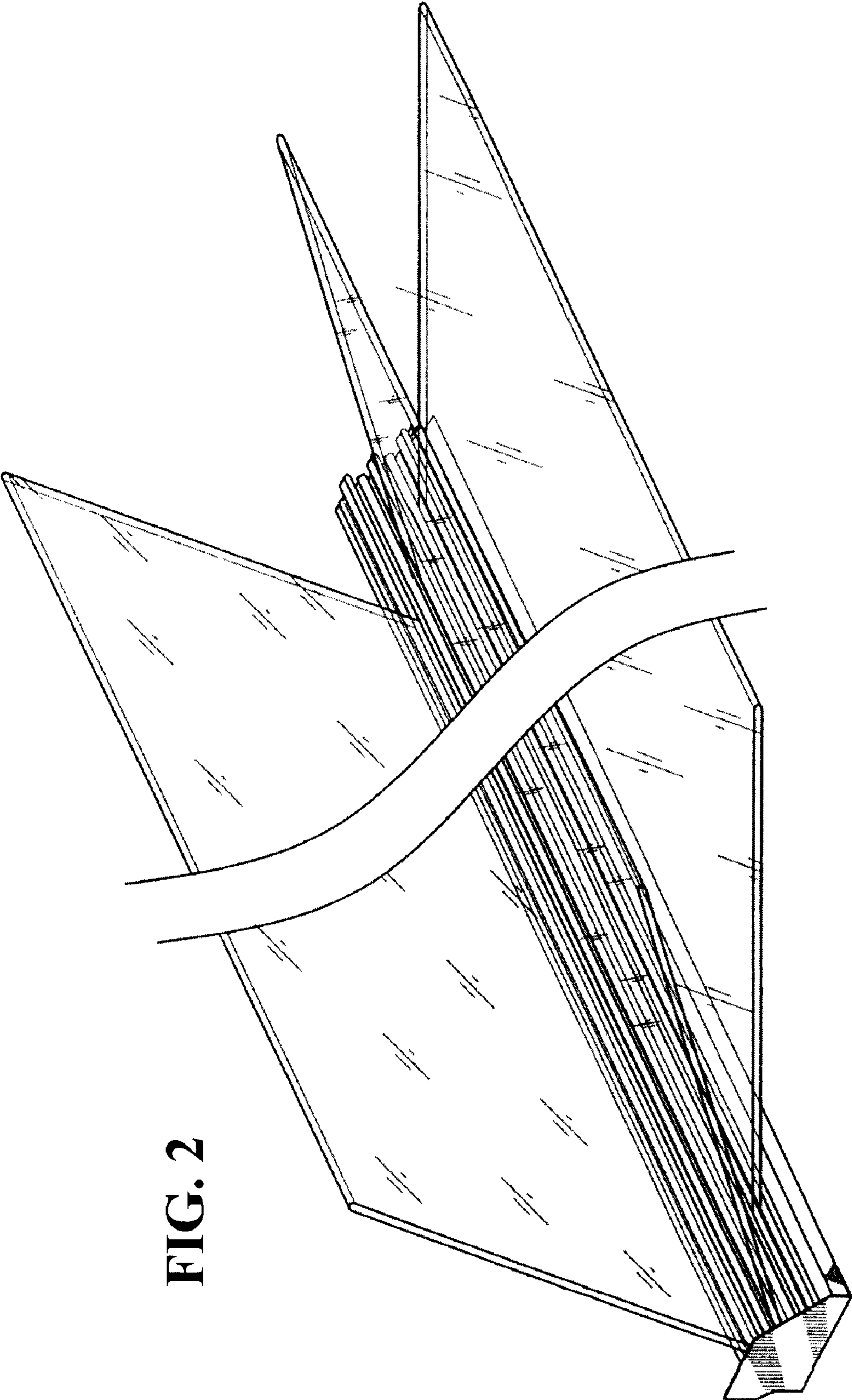

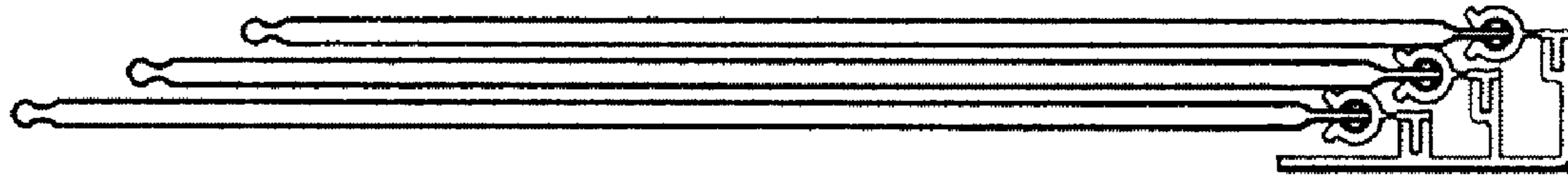

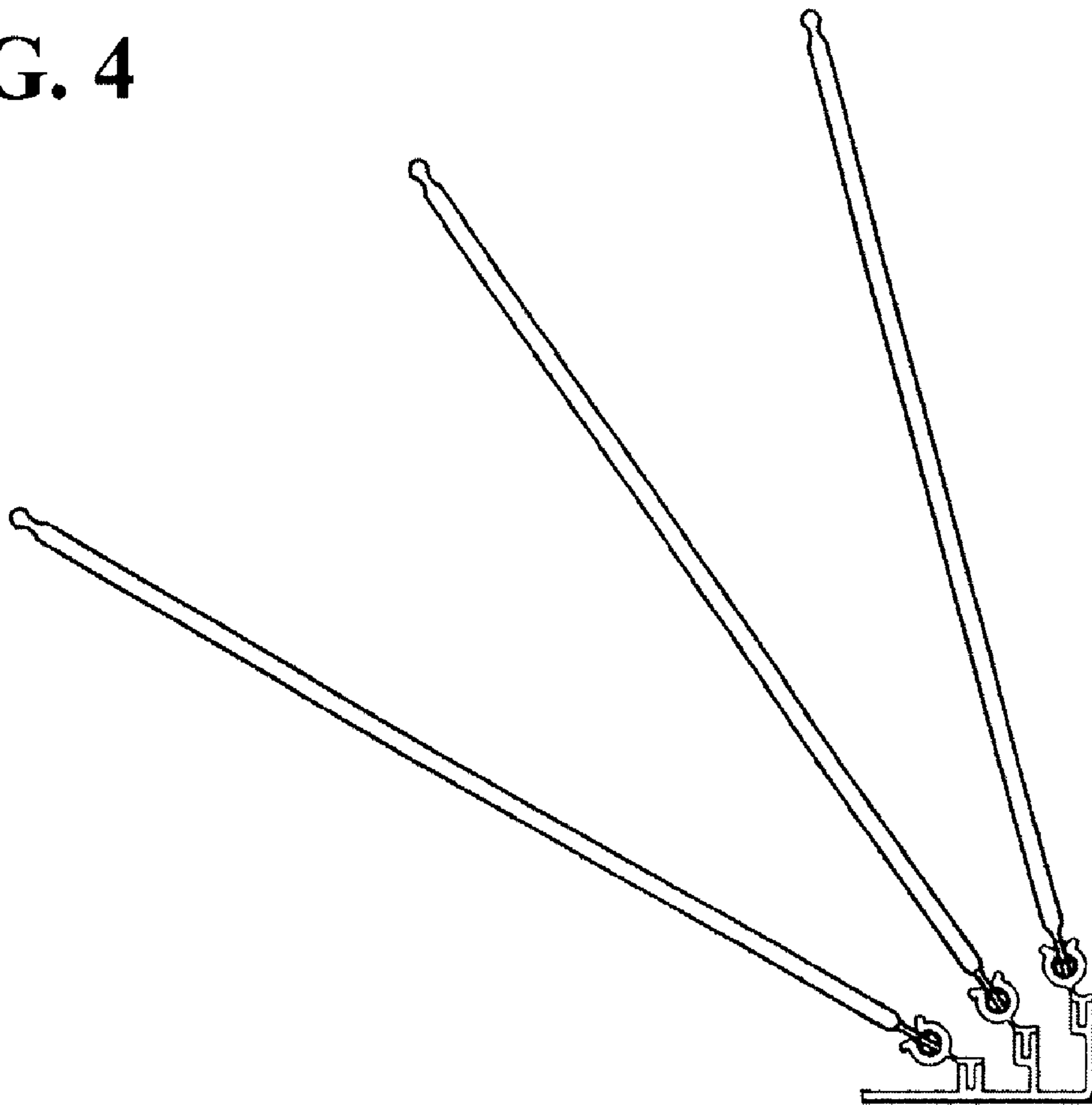

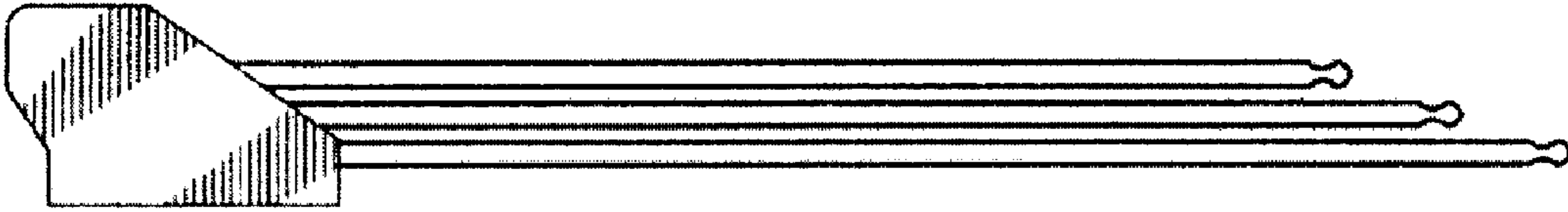
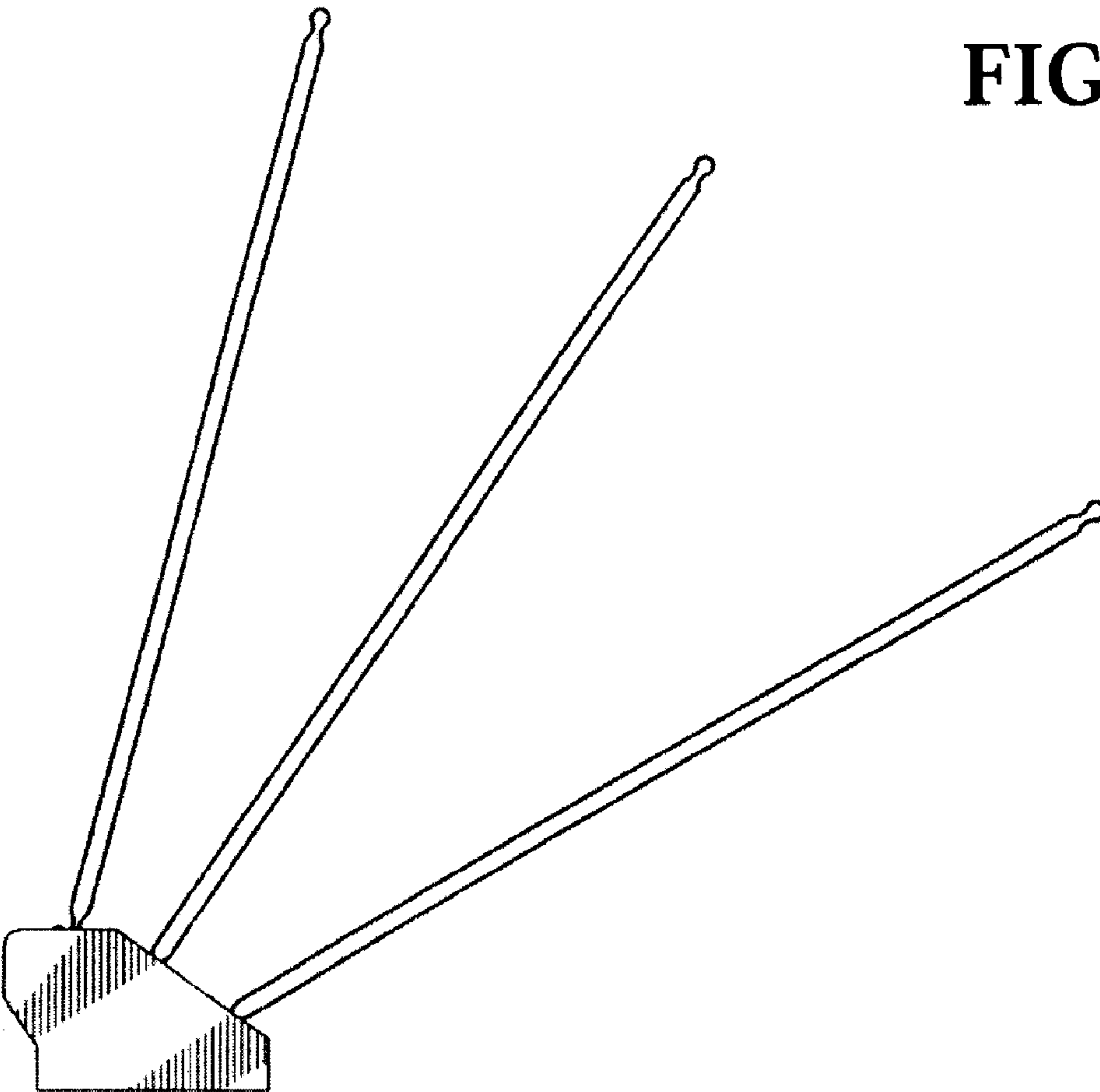

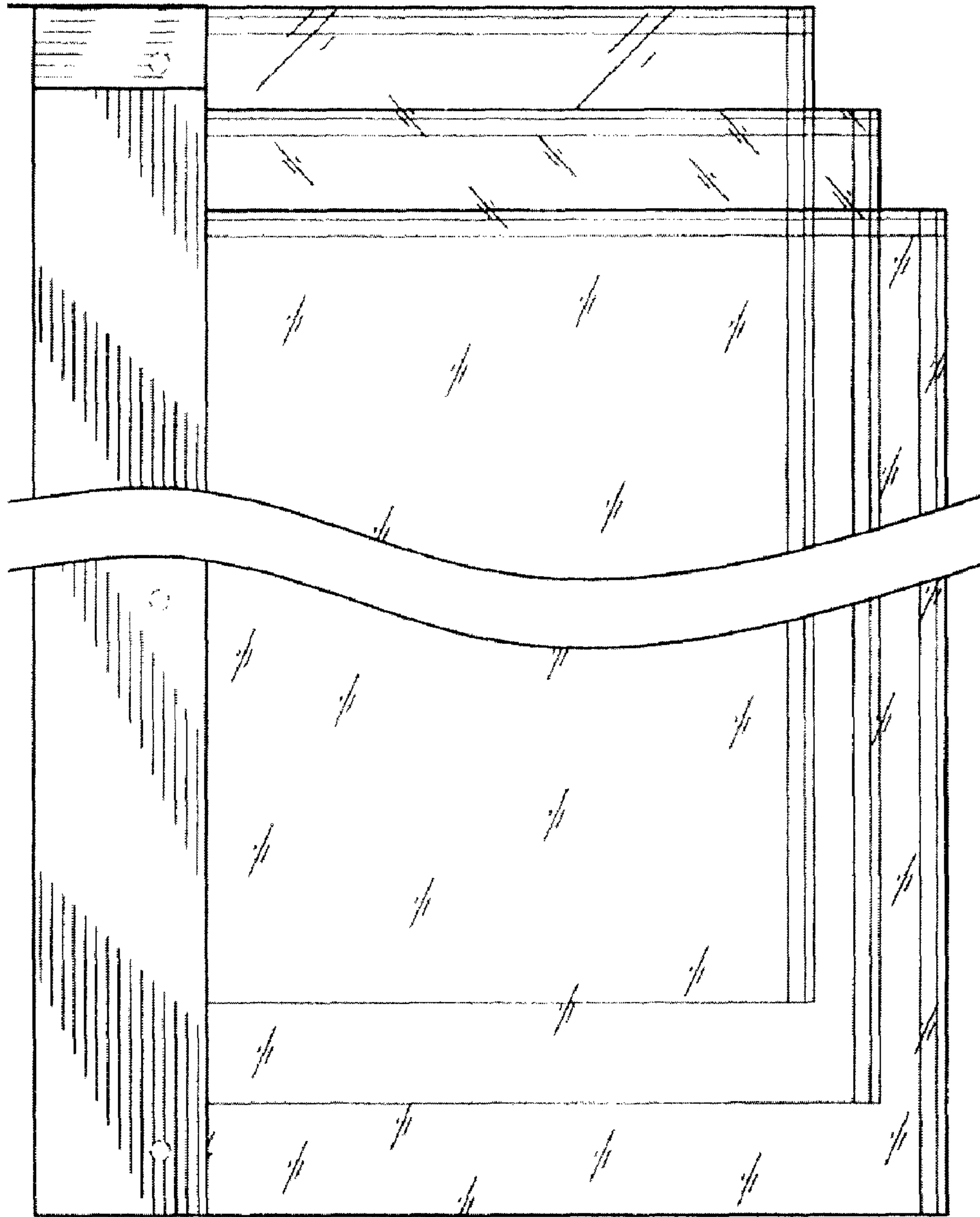

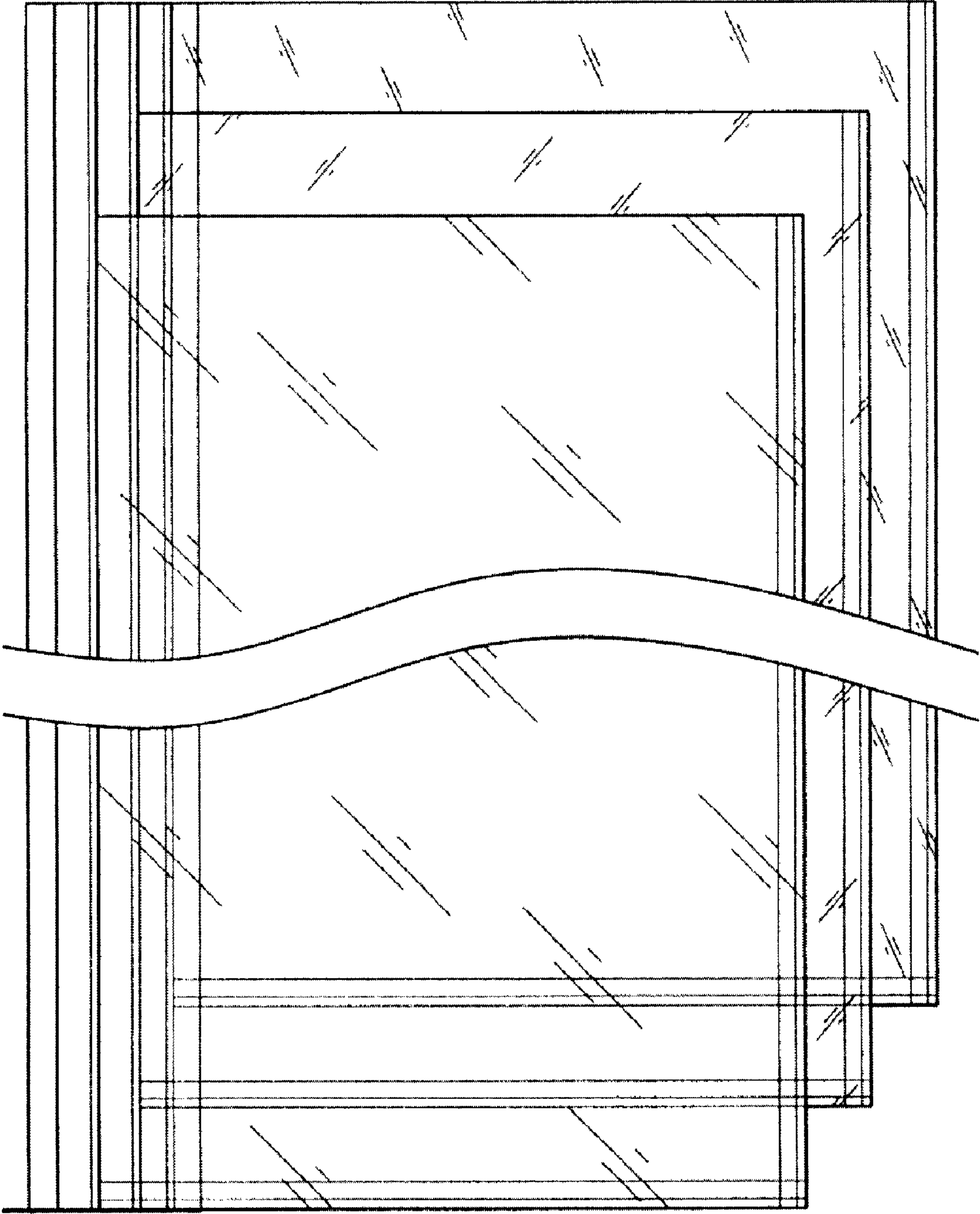

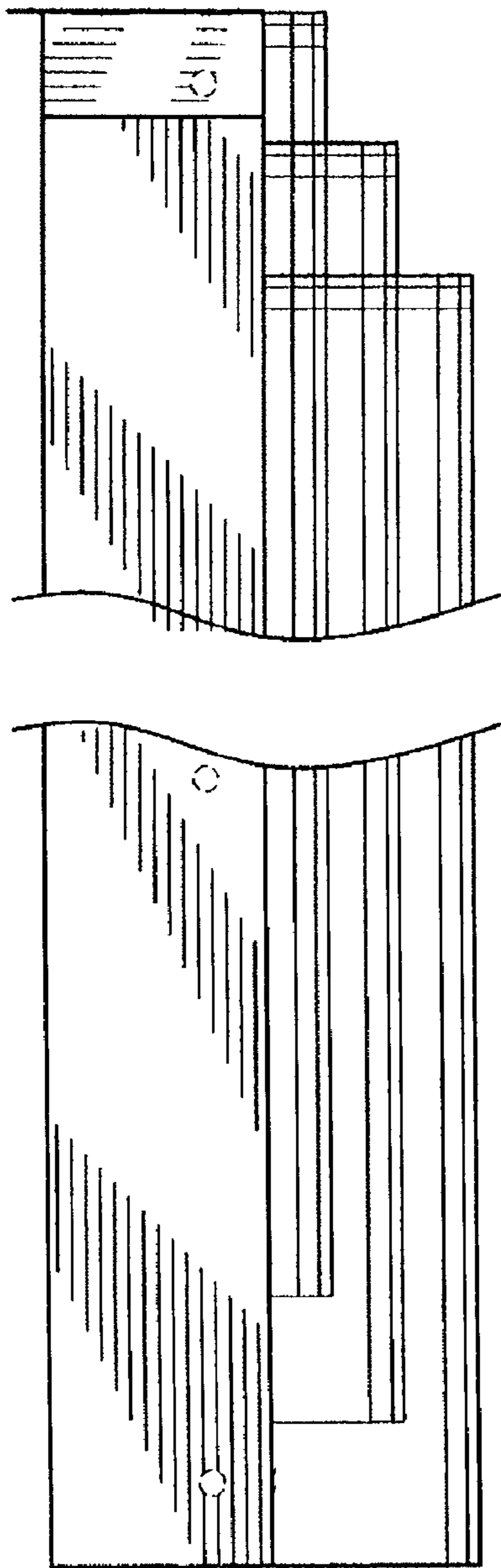
