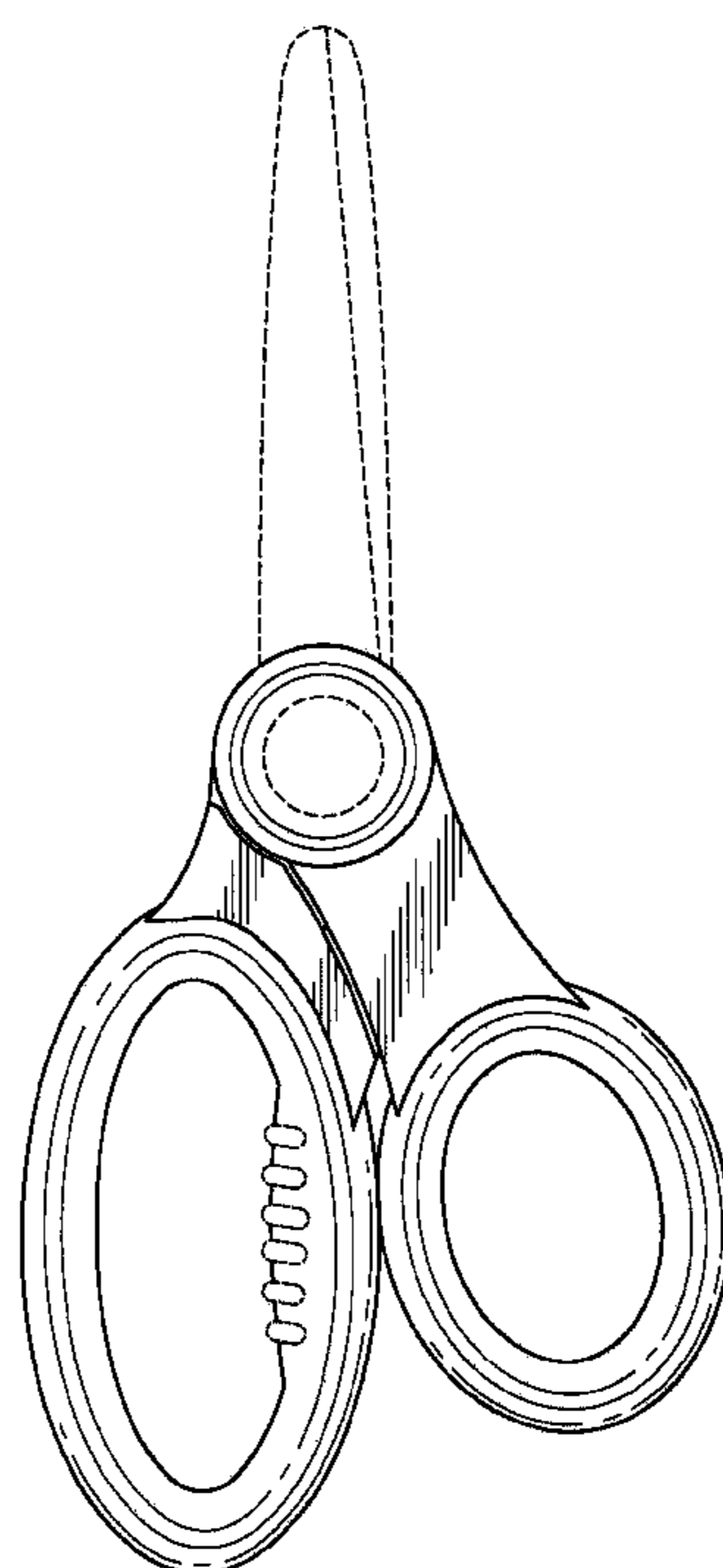
The ornamental design for scissors, as shown and described.

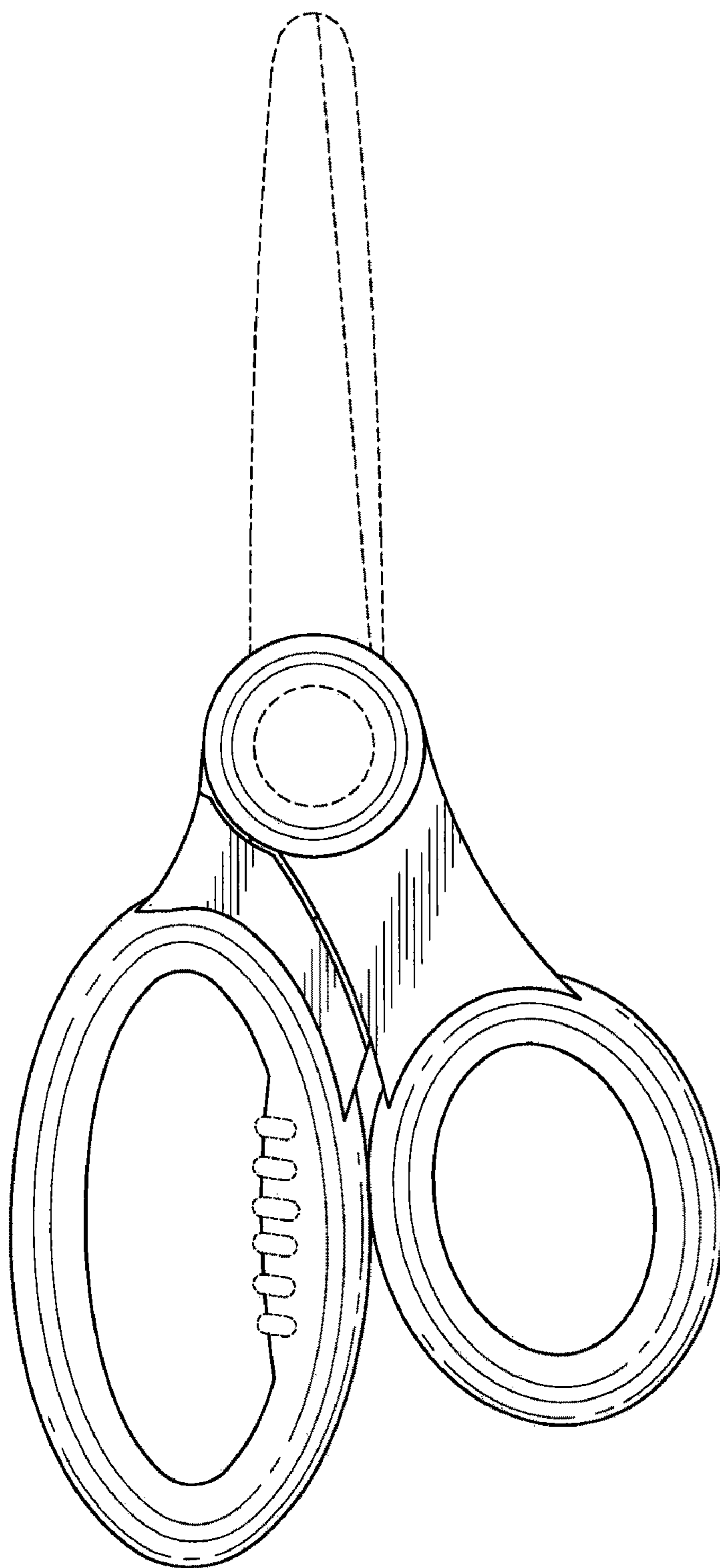
**DESCRIPTION**

FIG. 1 is a front view of the scissors design;

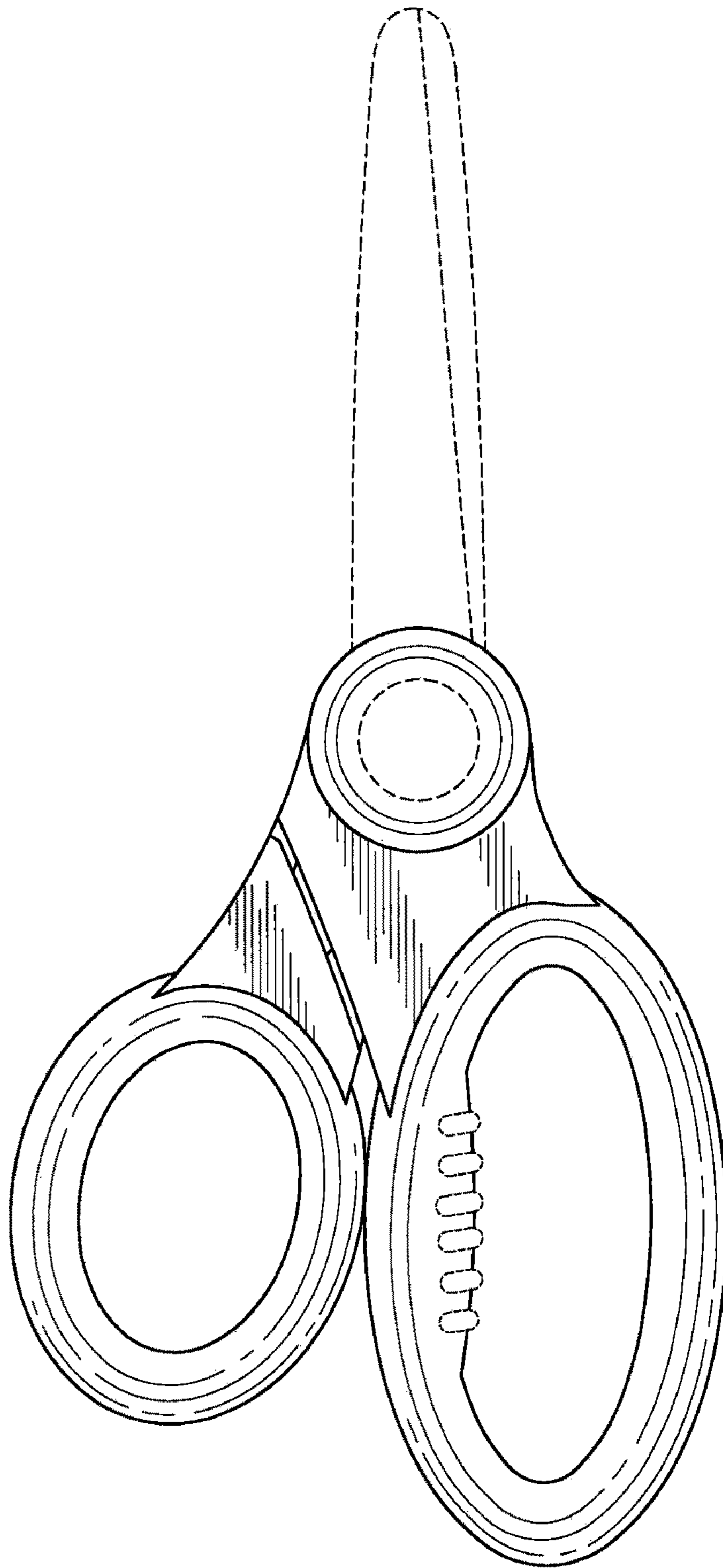

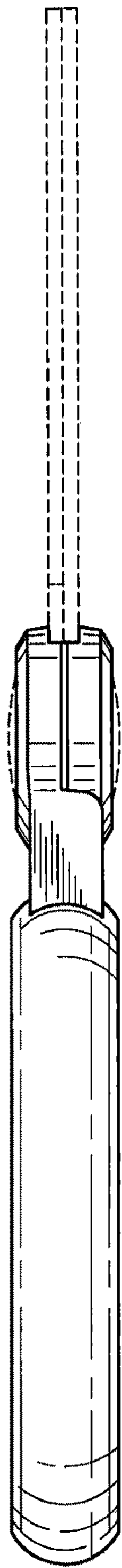

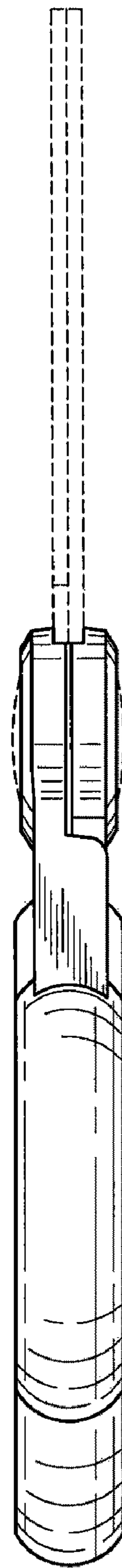

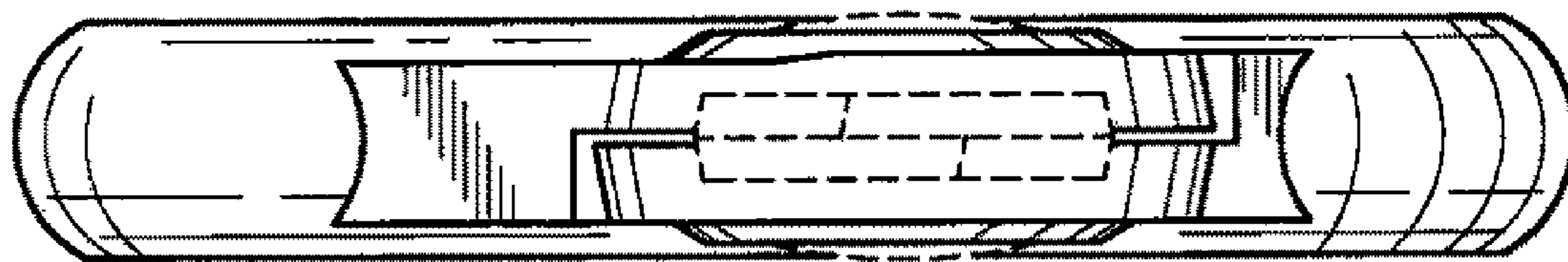

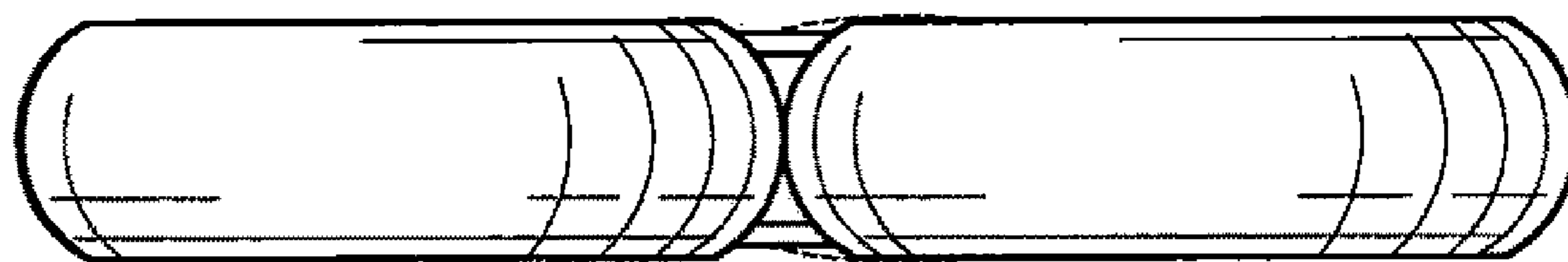

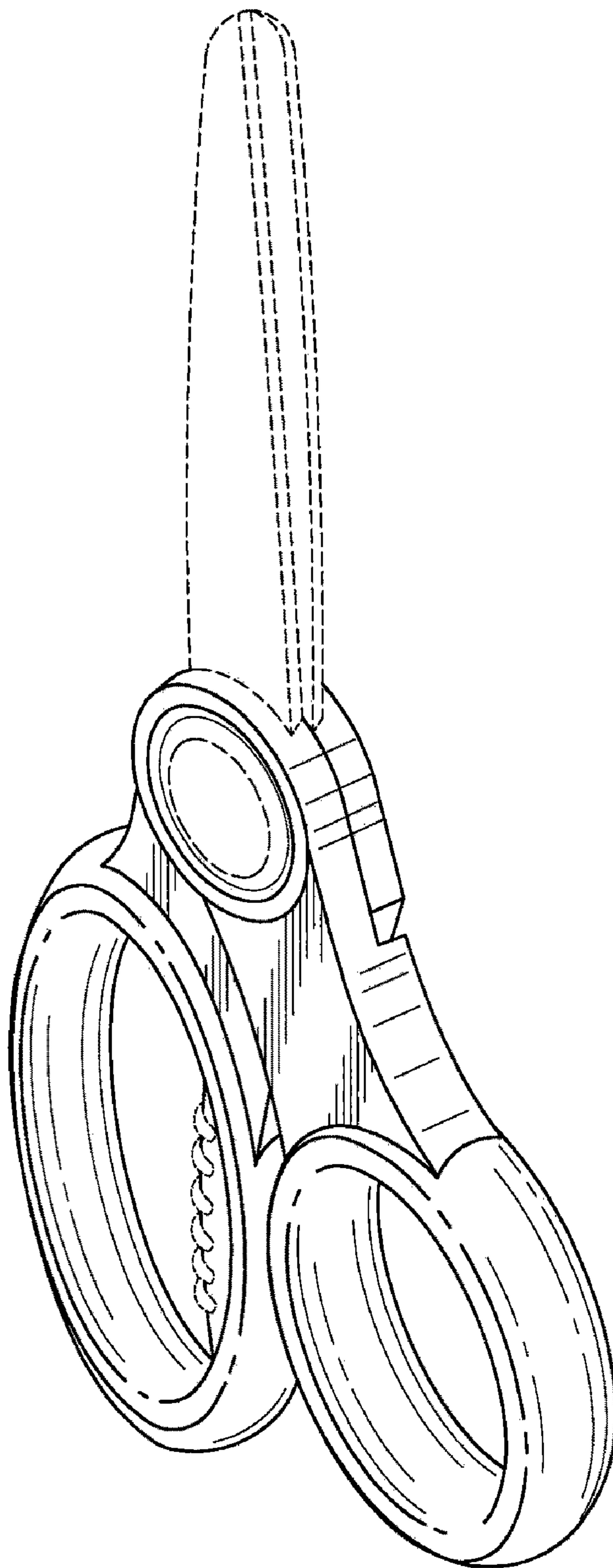
