(57) **CLAIM**

The ornamental design for a door lock housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a door lock housing depicting the front, top, and side of the new design;

FIG. 2 is another perspective view of the door lock housing depicting the rear, top, and side of the design;

FIG. 3 is a front elevation view of the door lock housing;

FIG. 4 is a side elevation view of the door lock housing, the other side being a mirror image thereof;

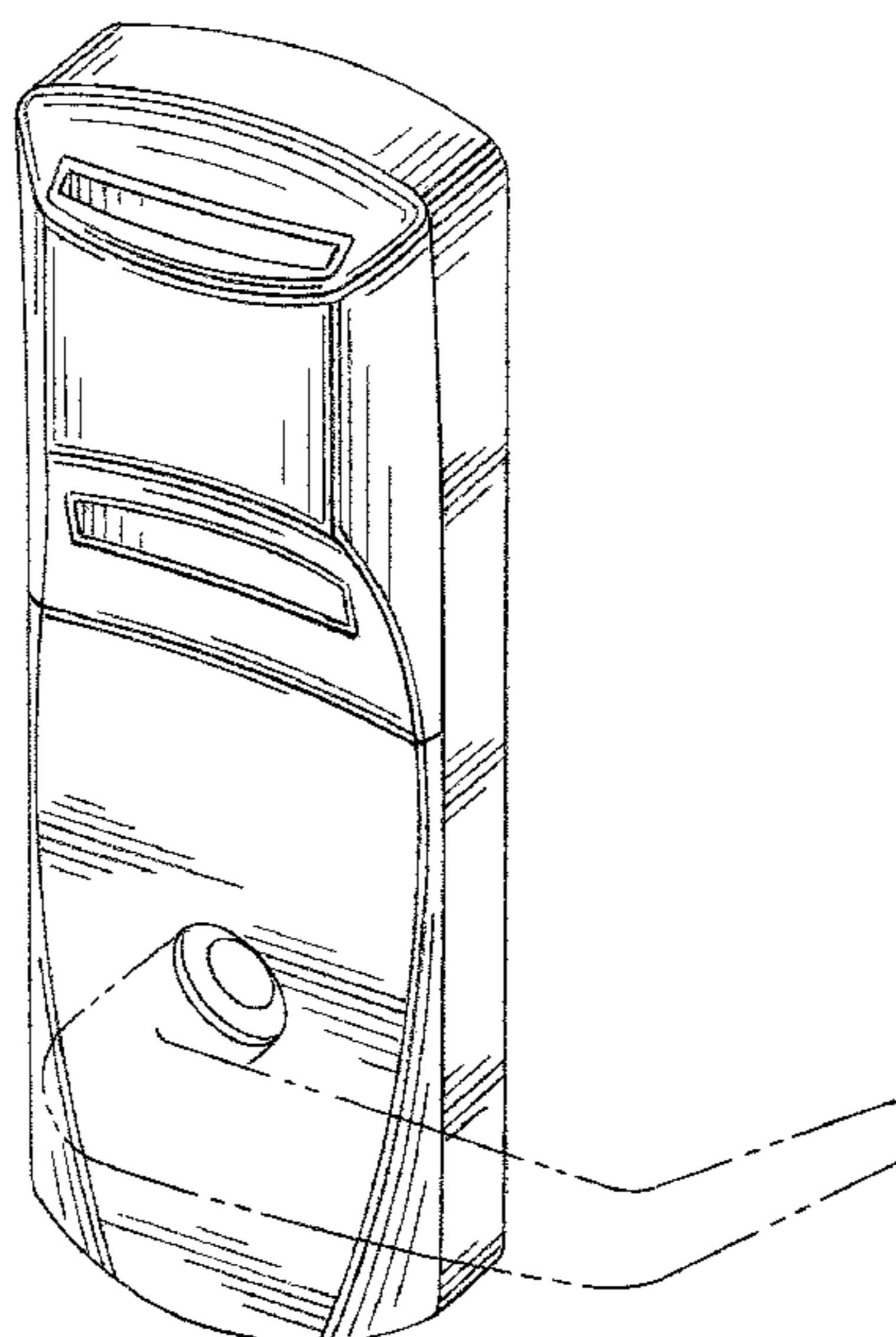
FIG. 5 is a rear elevation view of the door lock housing;

FIG. 6 is a top plan view of the door lock housing; and,

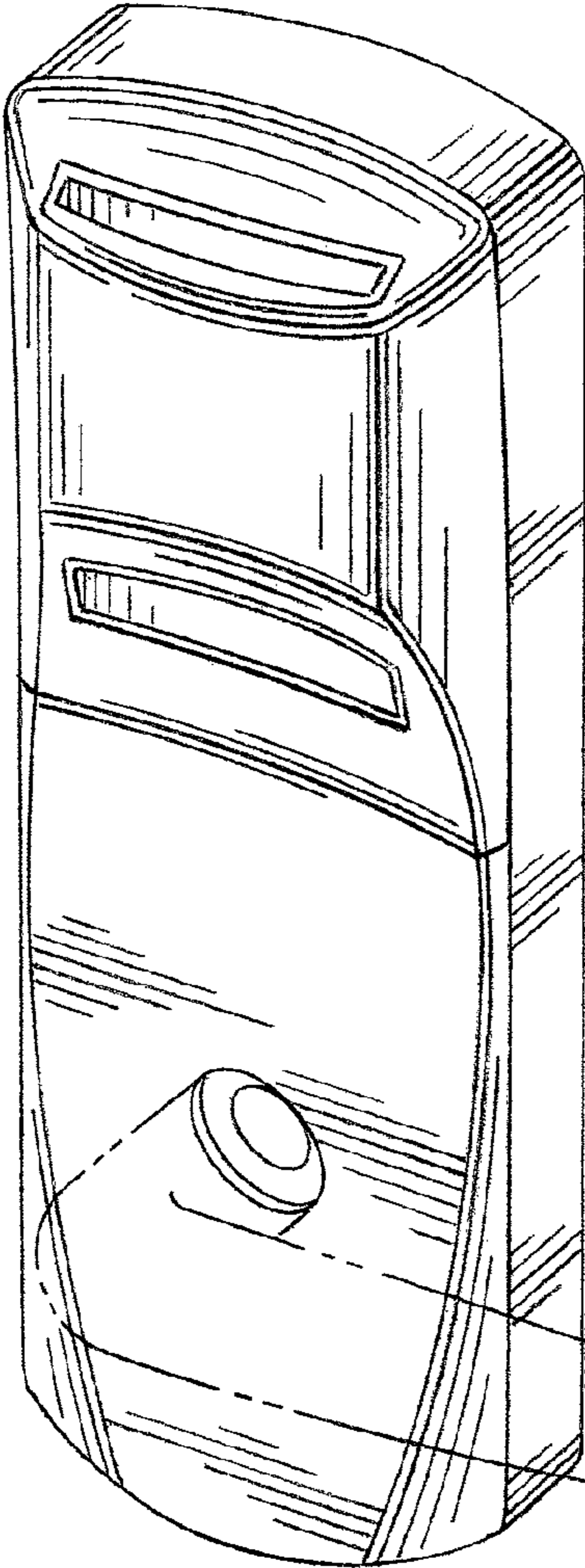

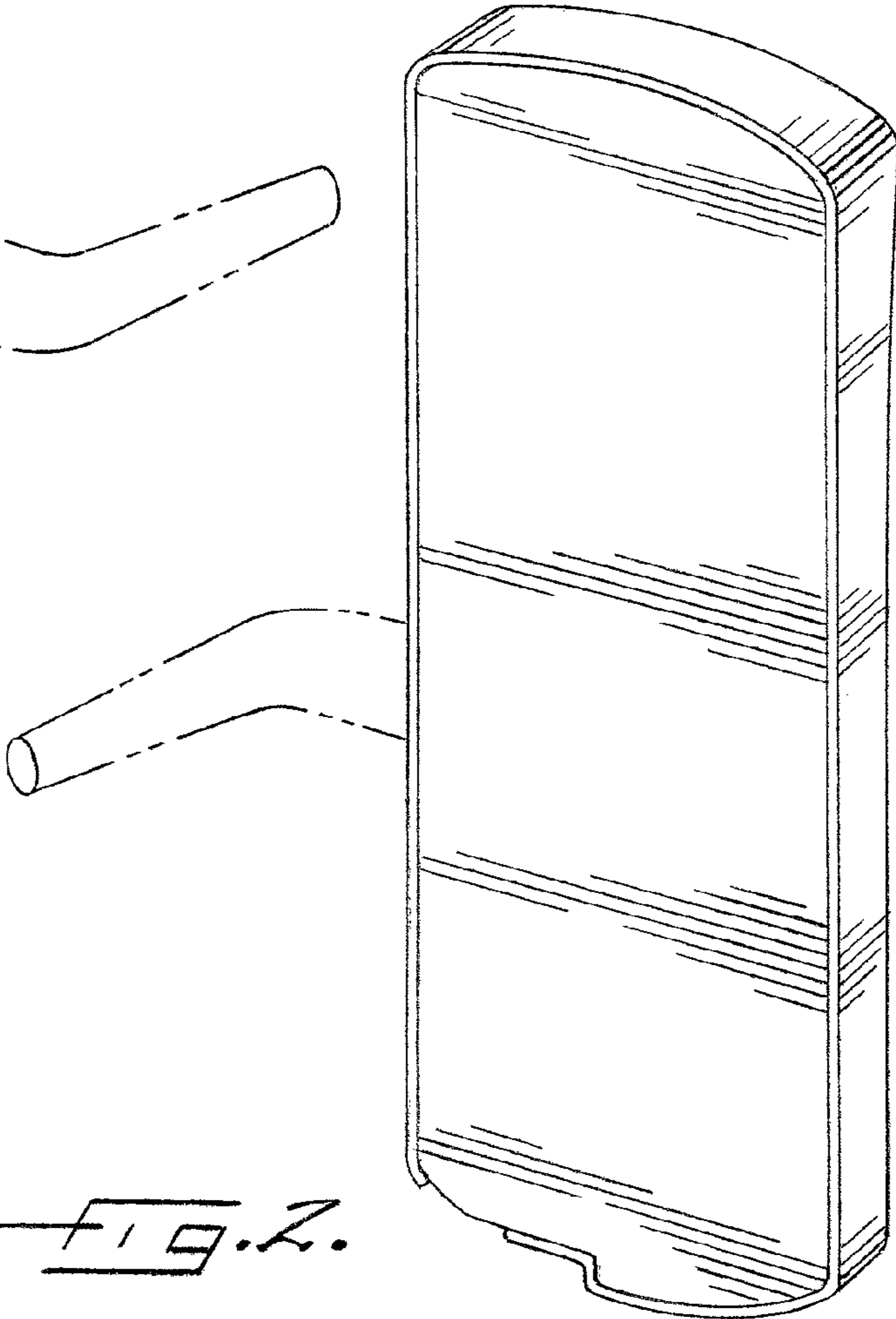
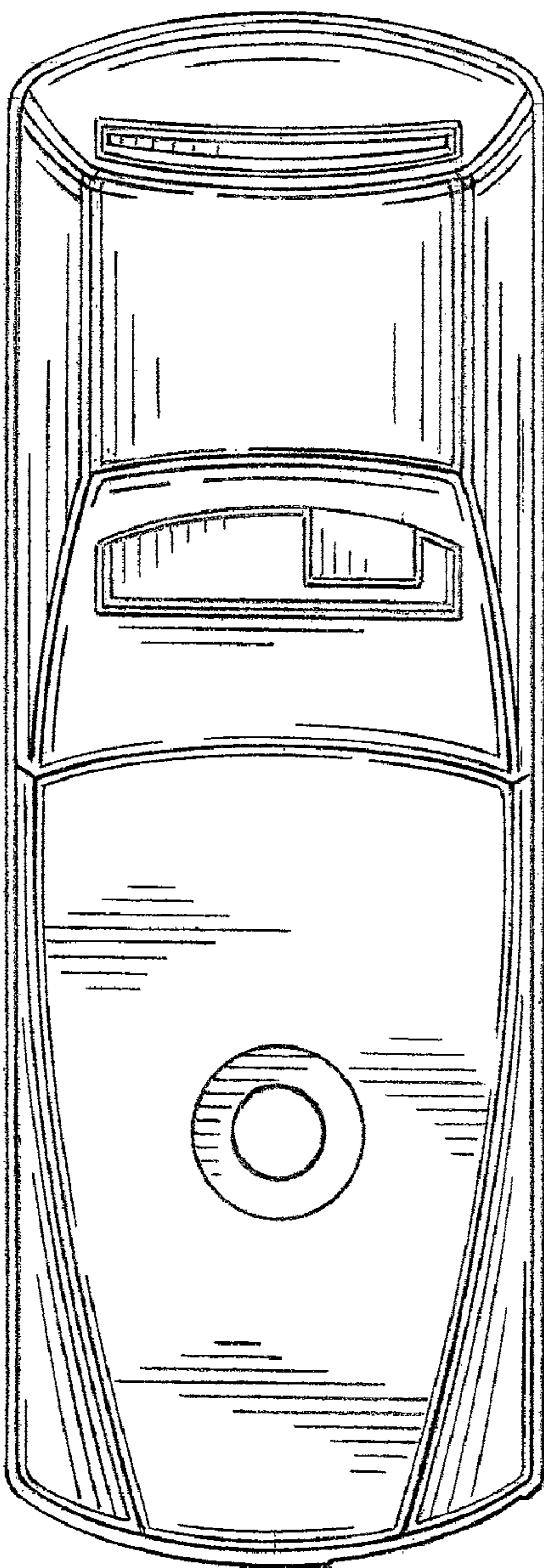
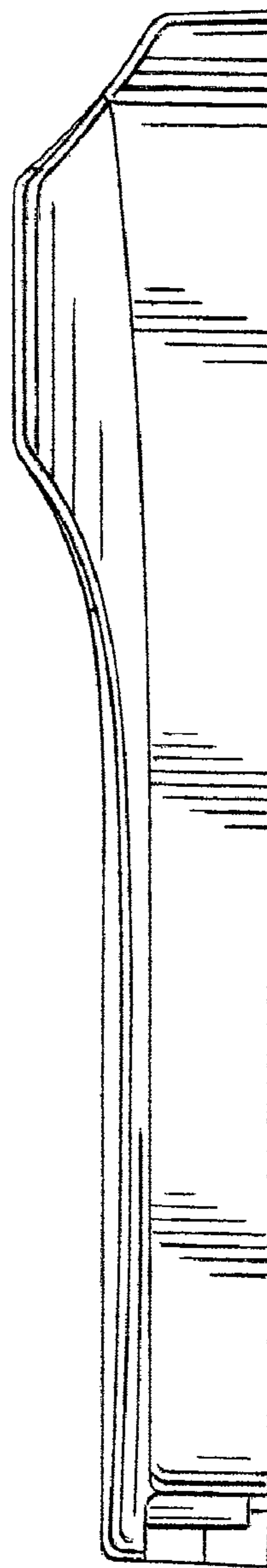

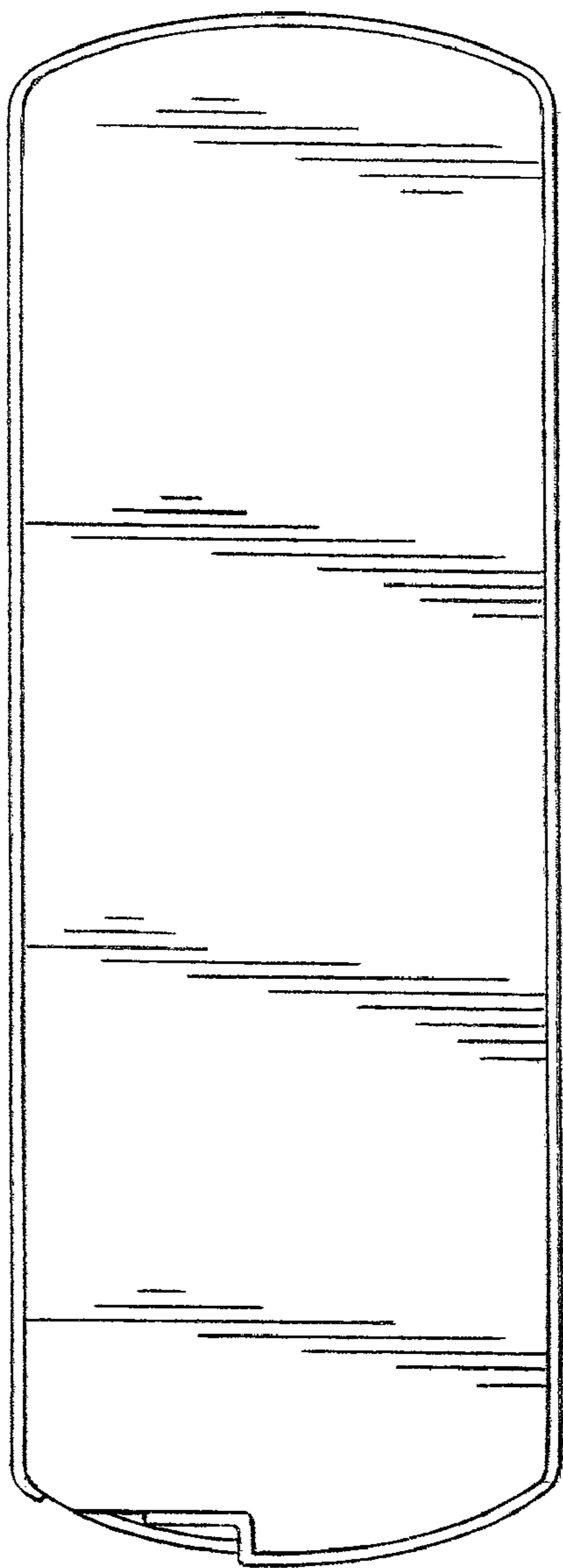

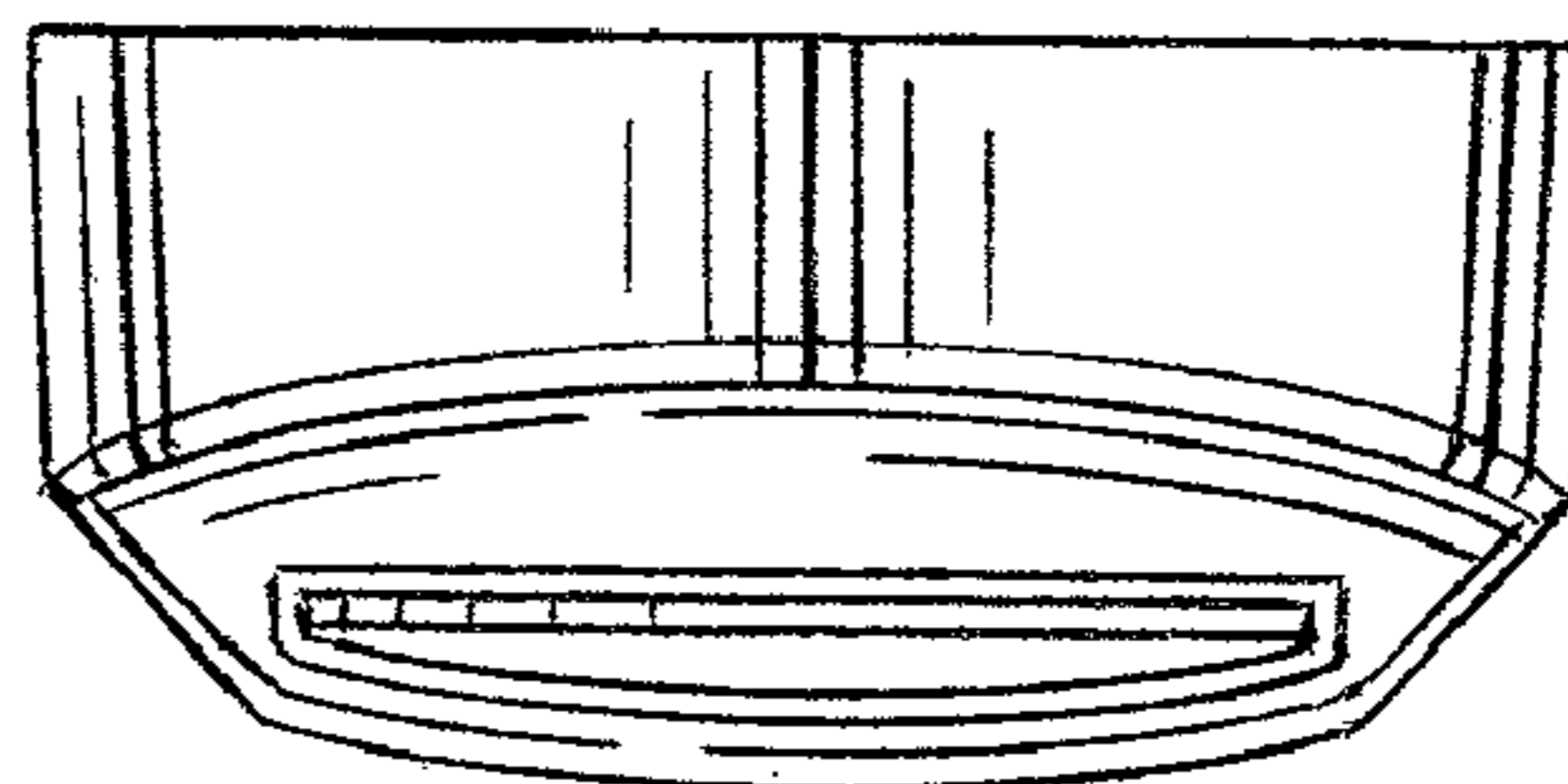

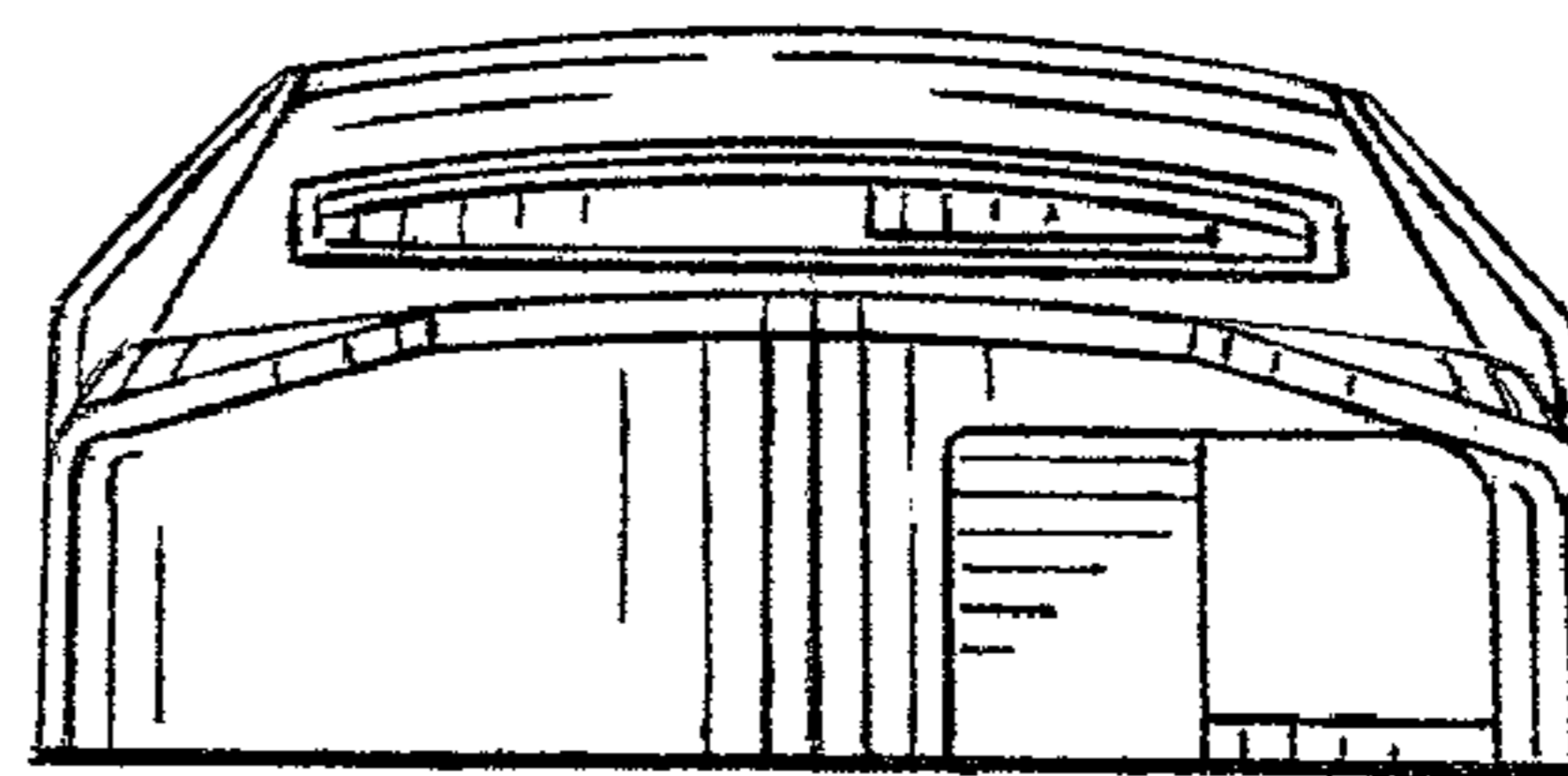
