(57) **CLAIM**

The ornamental designs for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bottle in accordance with an embodiment of the present design;

FIG. 2 is a right side elevational view of the bottle of FIG. 1, the left side elevational view being a mirror image of the right side elevational view;

FIG. 3 is a front elevational view of the bottle of FIGS. 1–2;

FIG. 4 is a rear elevational view of the bottle of FIGS. 1–3;

FIG. 5 is a top plan view of the bottle of FIGS. 1–4;

FIG. 6 is a bottom plan view of the bottle of FIGS. 1–5;

FIG. 7 is a perspective view of a variation of the bottle of FIGS. 1–6;

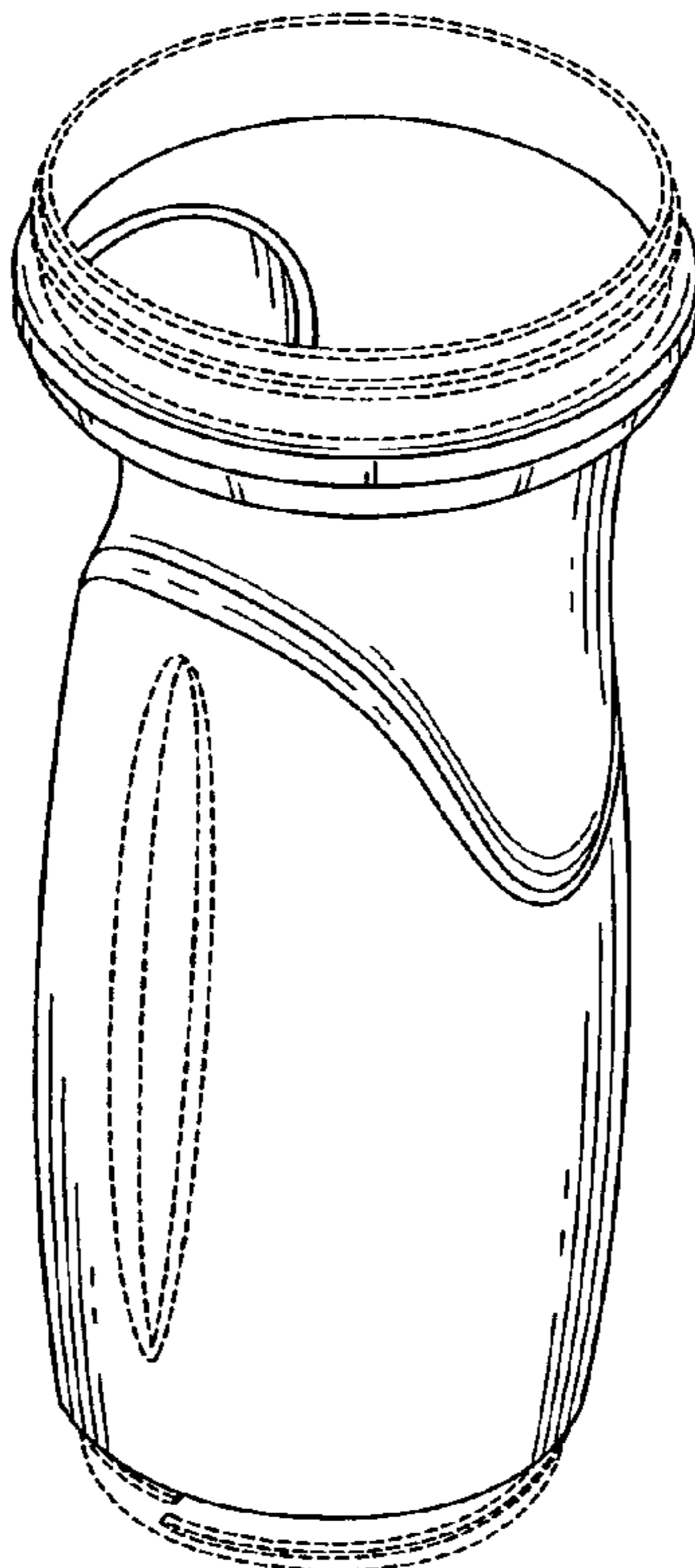
FIG. 8 is a front elevational view of the bottle of FIG. 7;

FIG. 9 is a bottom plan view of the bottle of FIGS. 7–9; and,

FIG. 10 is a longitudinal cross-sectional view of the bottle of FIGS. 7 and 8.

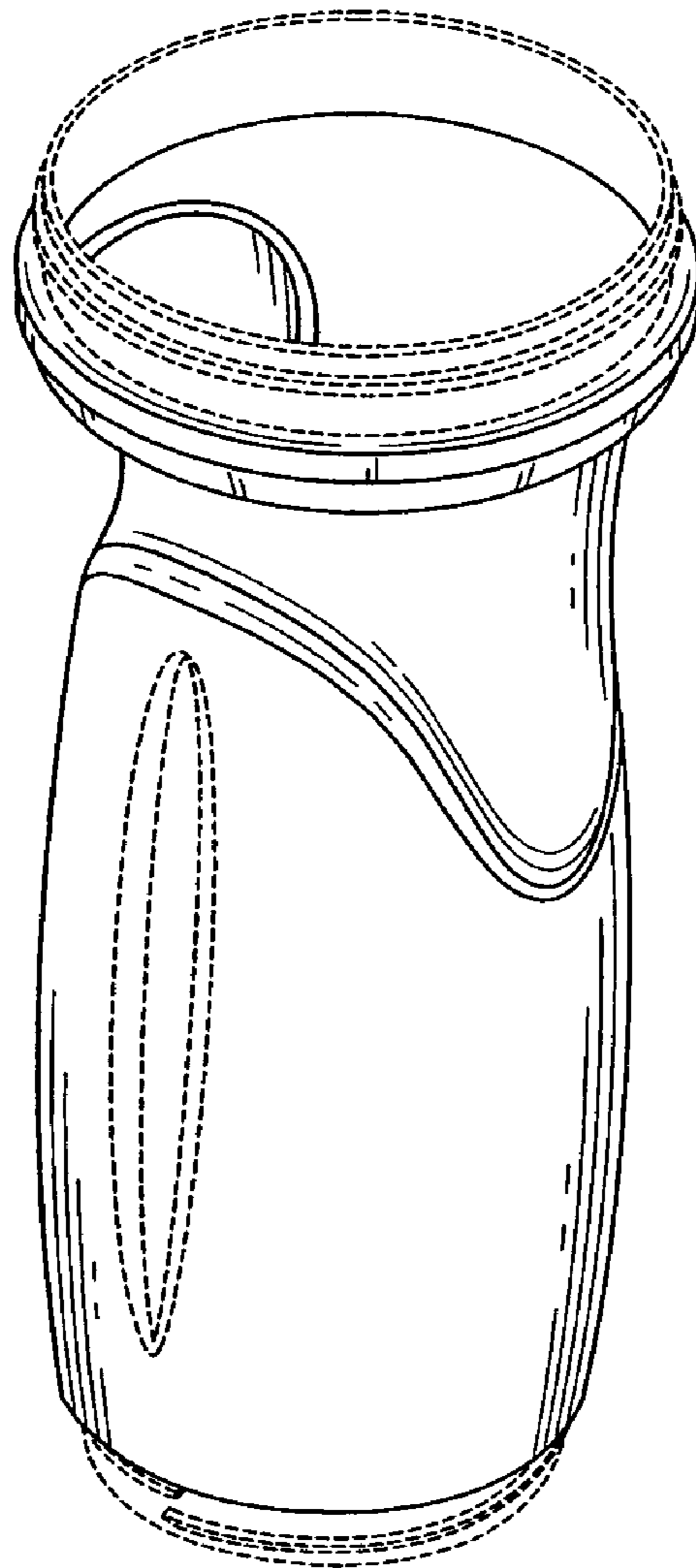

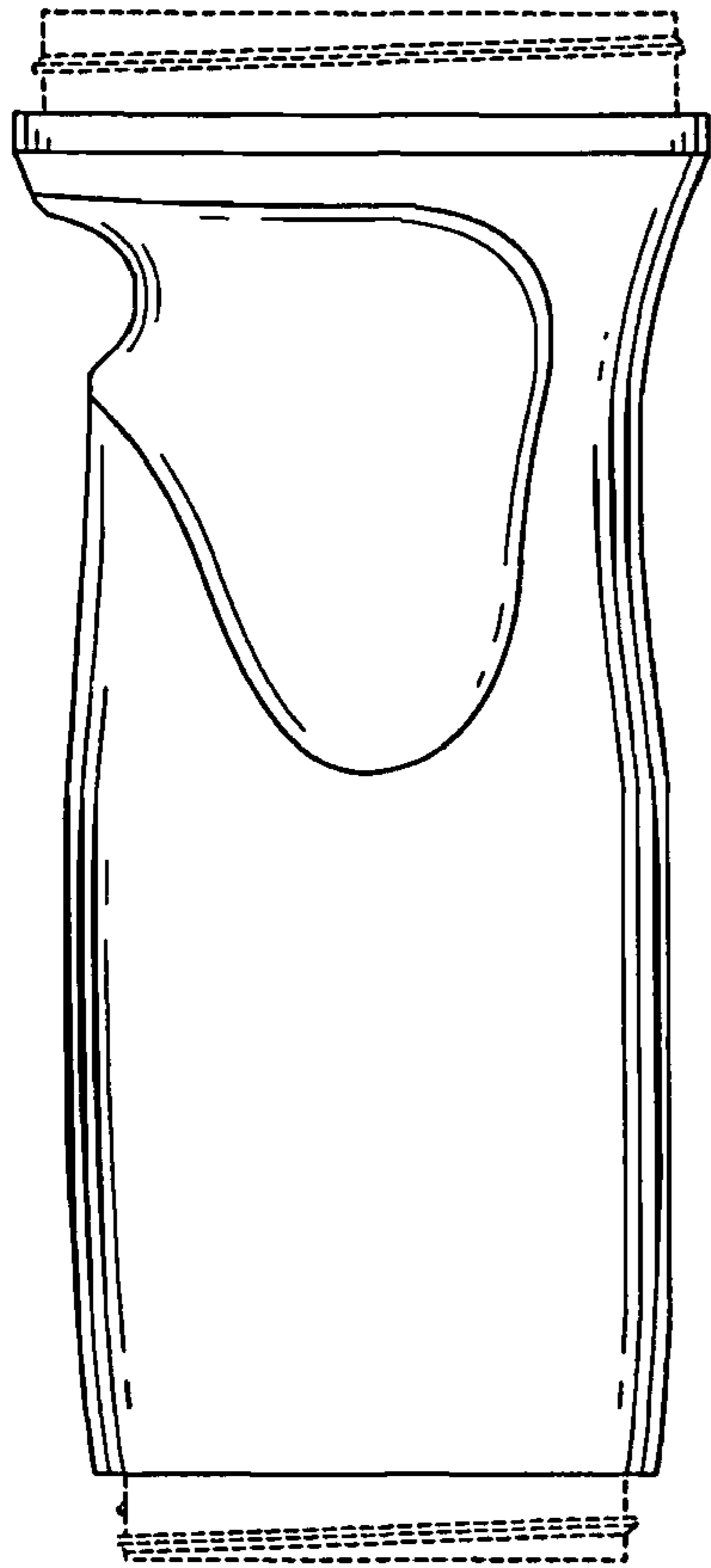

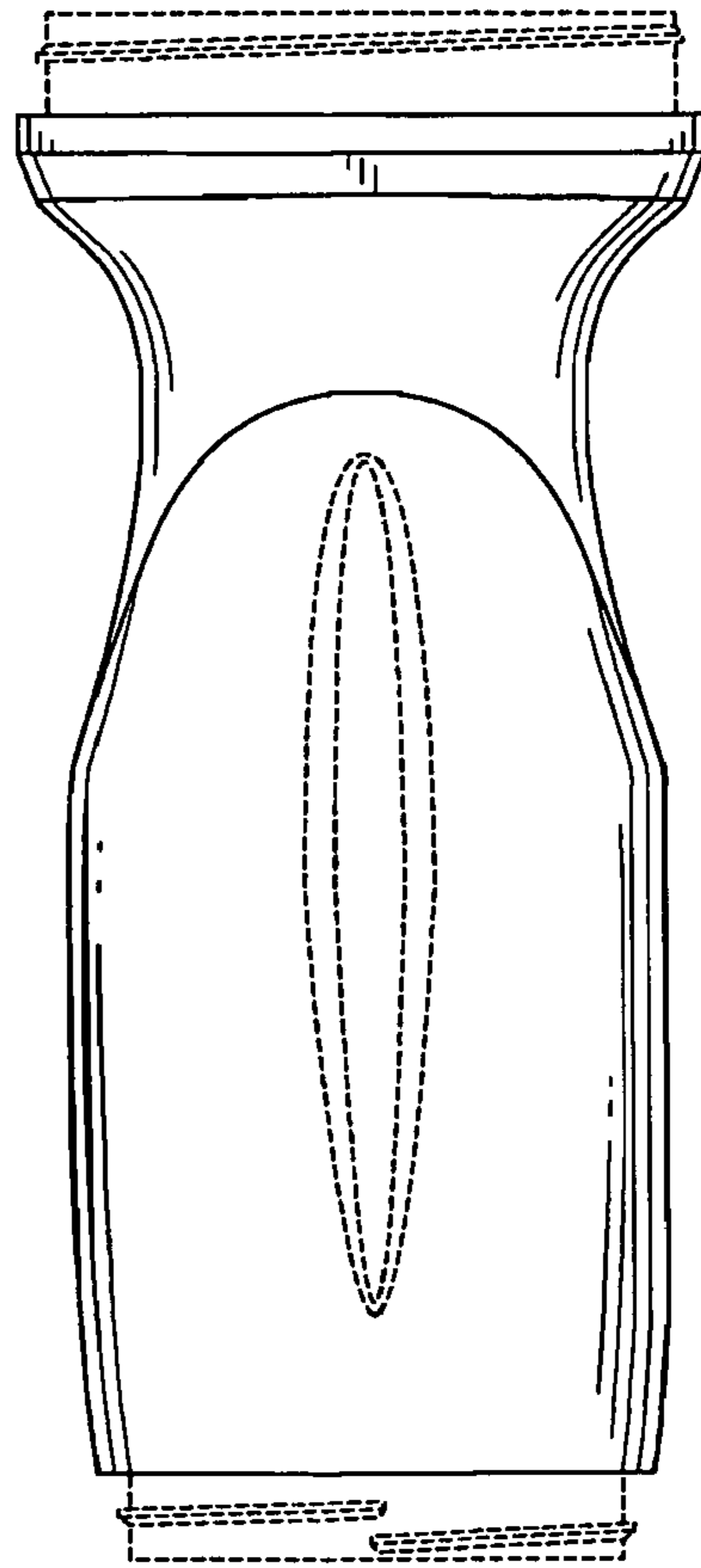

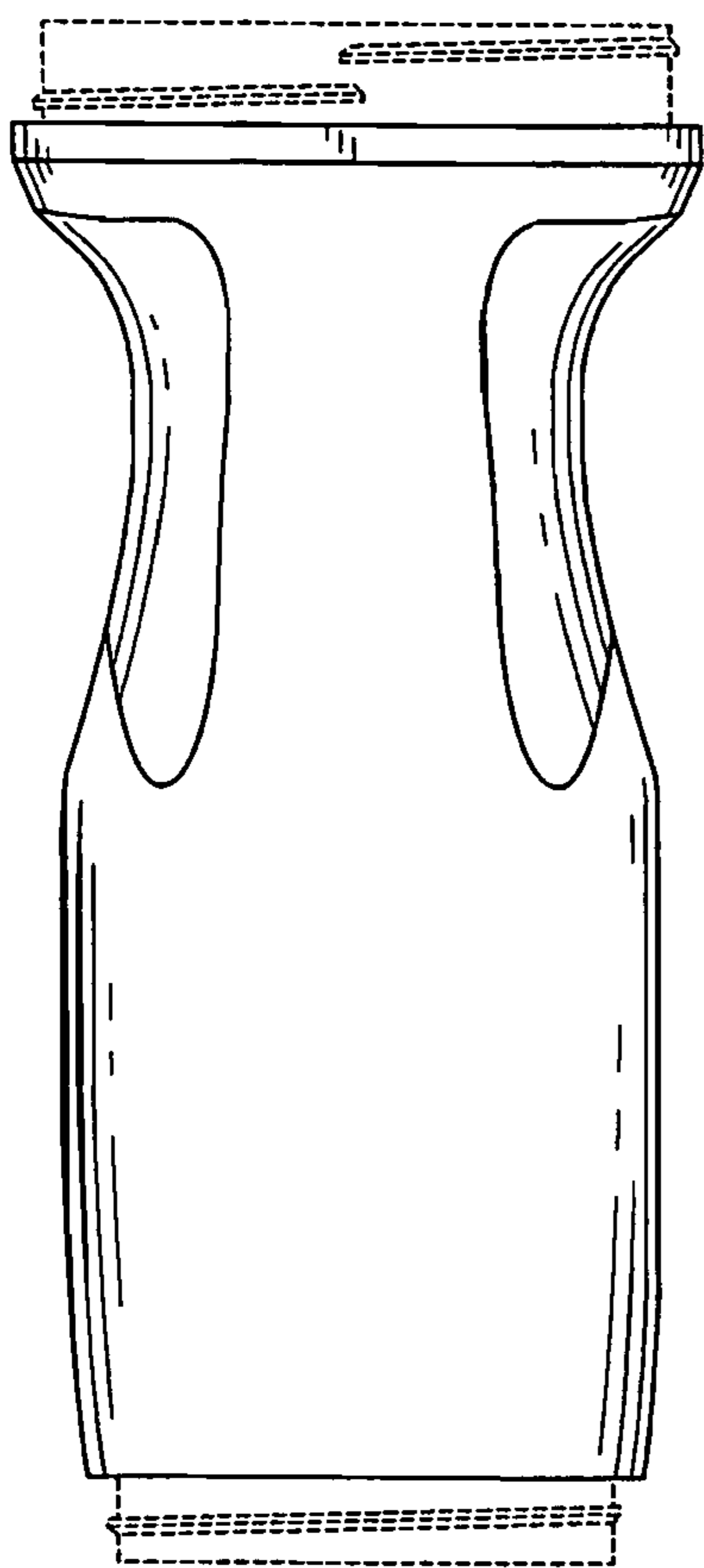

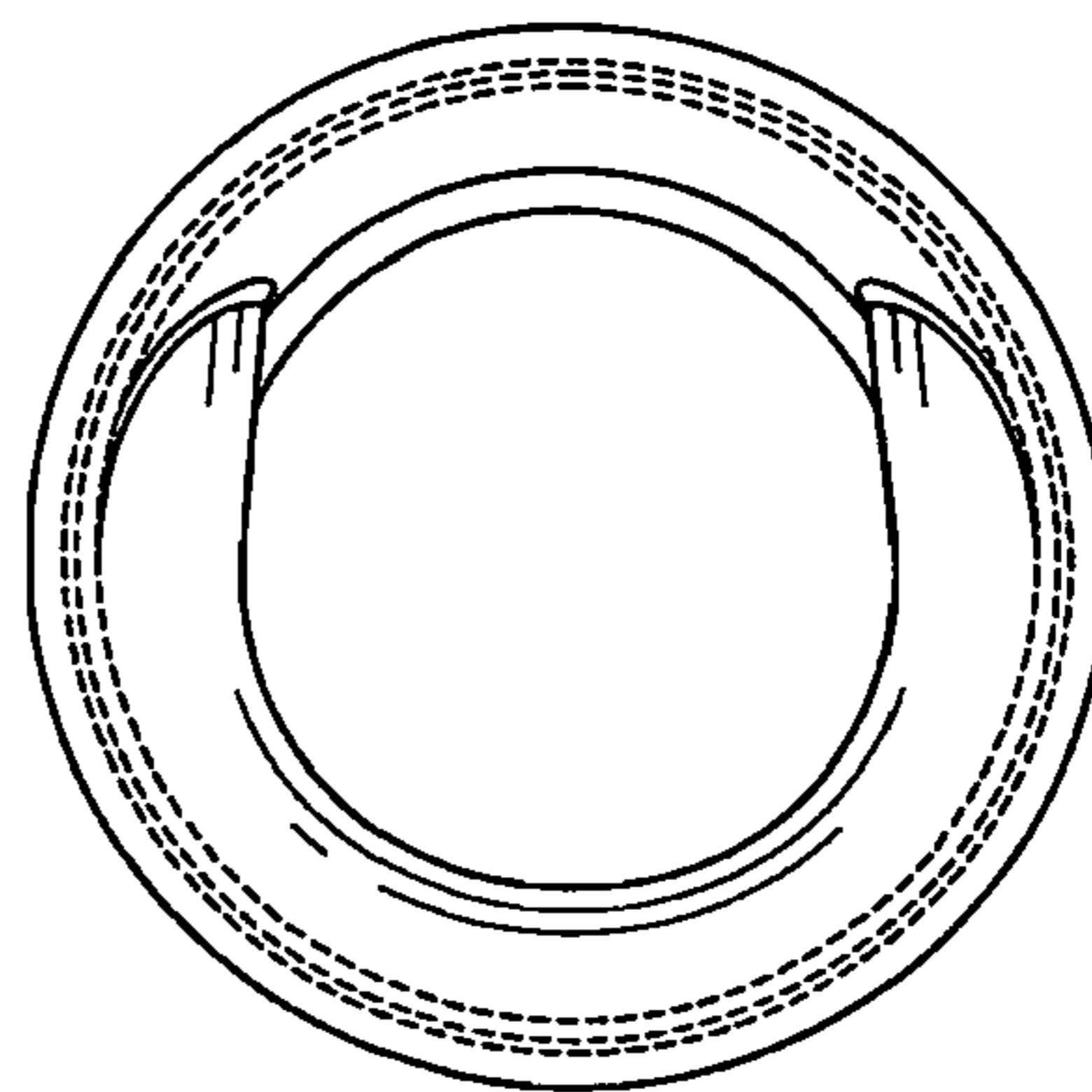

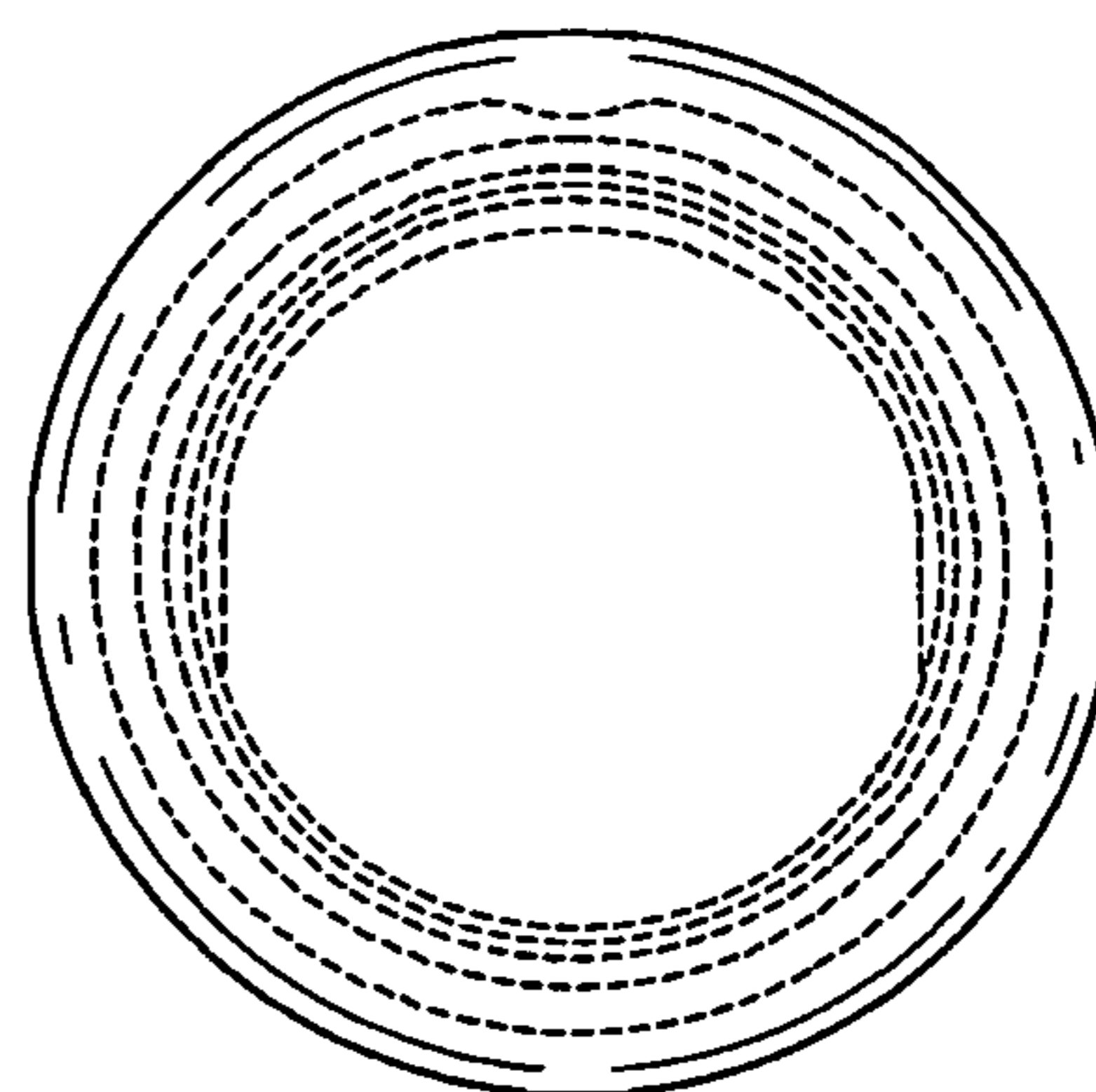

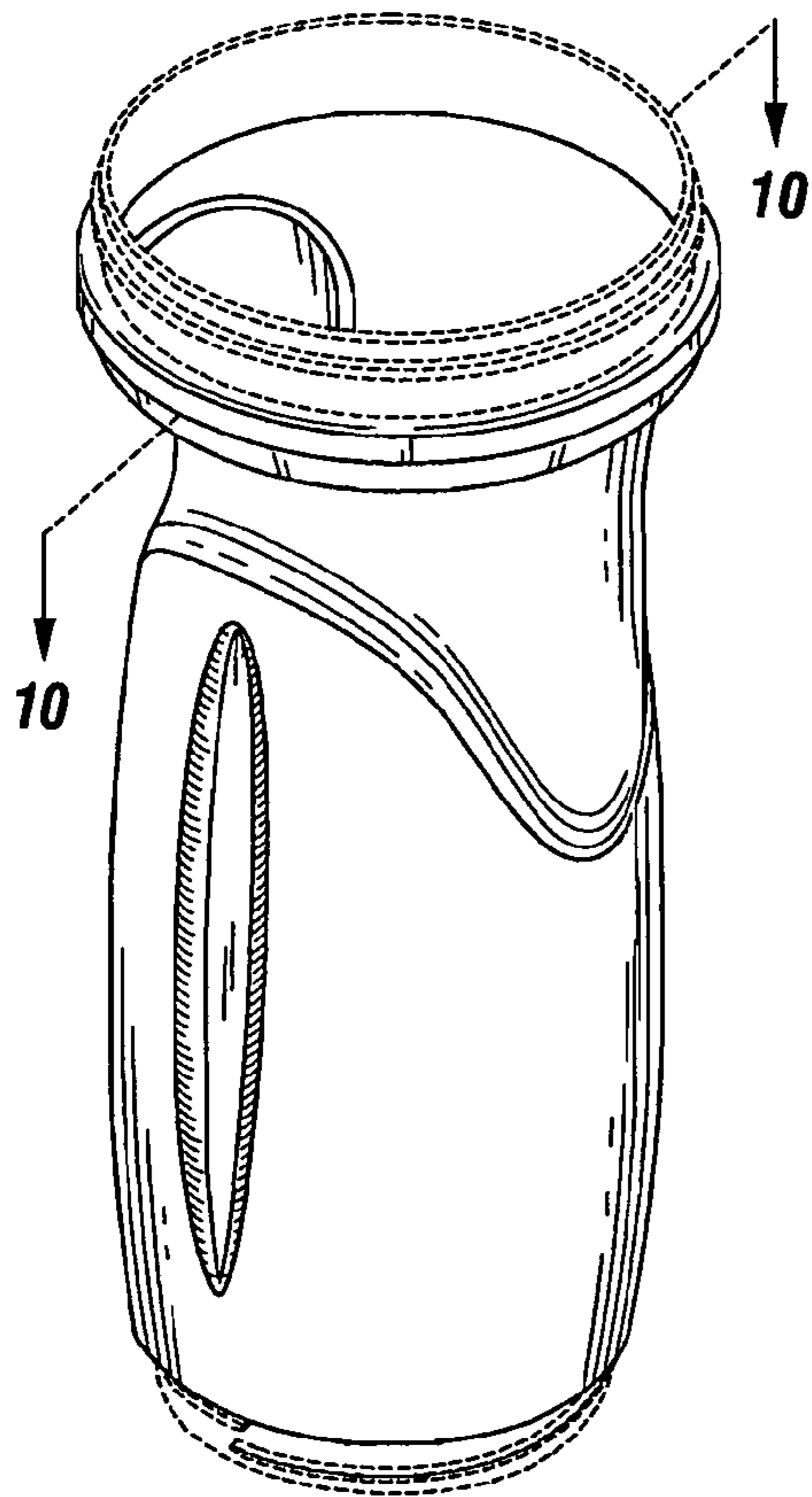

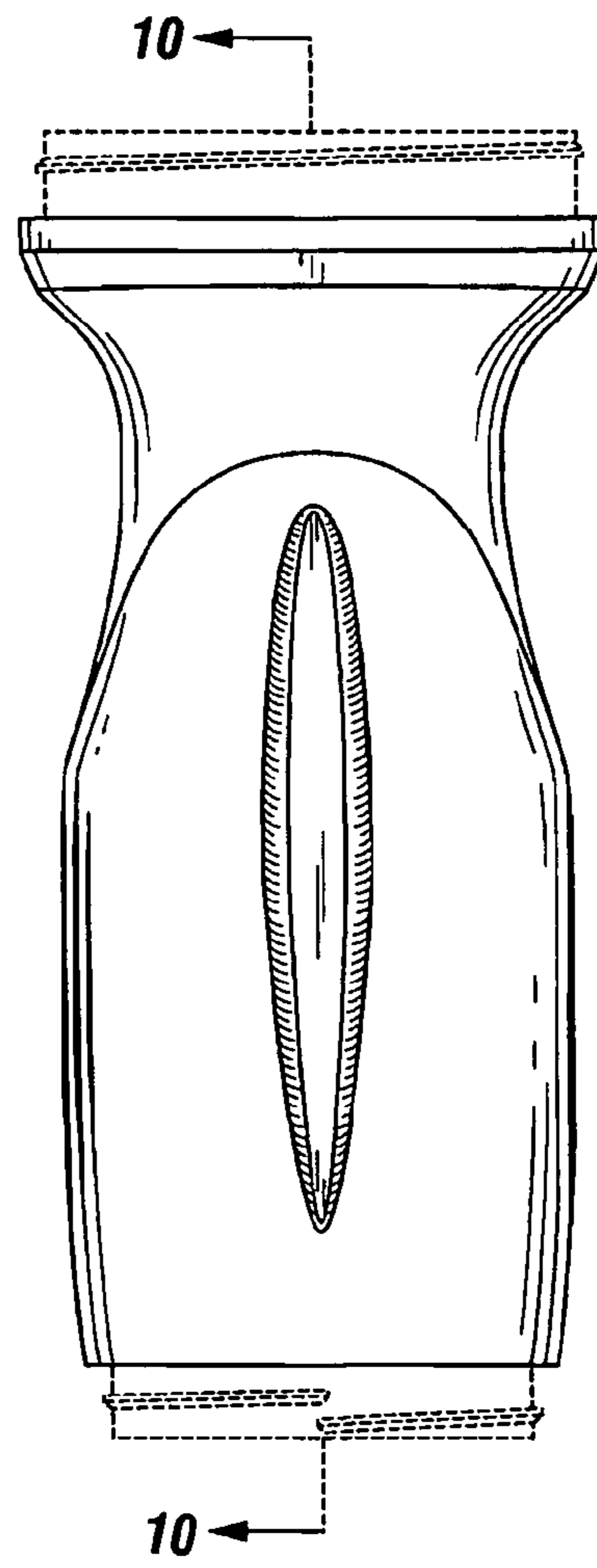

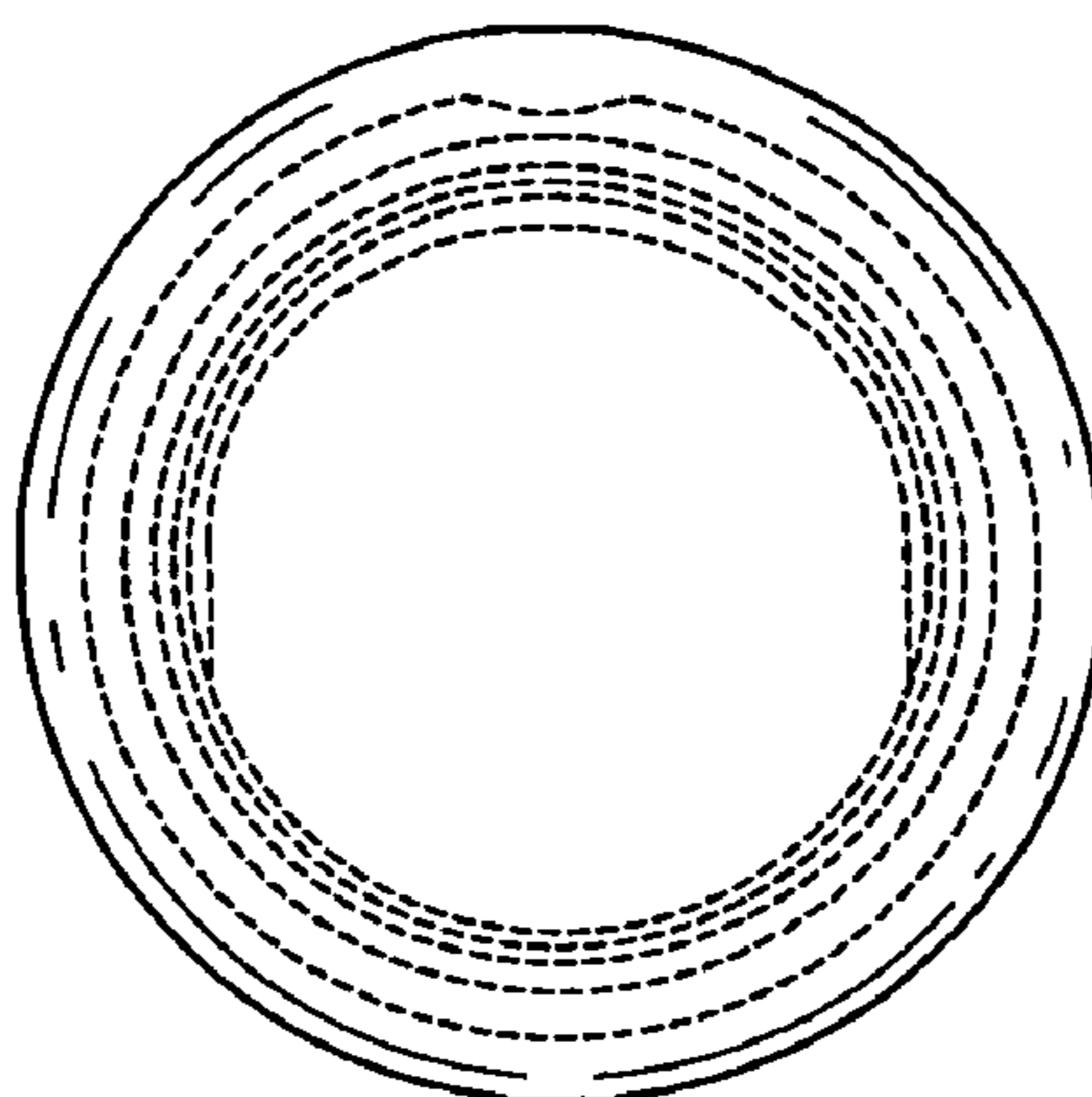

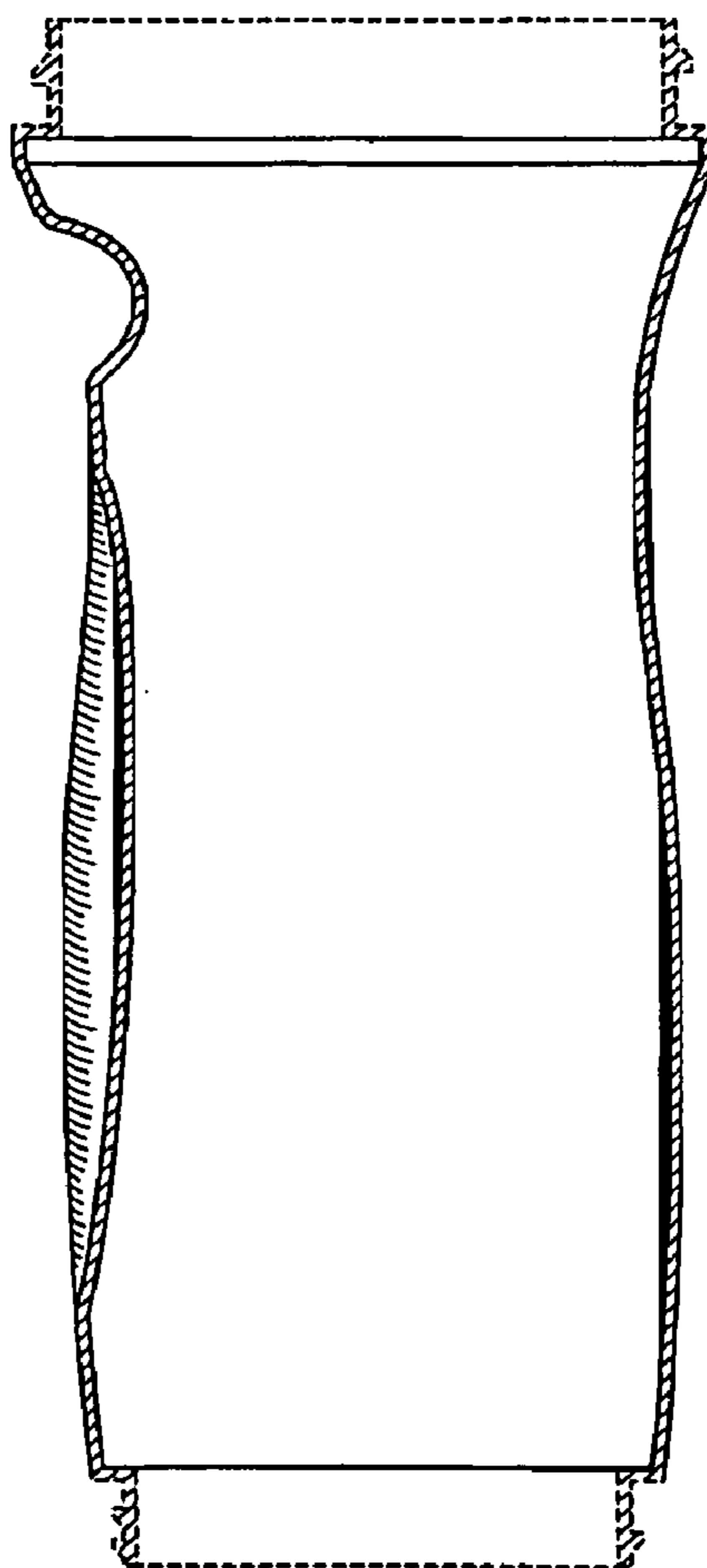
