FIG. 1 is a front, left side, perspective view of a frog figurine according to my new design;

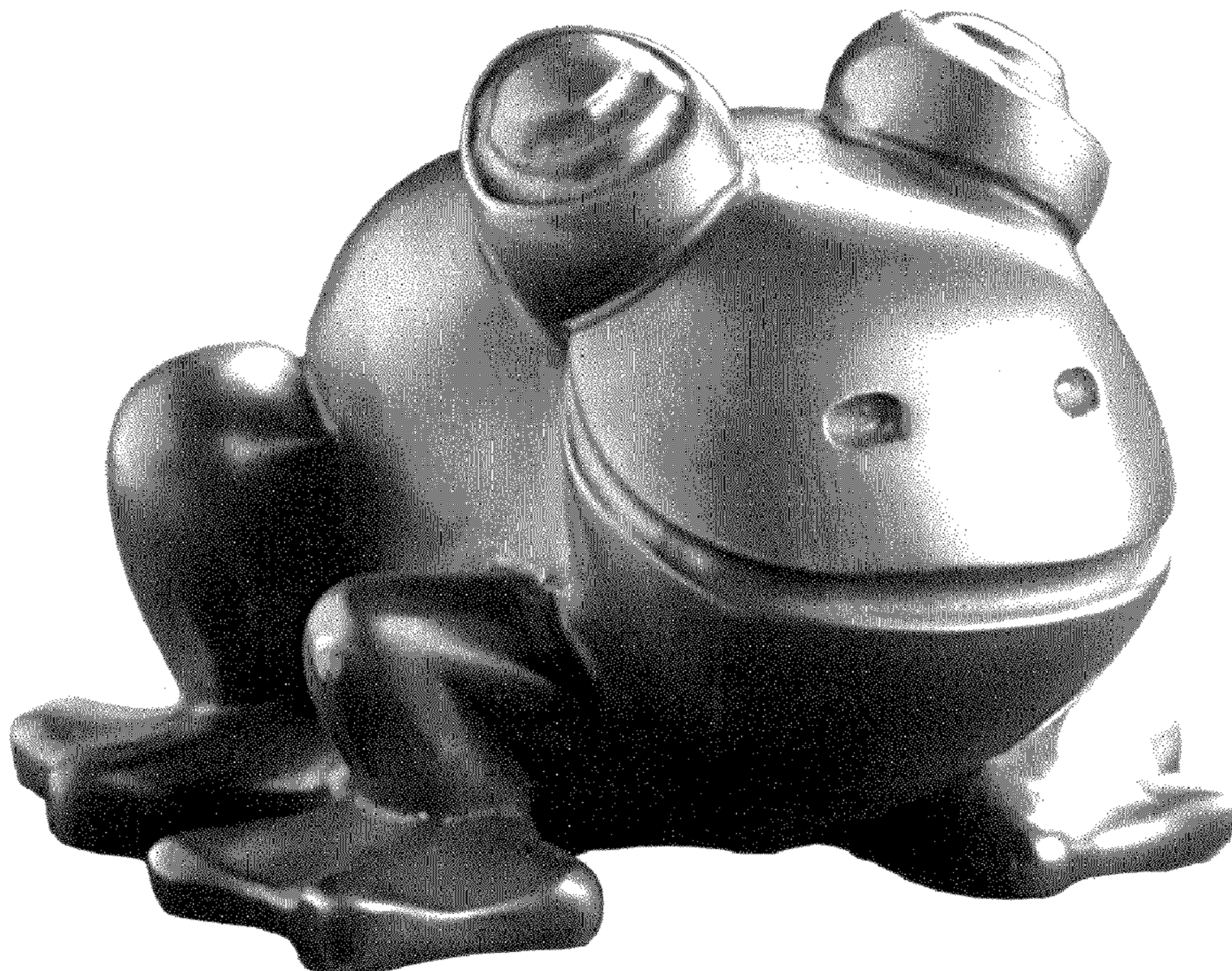
FIG. 2 is a right side perspective view thereof;

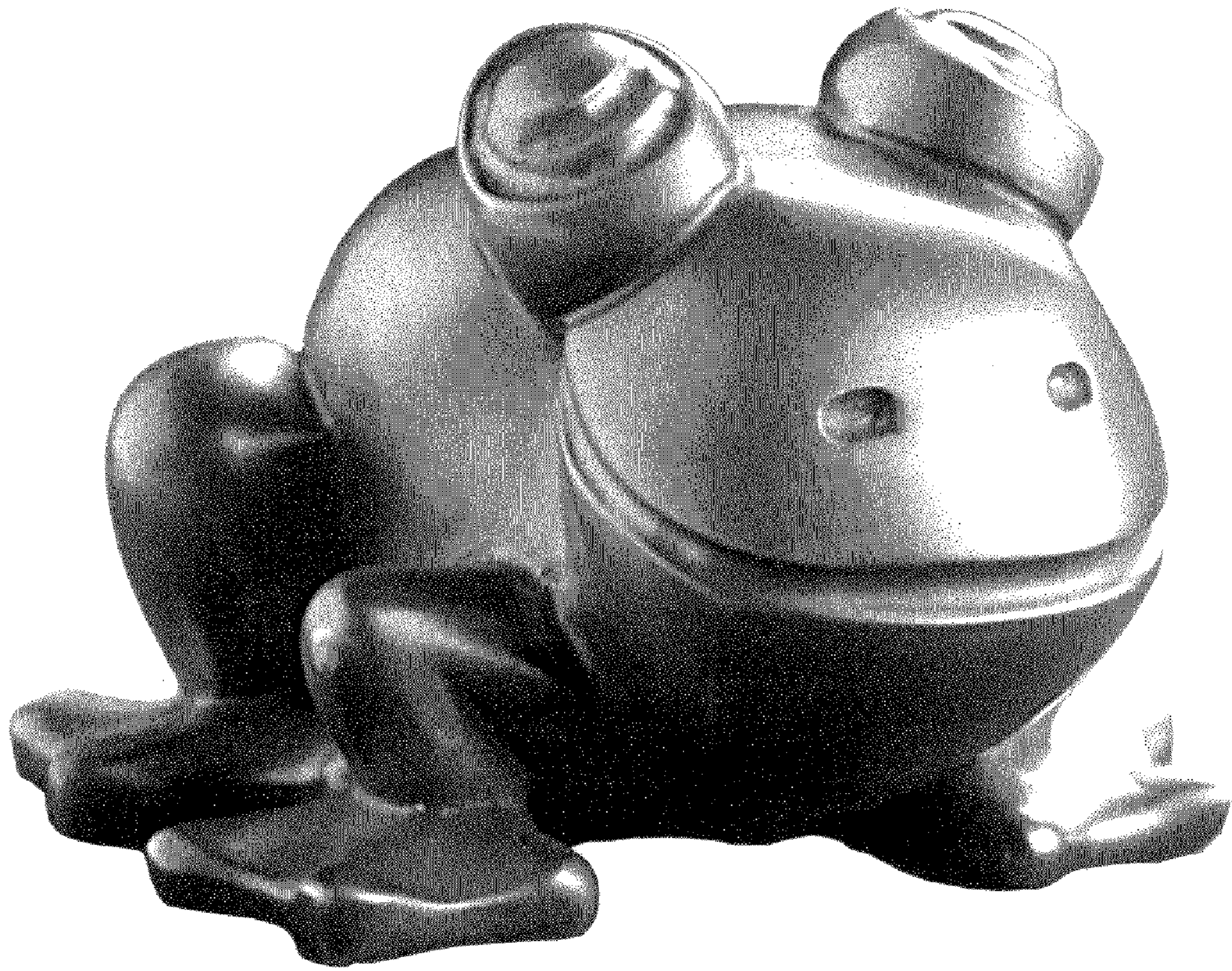
