FIG. 3 is a top plan view of the boring machine;

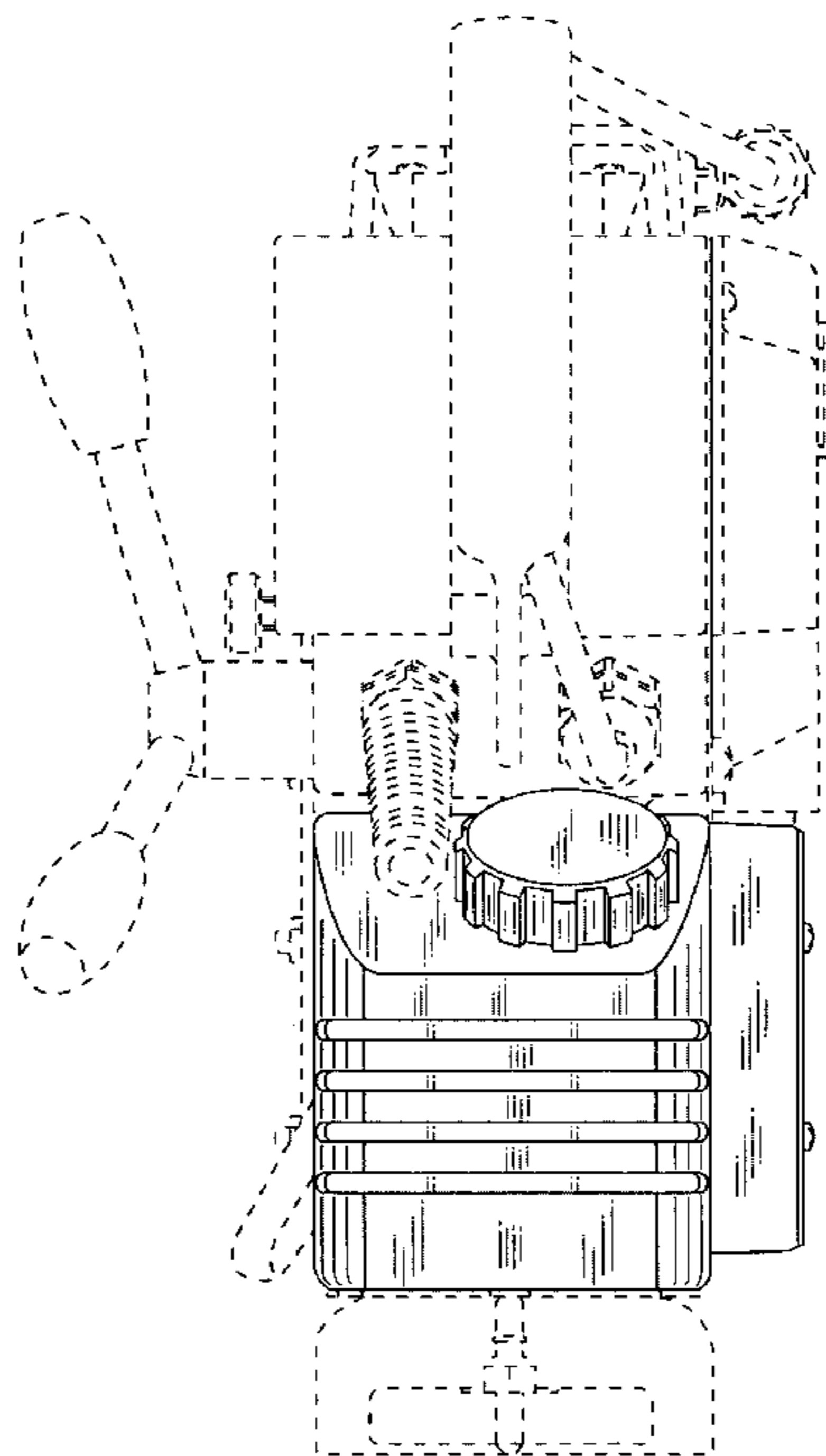
FIG. 4 is a bottom view of the boring machine;

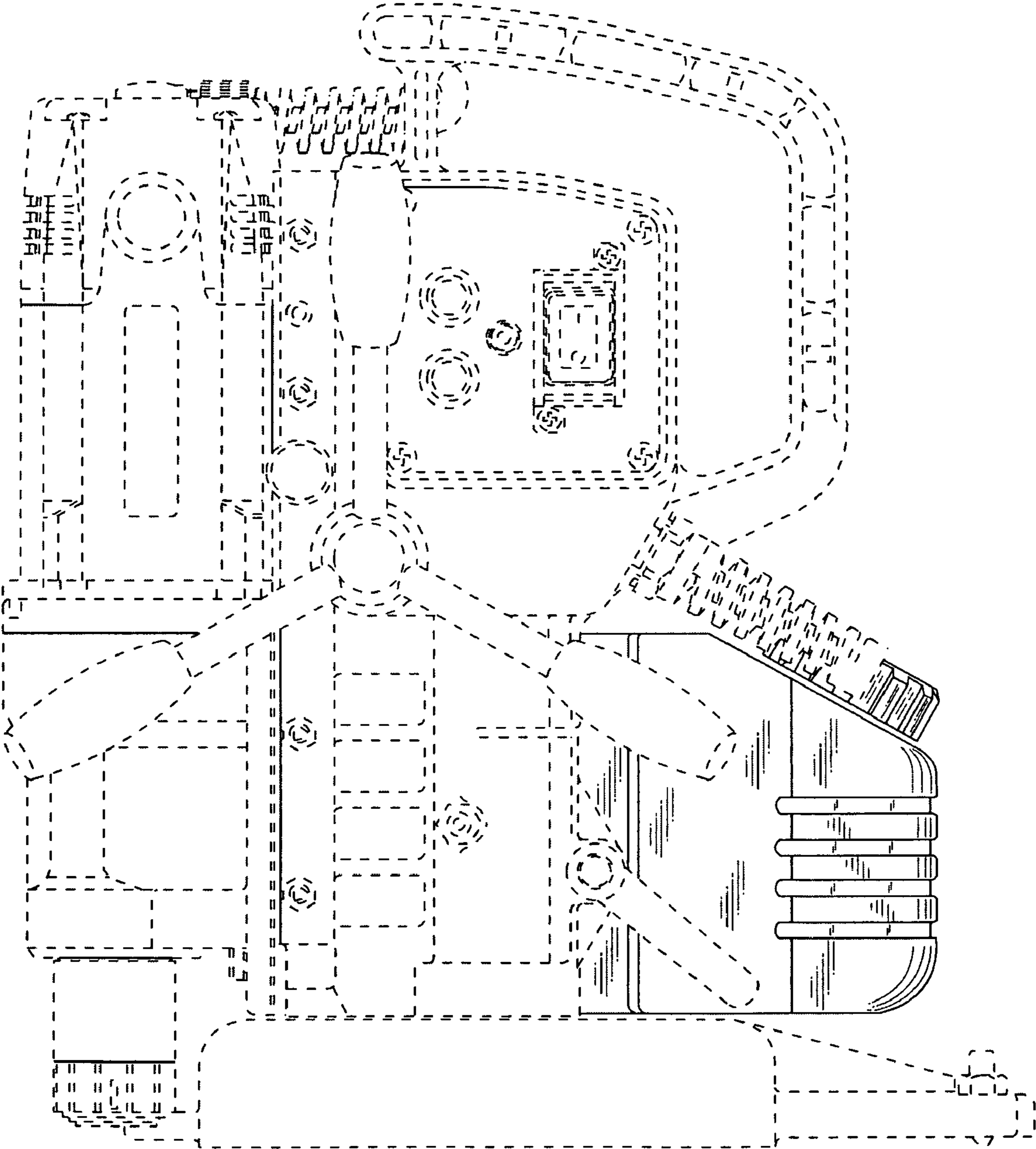

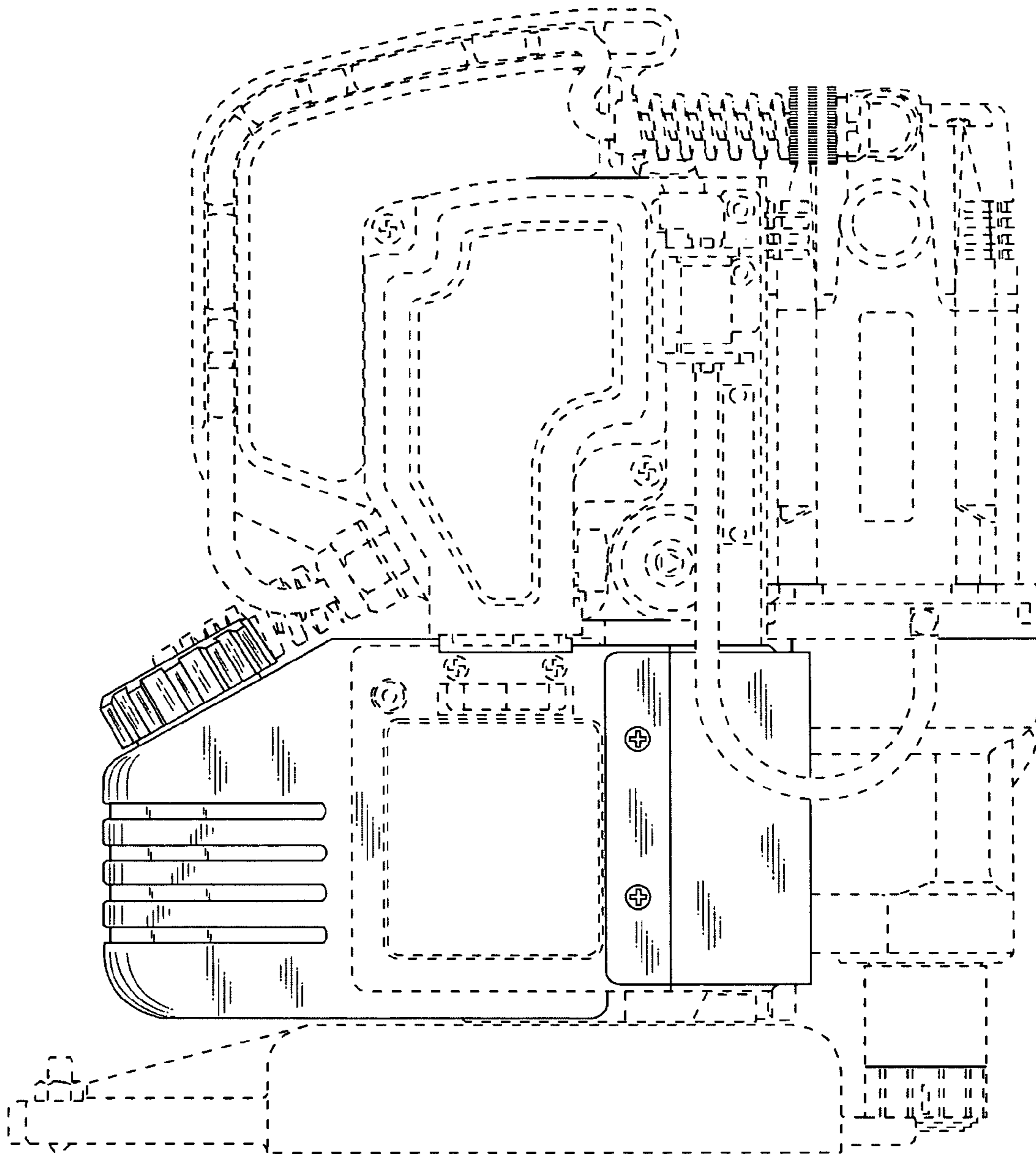

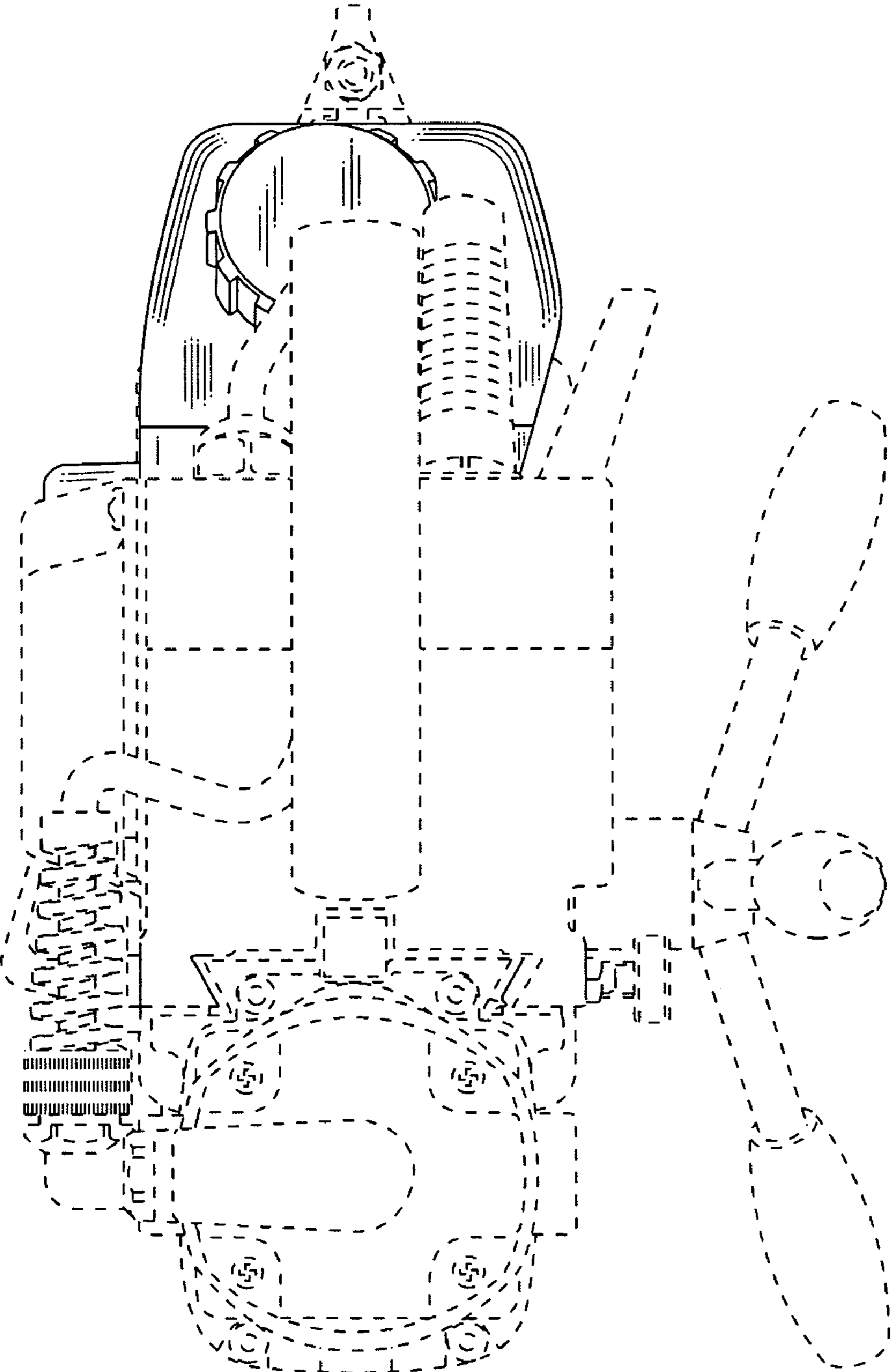

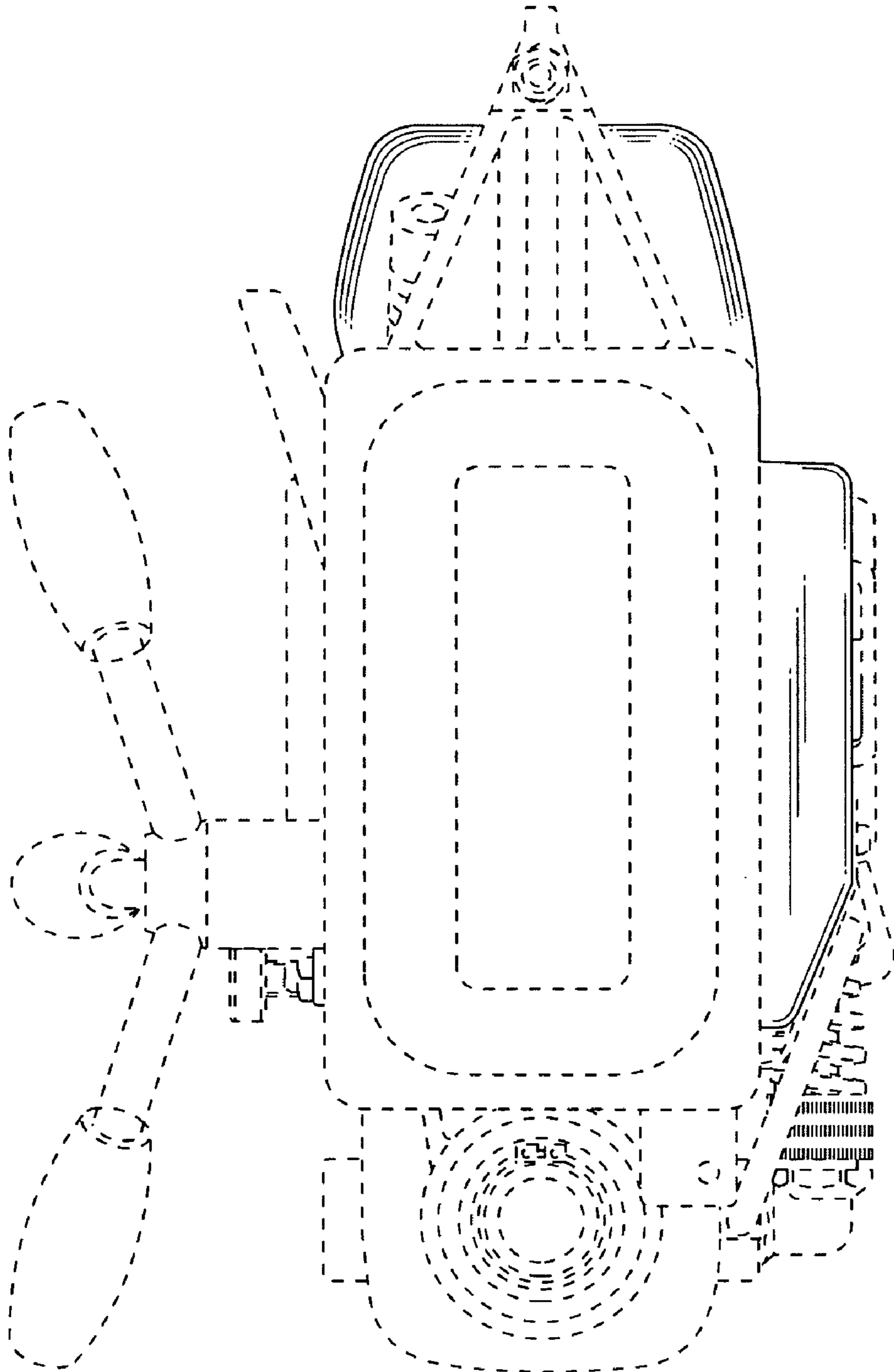

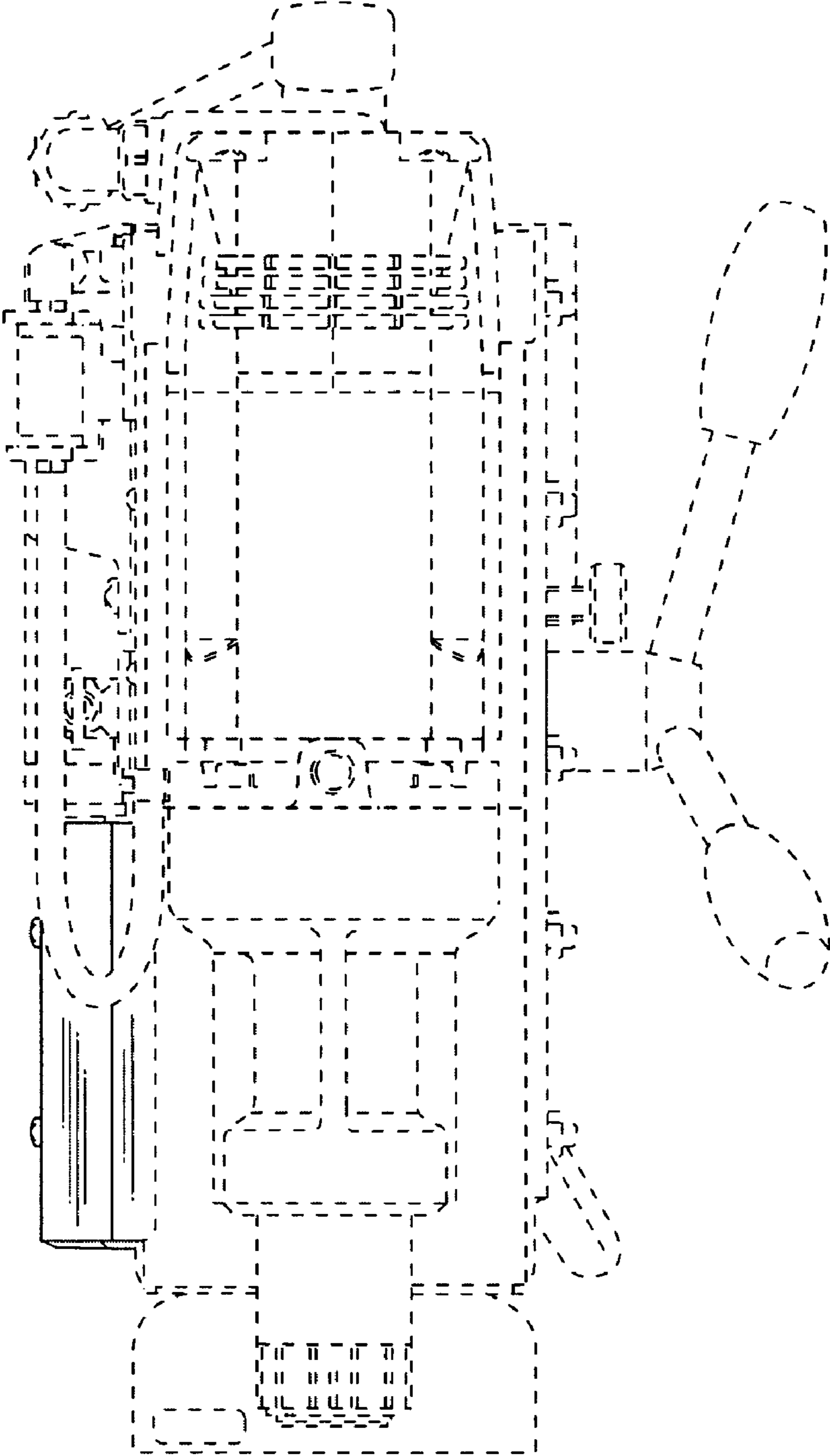

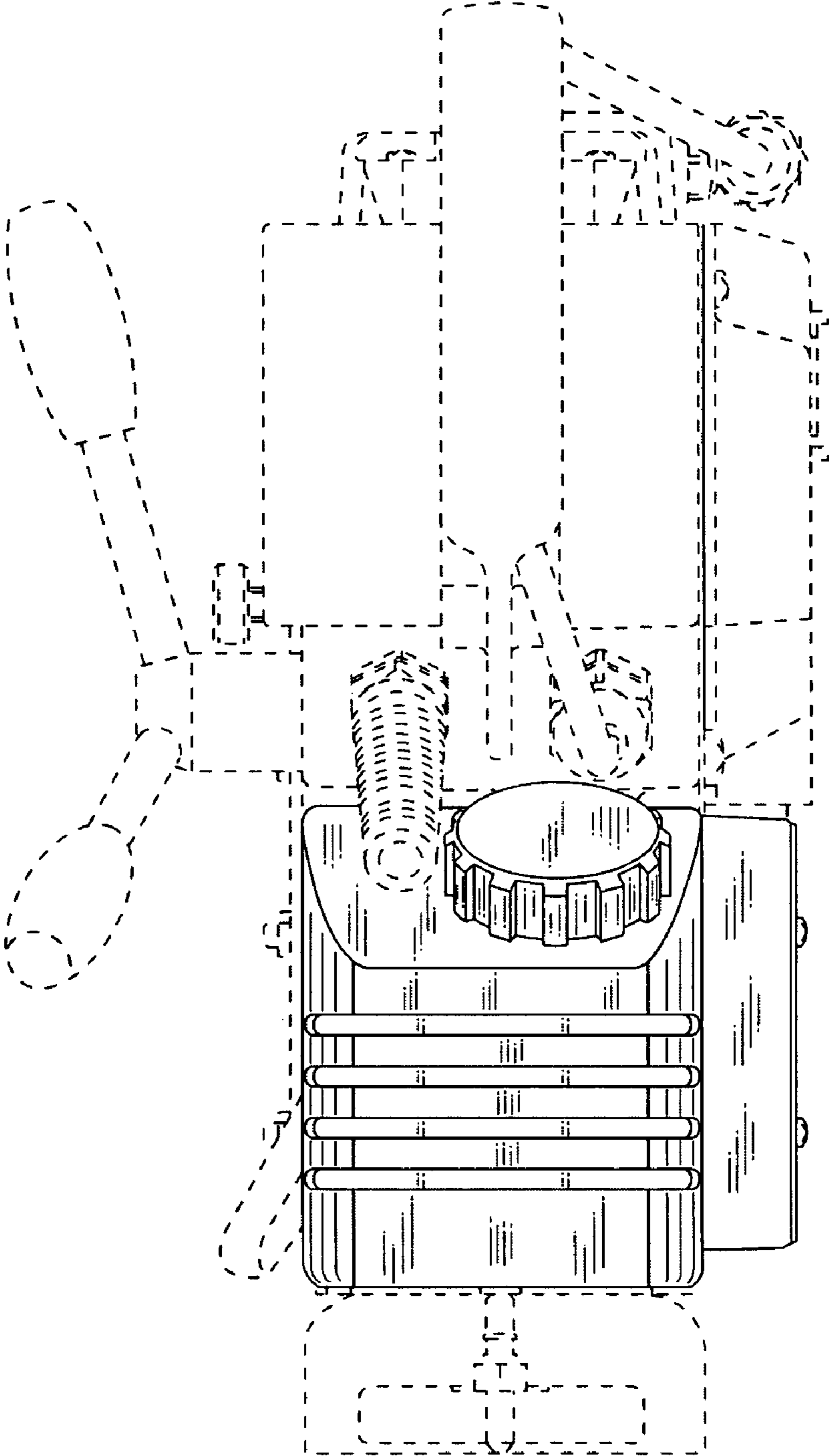
