(57) **CLAIM**

The ornamental design for a pen, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper front right perspective view of a pen showing our new design;

FIG. 2 is a right side elevation view thereof, with the cap removed and placed on the opposite end of the pen;

FIG. 3 is a left side elevation view of the pen shown in FIG. 1;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevation view thereof;

FIG. 6 is a right side elevation view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a rear elevation view thereof;

FIG. 9 is a front elevation view thereof, shown without the cap for convenience of illustration;

FIG. 10 is a right side elevation view thereof;

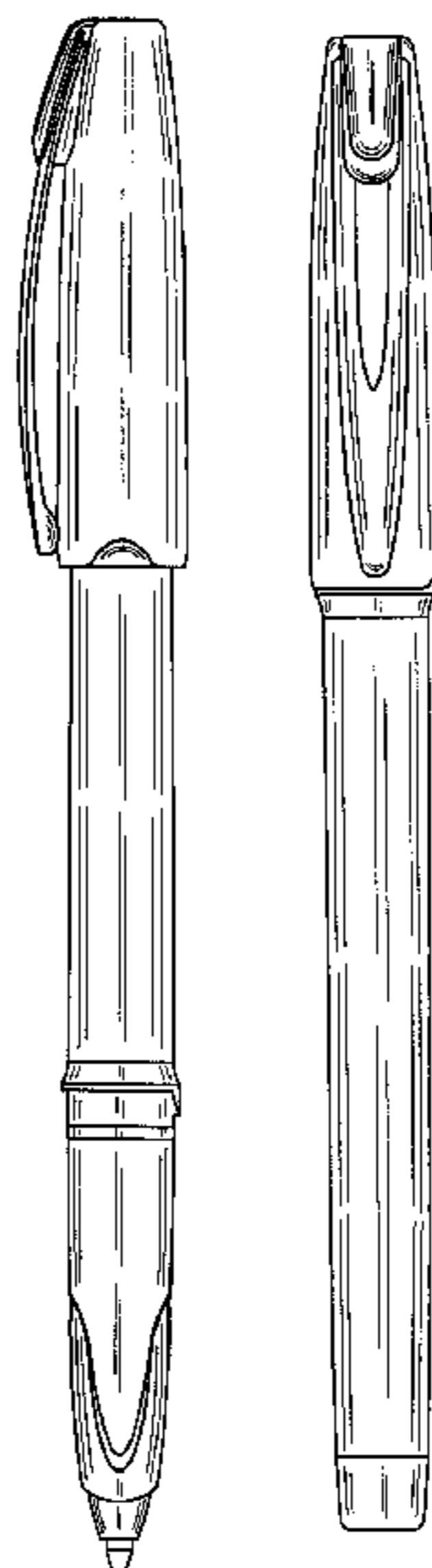
FIG. 11 is rear elevation view thereof;

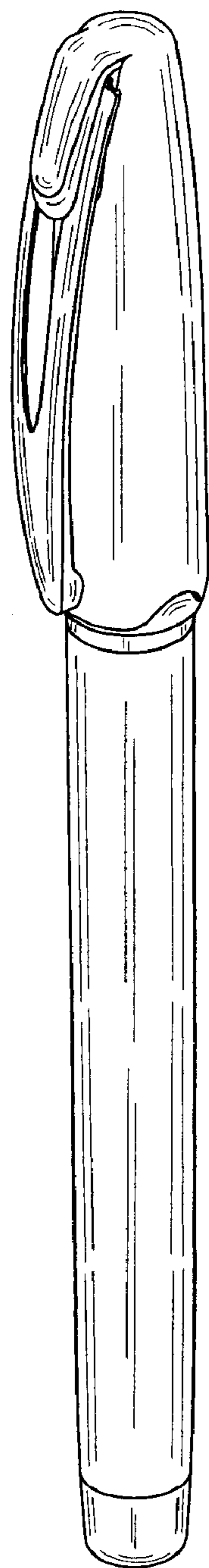
FIG. 12 is a left side elevation view thereof;

FIG. 13 is a bottom plan view thereof; and,

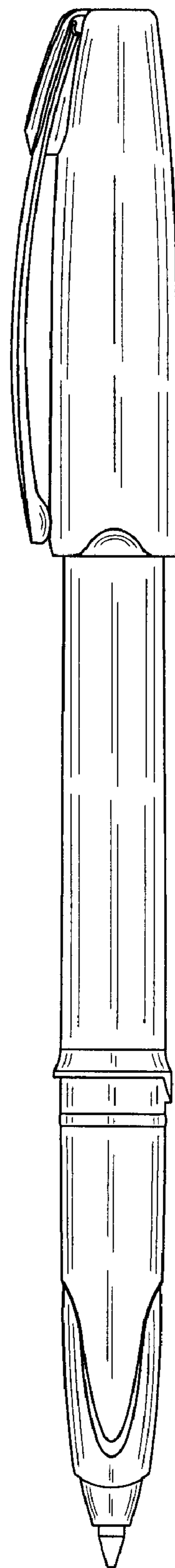
FIG. 14 is a top plan view thereof, with the cap removed.

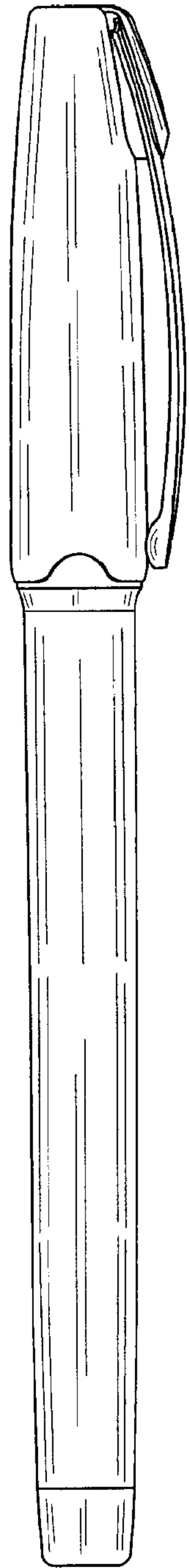




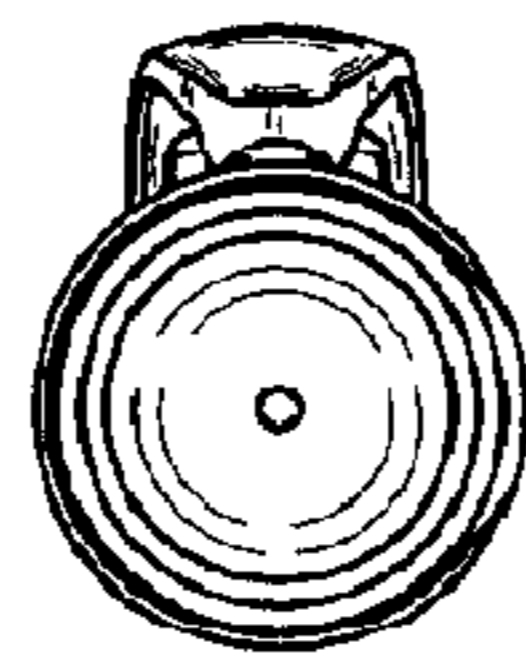

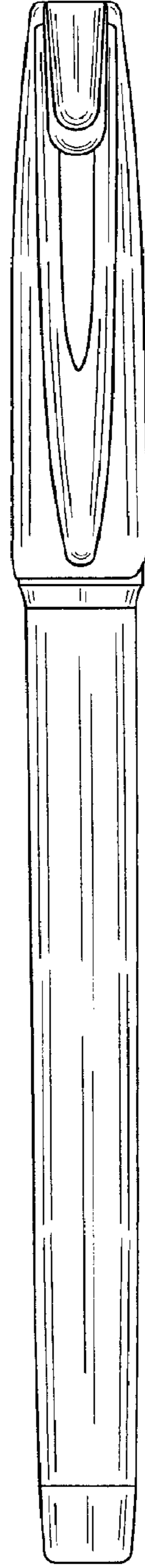

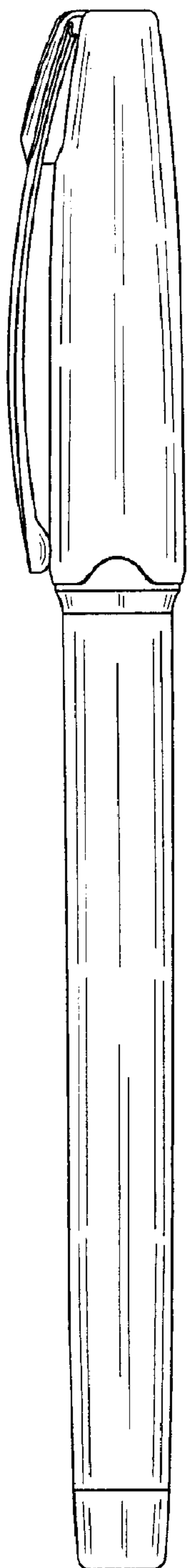

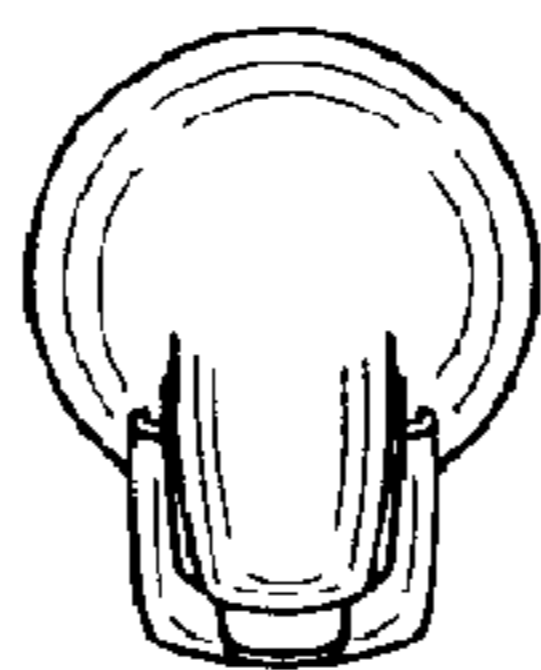

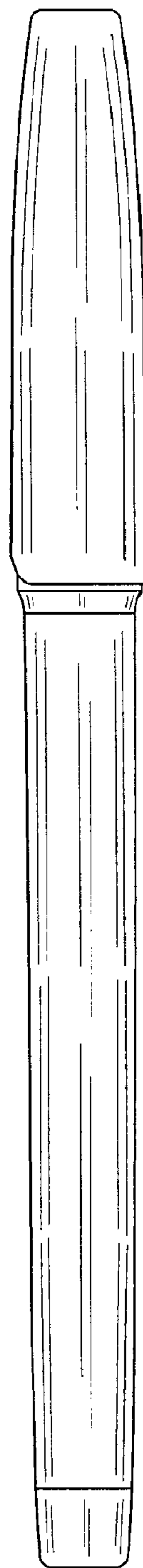

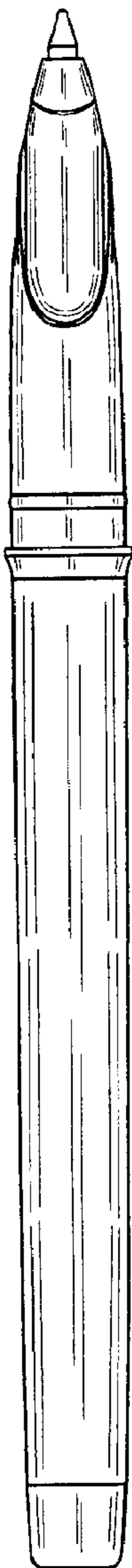

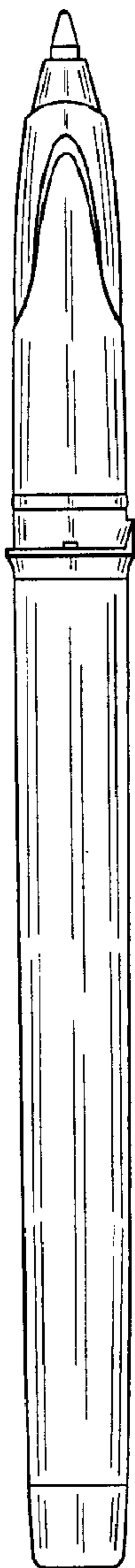

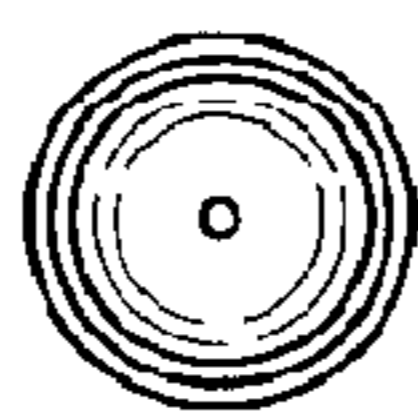
