FIG. 1 is a front view of the writing instrument of the present application;

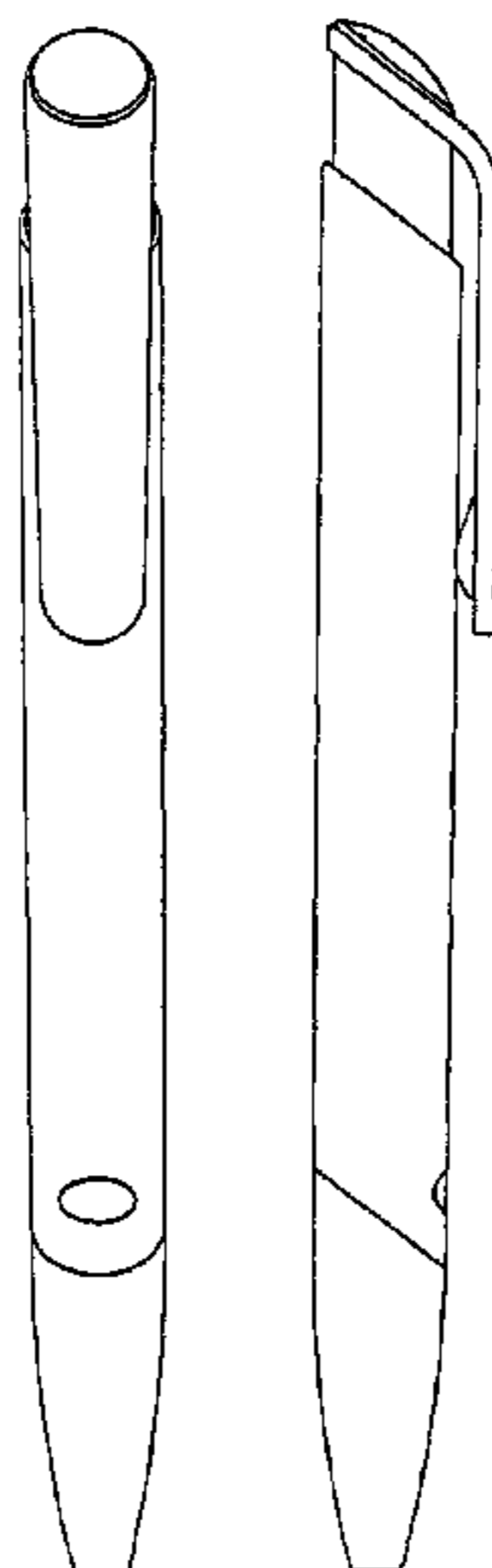
FIG. 2 is a back view of the writing instrument;

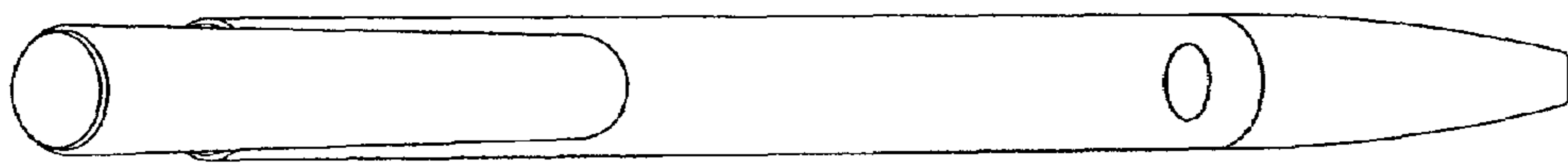

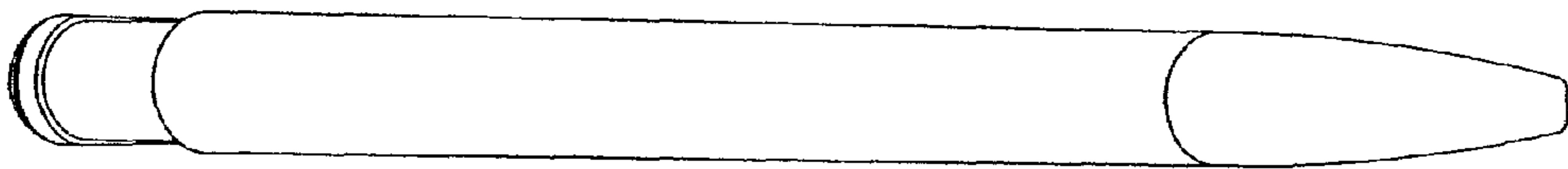

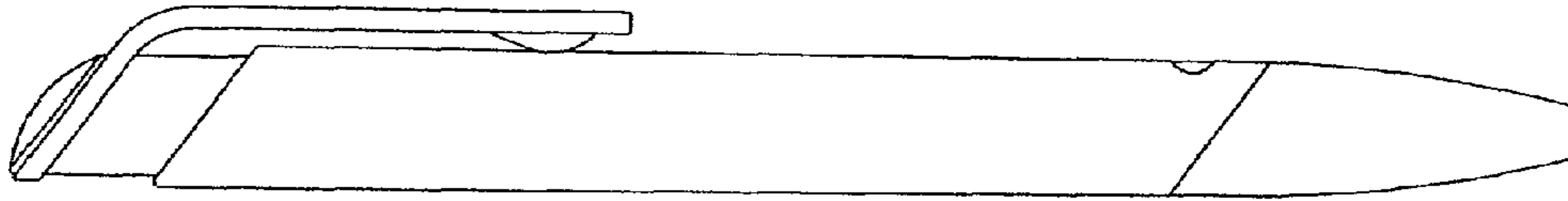

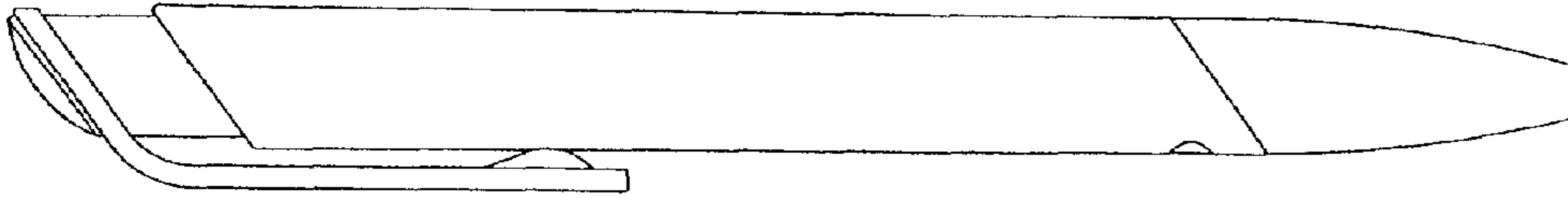

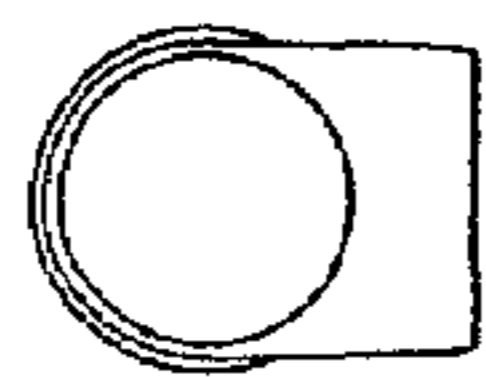
