(57) **CLAIM**

The ornamental design for a pen, as shown and described.

DESCRIPTION

- FIG. 1 is an upper front right perspective view of a pen showing my new design;
- FIG. 2 is an exploded lower front right perspective view thereof;
- FIG. 3 is an upper rear right perspective view of the pen shown in FIG. 1, with the cap removed and placed on the opposite end of the pen;
- FIG. 4 is a top plan view of the pen shown in FIG. 1;
- FIG. 5 is a bottom plan view thereof;
- FIG. 6 is a front elevation view thereof;
- FIG. 7 is a right side elevation view thereof;
- FIG. 8 is a rear elevation view thereof; and,
- FIG. 9 is a left side elevation view thereof.

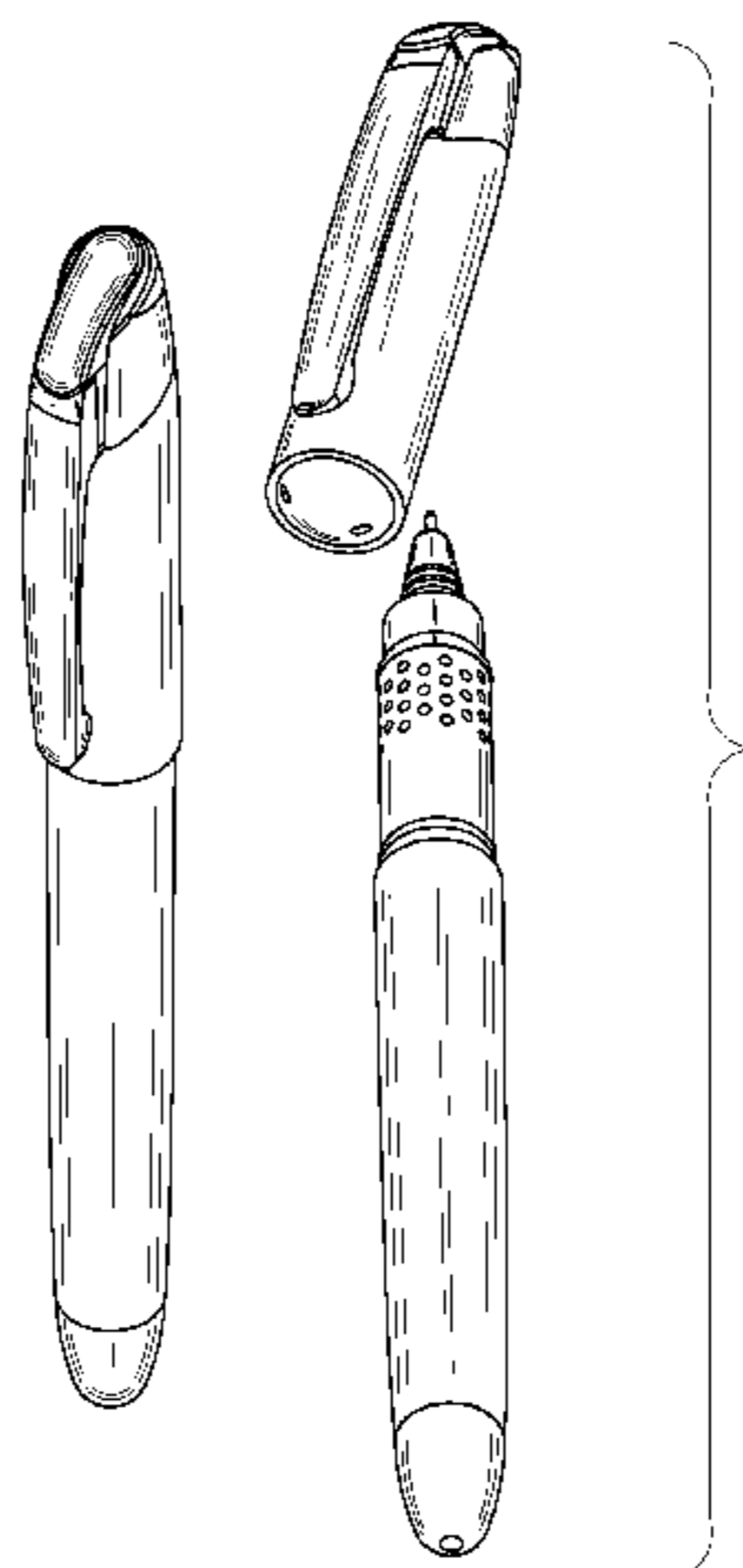

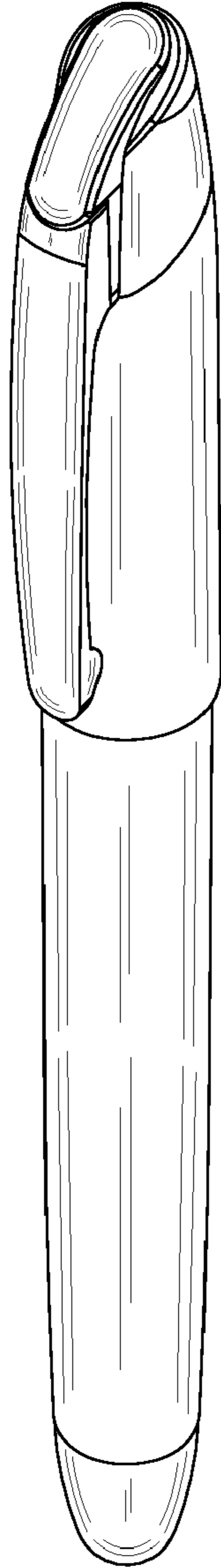
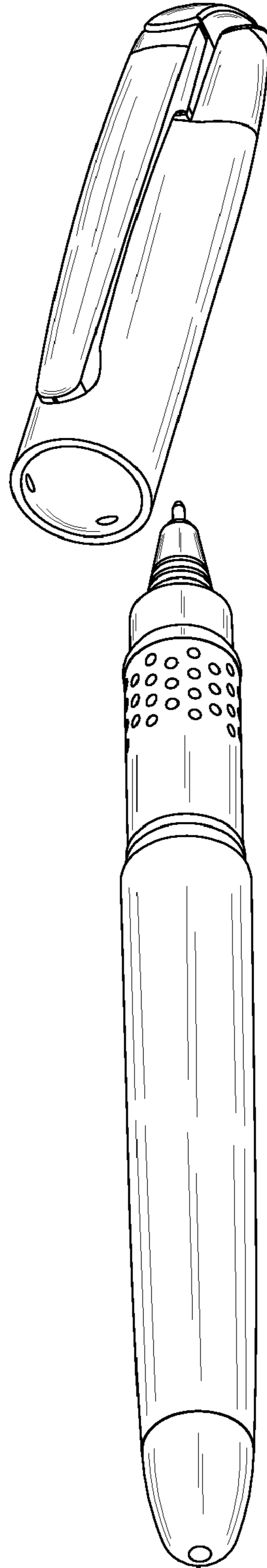

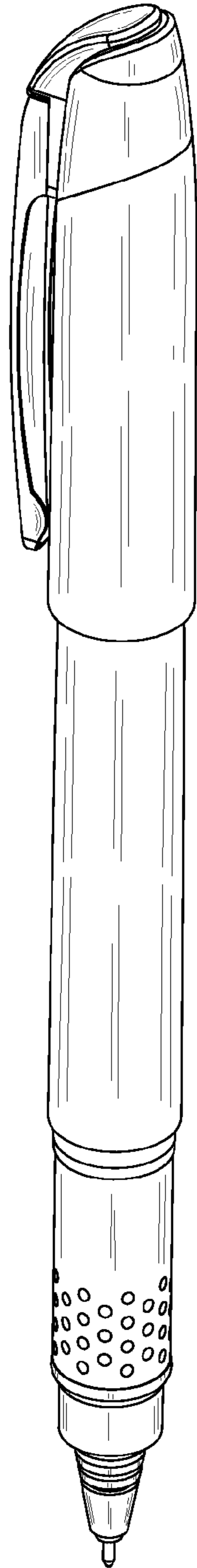

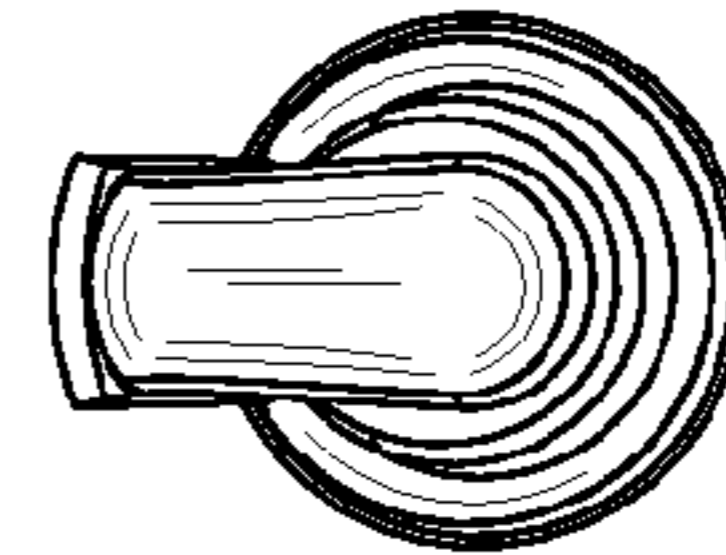

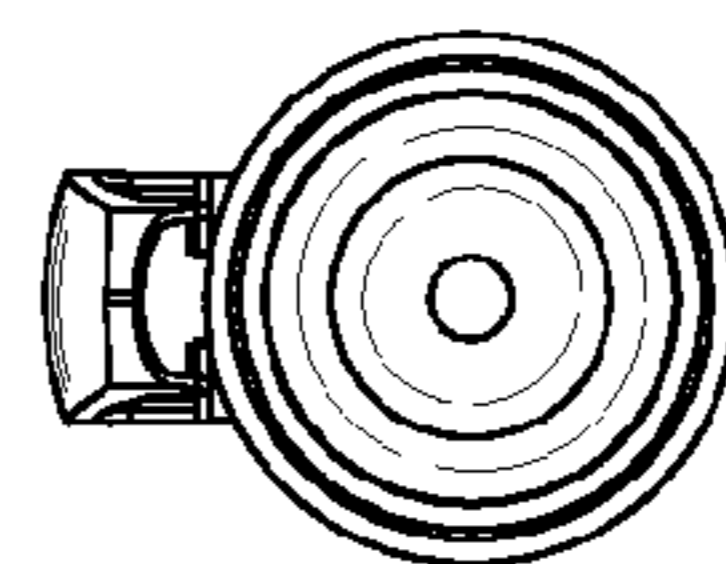

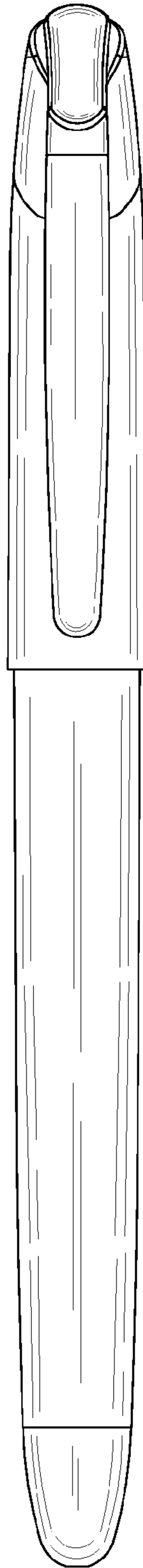

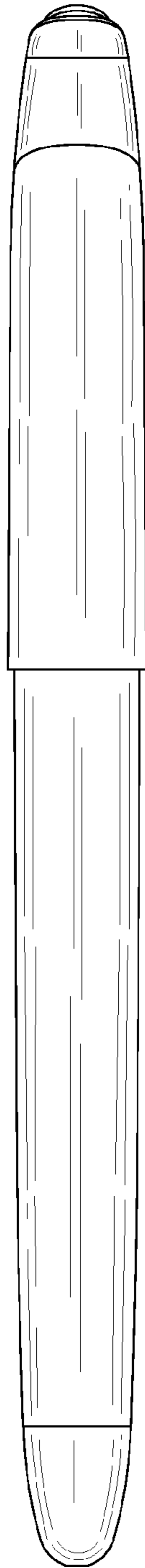

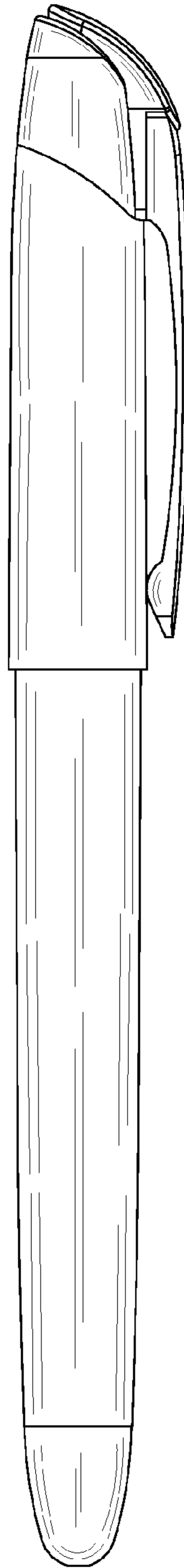
