FIG. 3 is a top view of FIG. 1.

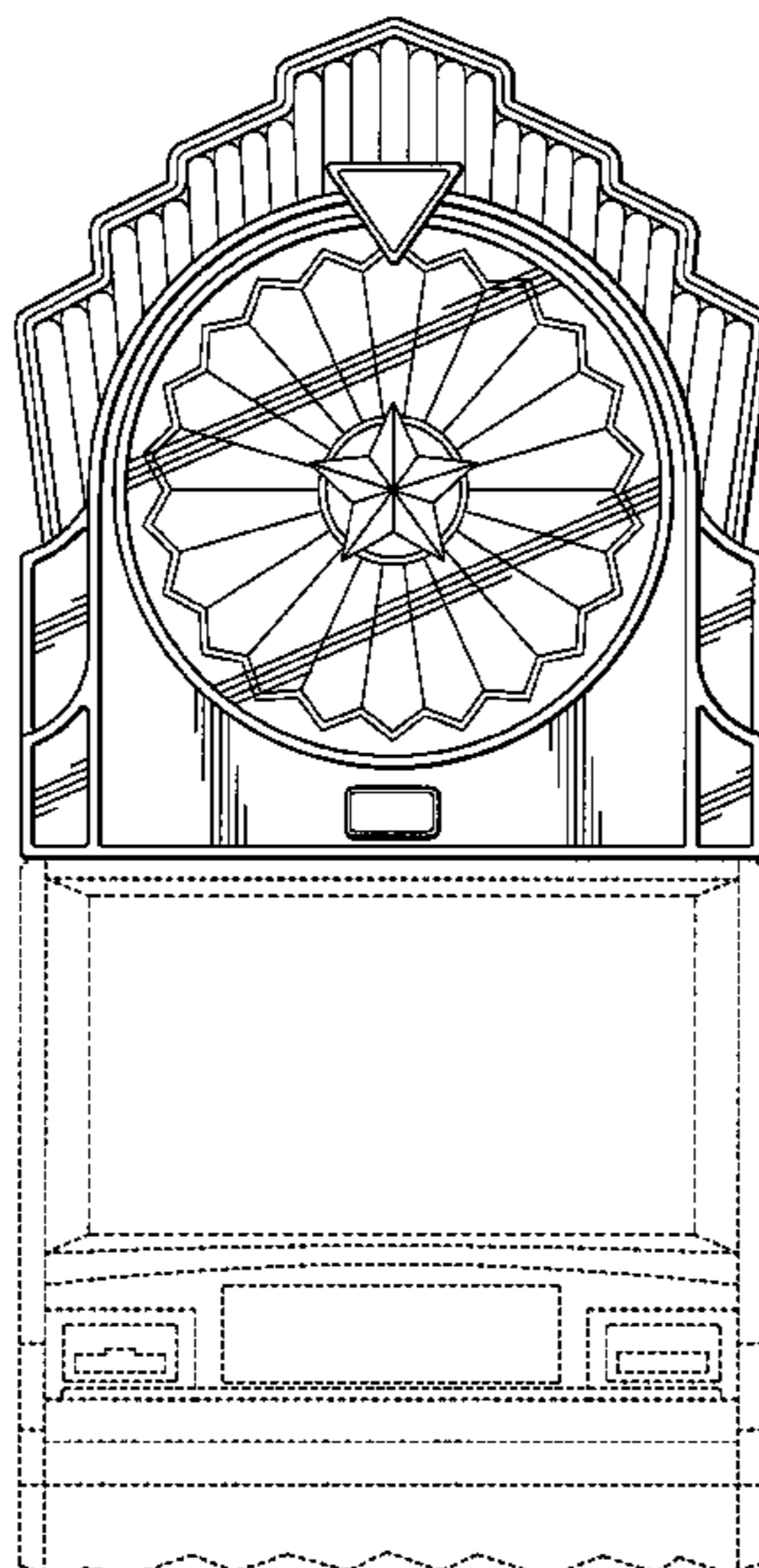
FIG. 4 is a front view of a secondary gaming console, showing a second embodiment thereof;

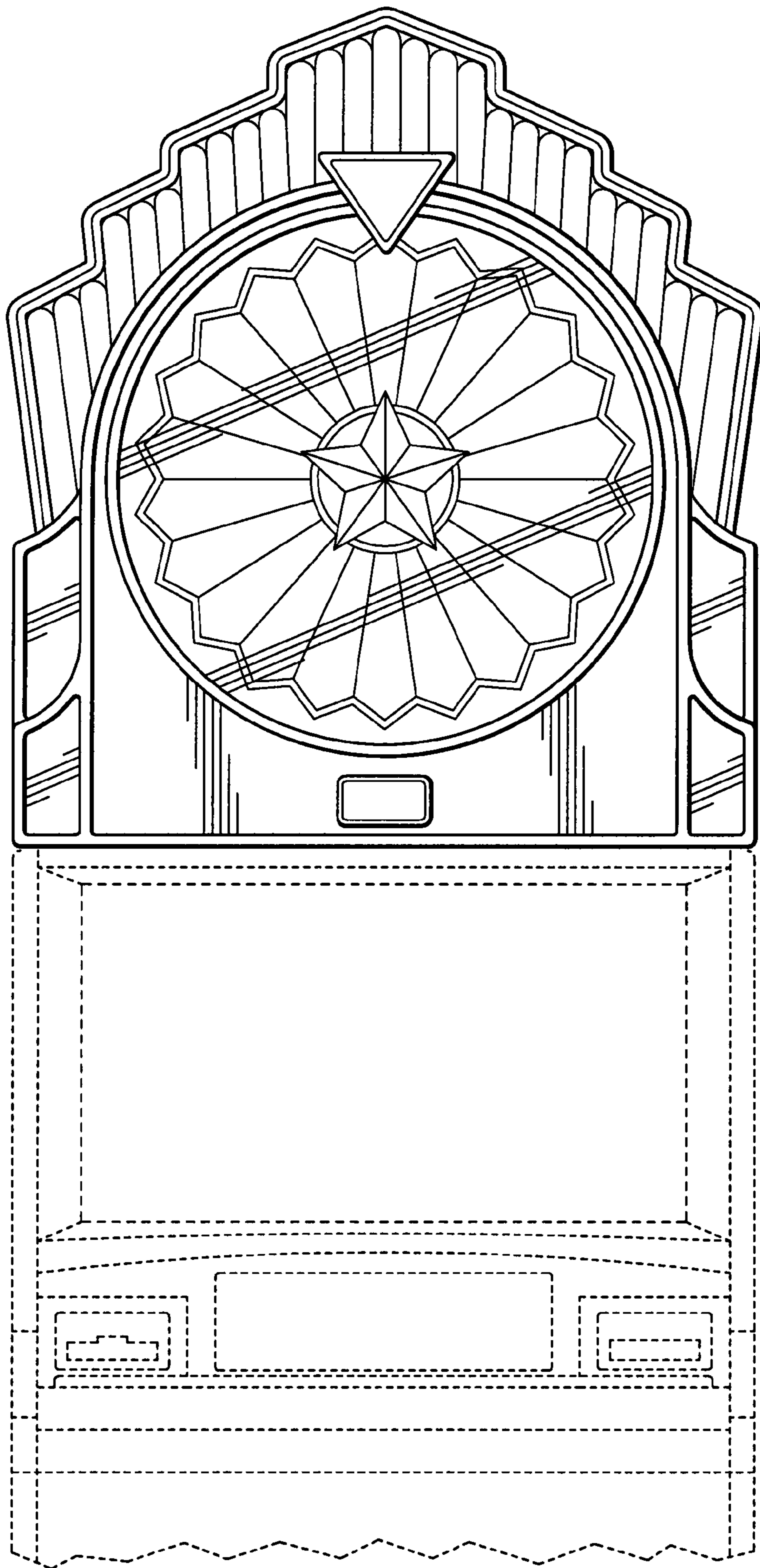

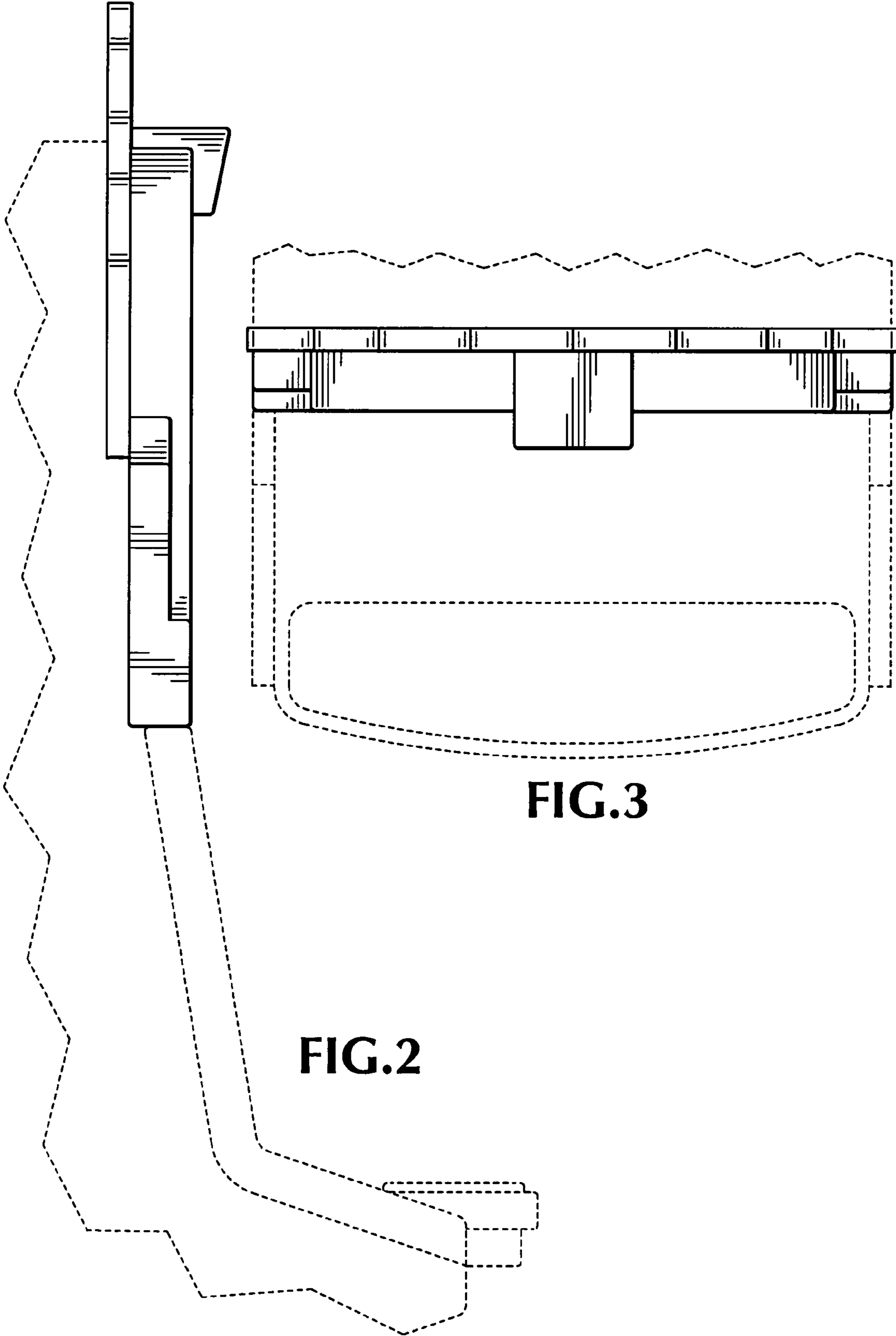

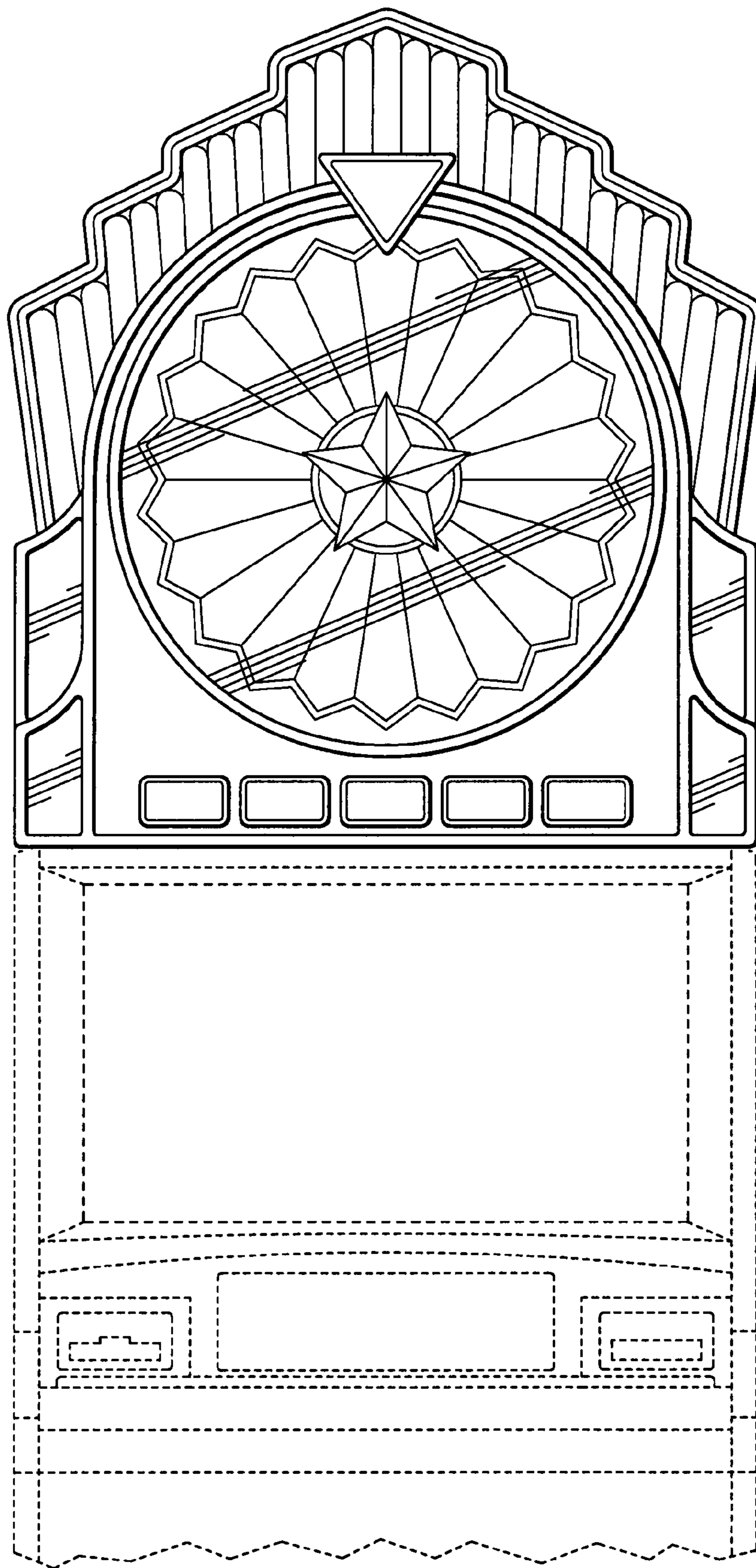

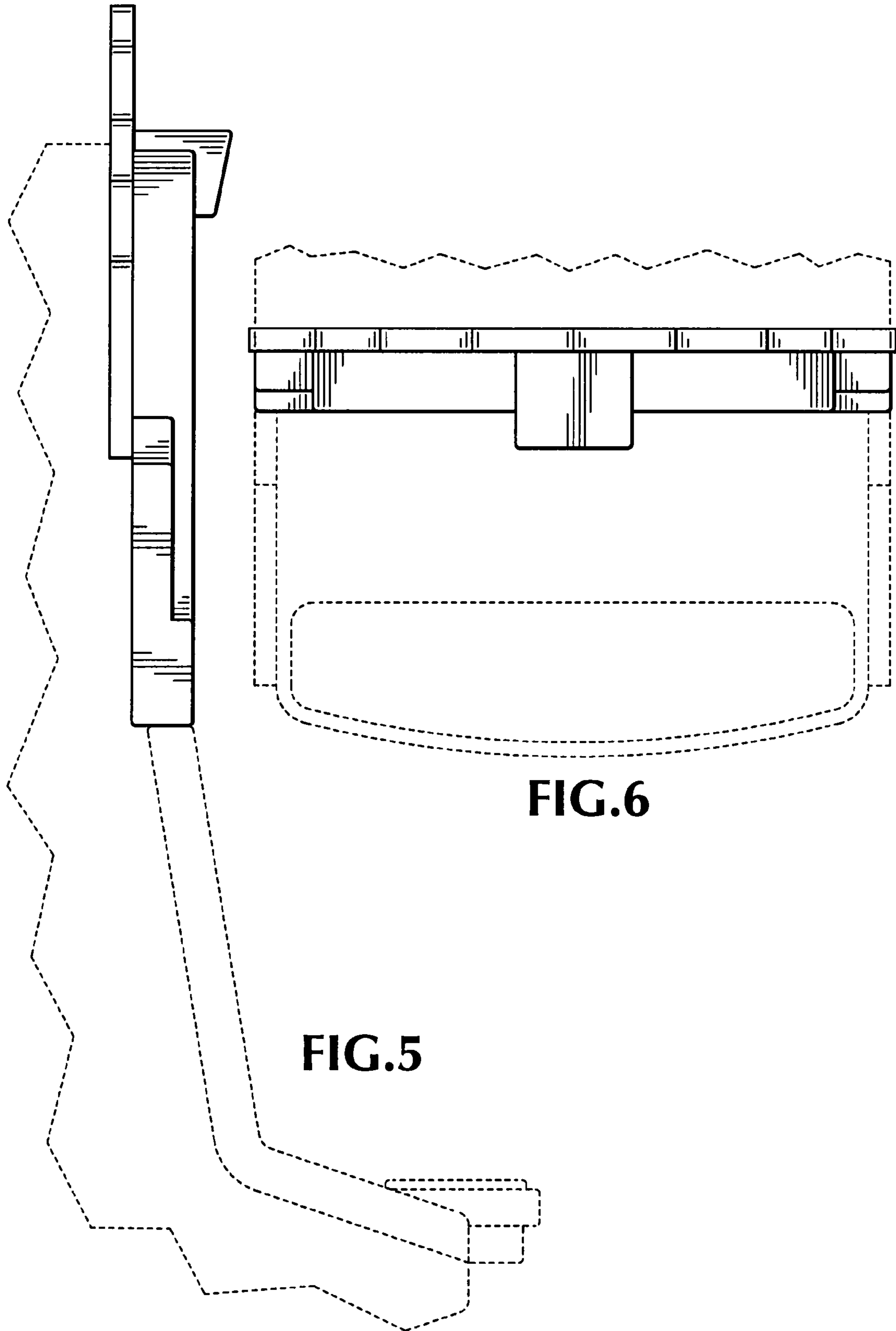
