The ornamental design of a hand-held spray head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hand-held spray head according to a first embodiment of the present invention;

FIG. 2 is a left side elevational view of the hand-held spray head of FIG. 1;

FIG. 3 is a right side elevational view of the hand-held spray head of FIG. 1;

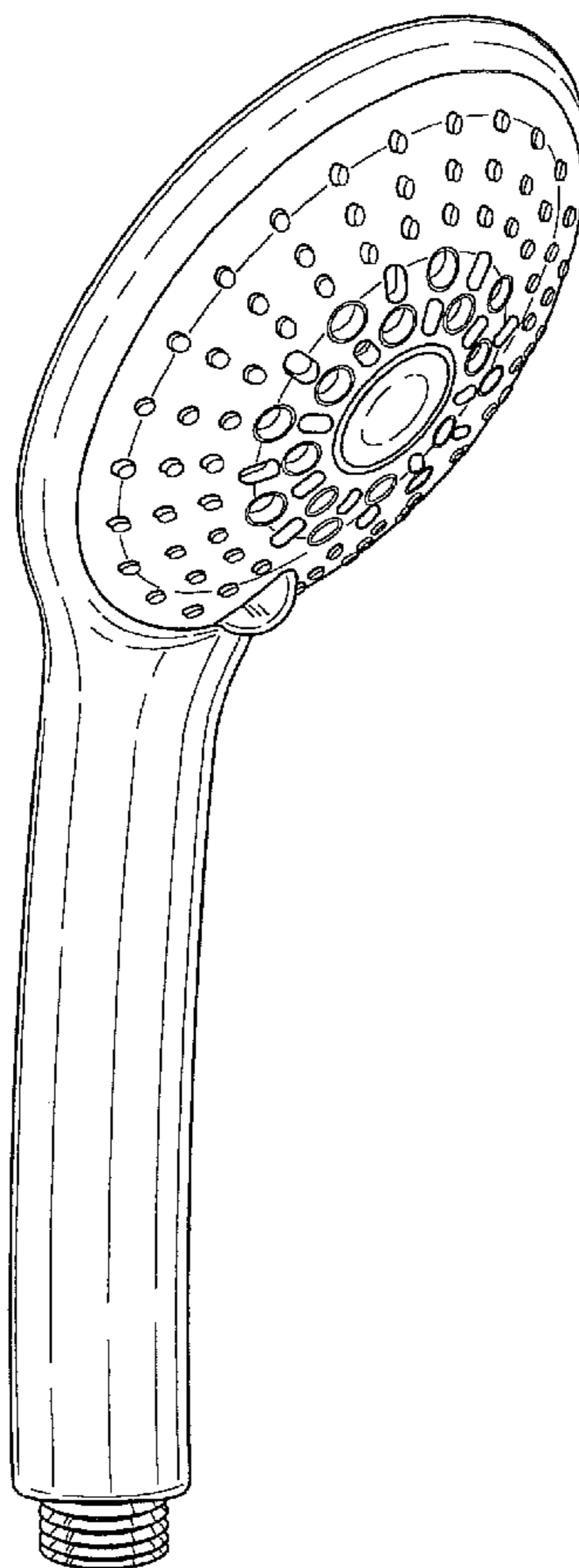
FIG. 4 is a rear elevational view of the hand-held spray head of FIG. 1;

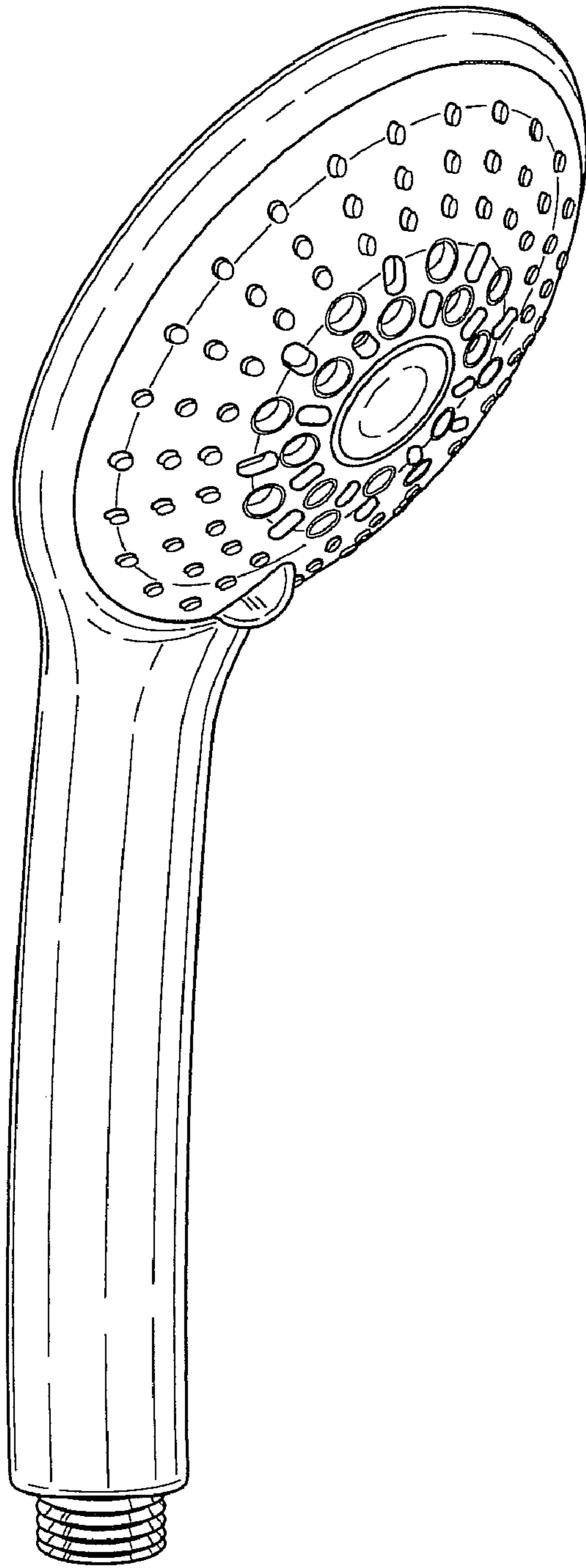

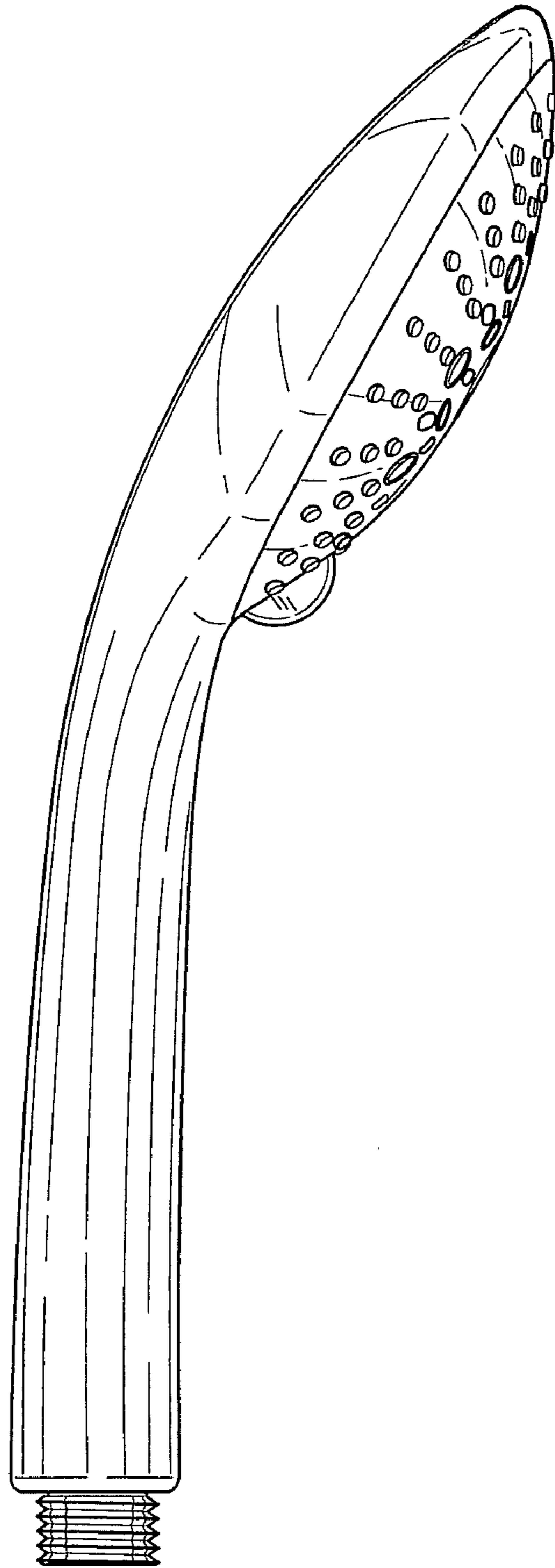

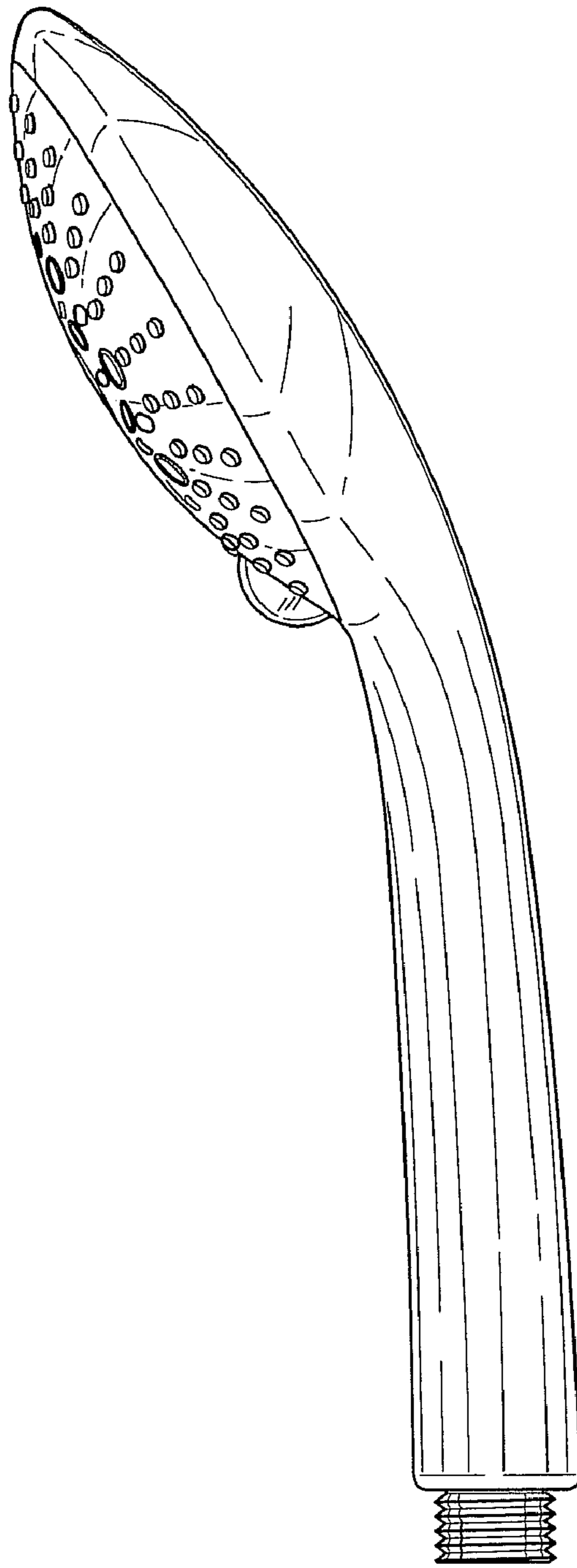

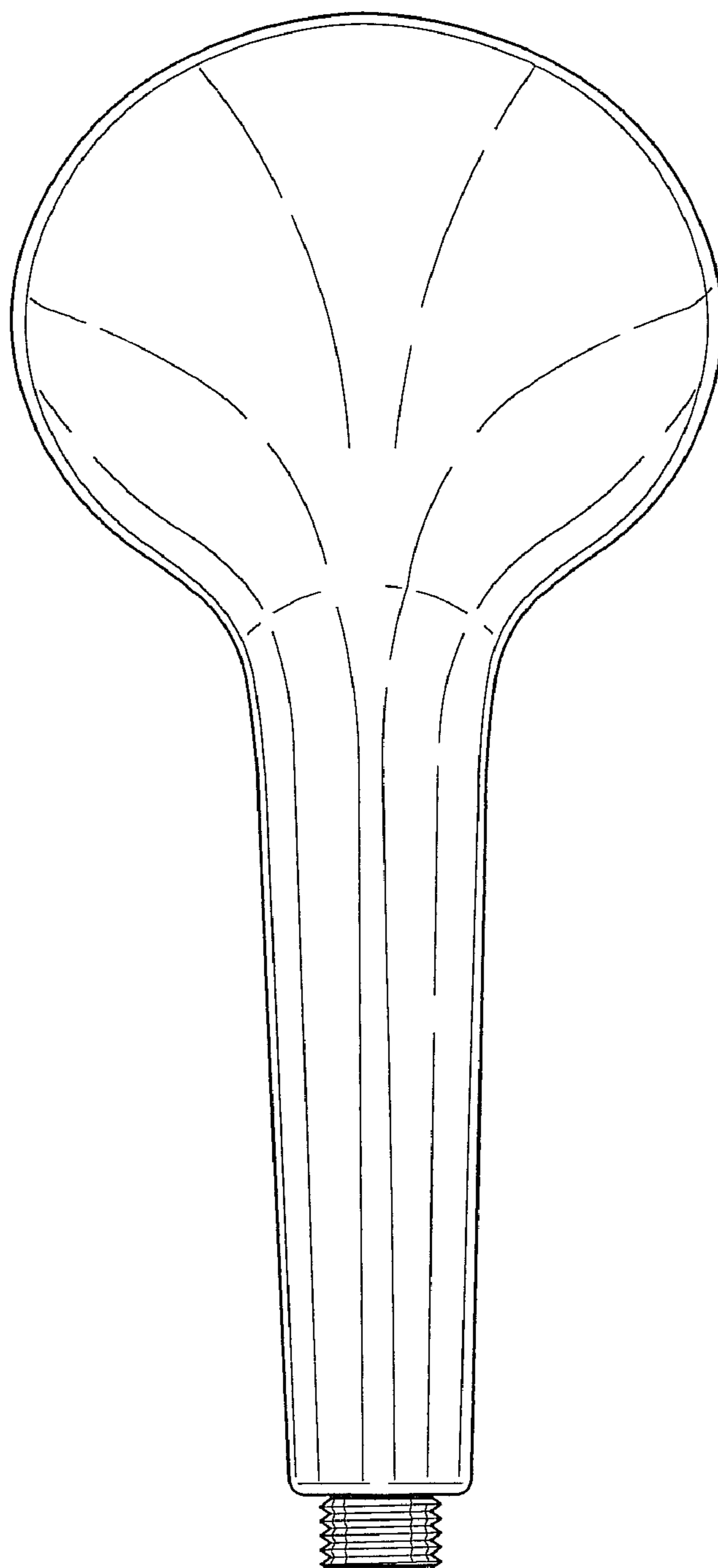

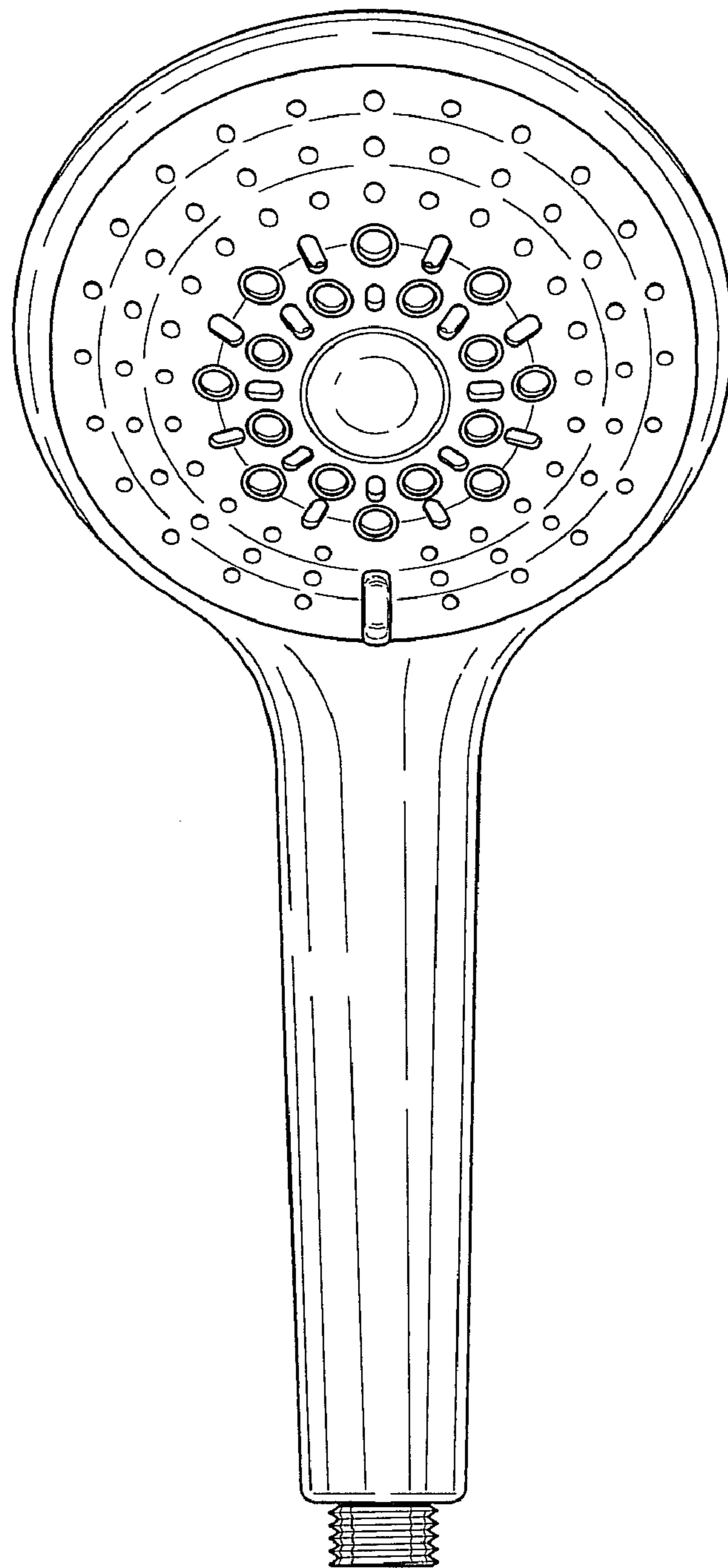

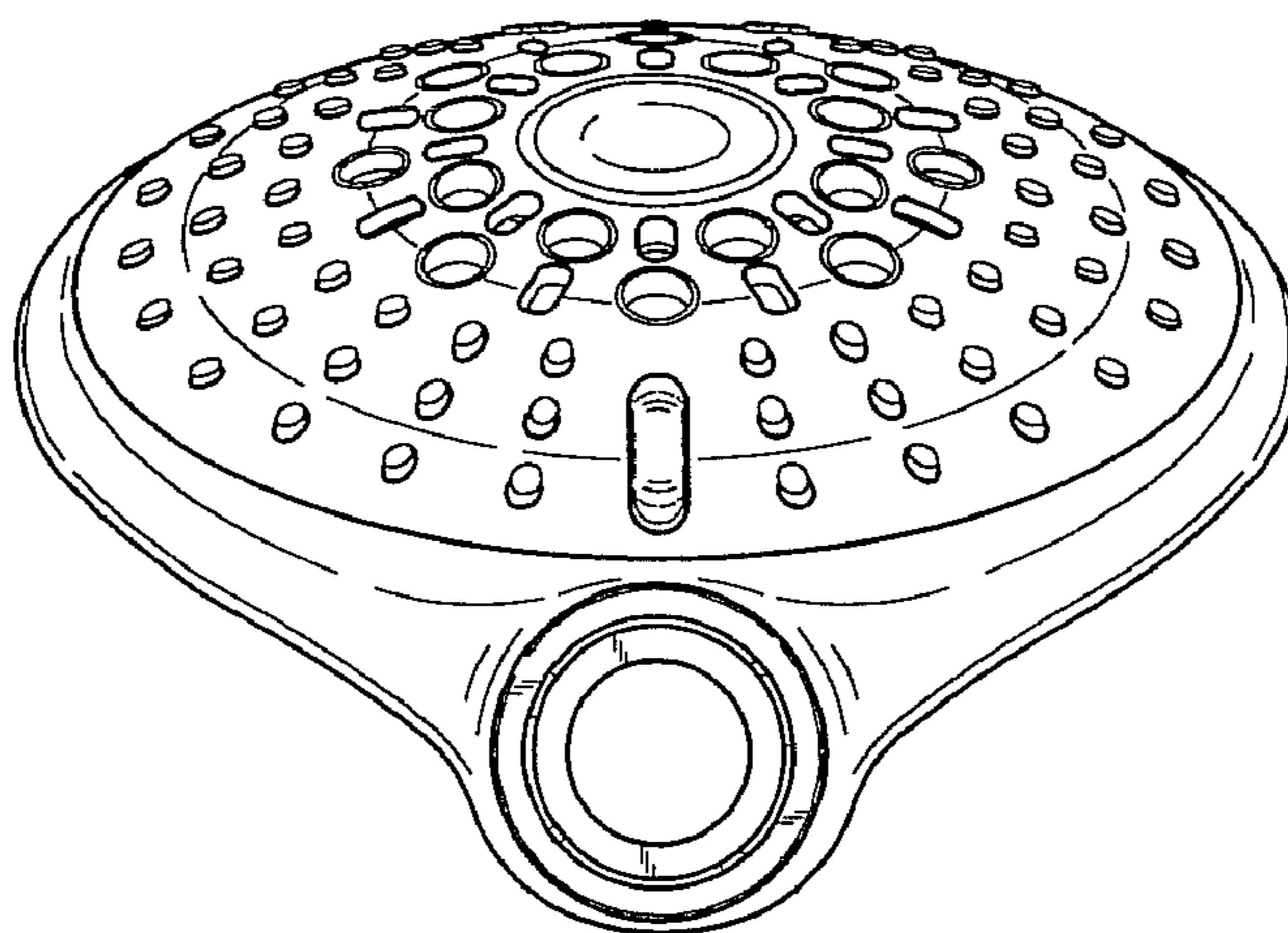

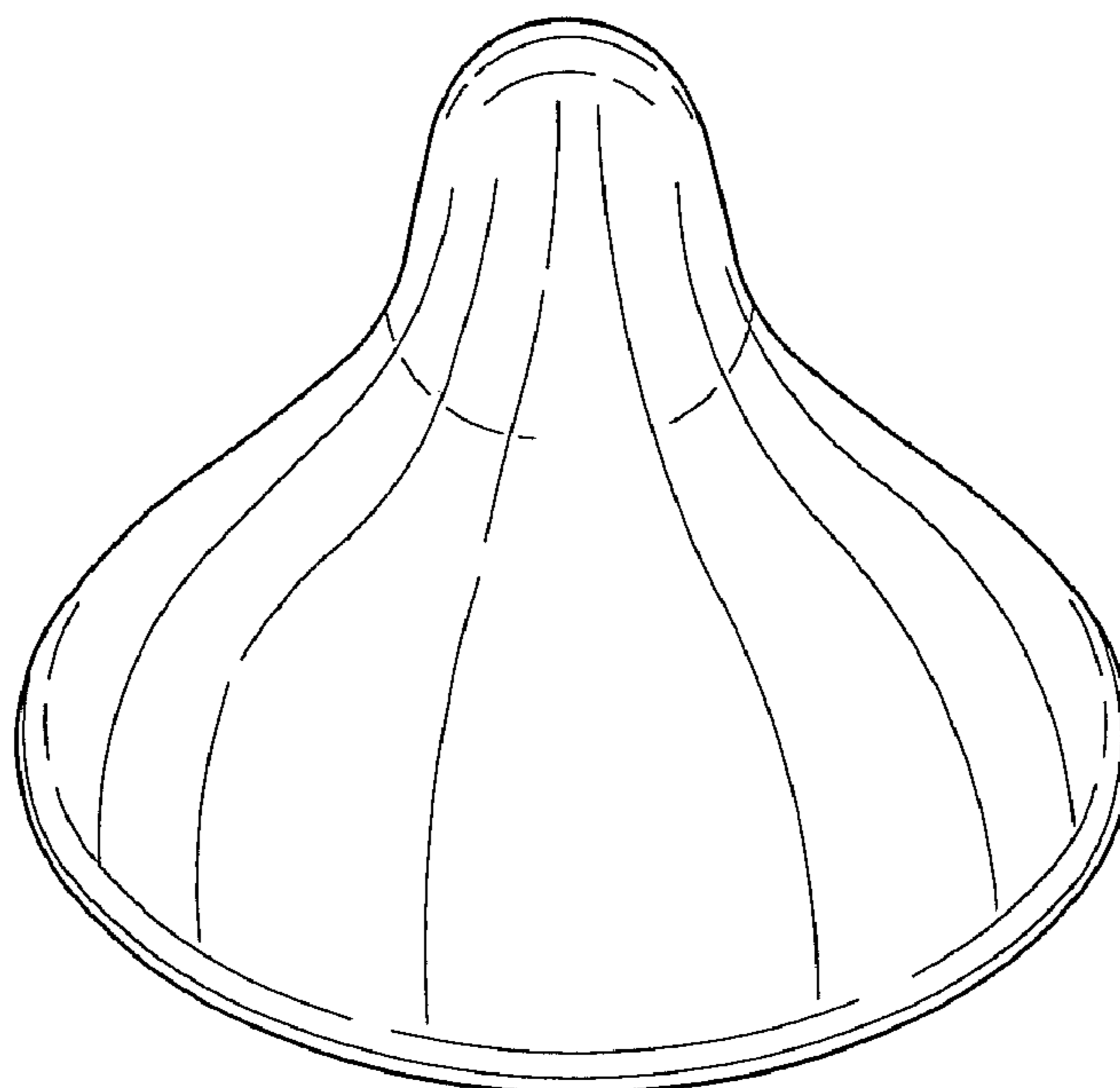
