DESCRIPTION

FIG. 1 is a front perspective view of a frame for a respiratory mask according to an embodiment of our design;

FIG. 3 is a rear view thereof;

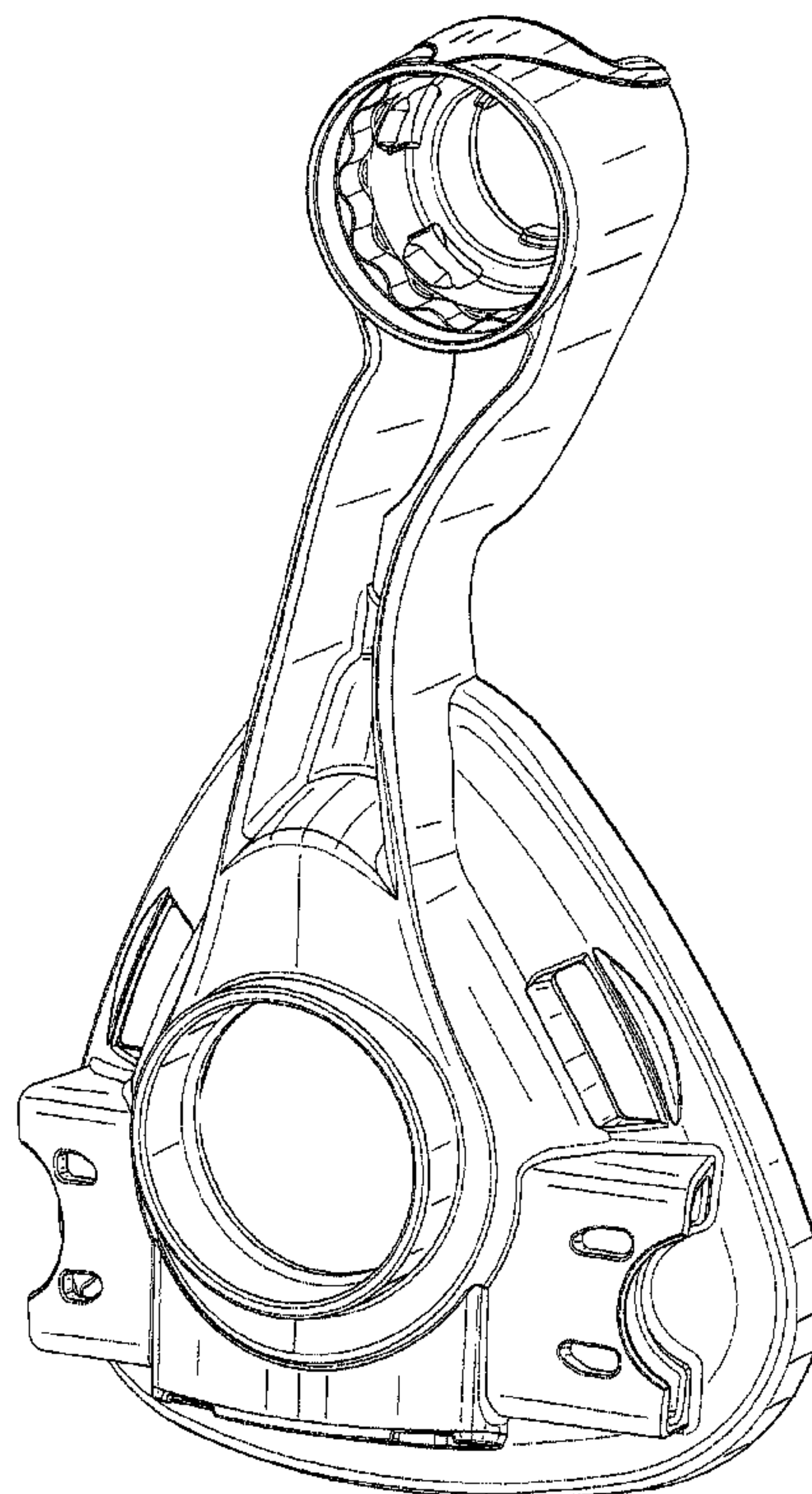
FIG. 4 is a top view thereof;

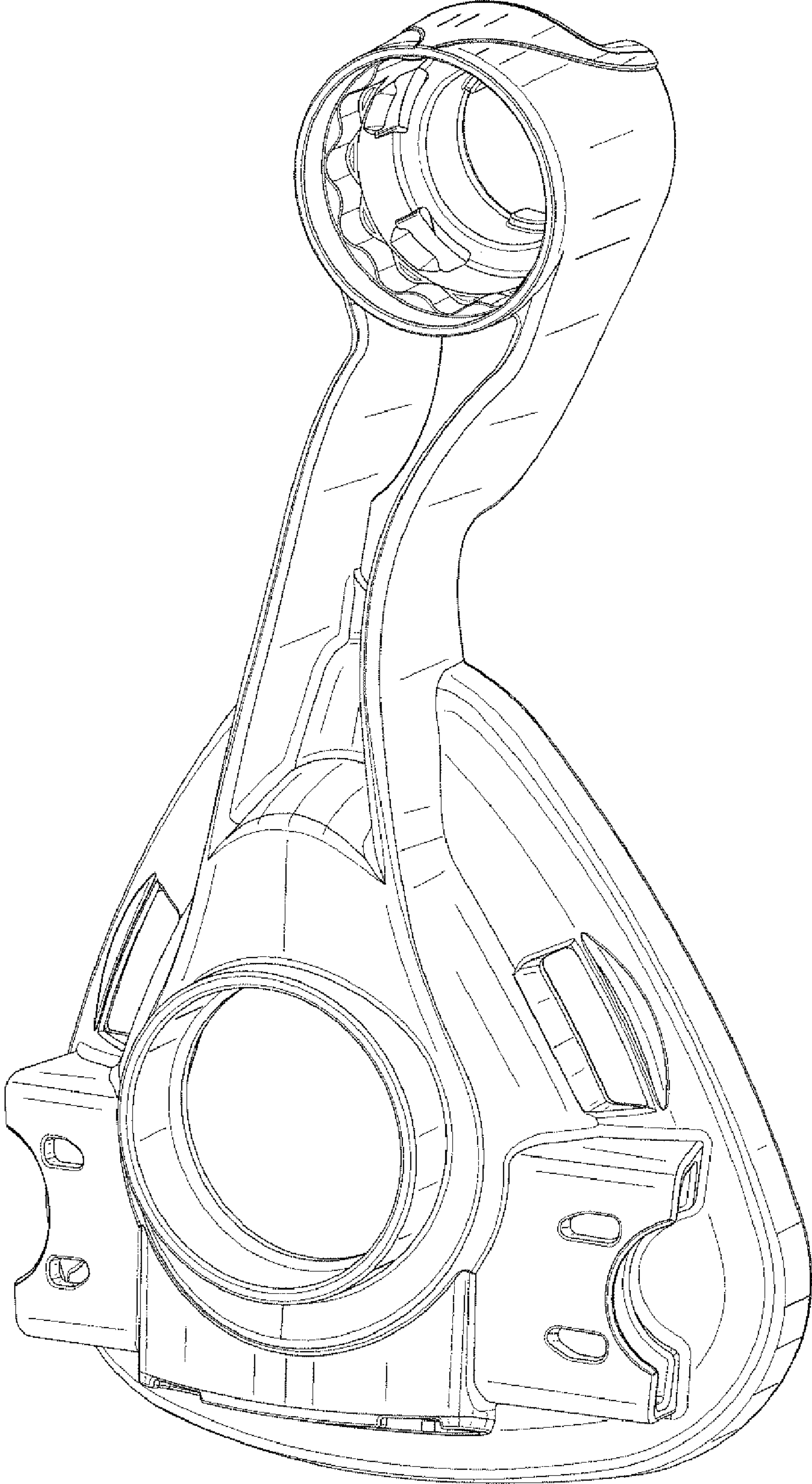

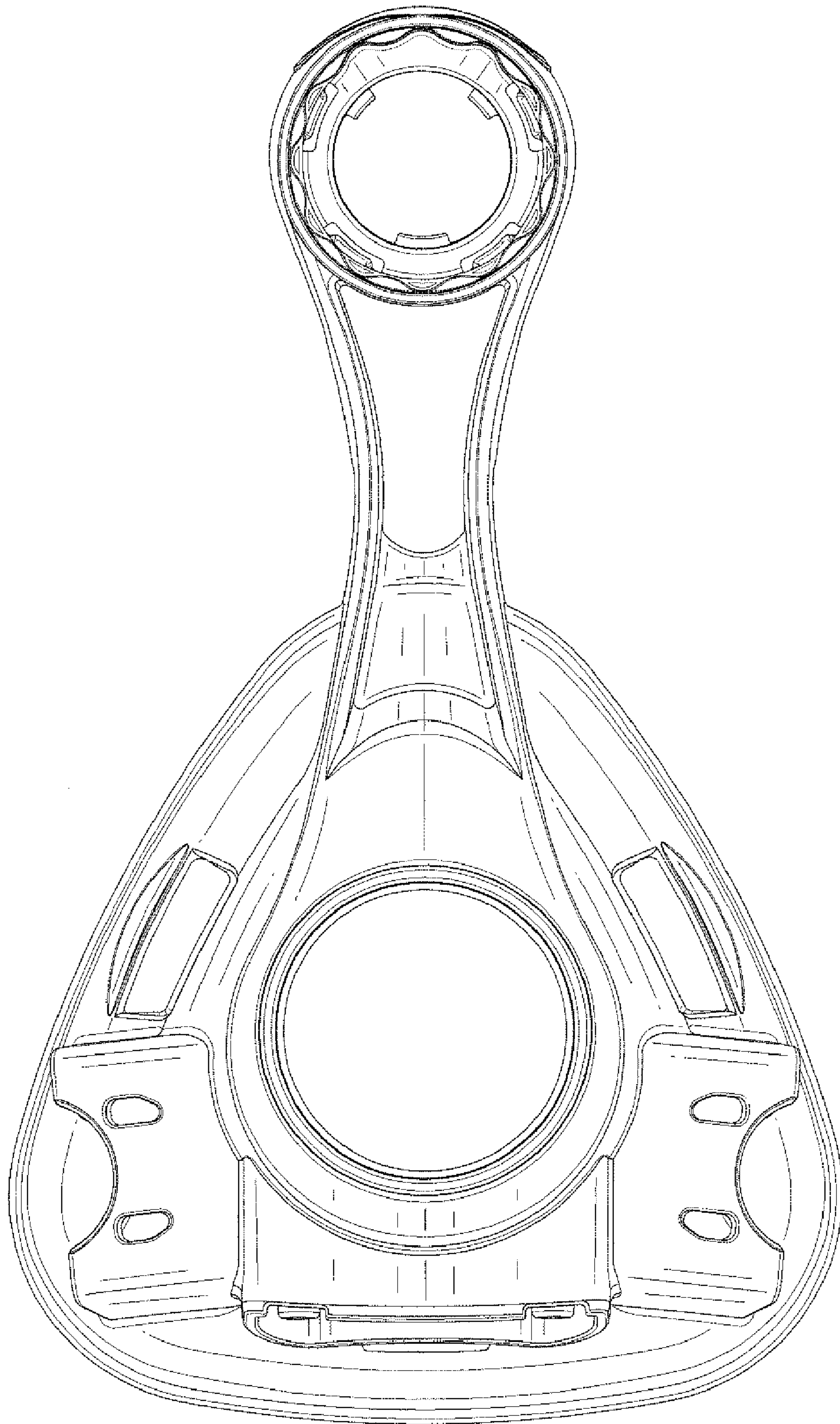

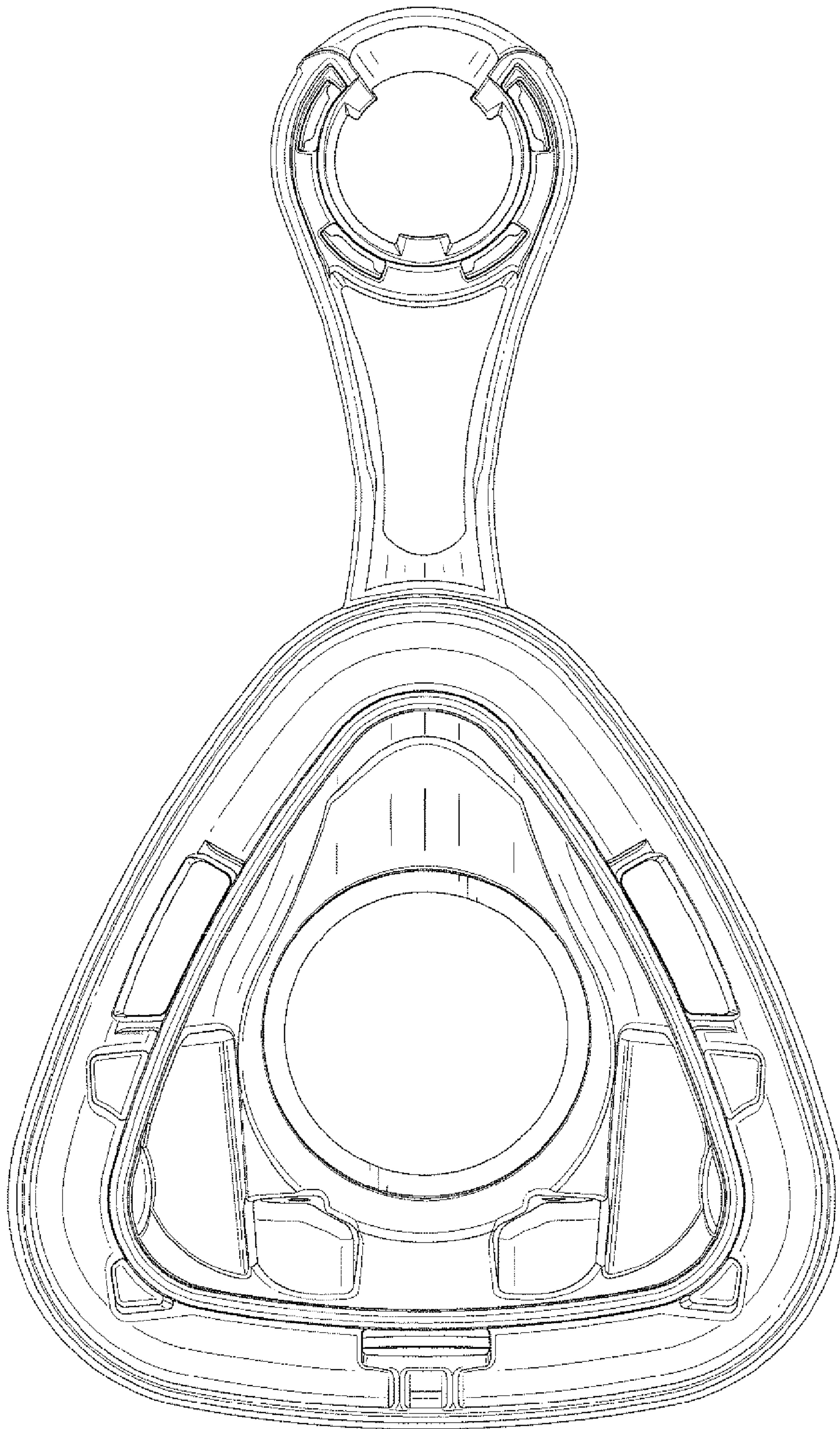

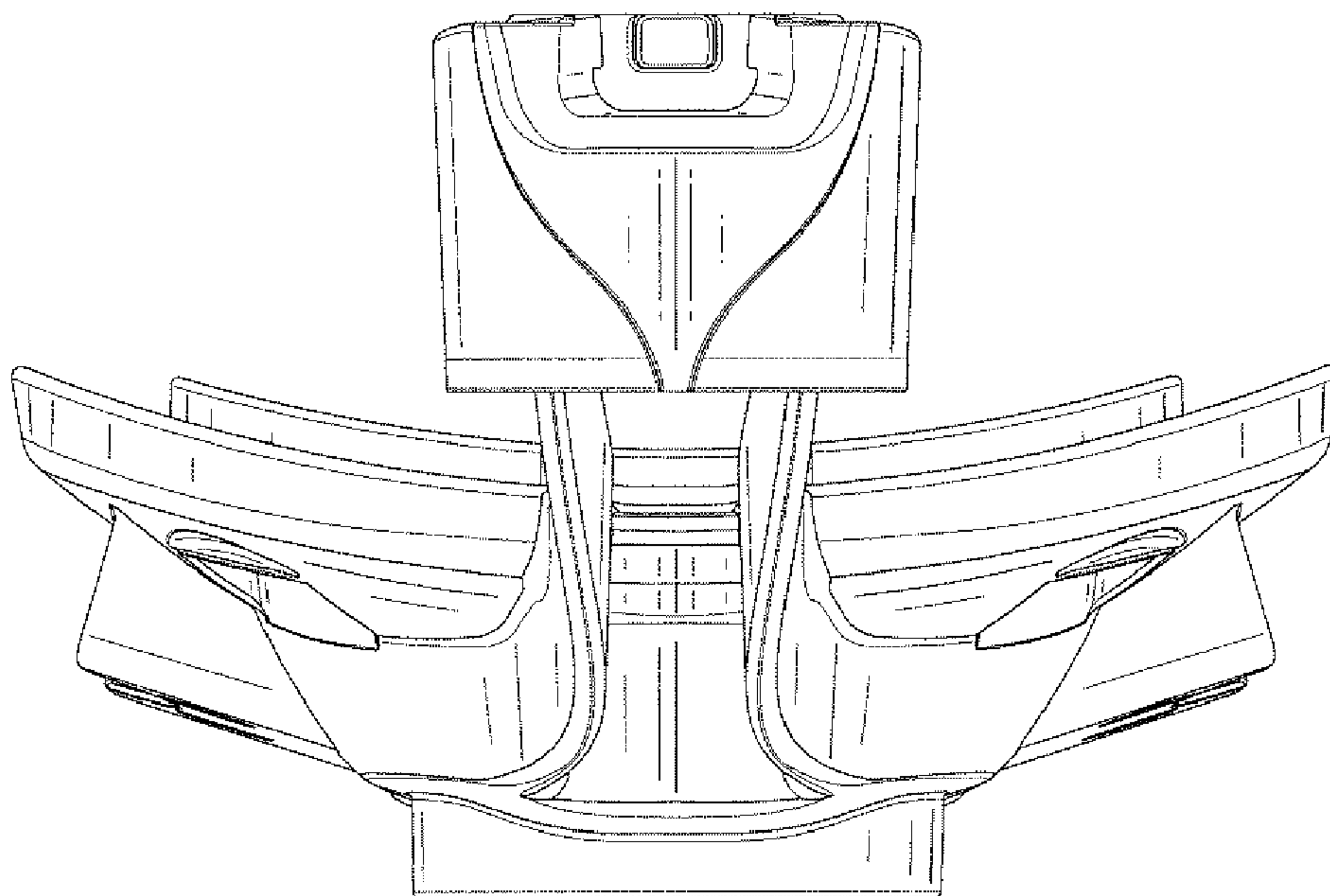

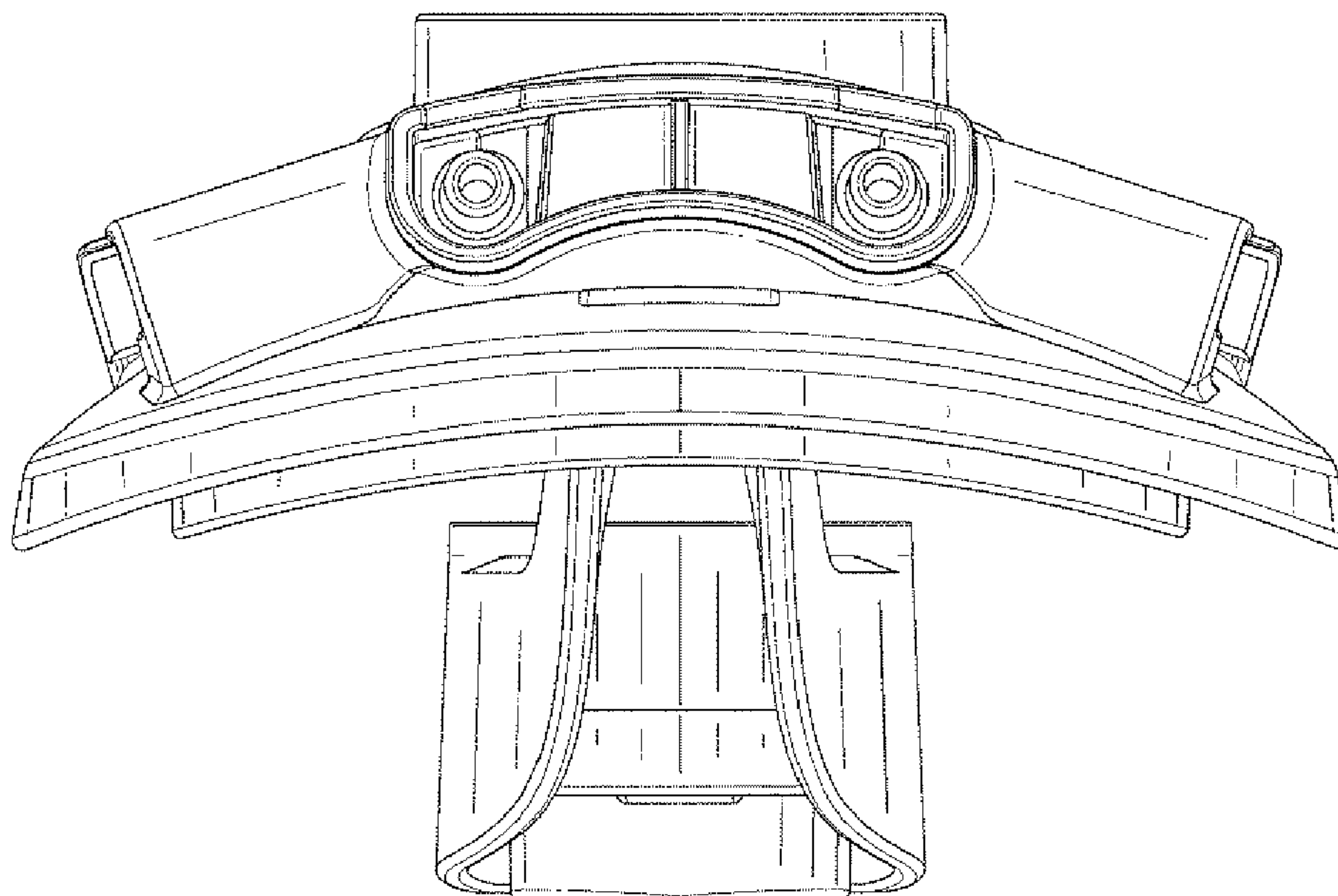

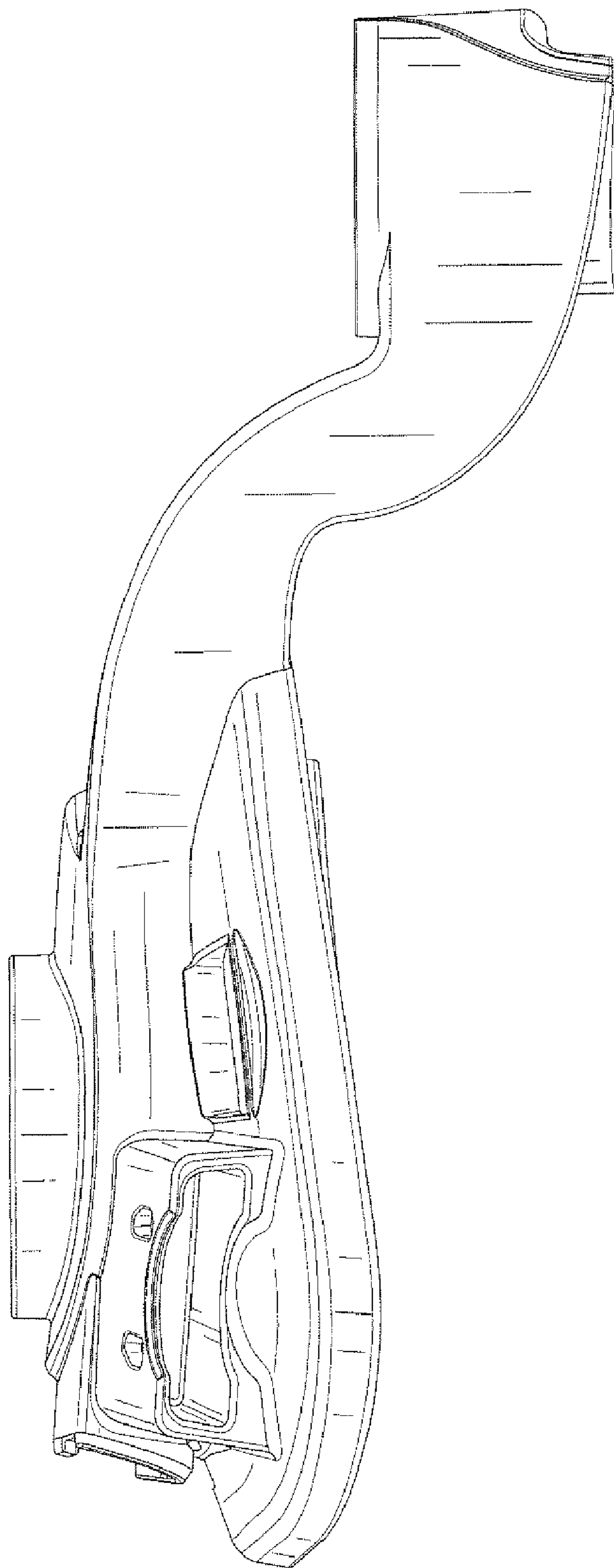

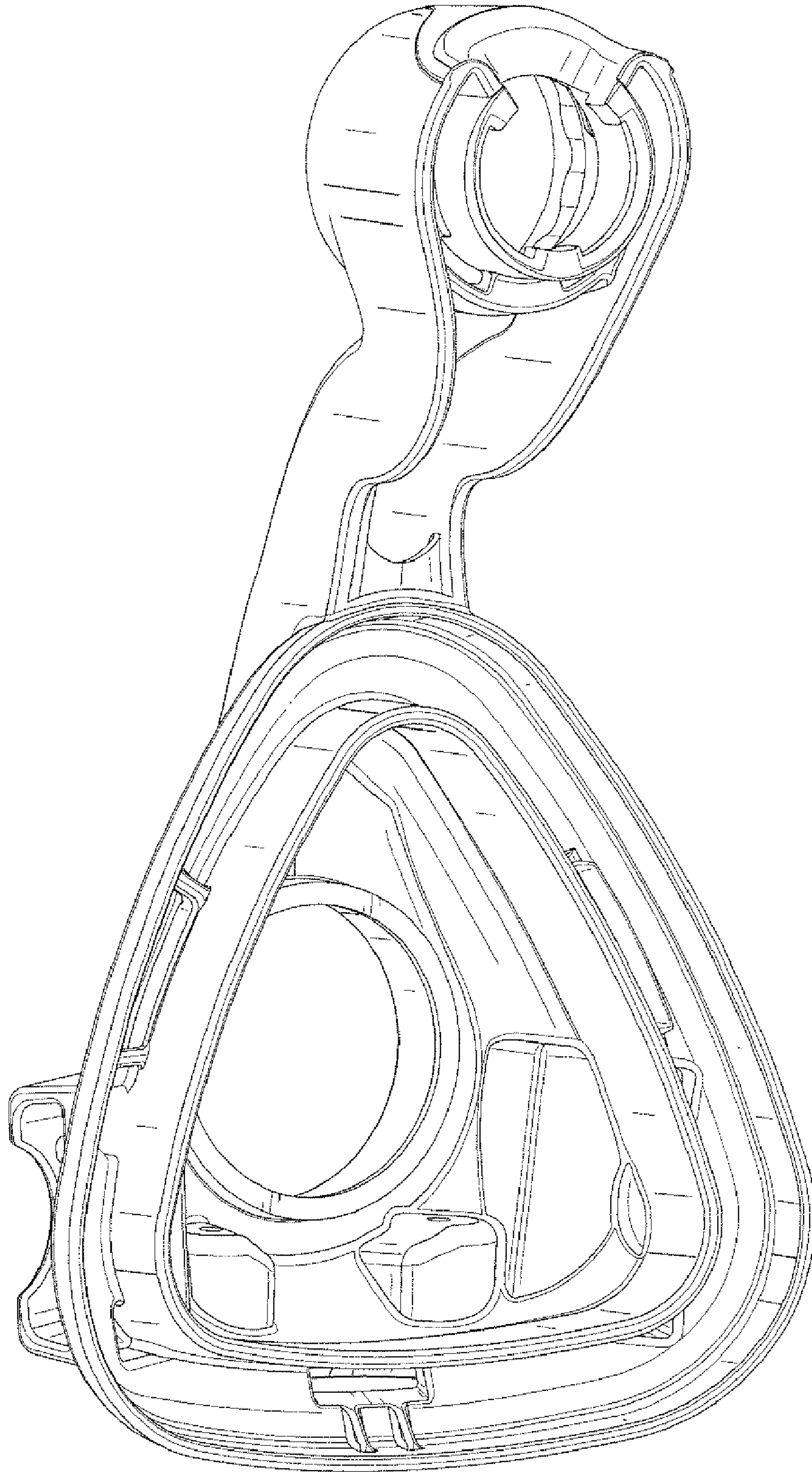
