(57) **CLAIM**

I claim the ornamental design for a dog house, as shown.

DESCRIPTION

FIG. 1 is a right side view of the dog house according to the present invention;

FIG. 2 is a front view of the dog house;

FIG. 3 is a left side view of the dog house;

FIG. 4 is a rear view of the dog house;

FIG. 5 is a top view of the dog house;

FIG. 6 is a bottom view of the dog house; and,

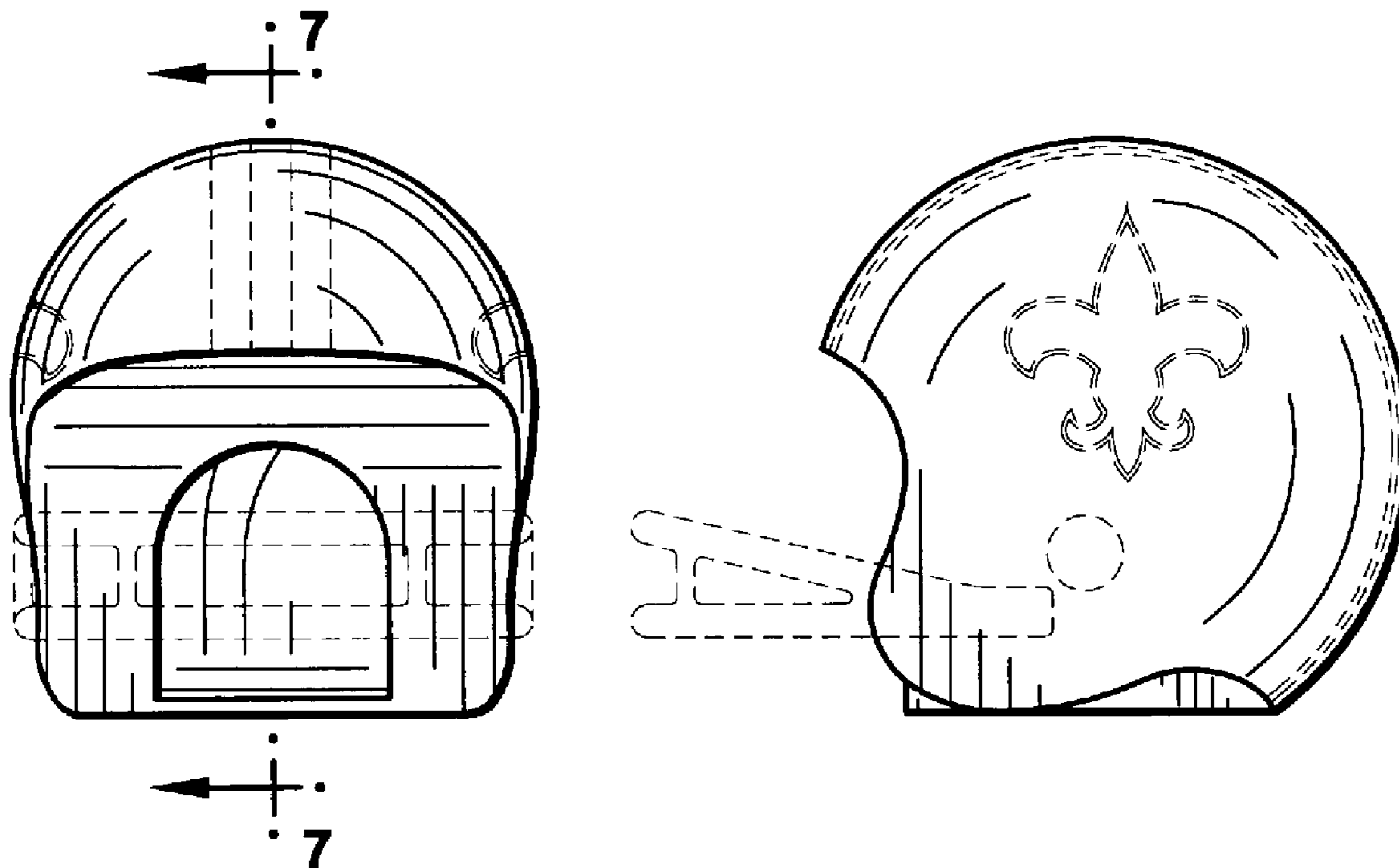

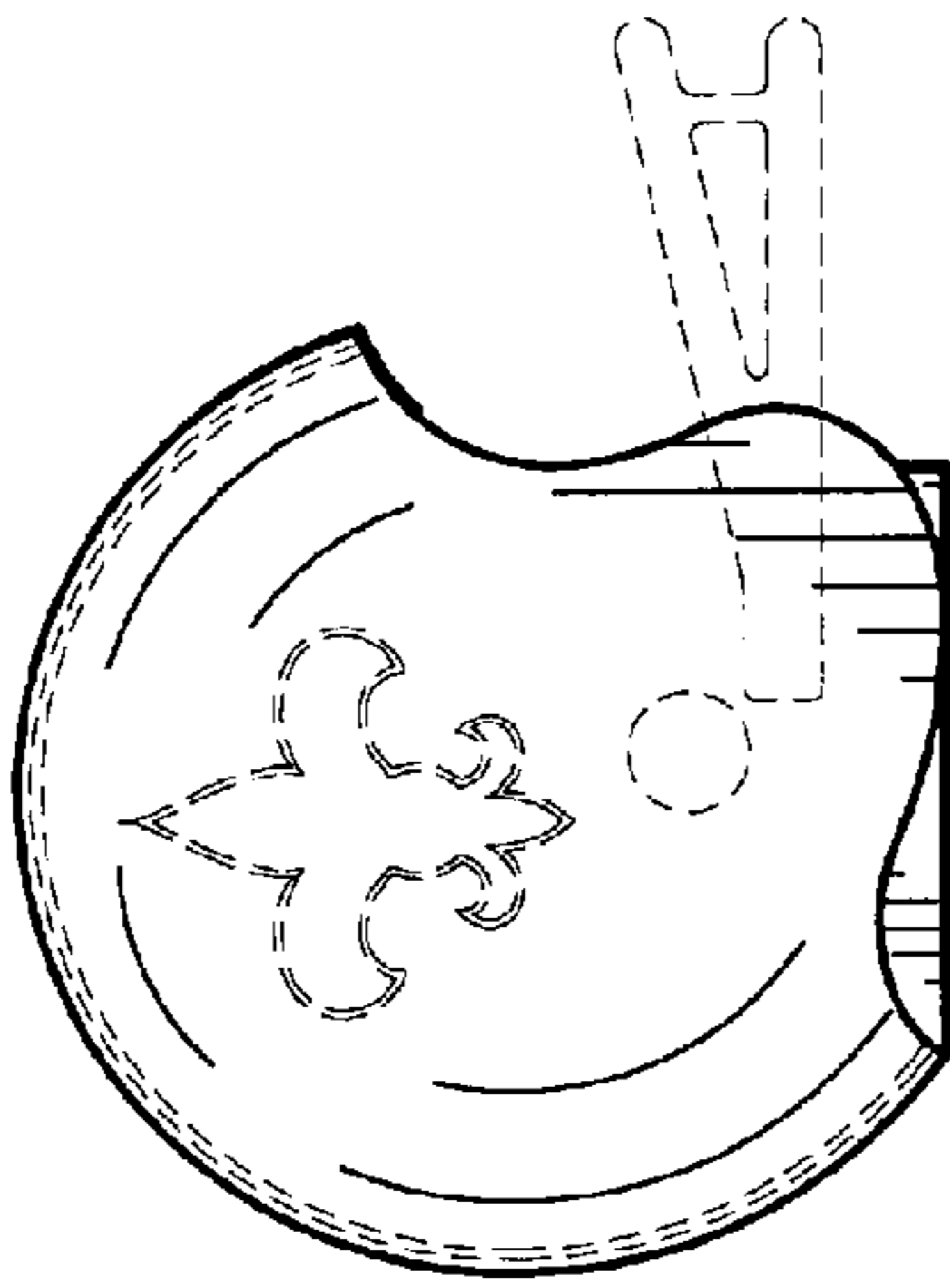

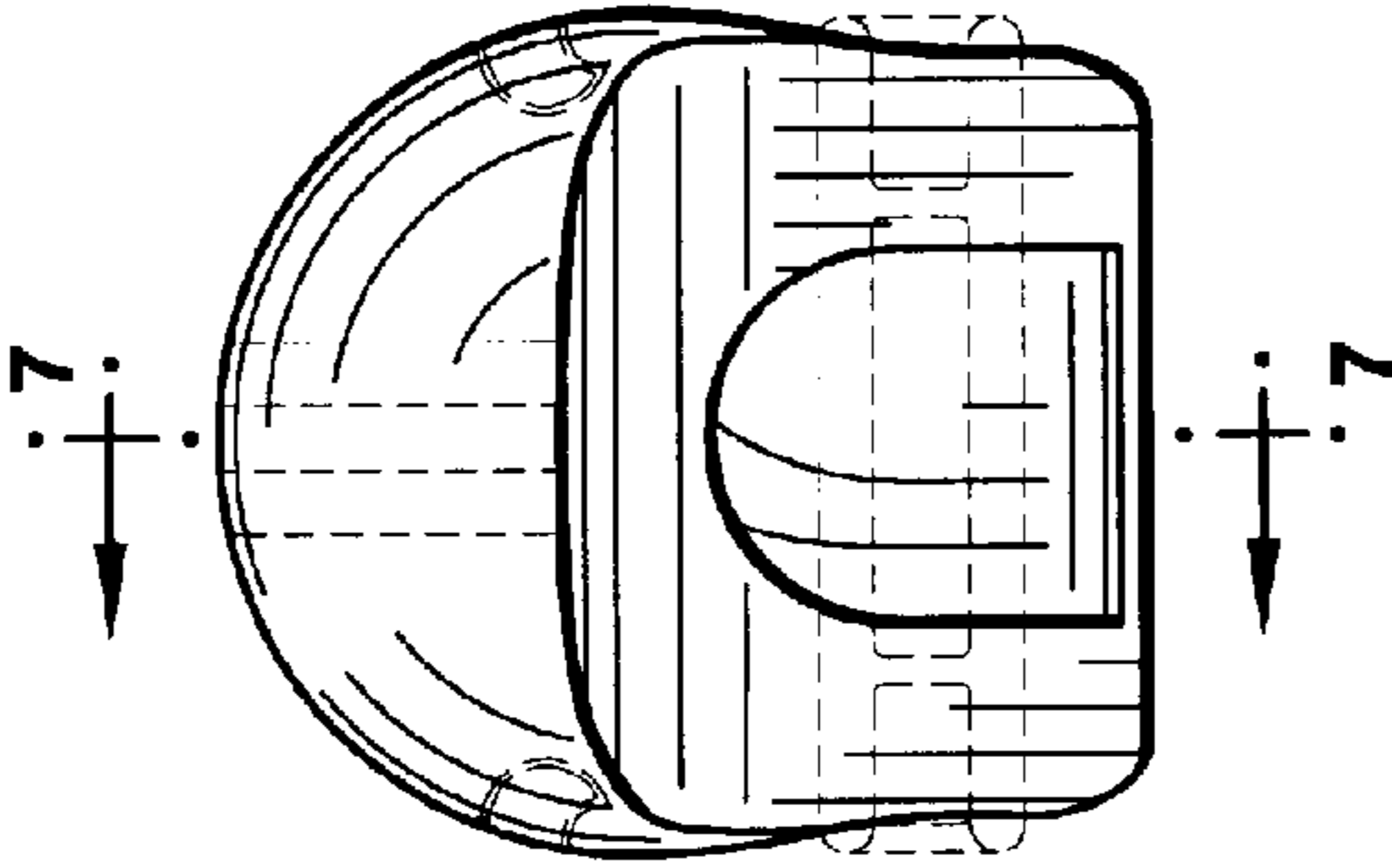

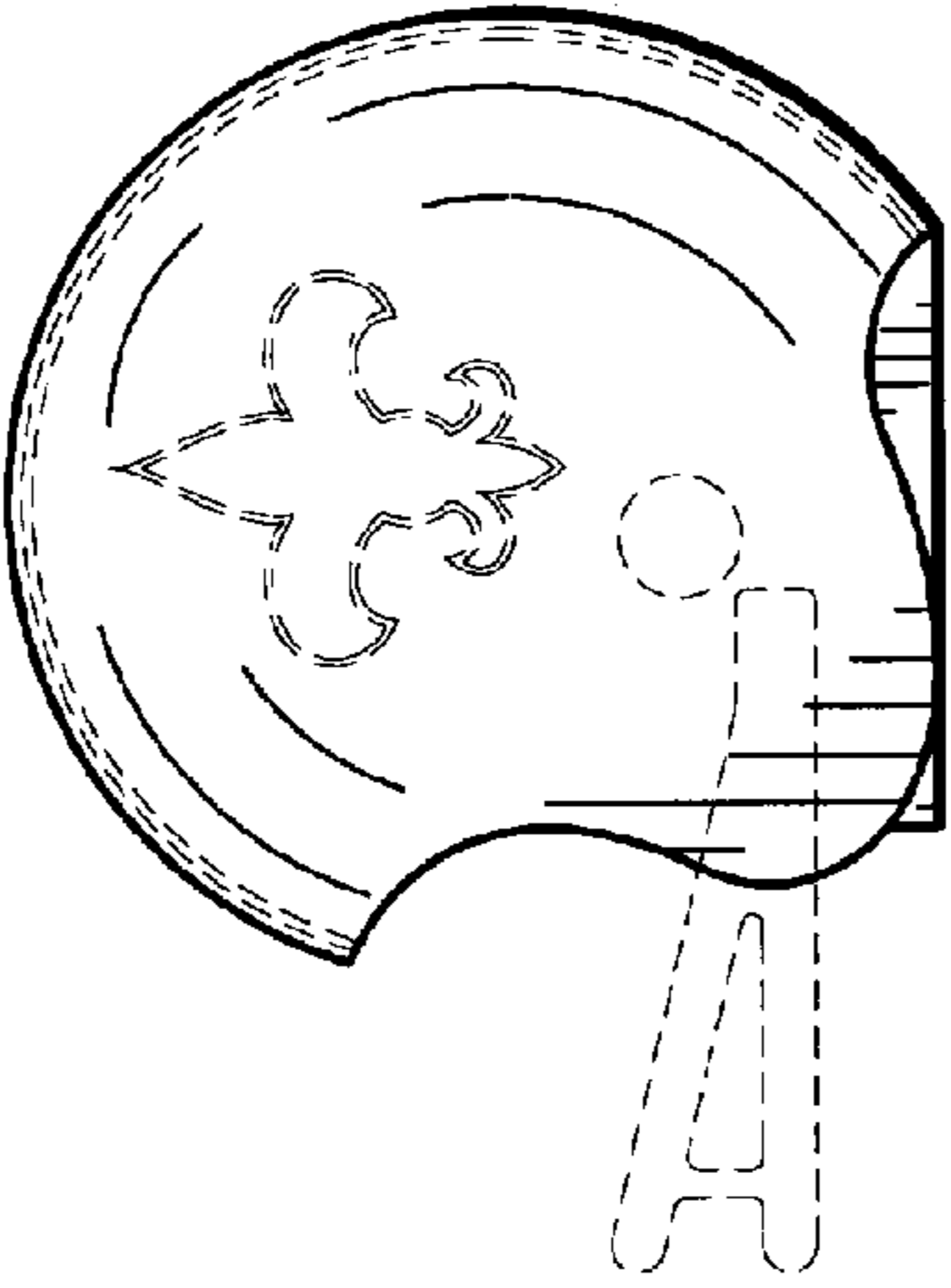

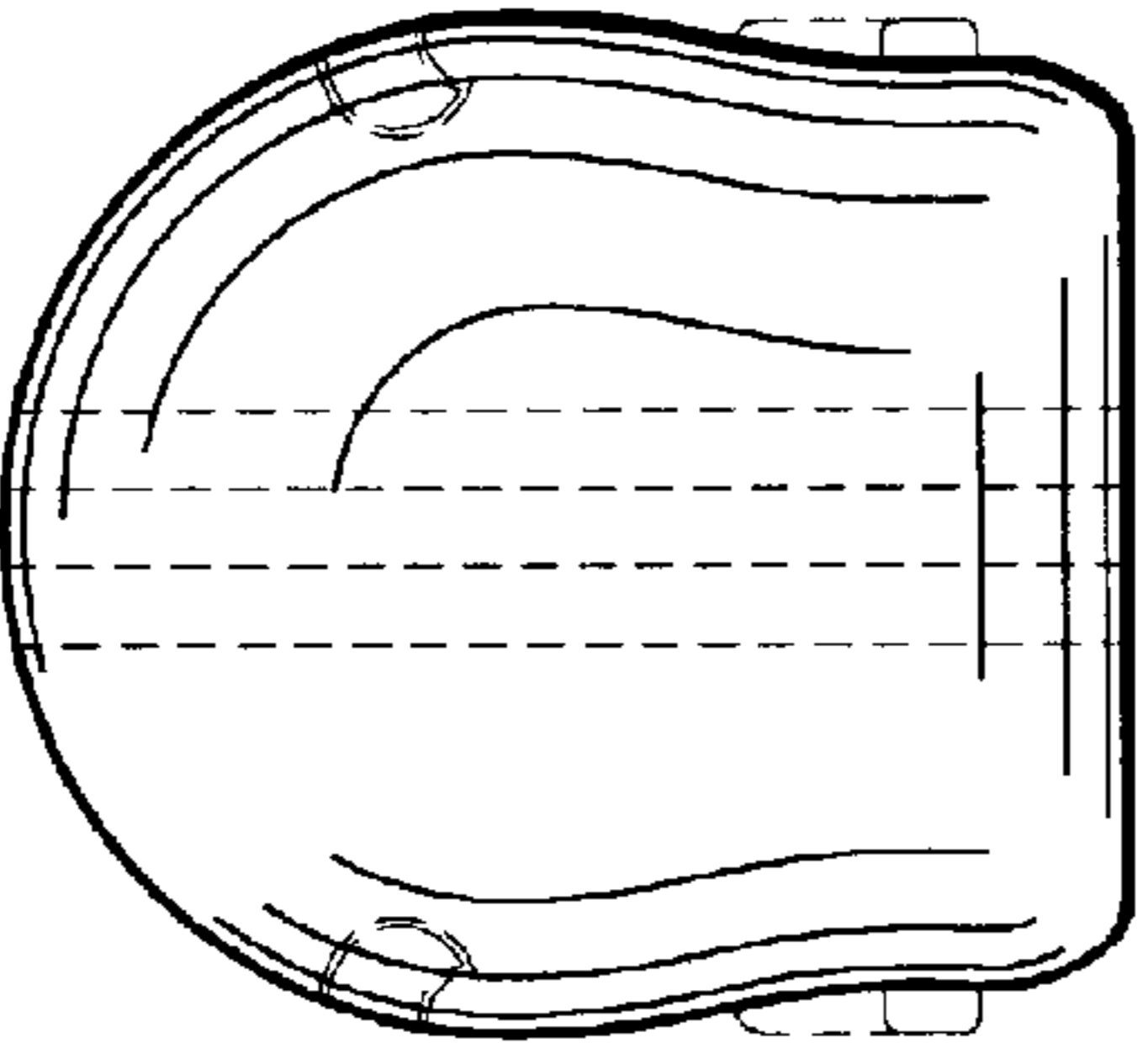

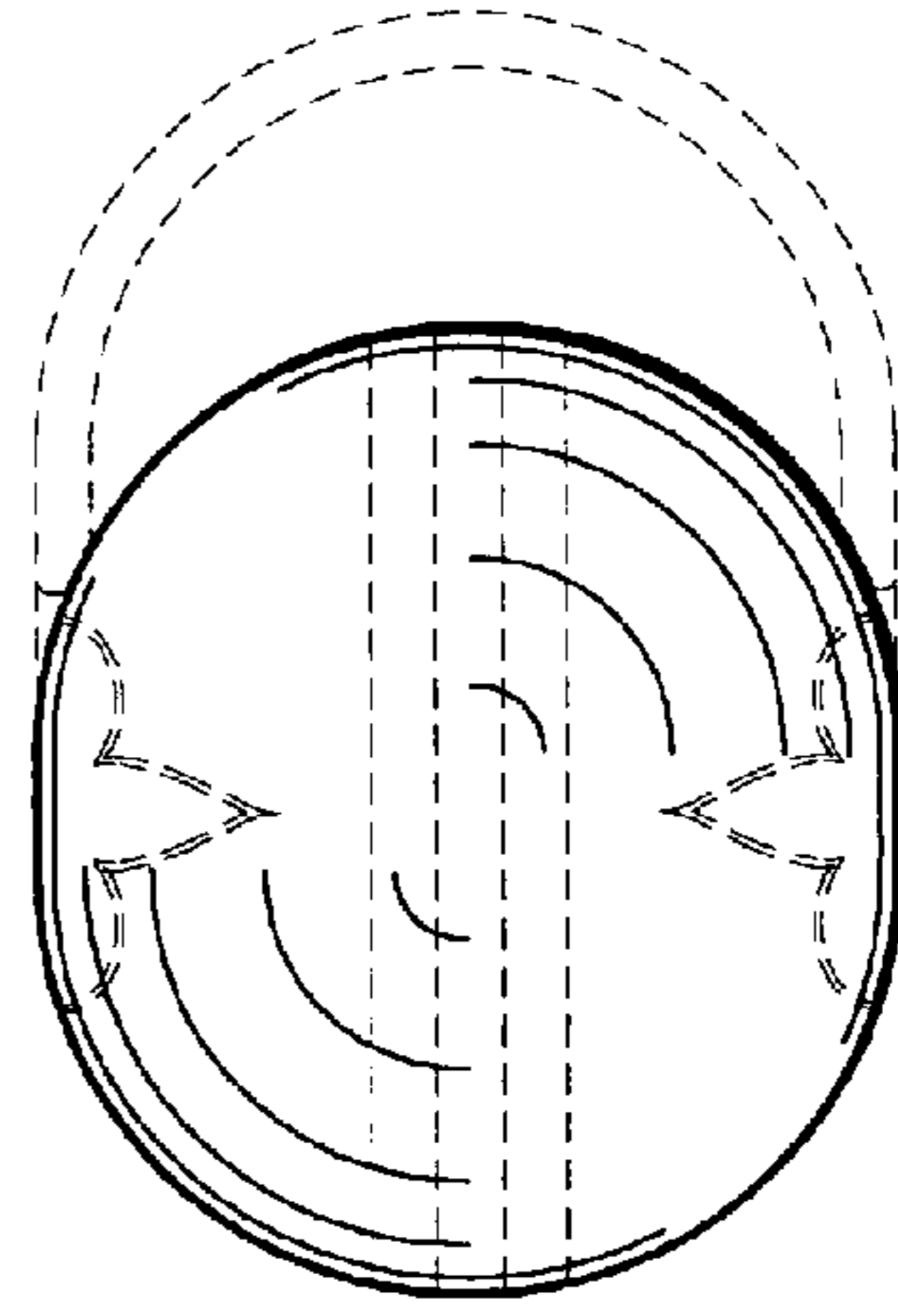

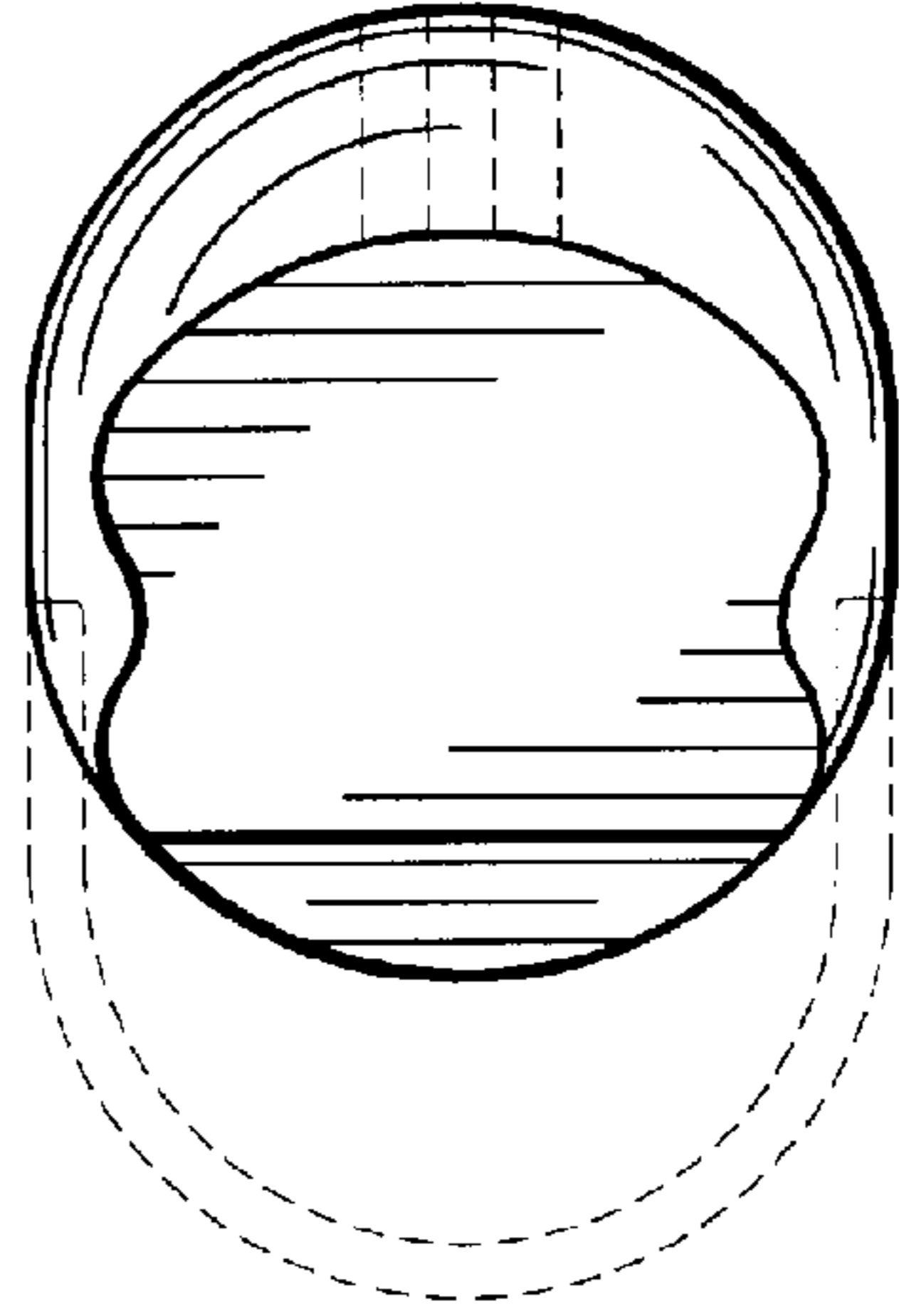
