FIG. 10 is a front elevational view of the second embodiment;

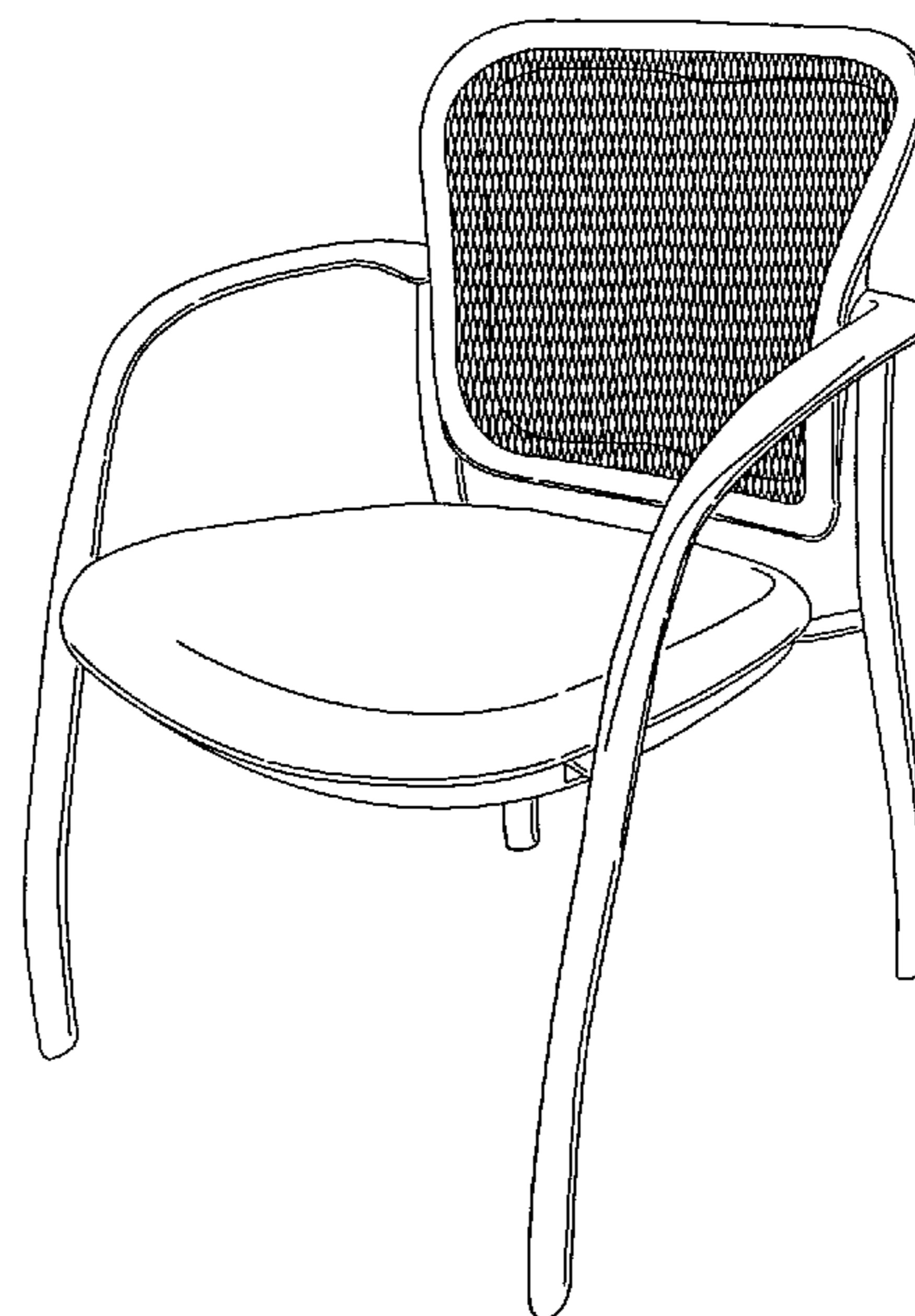
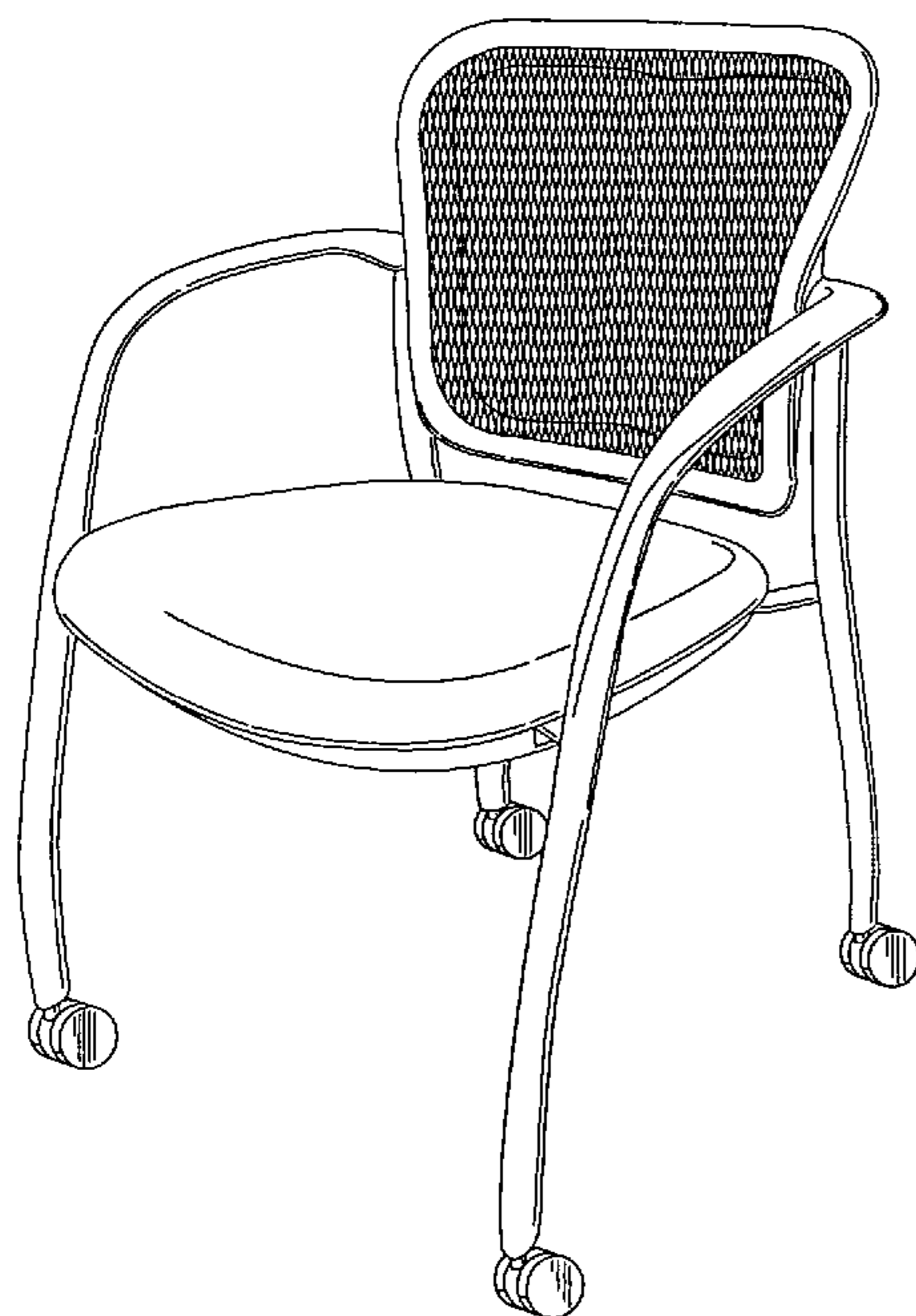
FIG. 11 is a left side elevational view of the second embodiment;

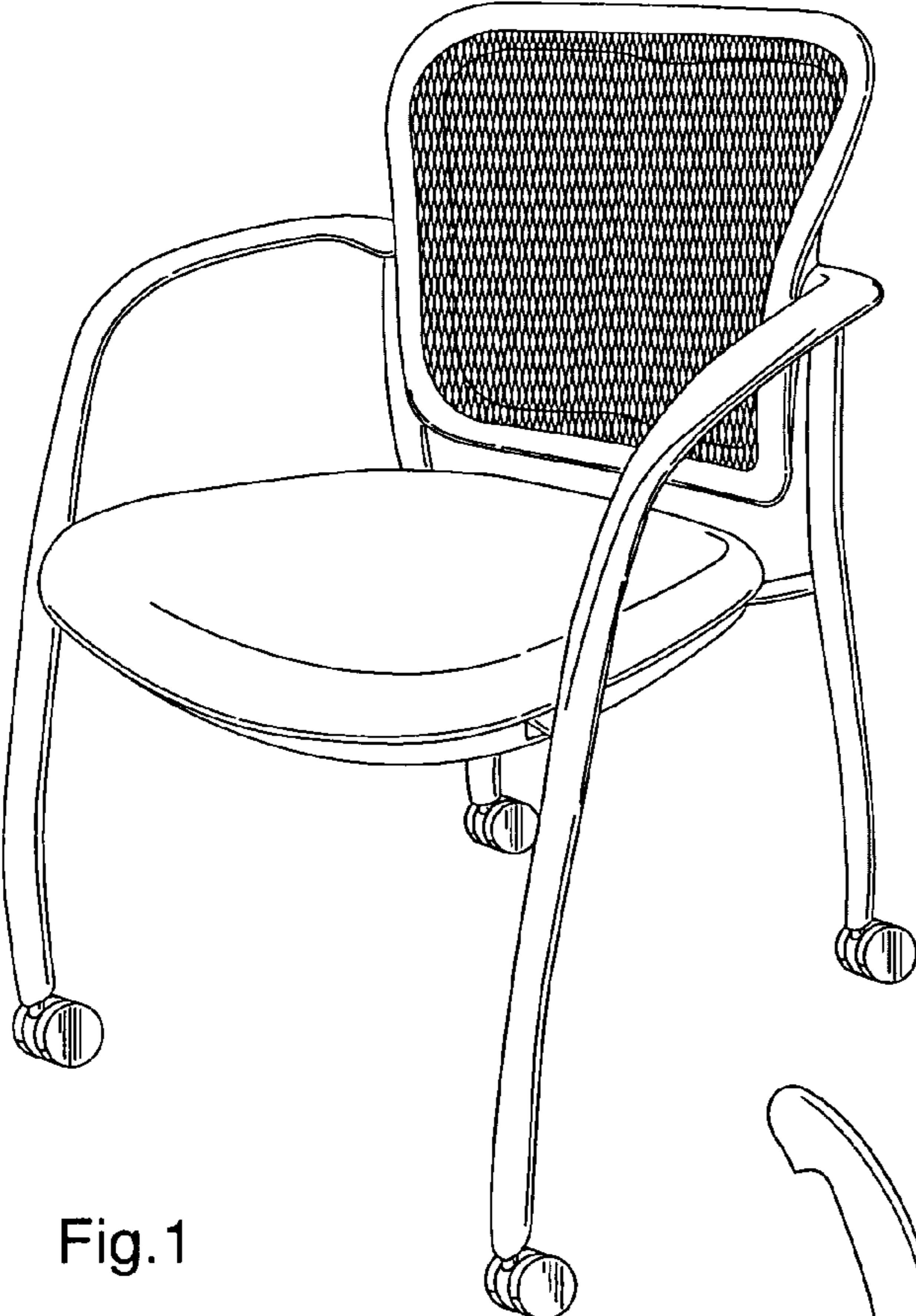

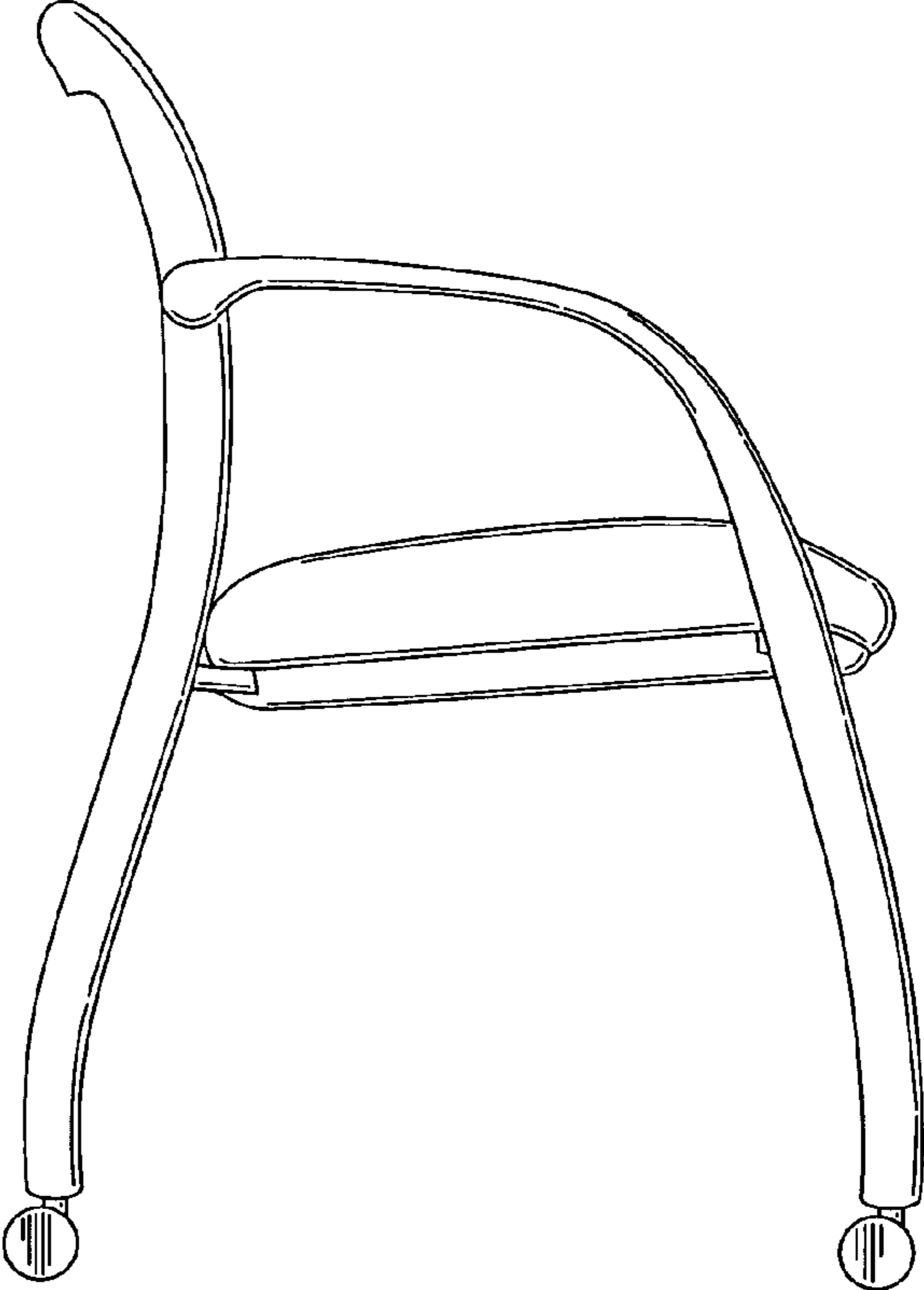

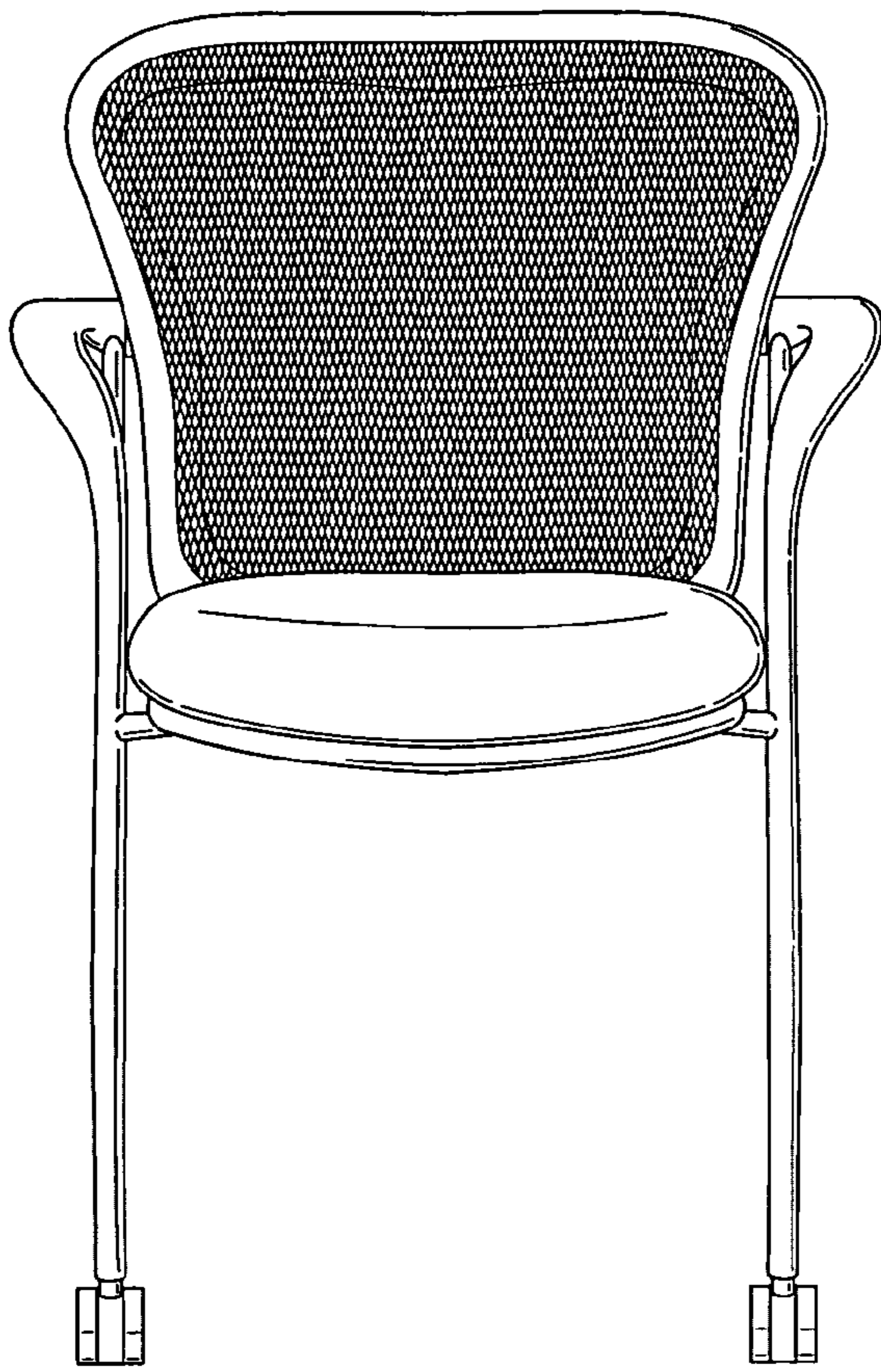

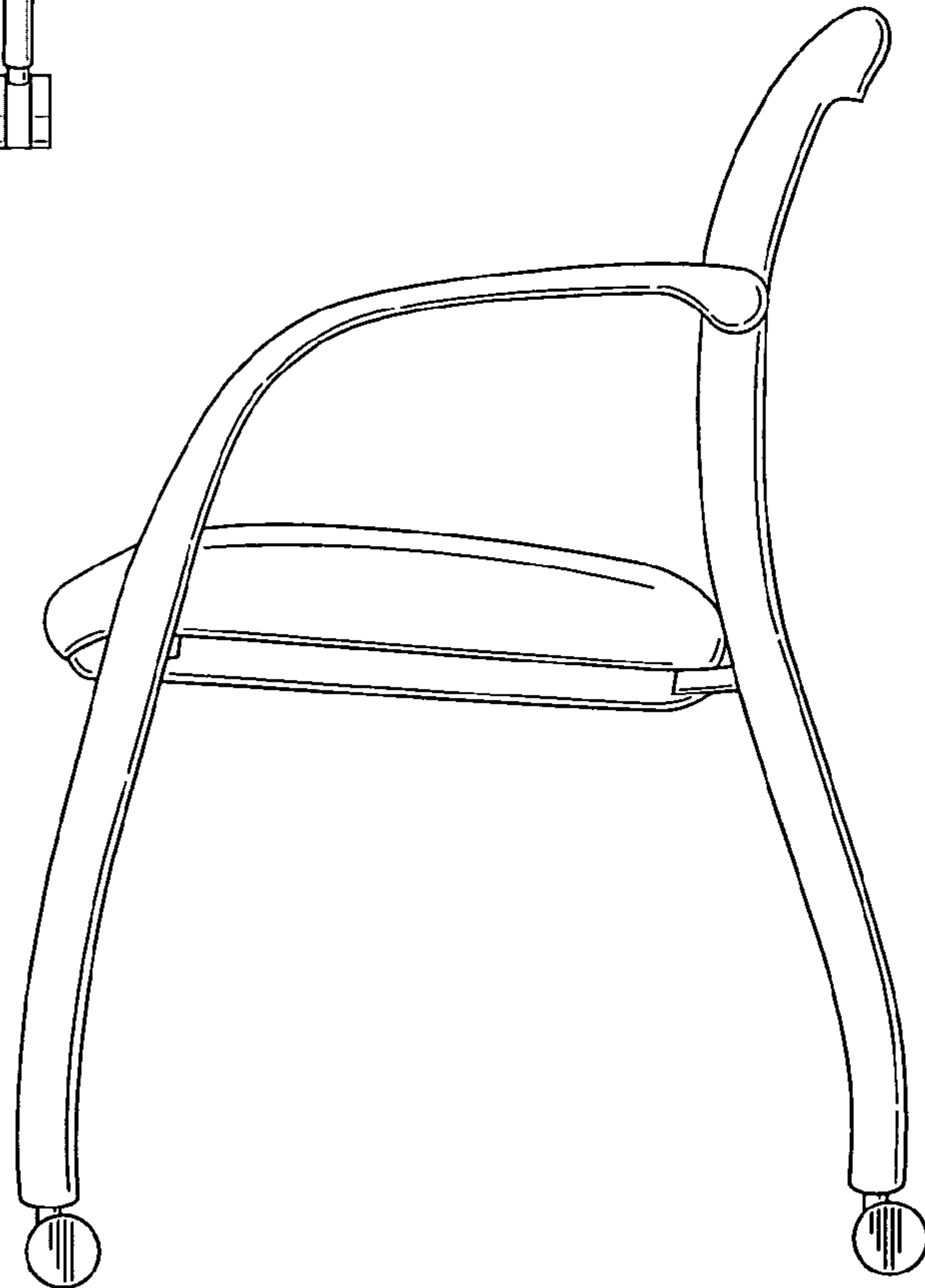

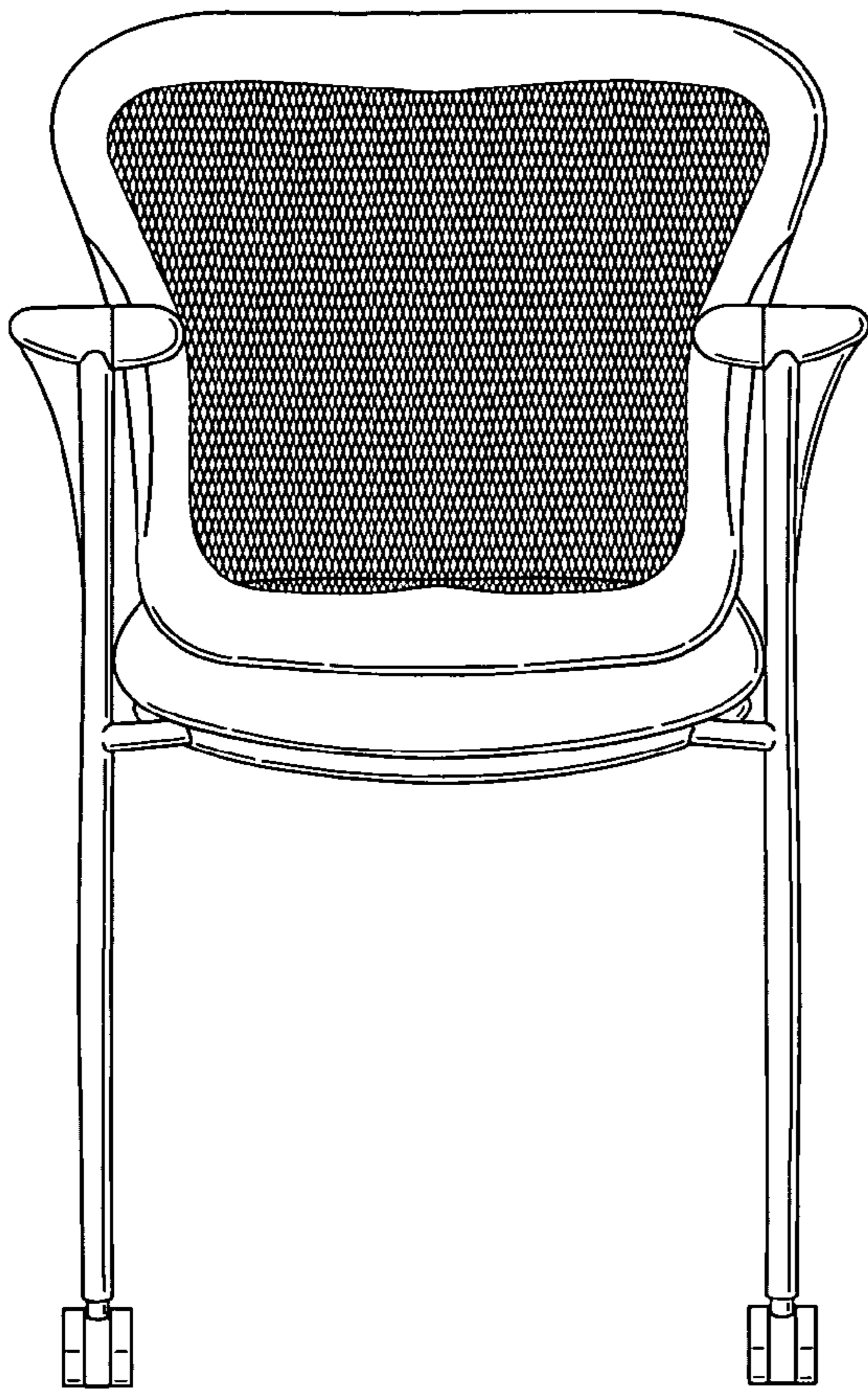

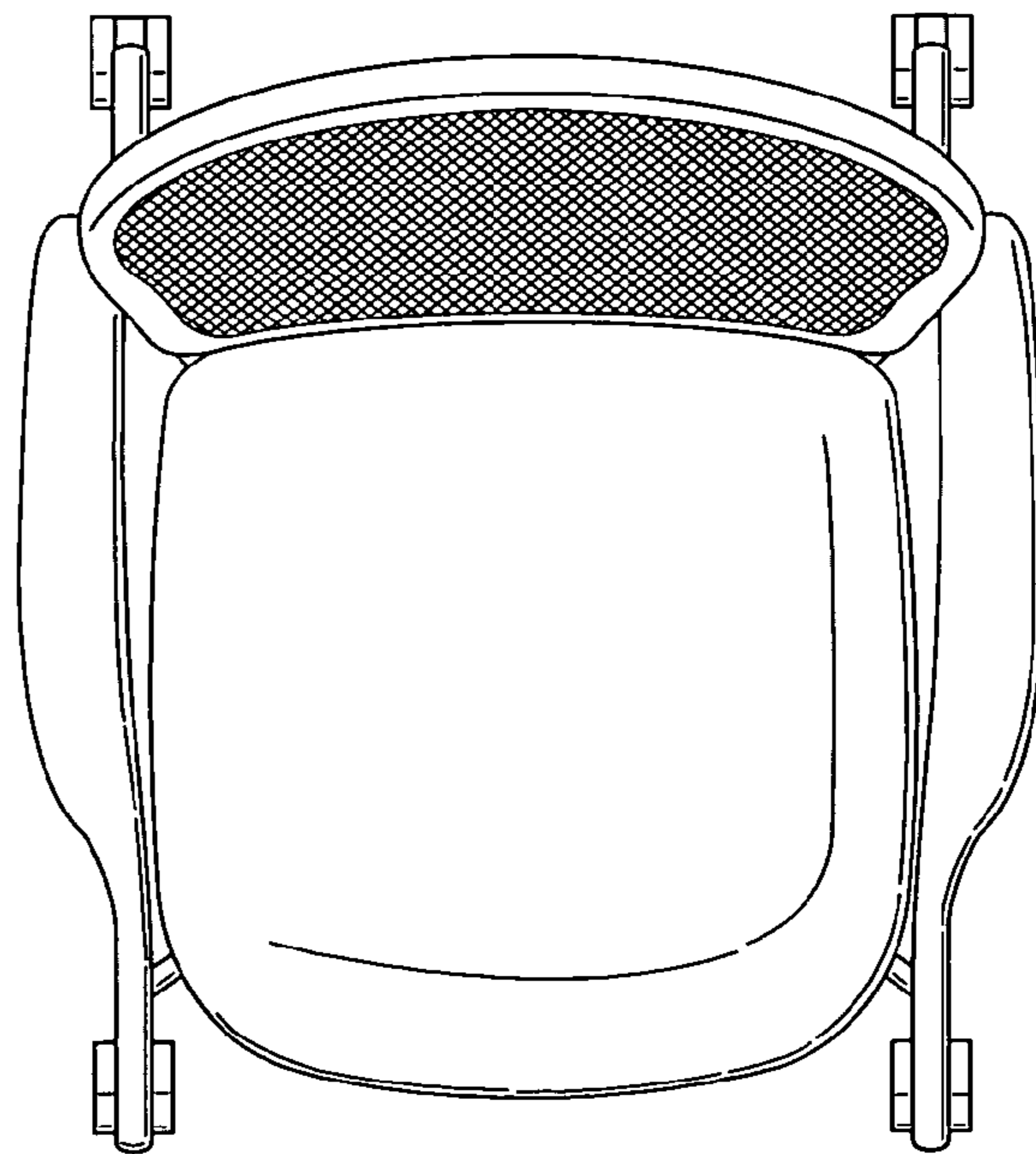

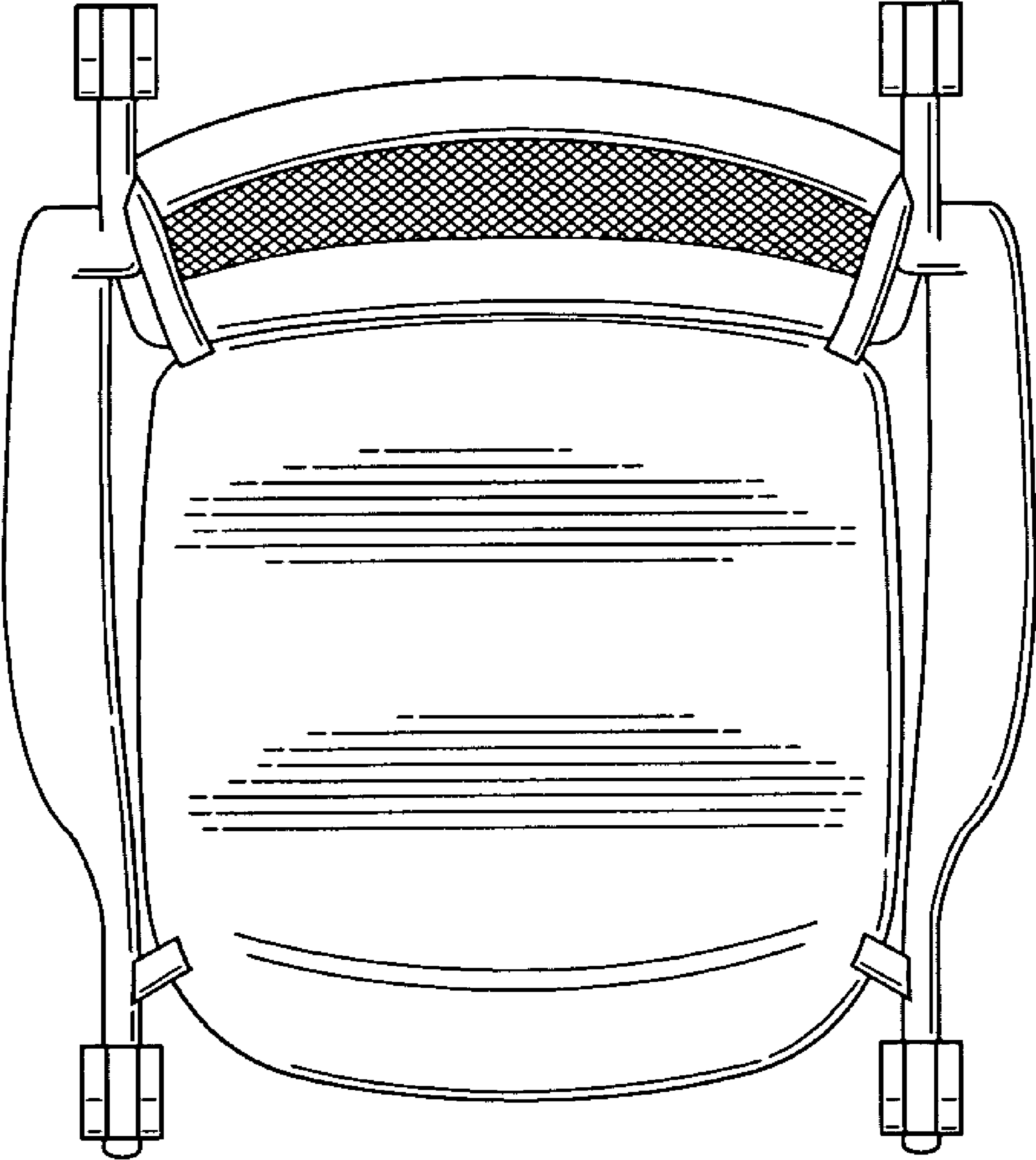

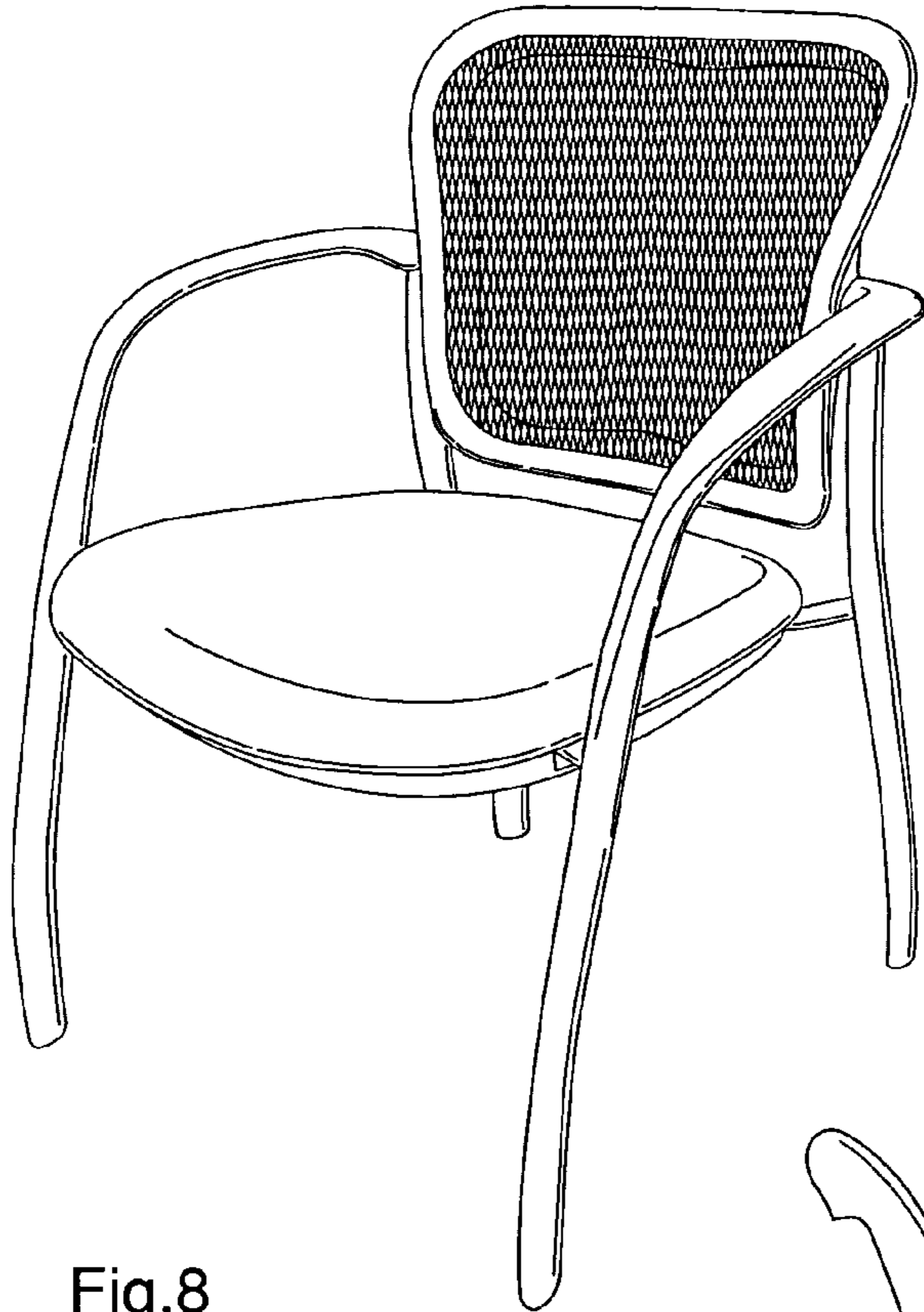

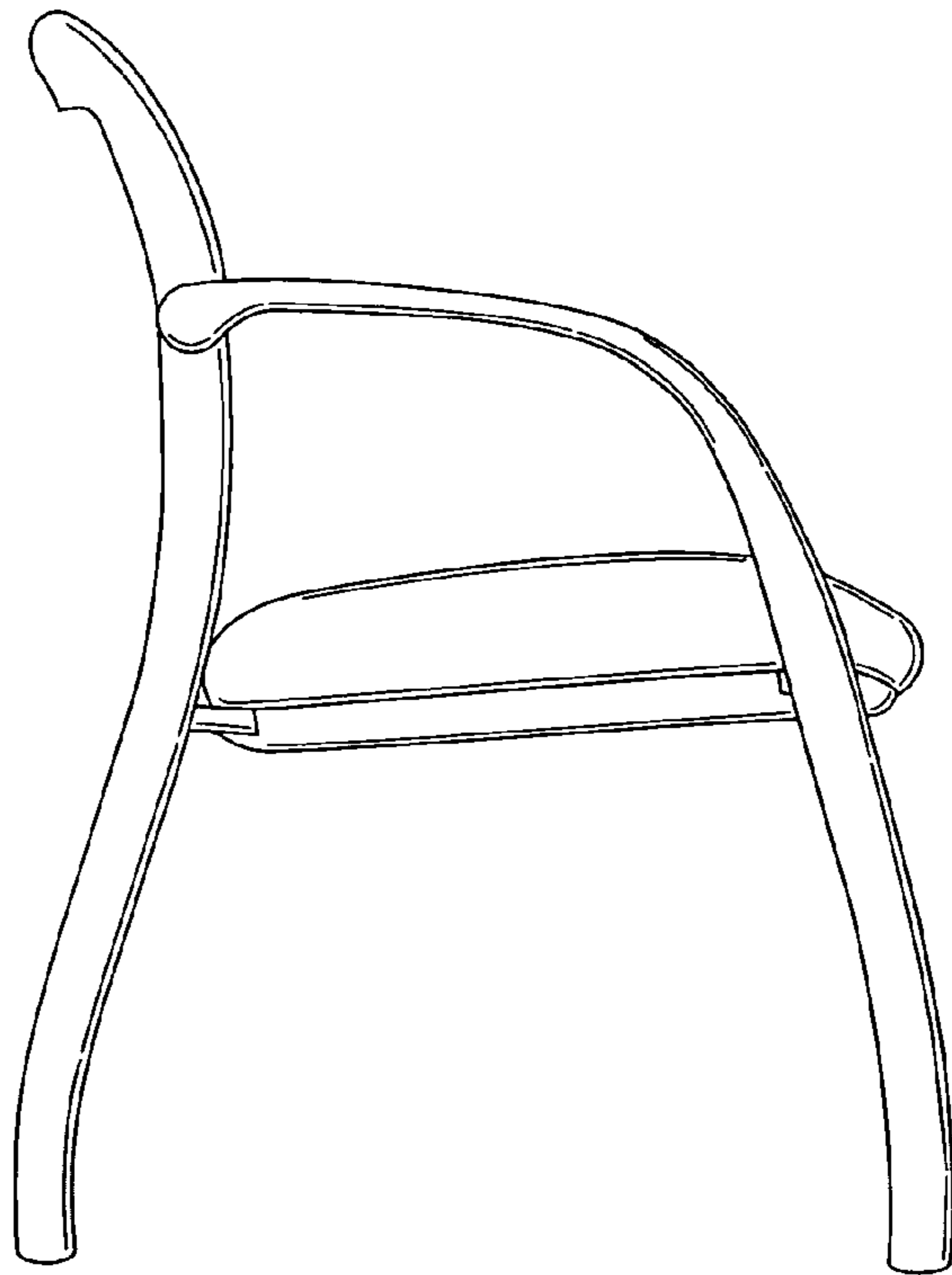

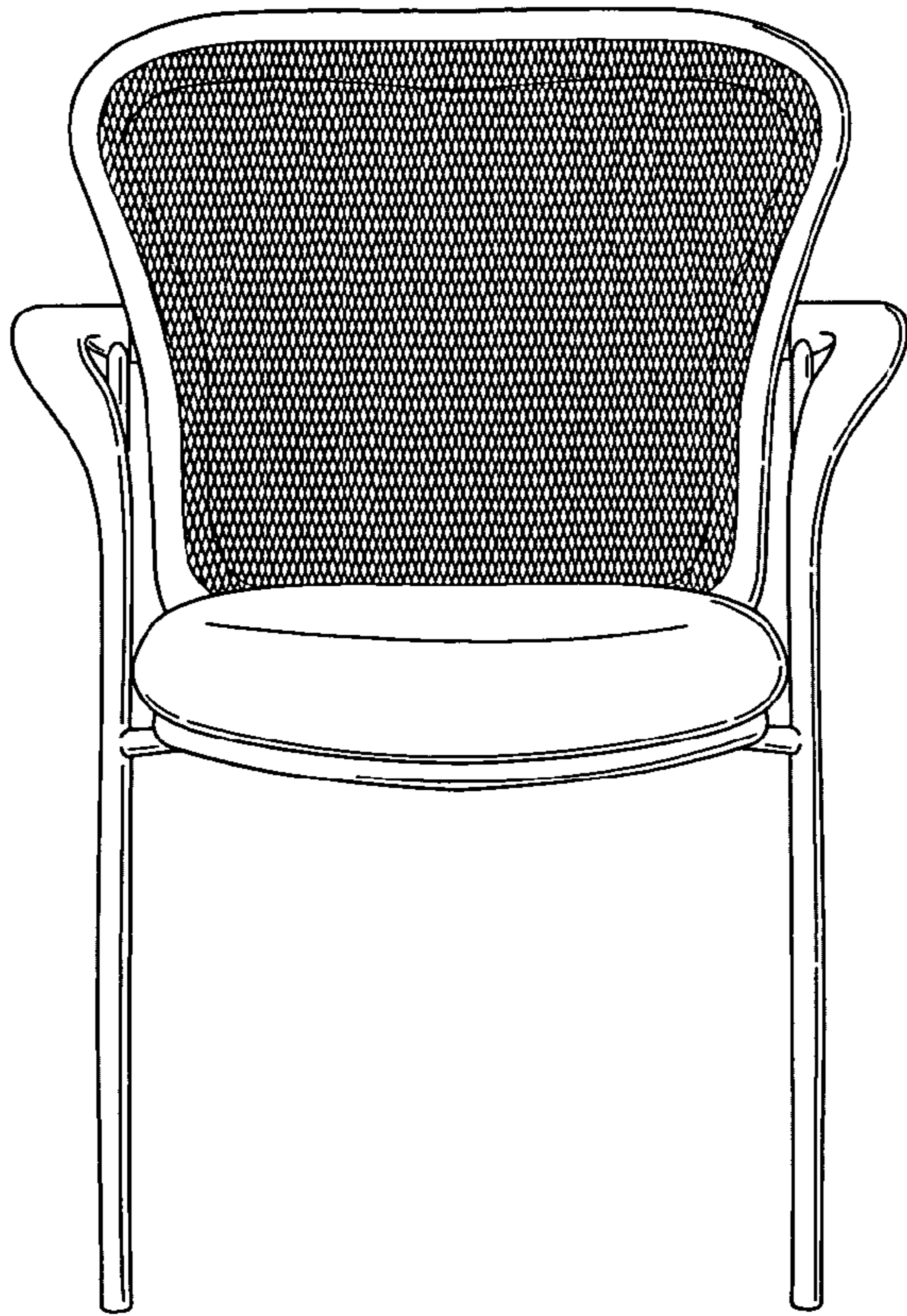

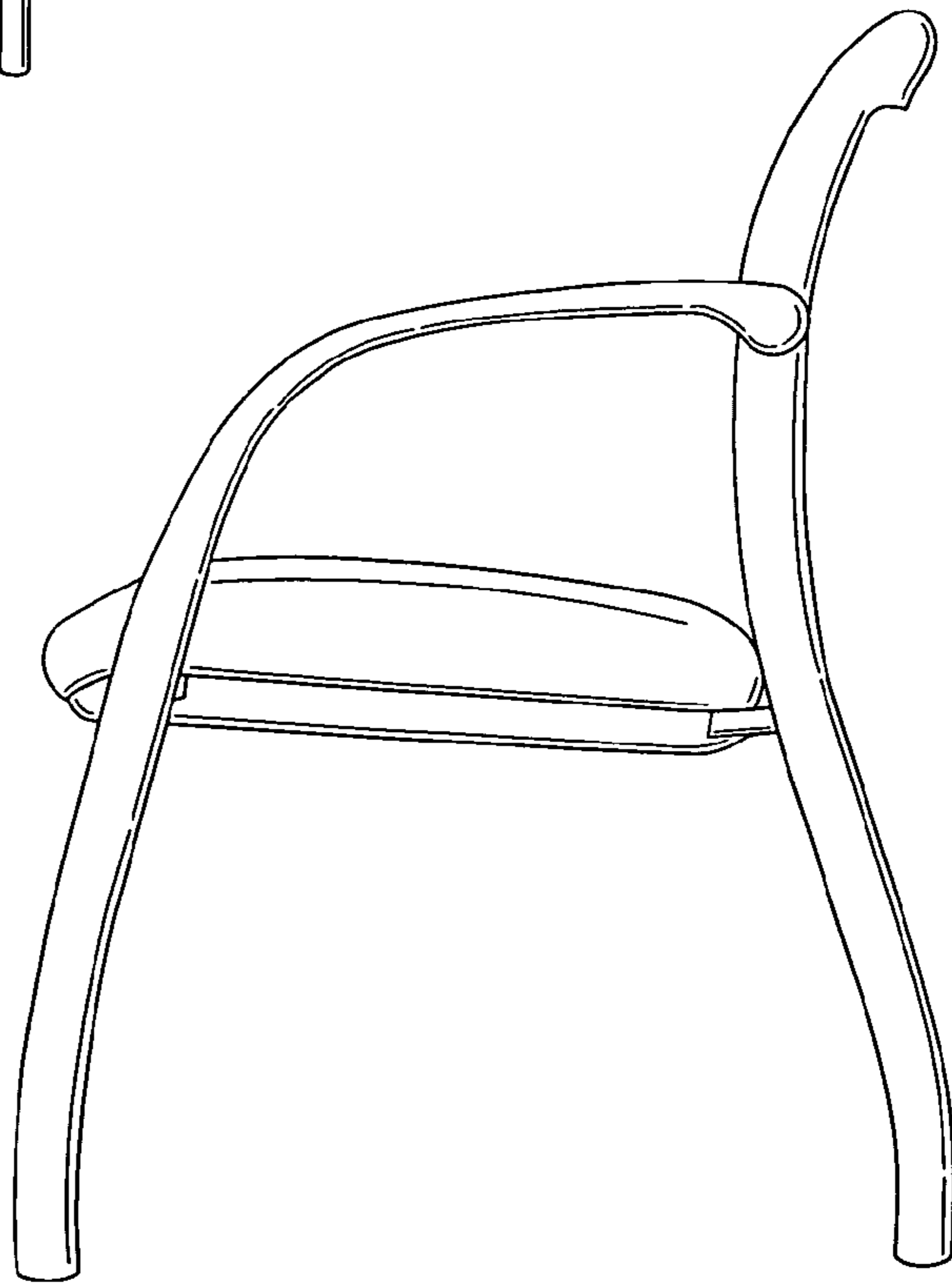

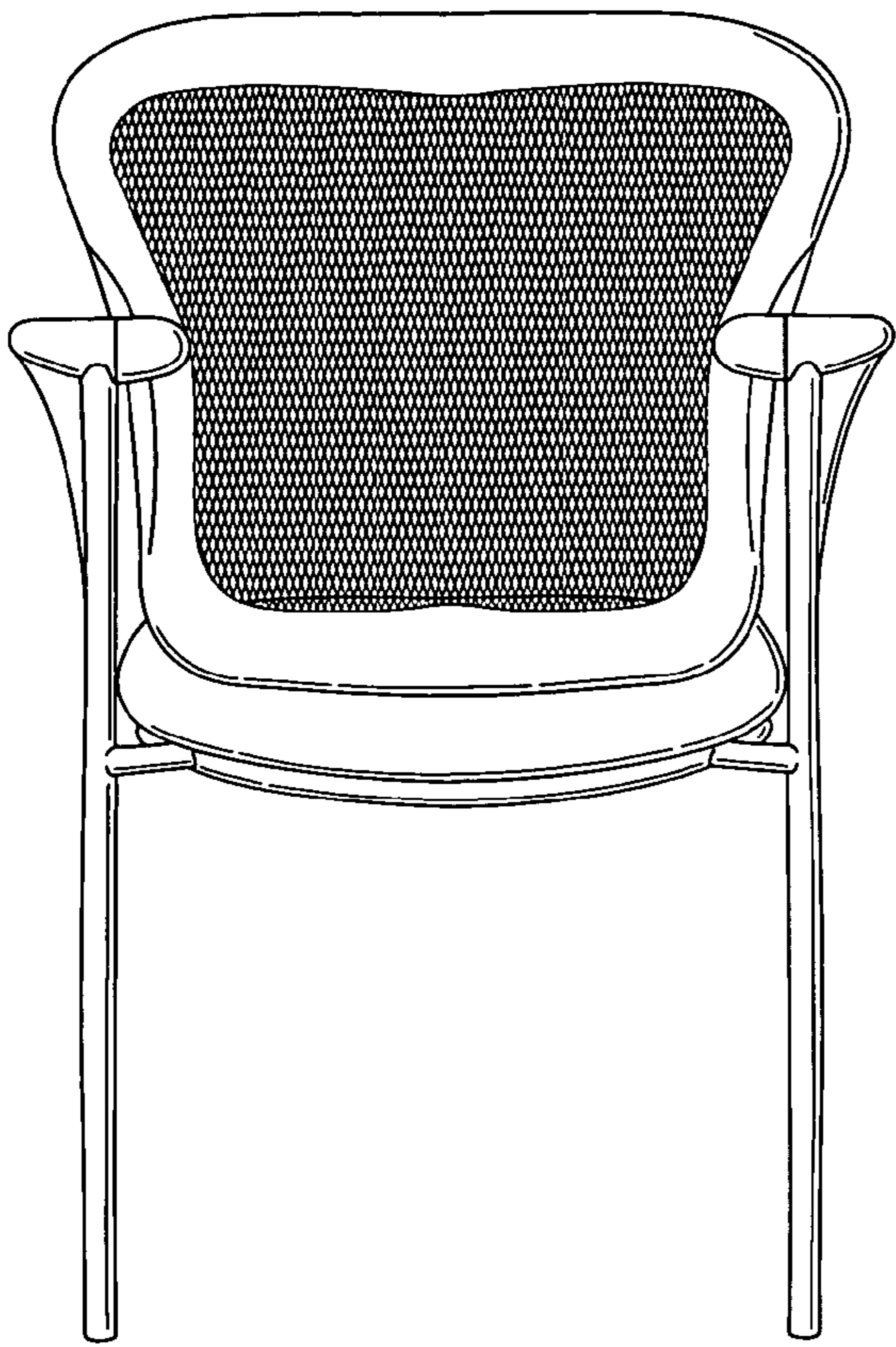

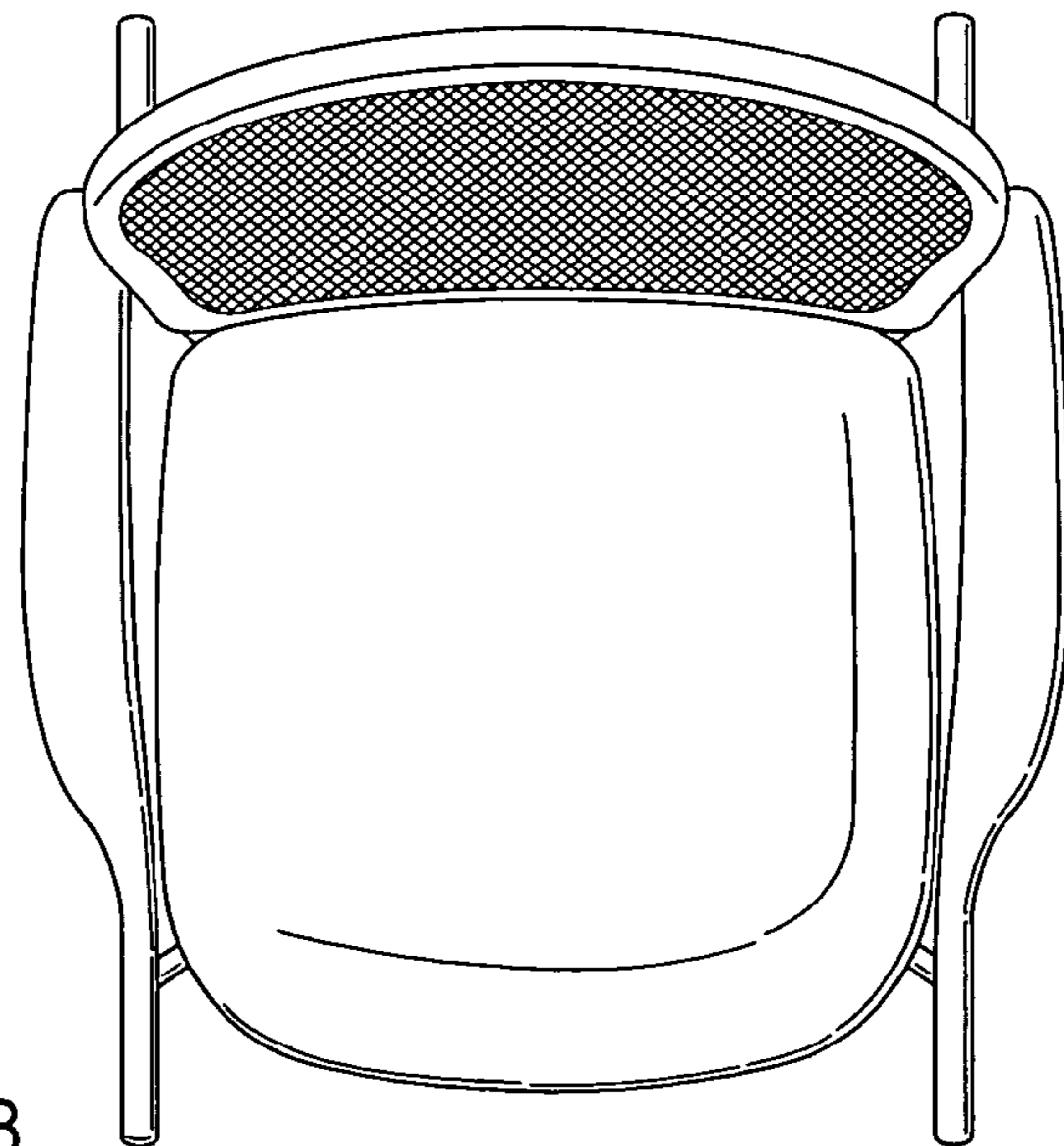

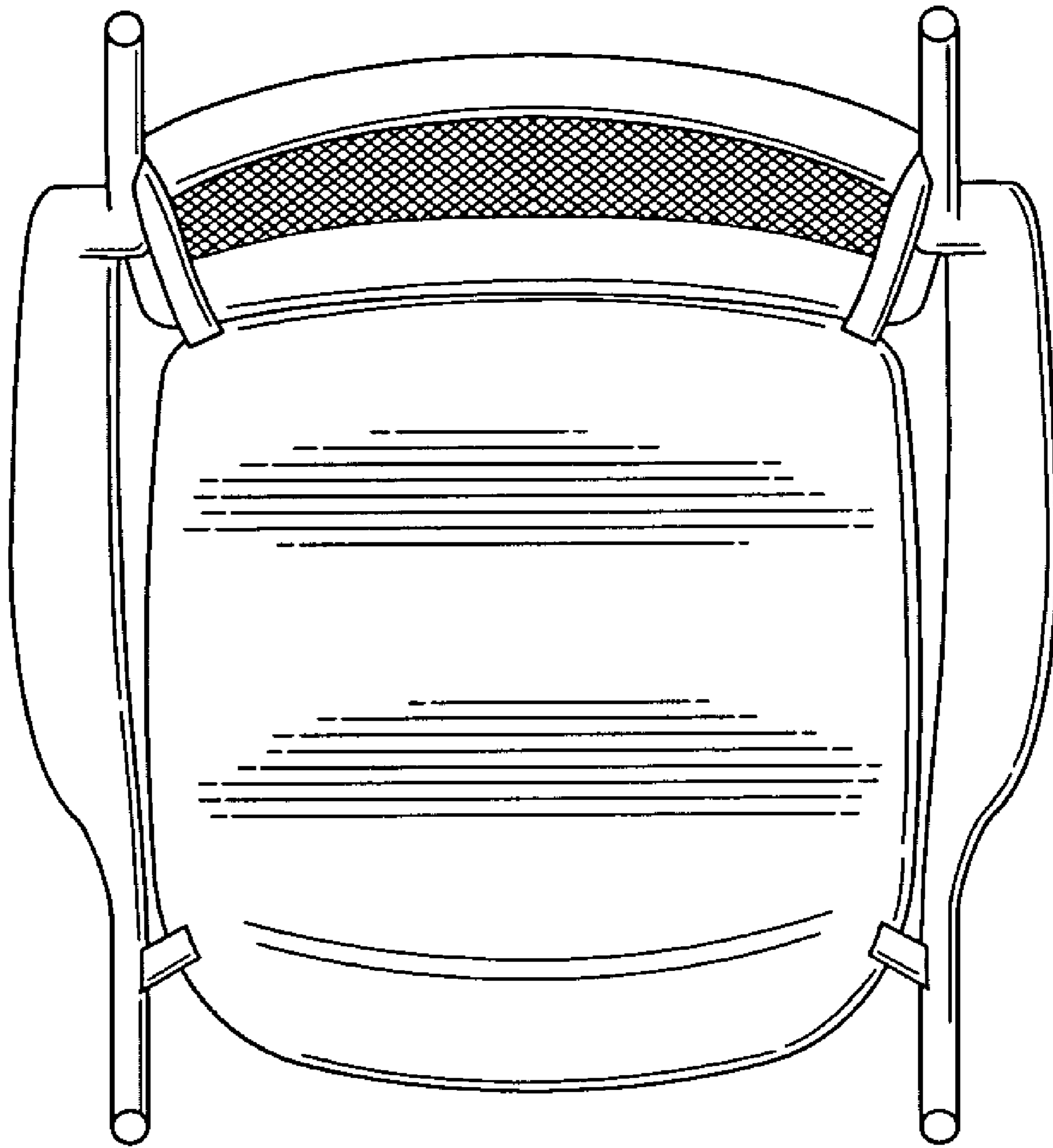
