FIG. 18 is a bottom plan view of the bottle of FIG. 13;

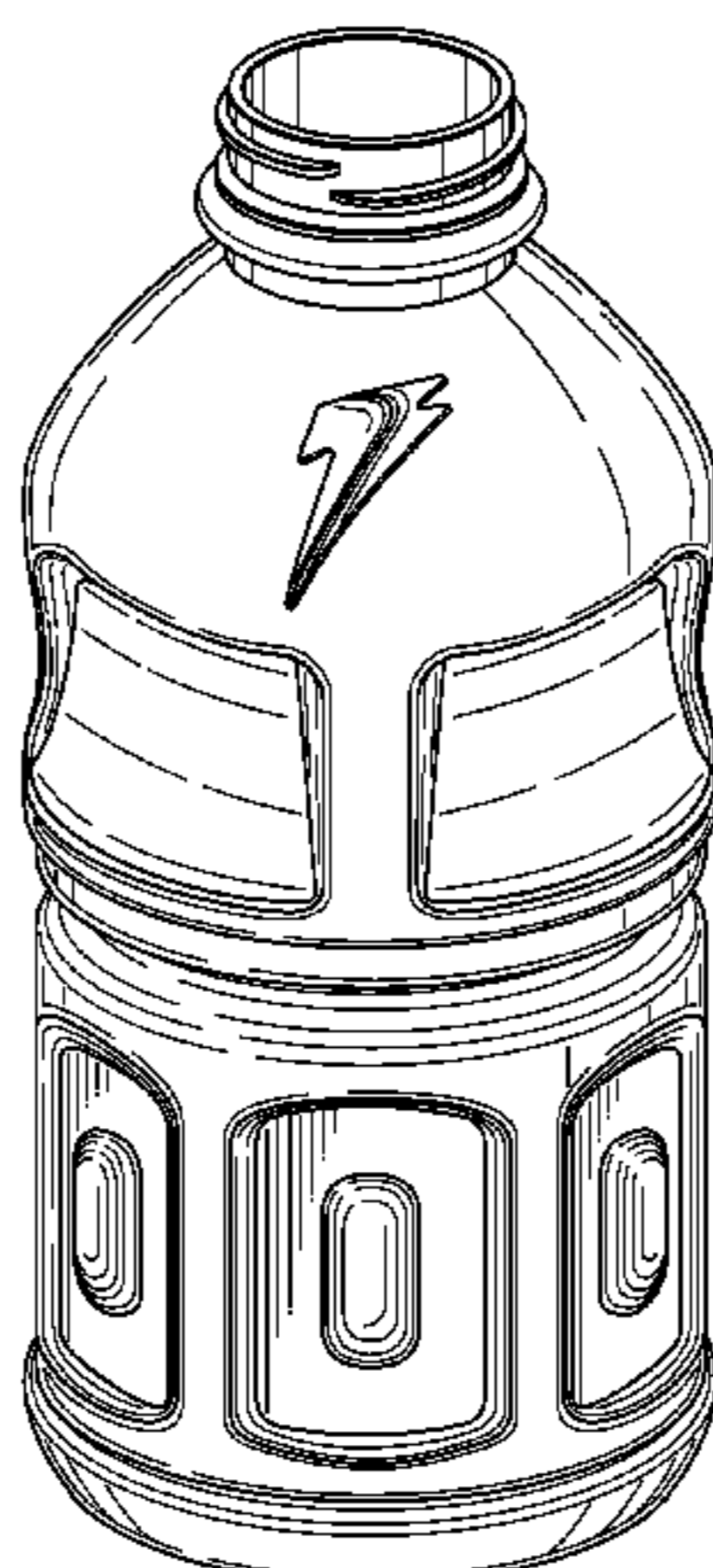


FIG. **19** is a perspective view of a fourth embodiment of the bottle;

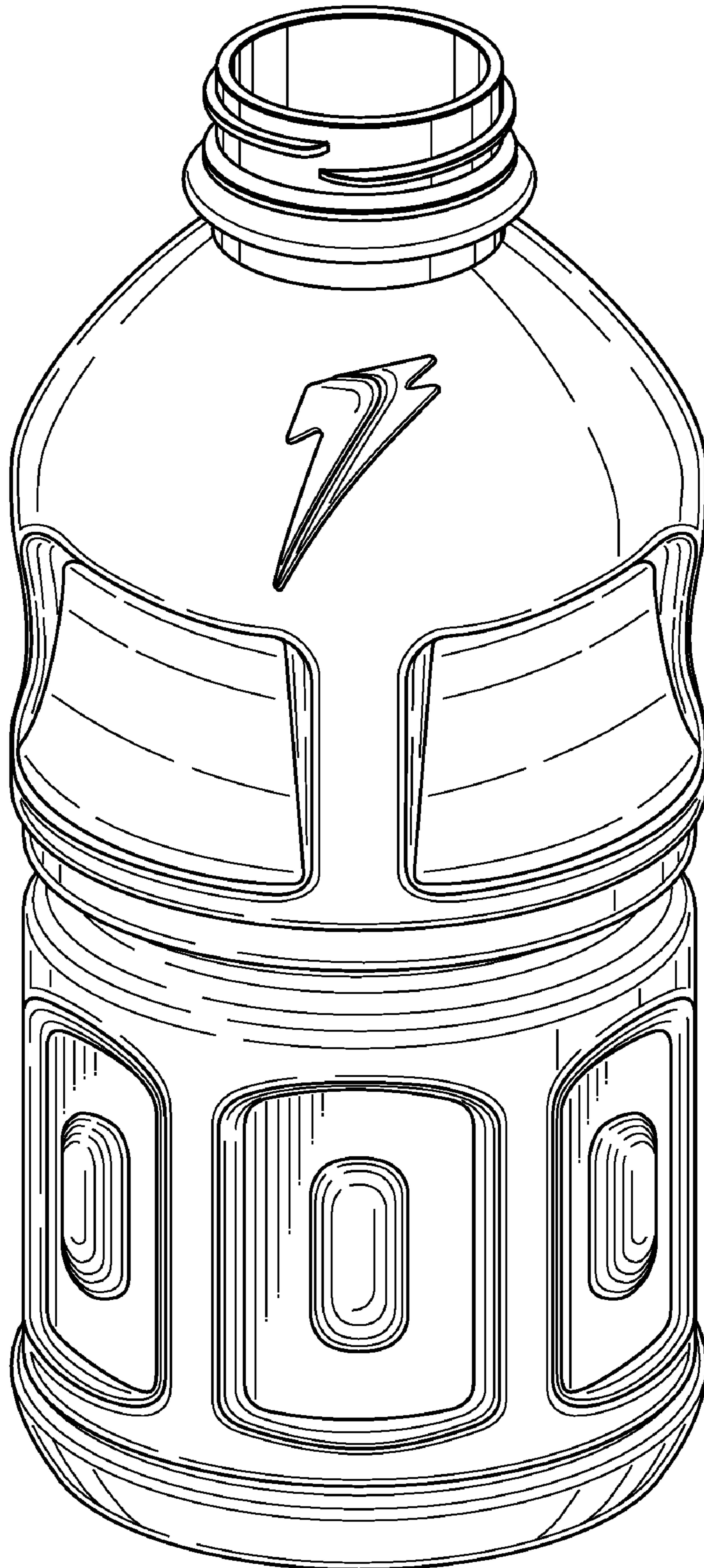

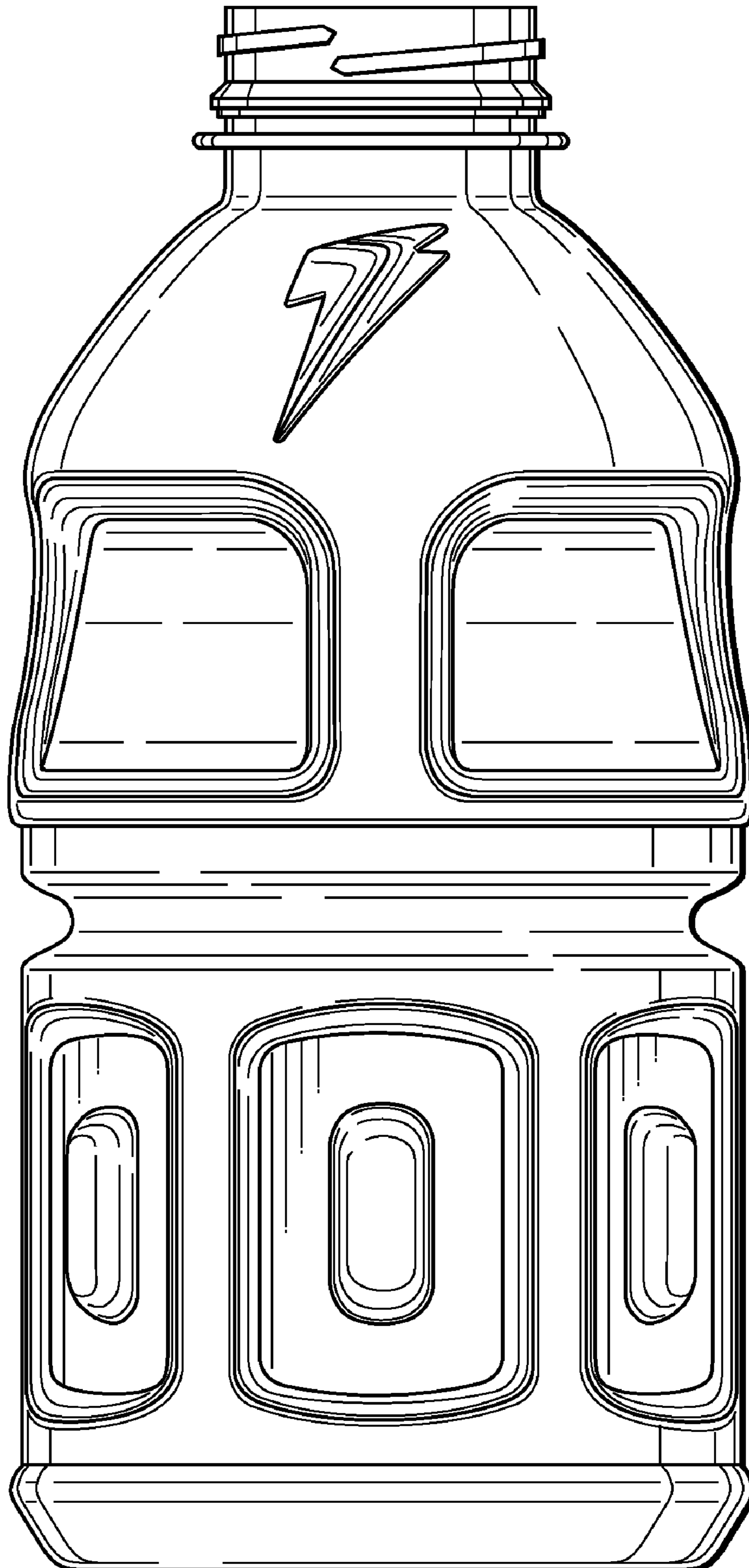

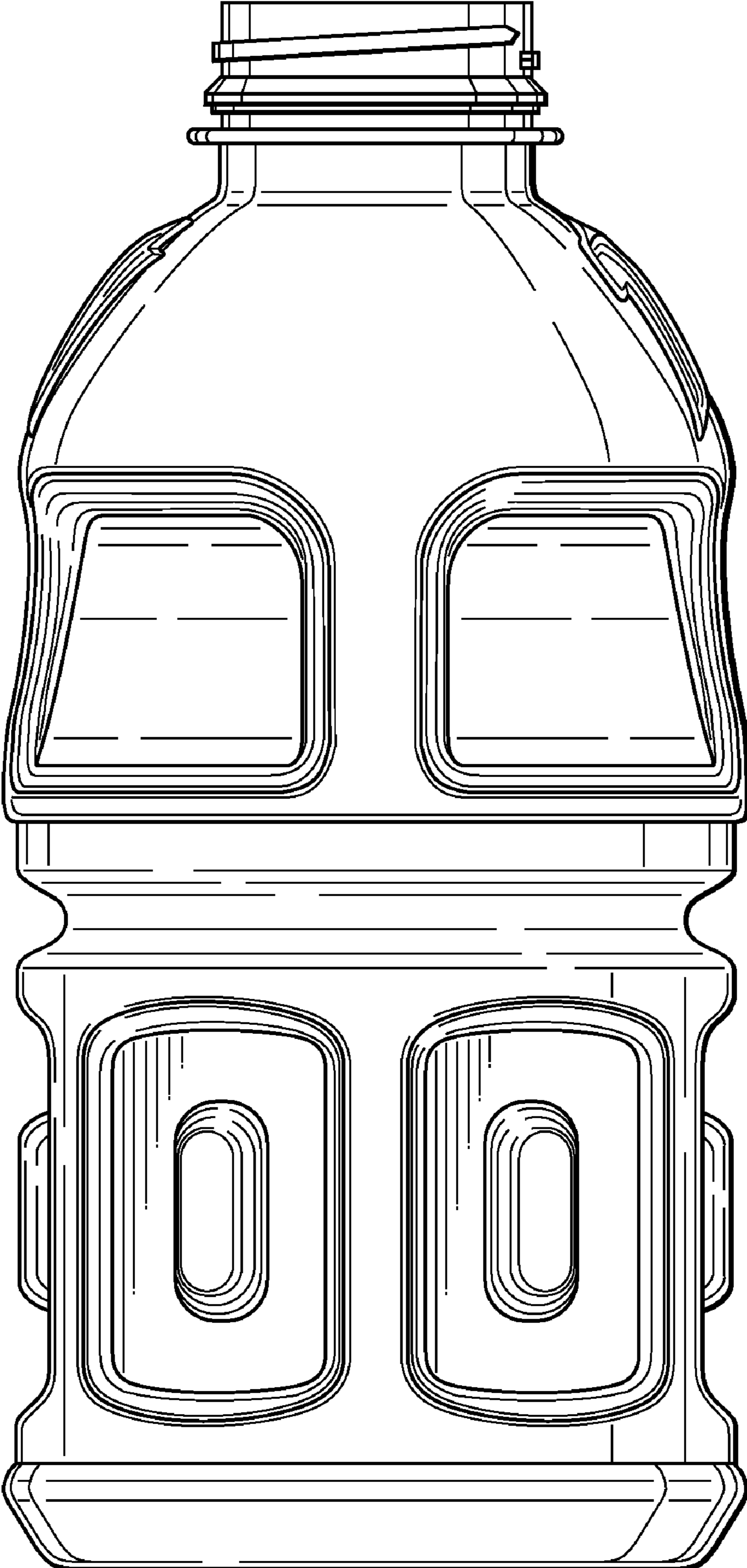

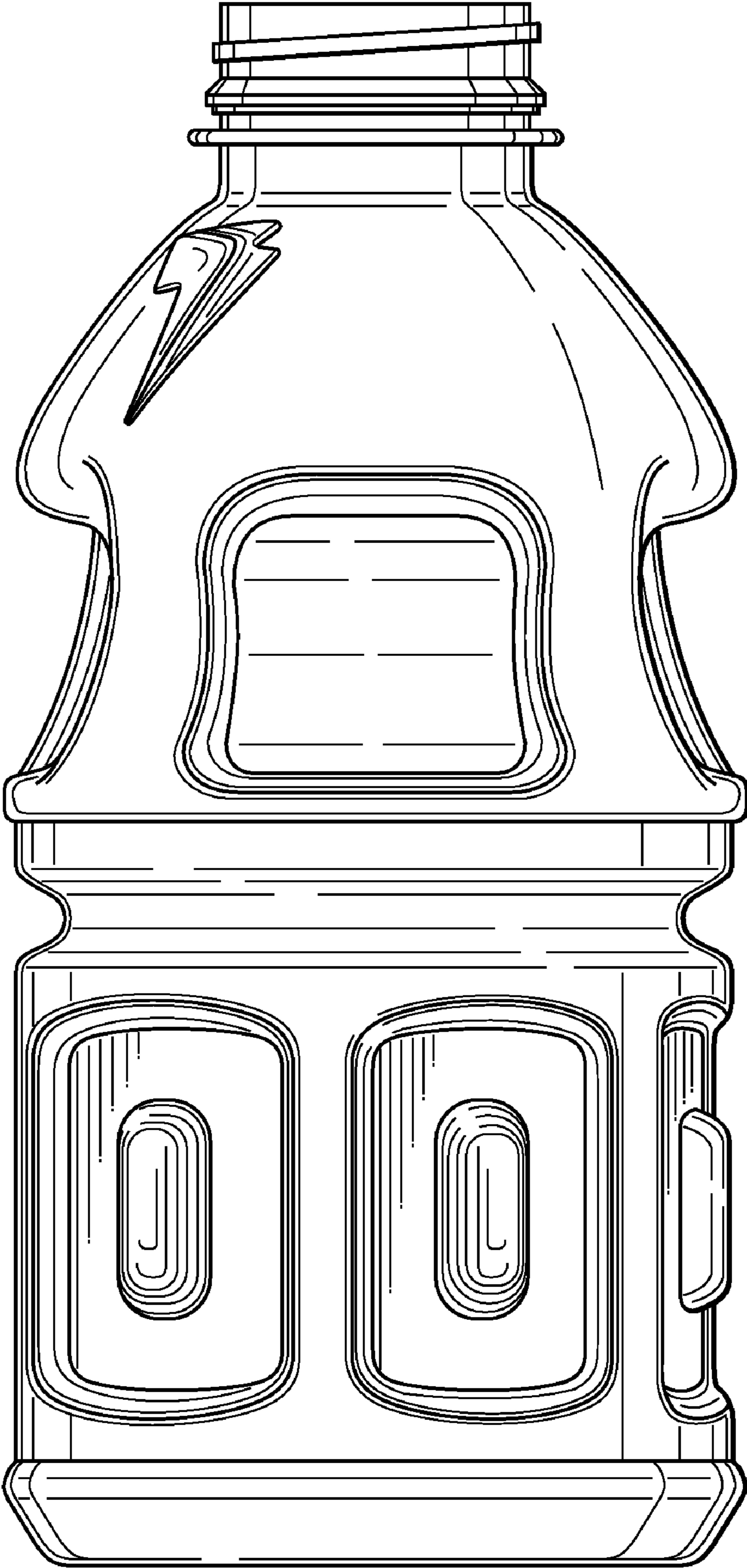

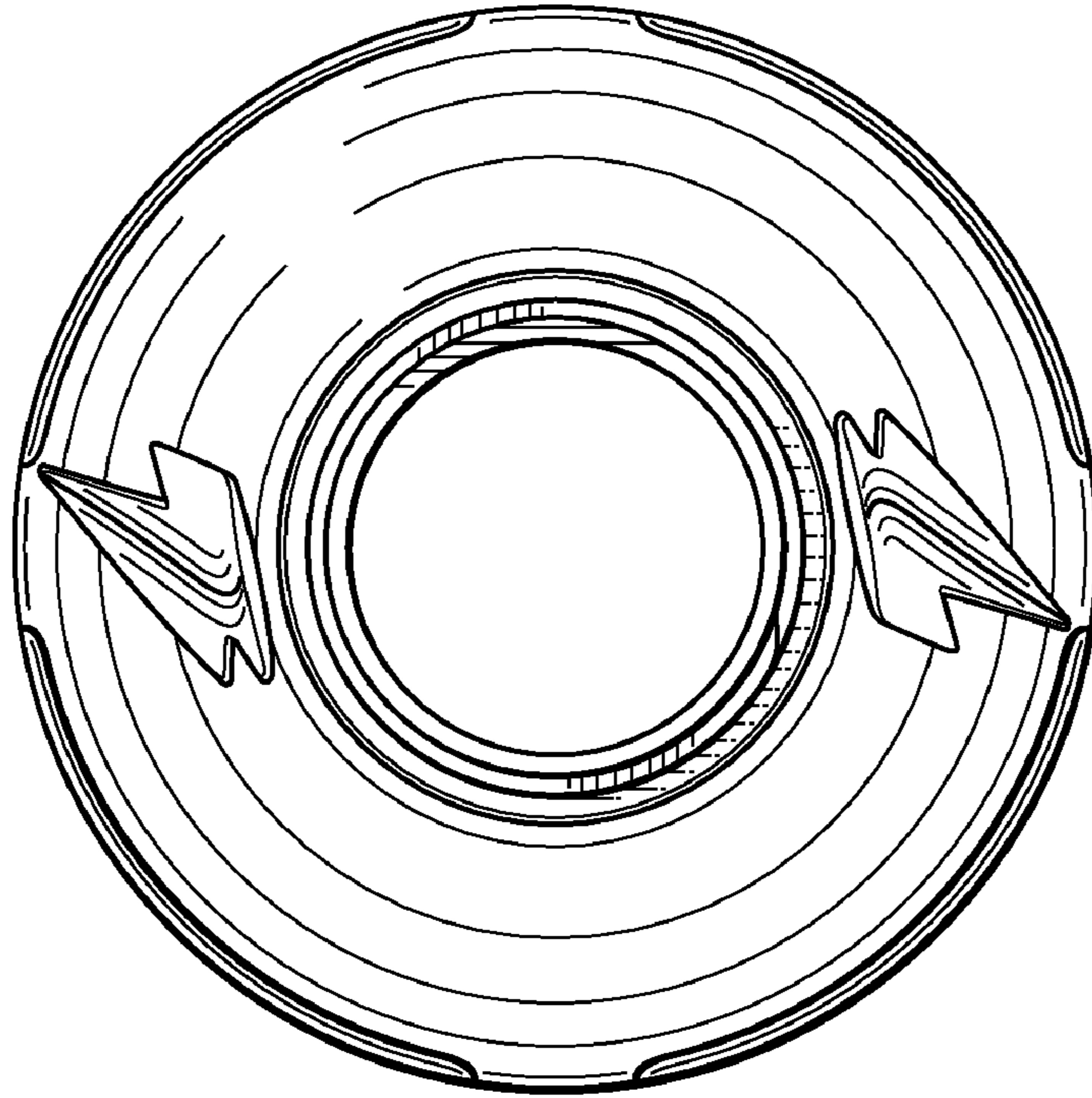

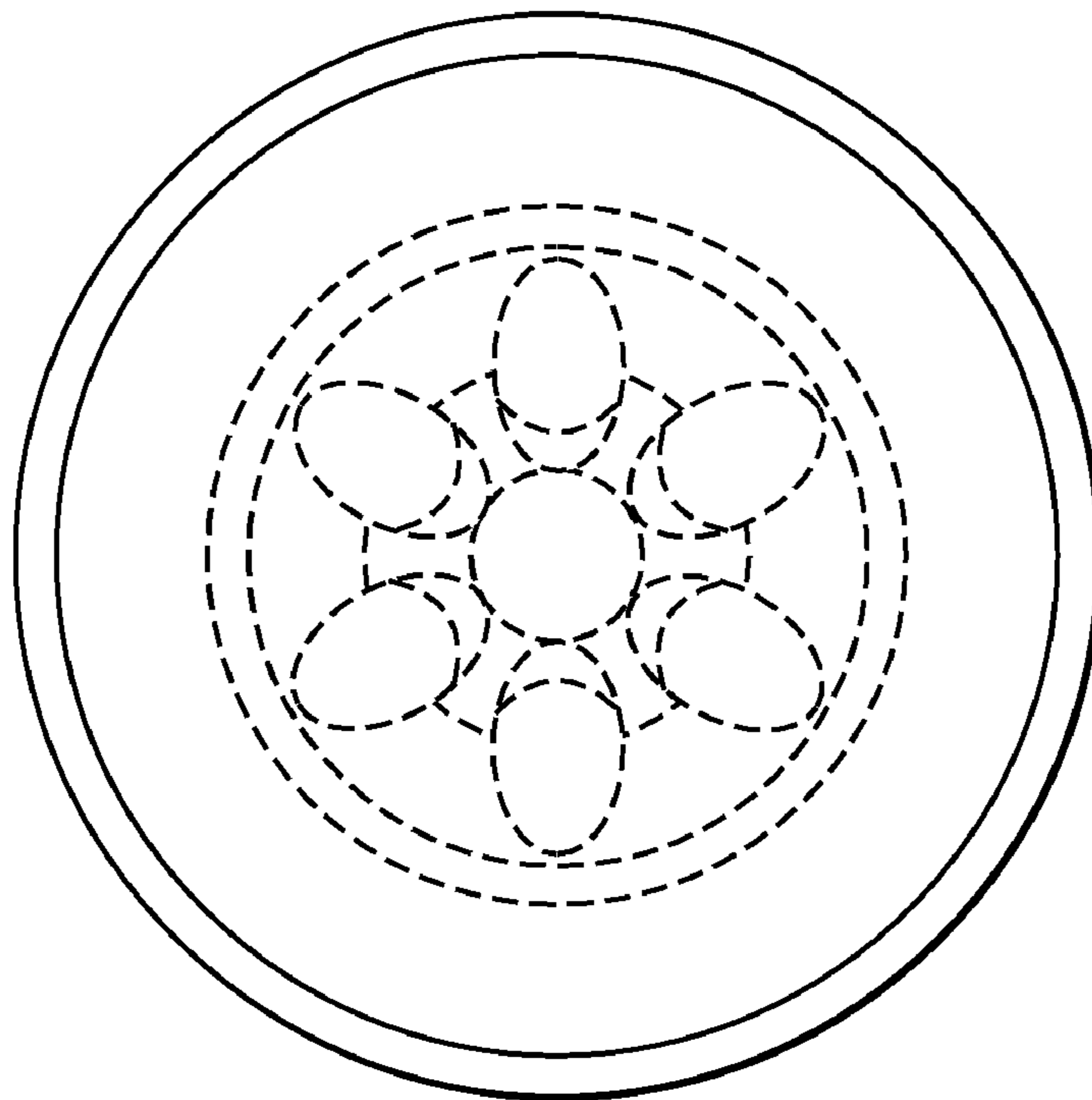

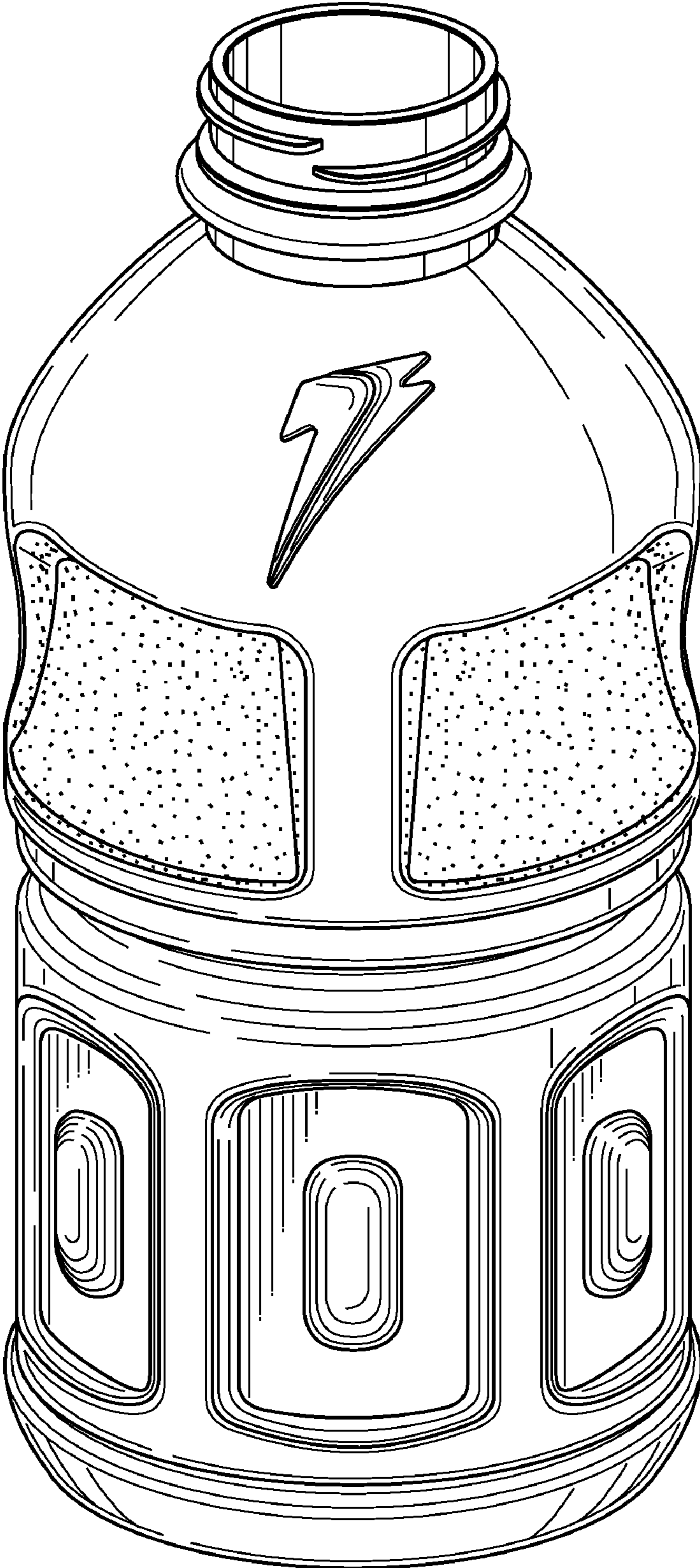

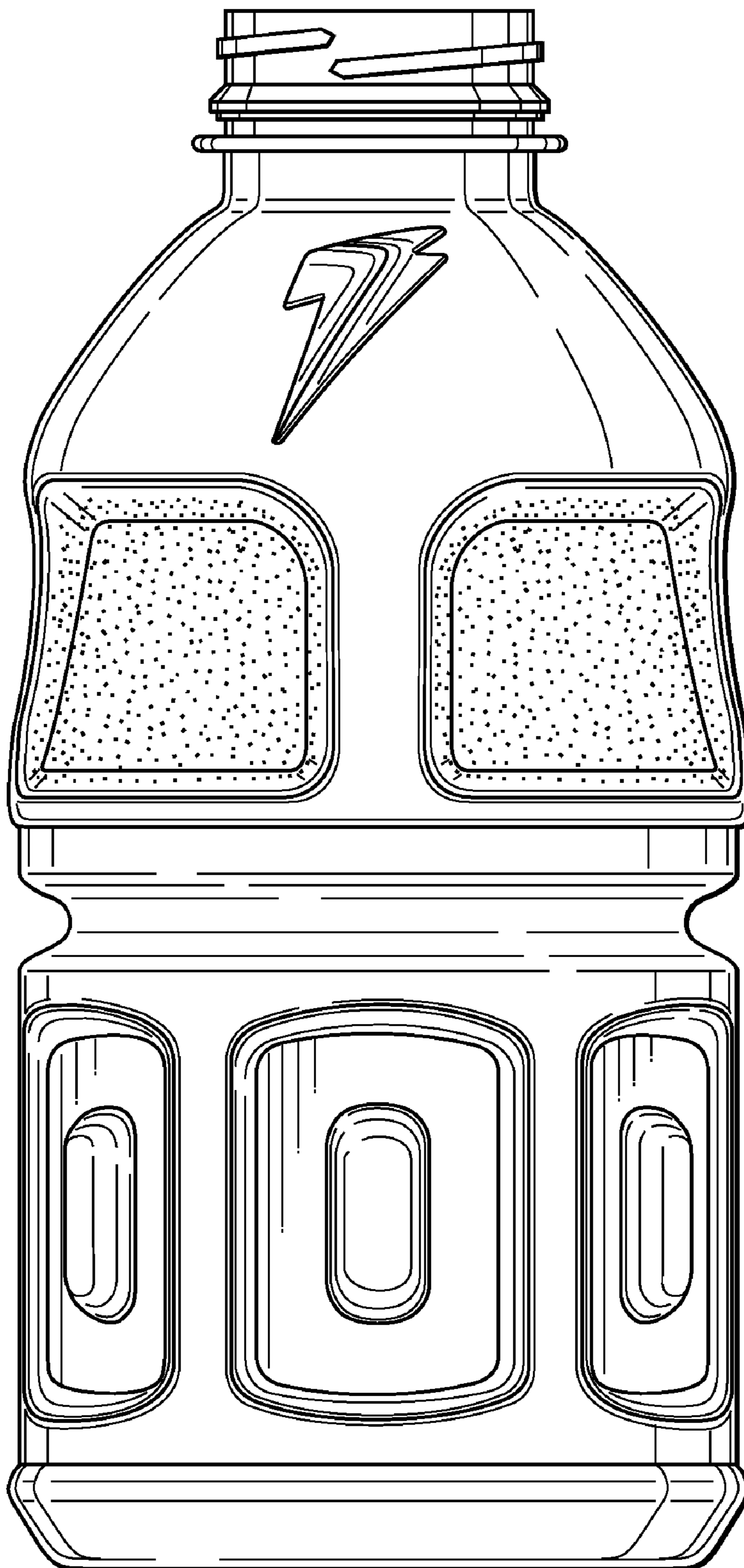

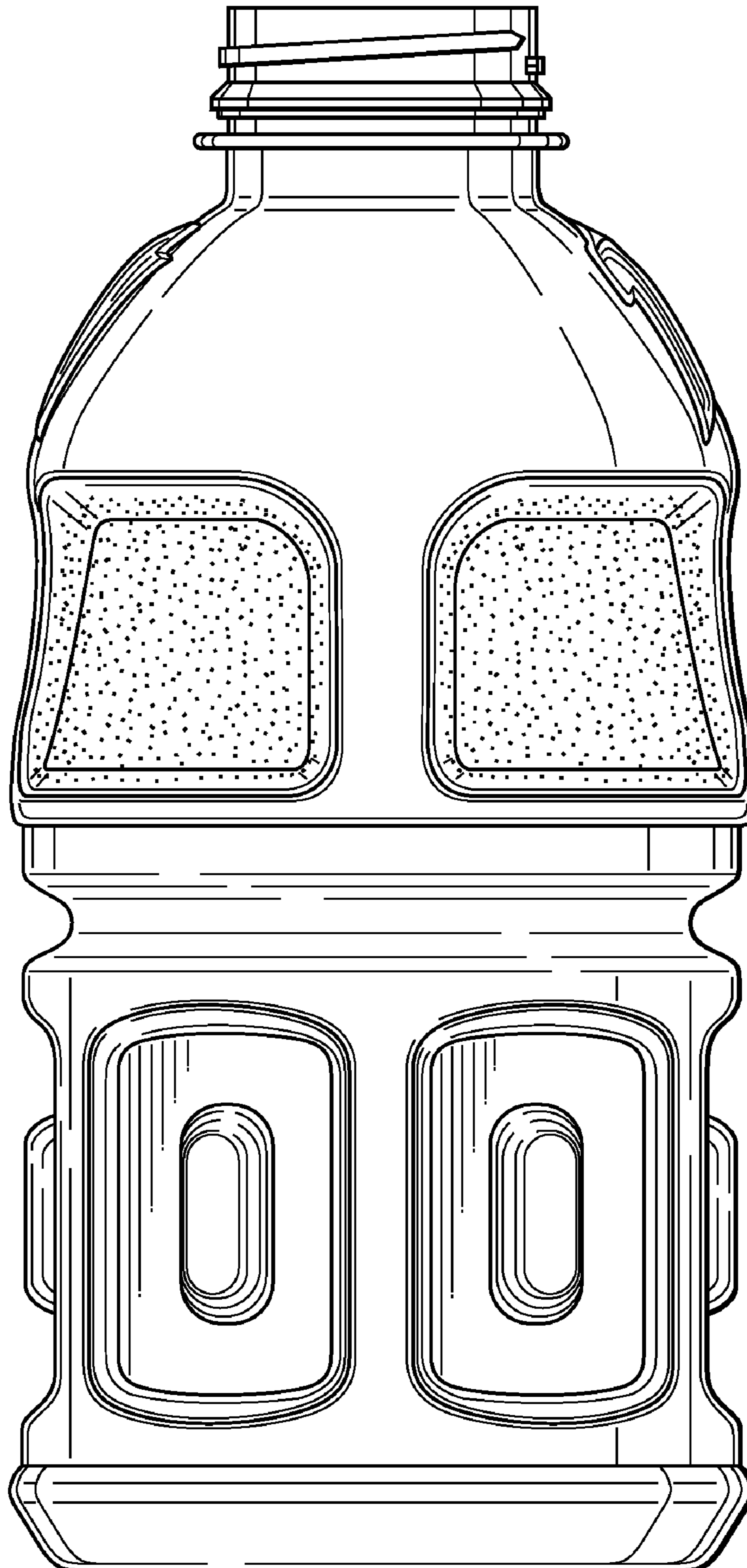

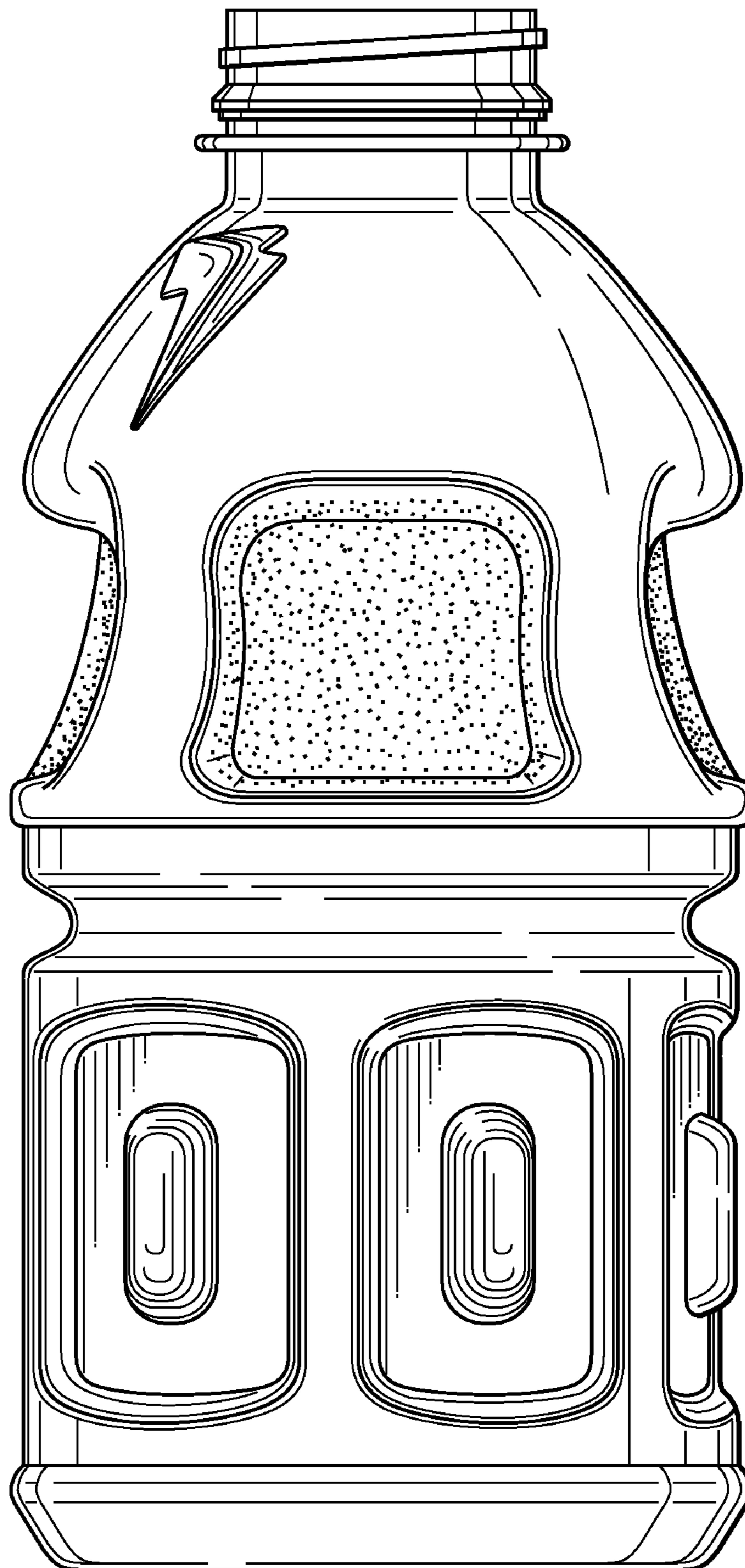

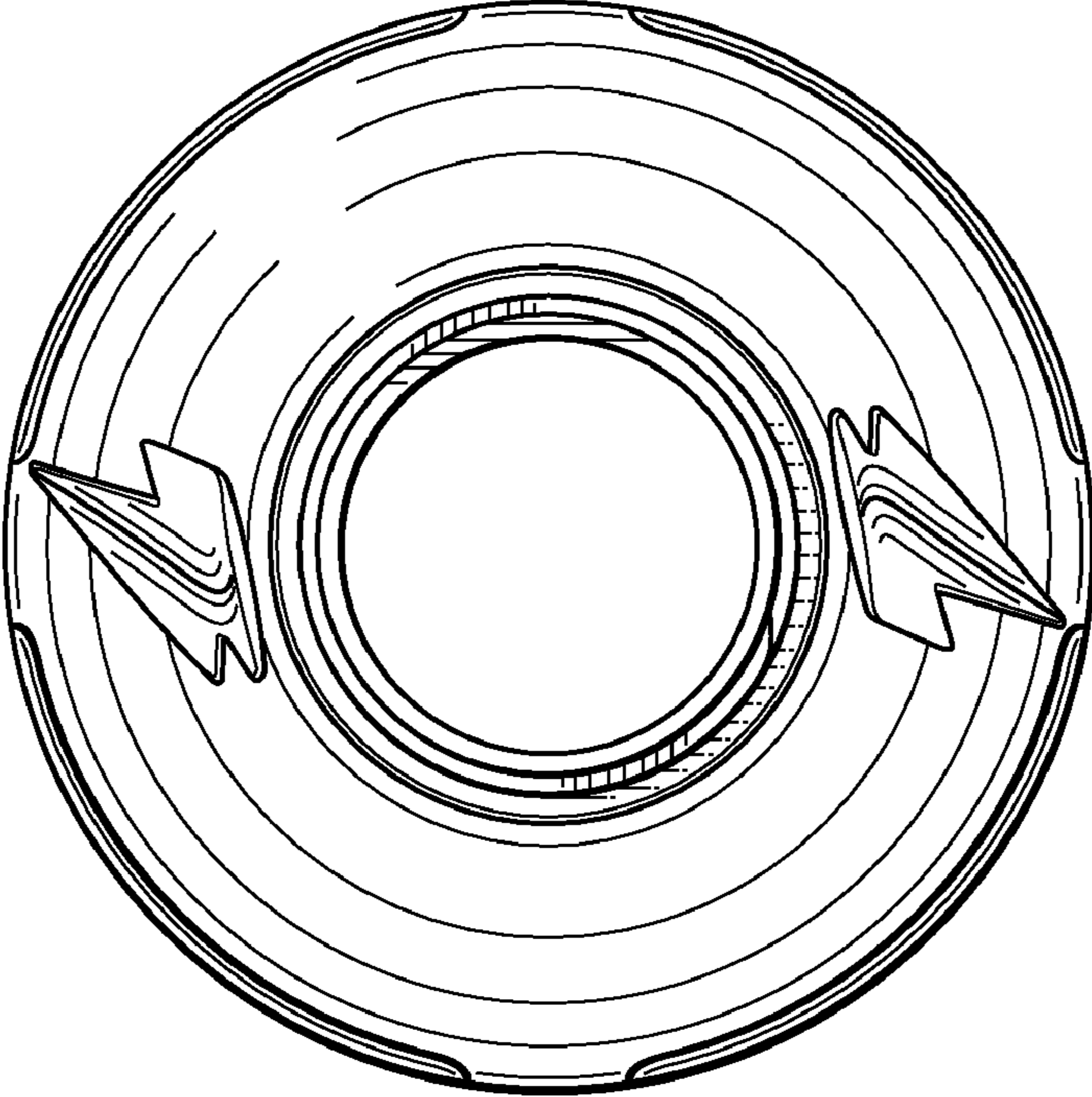

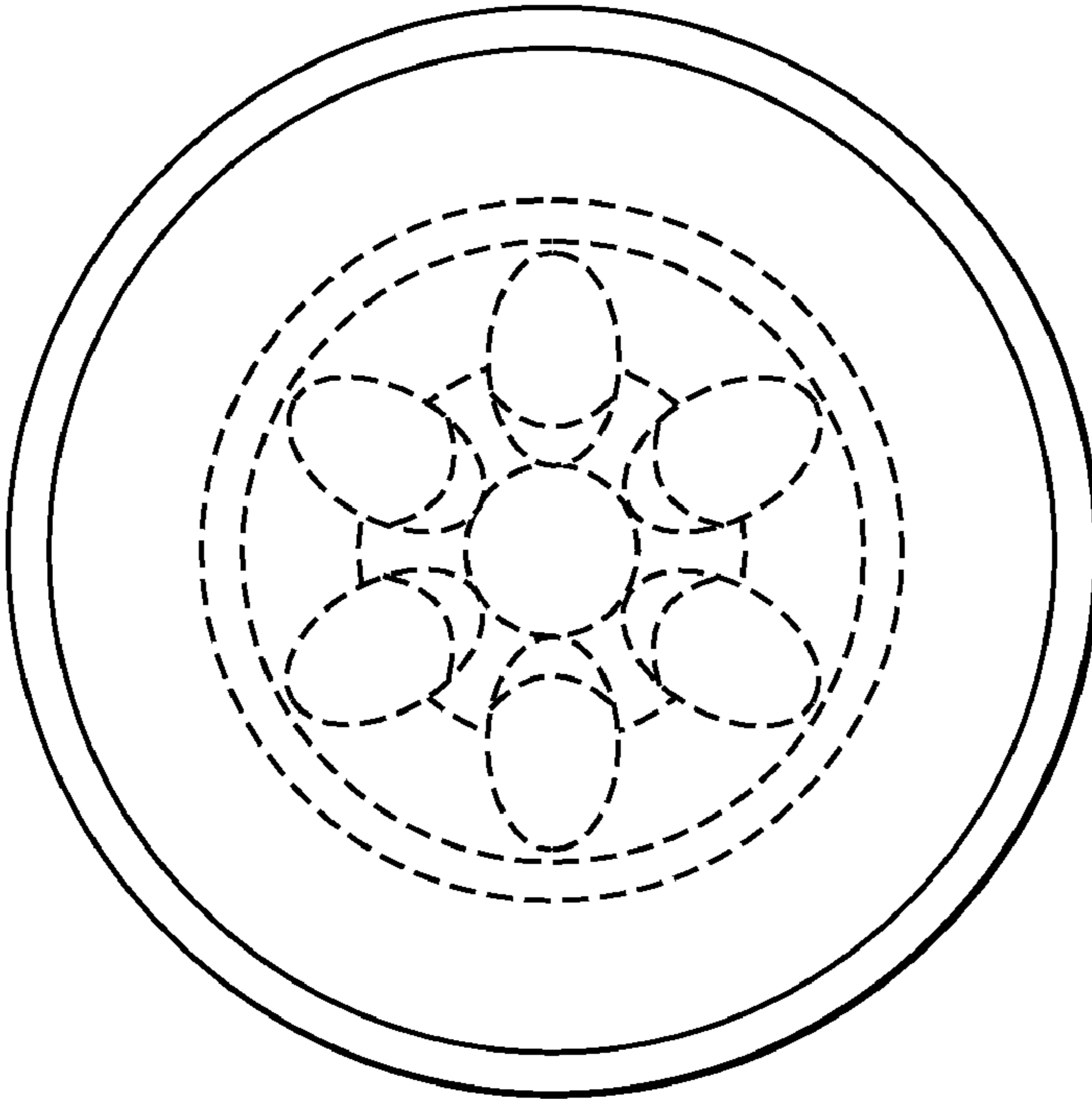

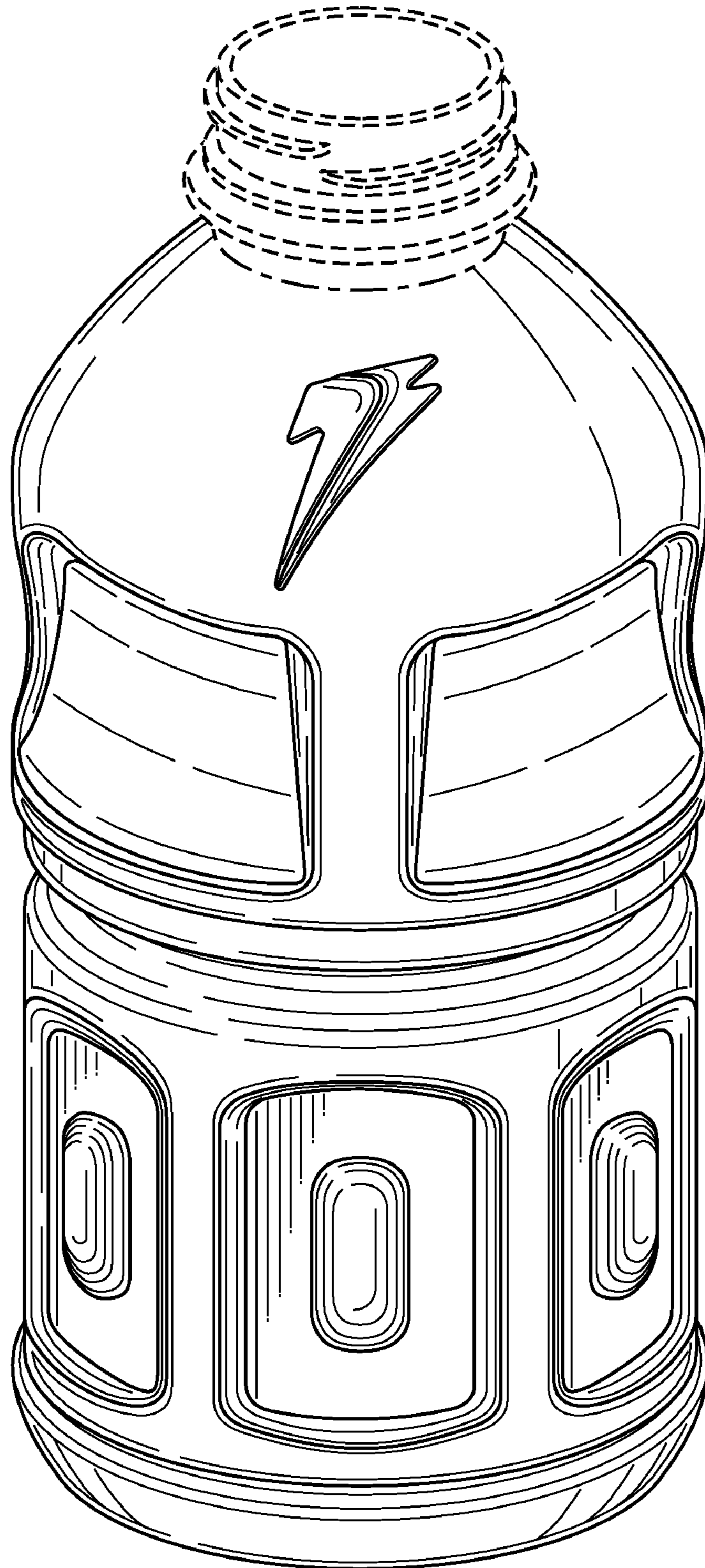

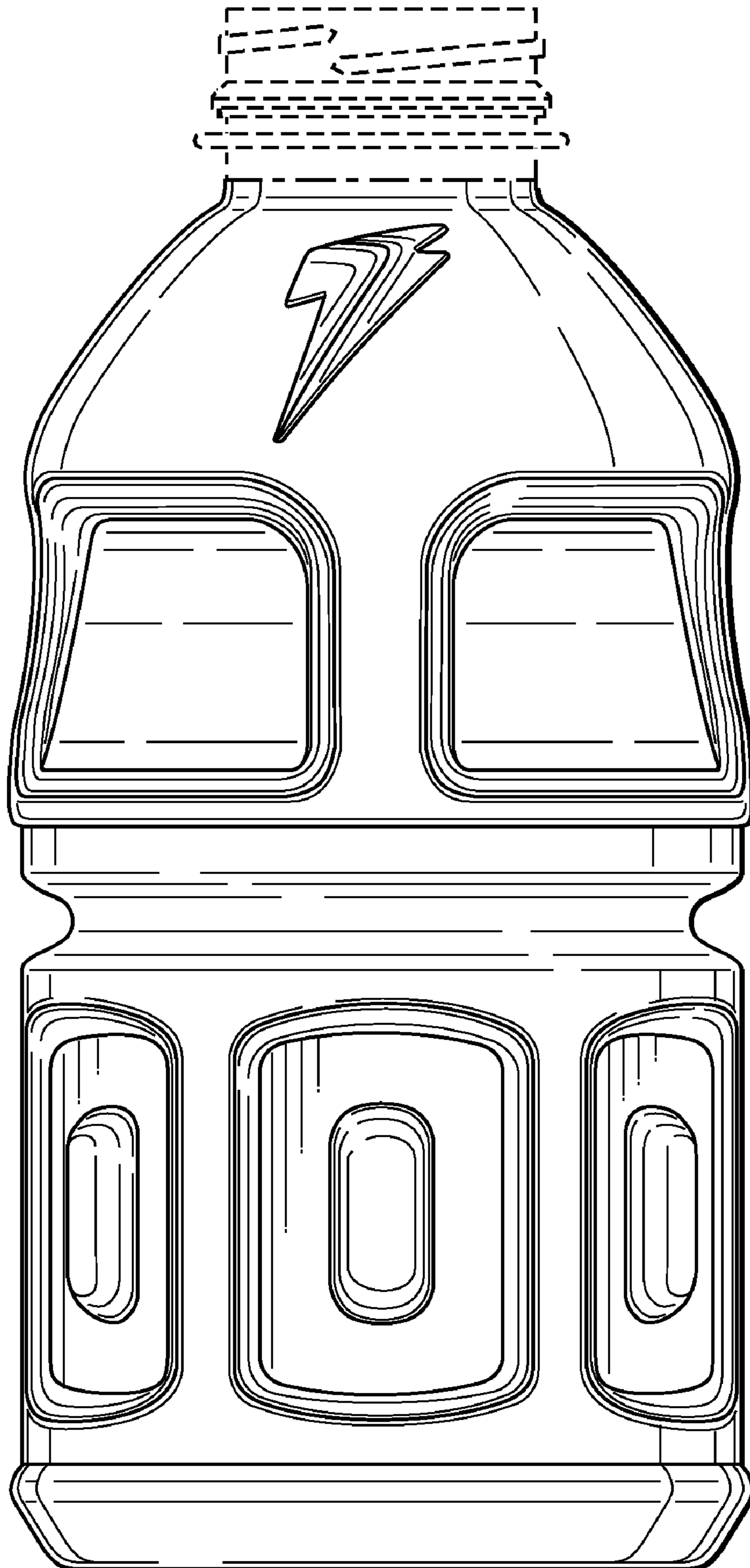

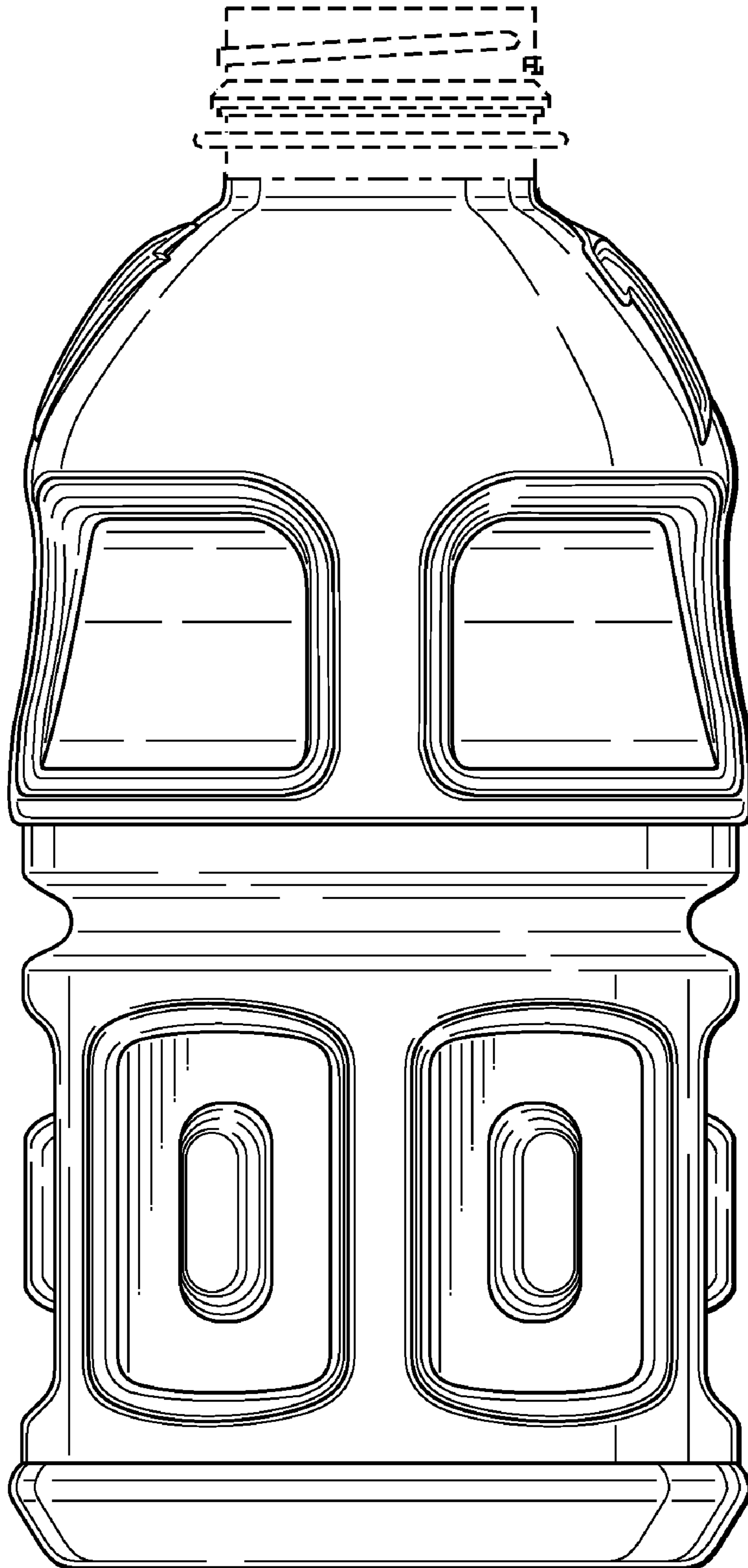

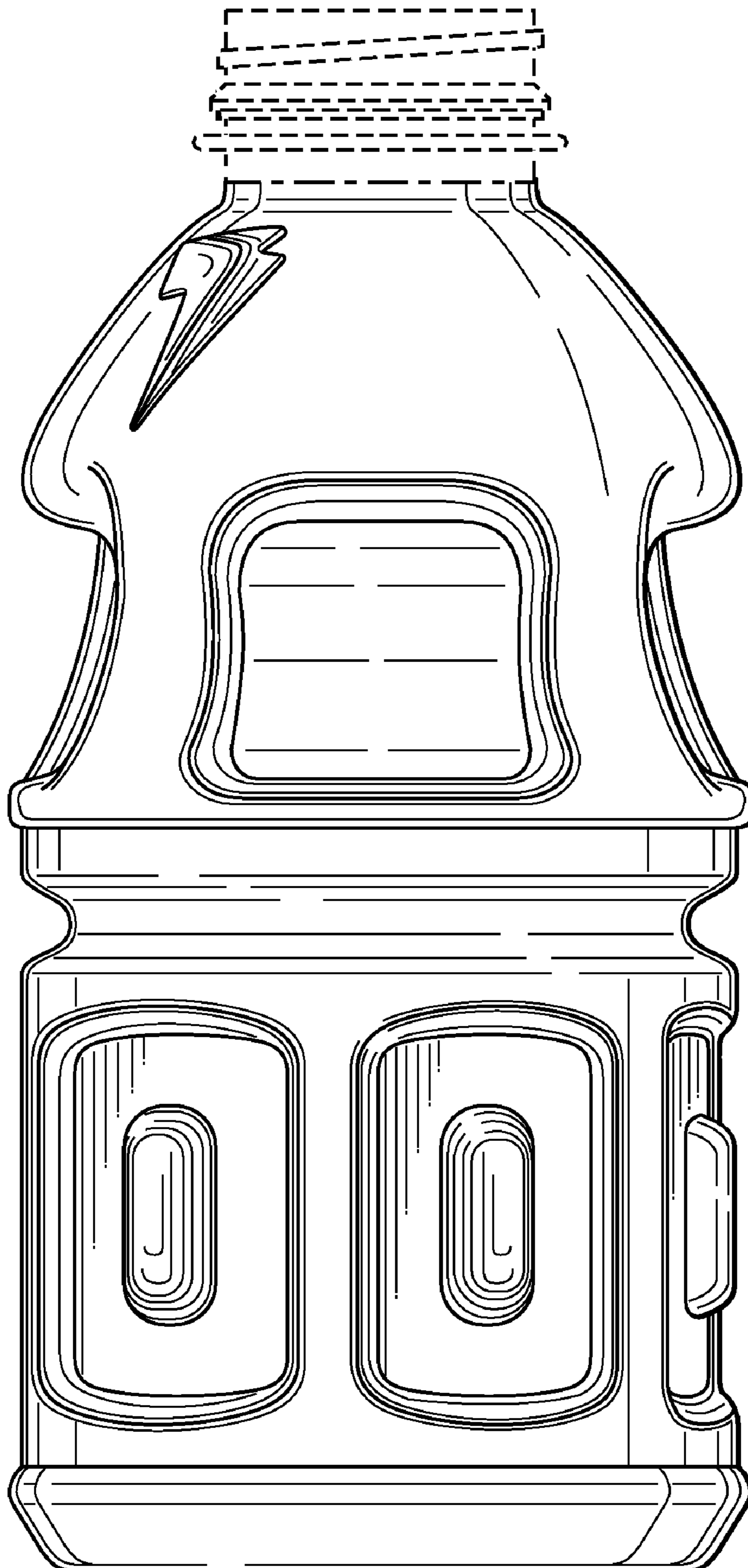

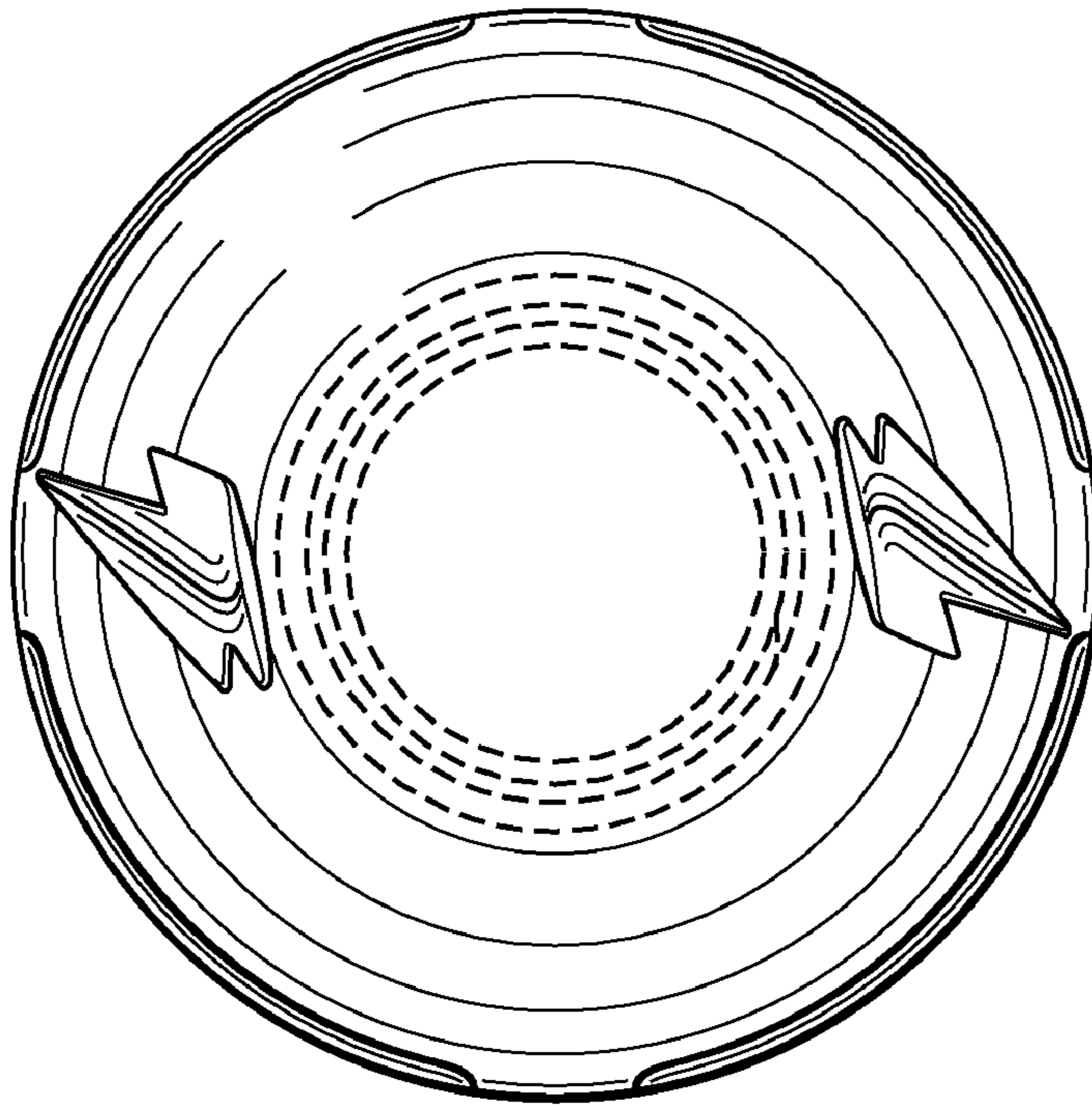

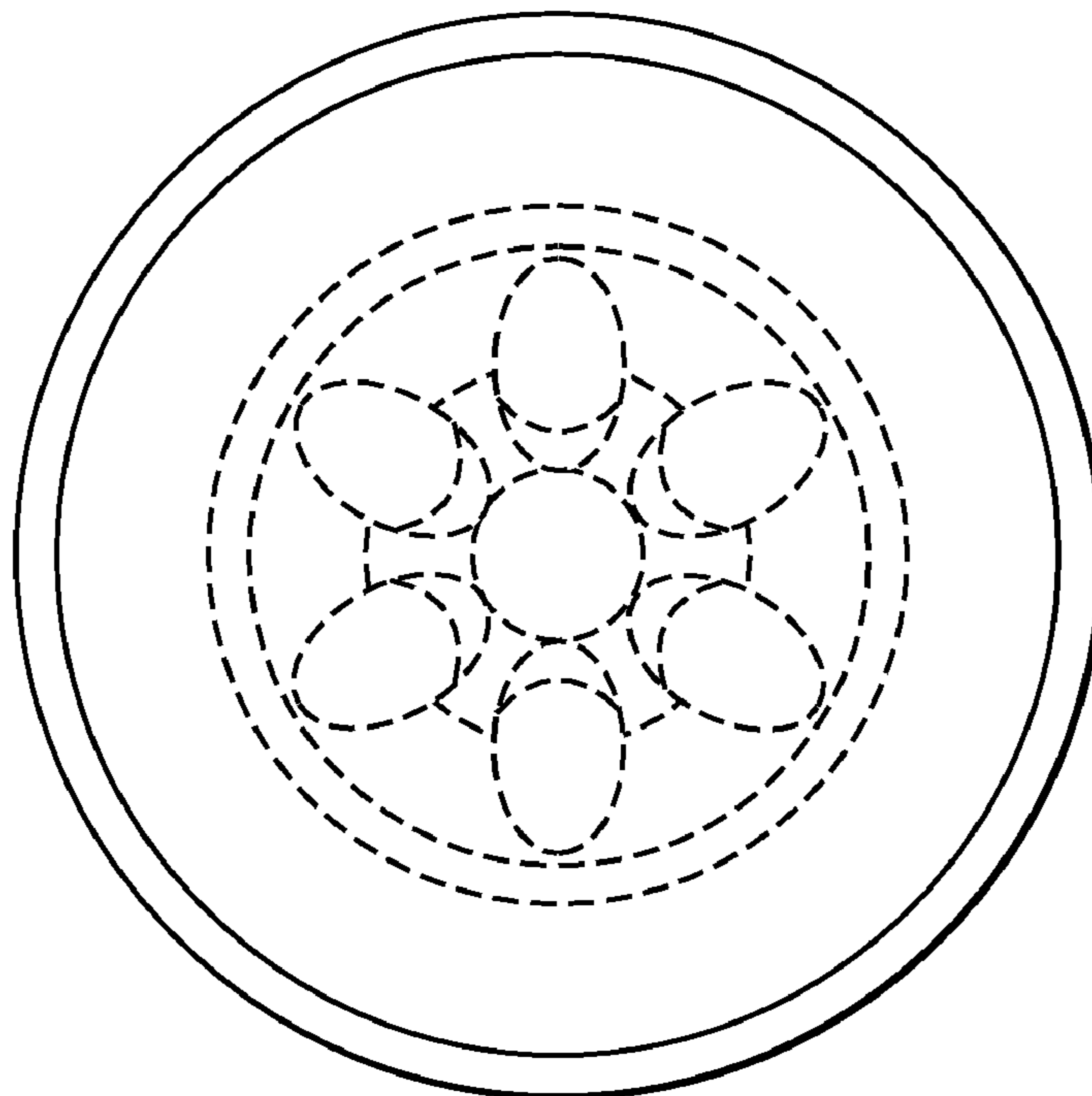

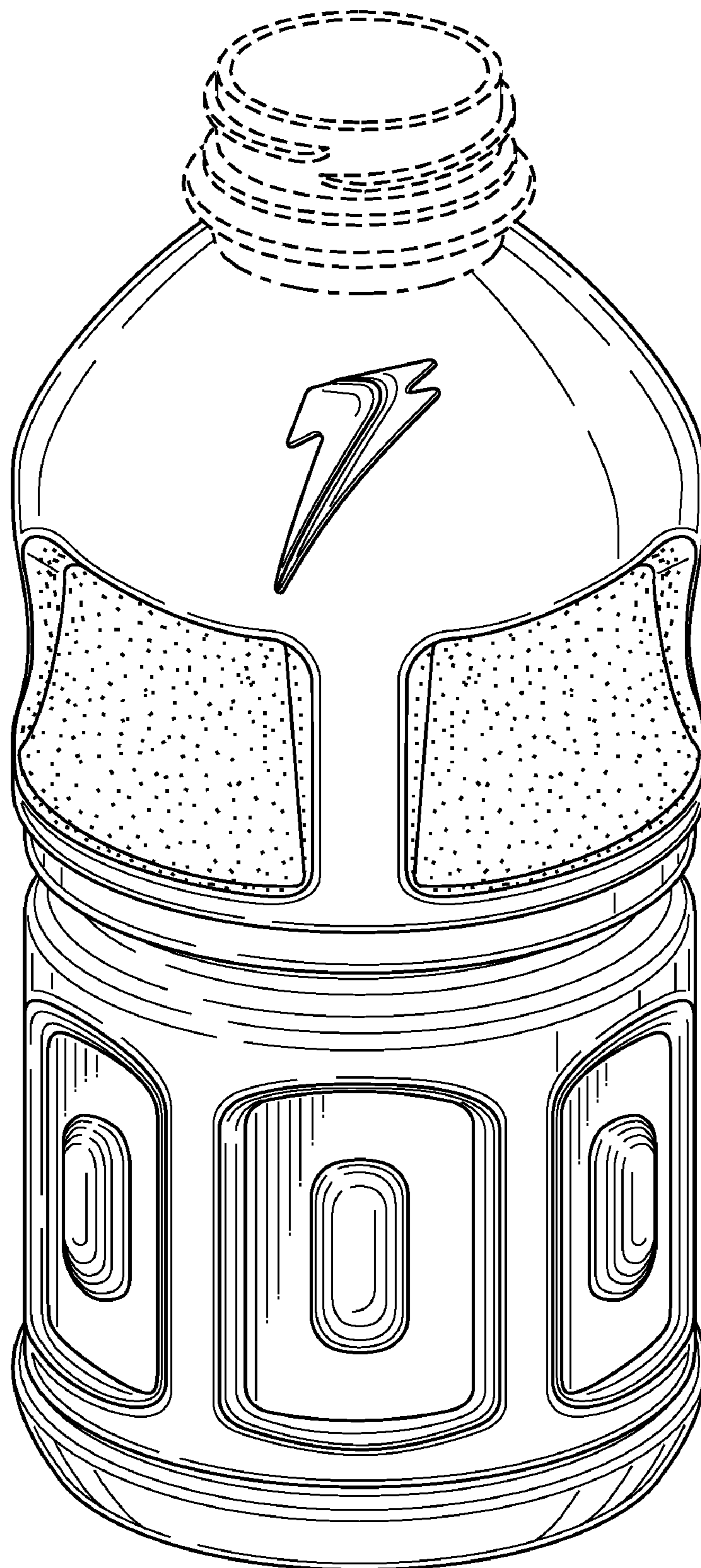

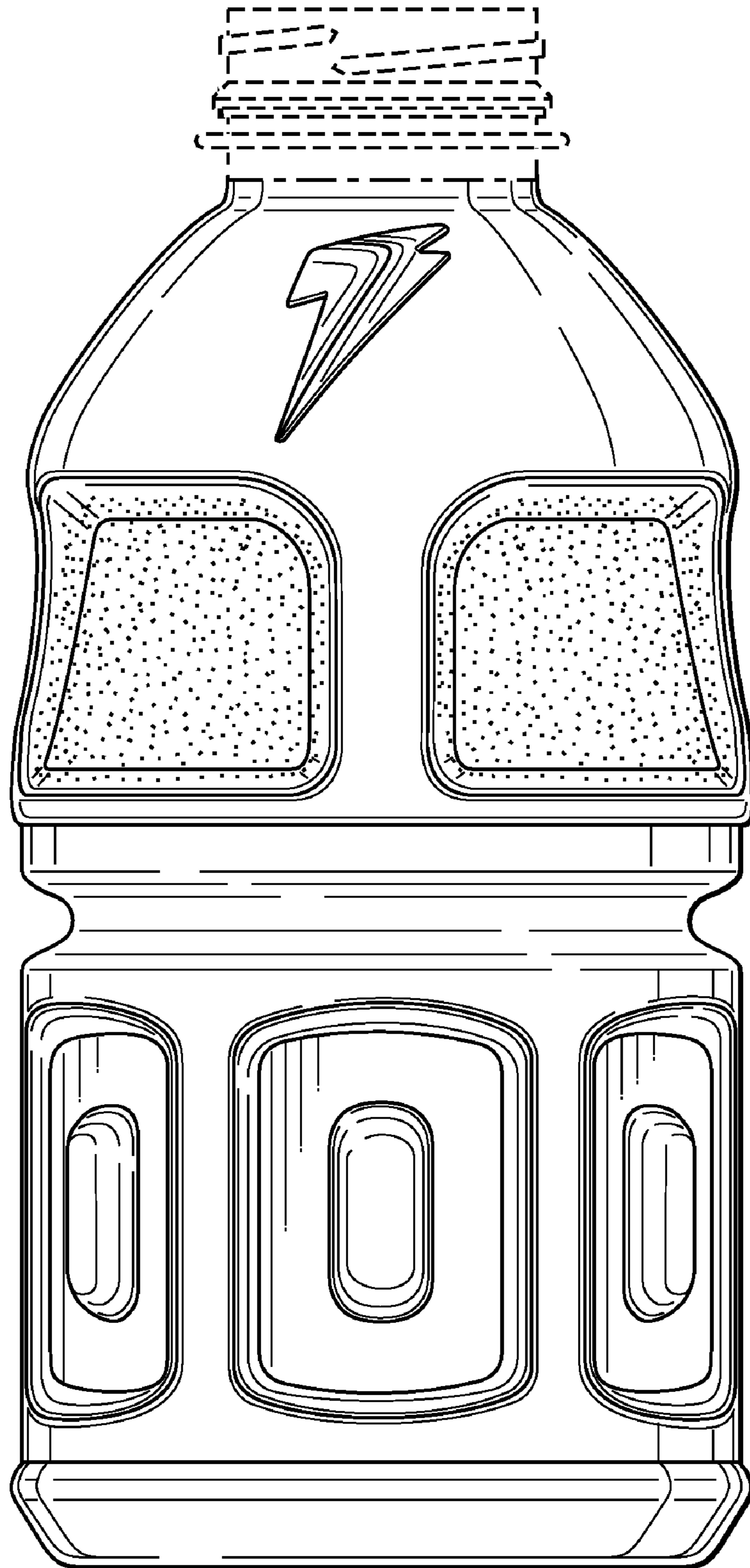

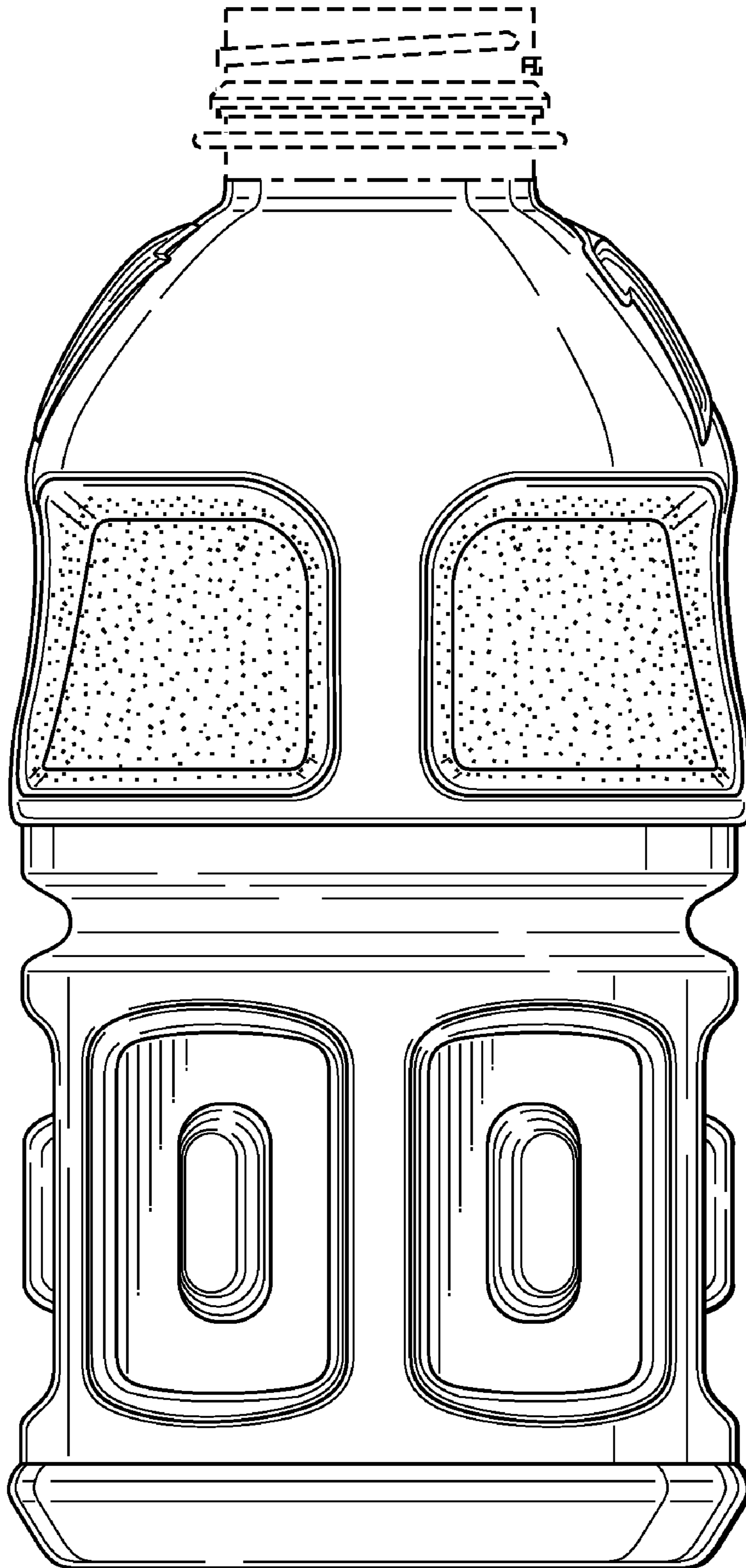

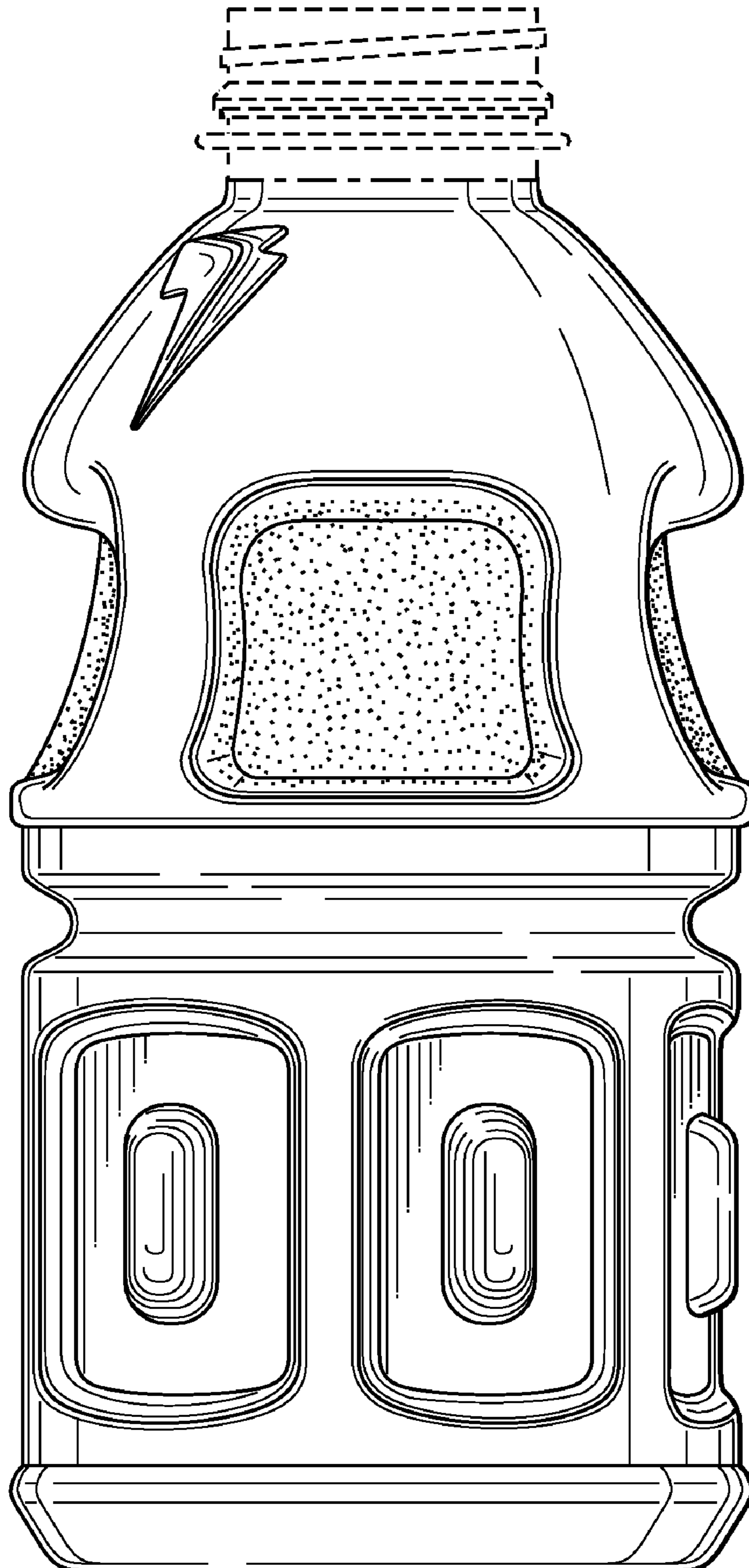

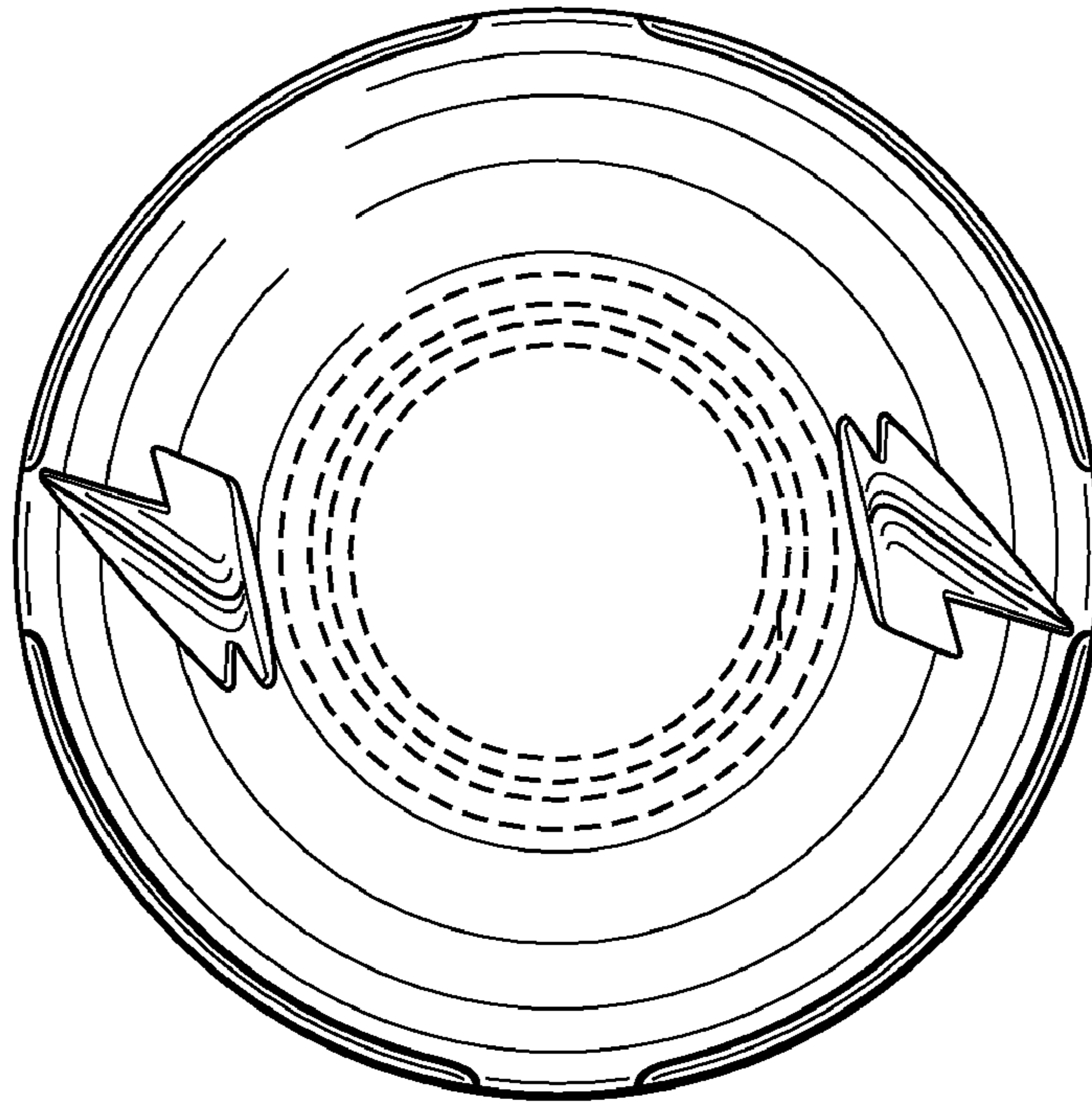

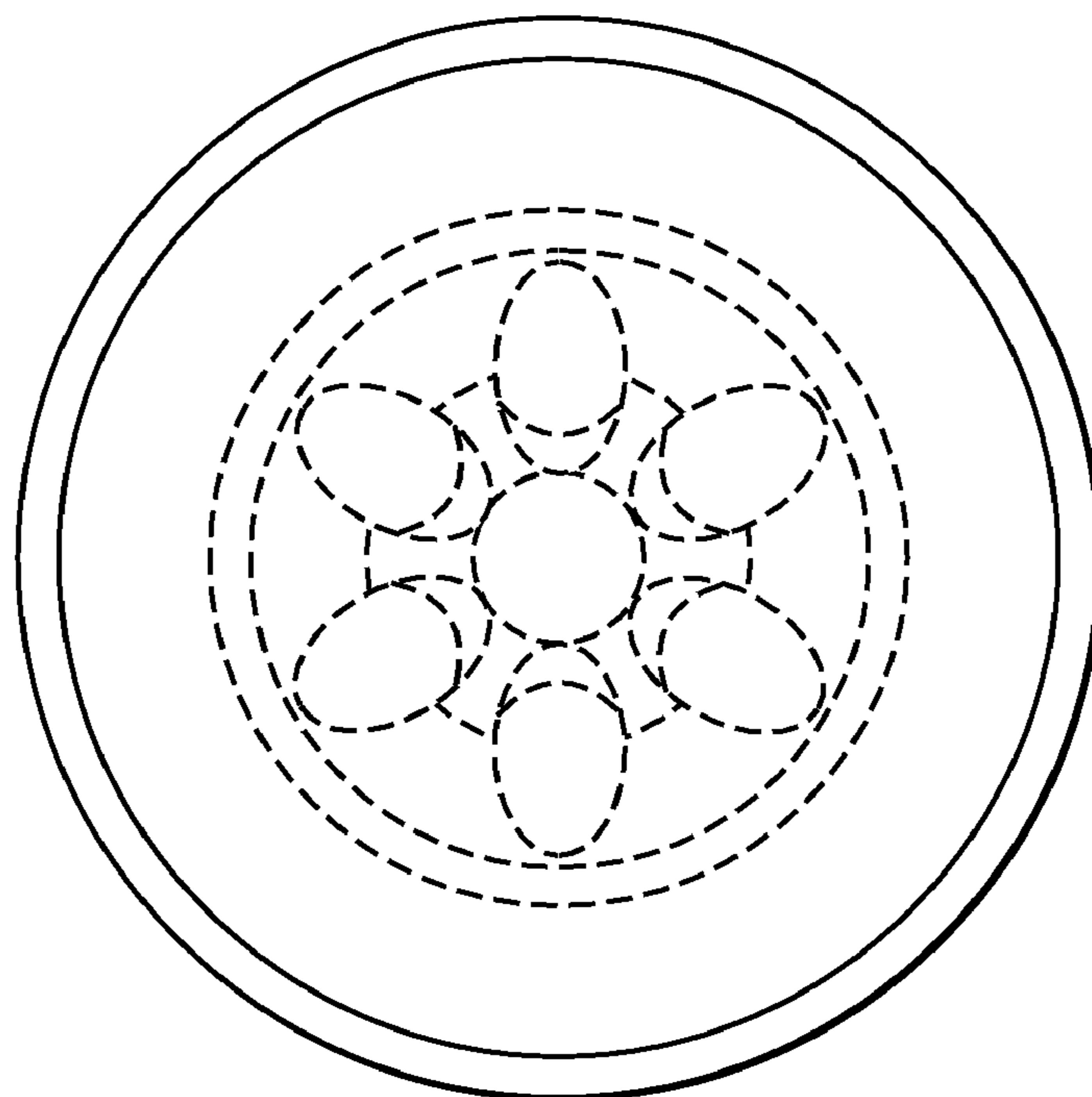

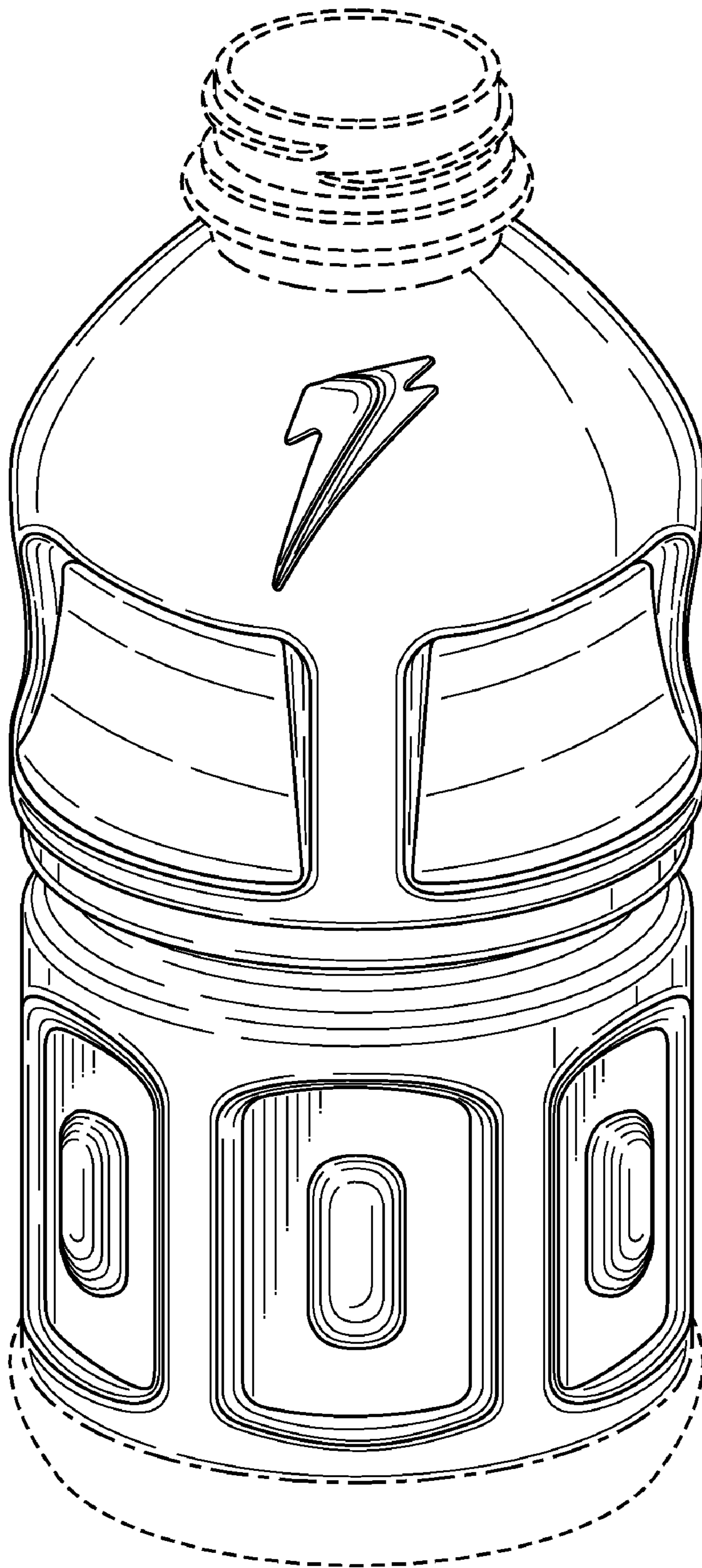

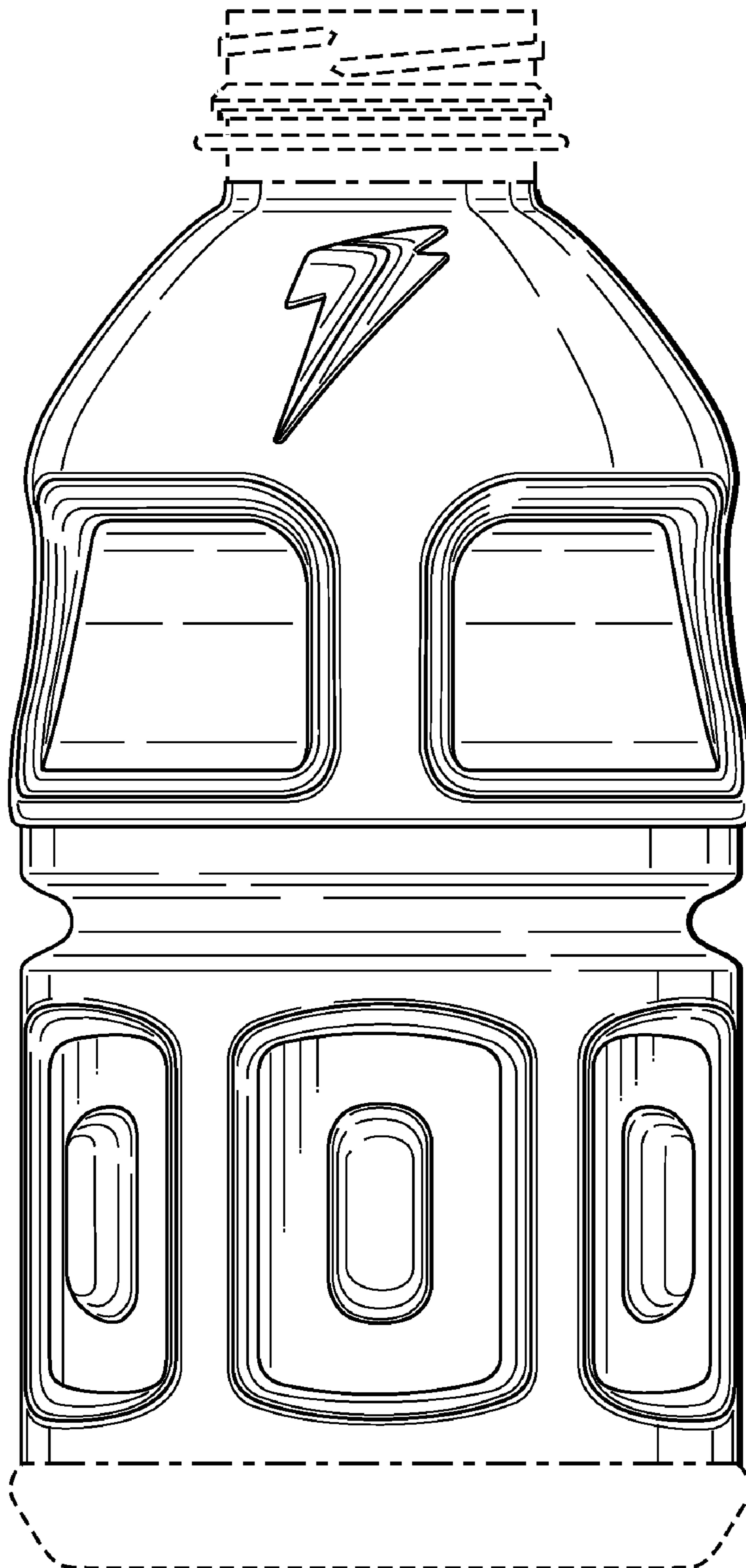

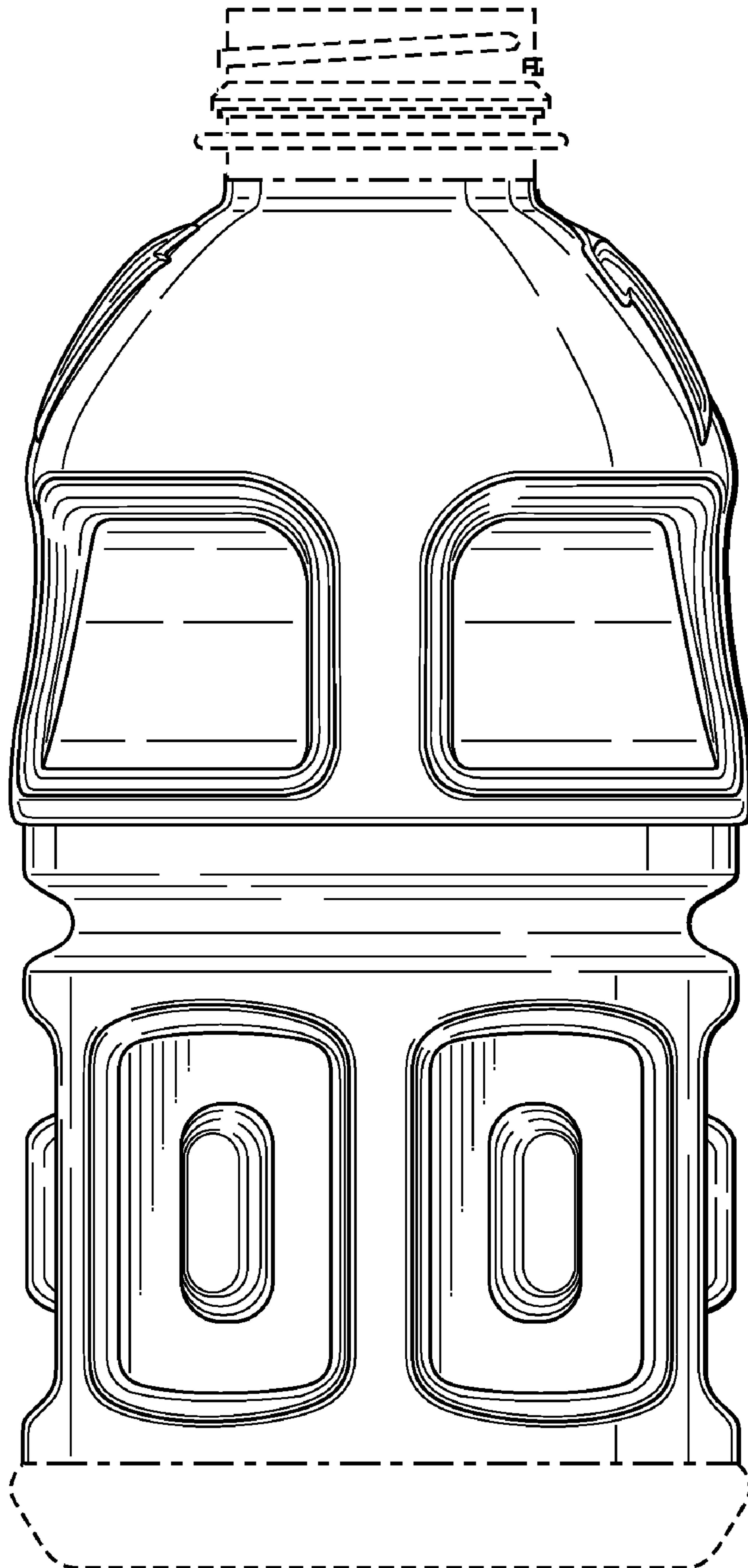

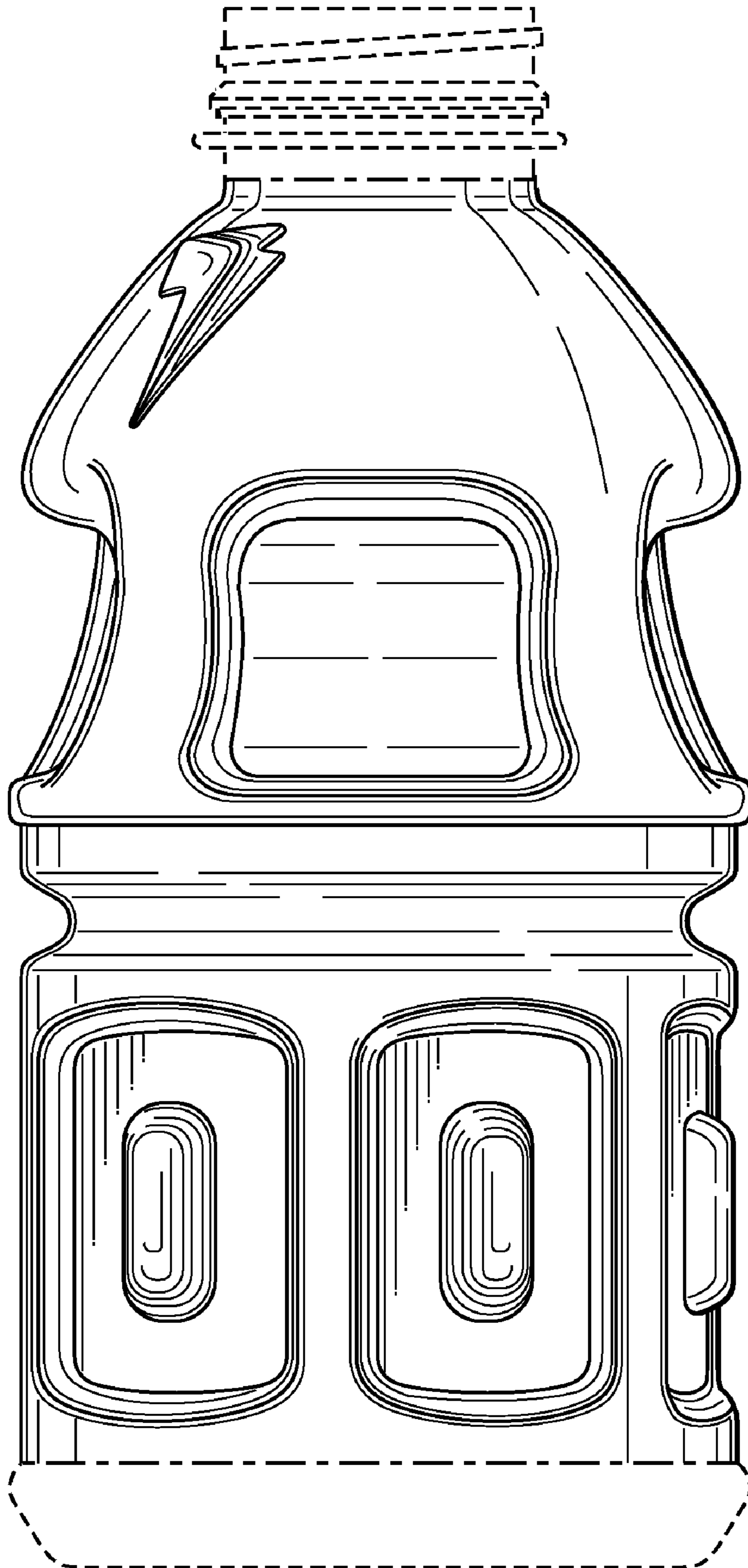

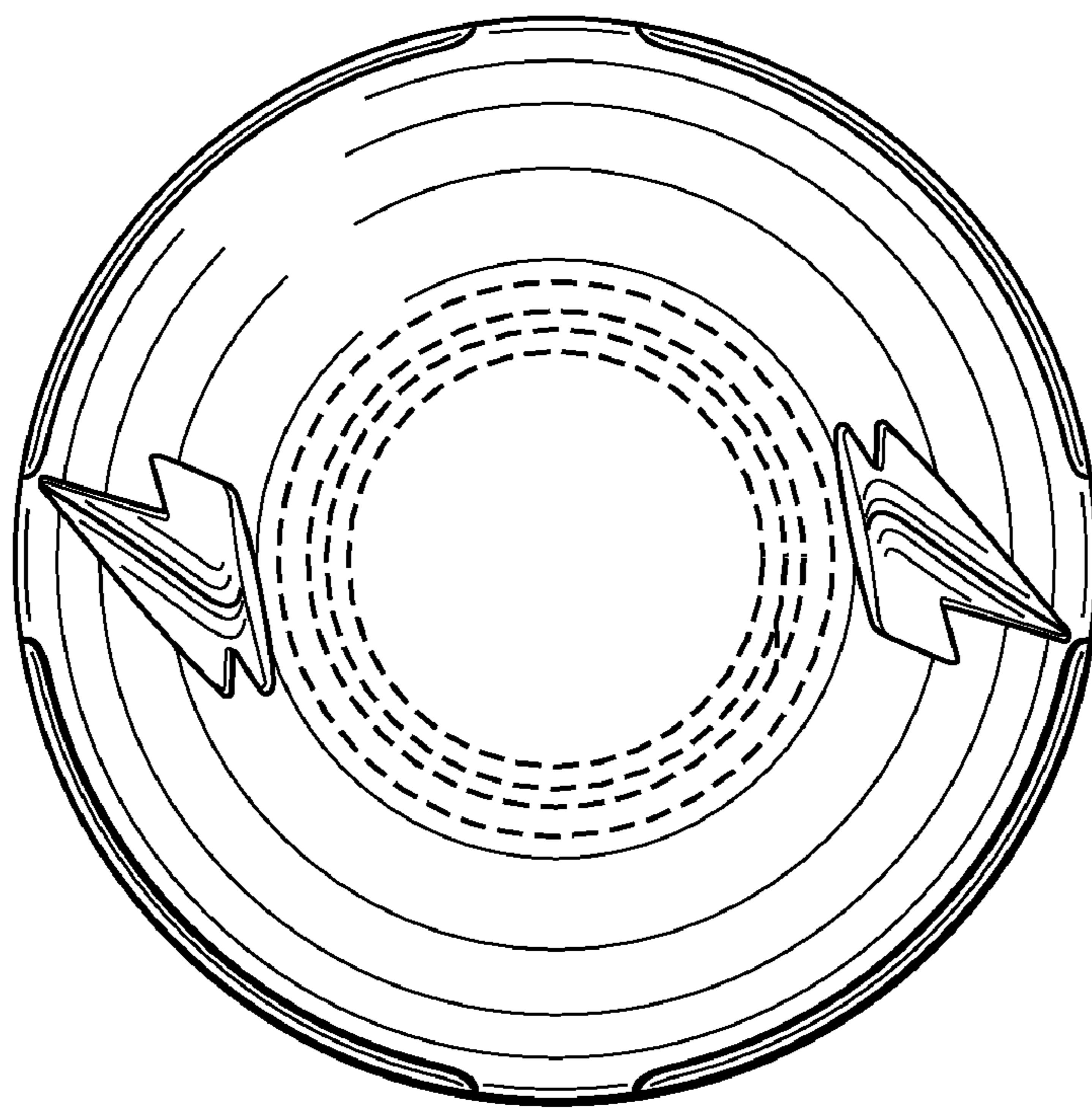

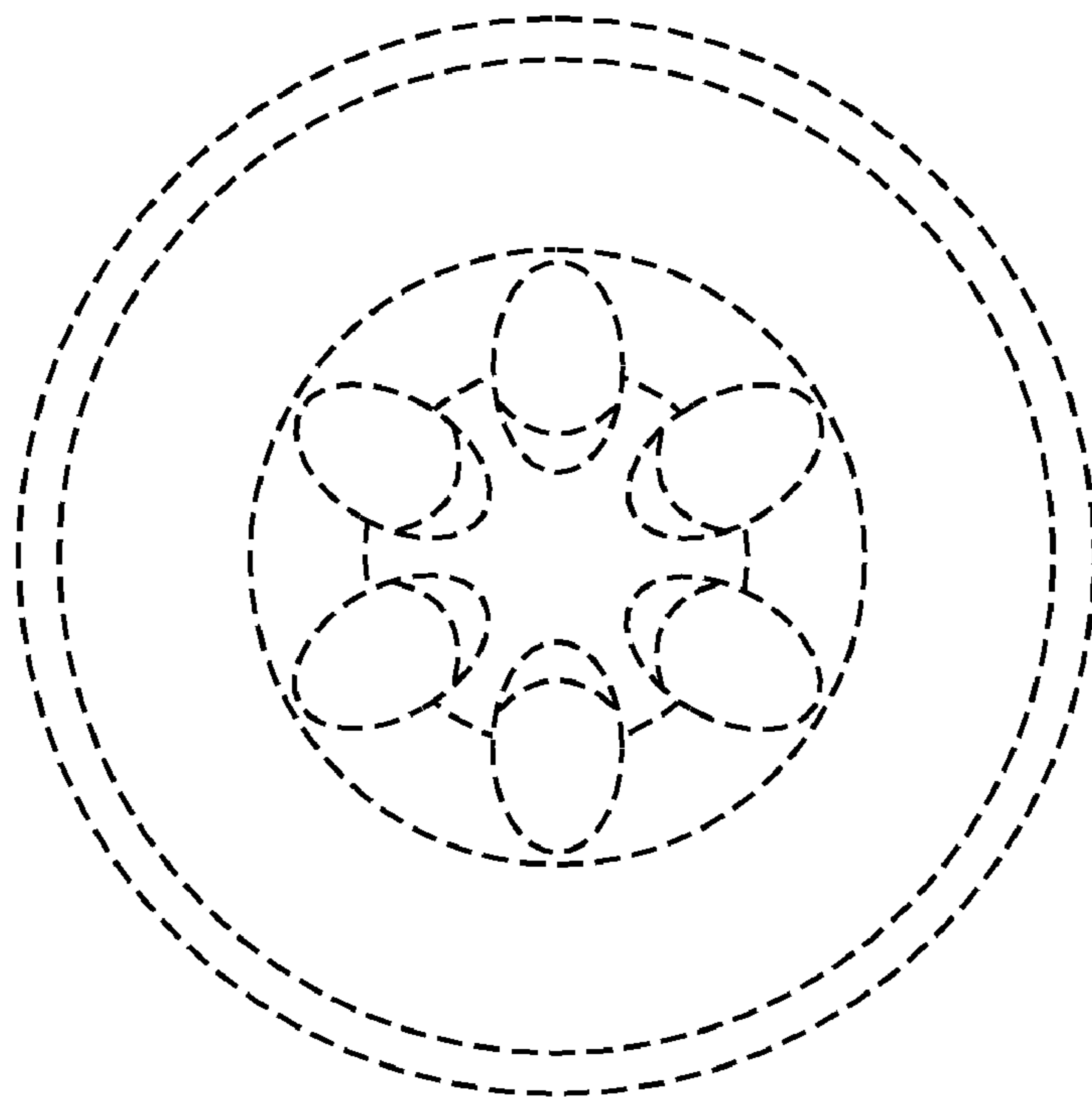

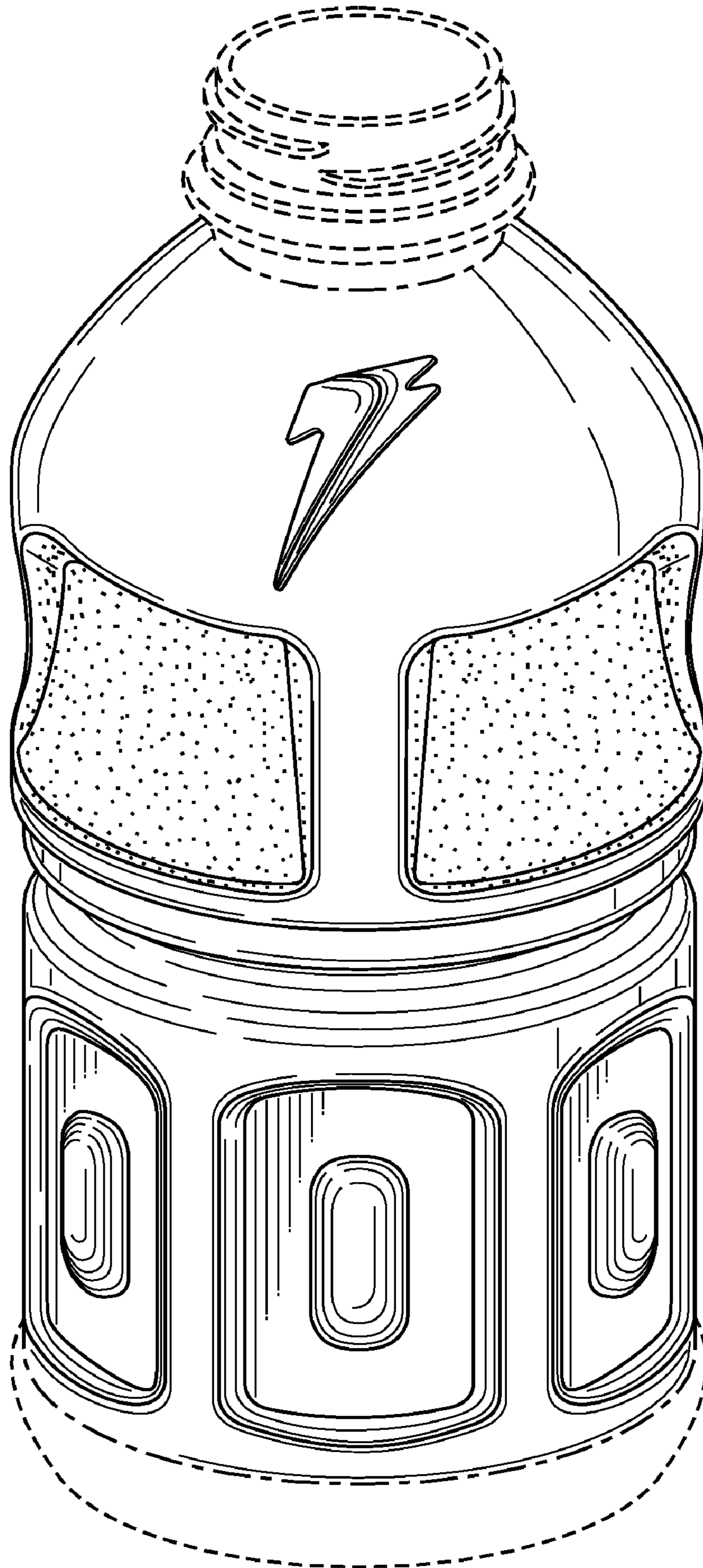

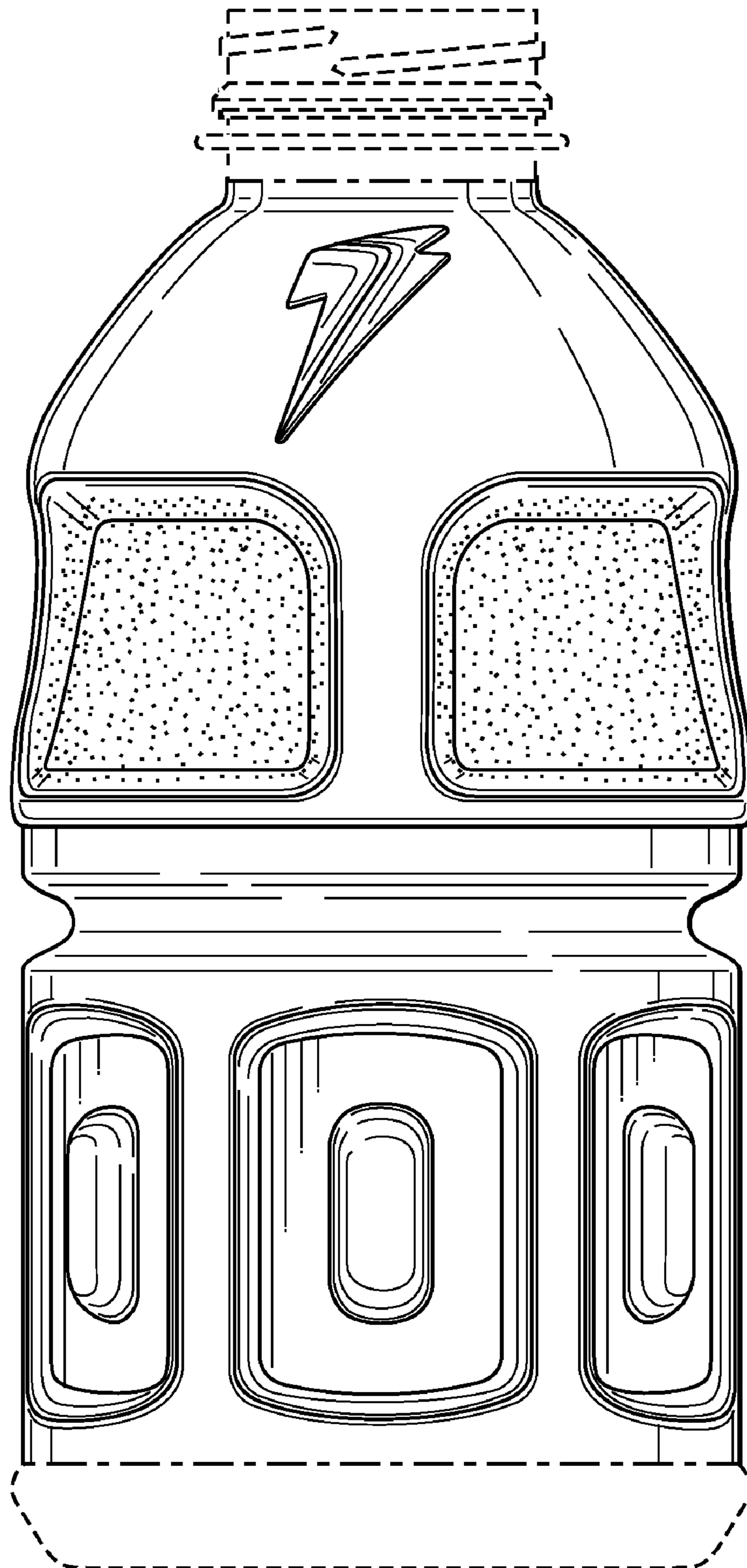

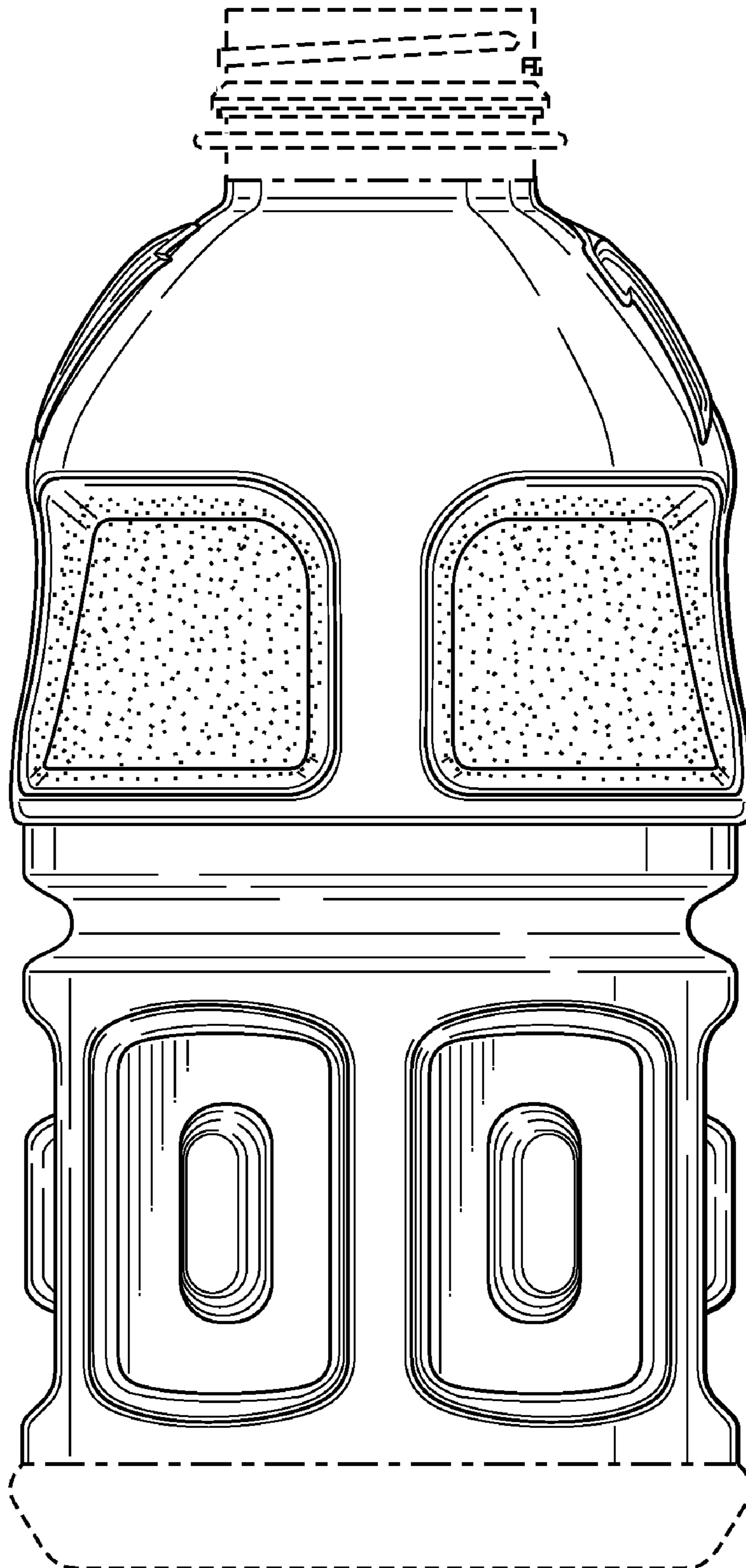

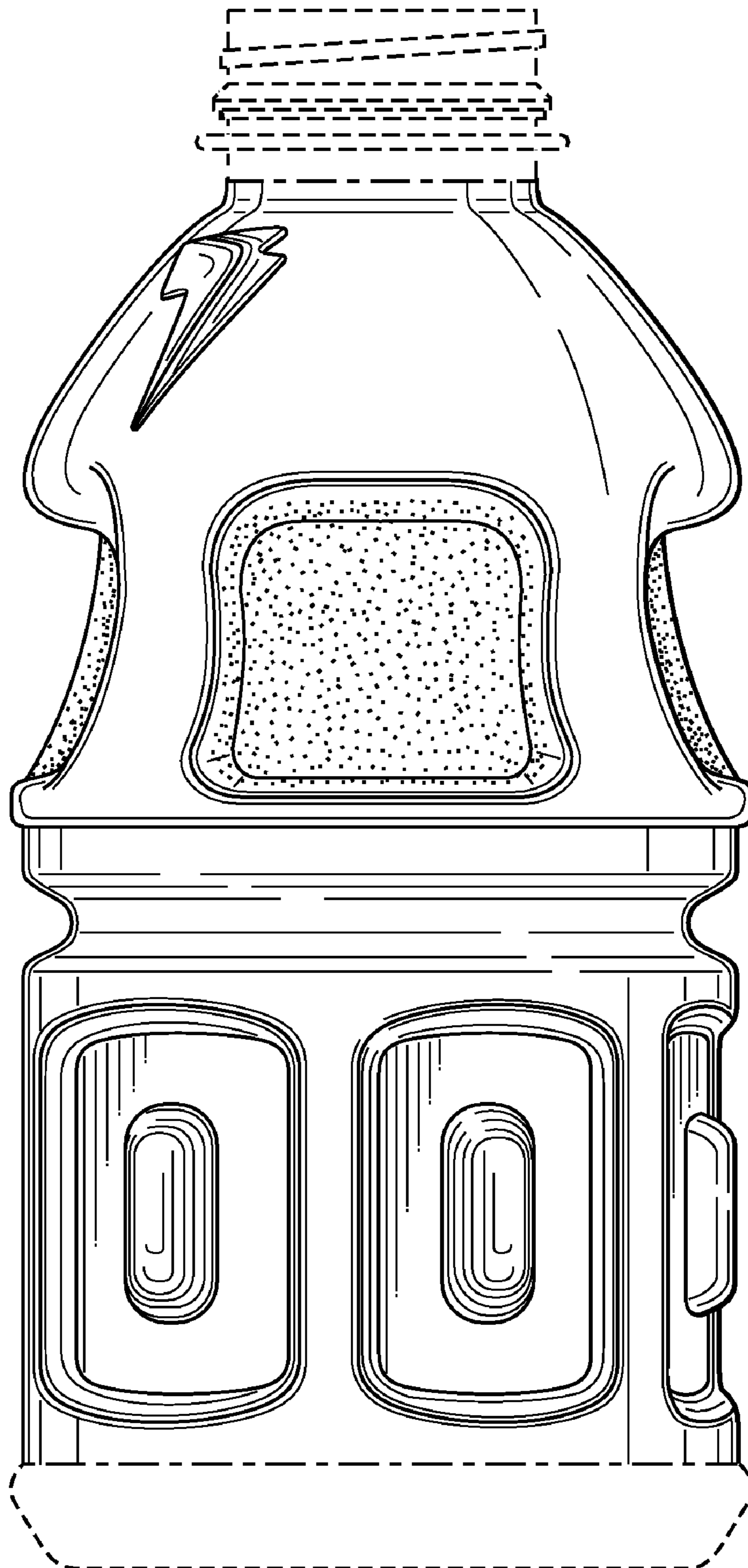

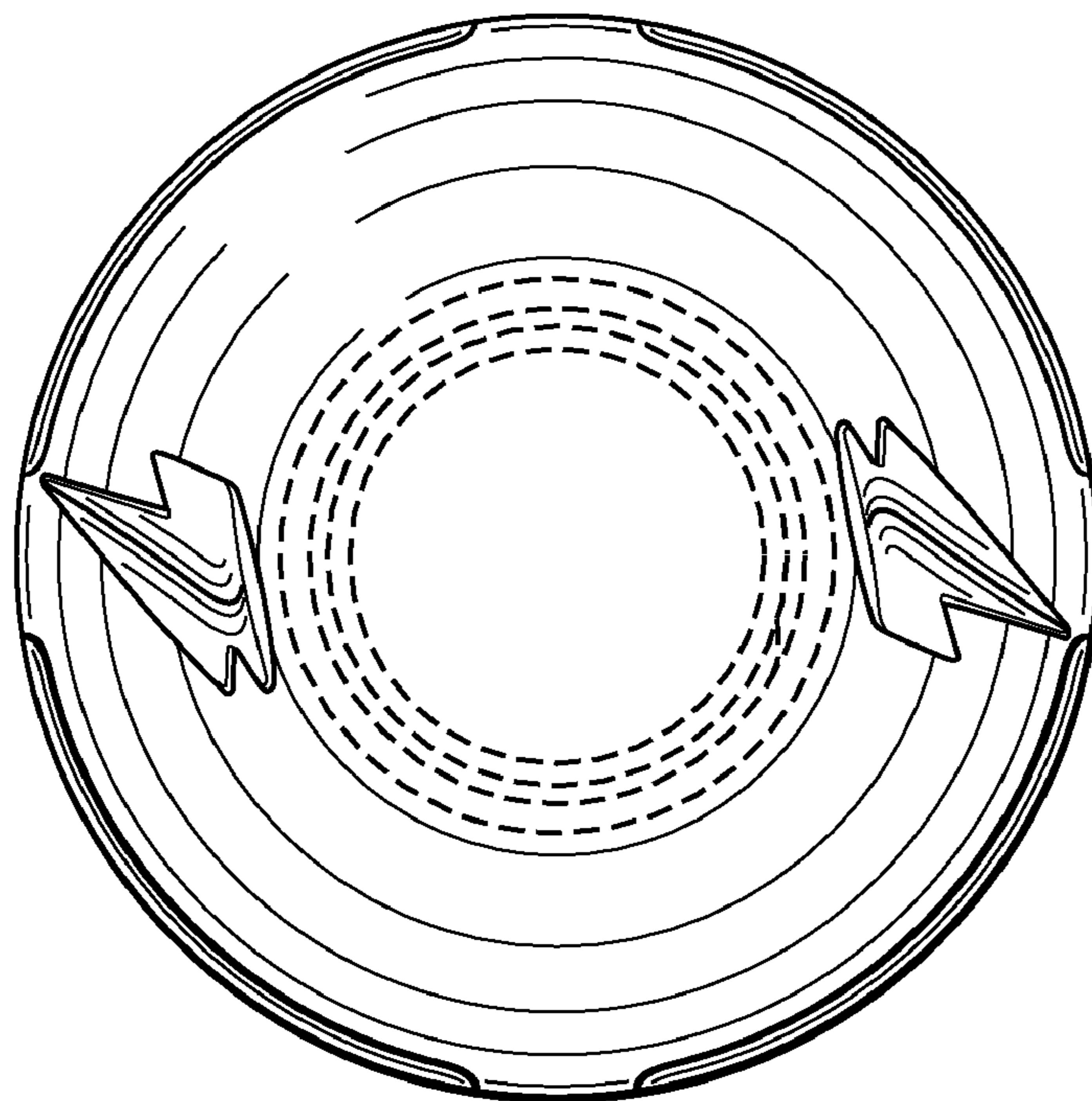
