FIG. 6 is a bottom perspective view thereof; and,

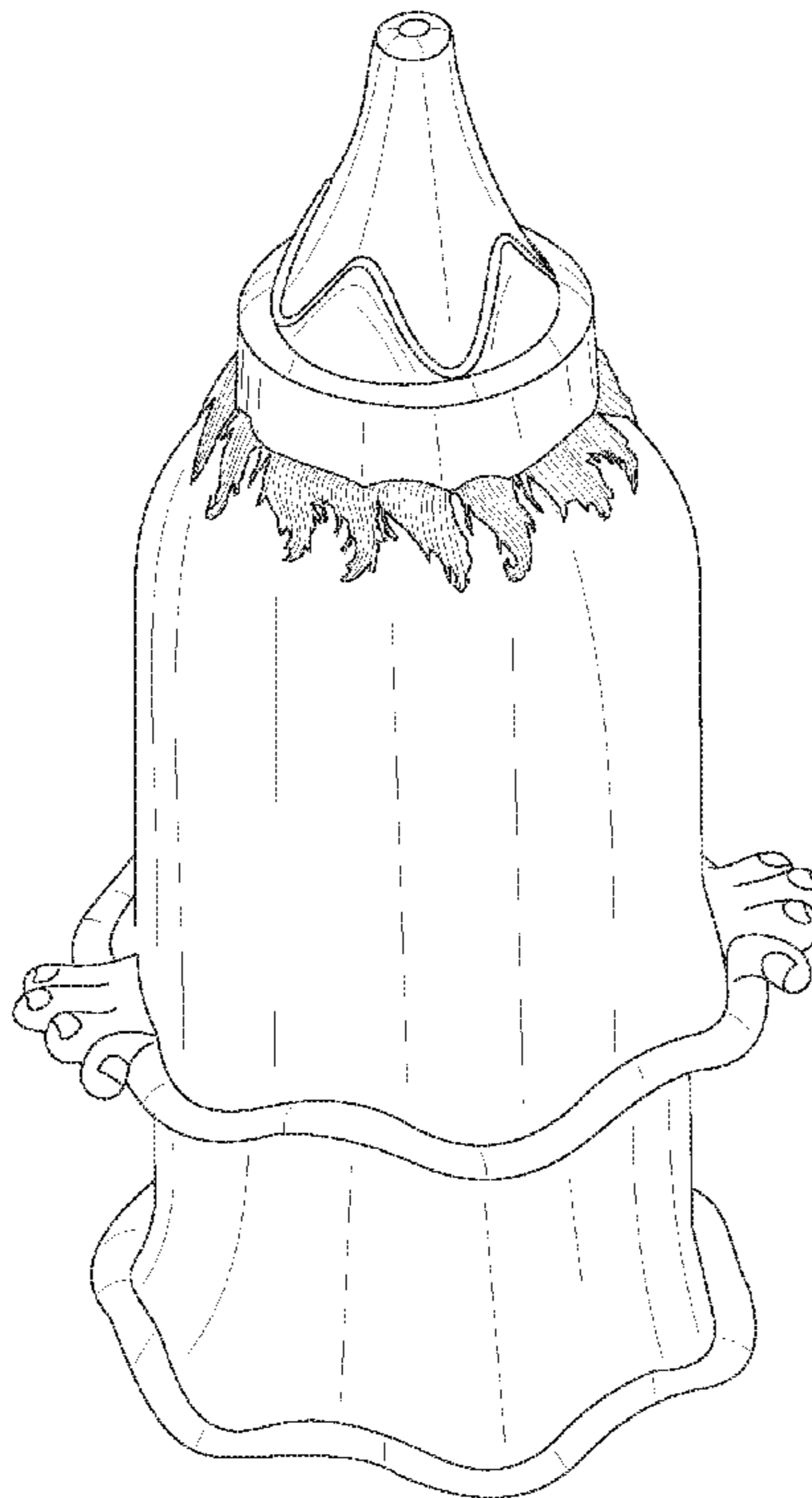
FIG. 7 is an exploded view thereof.

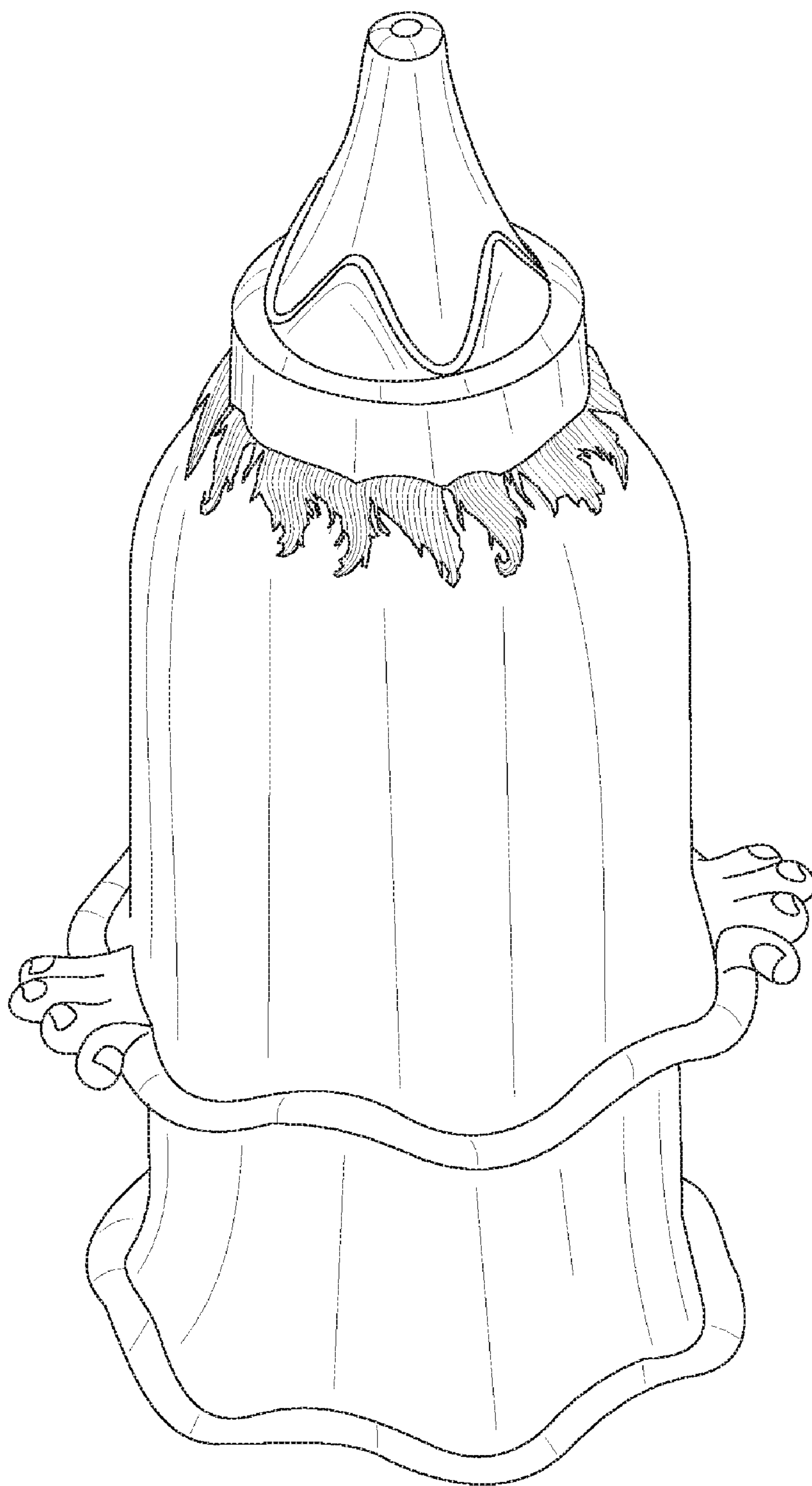

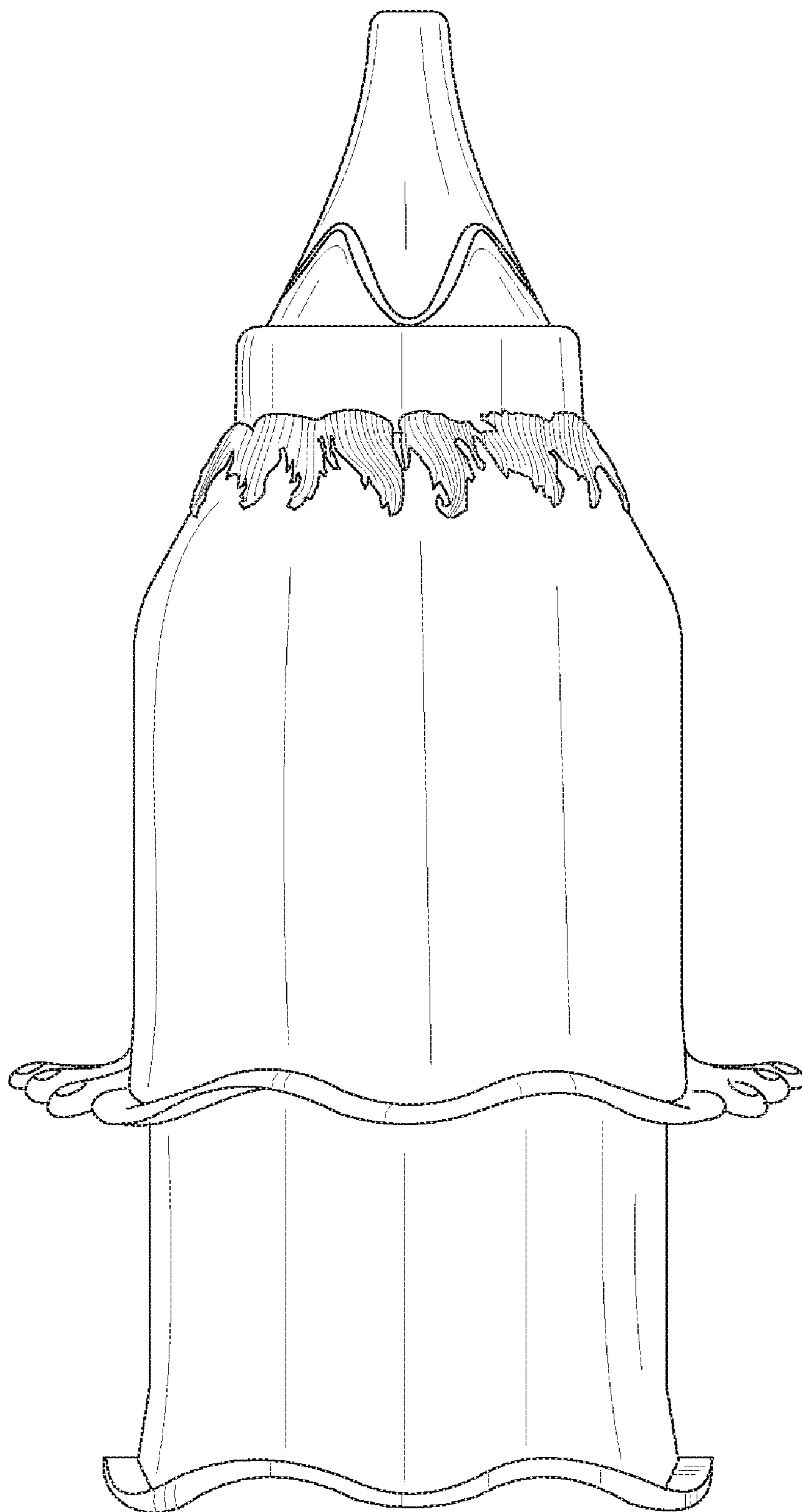

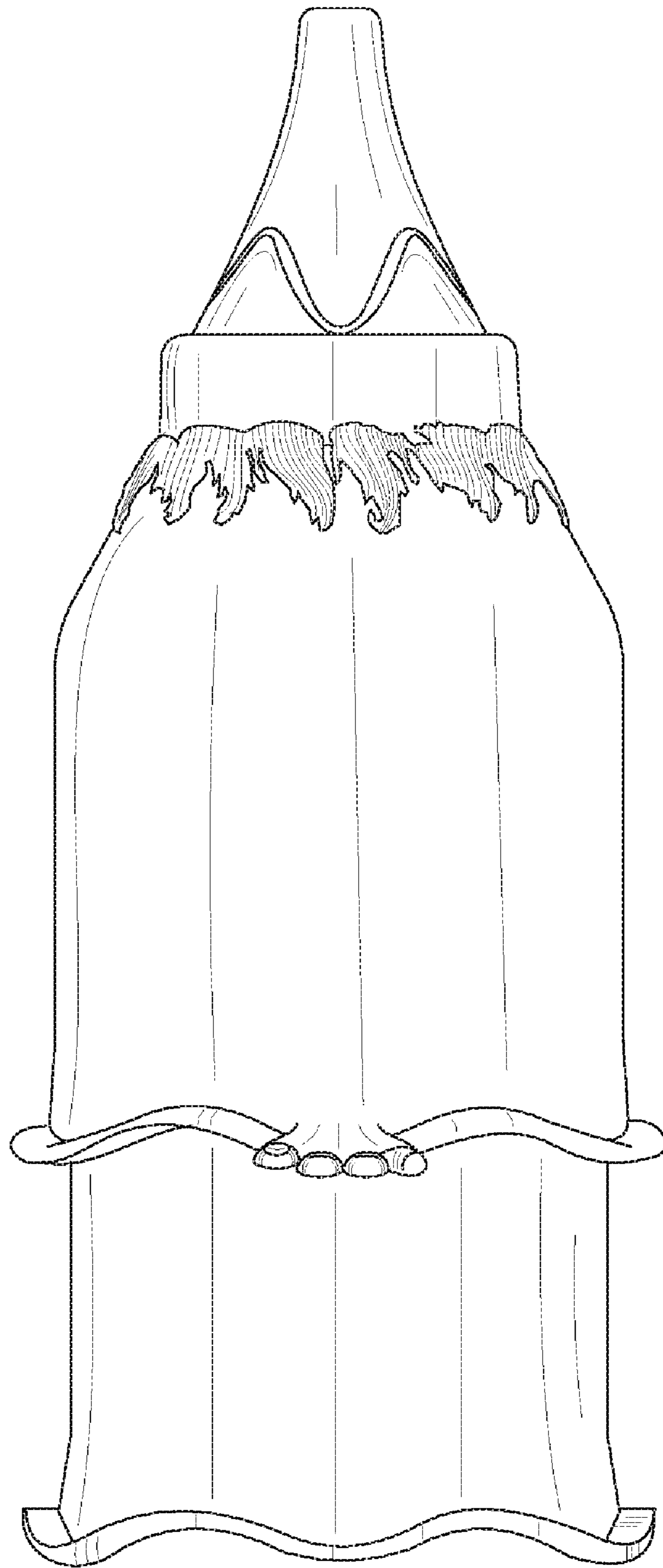

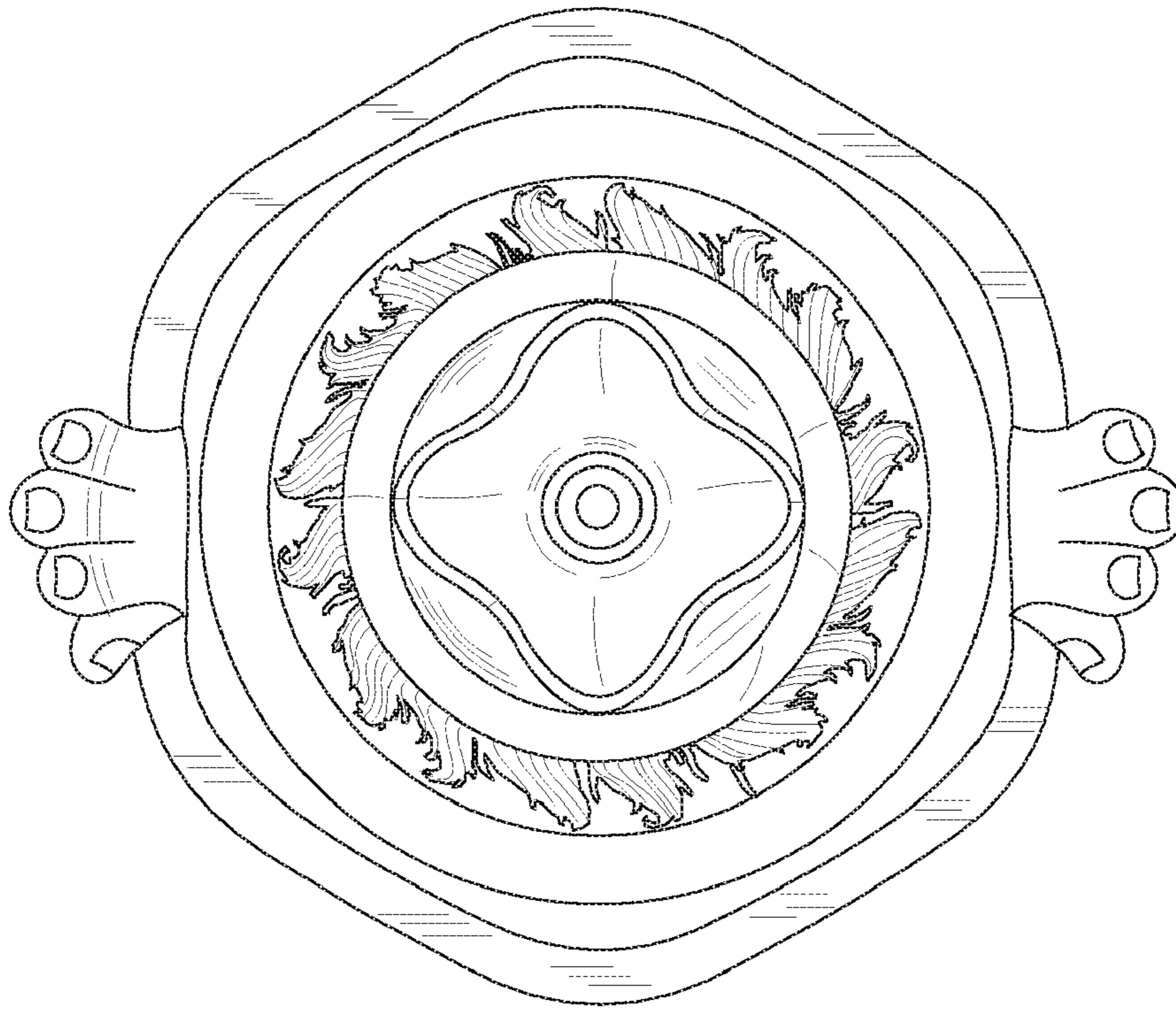

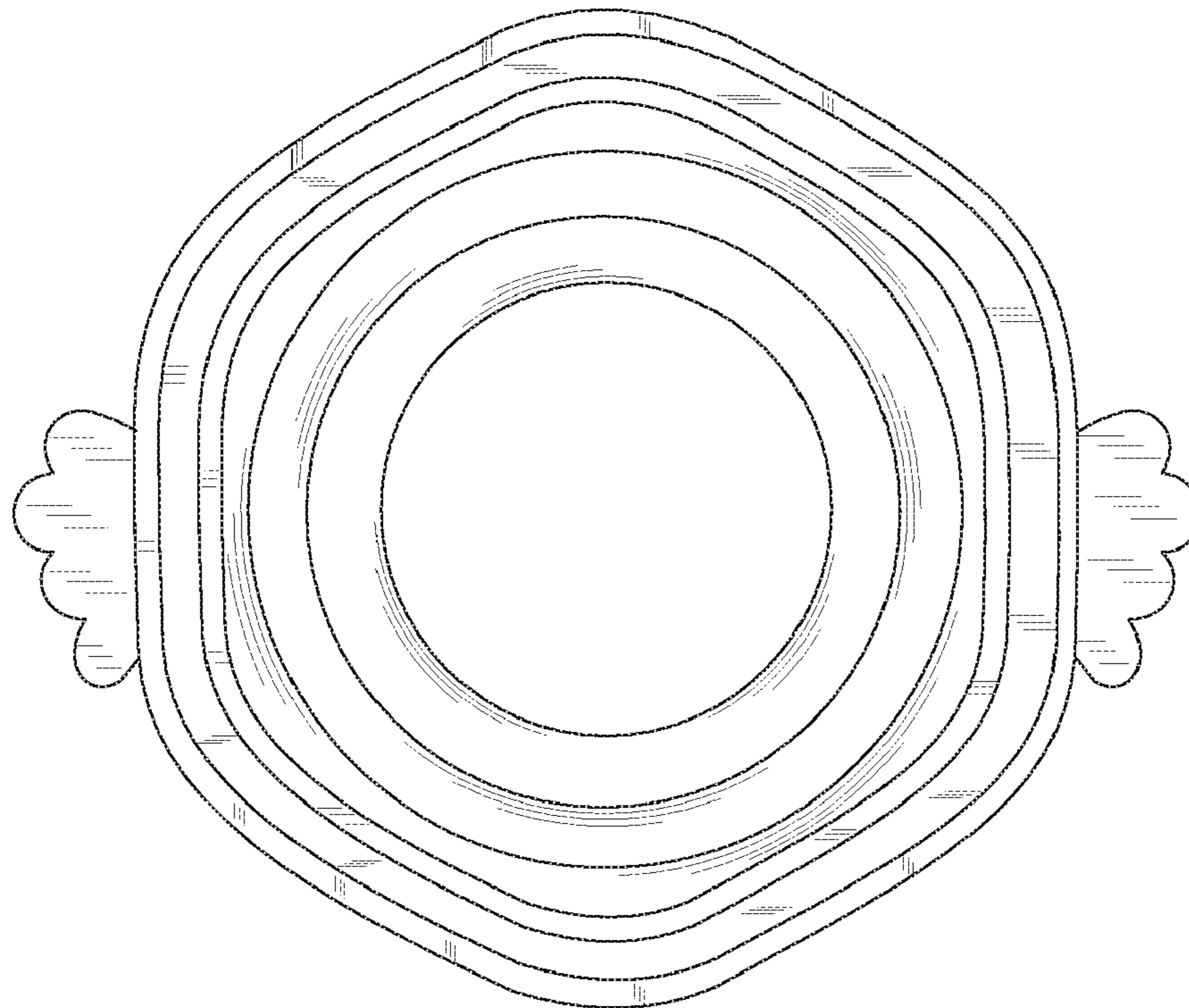

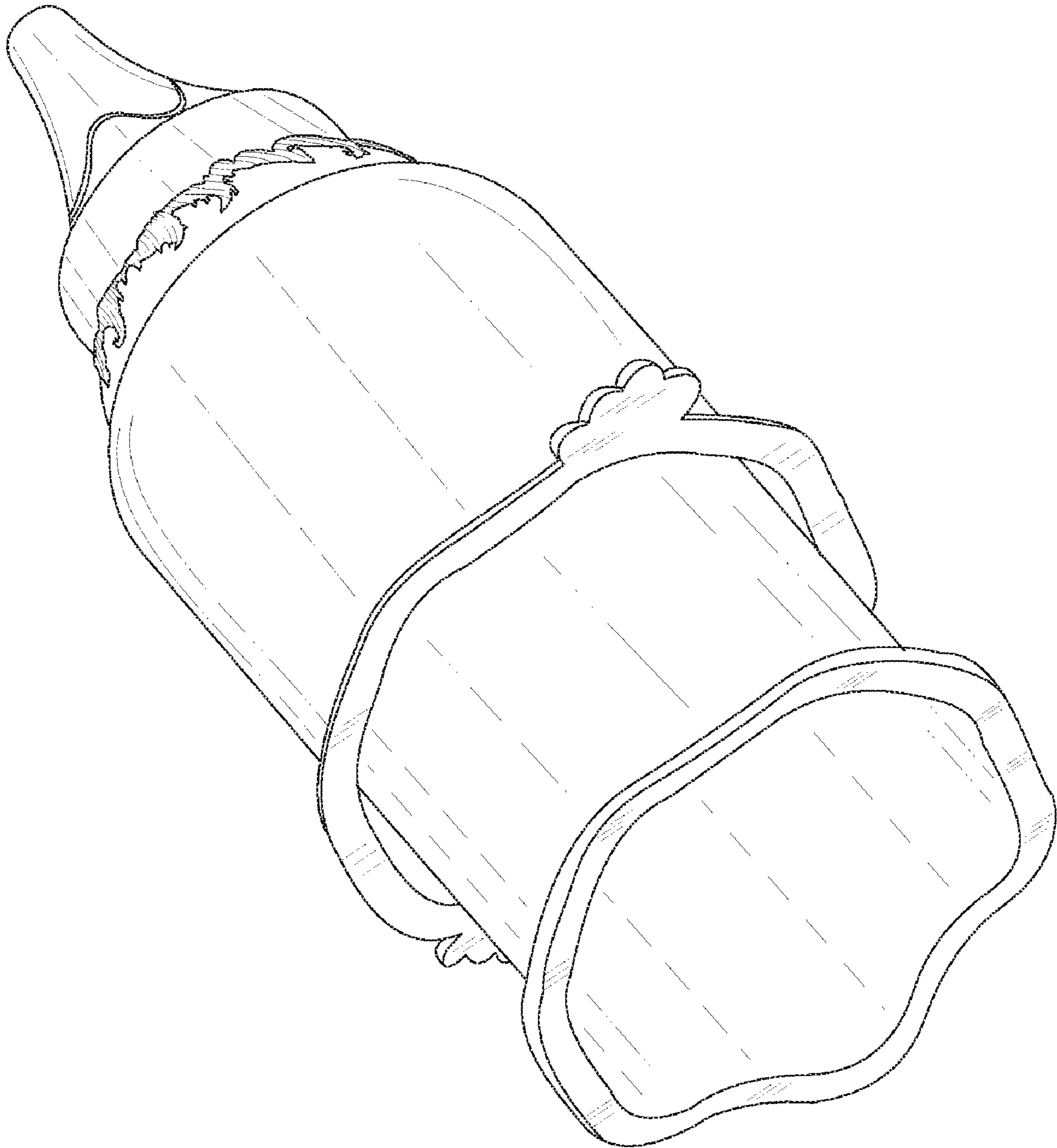

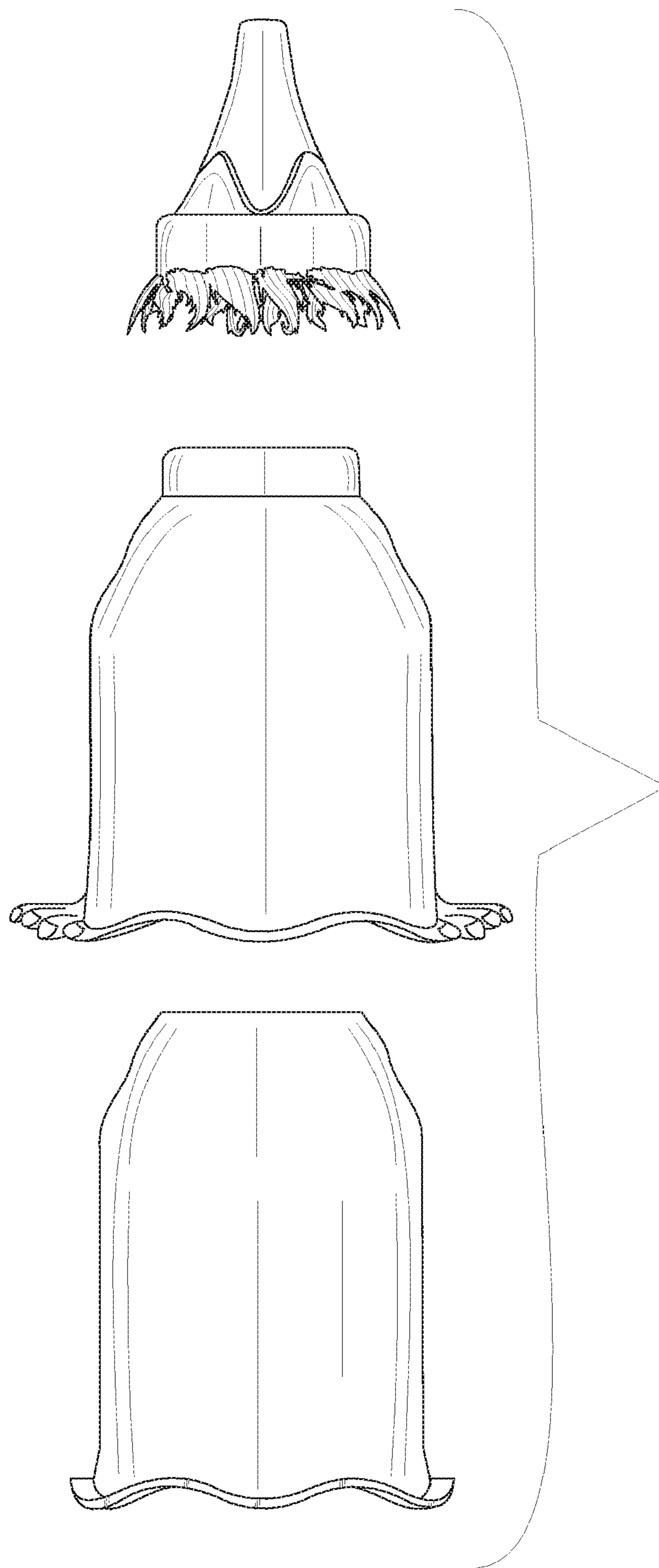
