FIG. 6 is a top view of the weighing apparatus of FIG. 1;

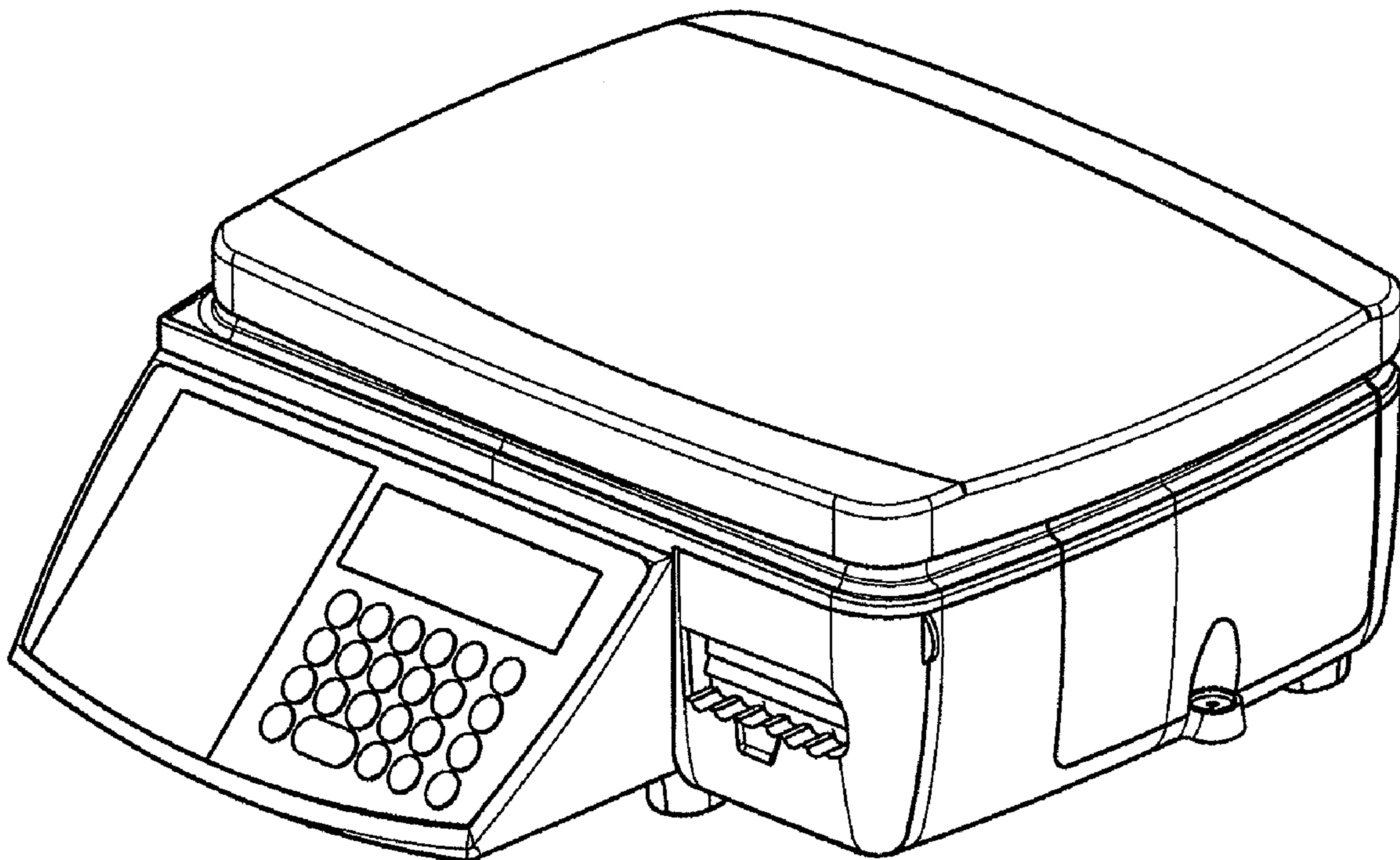
FIG. 7 is a bottom view of the weighing apparatus of FIG. 1;

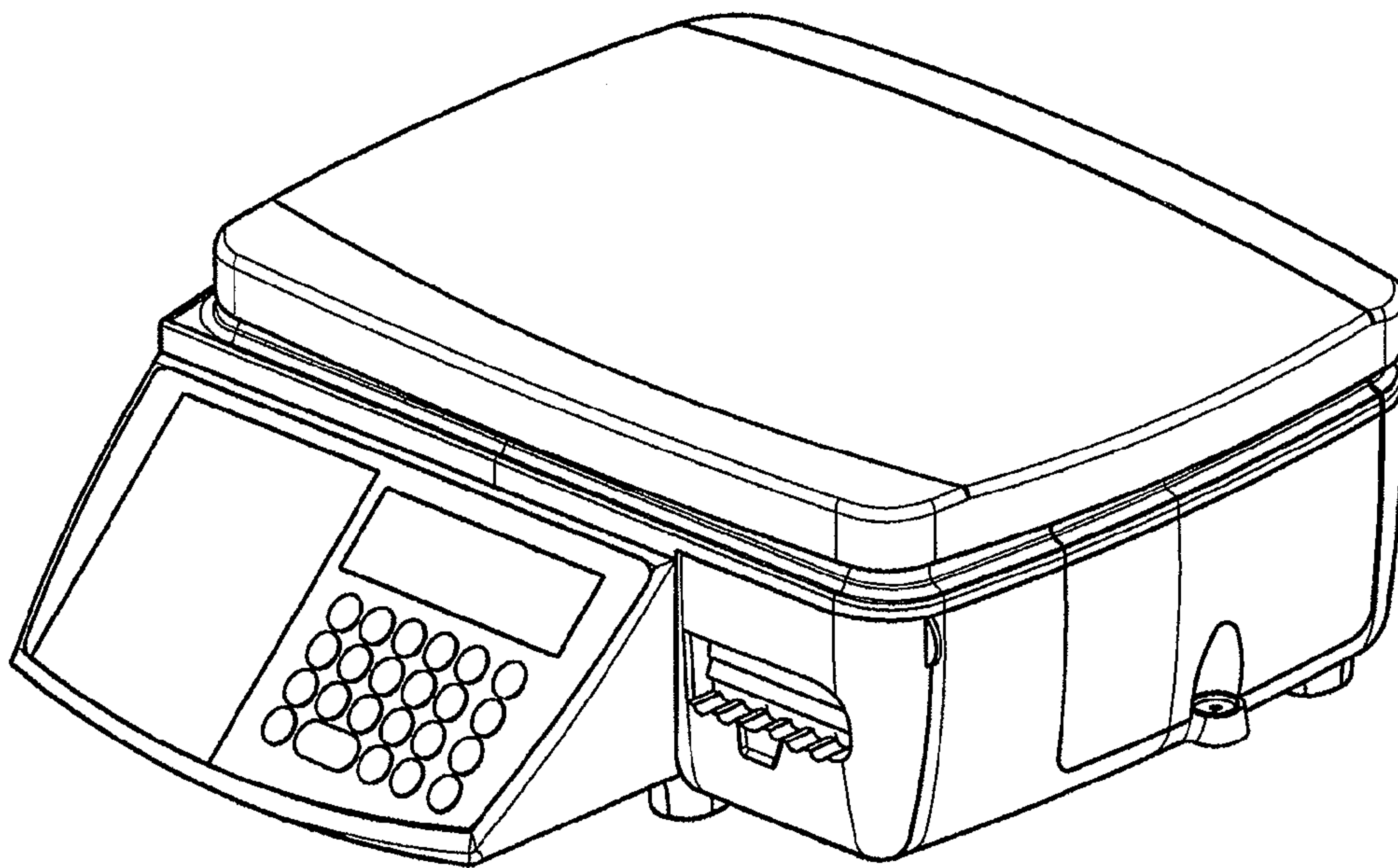

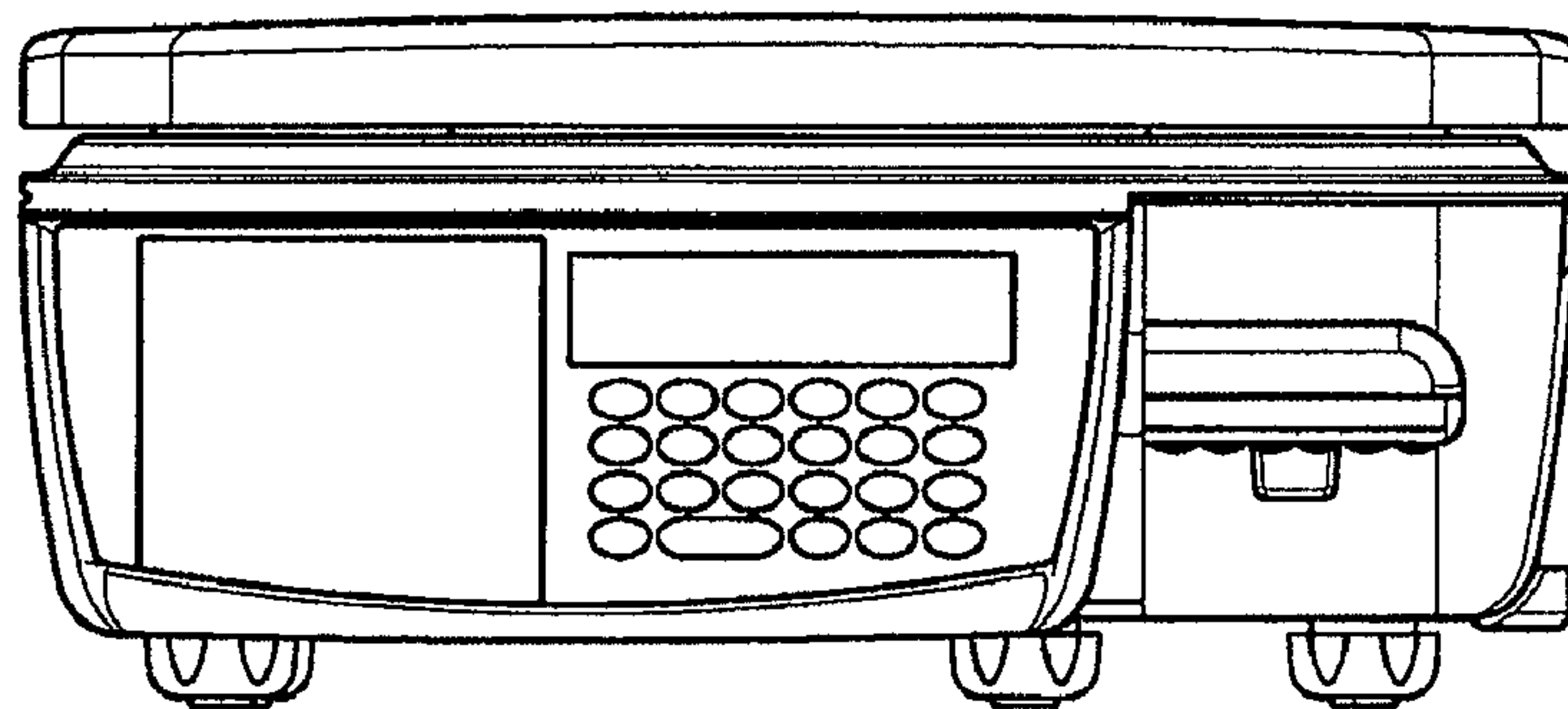

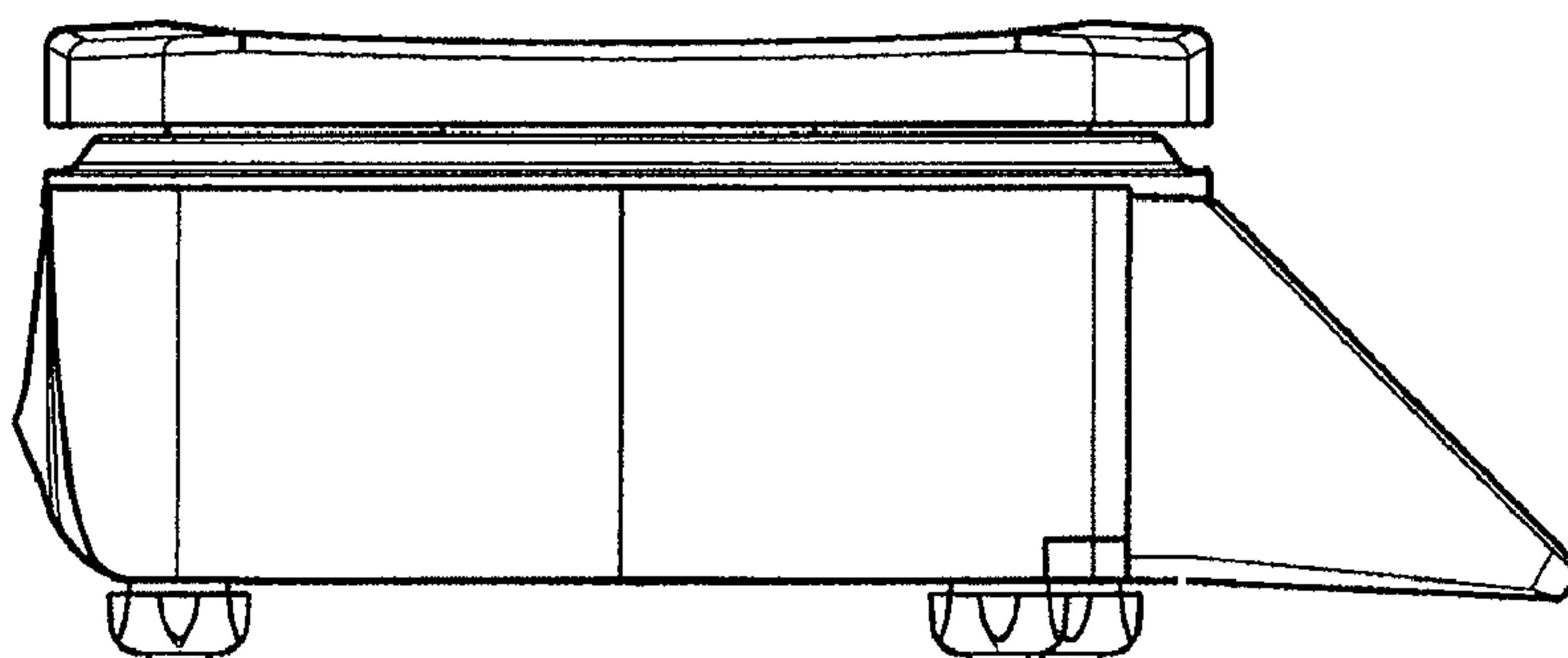

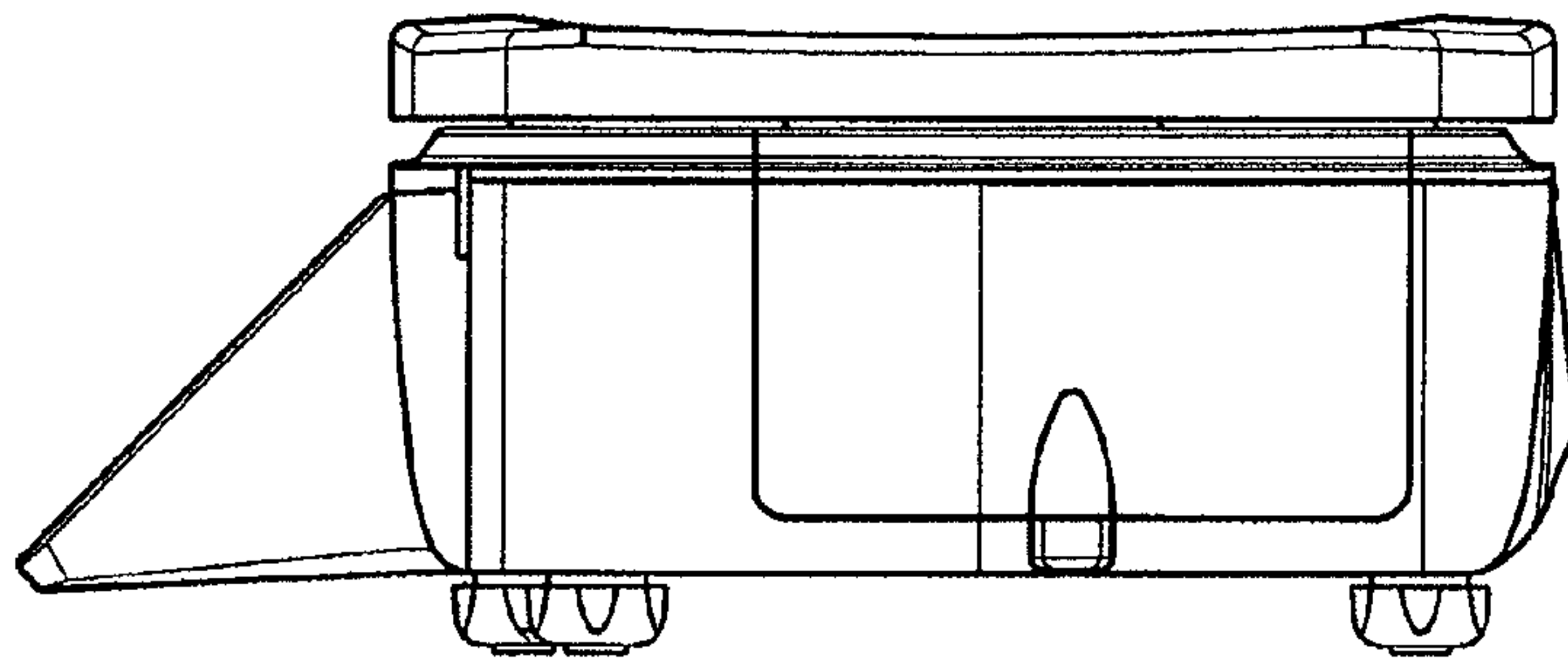

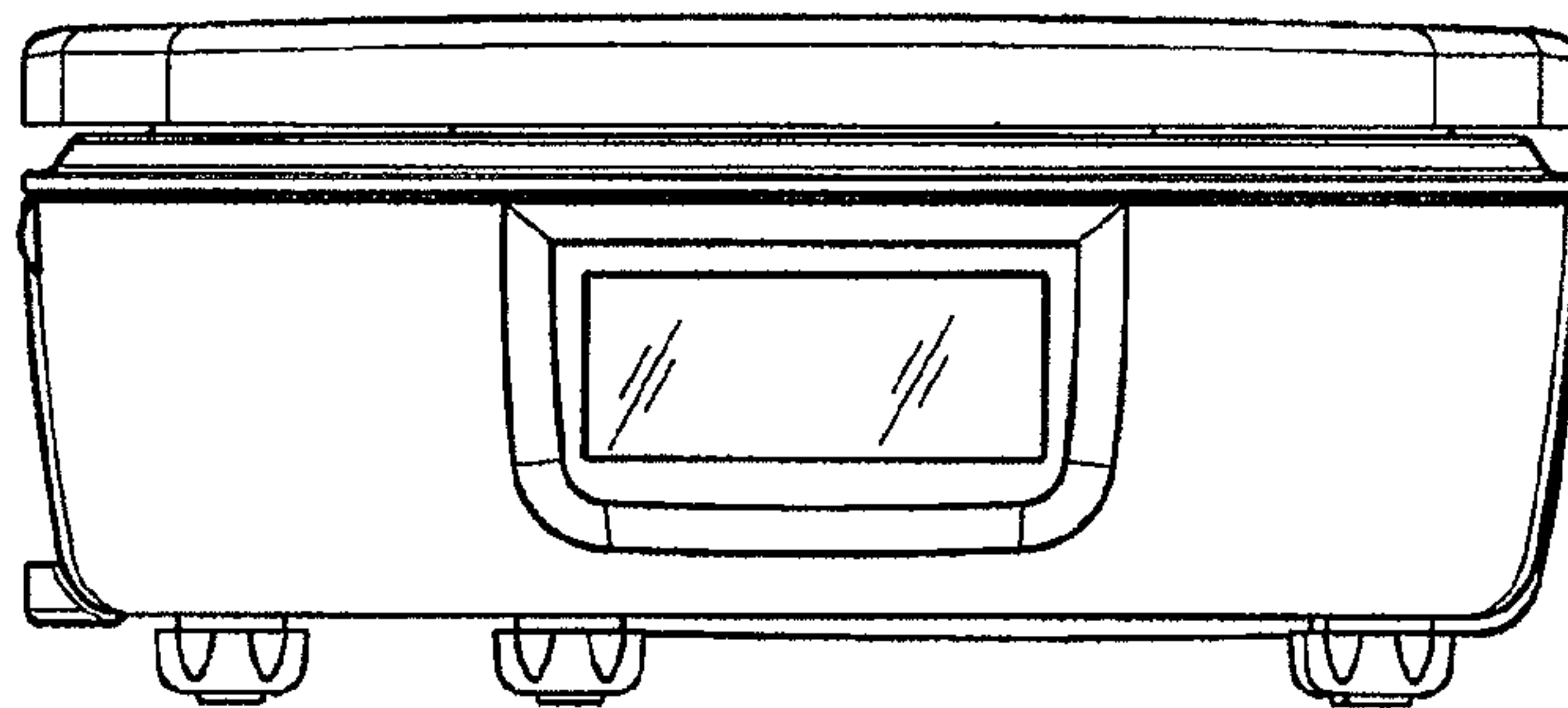

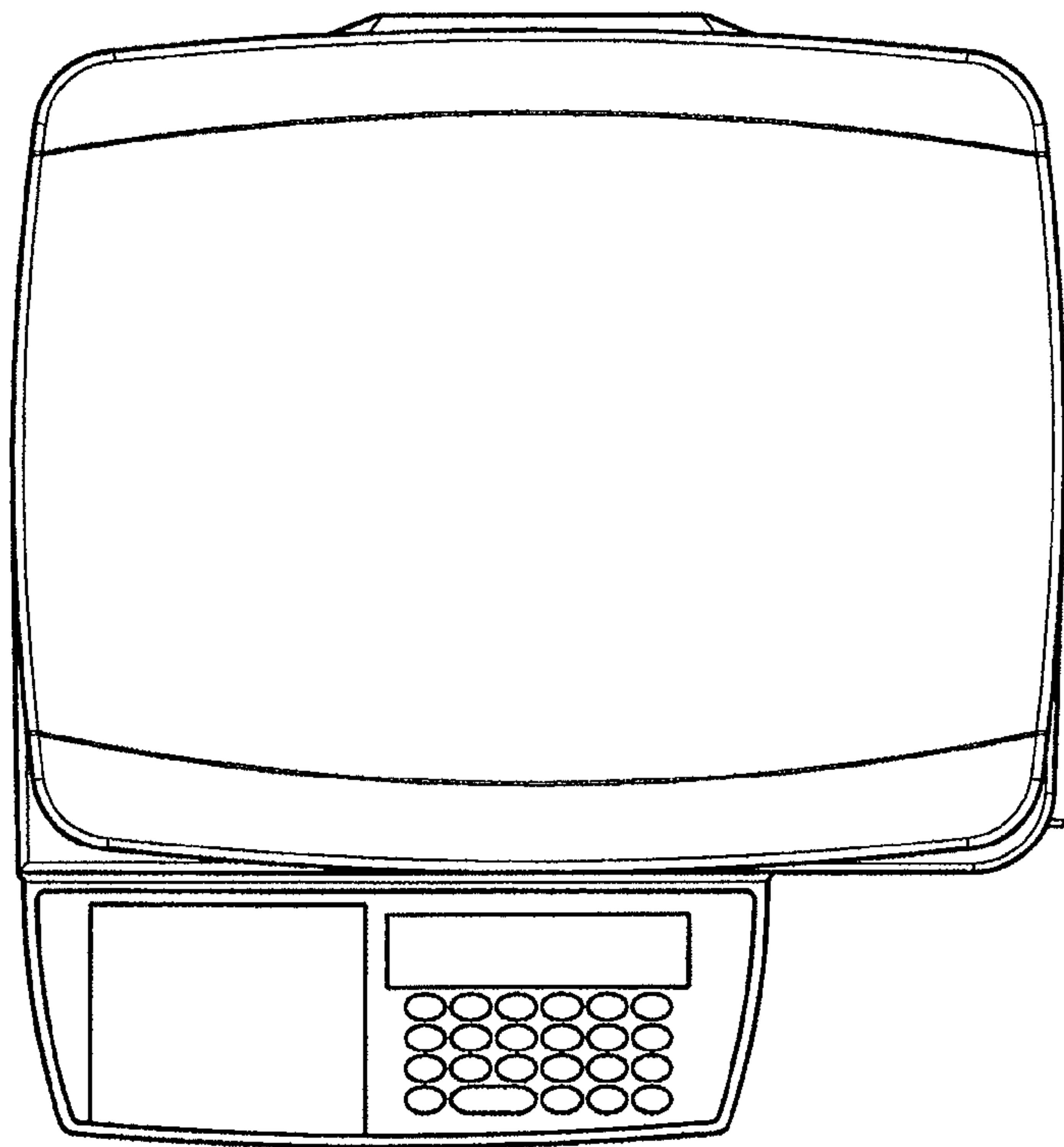

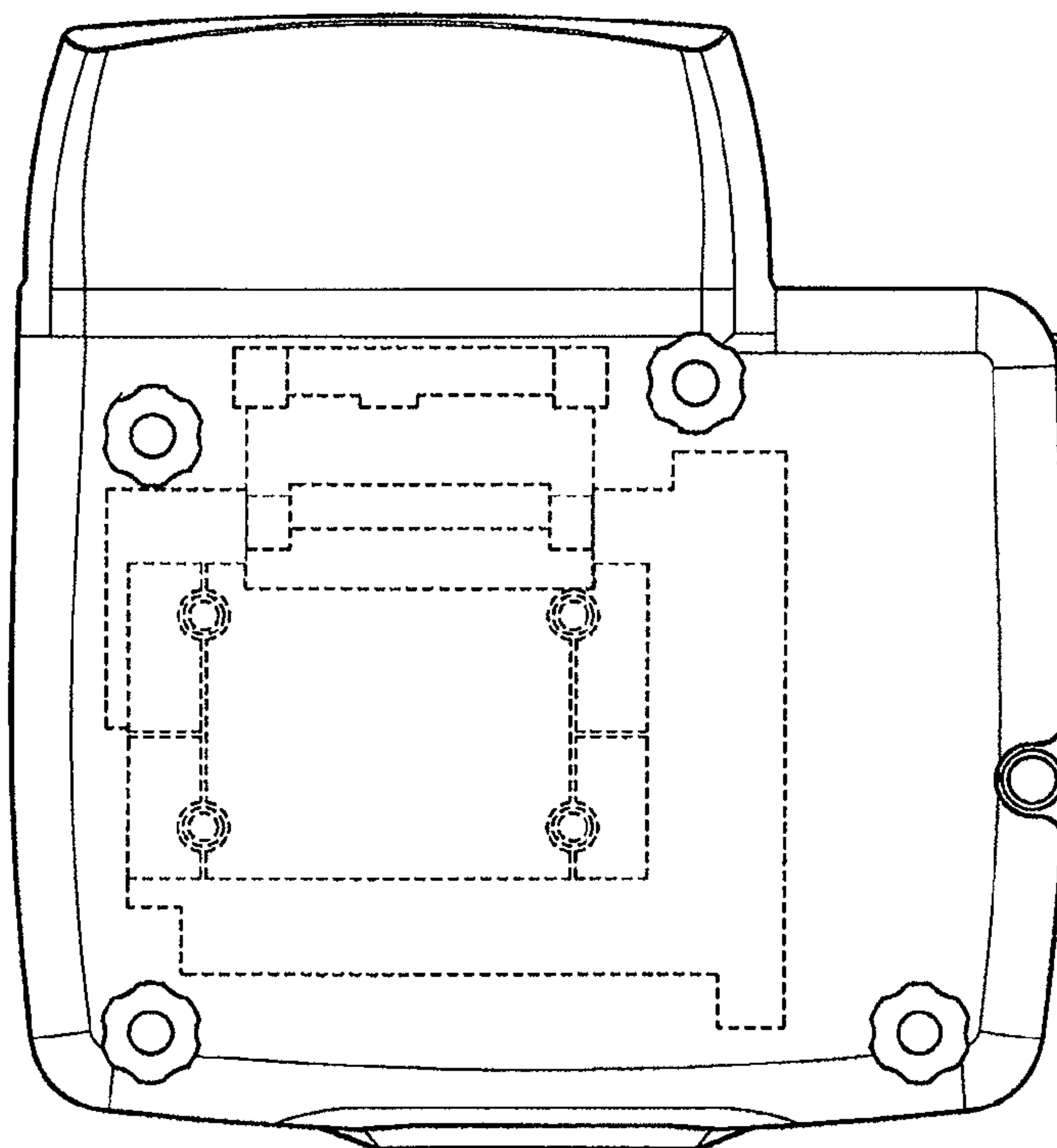

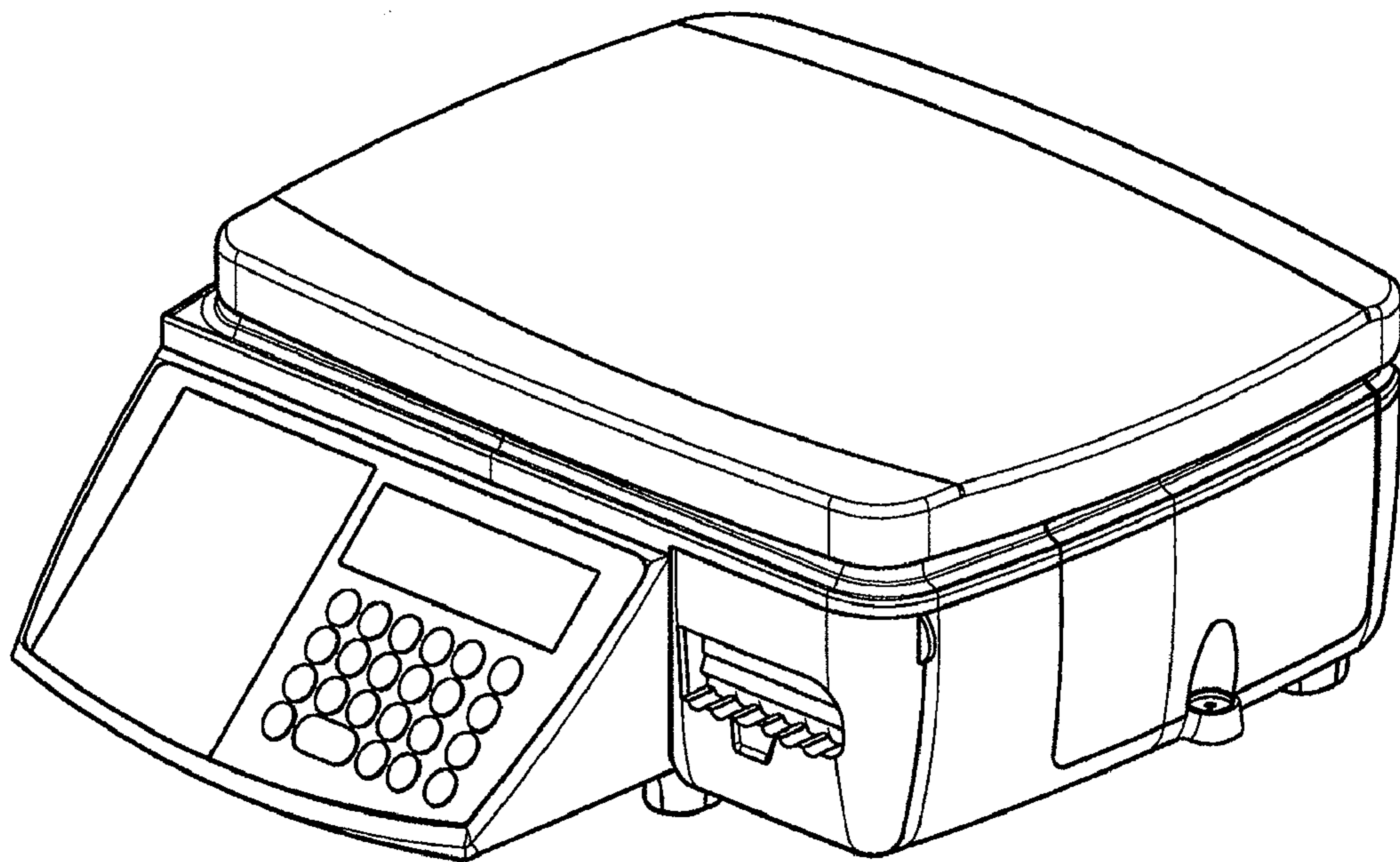

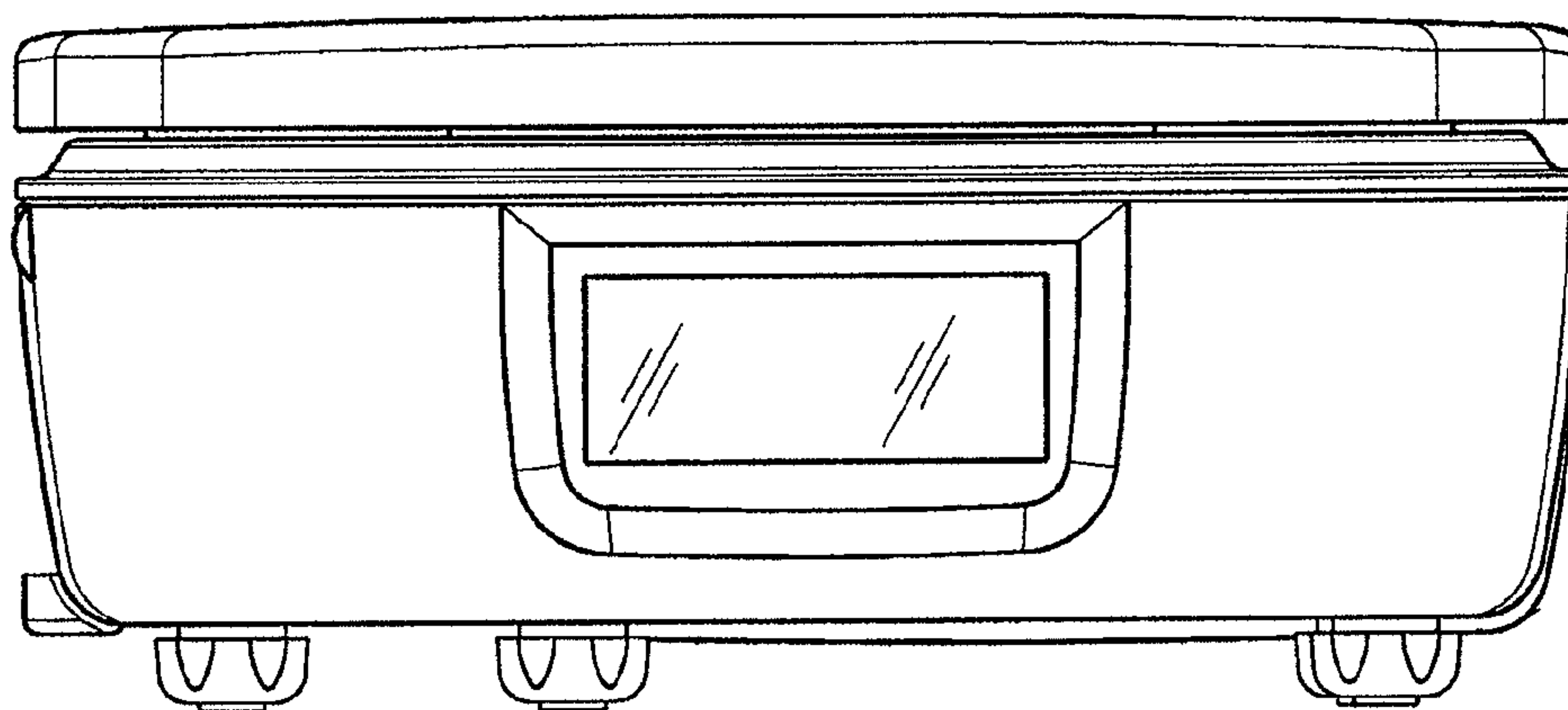
