The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a mobile phone that has the design.

FIG. 2 is top plan view of the mobile phone.

FIG. 3 is rear view of the mobile phone.

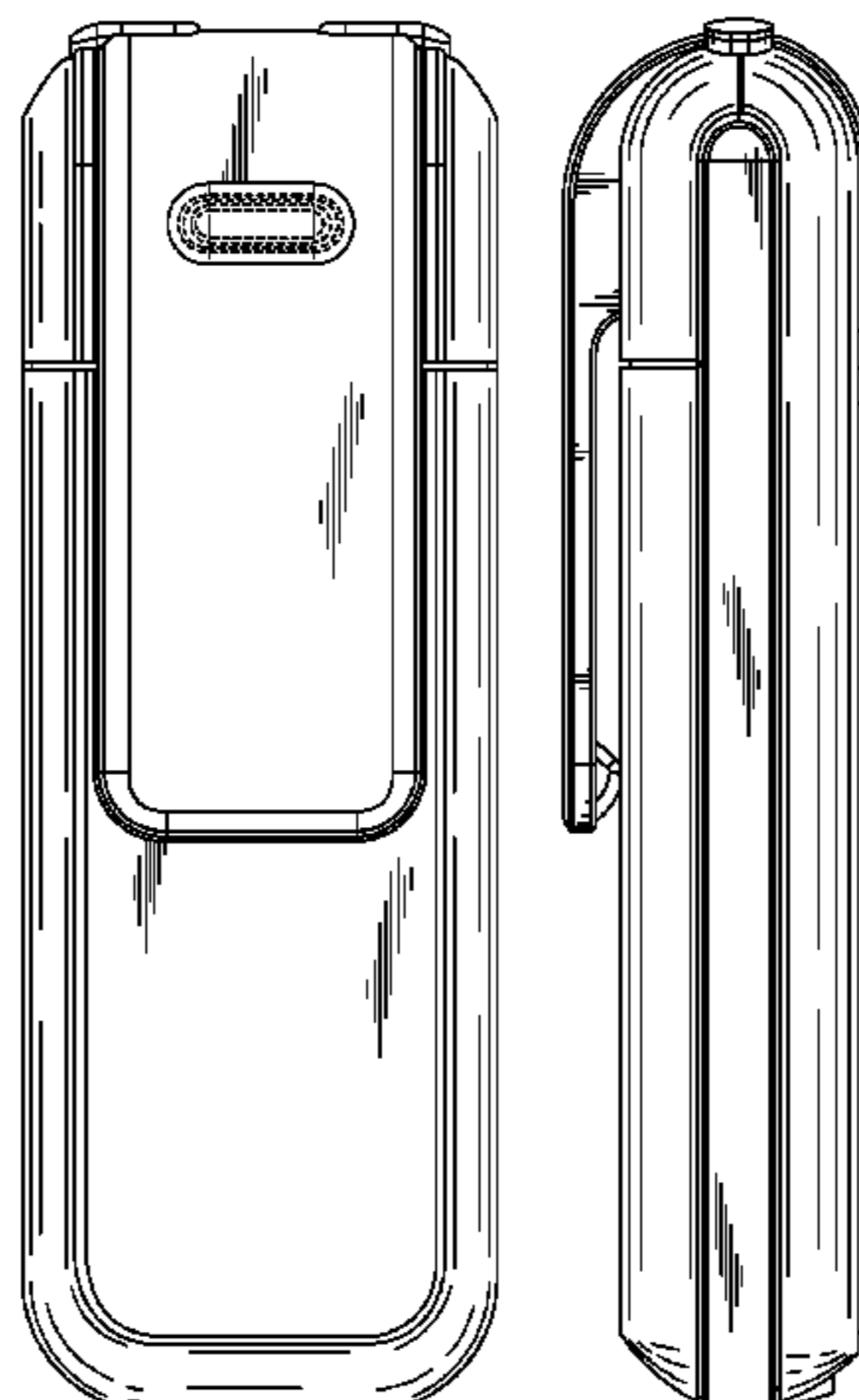
FIG. 4 is left side view of the mobile phone.

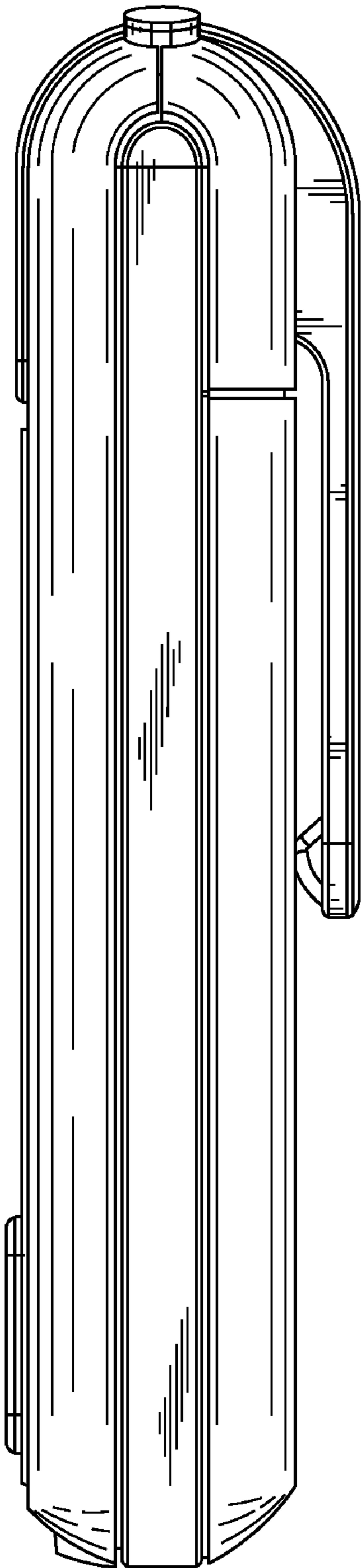

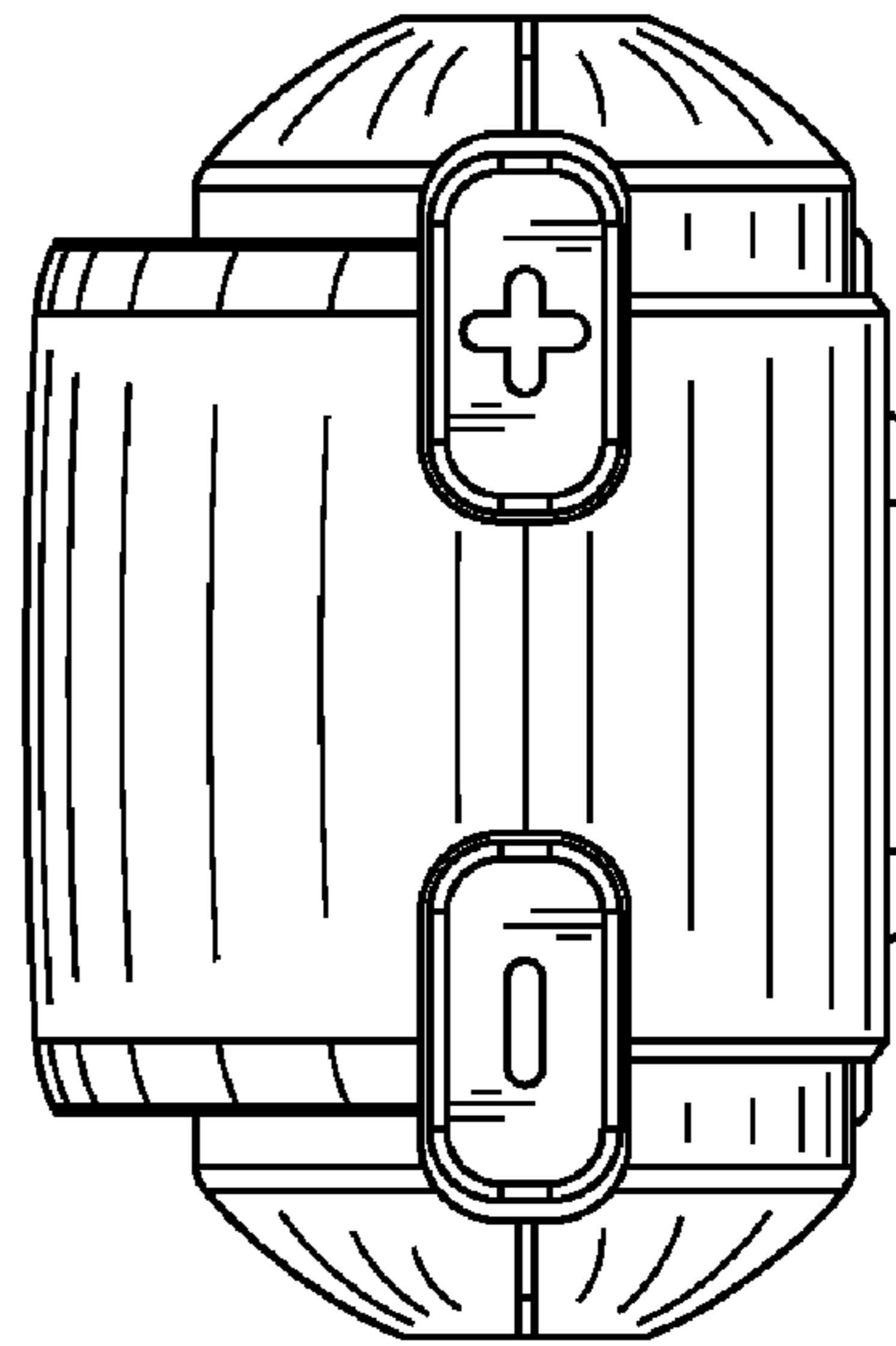

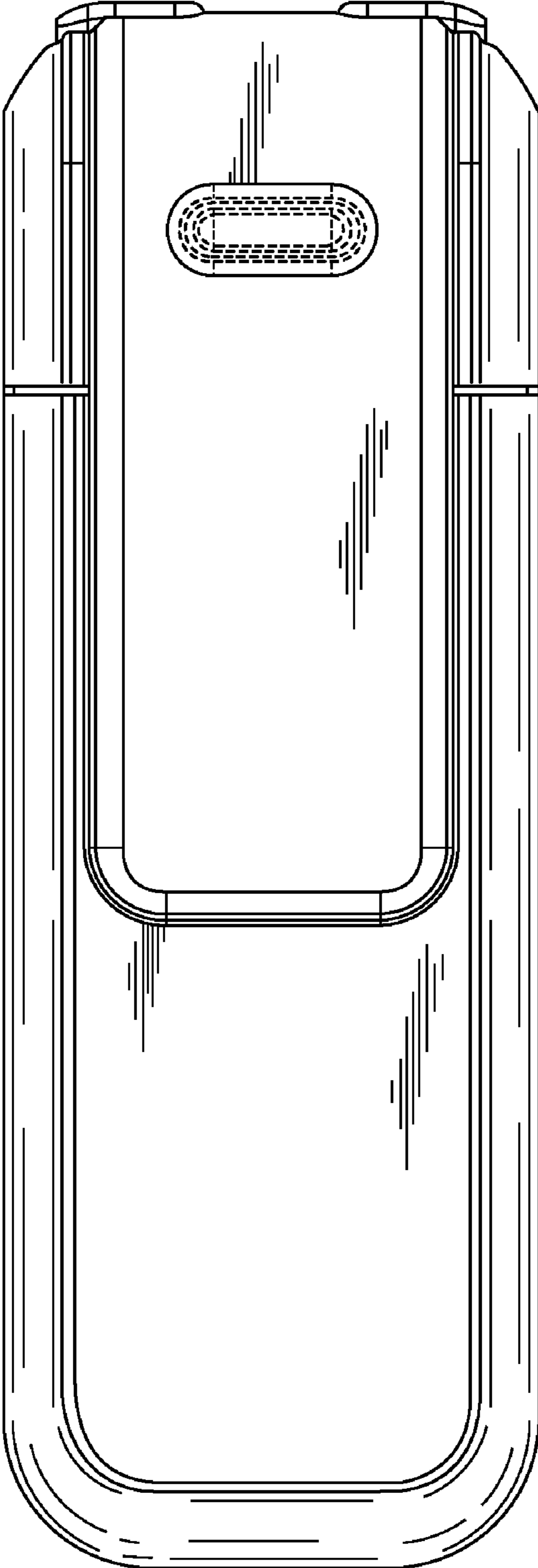

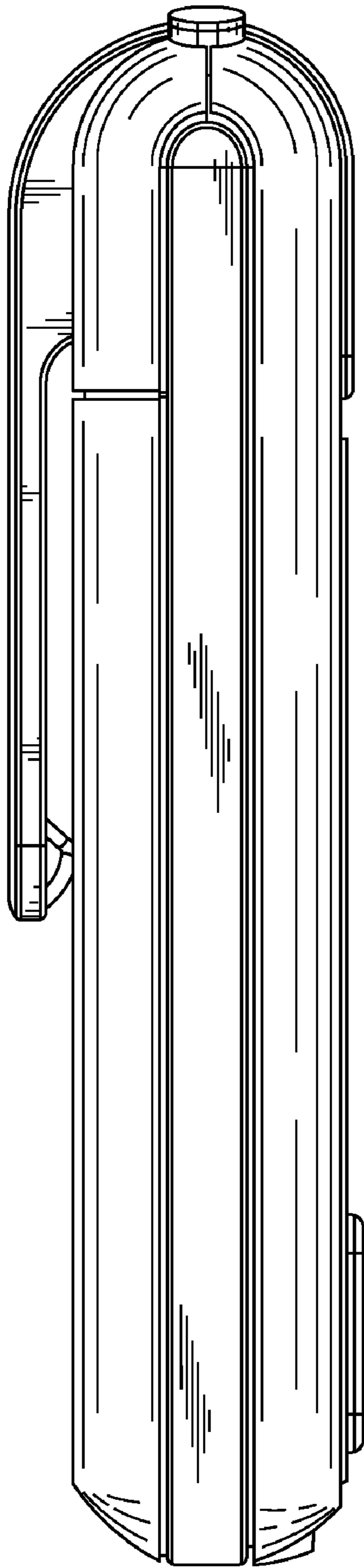

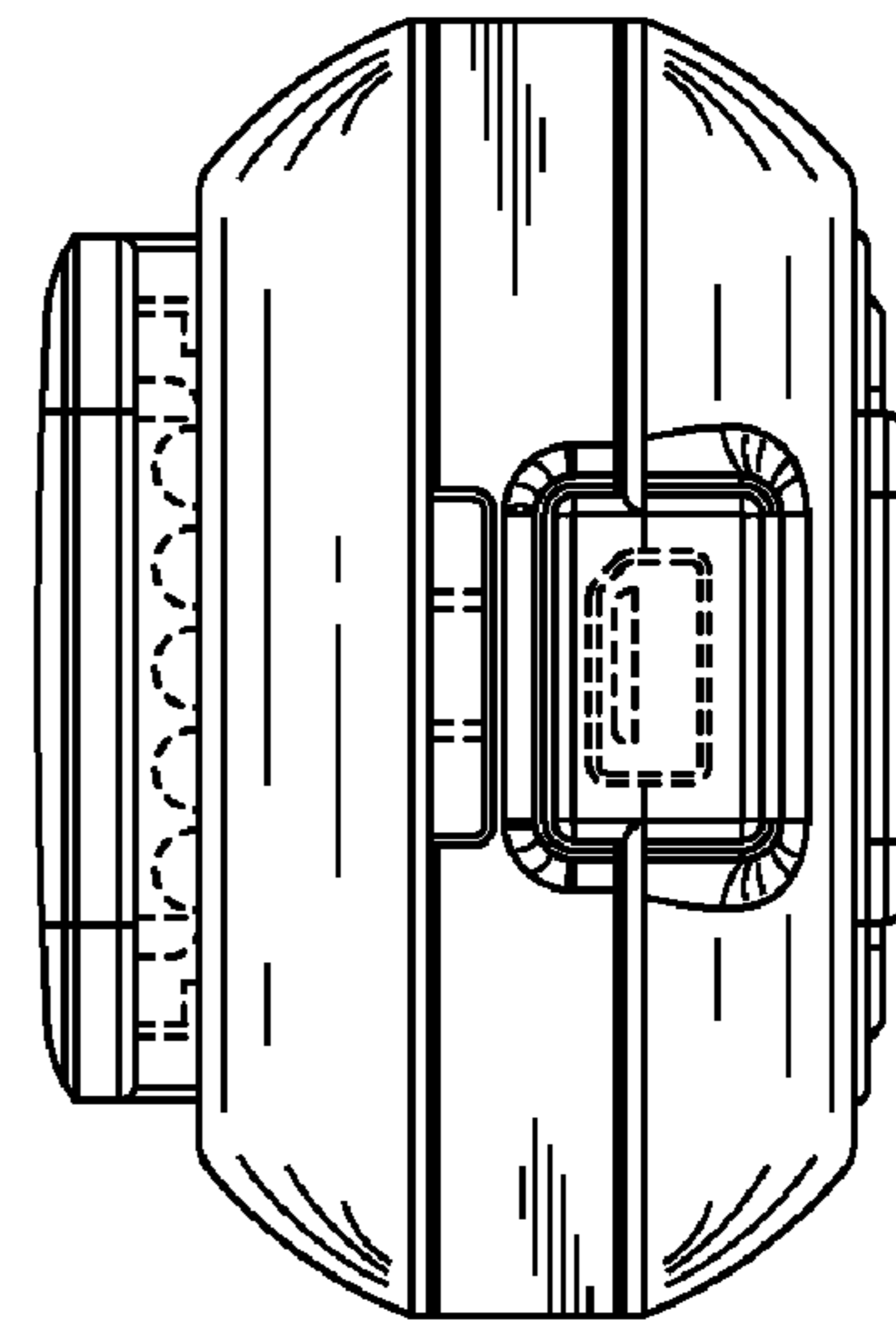

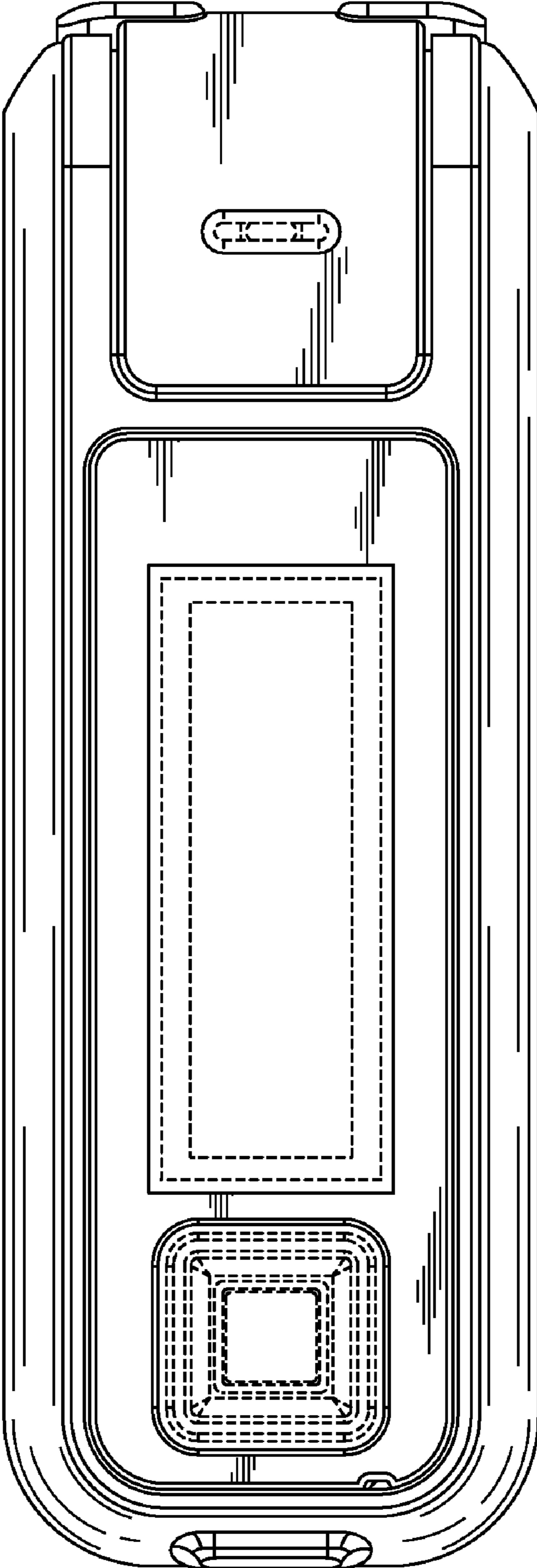
