(57) **CLAIM**

The ornamental design for a television or communication antenna element comprising a high frequency wave coupler, as shown and described.

FIG. 4 is a top view thereof;

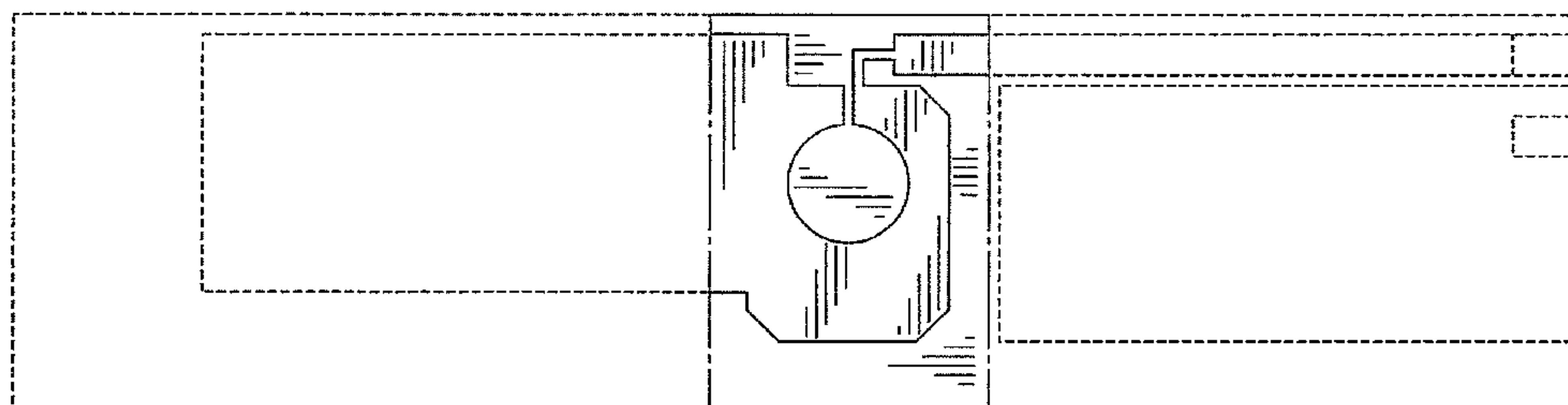
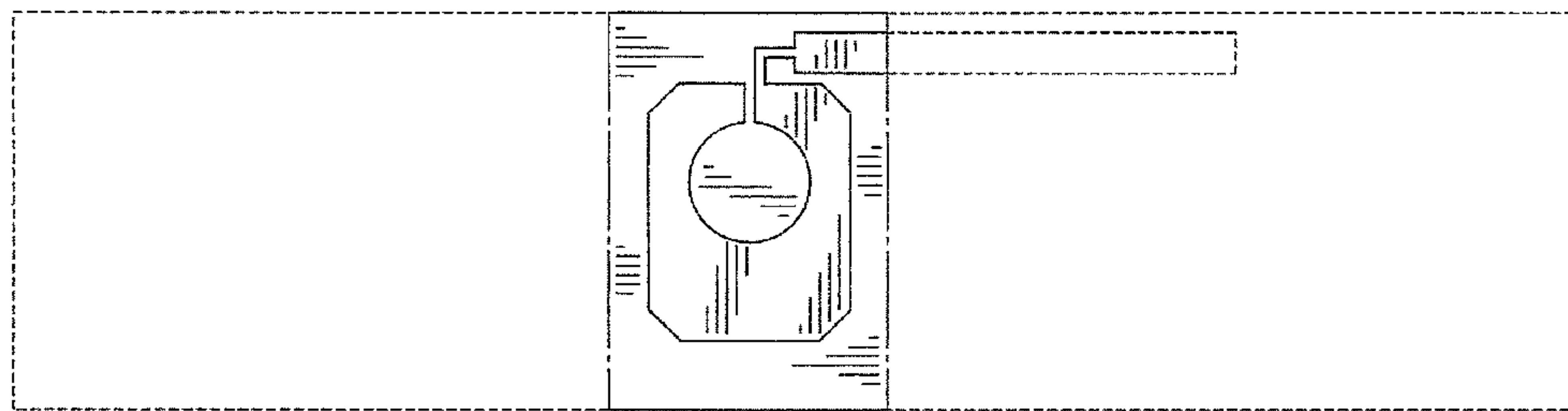
FIG. 5 is a bottom view thereof;

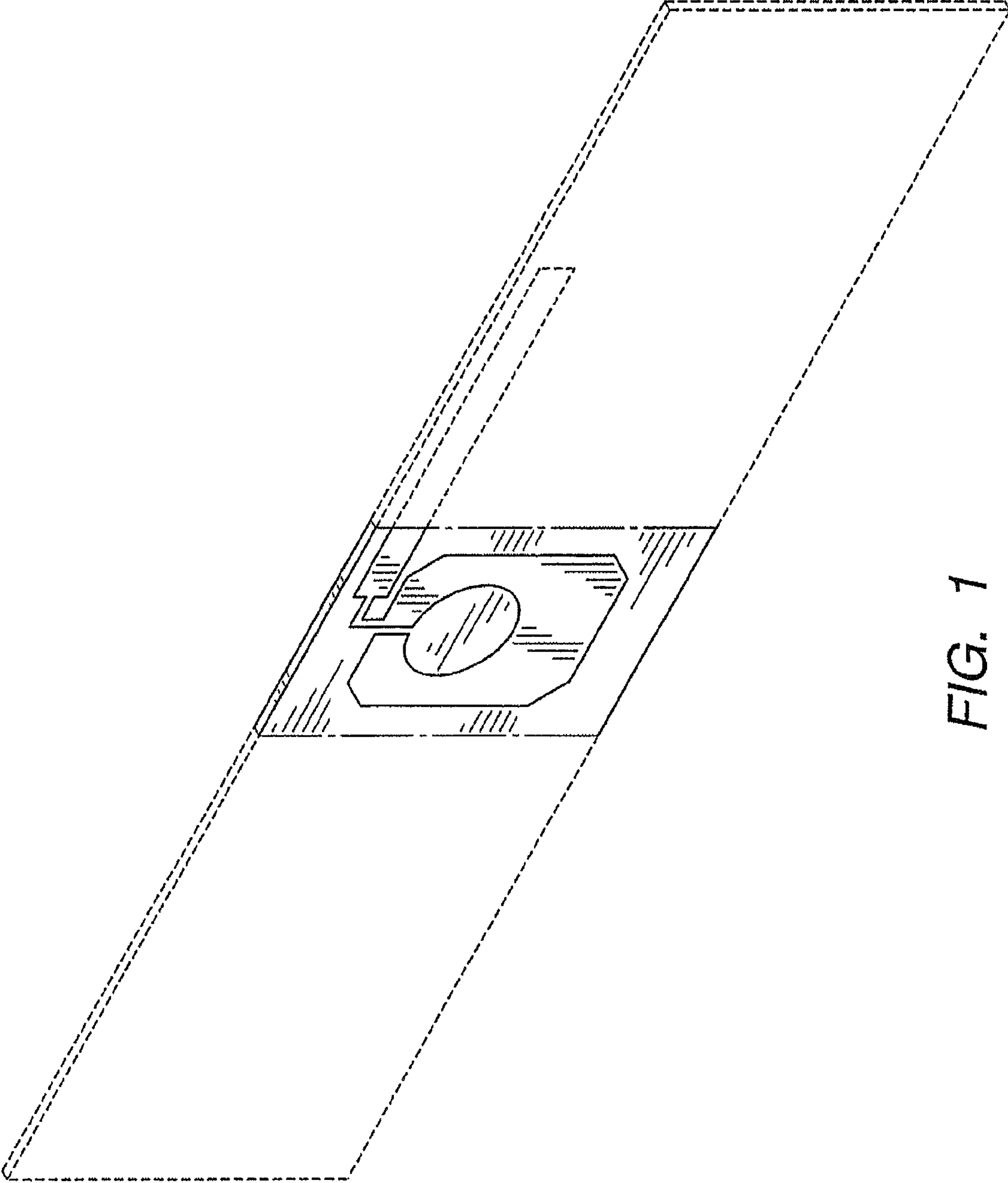

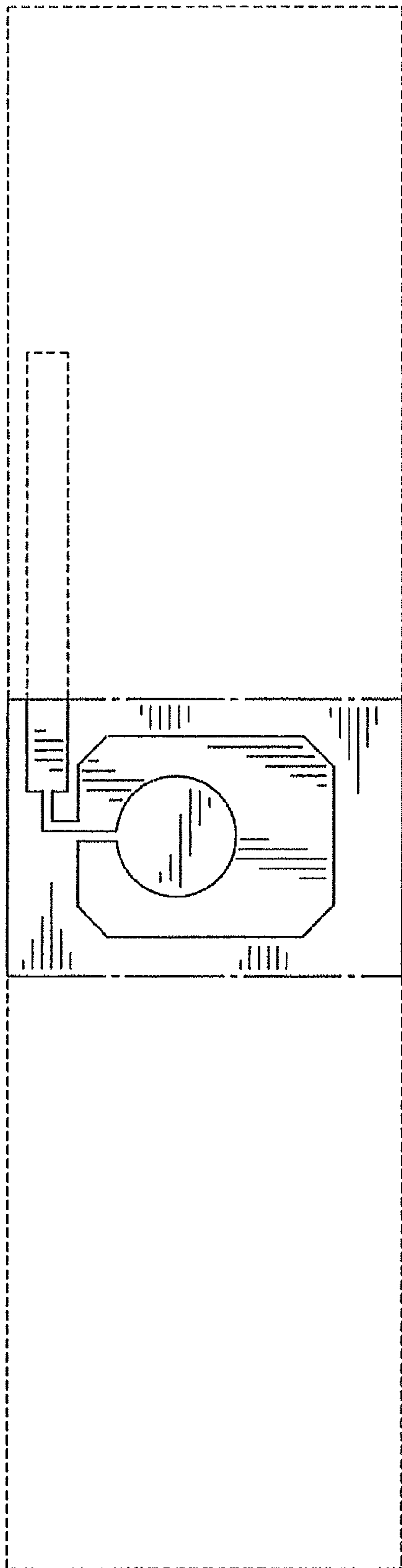

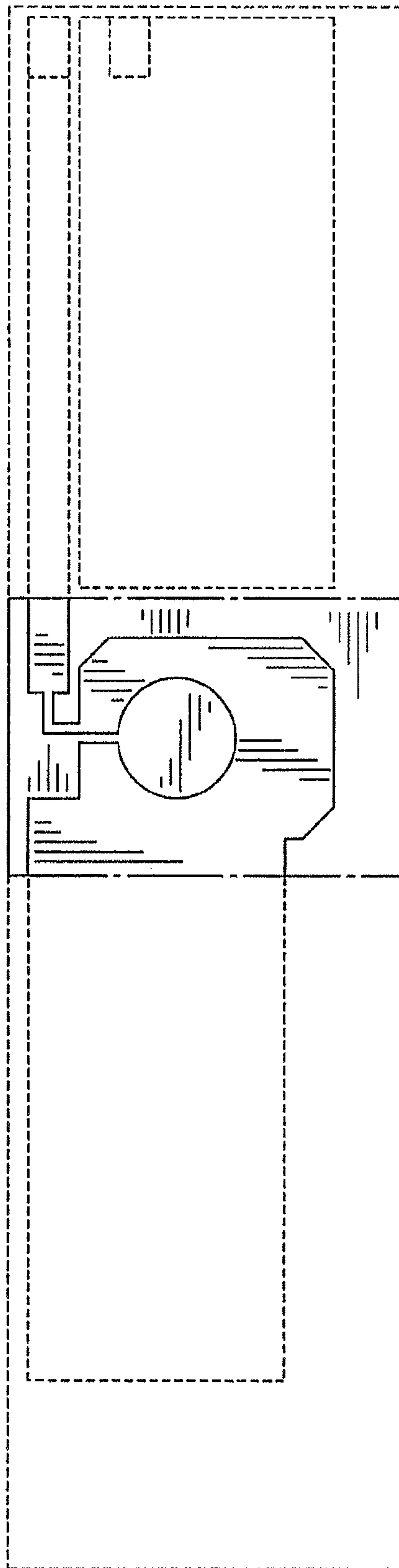

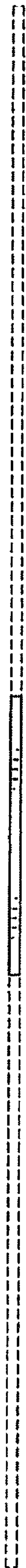

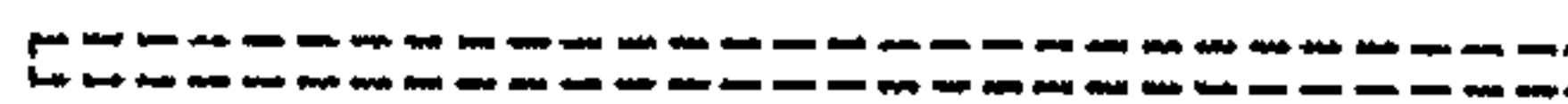

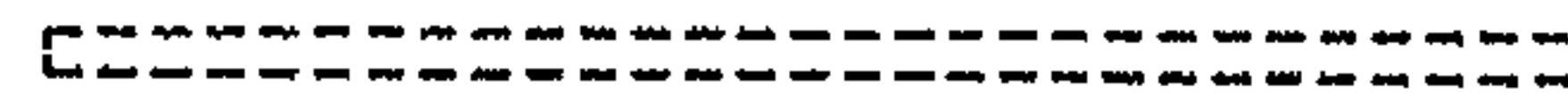
