(57) **CLAIM**

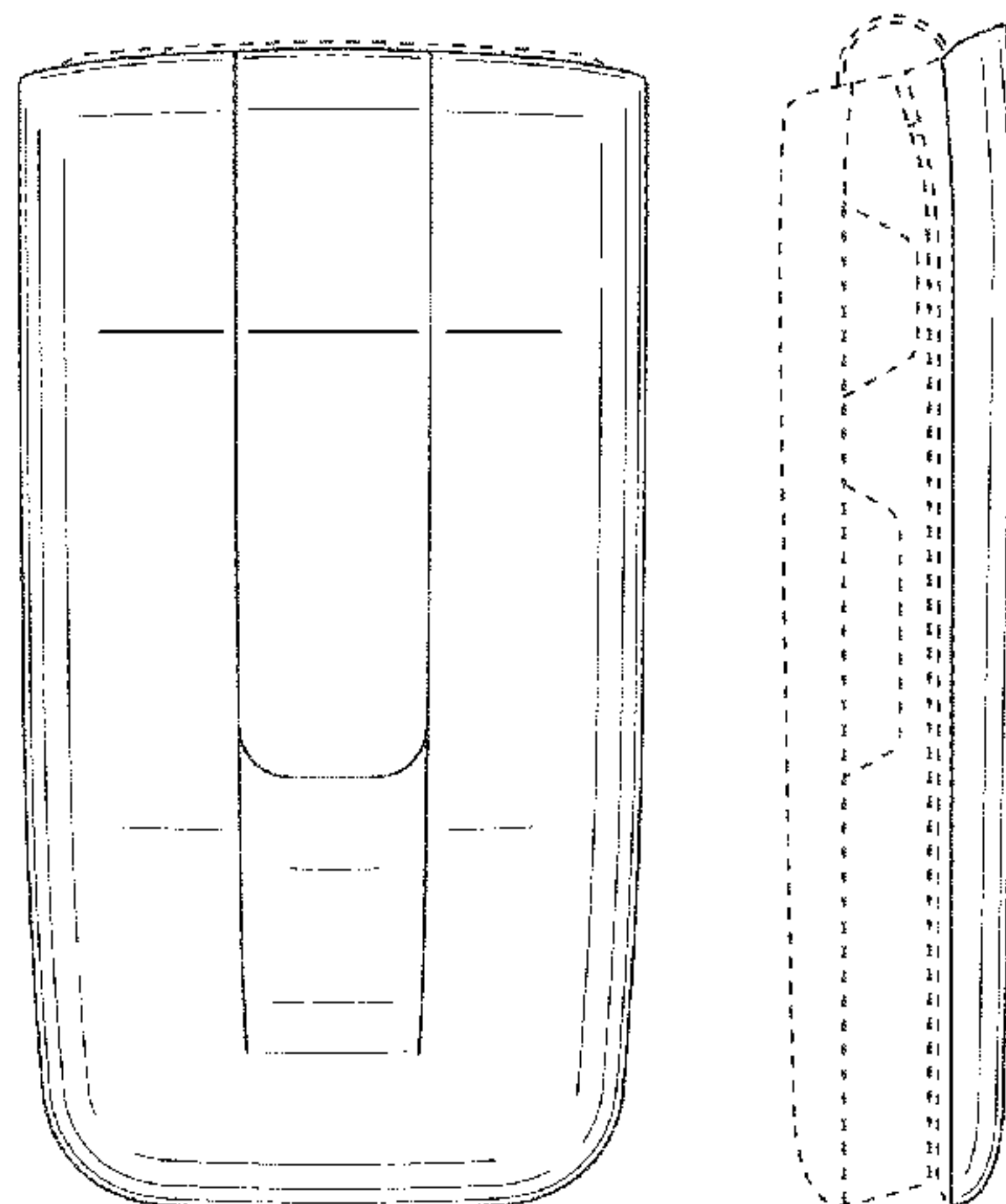
The ornamental design for a front cover for a handset, as shown and described.

**DESCRIPTION**

- FIG. 1 is a front perspective view of a handset in a closed position showing my new design;

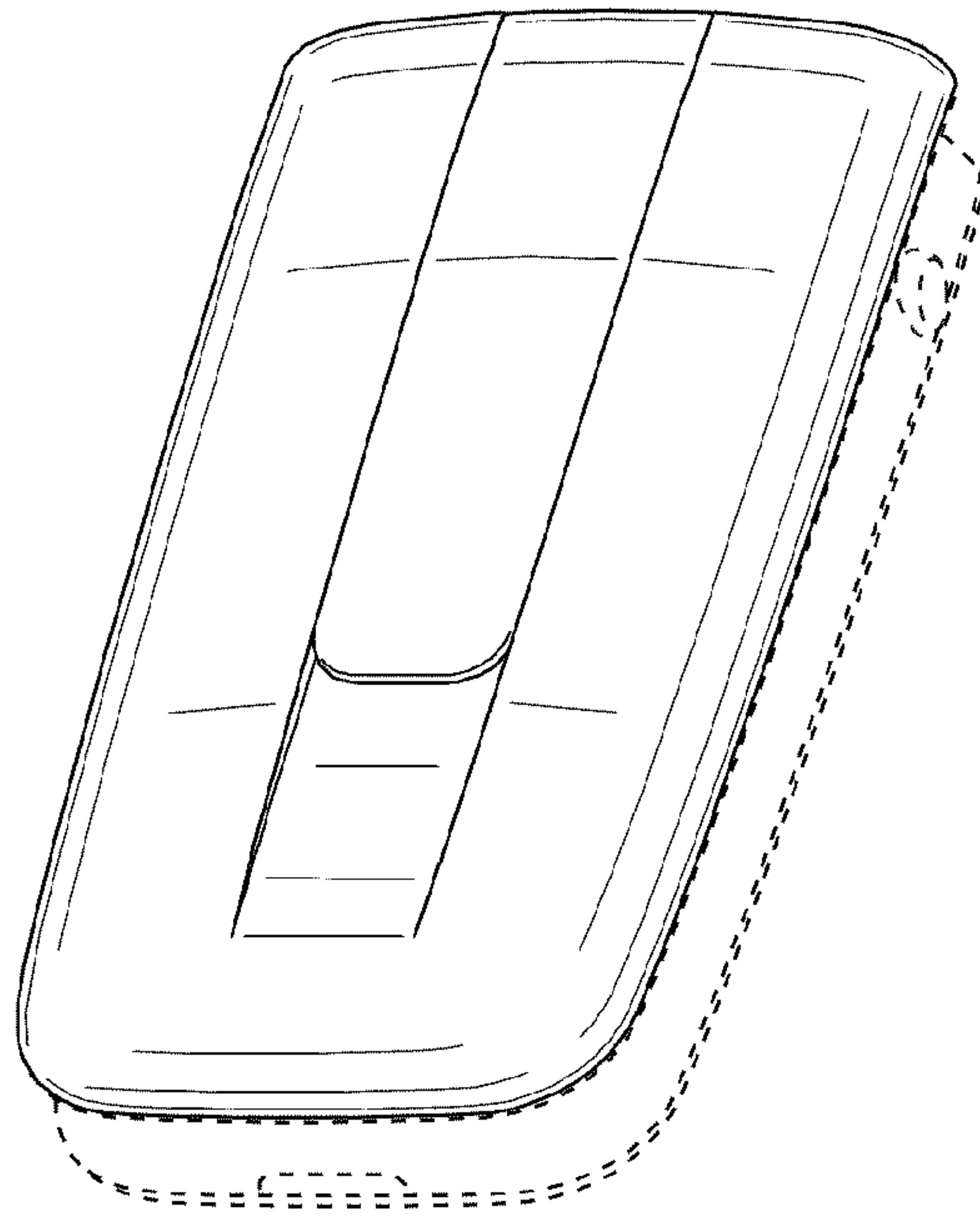

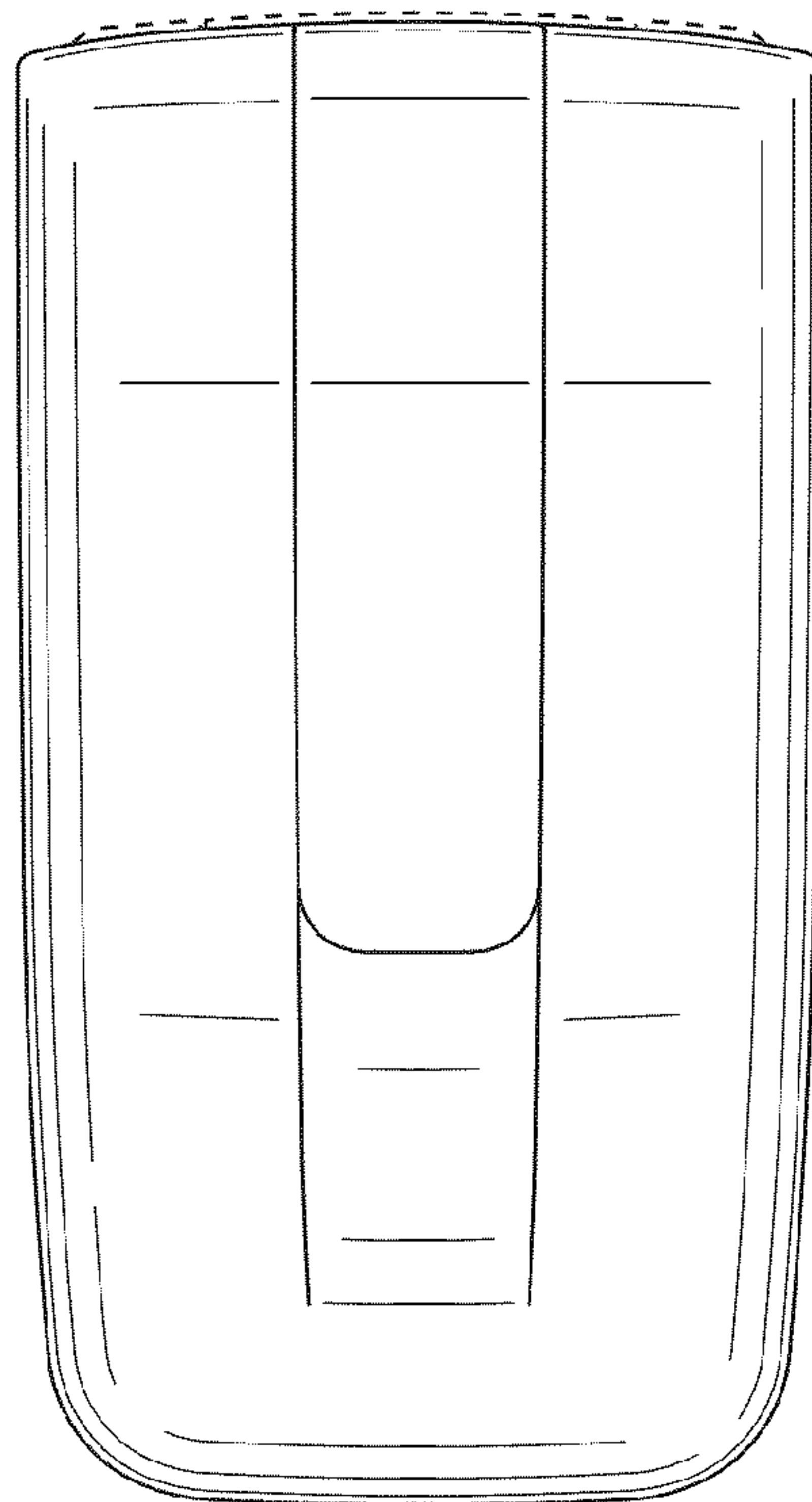

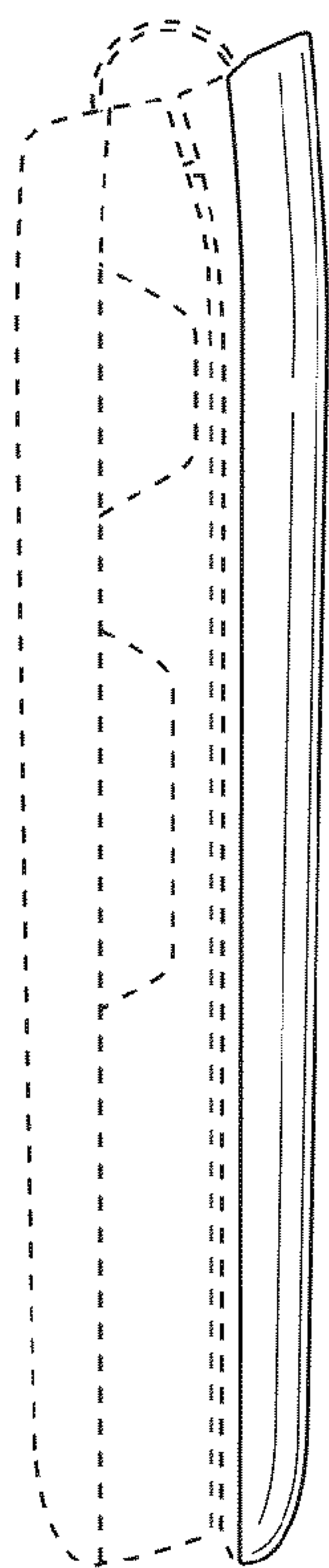

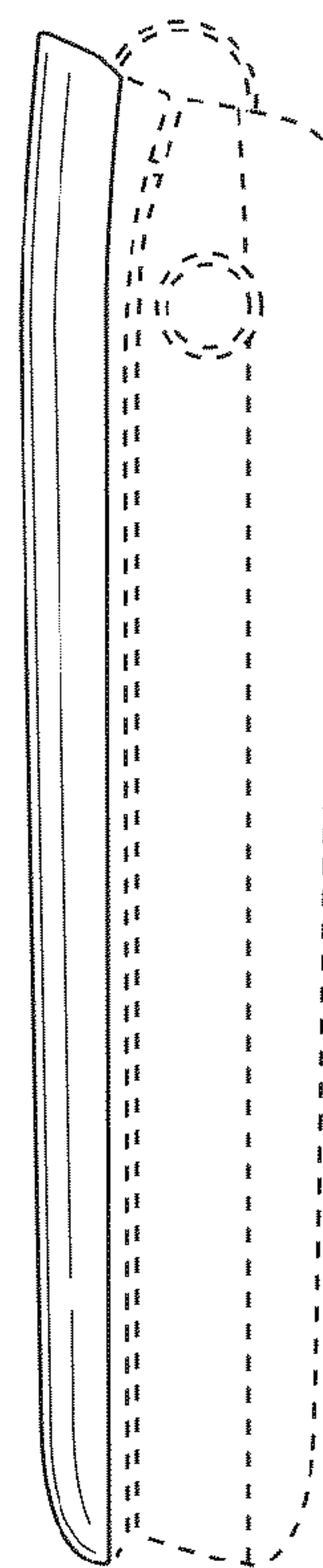

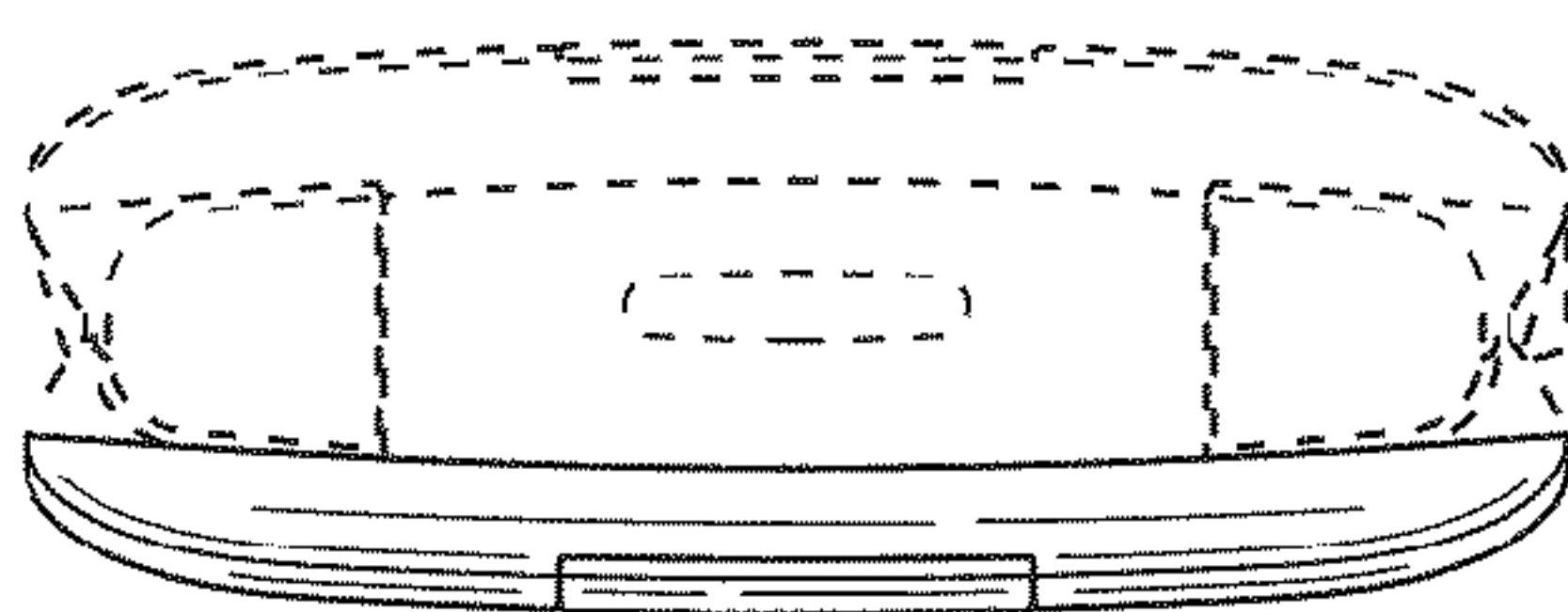

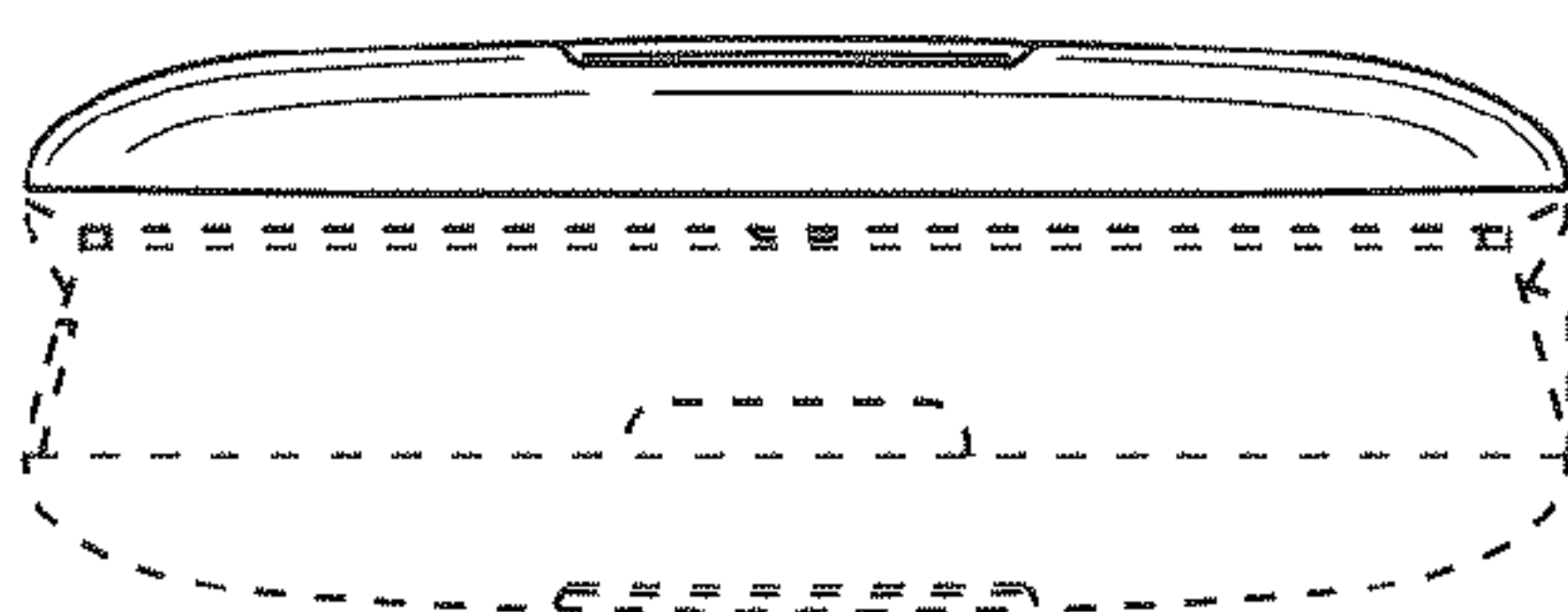
