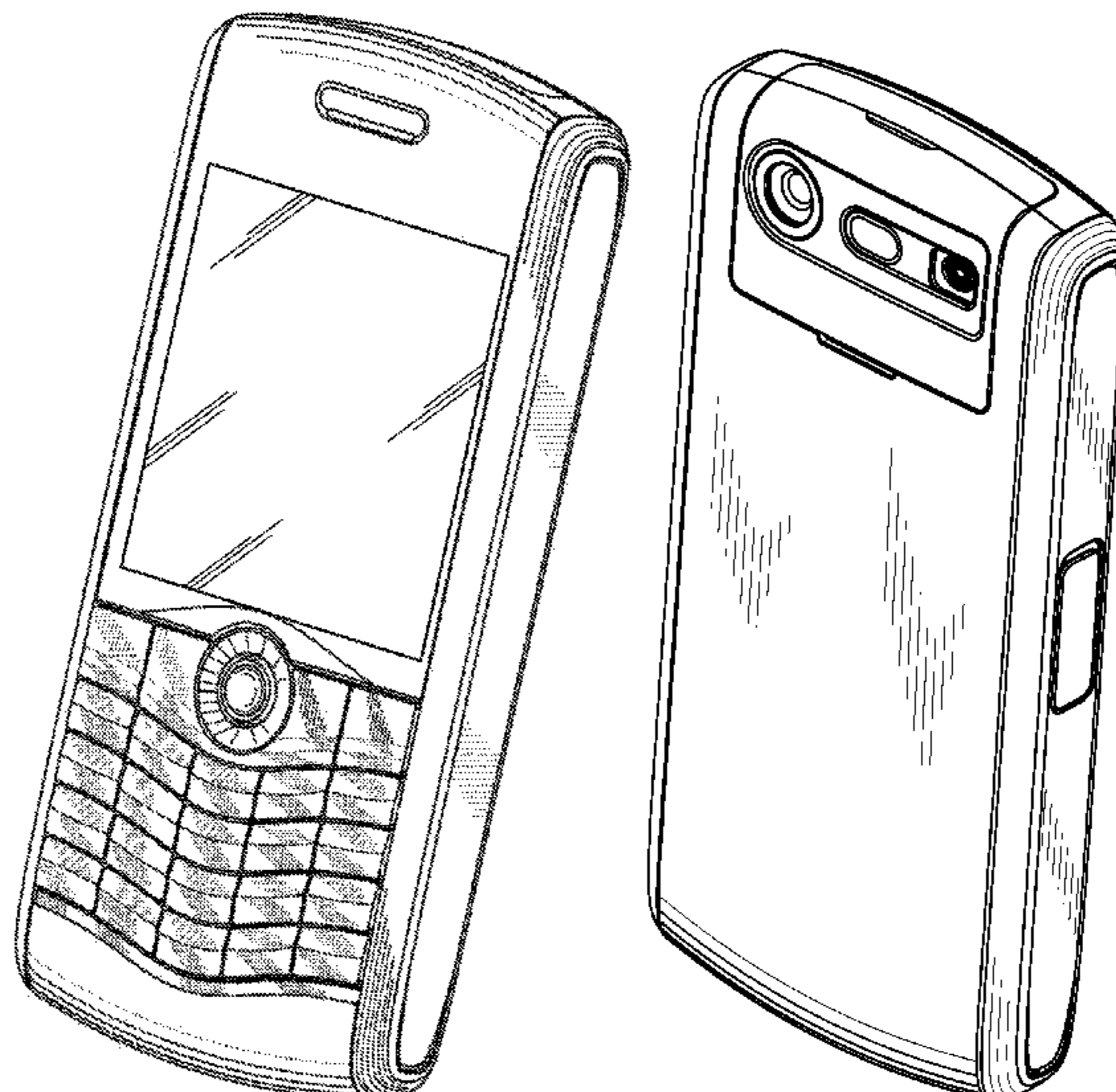
(57) **CLAIM**

We claim the ornamental design for a hand-held electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hand-held electronic device;
FIG. 2 is a back perspective view thereof;

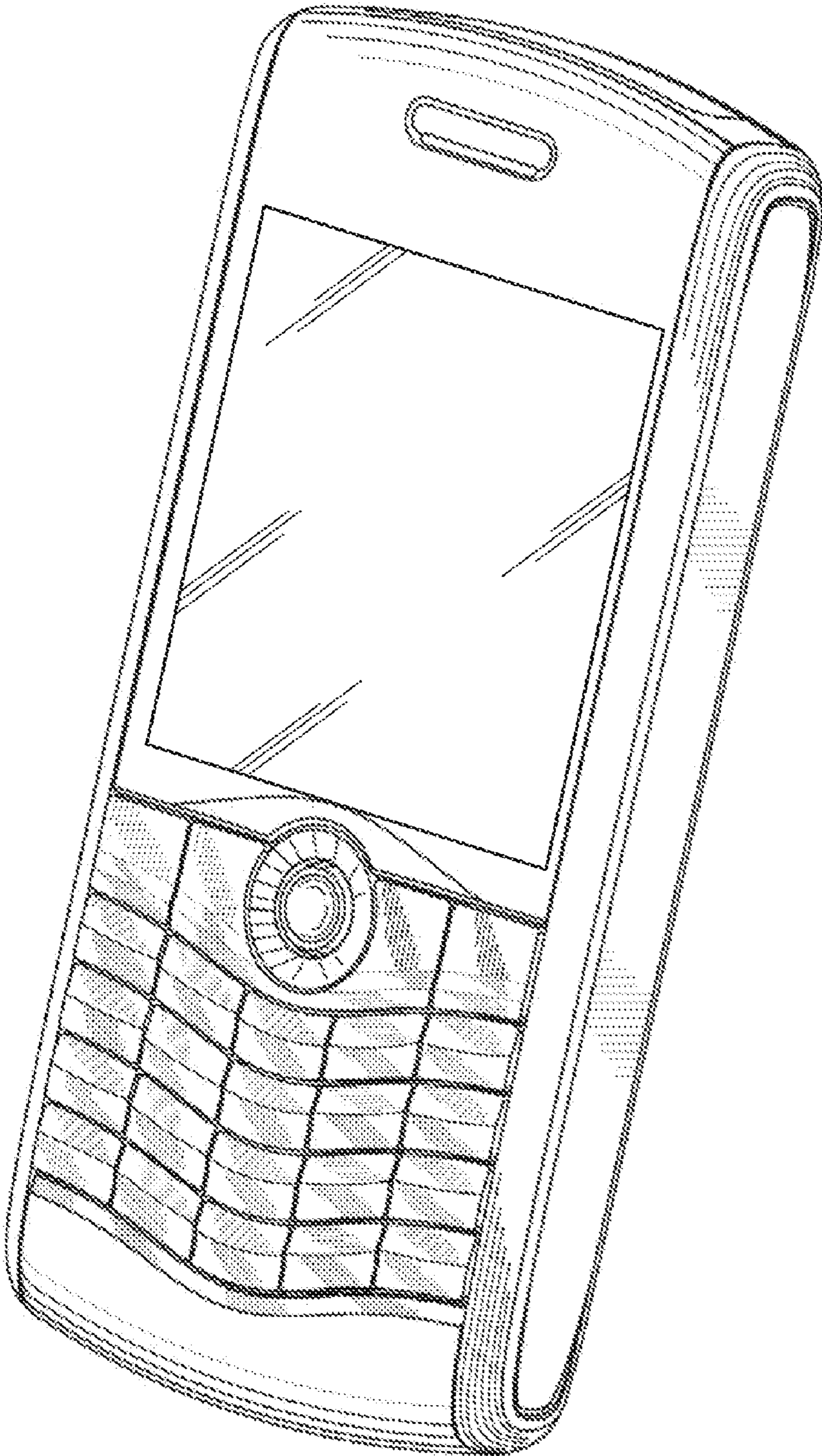

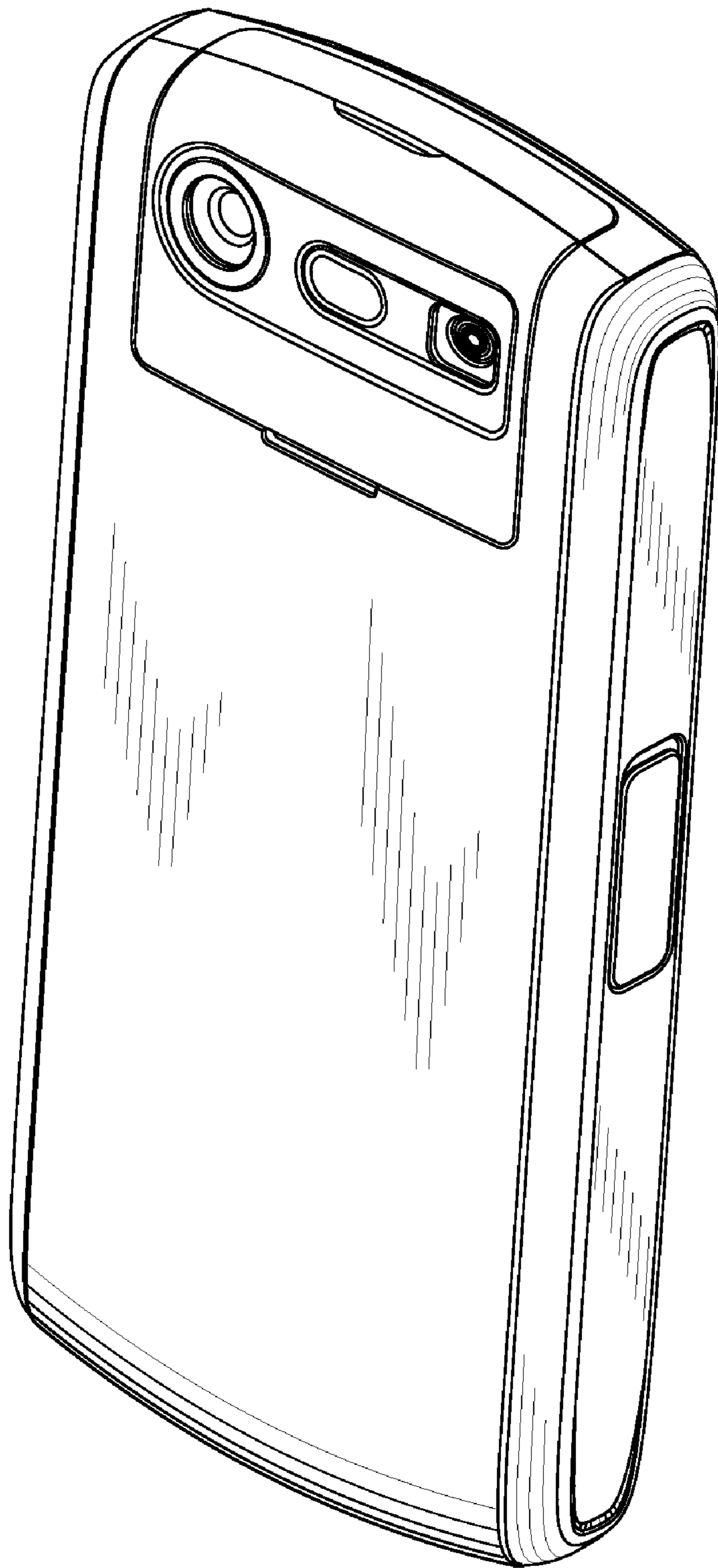

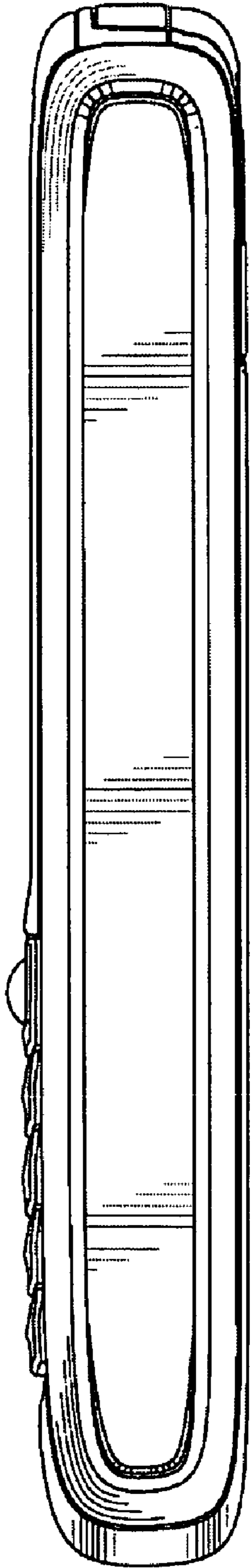

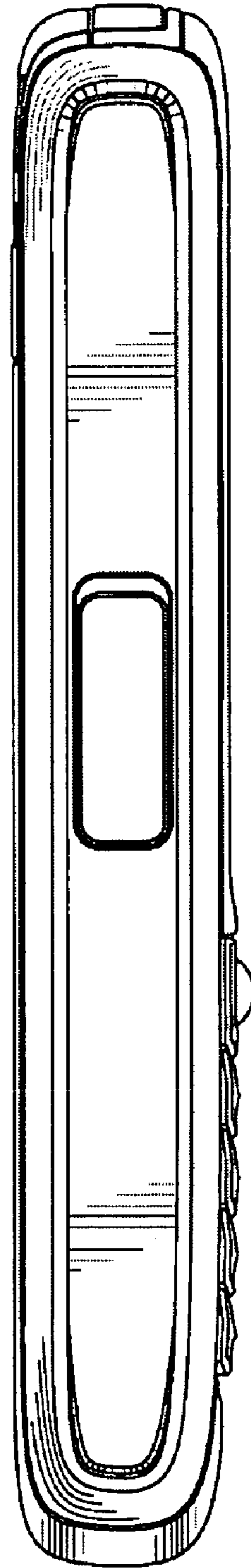

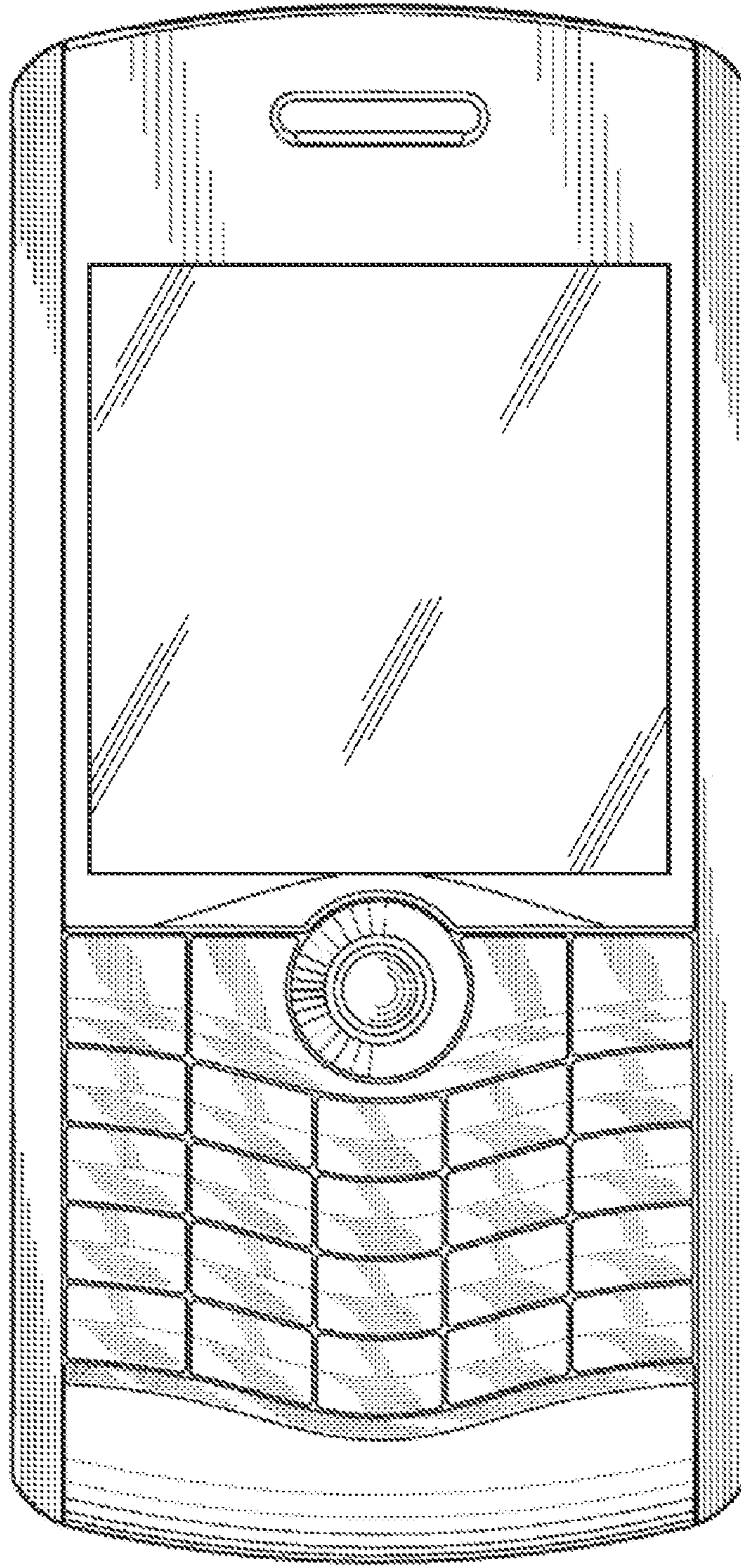

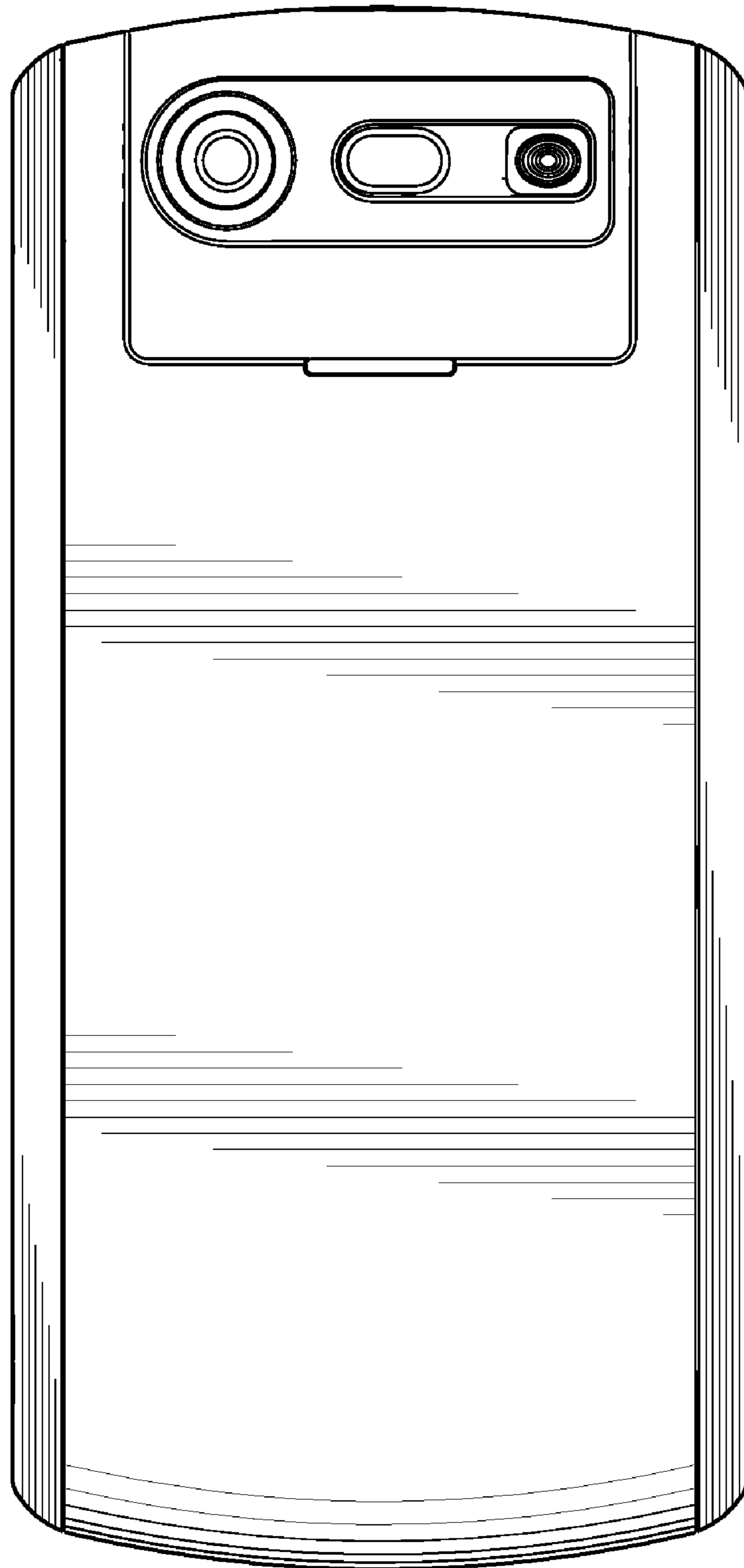

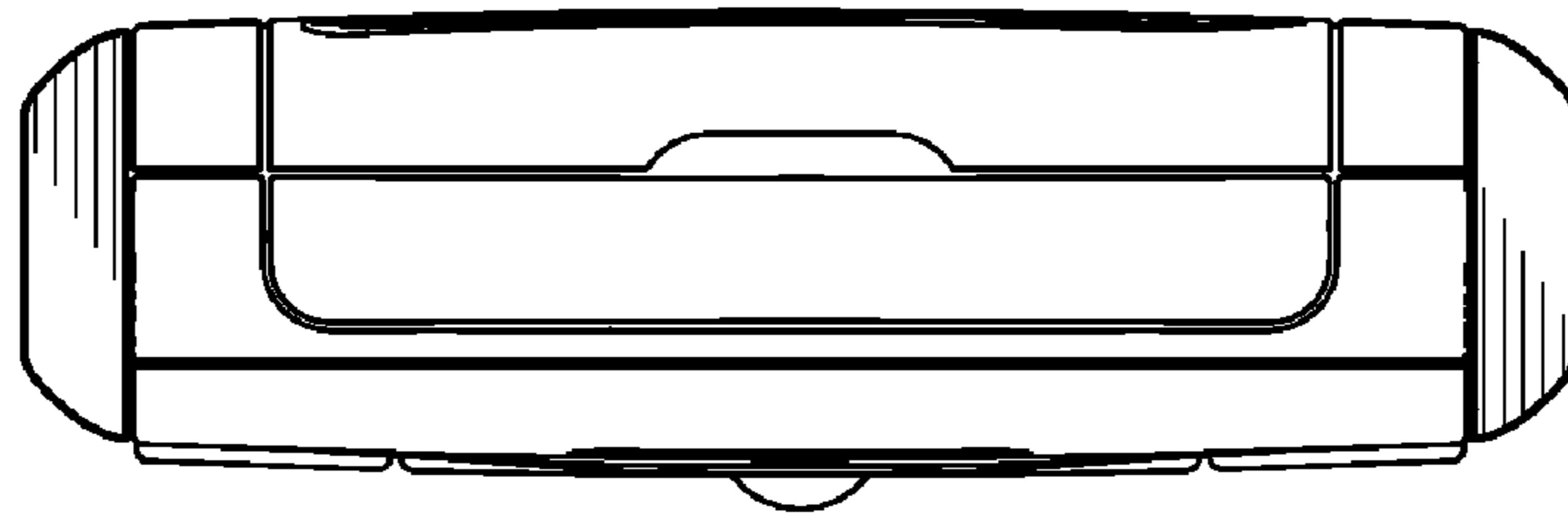

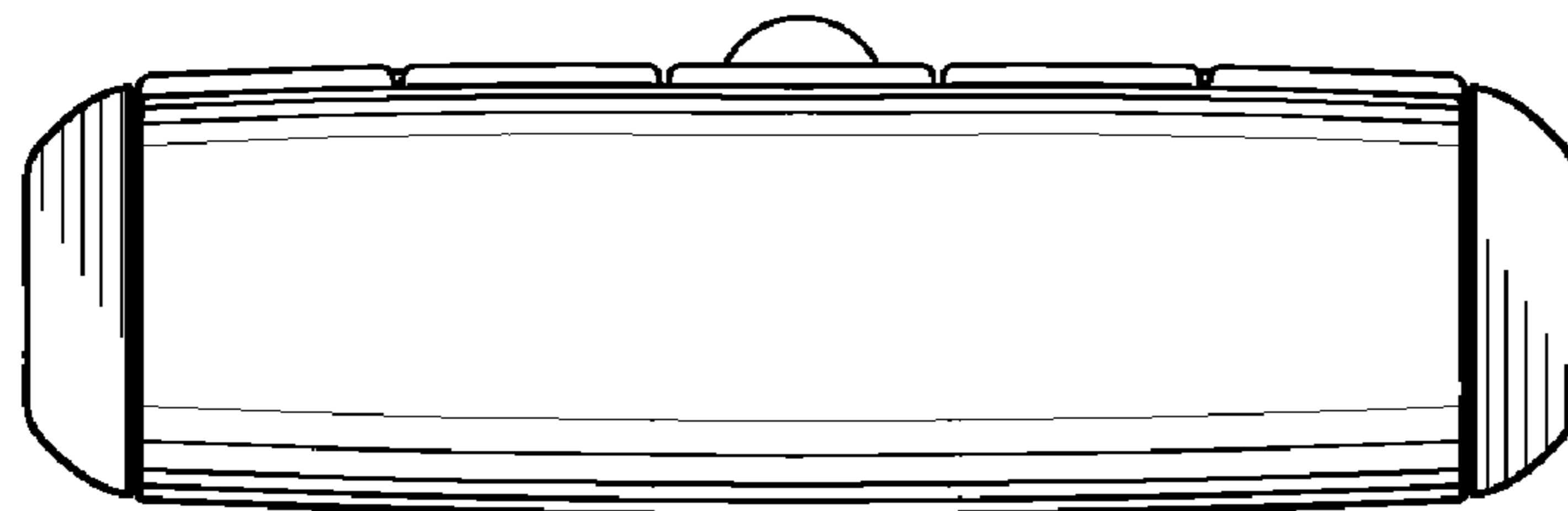
