FIG. 24 is a rear elevational view thereof;

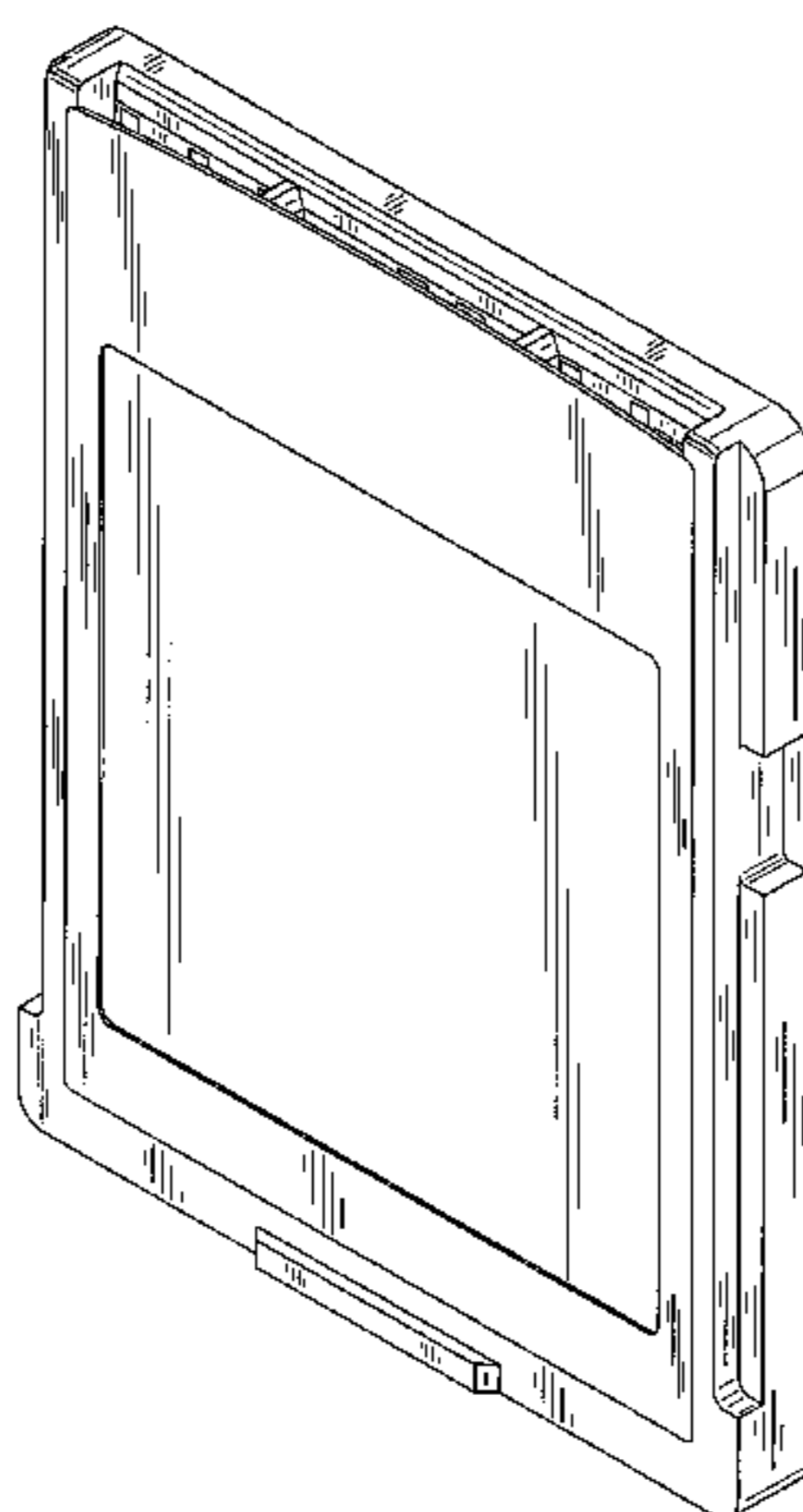
FIG. 25 is a left side elevational view thereof;

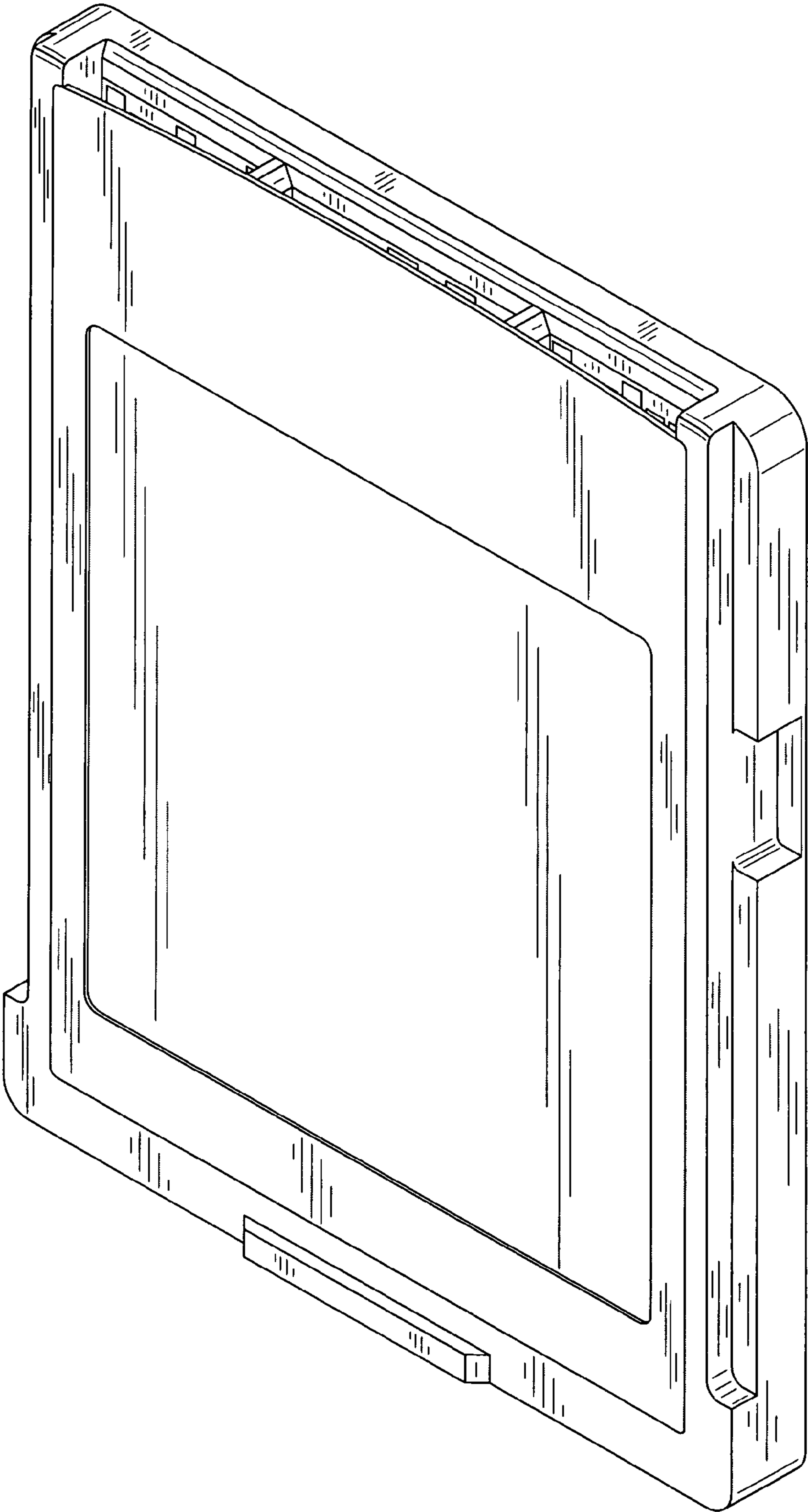

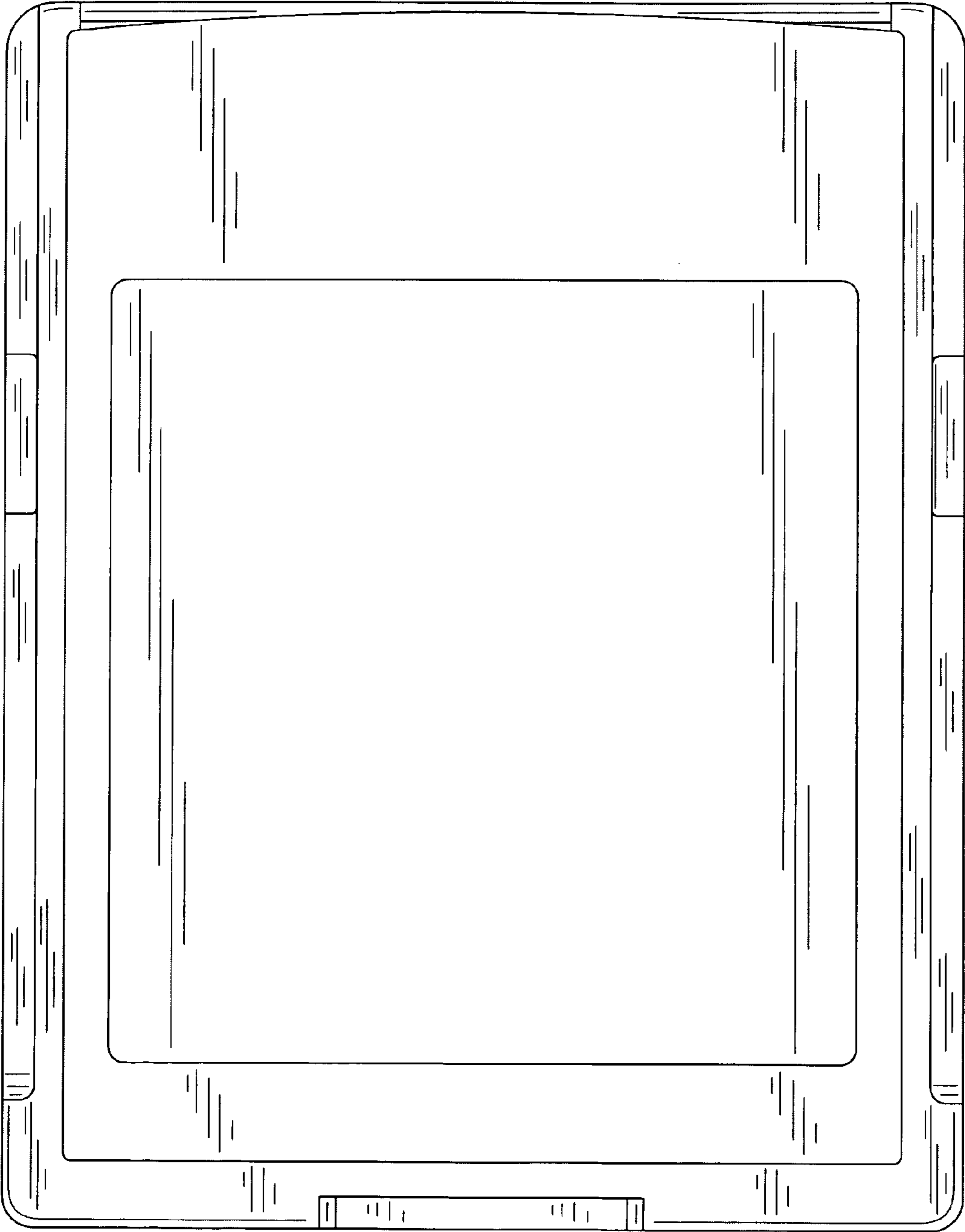

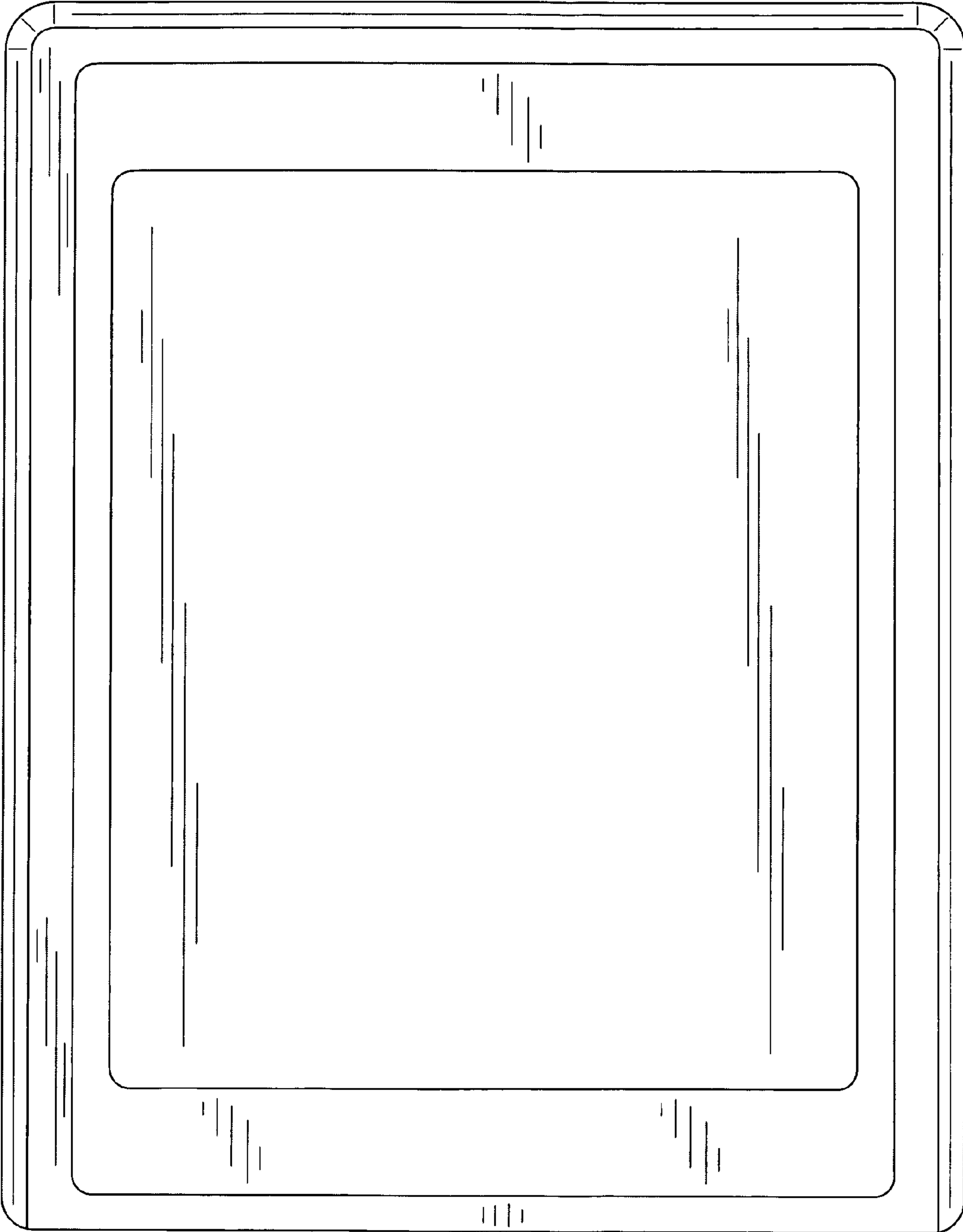

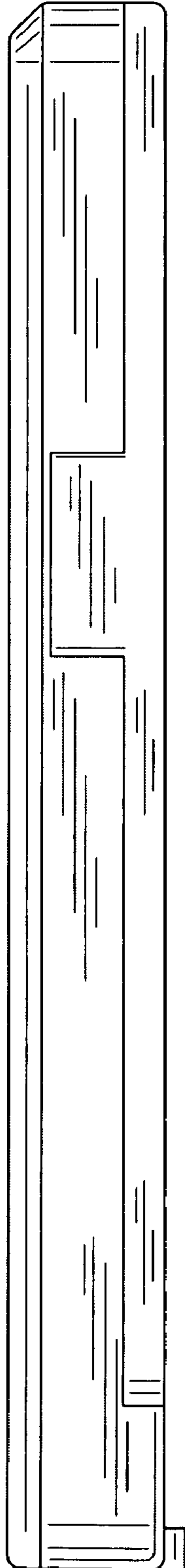

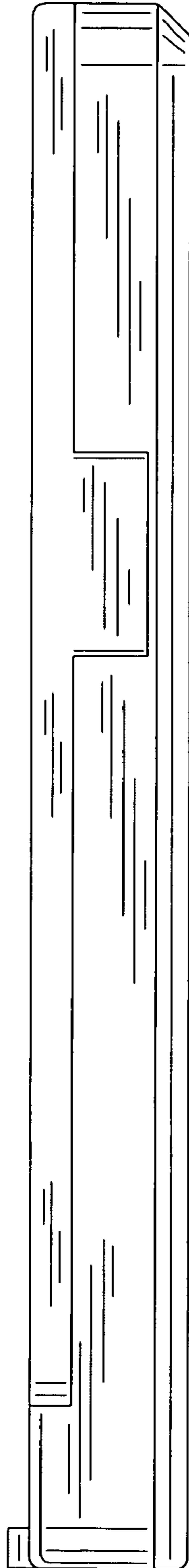

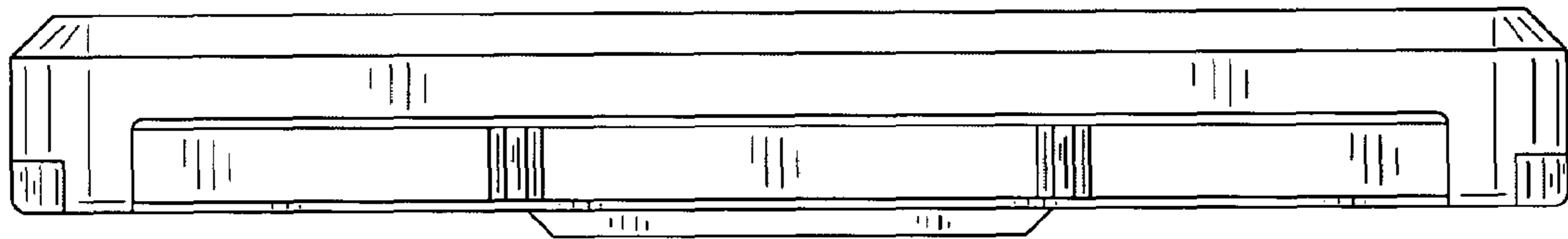

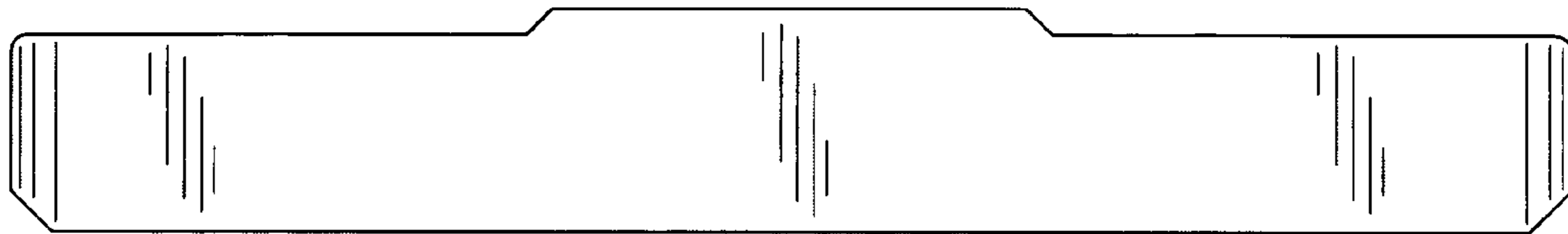

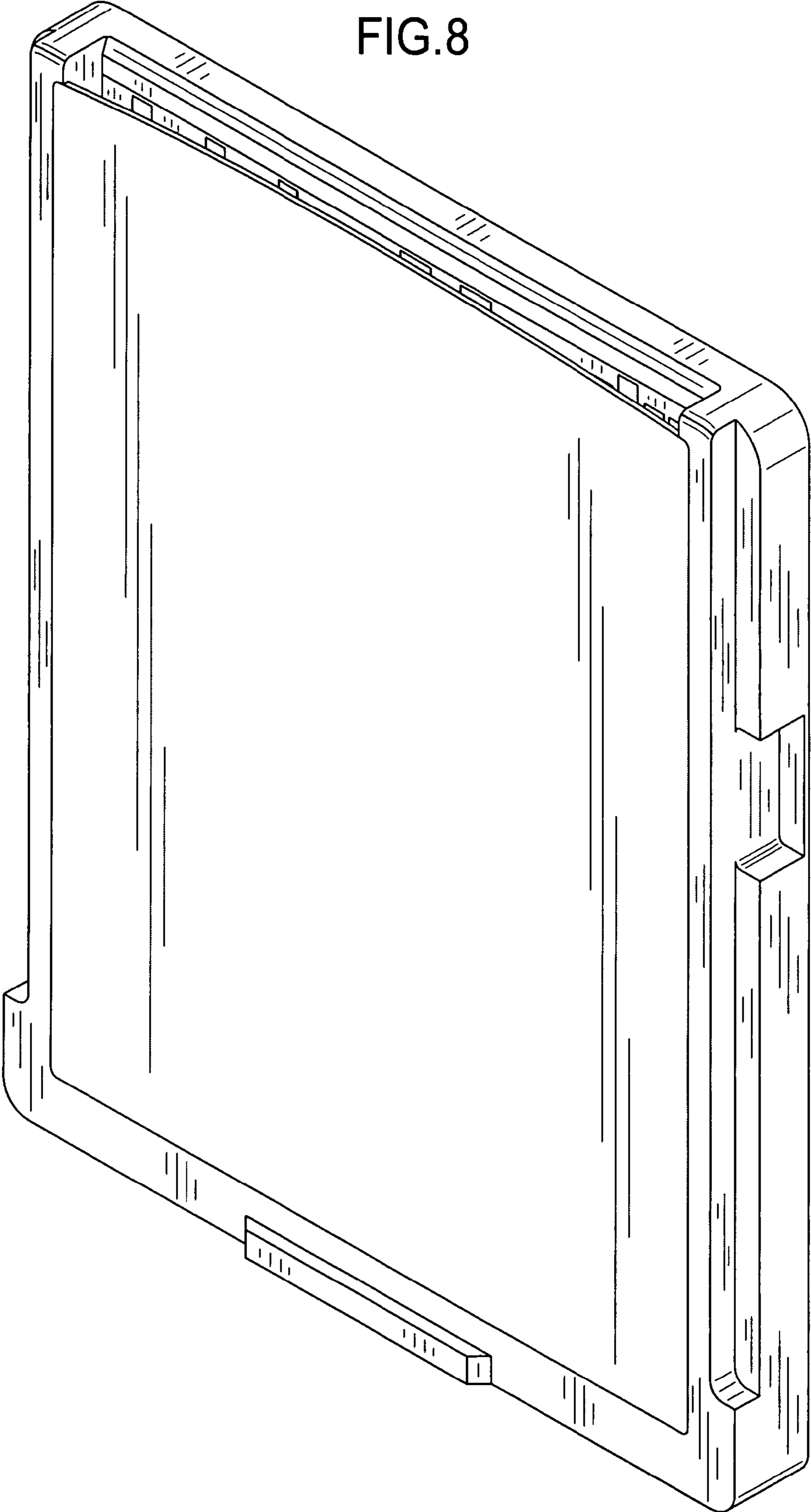

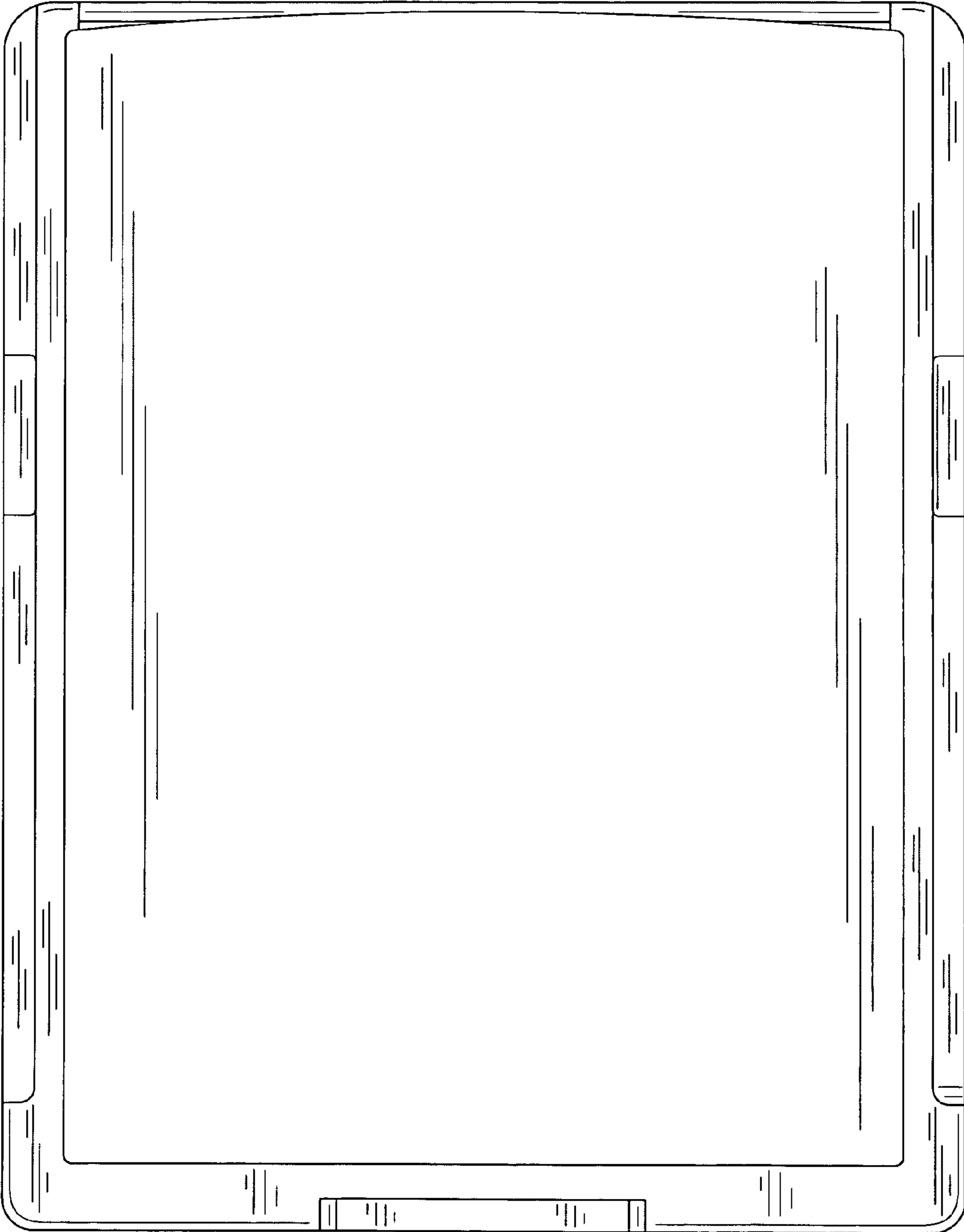

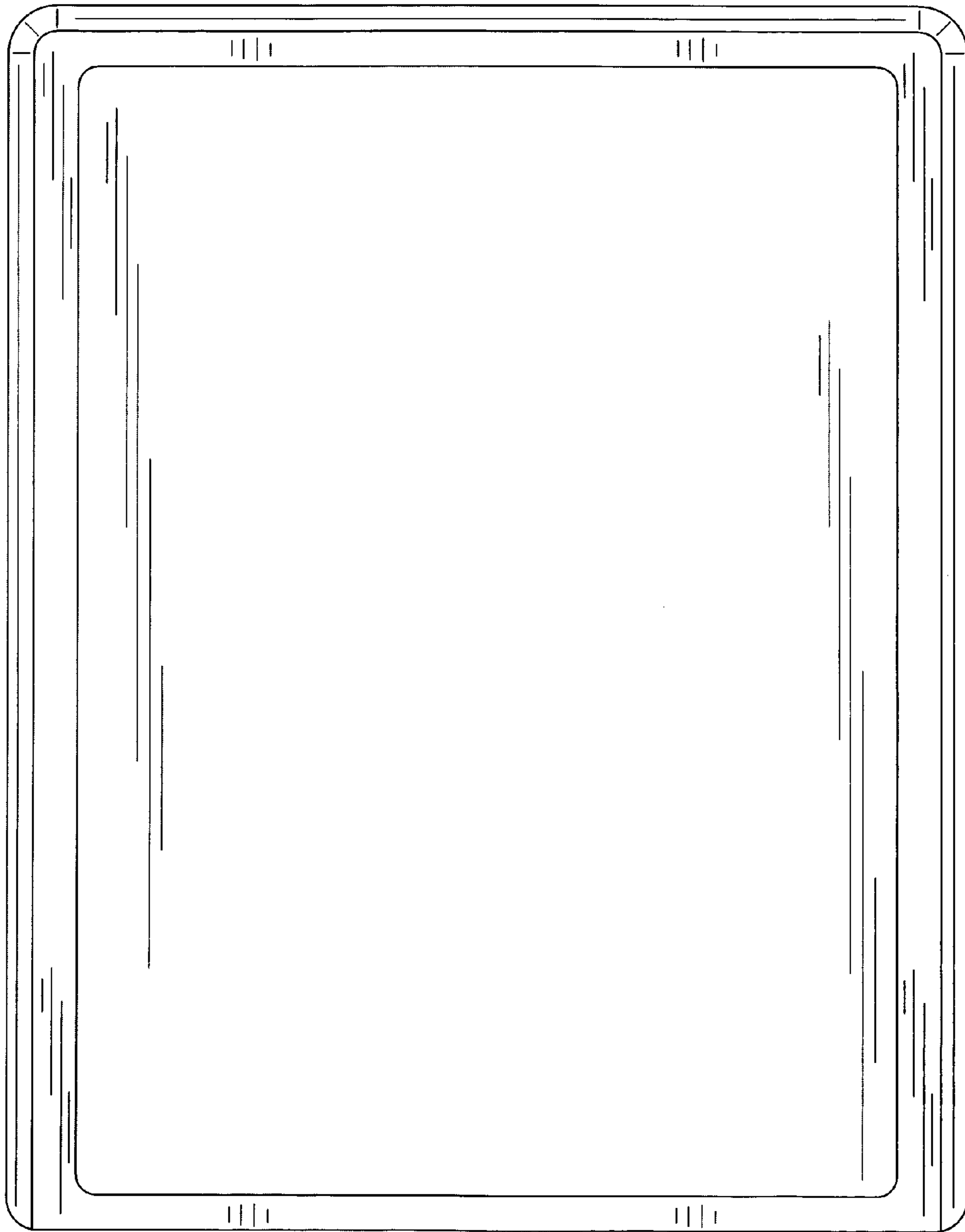

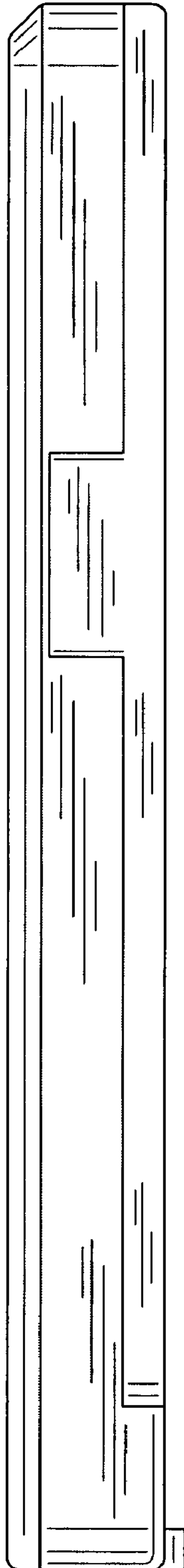

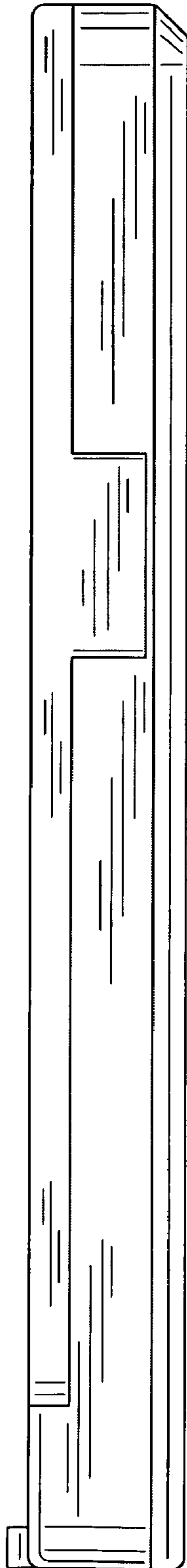

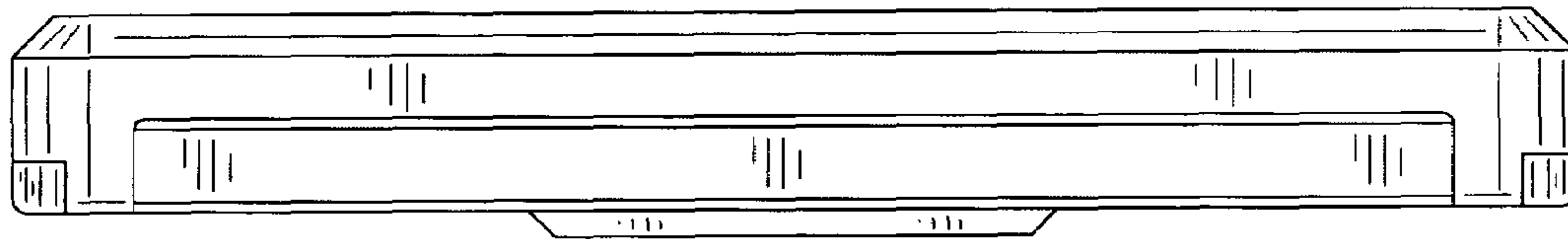

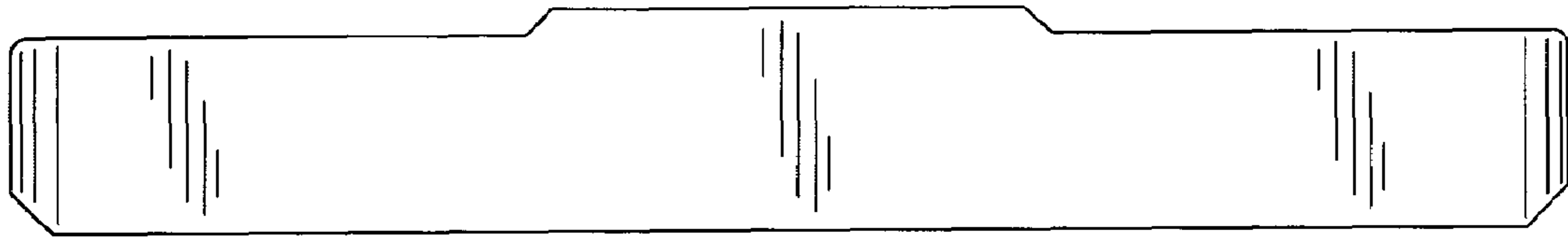

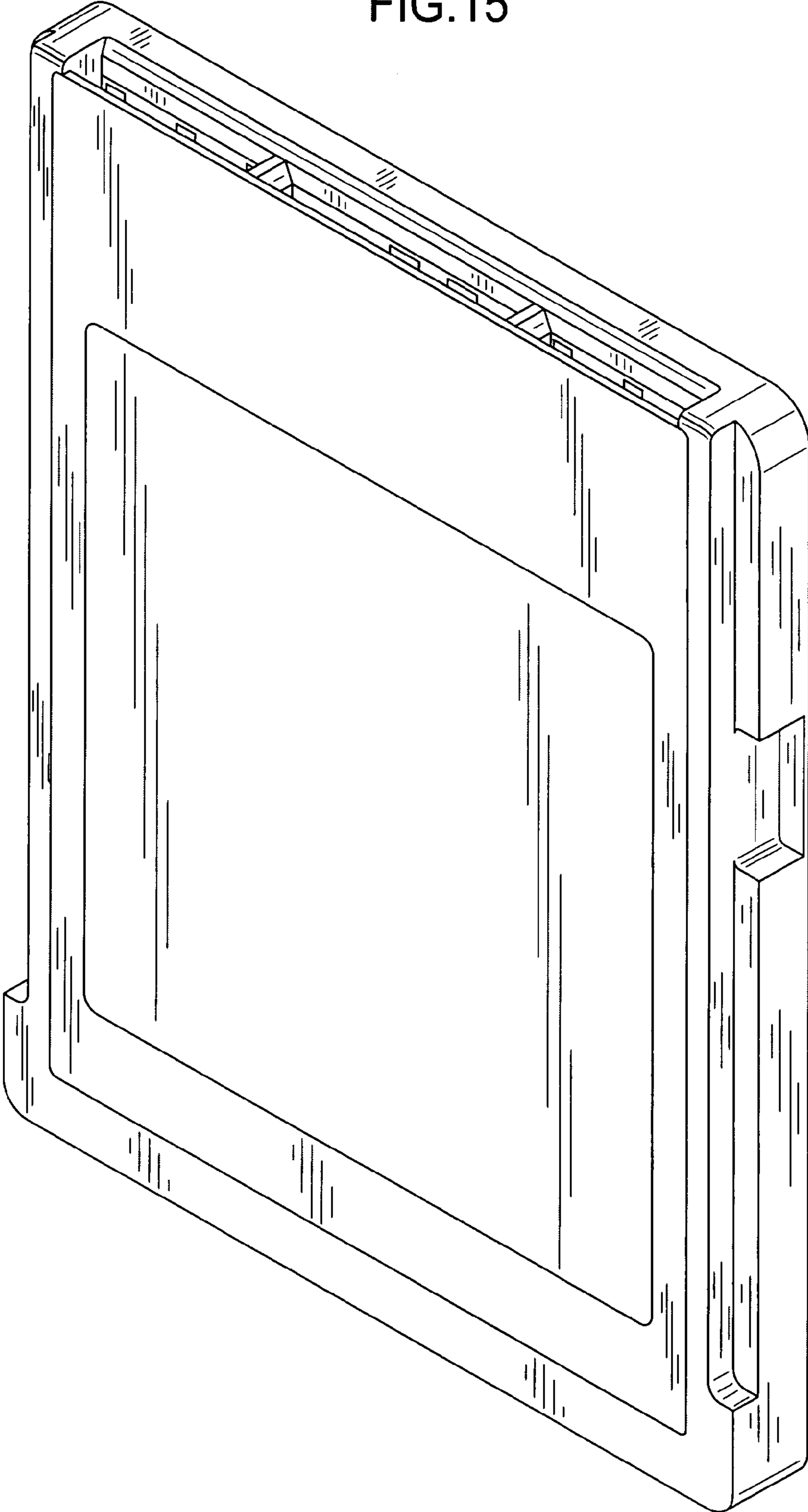

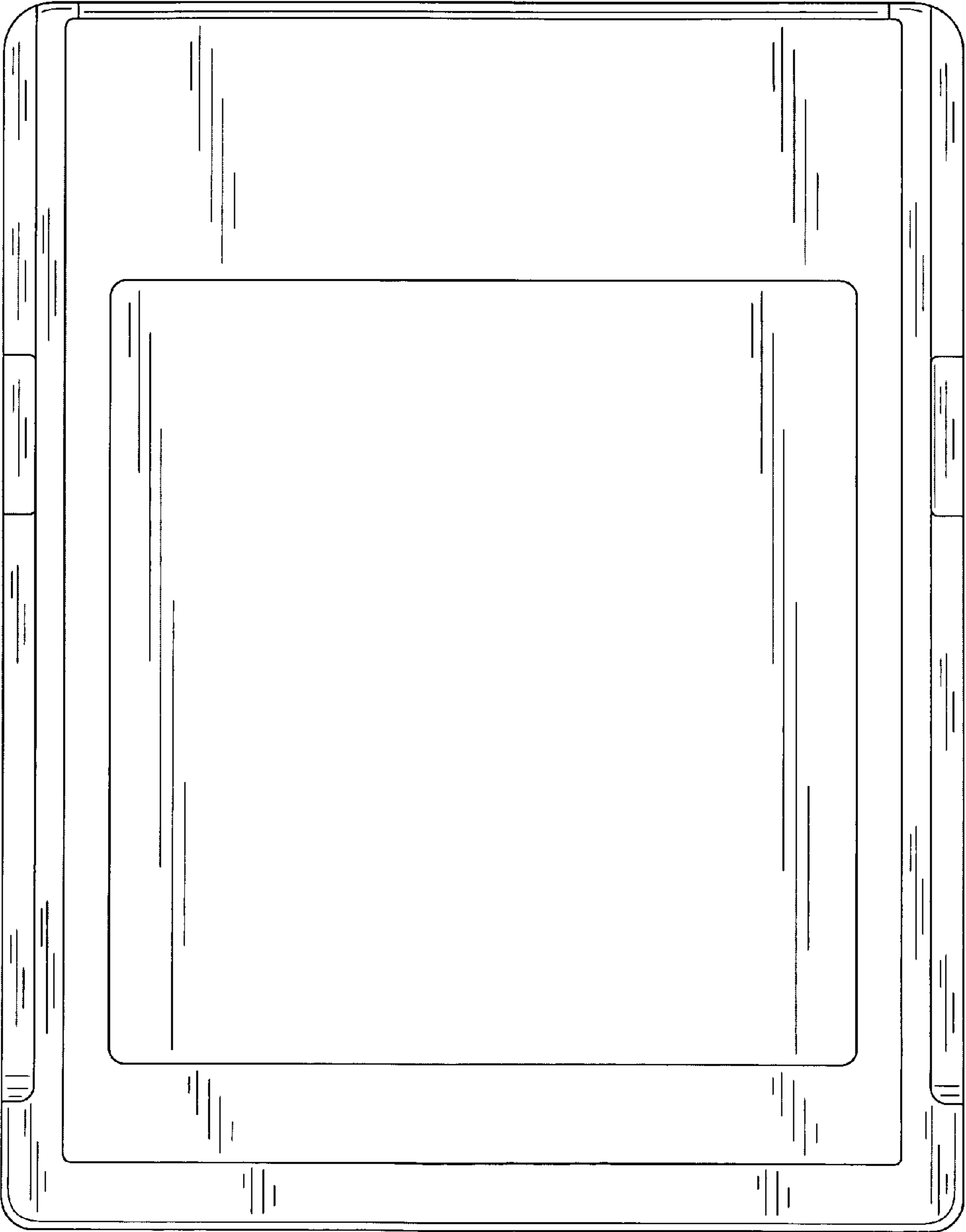

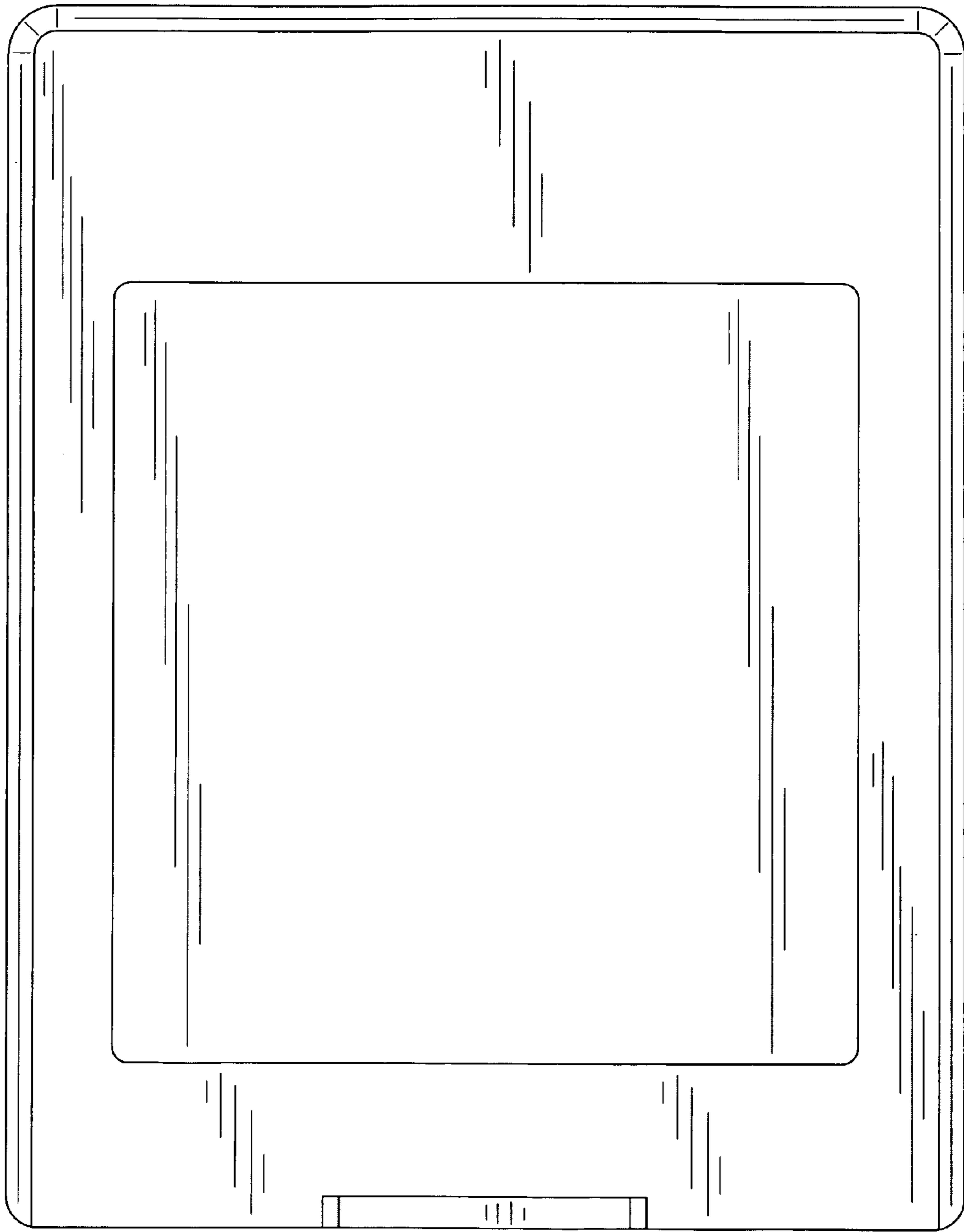

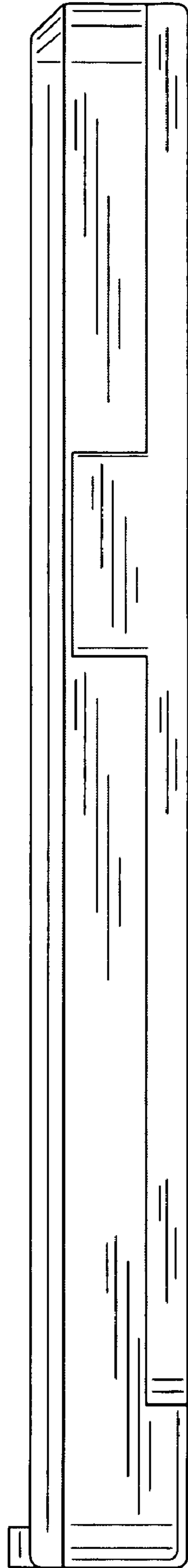

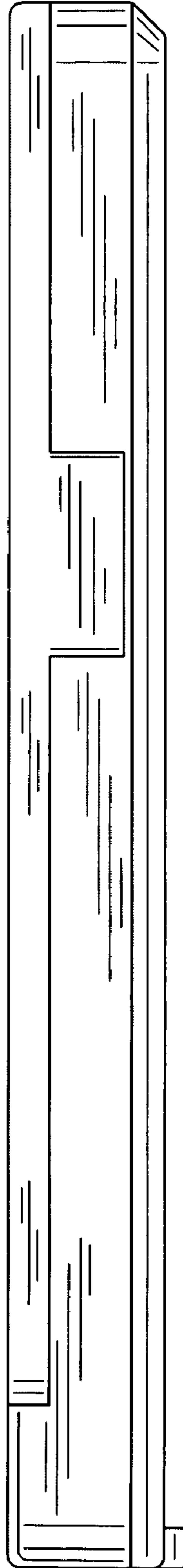

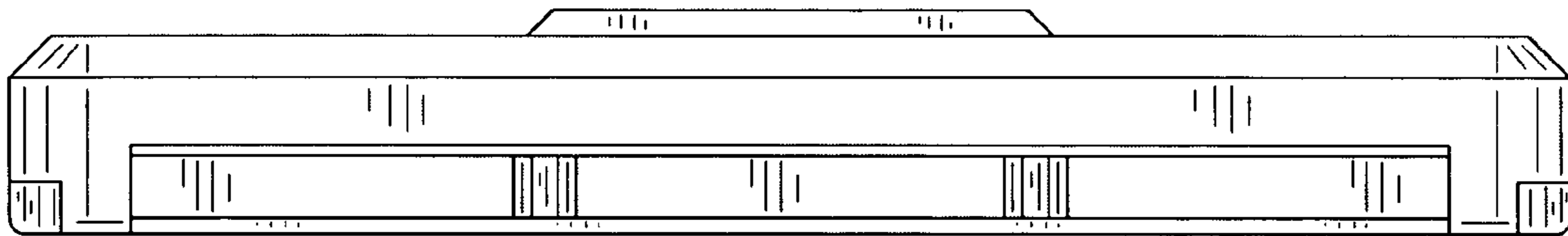

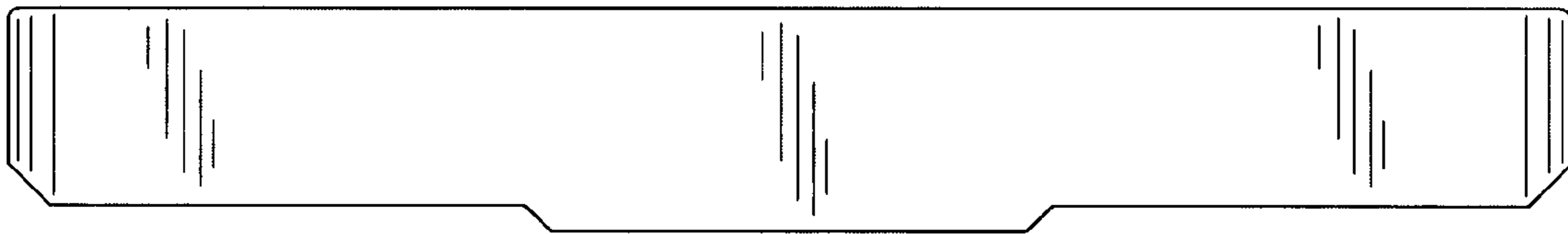

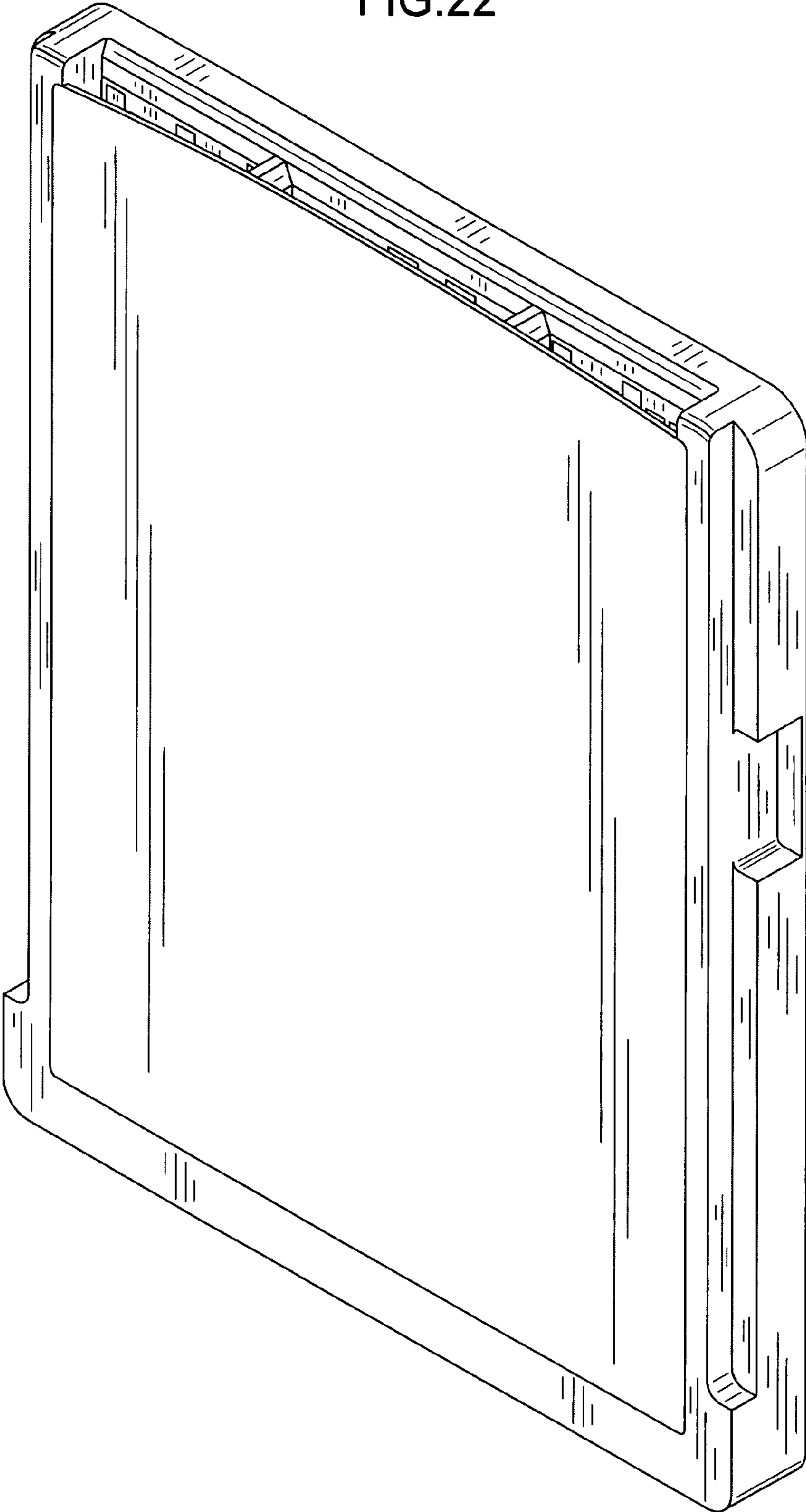

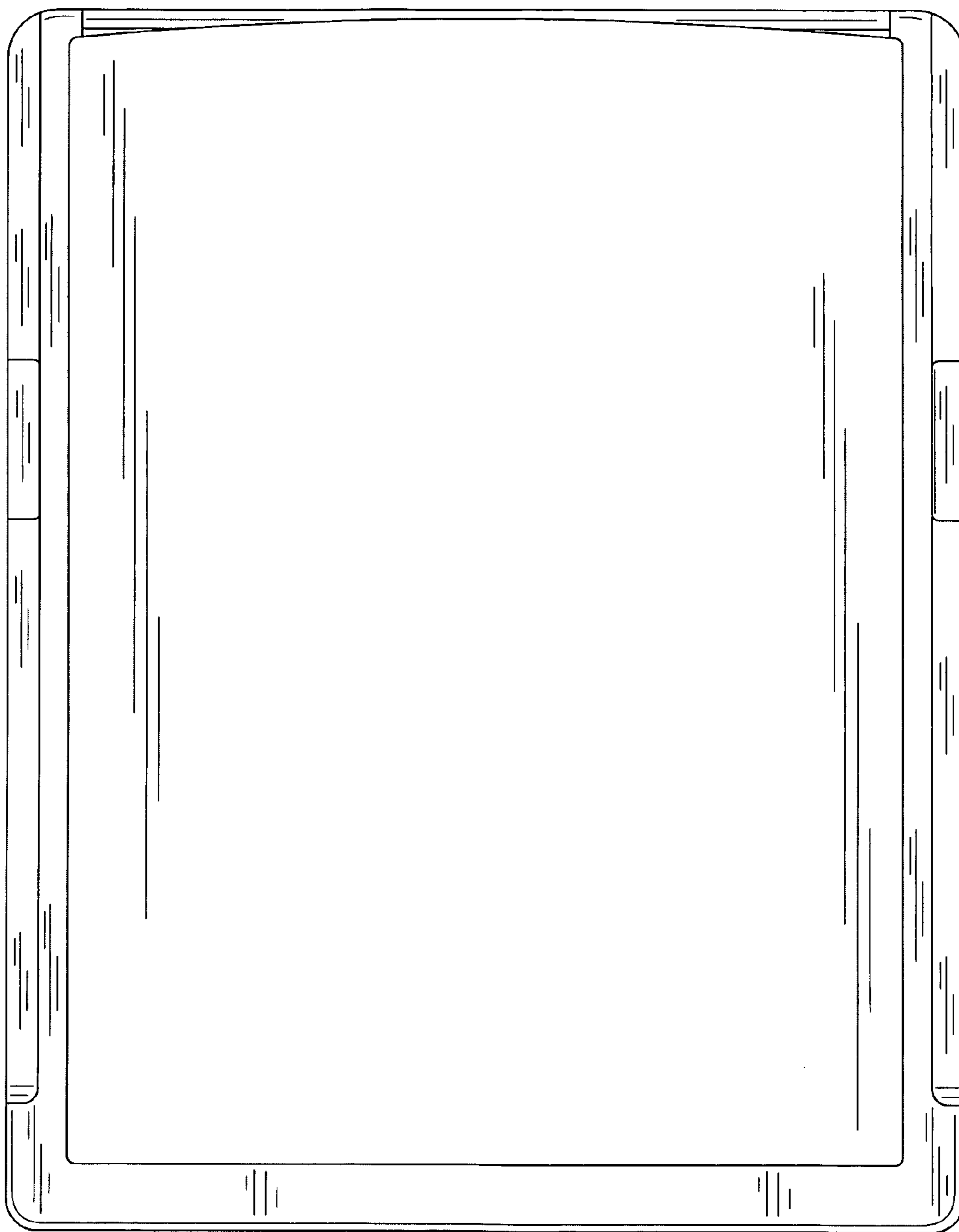

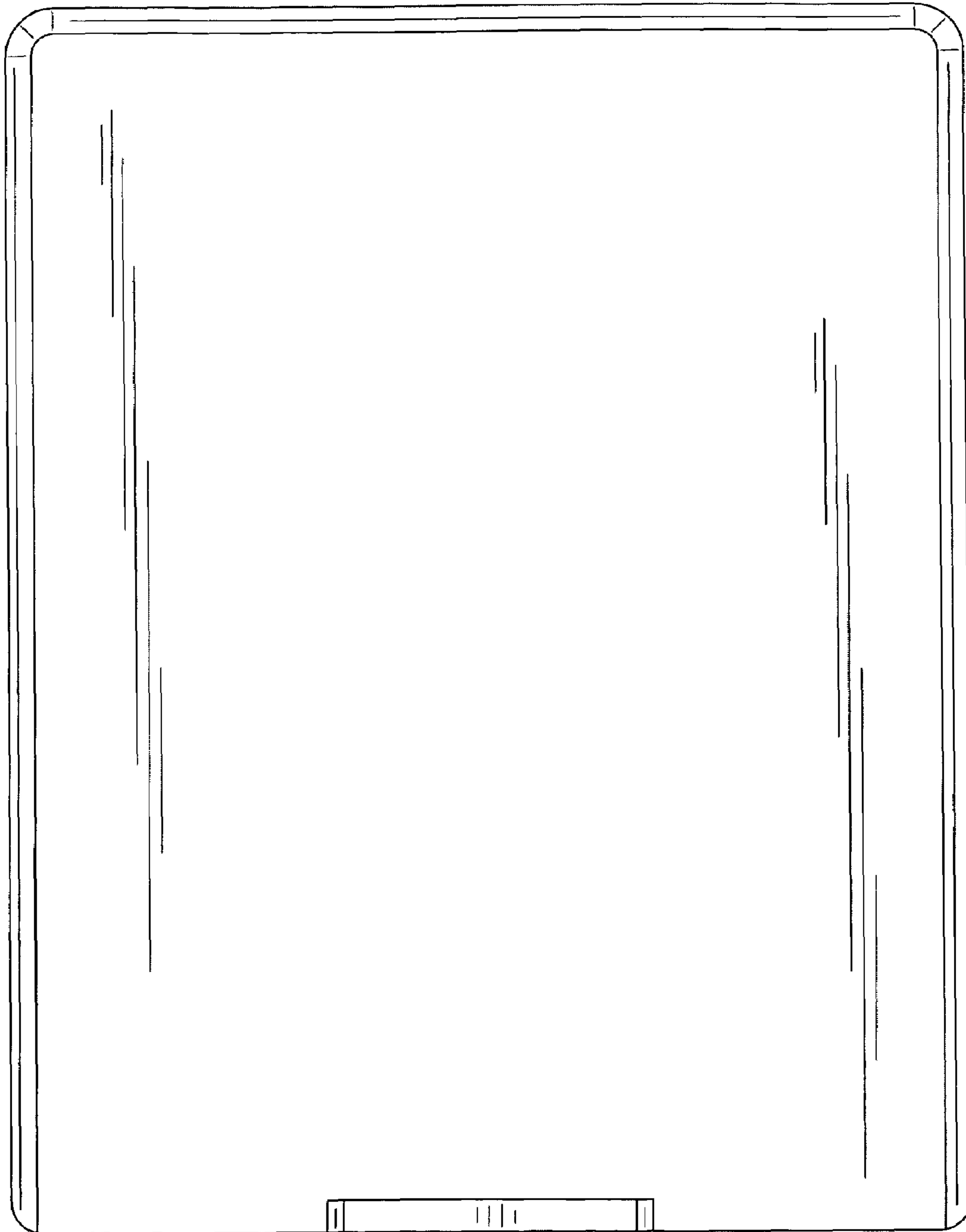

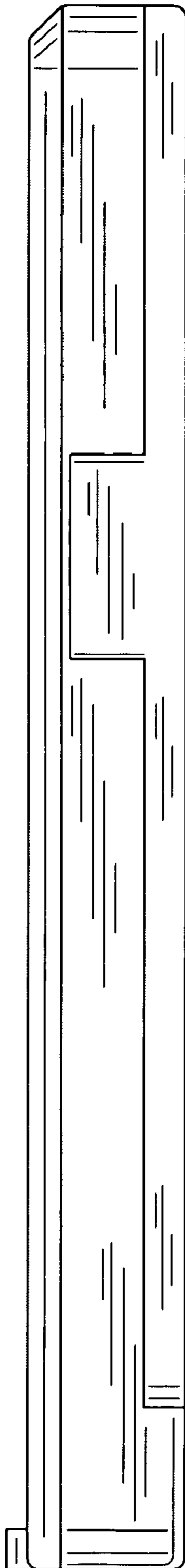

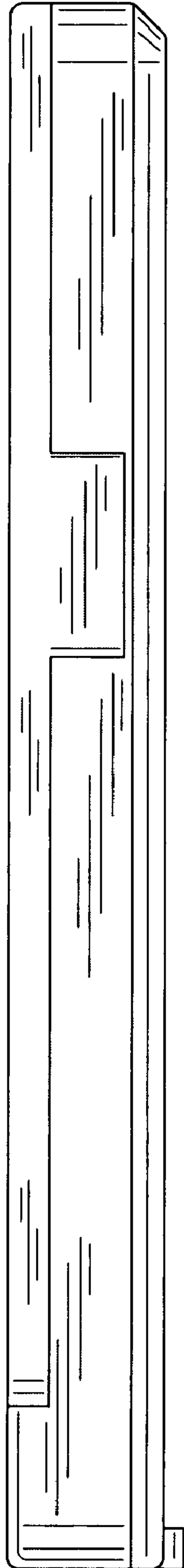

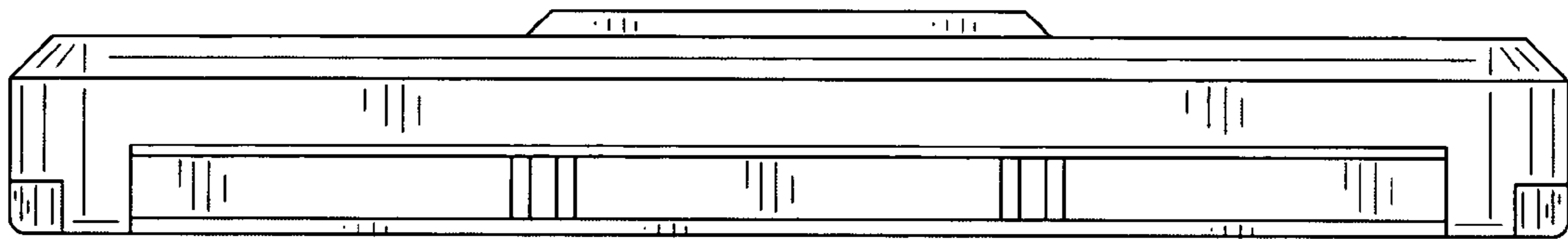
