The ornamental design for a distributor plate for a pressure vessel, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a distributor plate for a pressure vessel showing our new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 4 is a right side view thereof, the left side being a mirror image thereof;

FIG. 6 is a bottom view thereof.

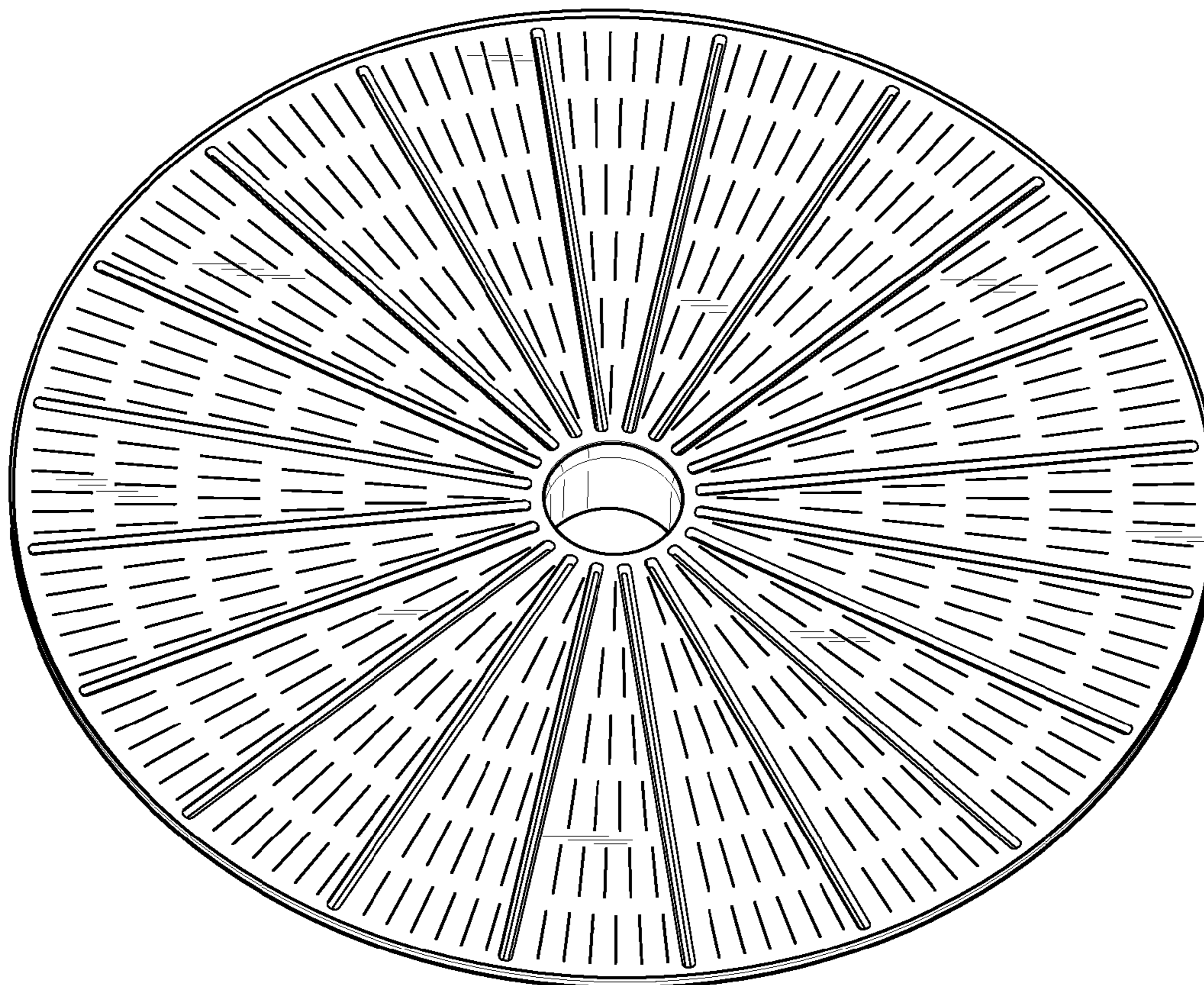

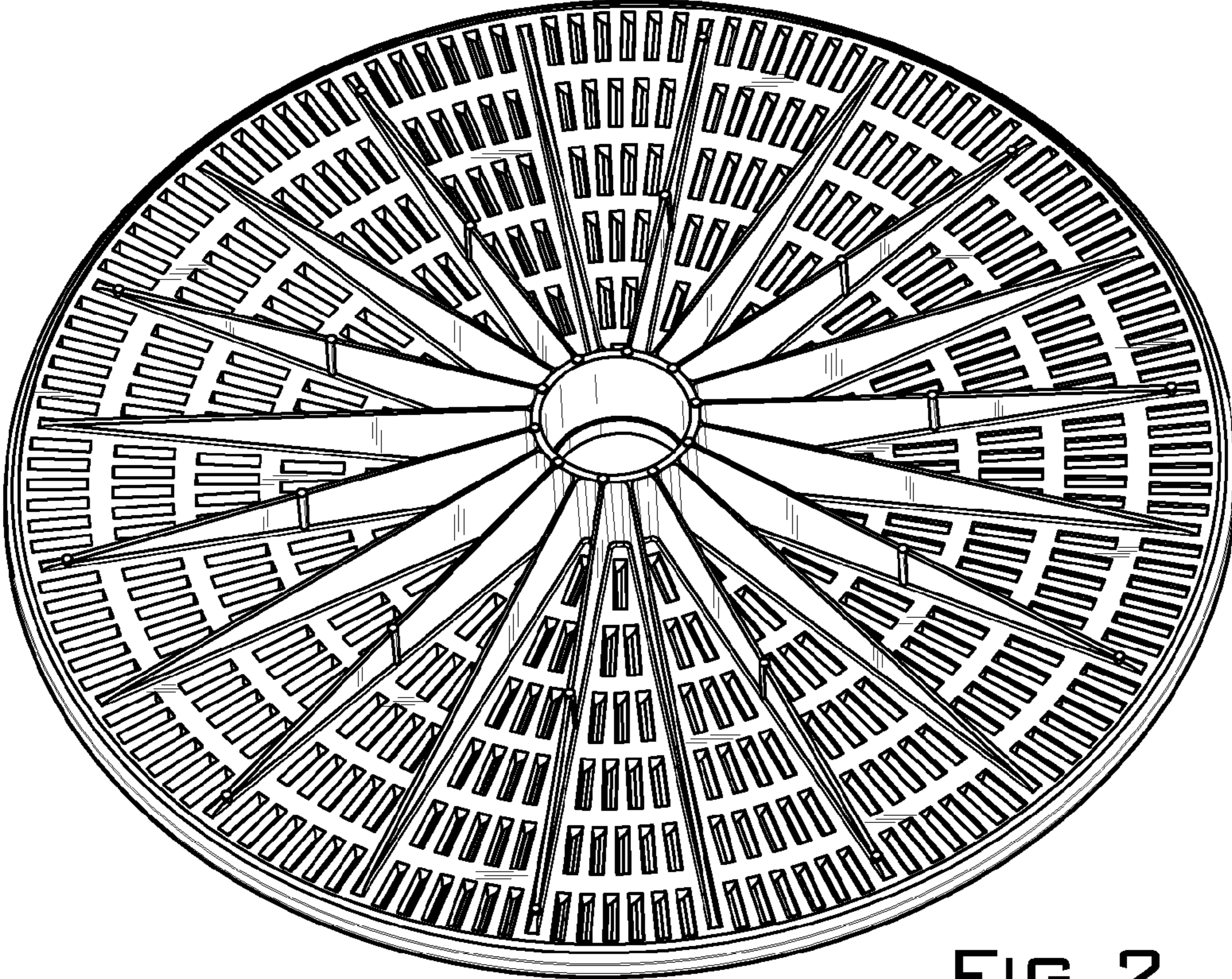
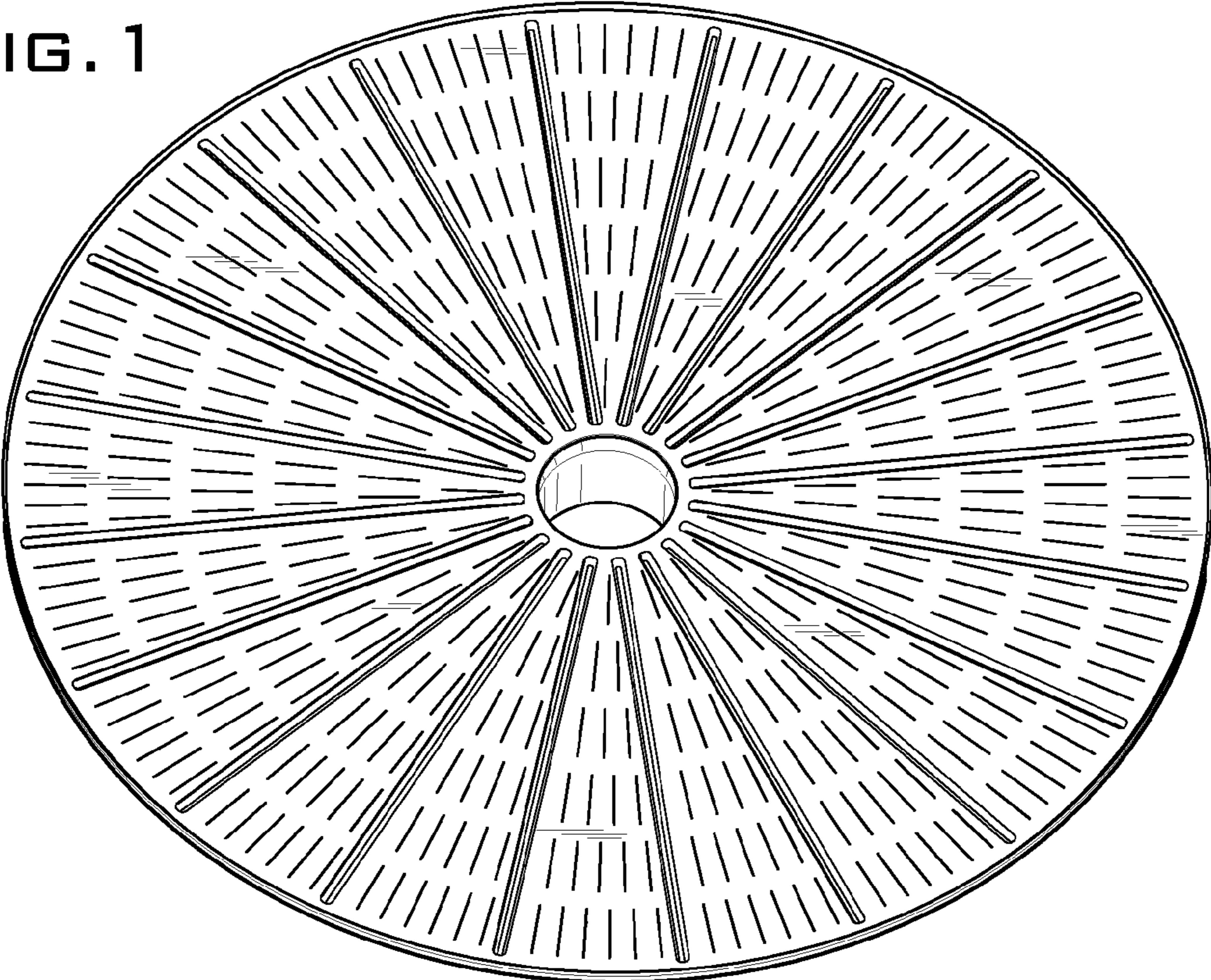

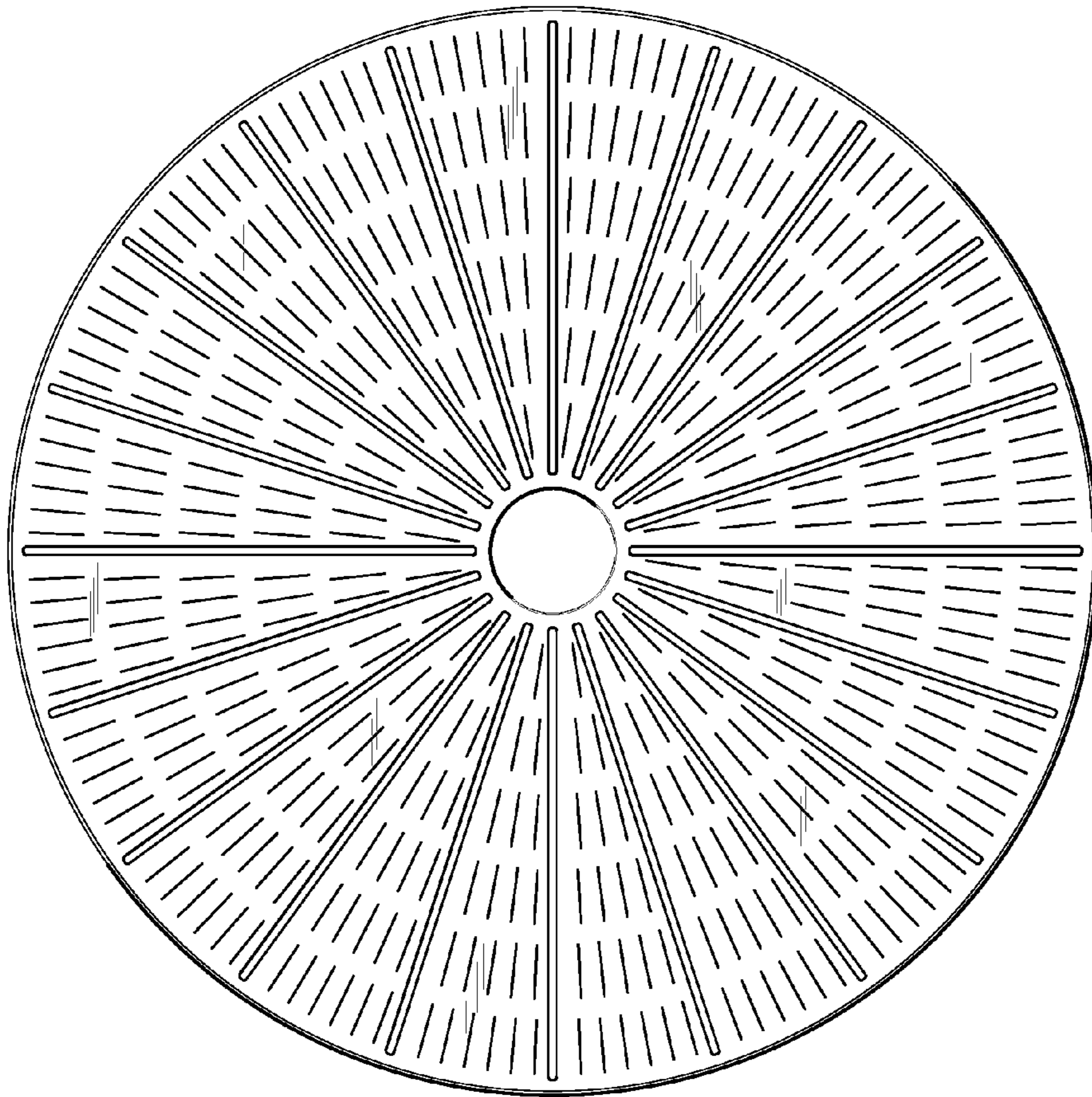

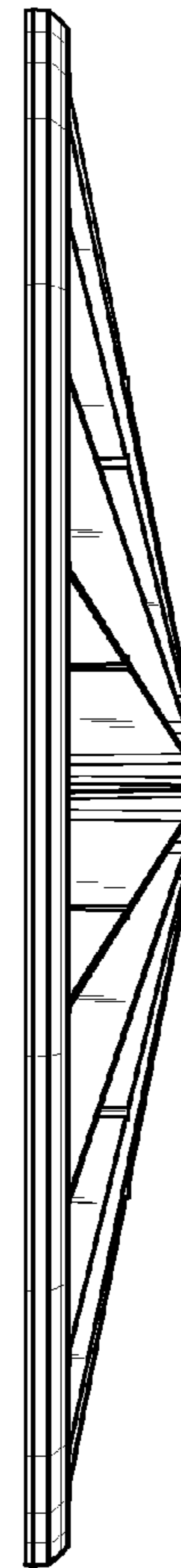

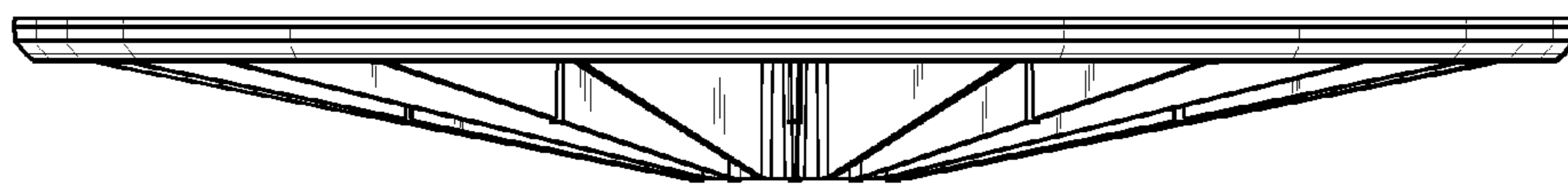

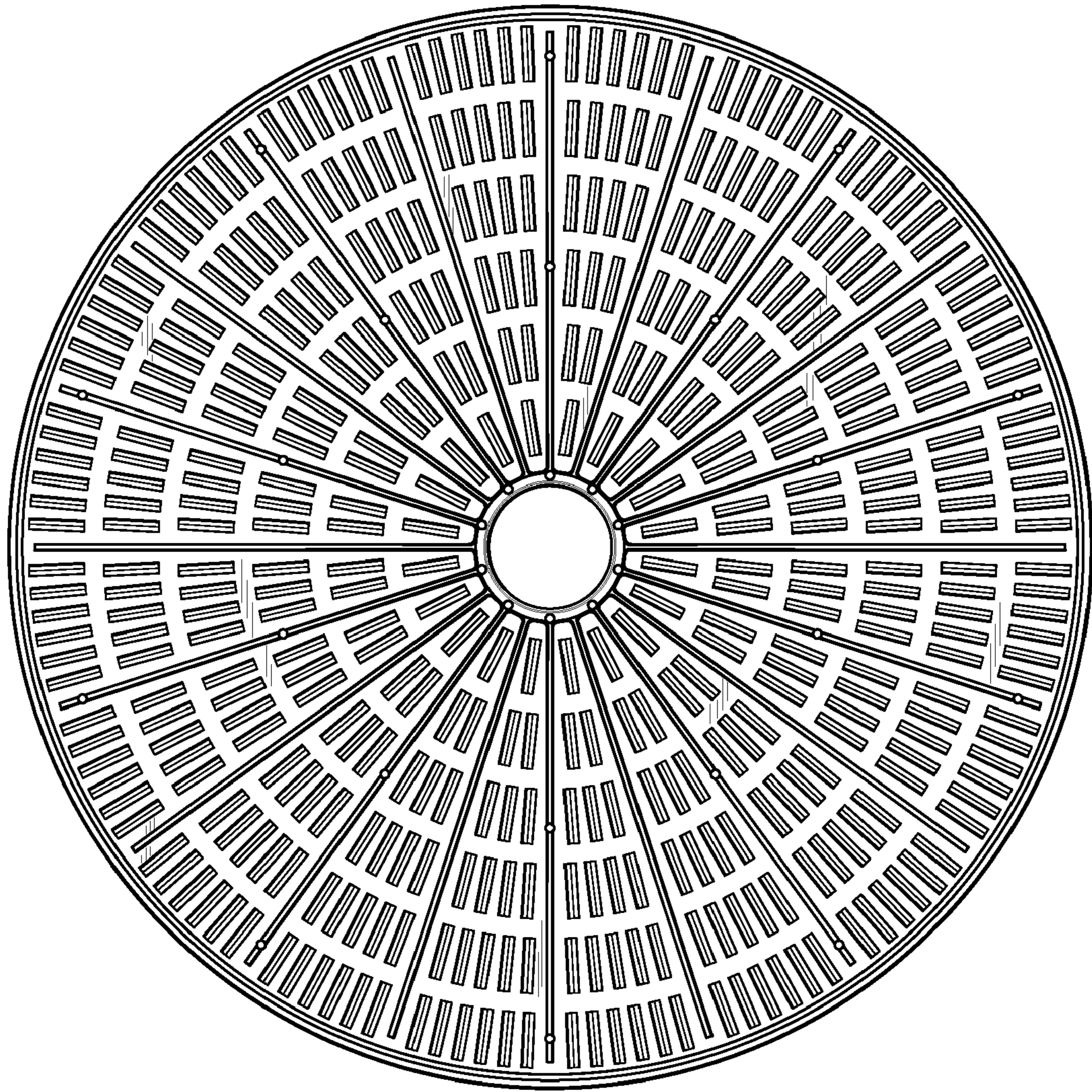
