The ornamental design for a candle holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the candle holder according to my new design;

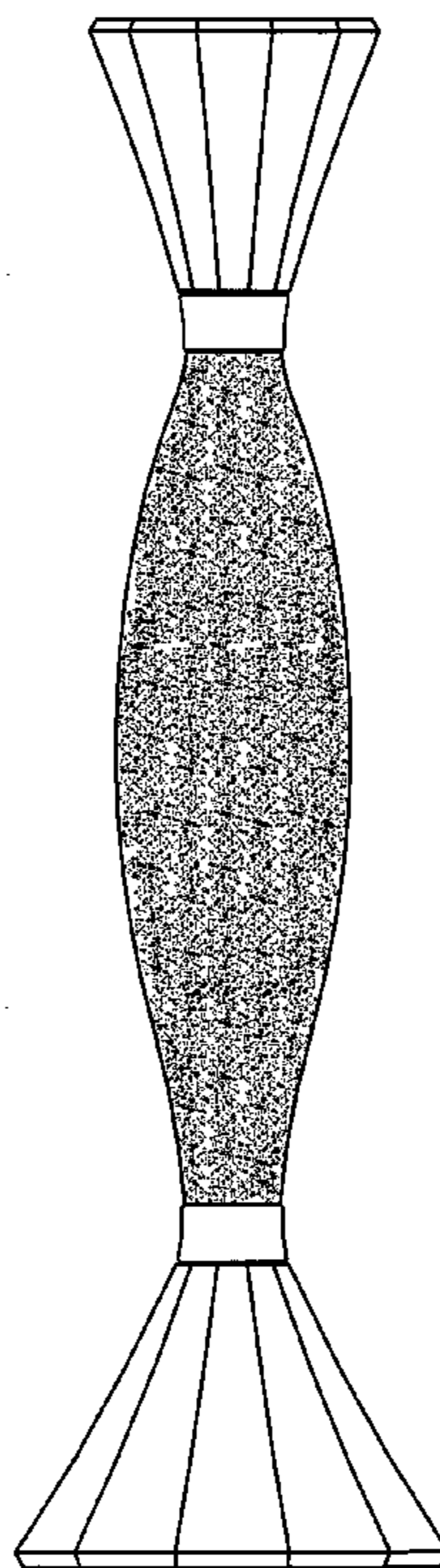

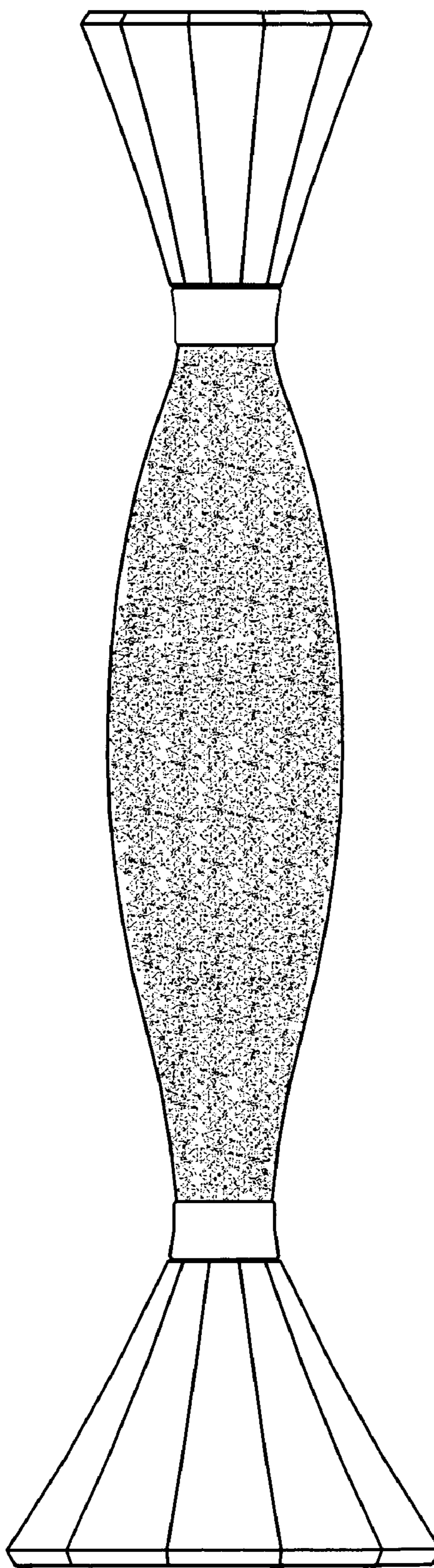

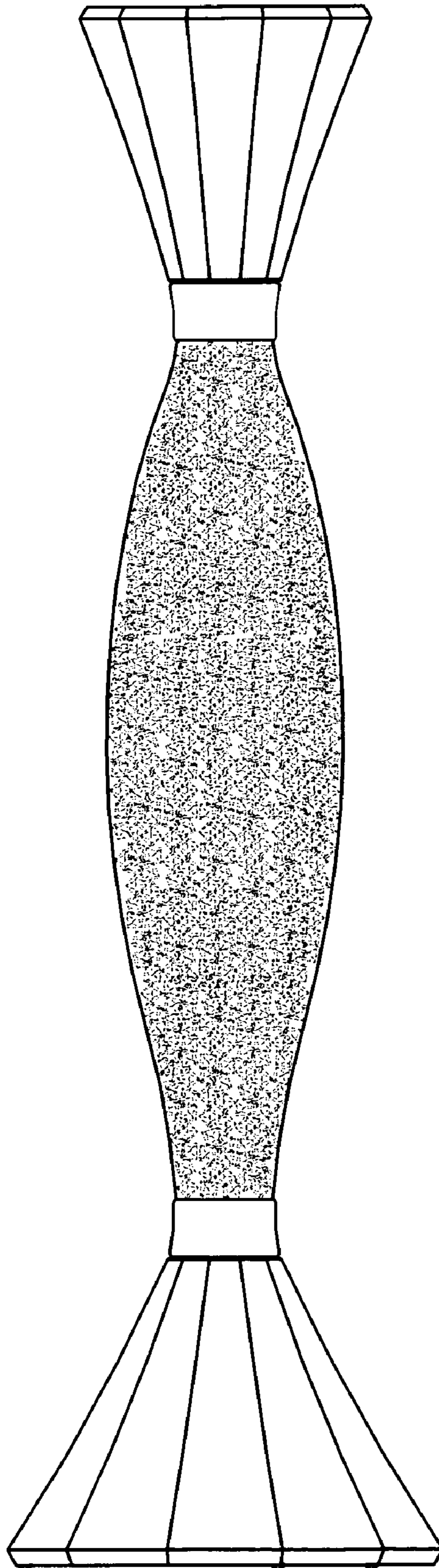

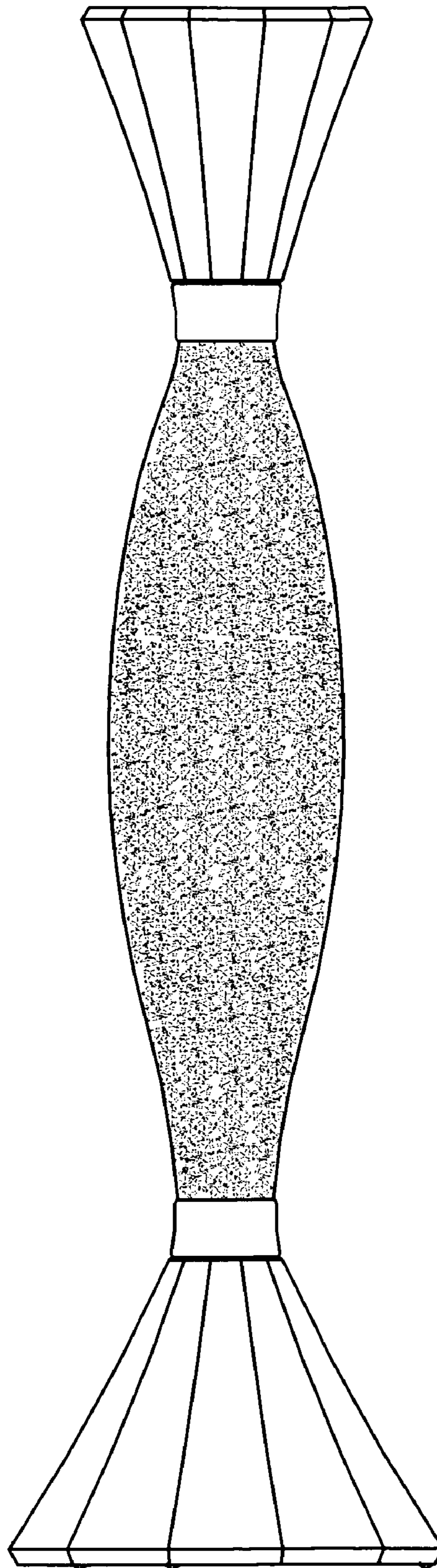

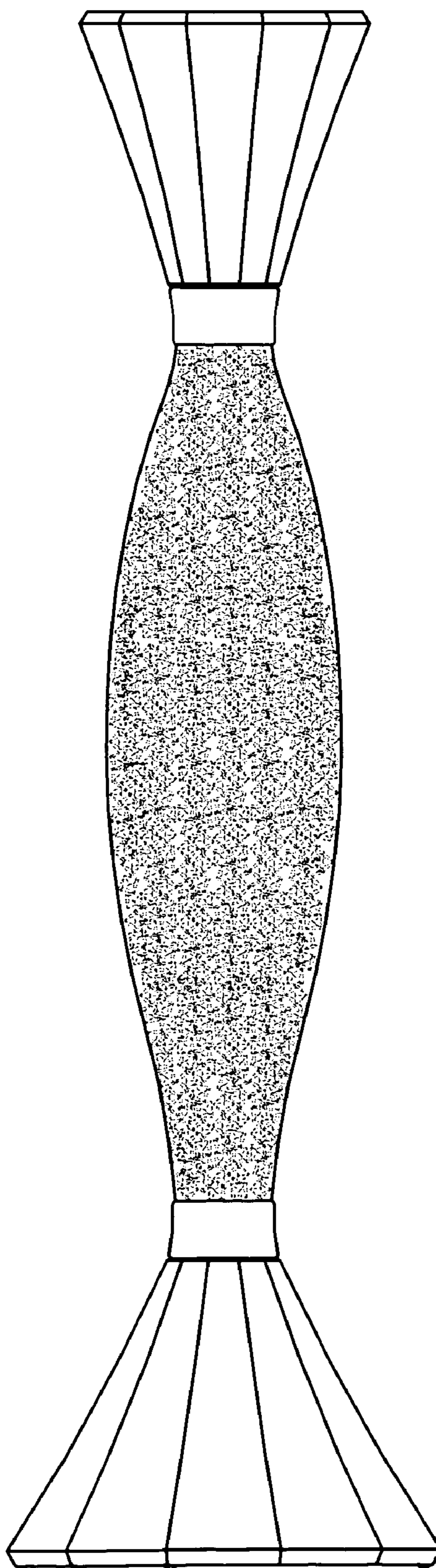

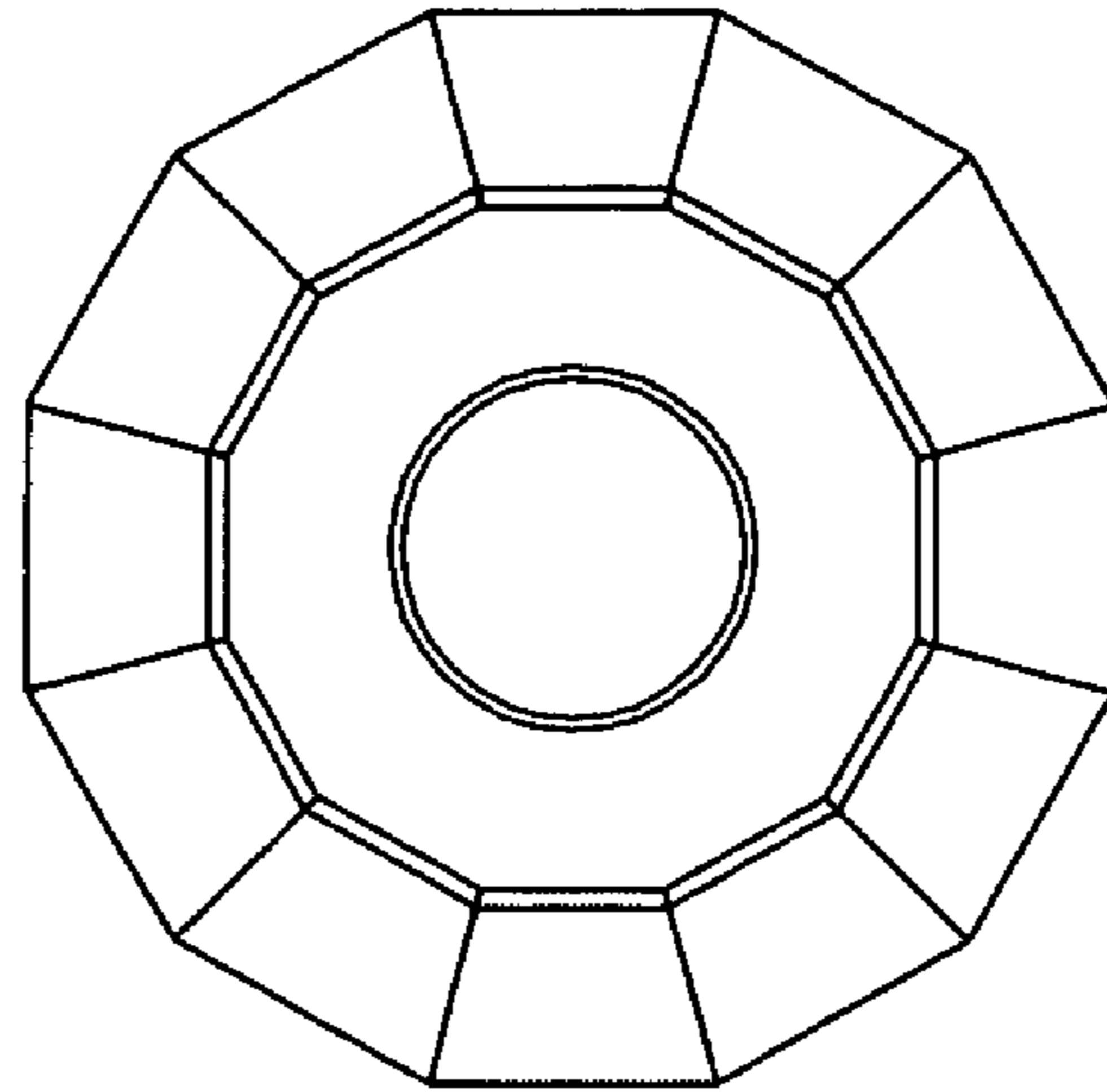

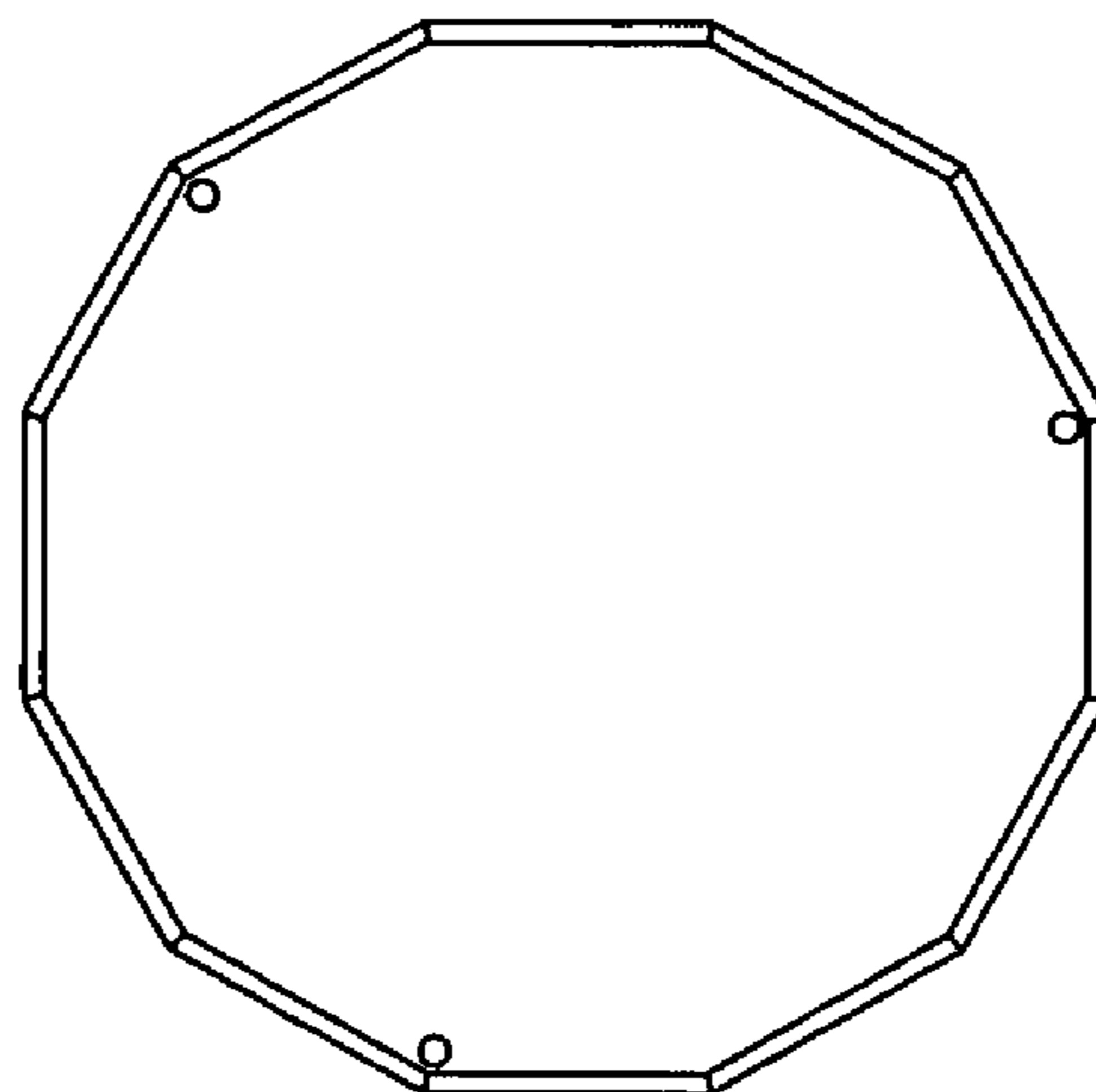
