The ornamental design for a lamp head for LED streetlight, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of the lamp head for LED streetlight showing the new design;

FIG. 5 is a rear elevational view thereof;

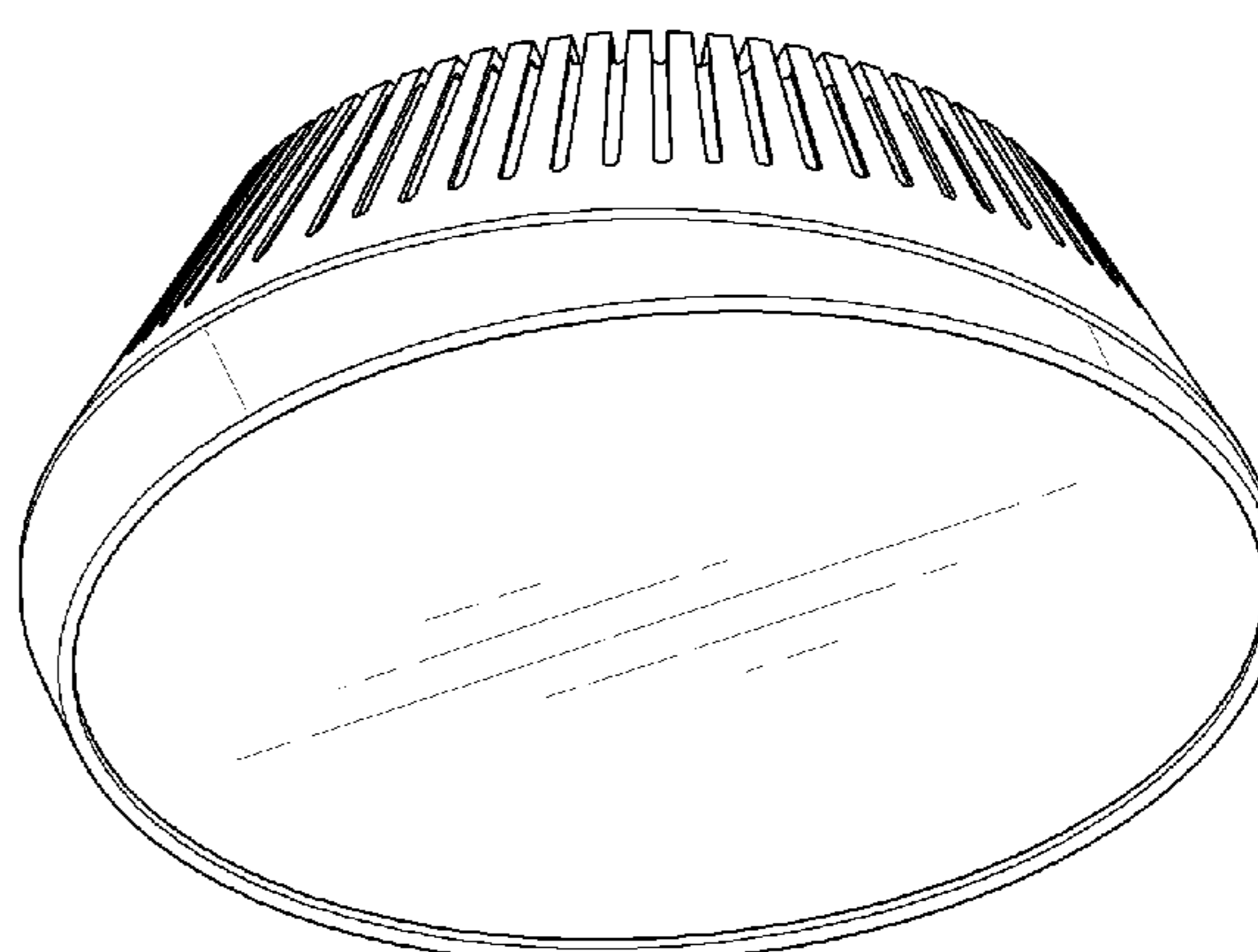
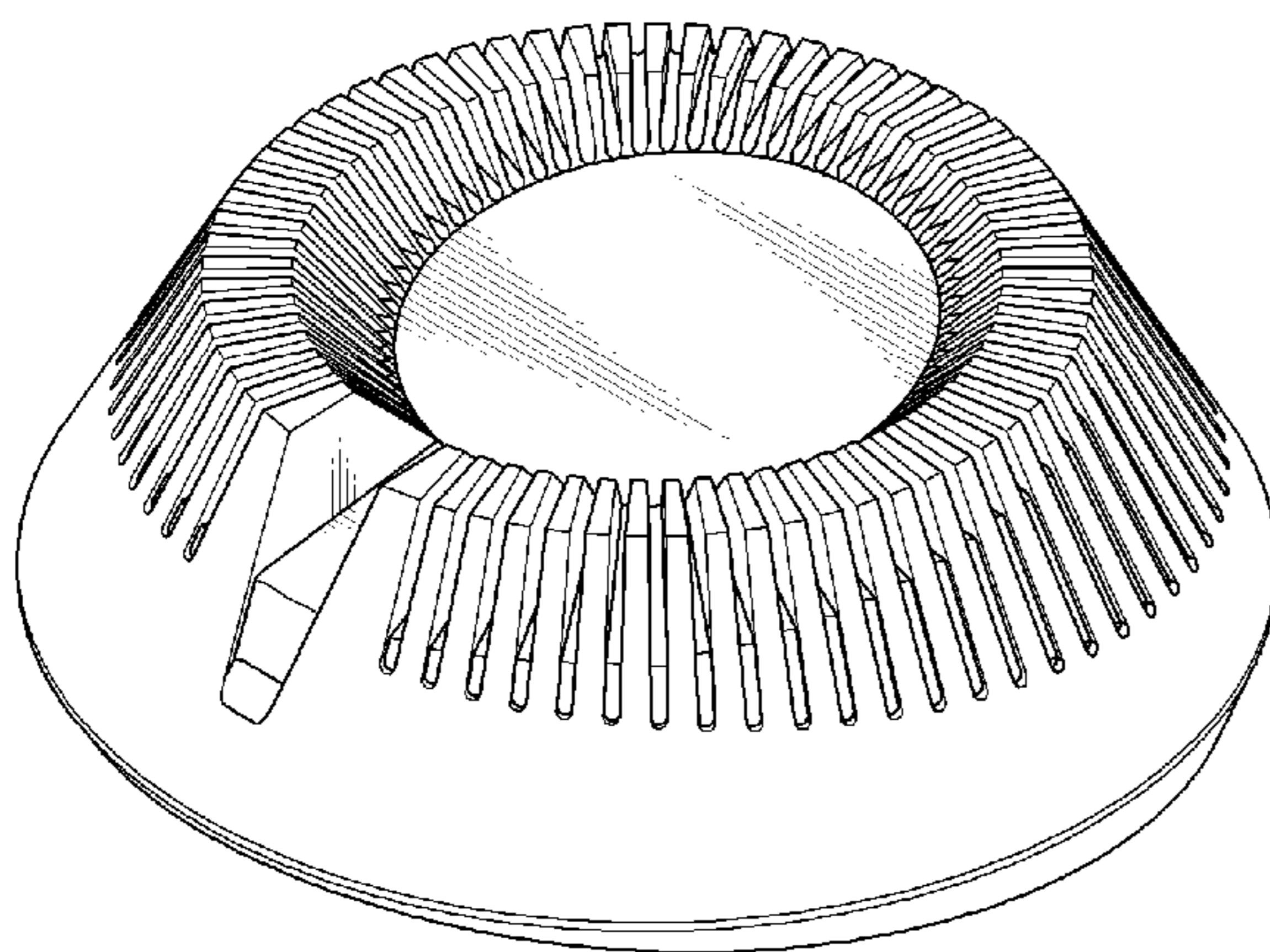
FIG. 6 is a bottom, rear perspective view thereof;

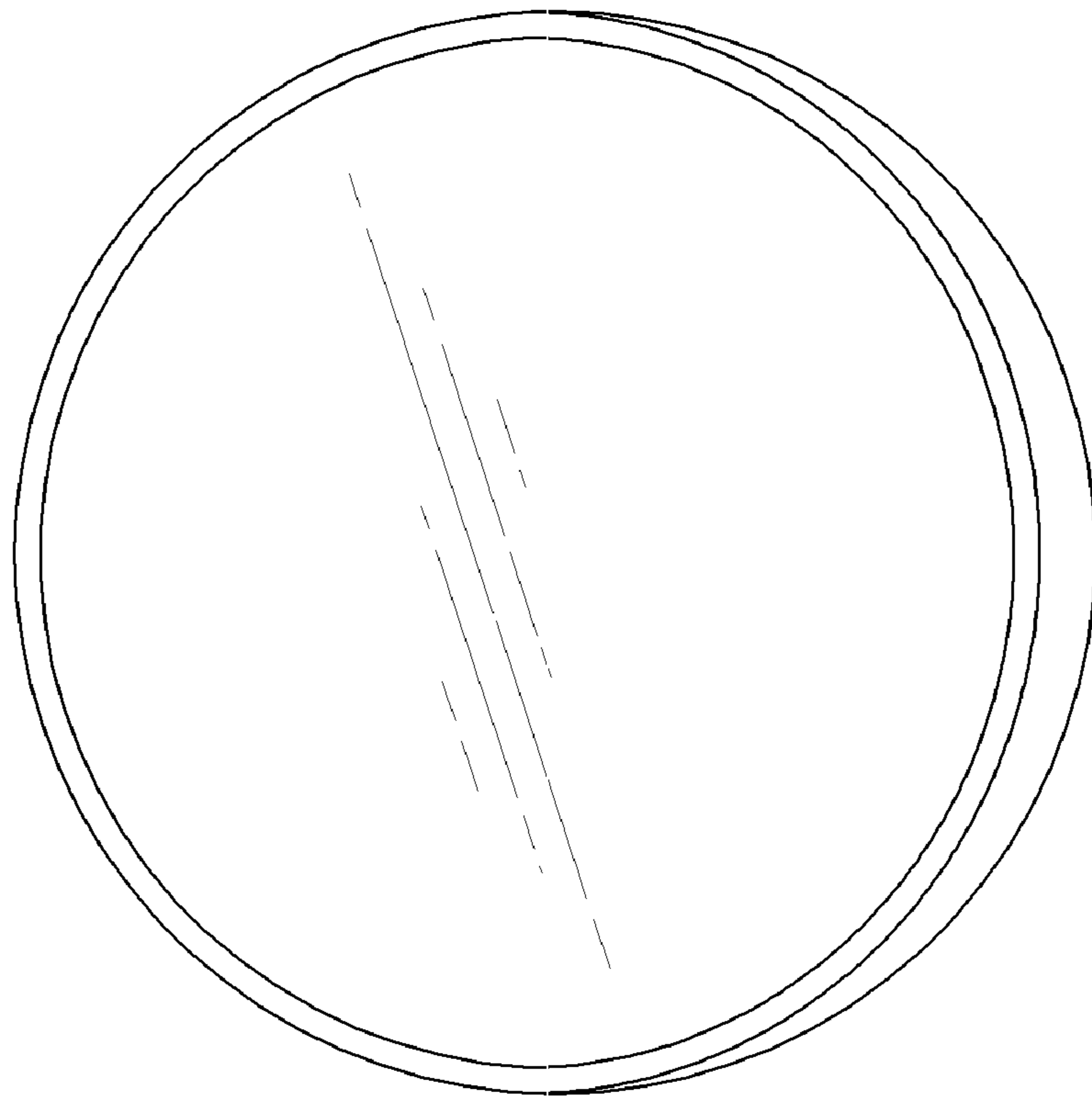

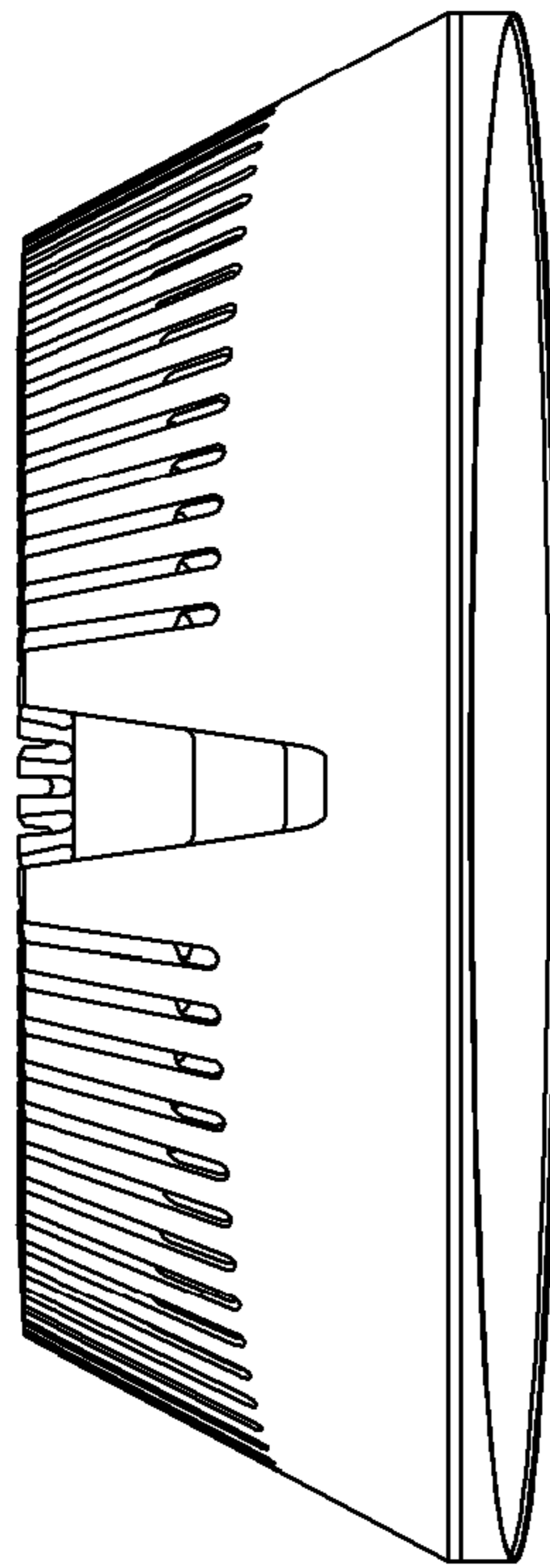

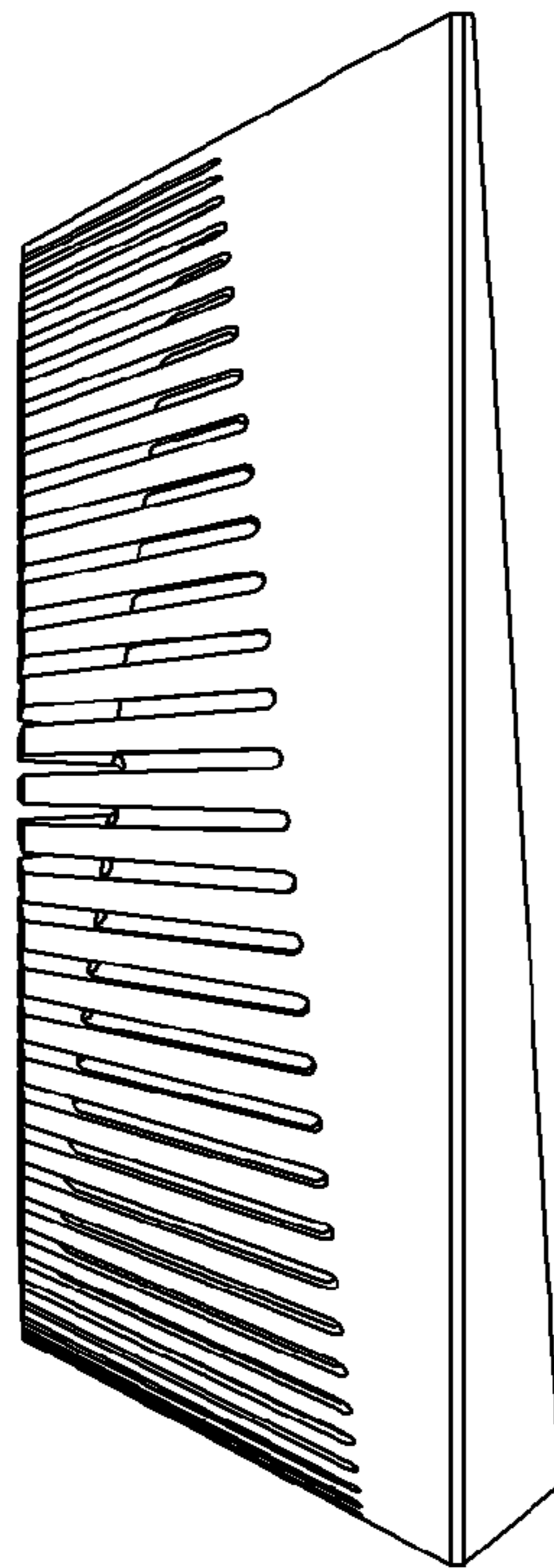

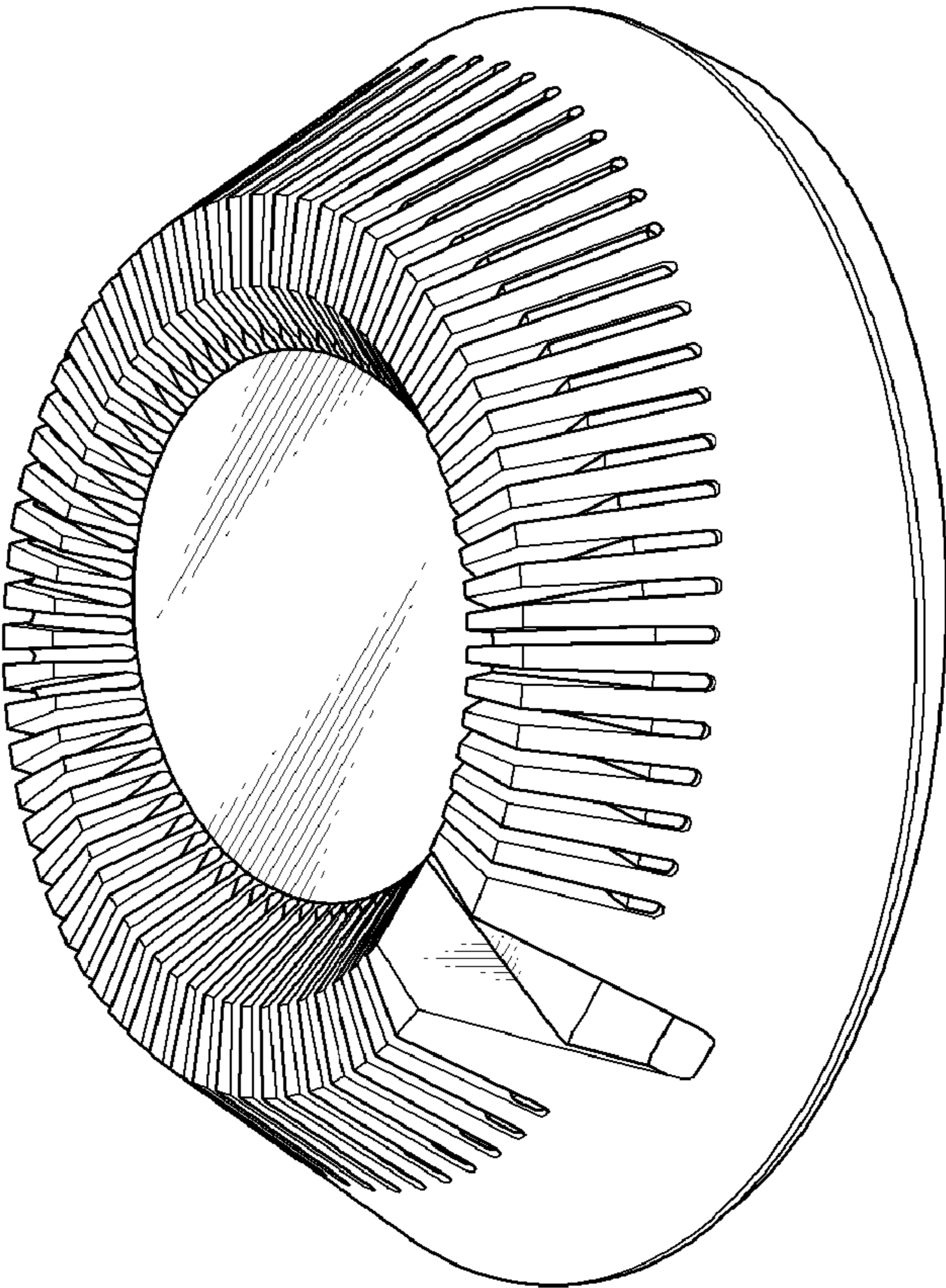

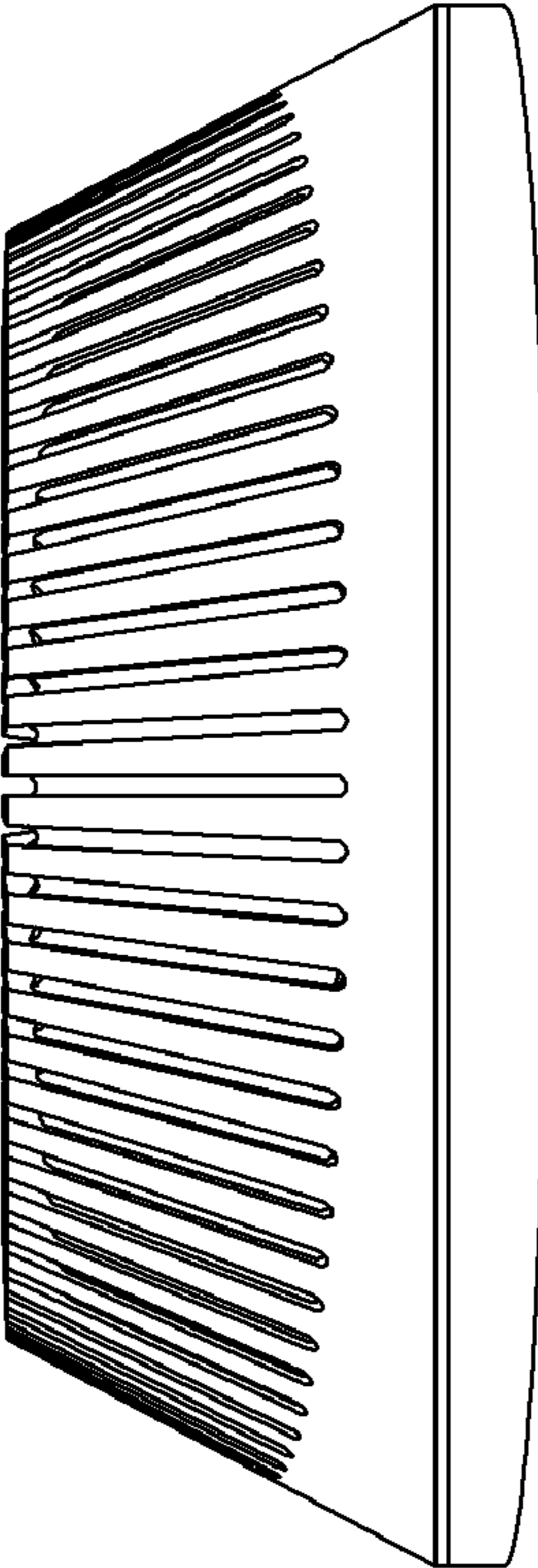

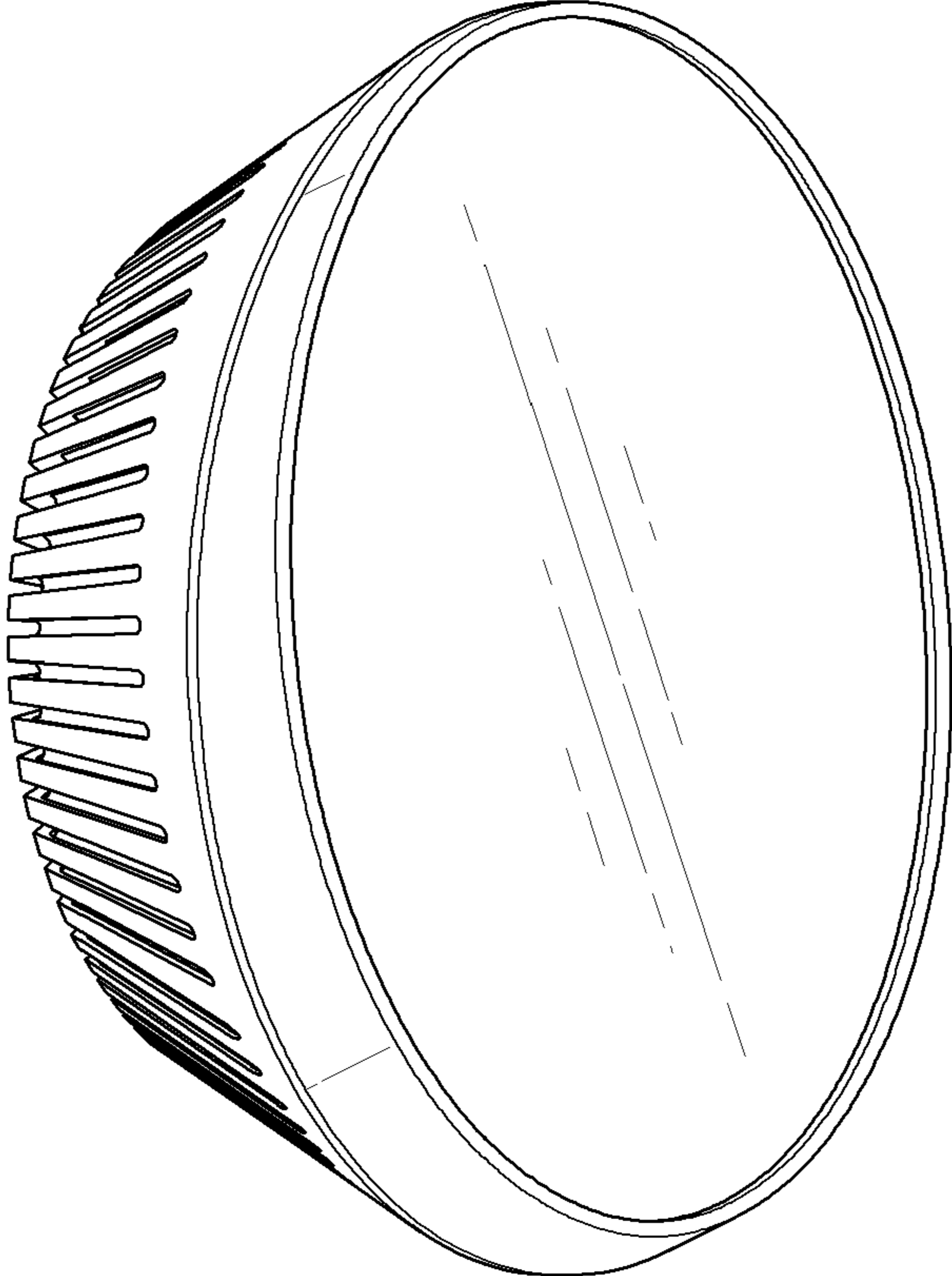

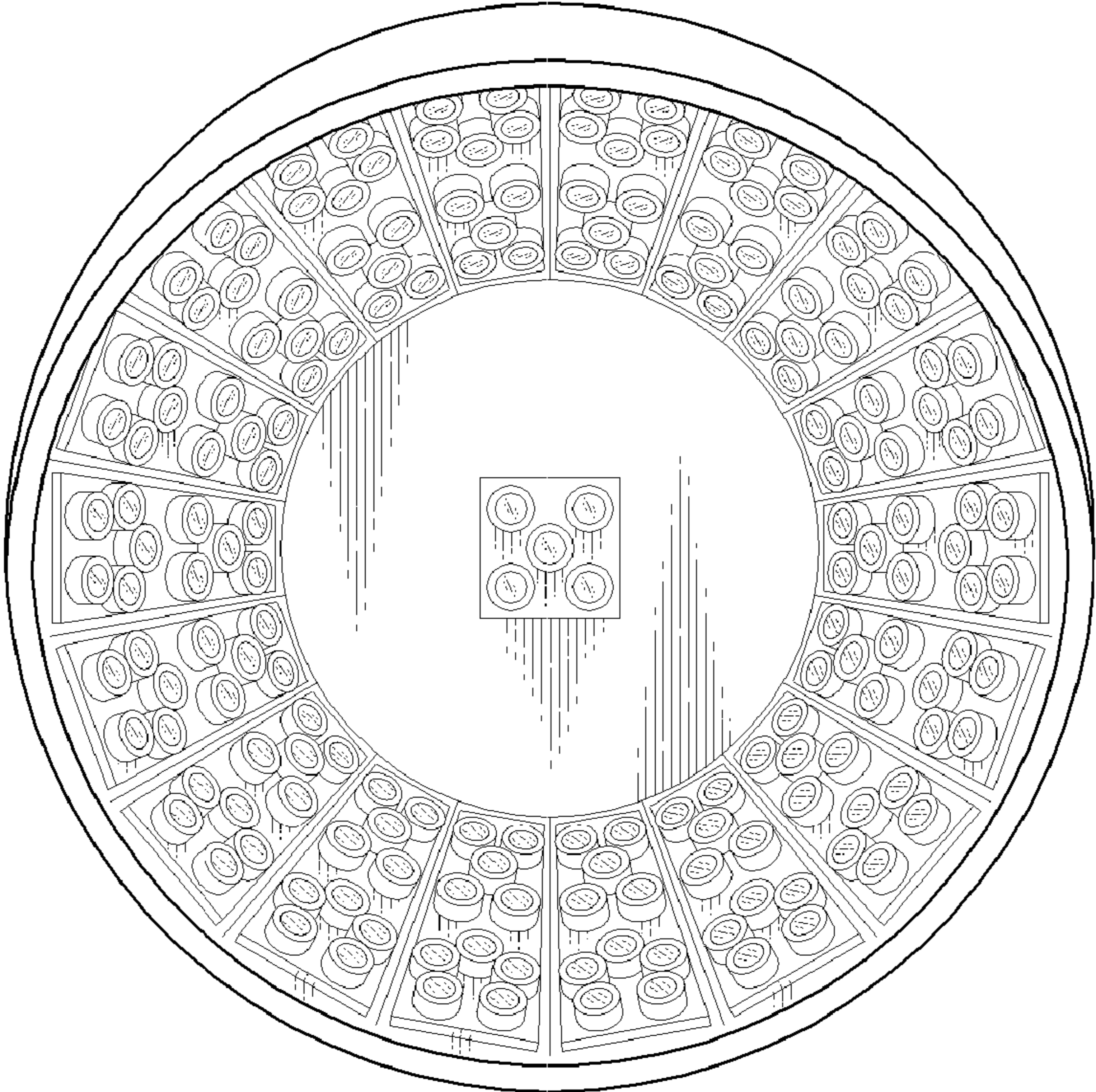

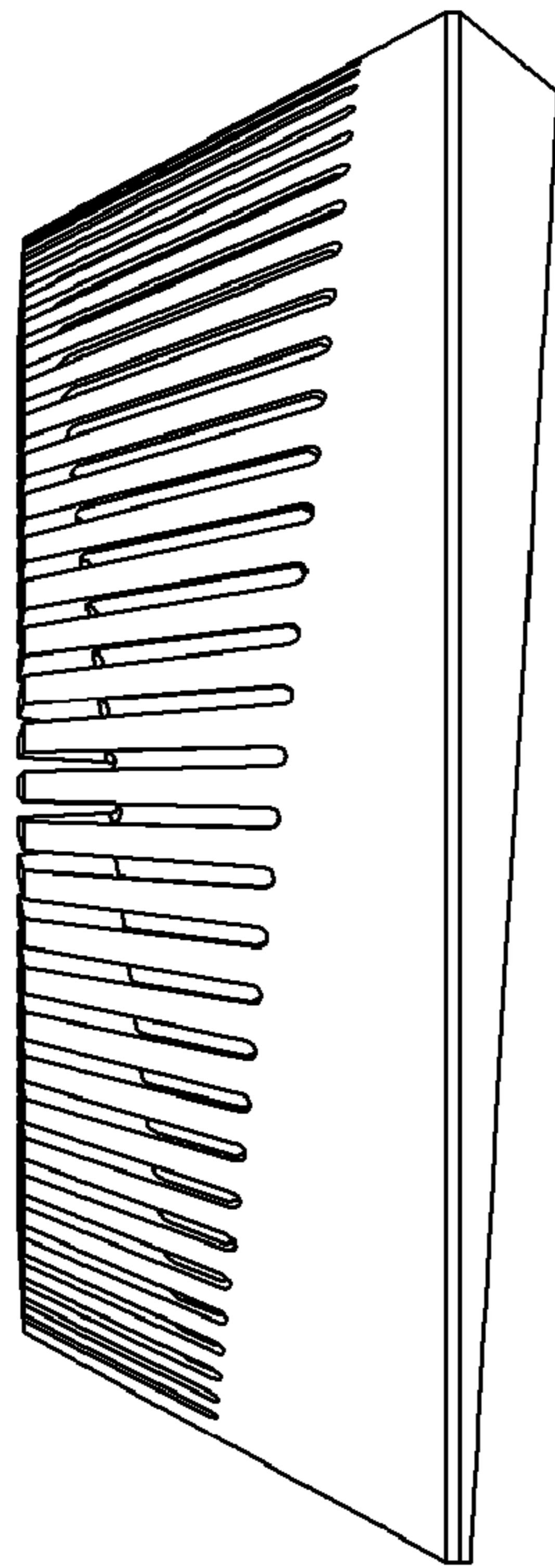

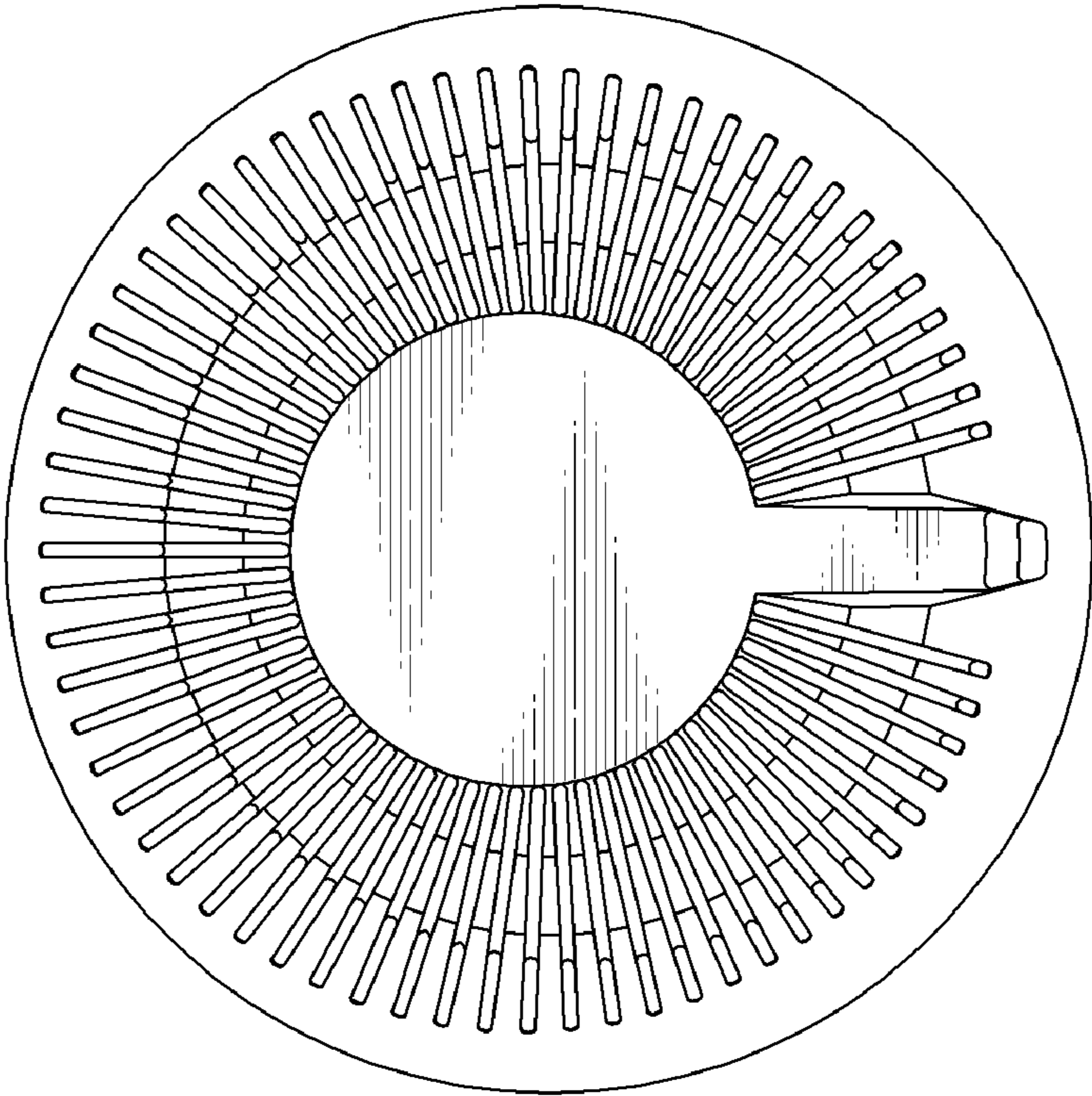
