DESCRIPTION

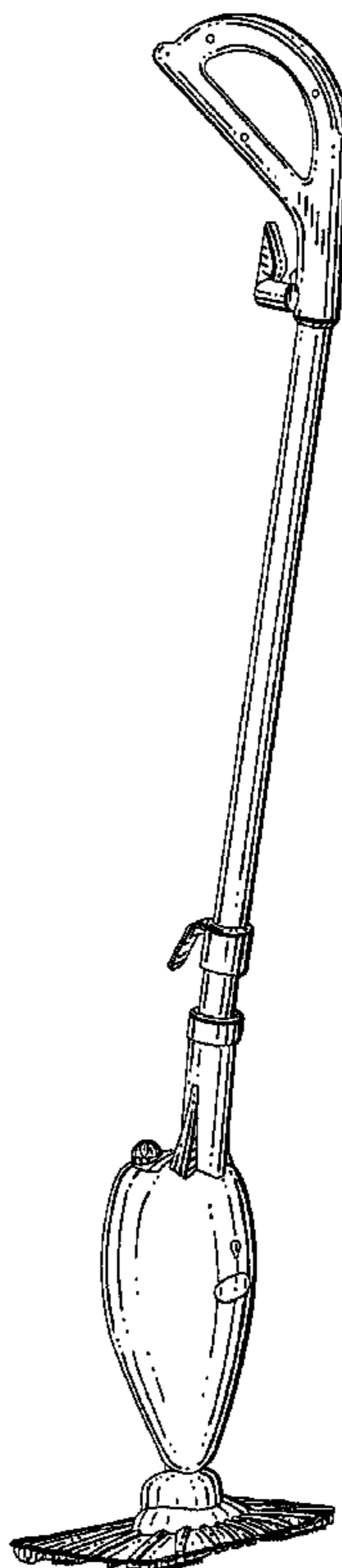

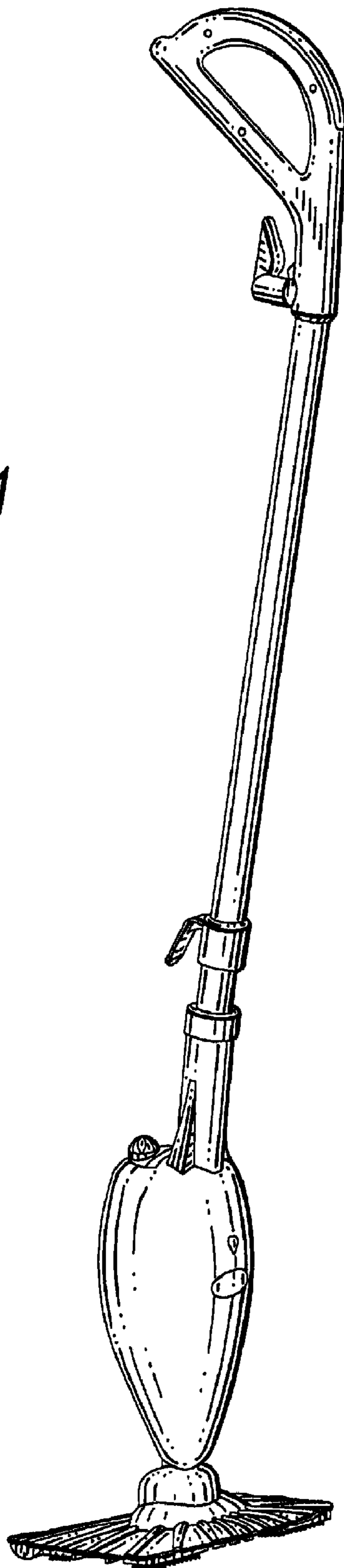
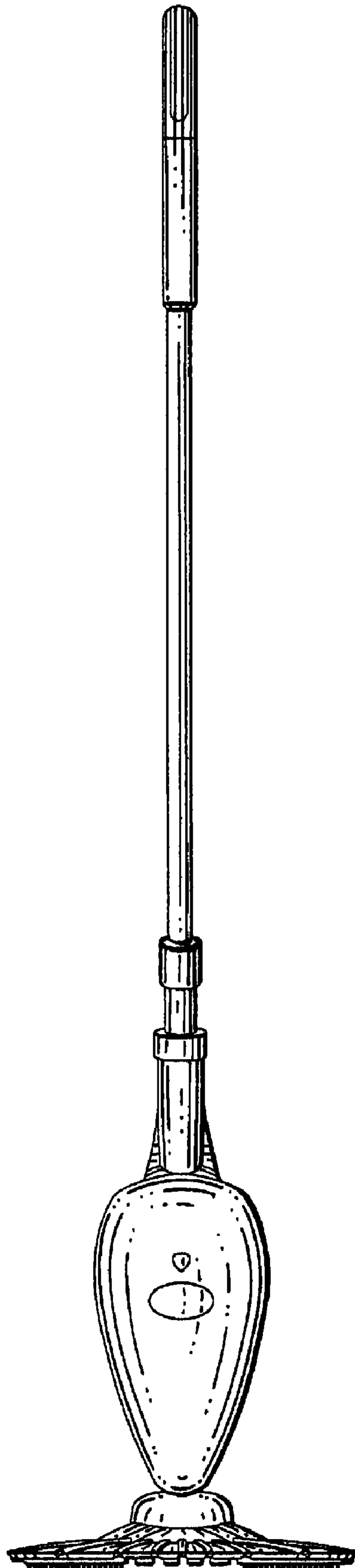

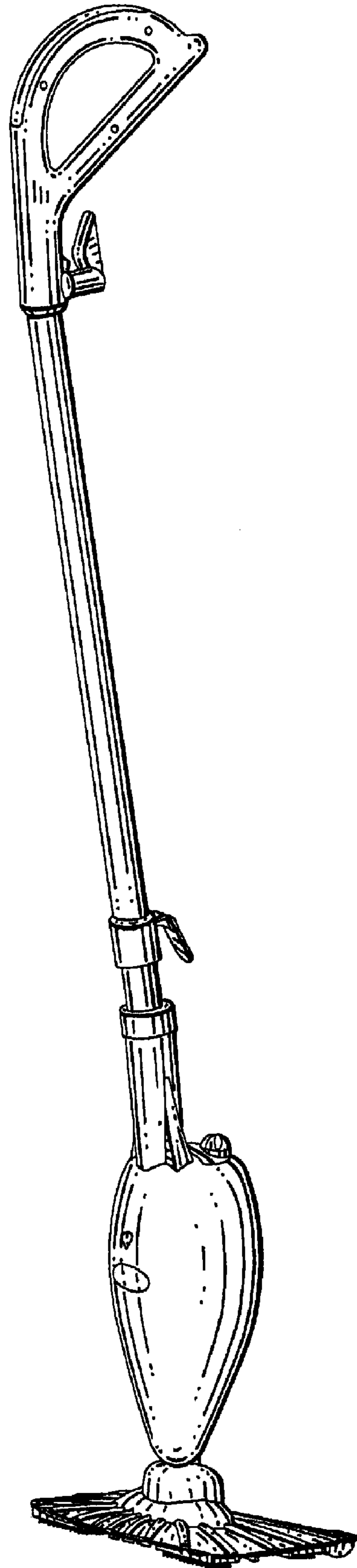

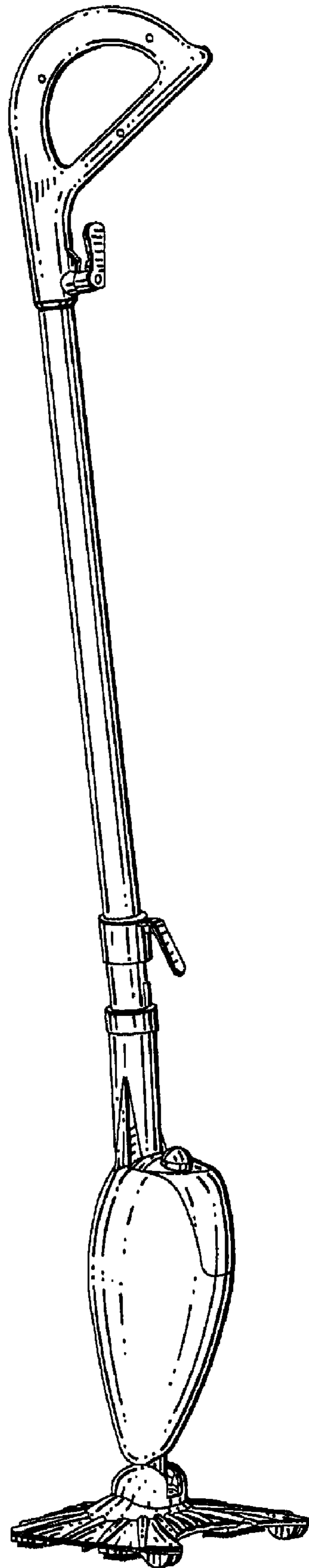

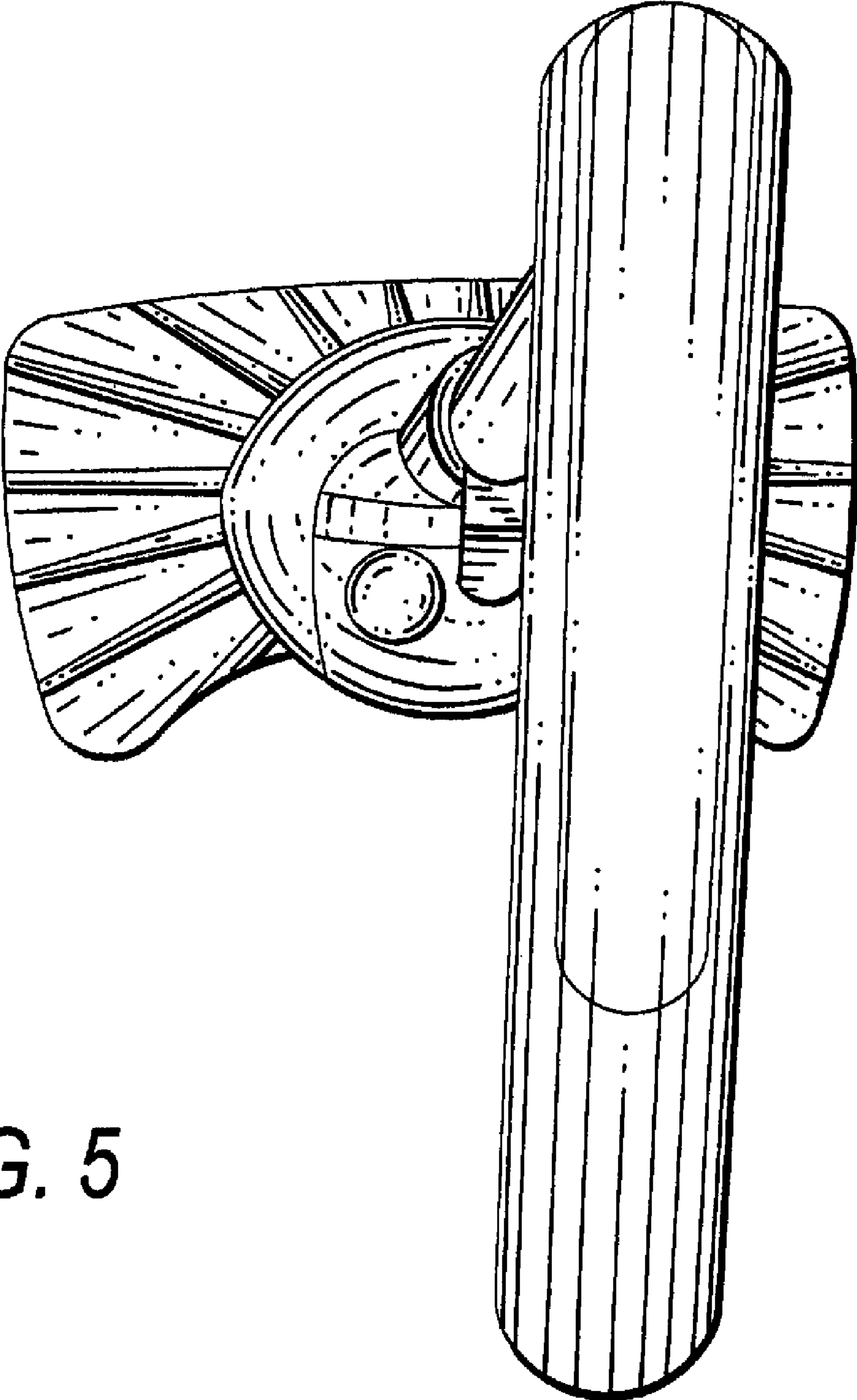

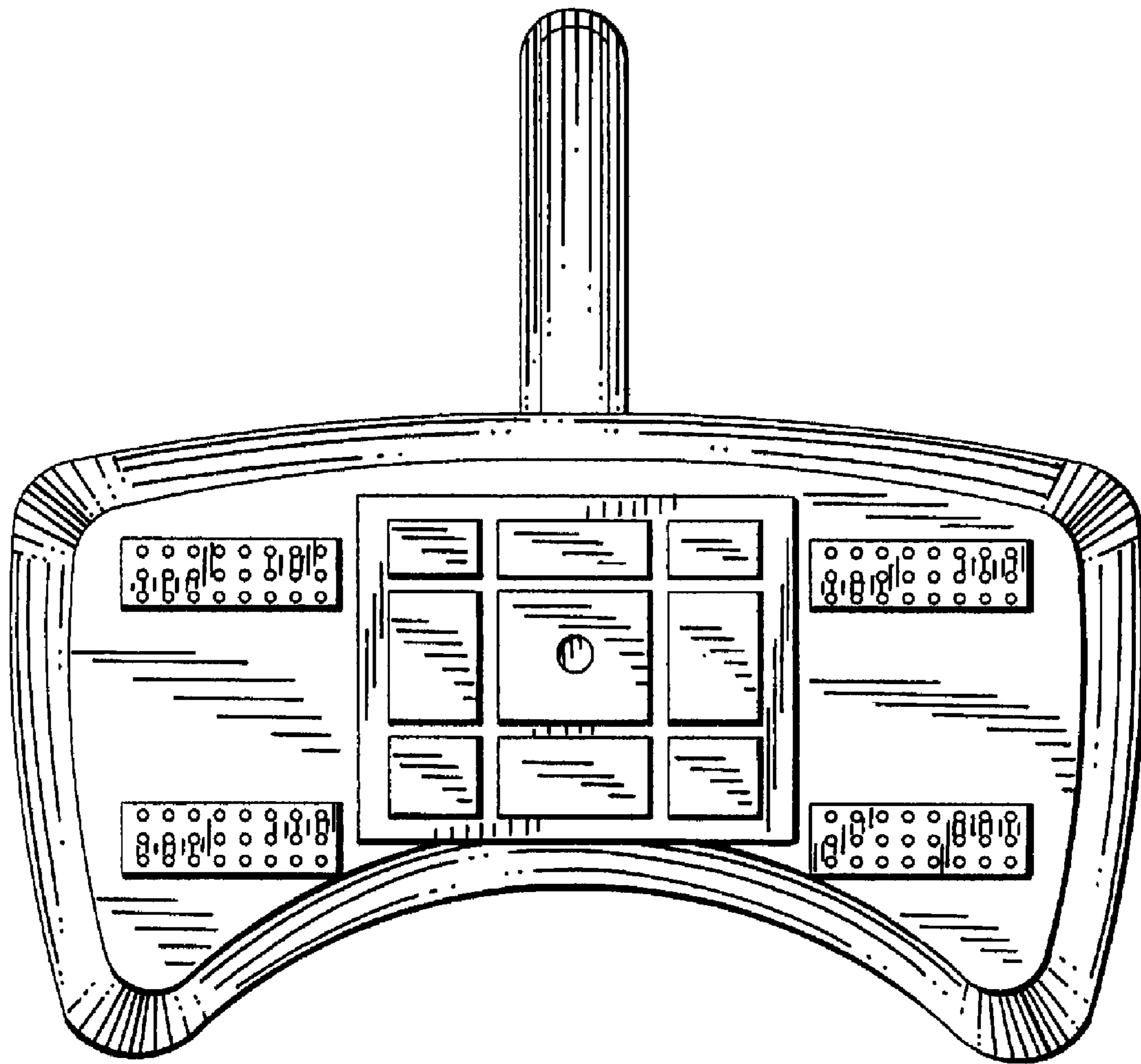
