FIG. 2 is a side view of an embodiment of the bag shown in FIG. 1.

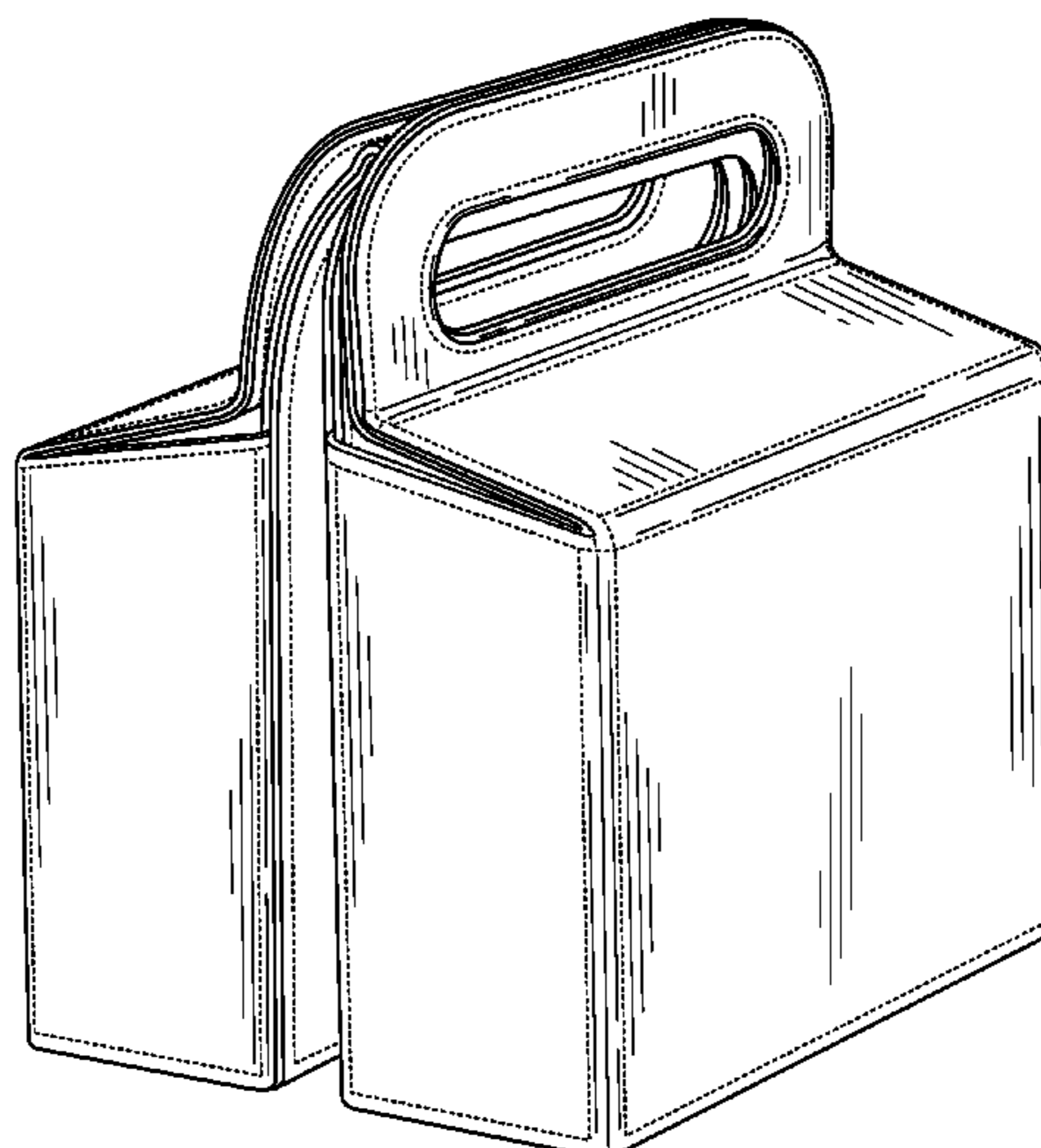
FIG. 3 is a front view of the embodiment of the bag shown in FIG. 1.

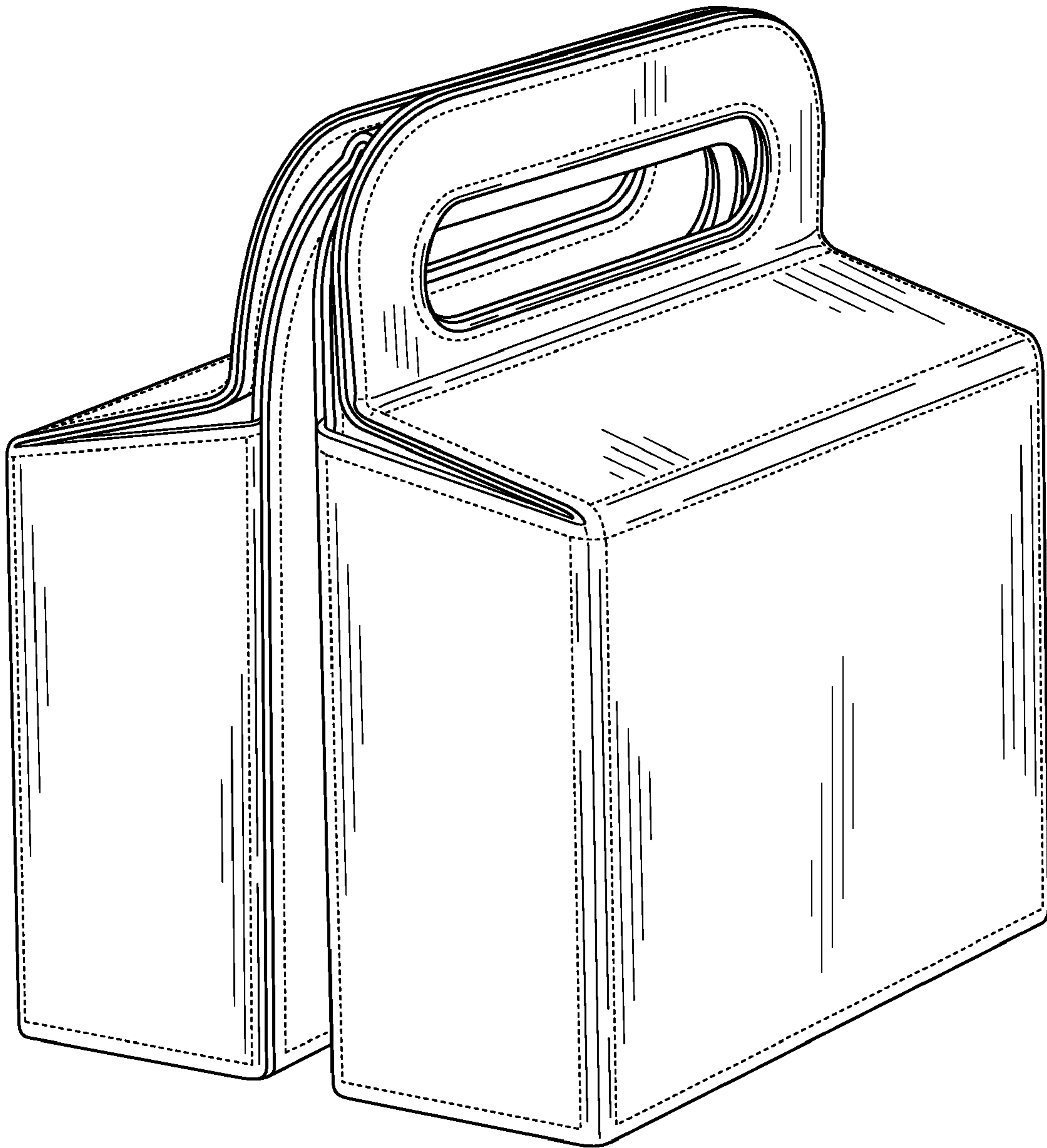

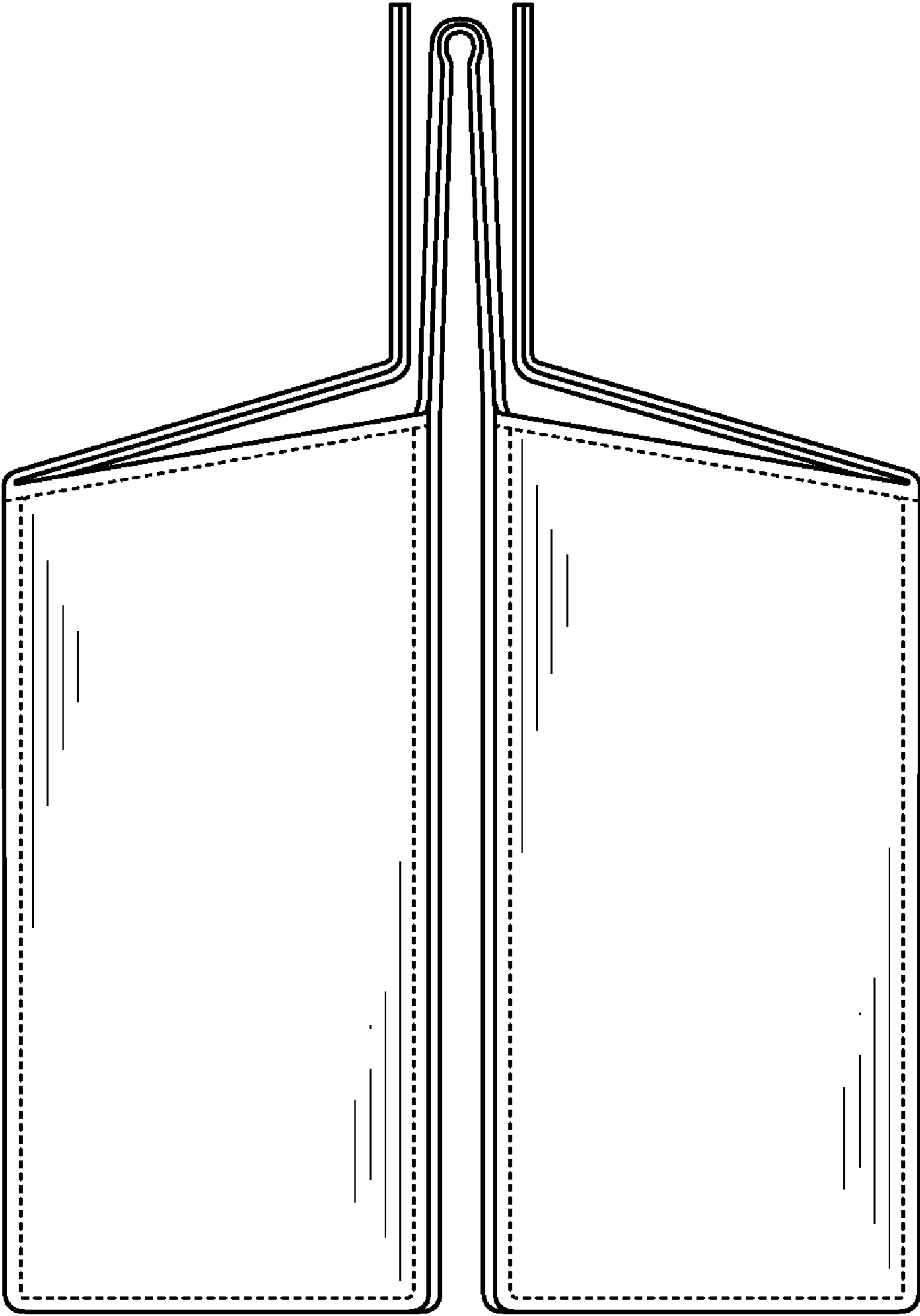

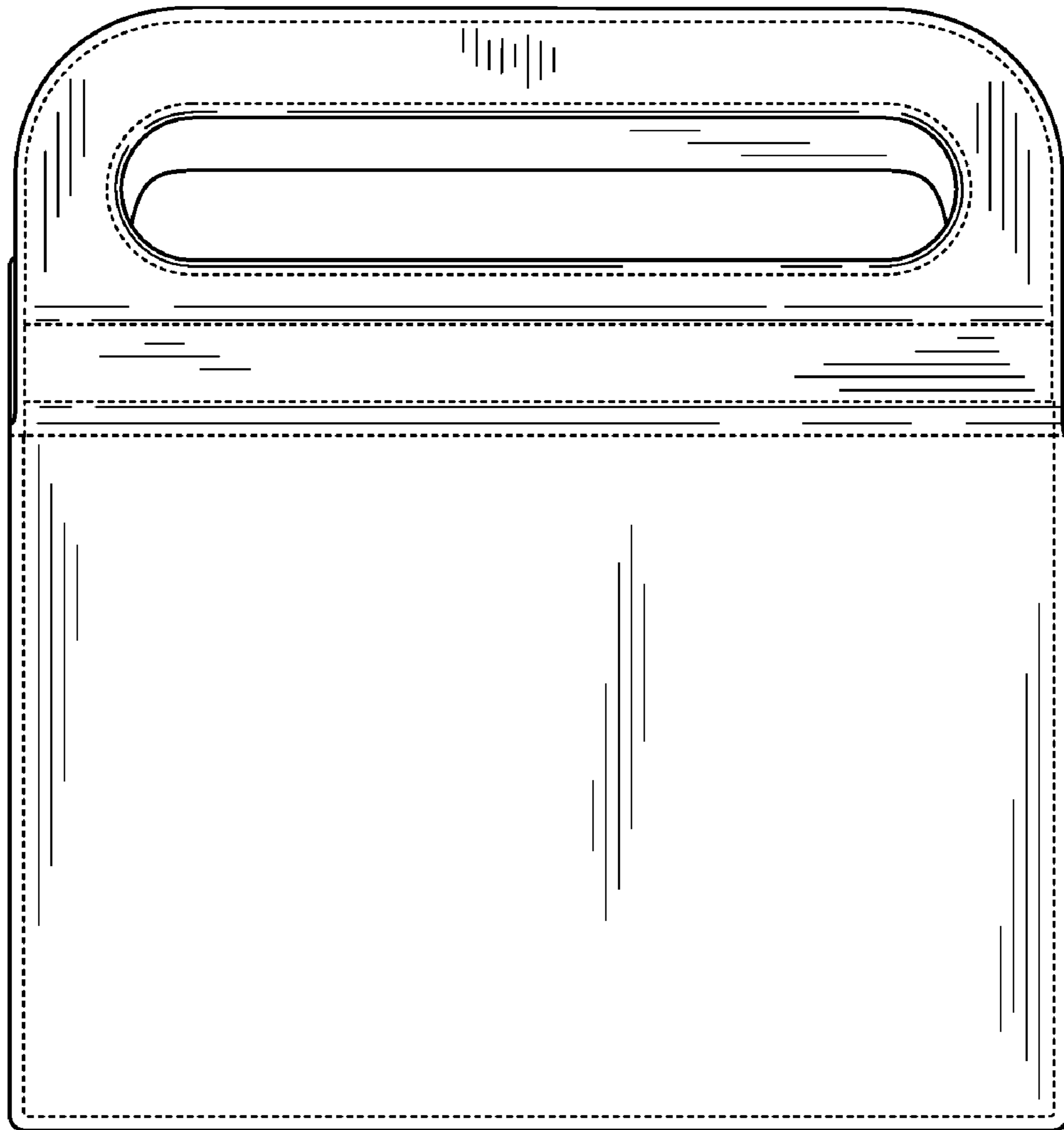

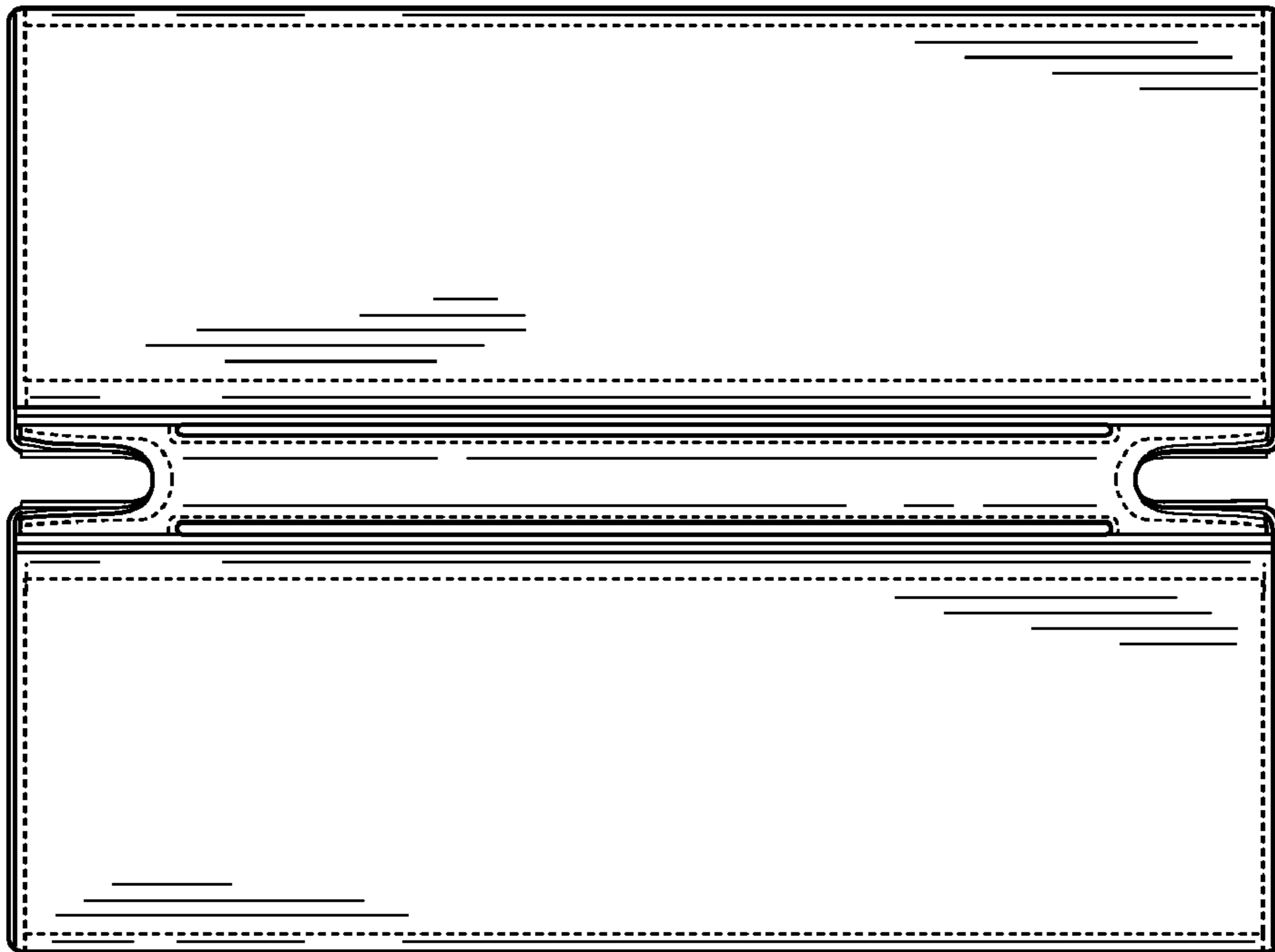

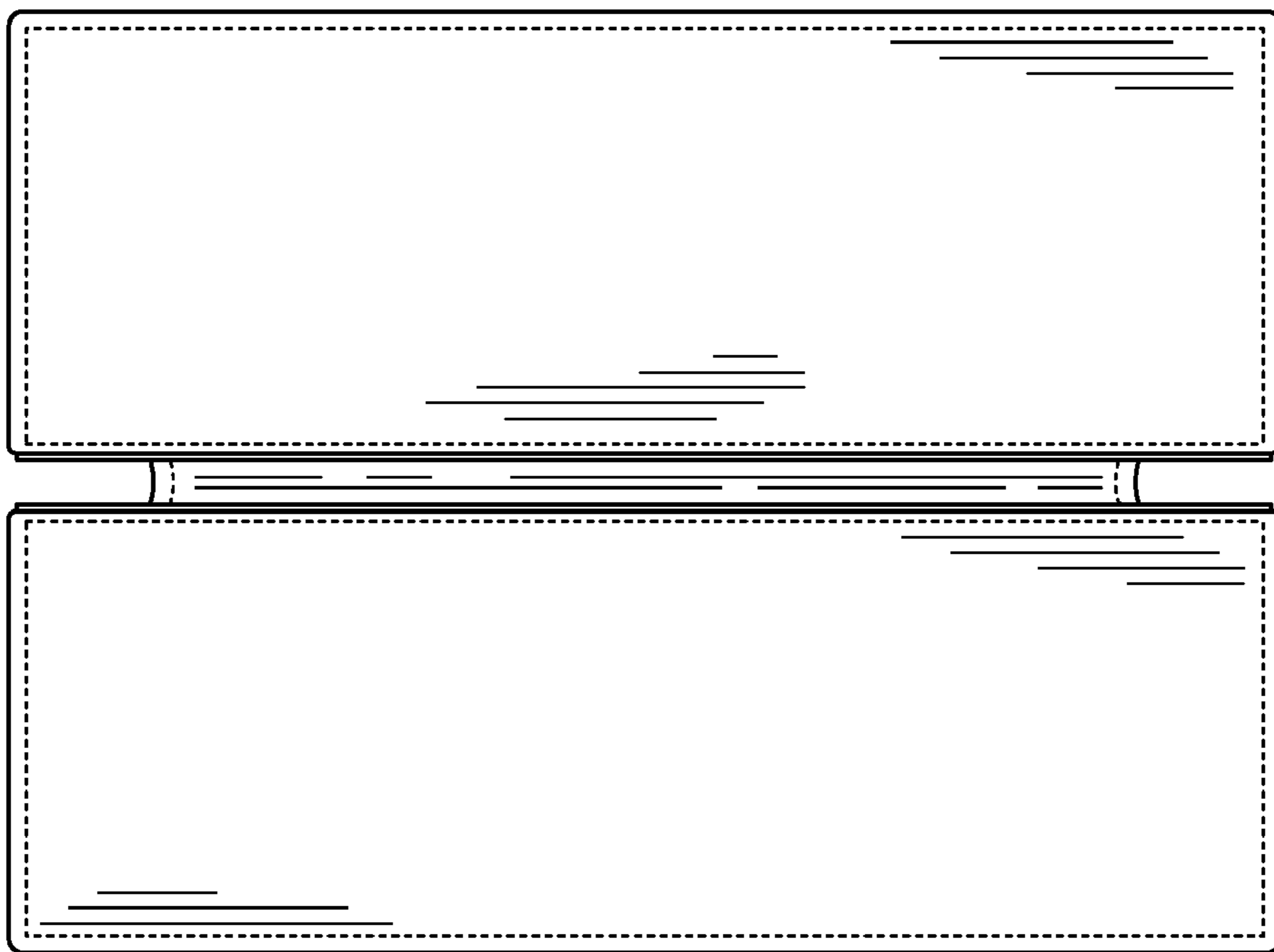
