FIG. 1 is a perspective view of a steering column knob showing my new design;

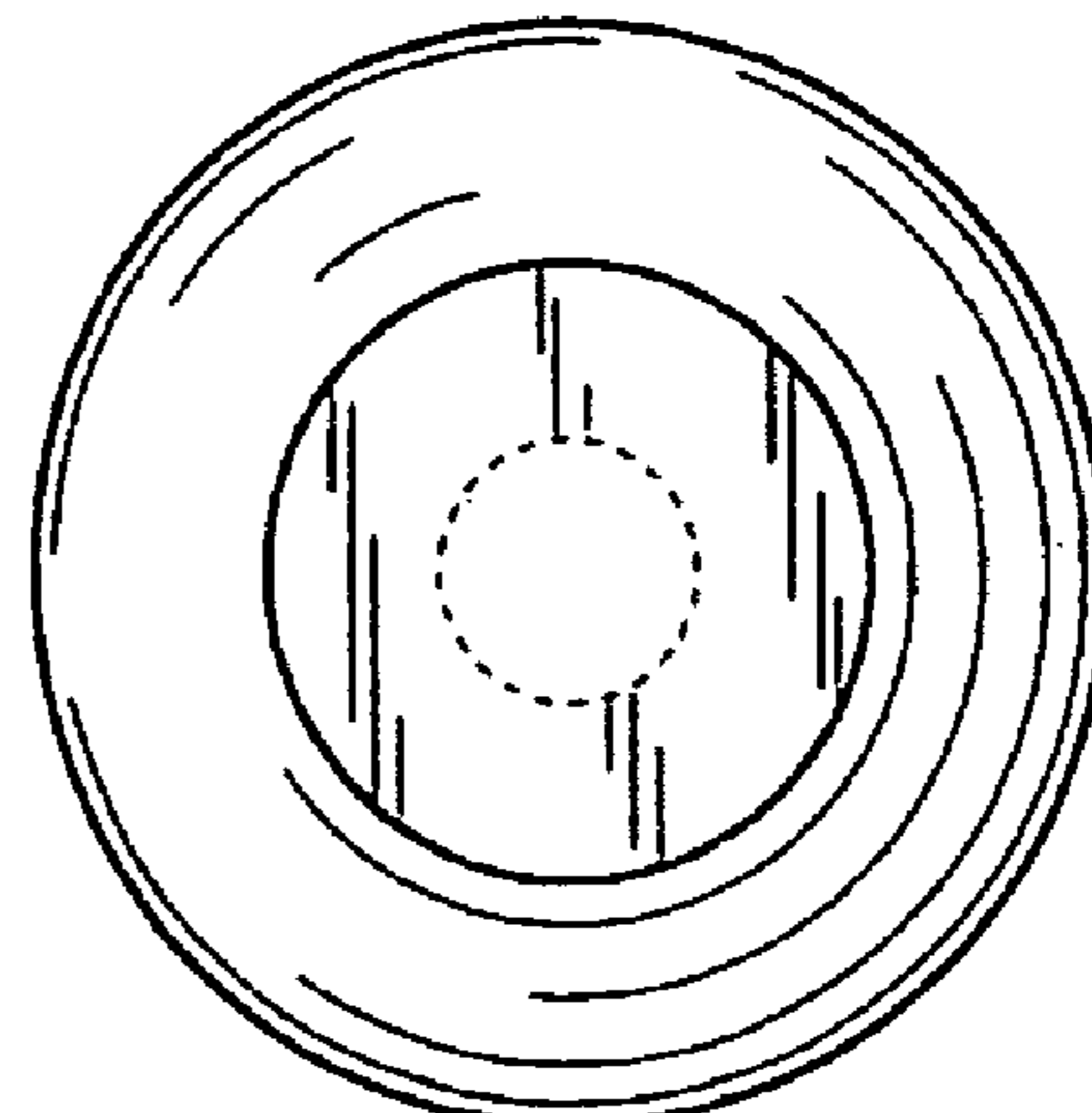
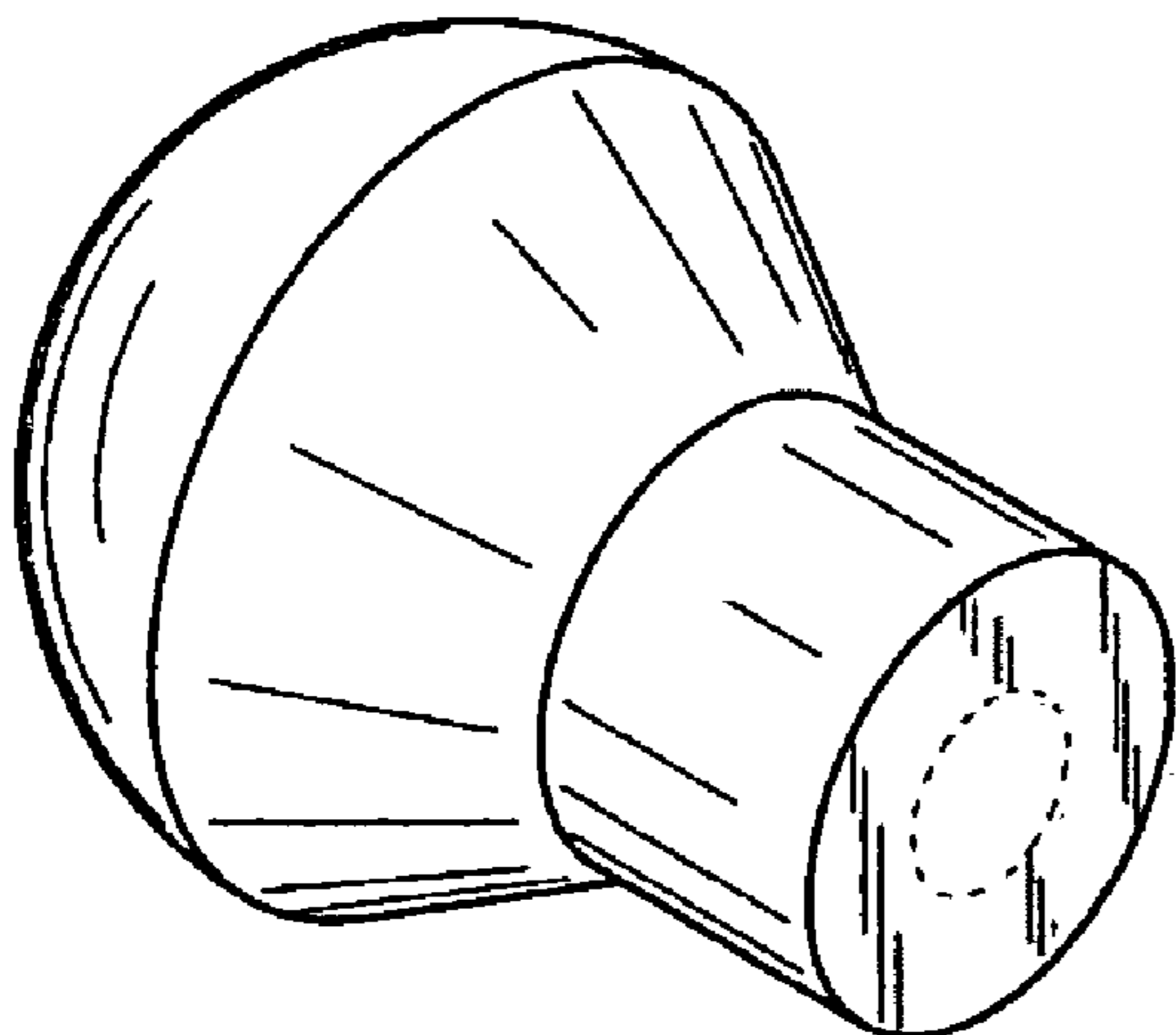
FIG. 2 is a side elevation view thereof;

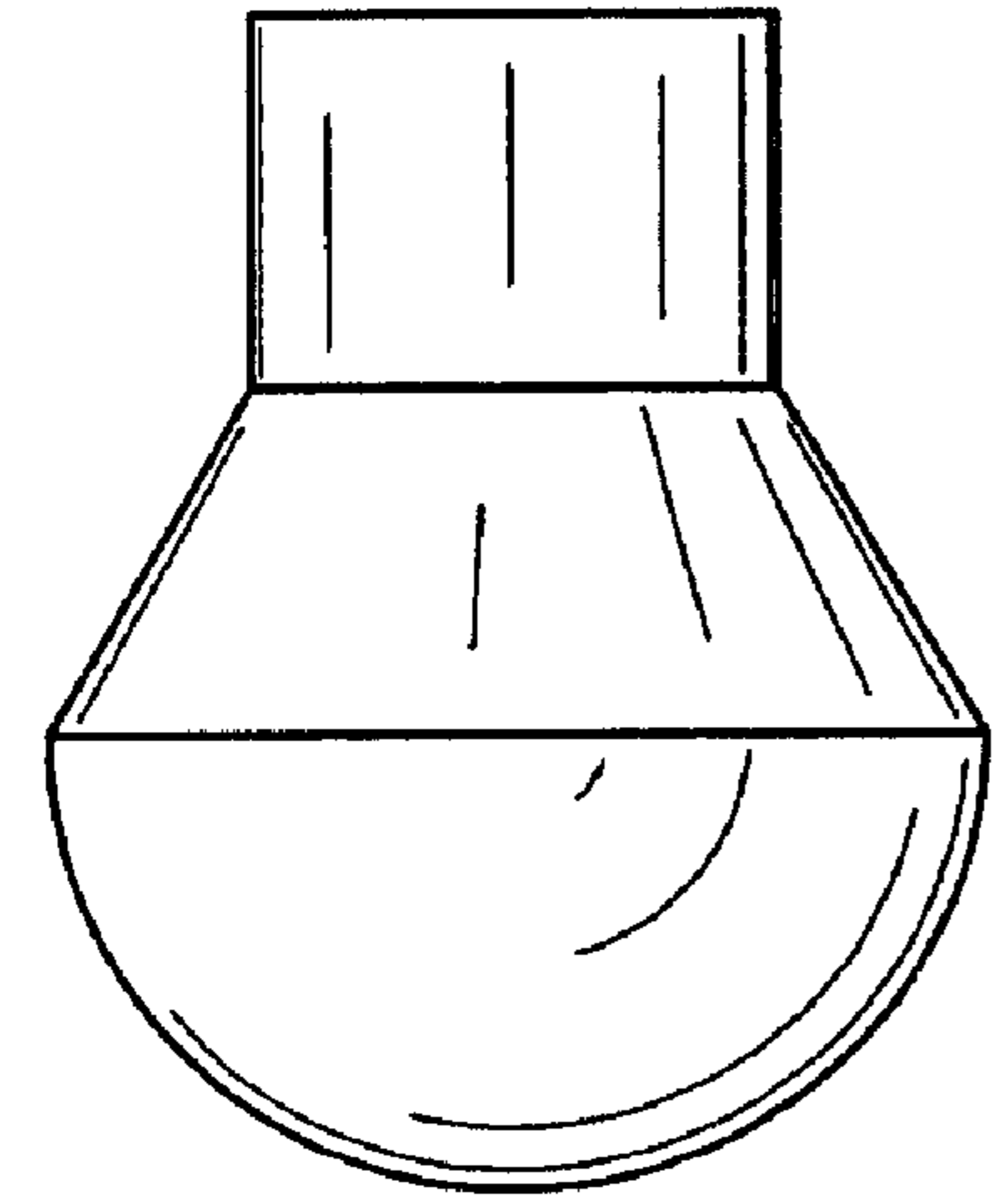

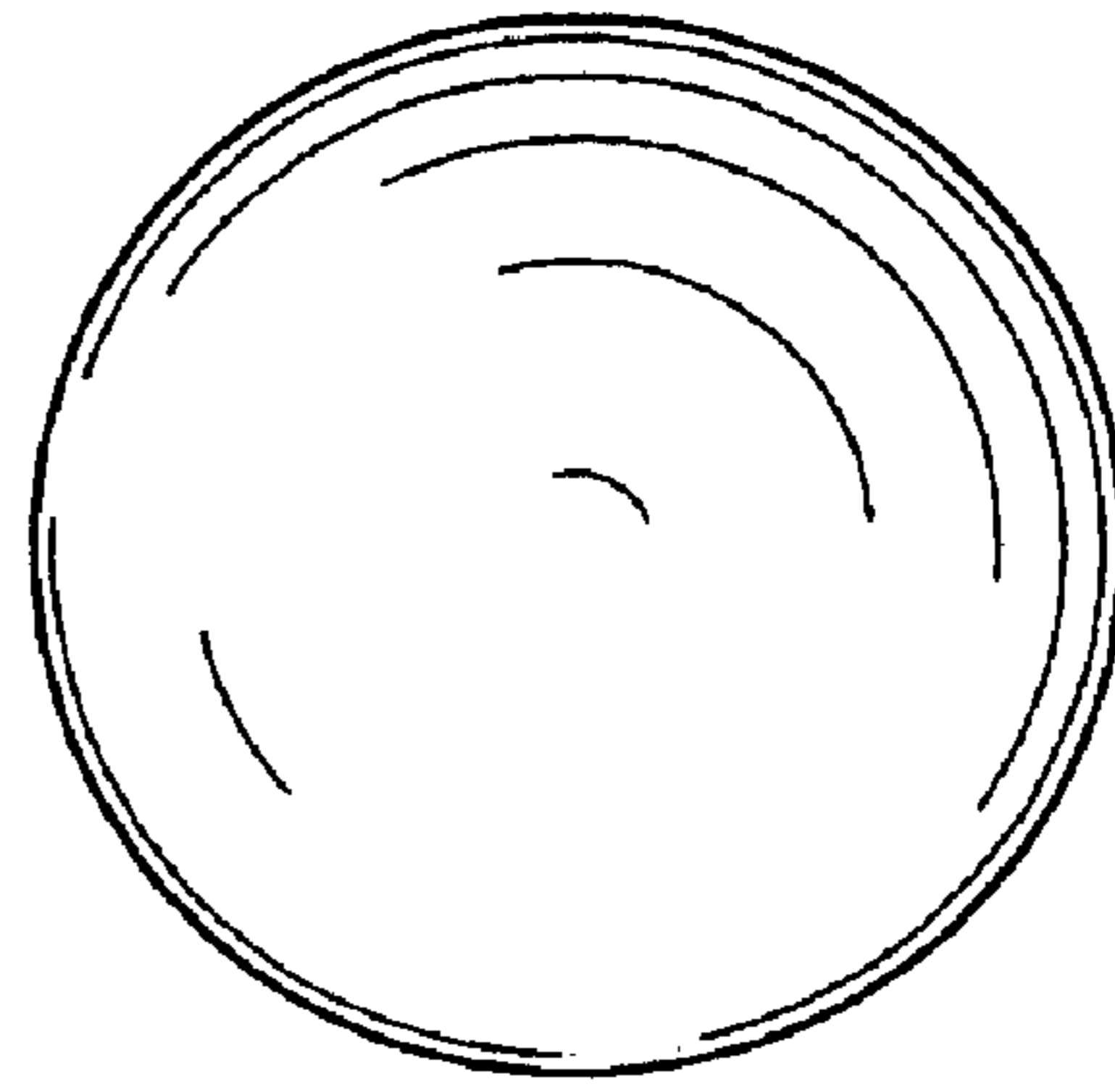

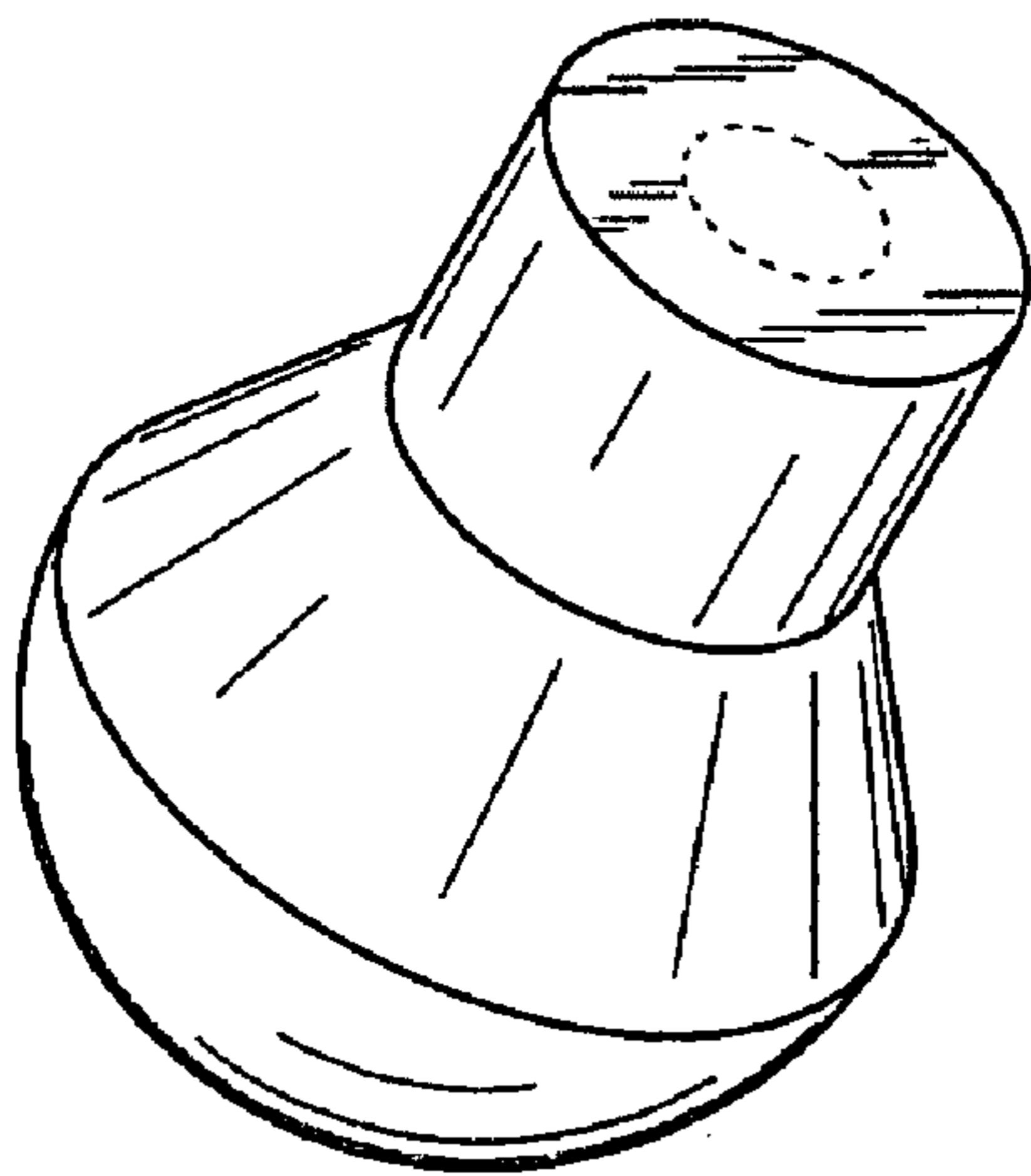

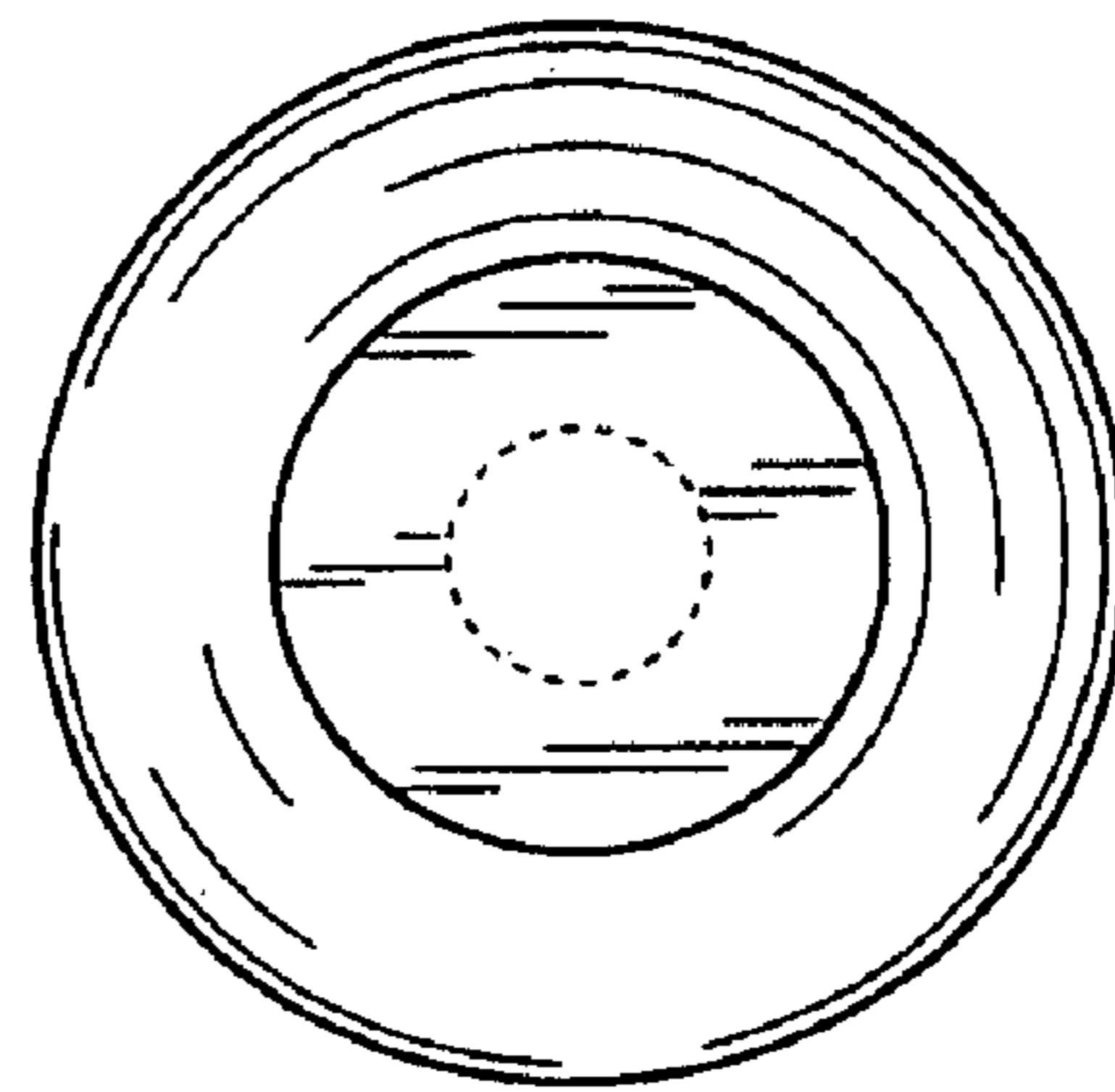
