DESCRIPTION

FIG. 1 is a front view of product packaging showing a first embodiment of my new design;

FIG. 2 is a perspective view thereof;

FIG. 3 is a front view of product packaging showing a second embodiment of my new design;

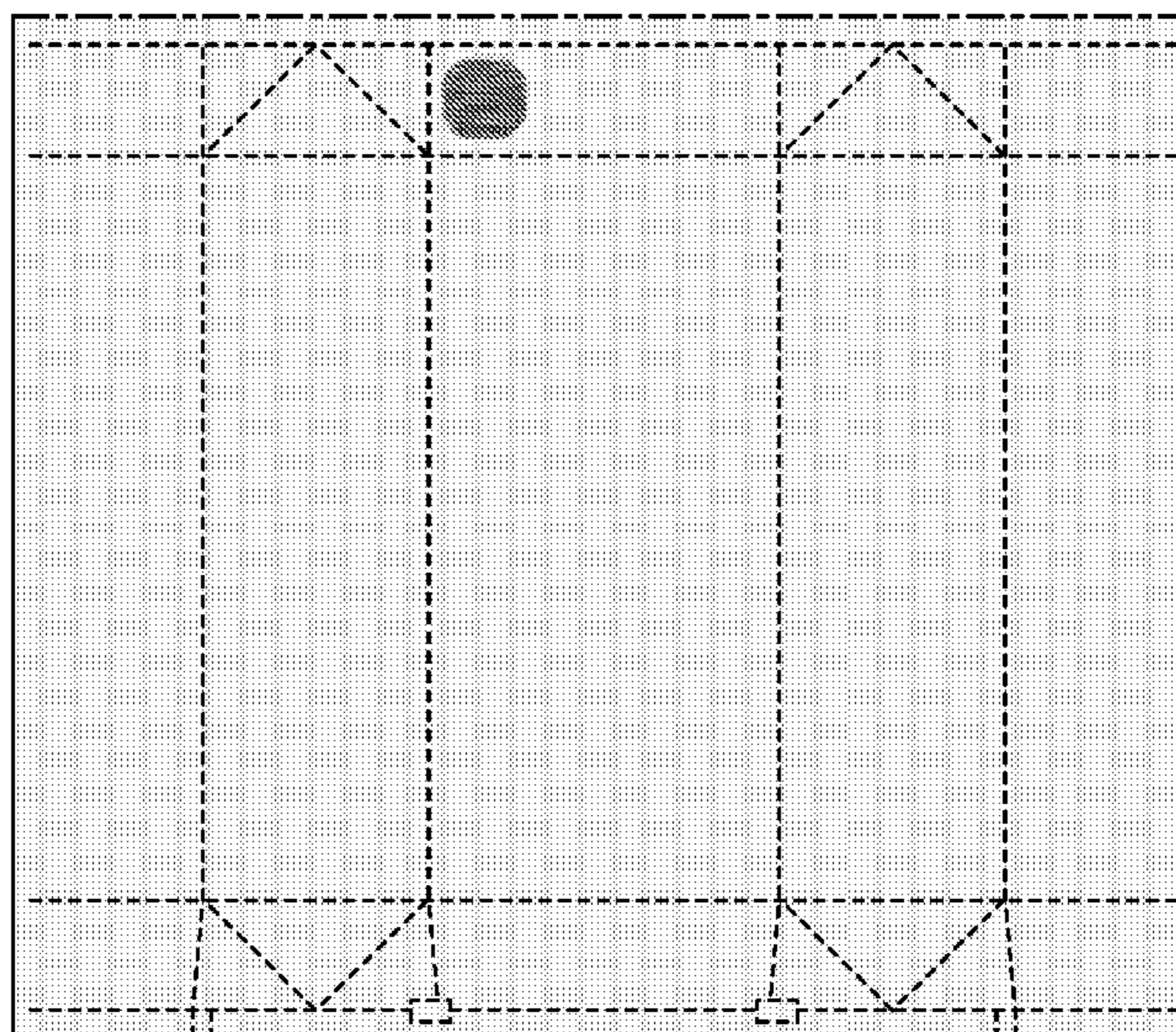
FIG. 4 is a perspective view thereof;

The broken lines formed by segments of equal length depict claimed pre-weakened fold lines on the product packaging and the broken lines formed by segments of alternating length on the top and bottom of the design form the boundaries of the claimed design and form no part of the claimed design.

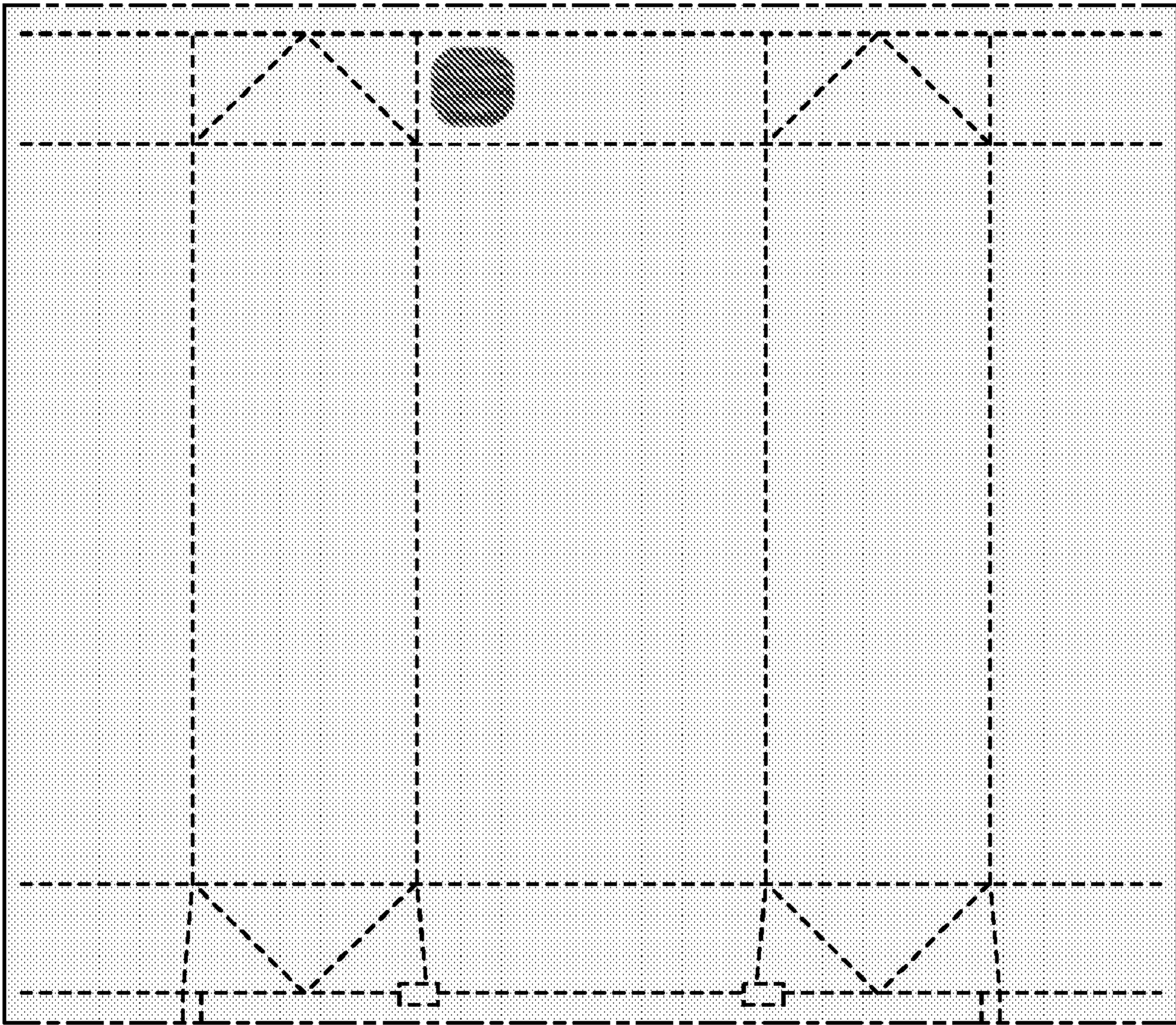

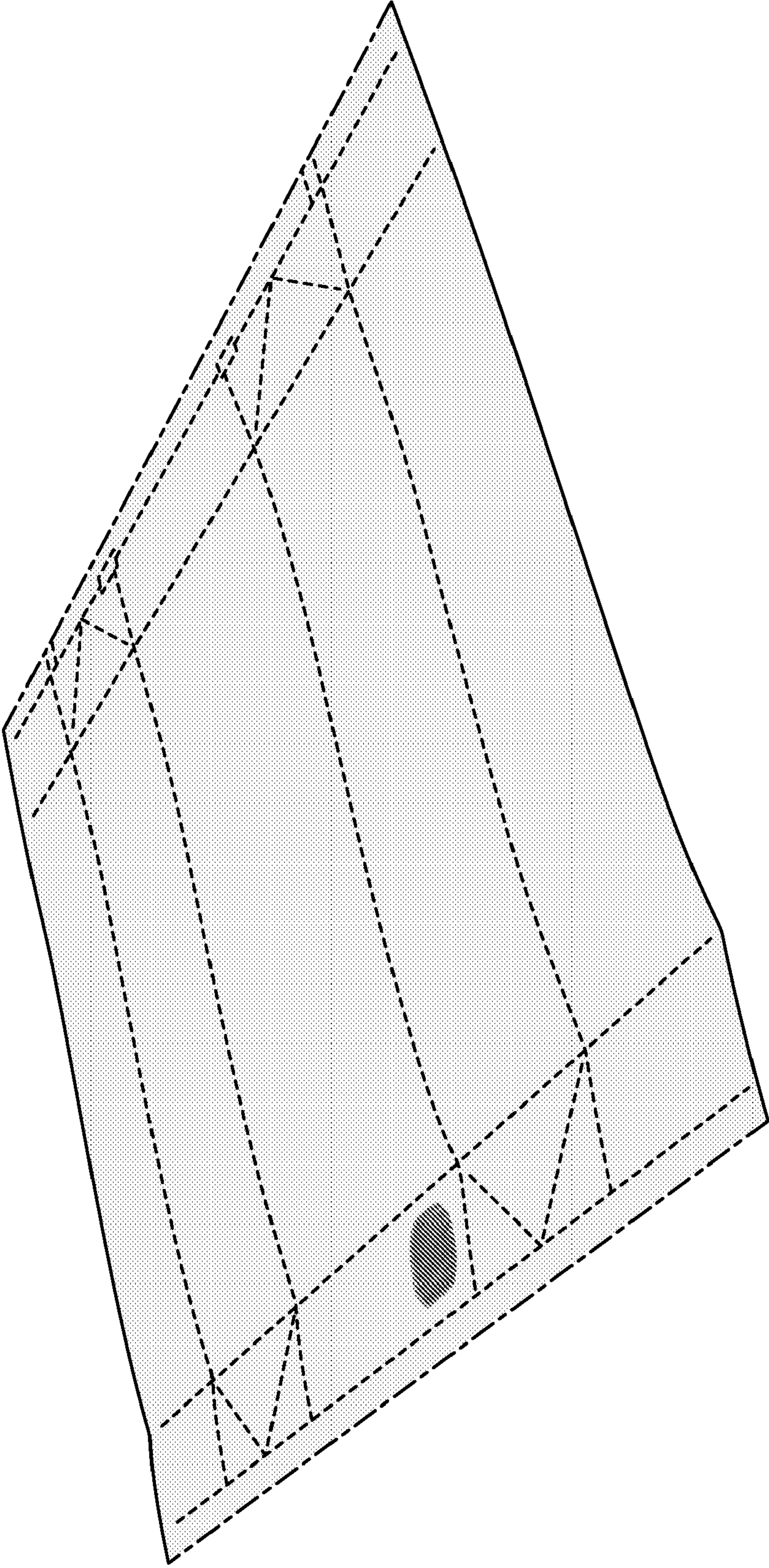

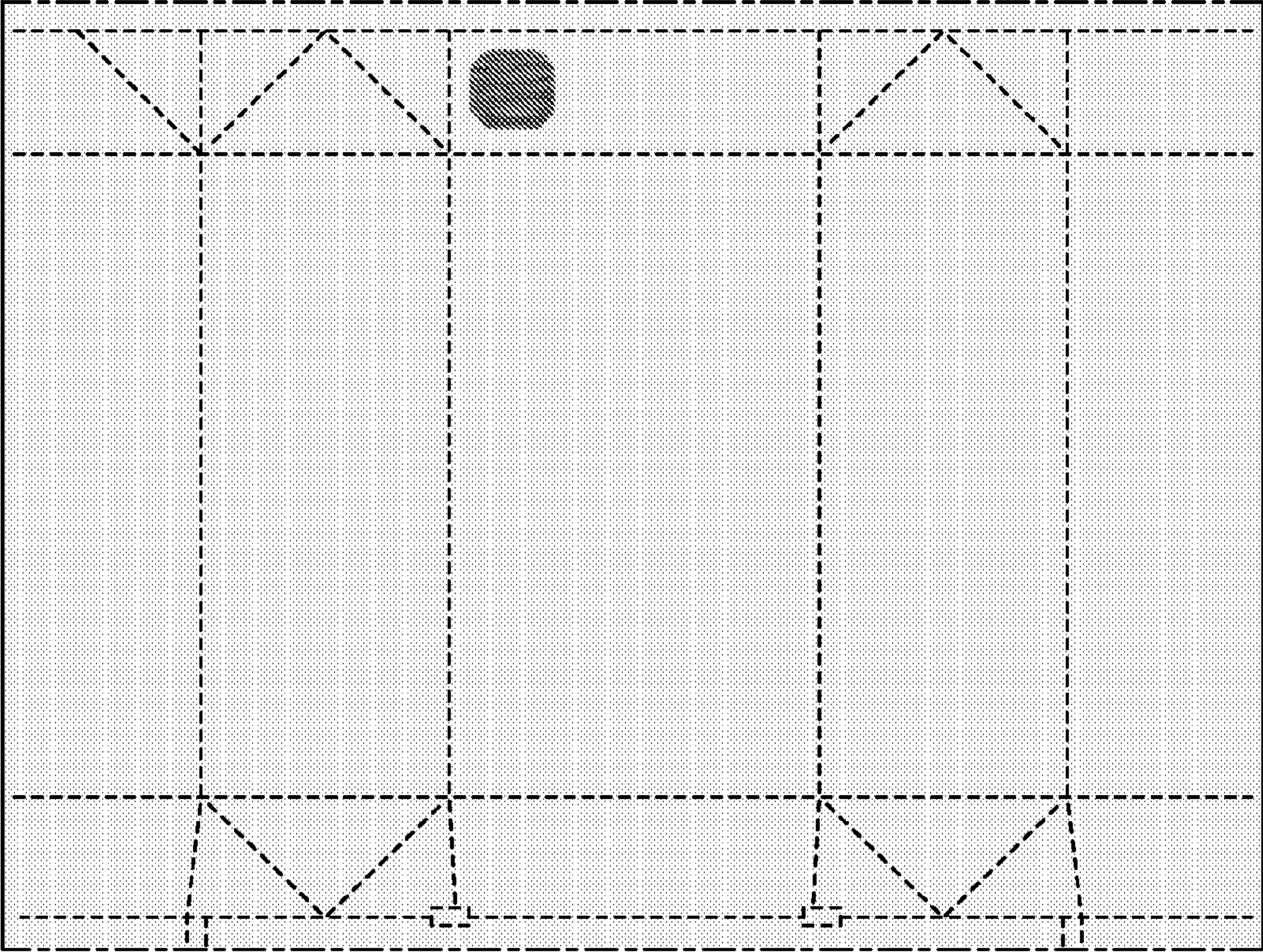

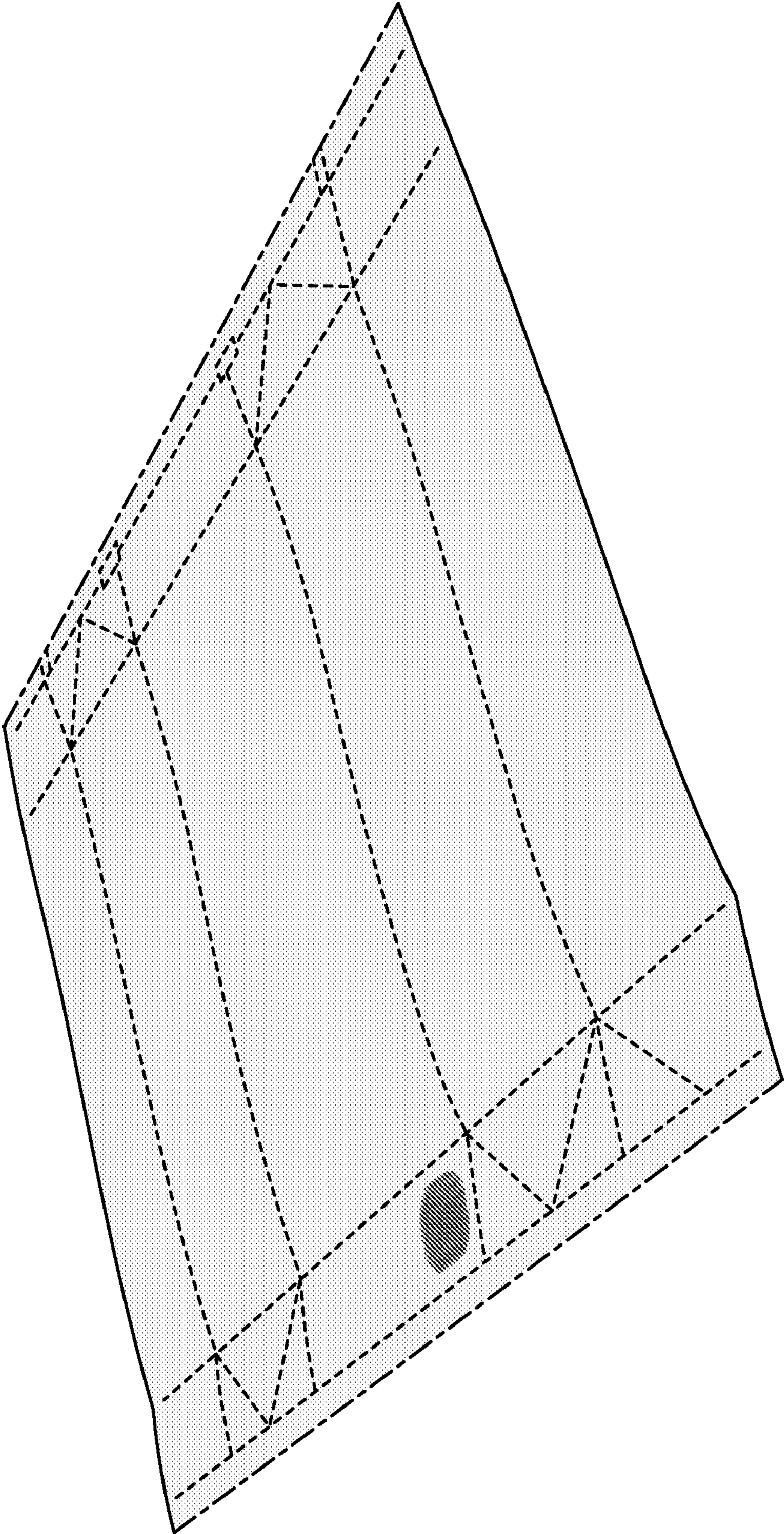

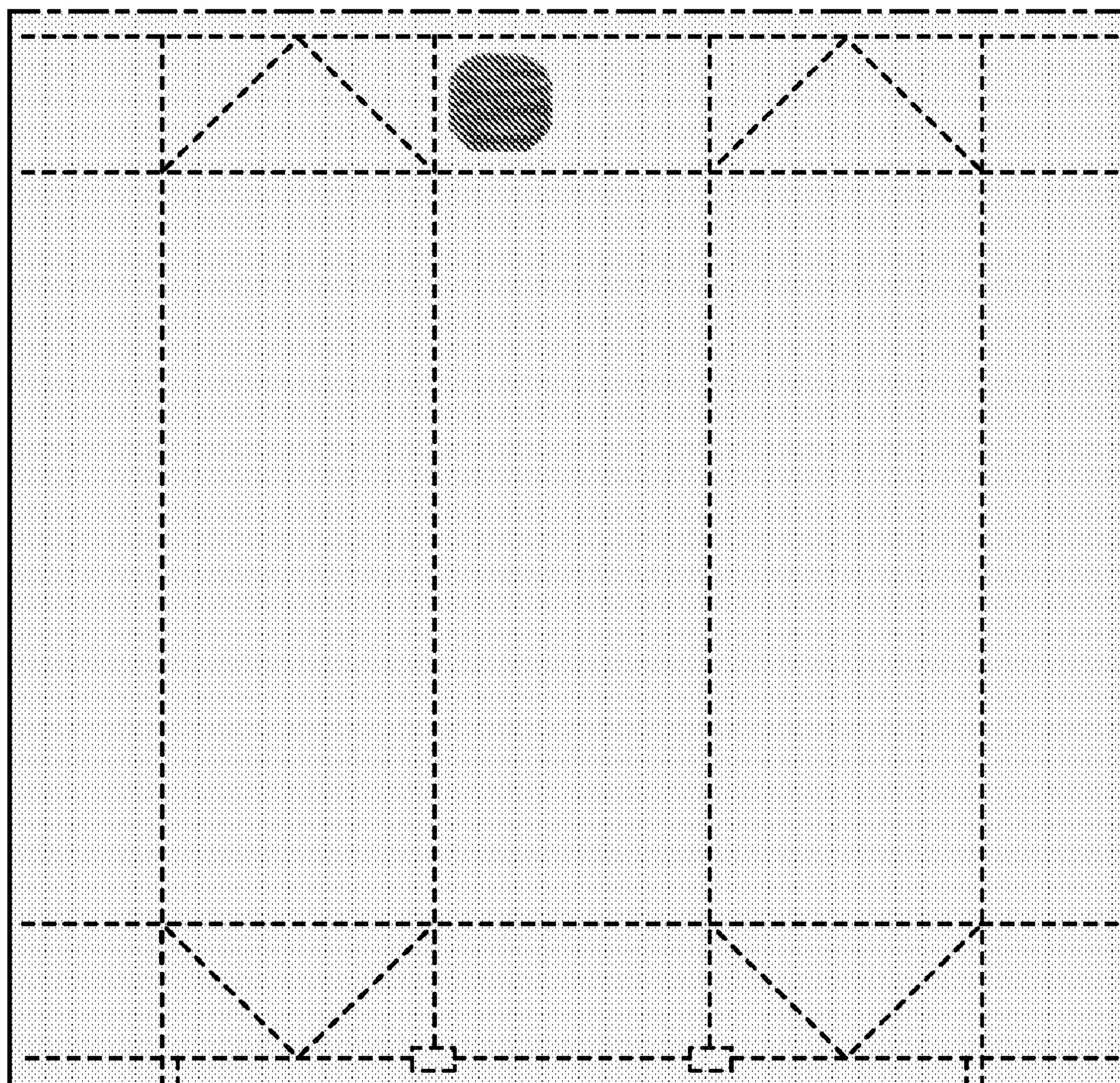

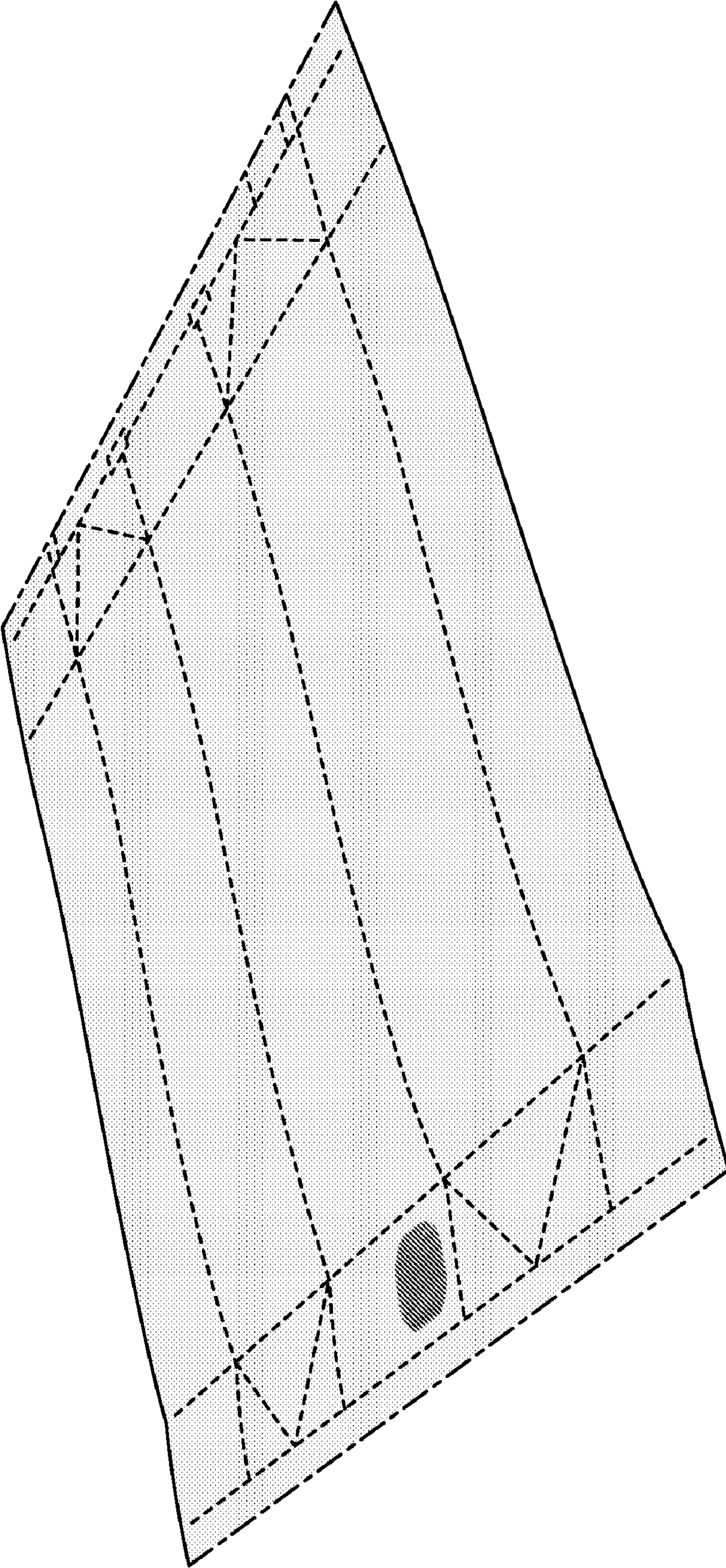
