FIG. 4 right side elevational view thereof;

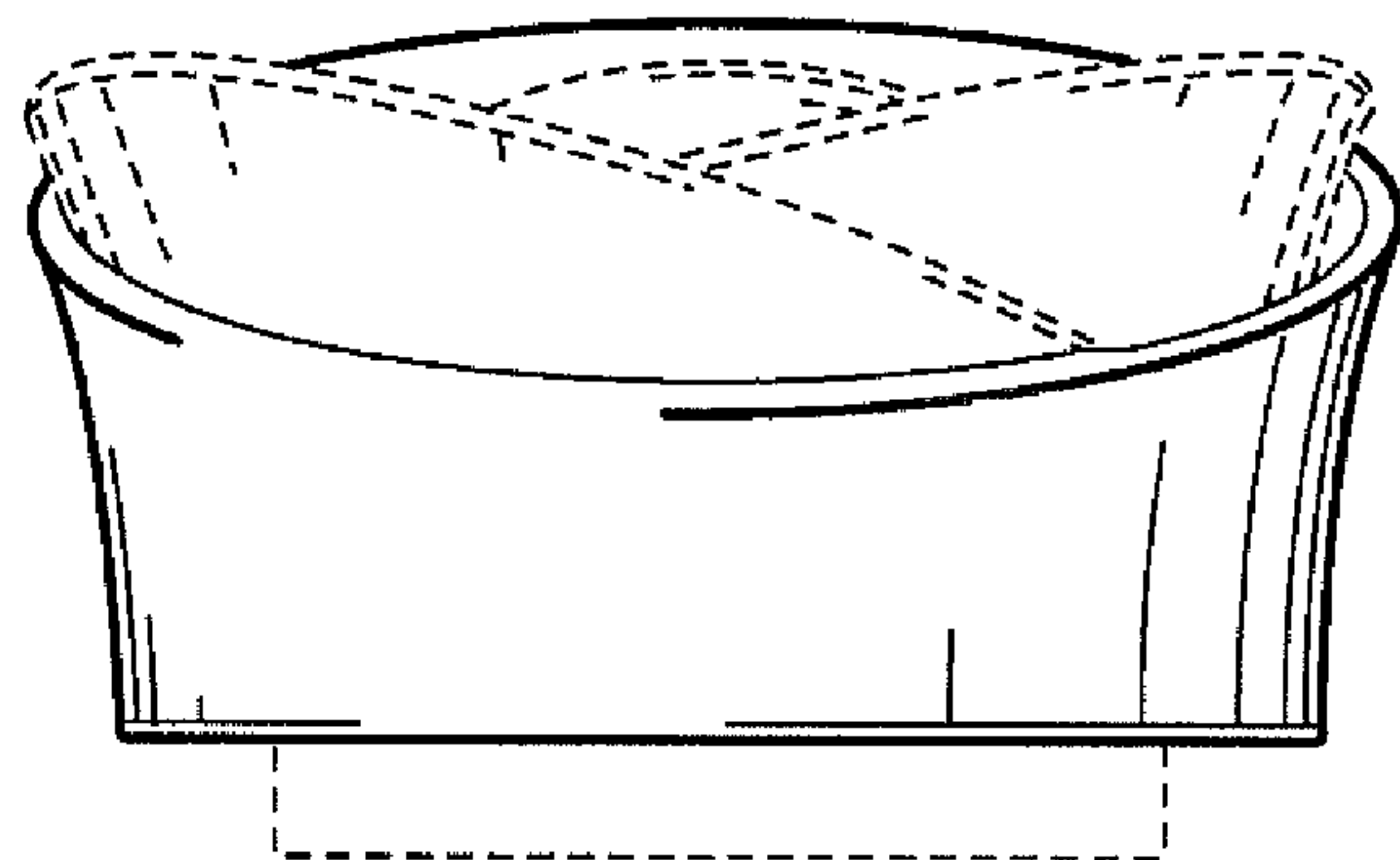
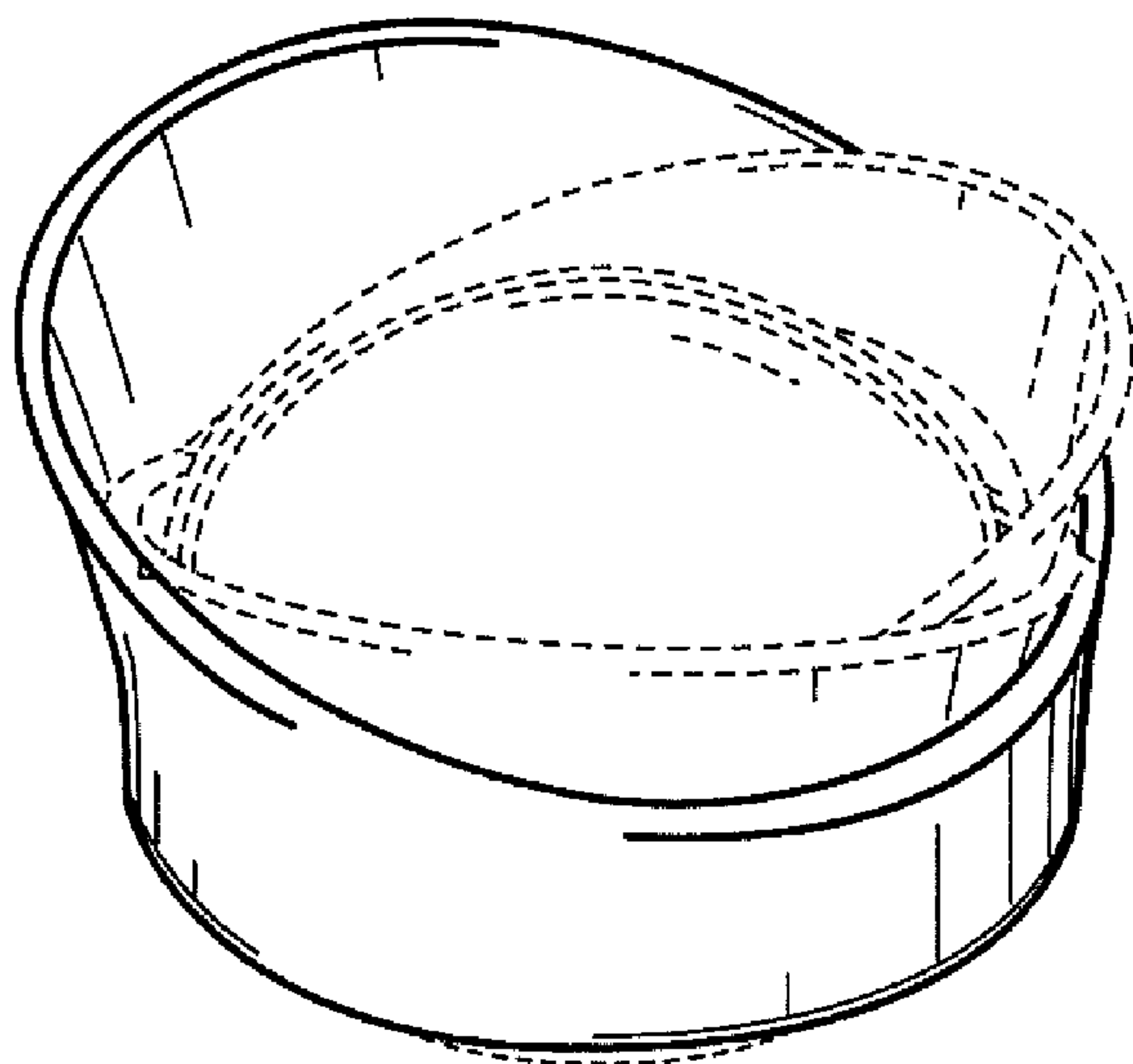
FIG. 5 left side elevational view thereof;

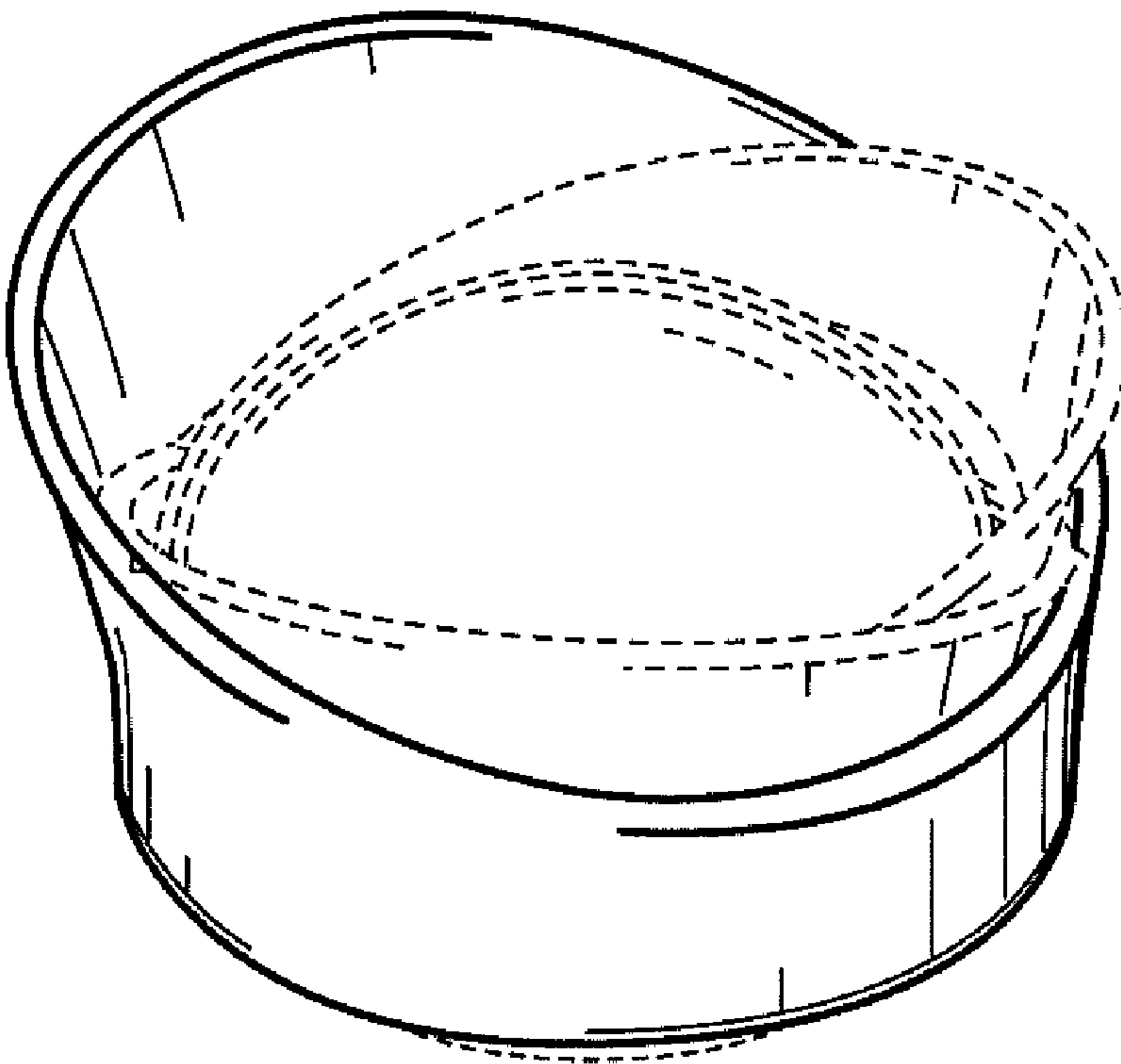

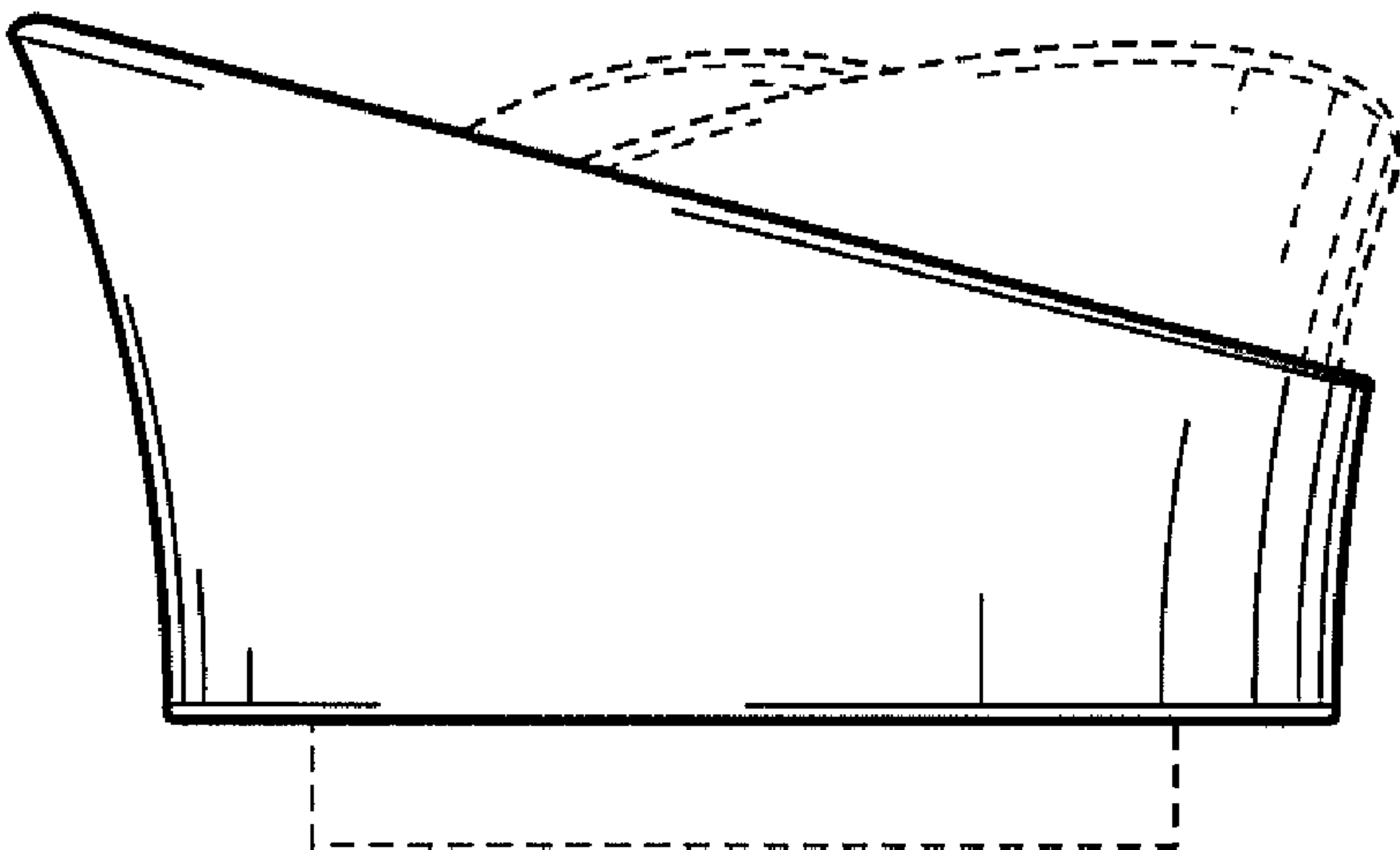

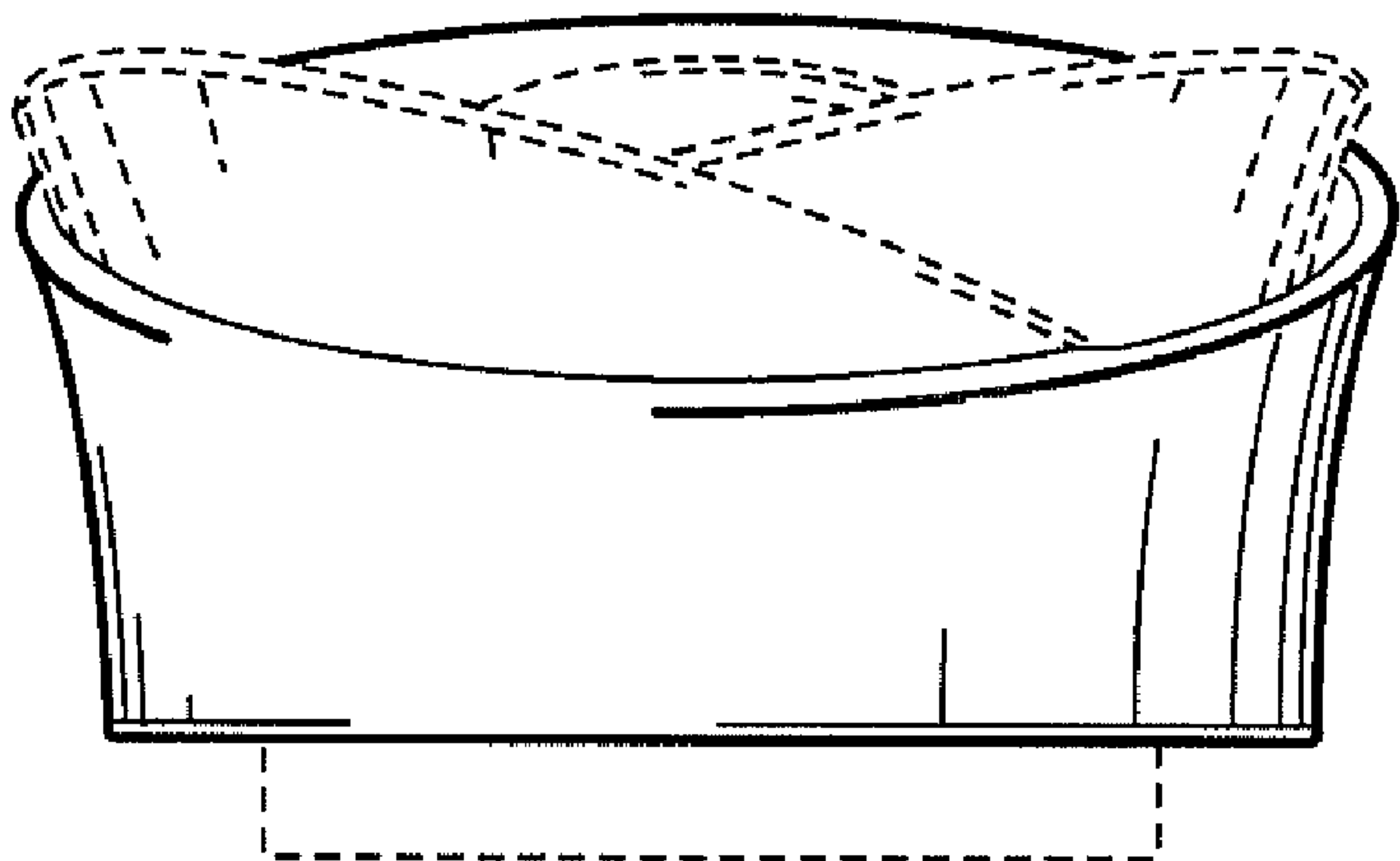

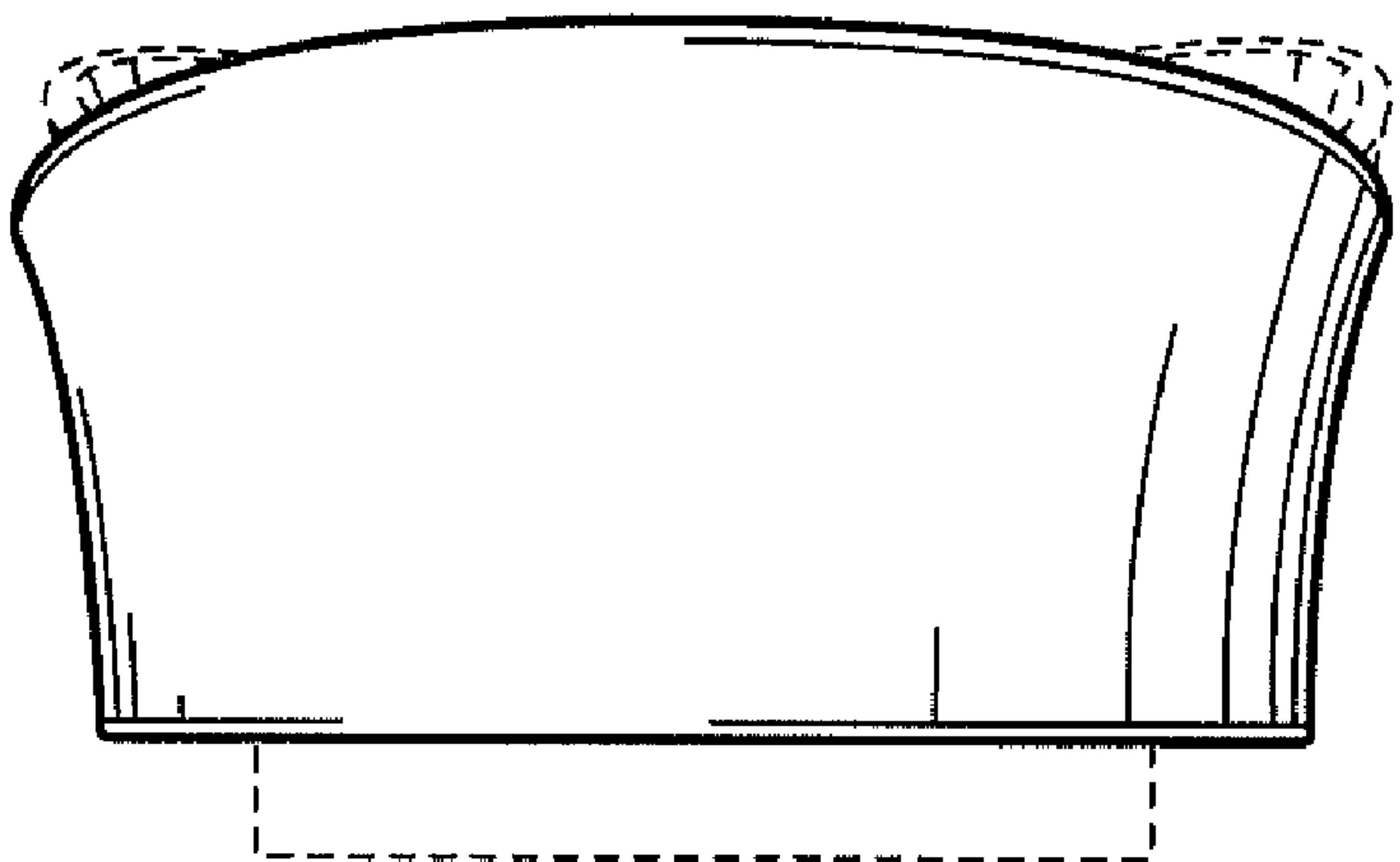

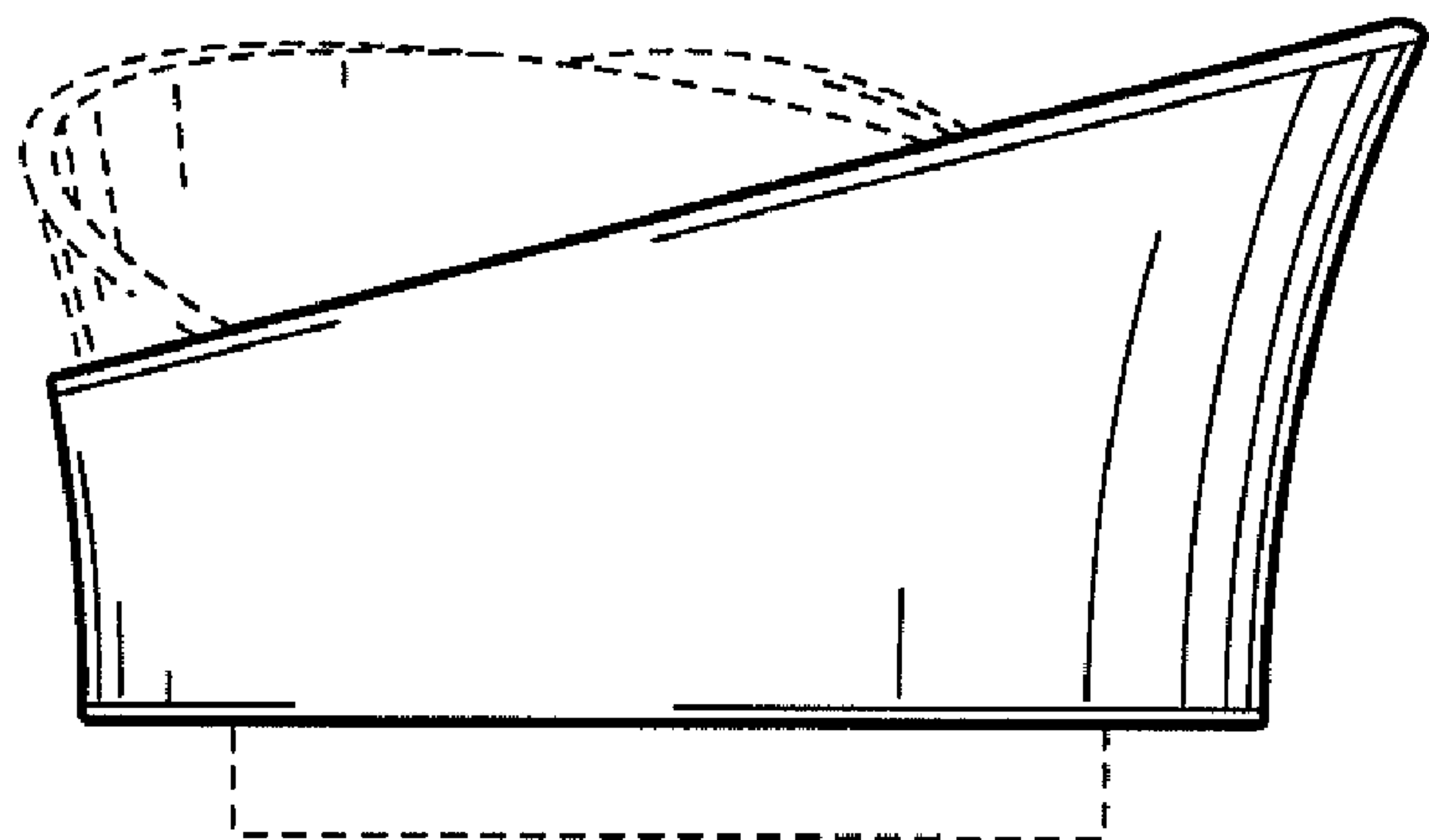

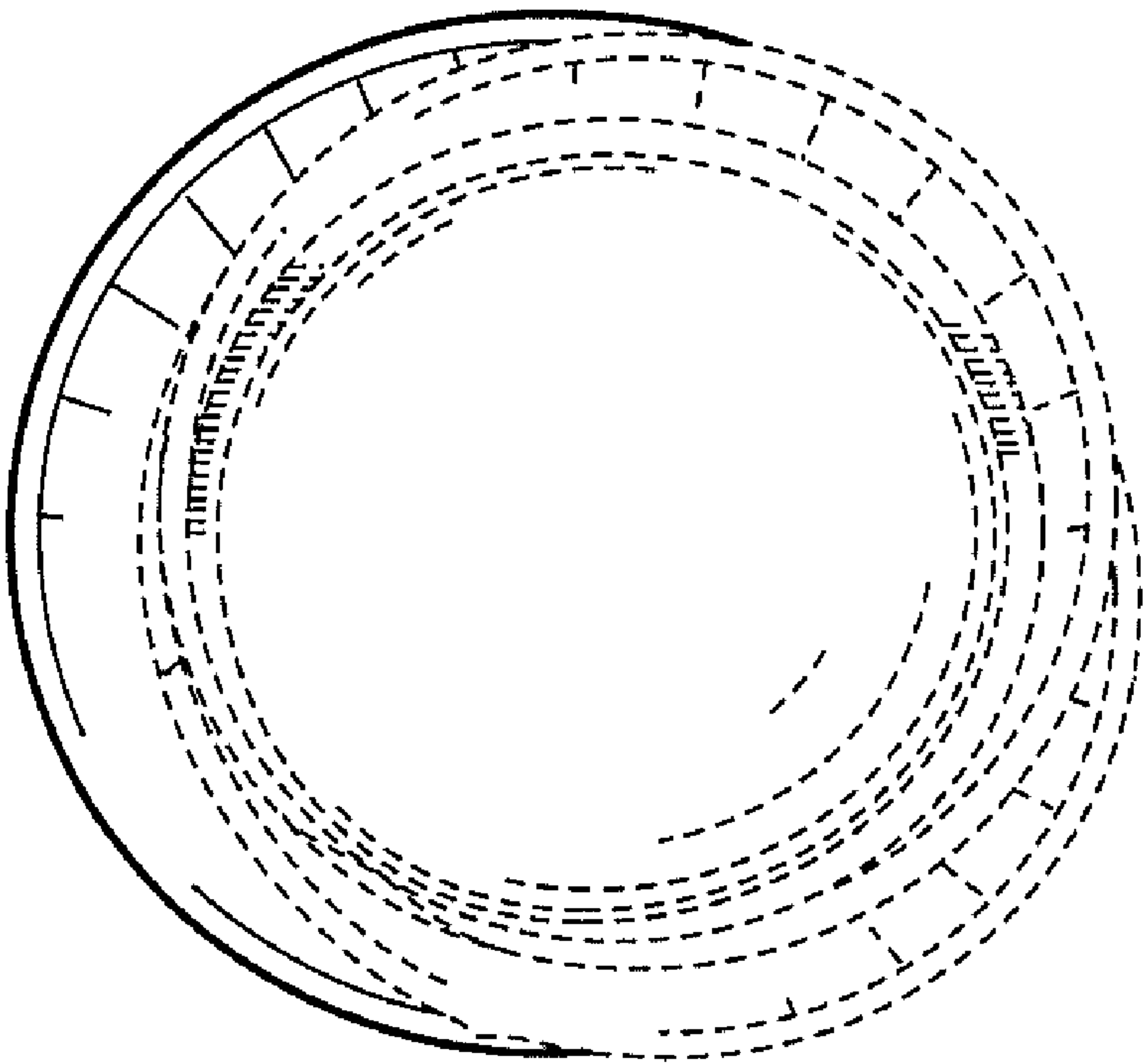

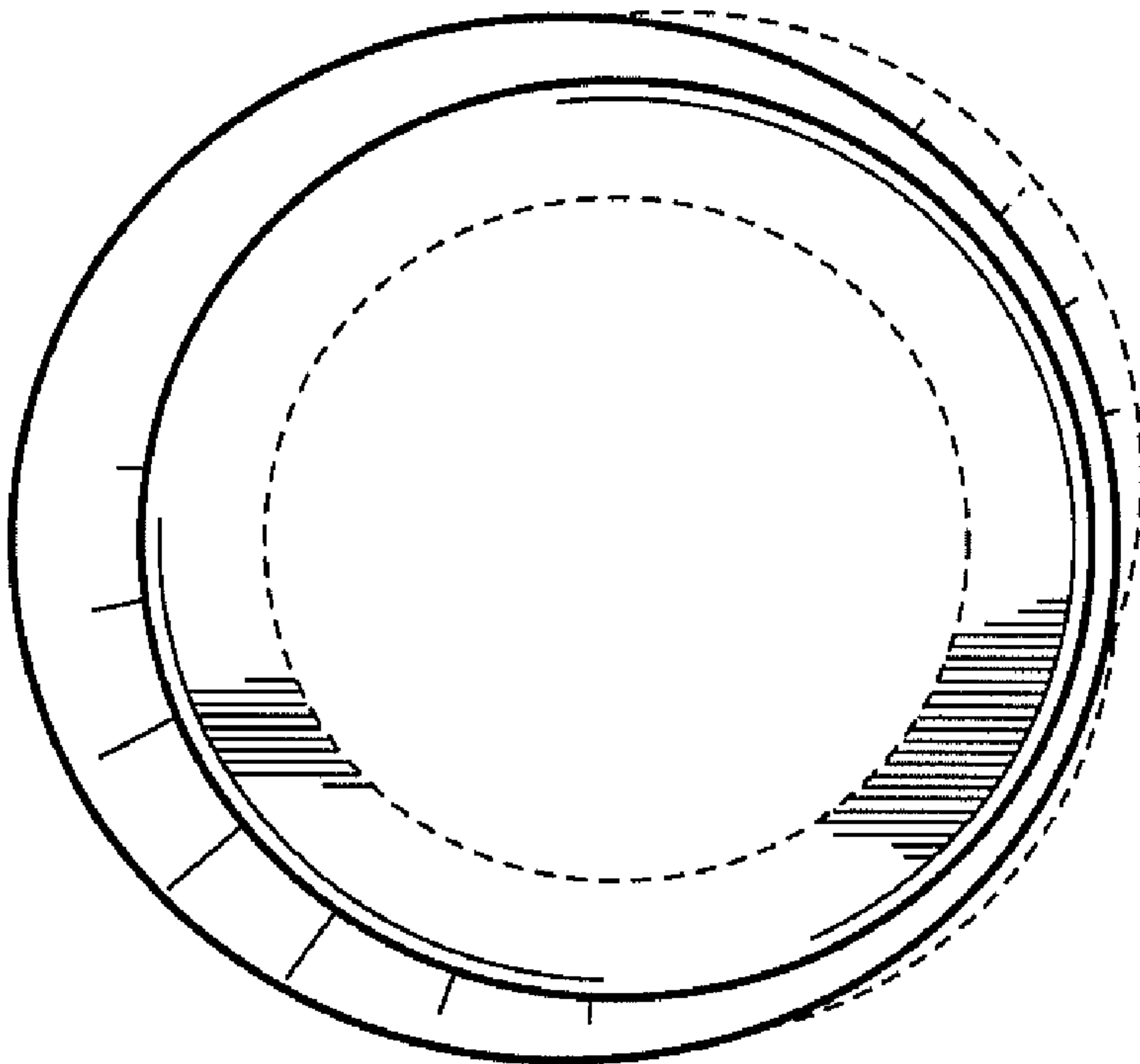
