**DESCRIPTION**

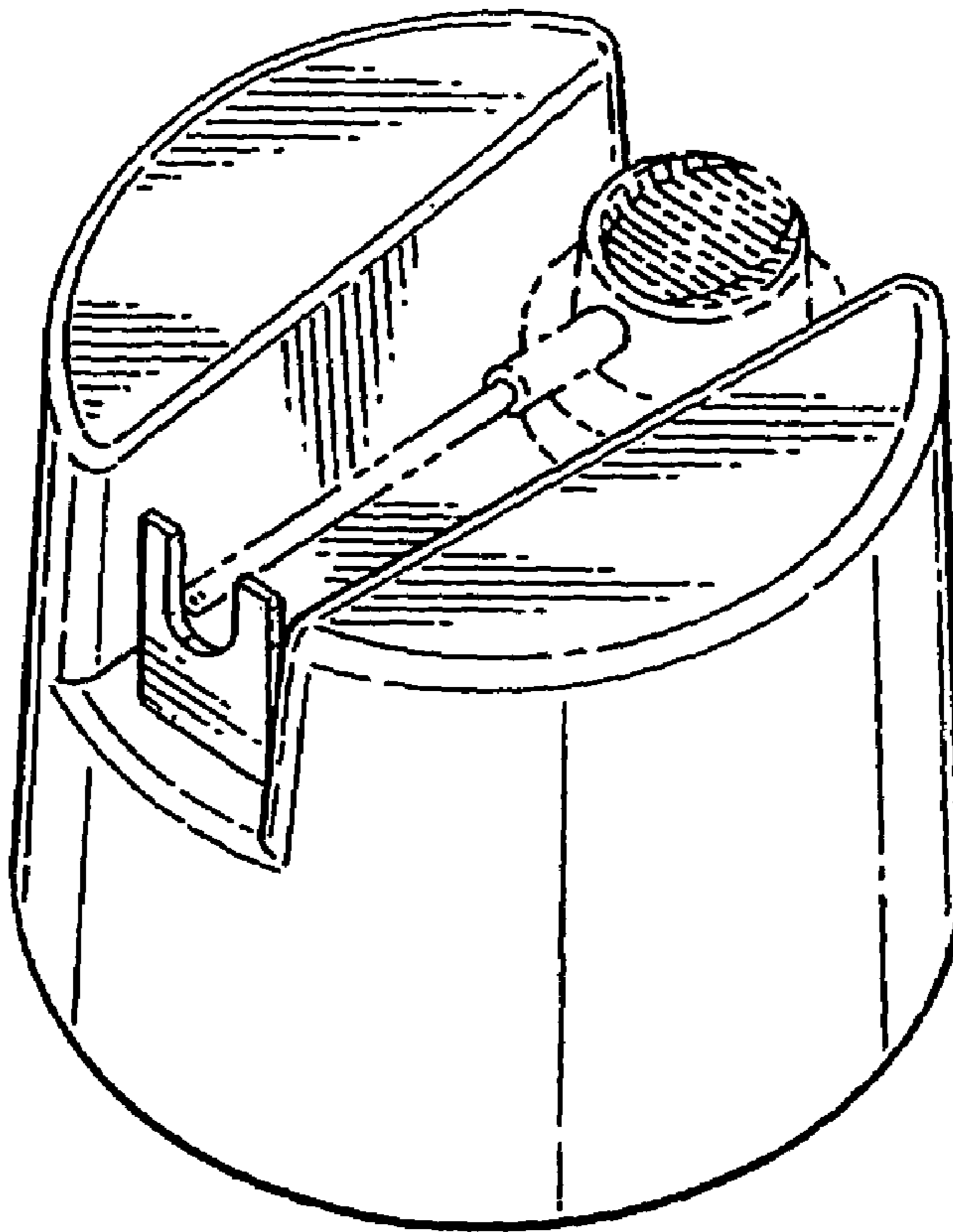

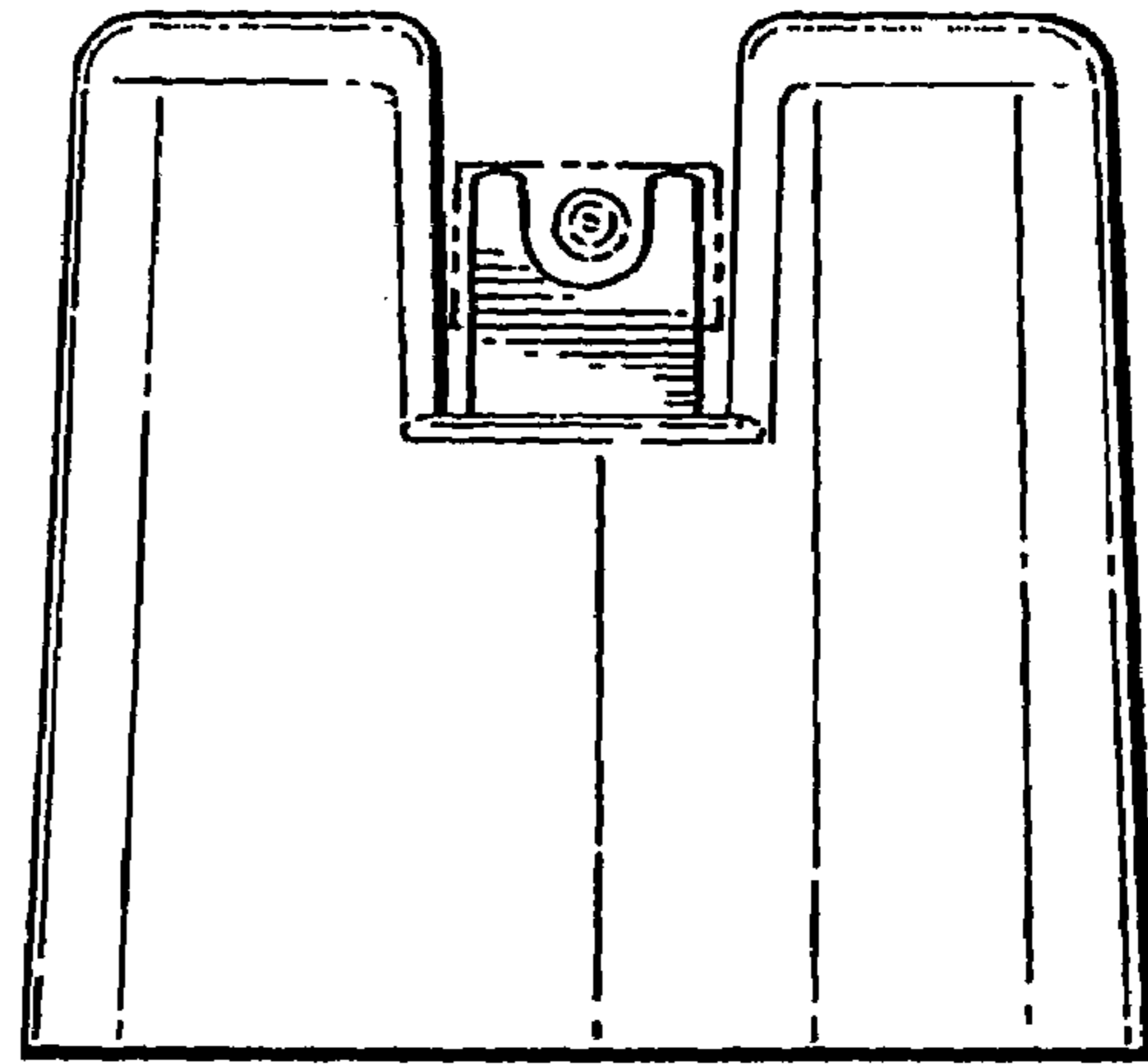
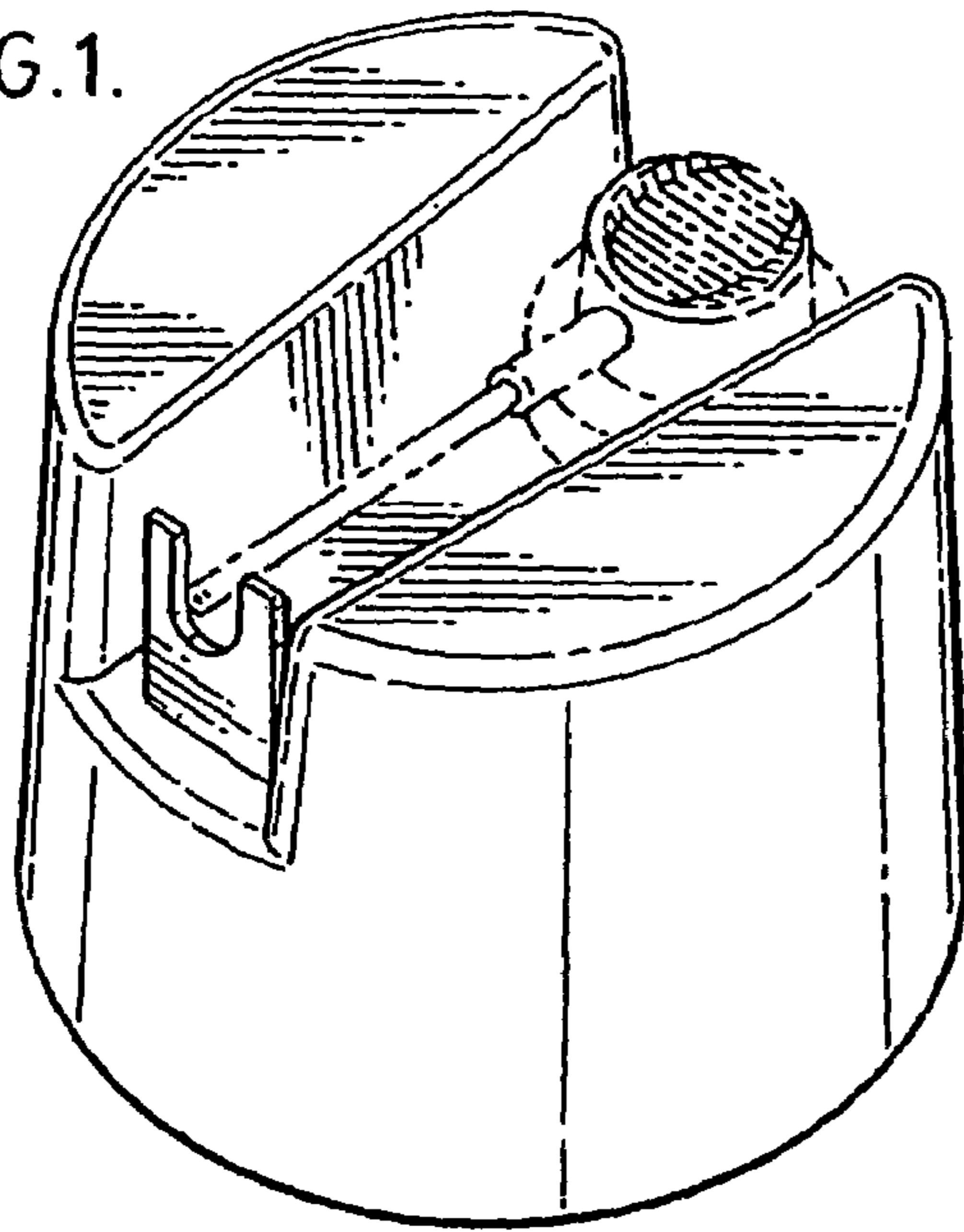

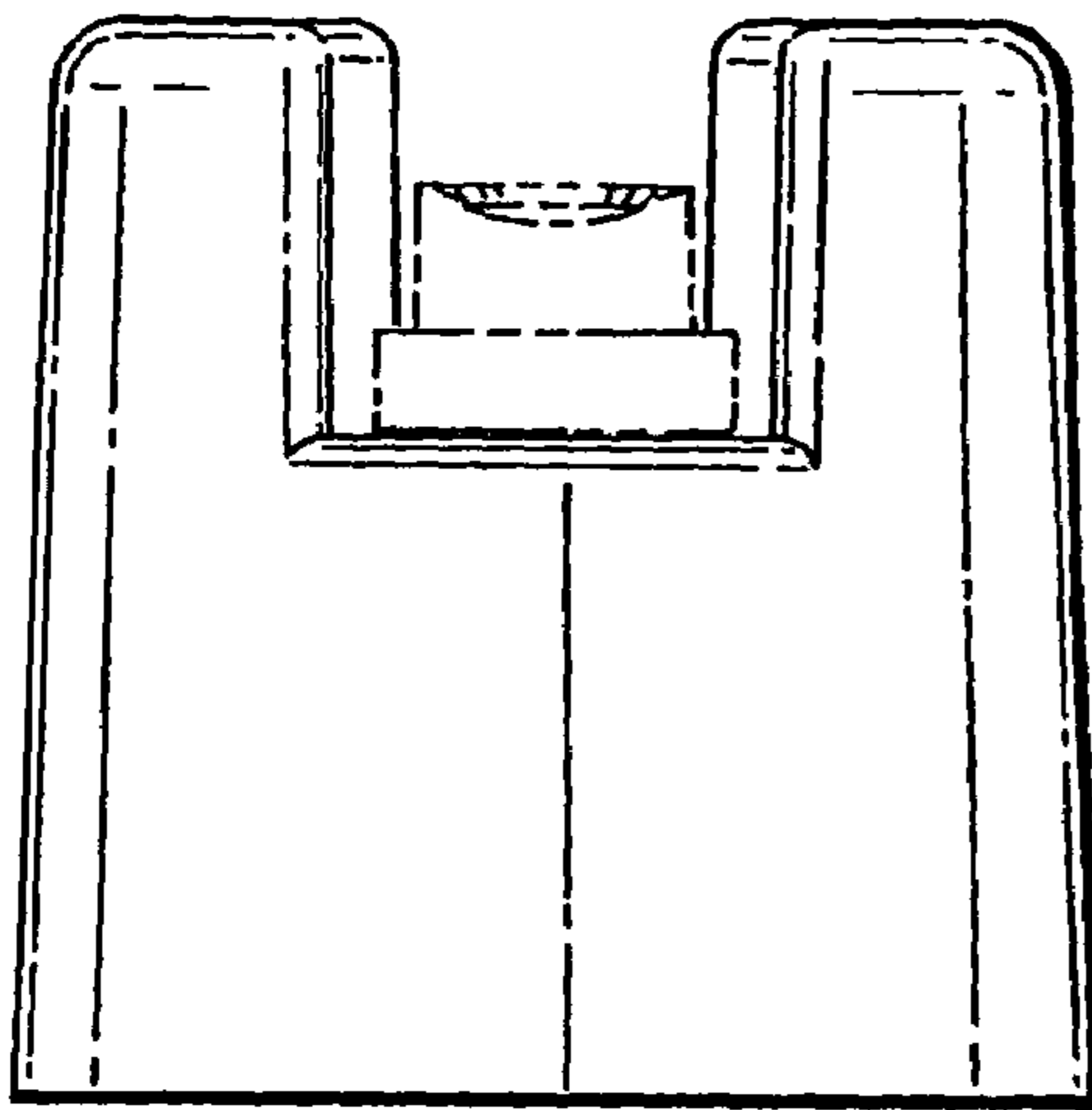

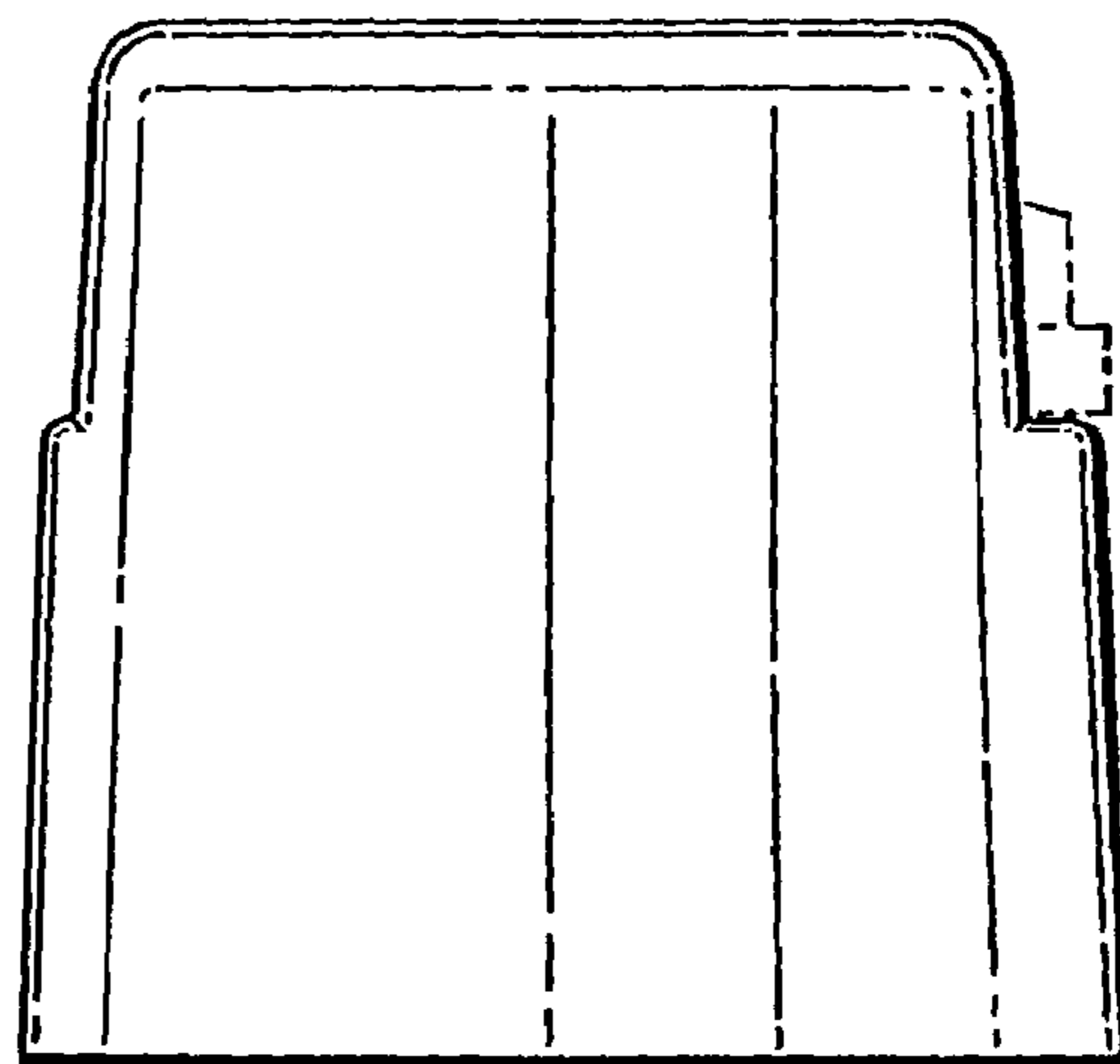

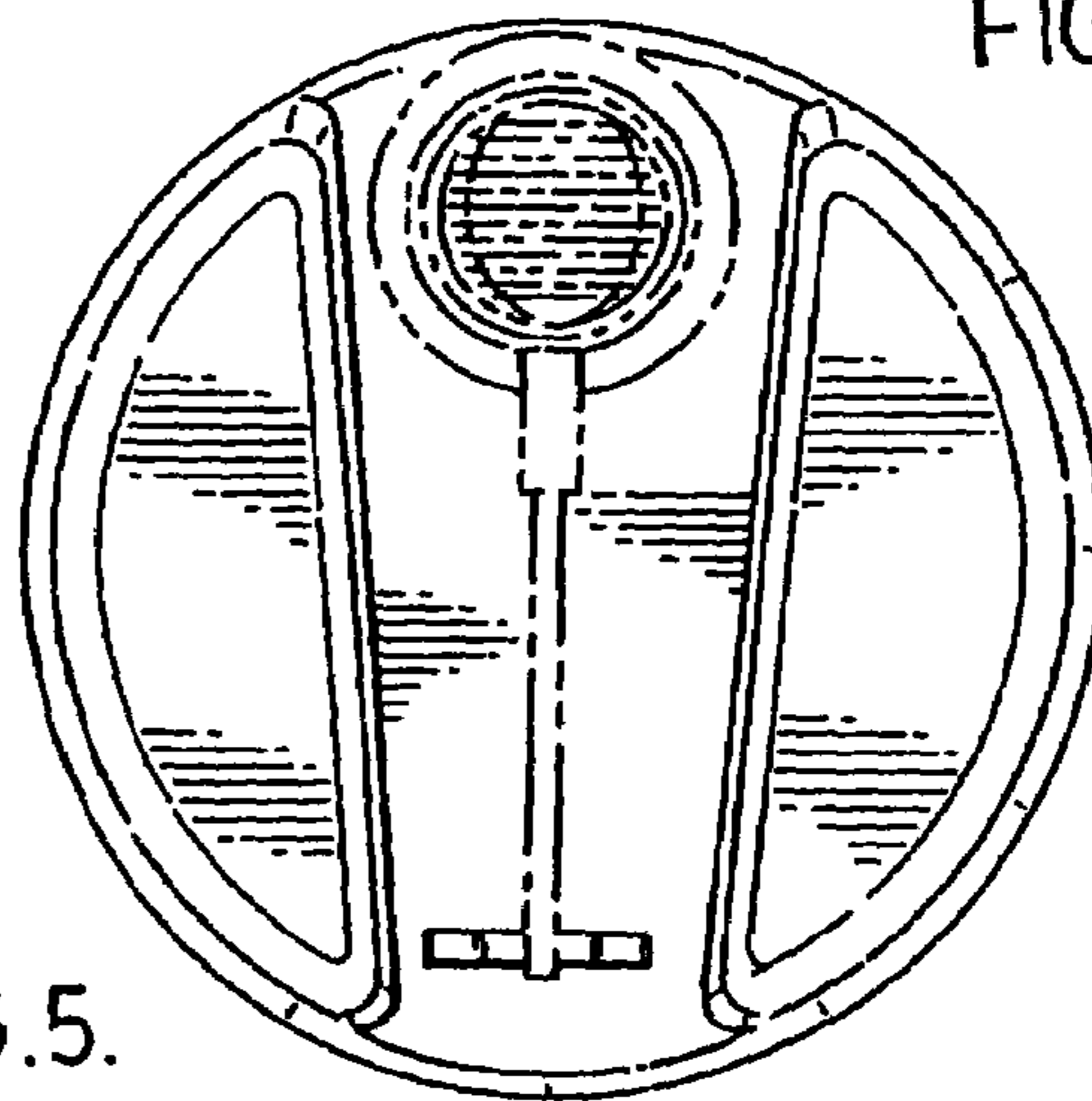

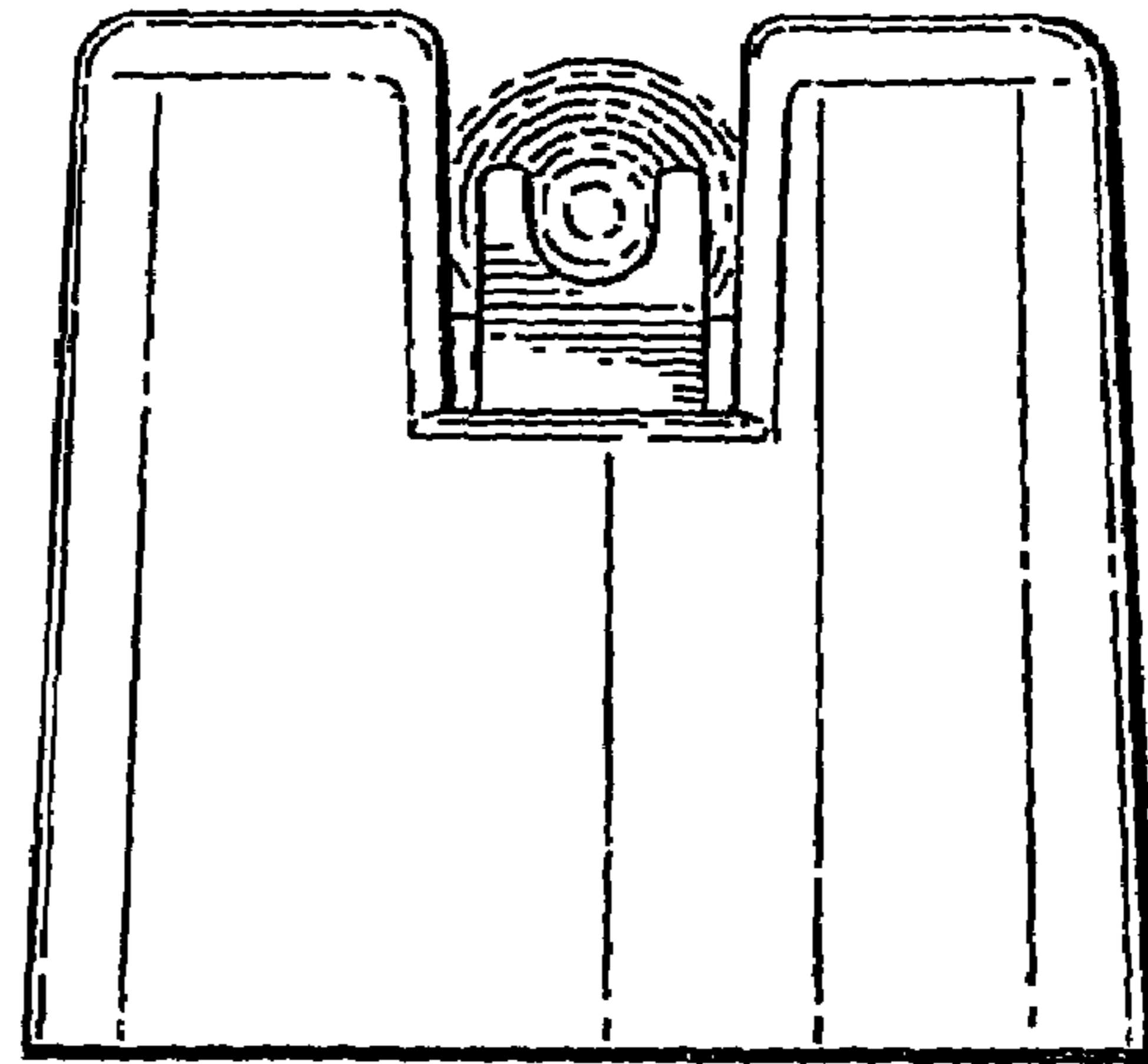
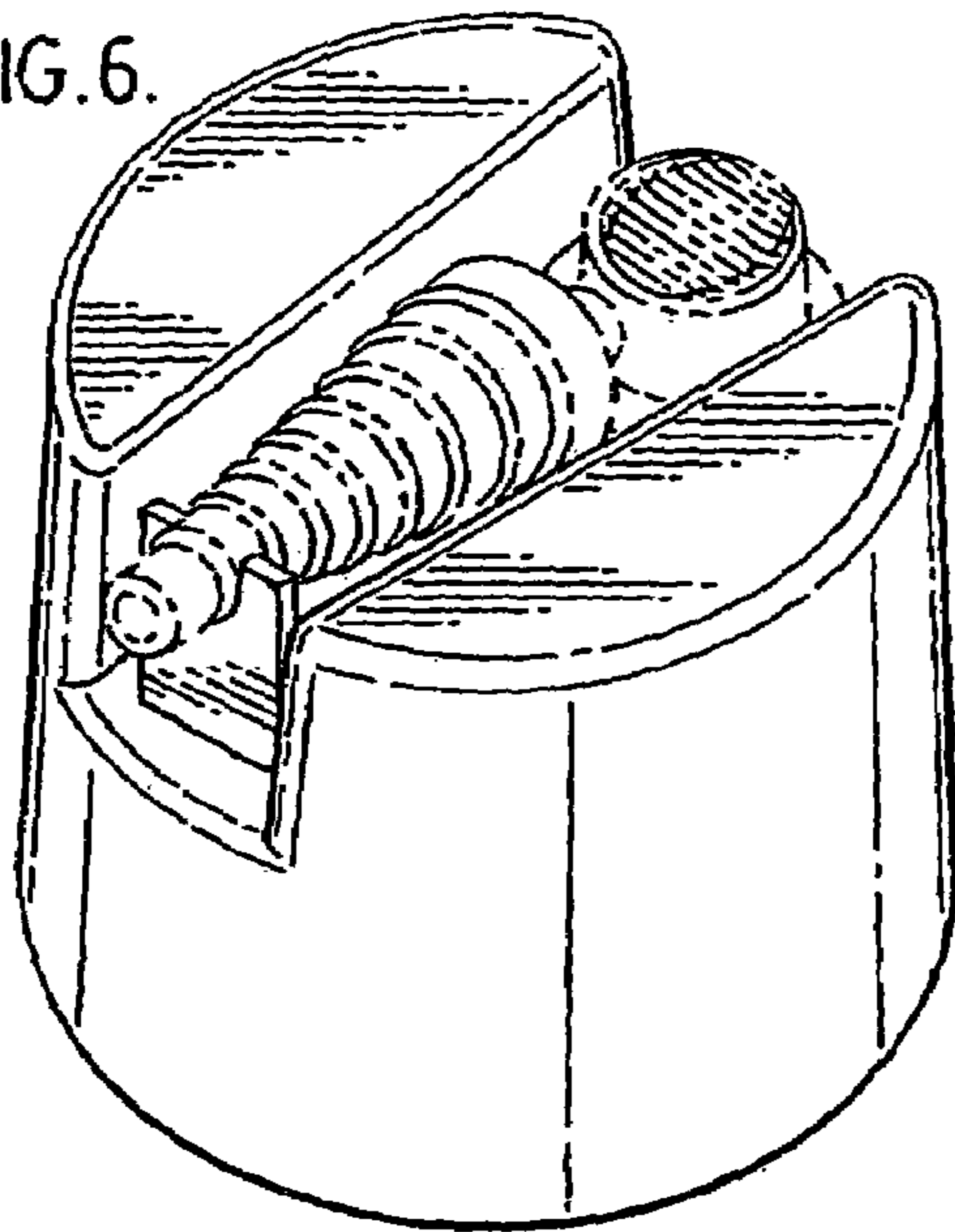

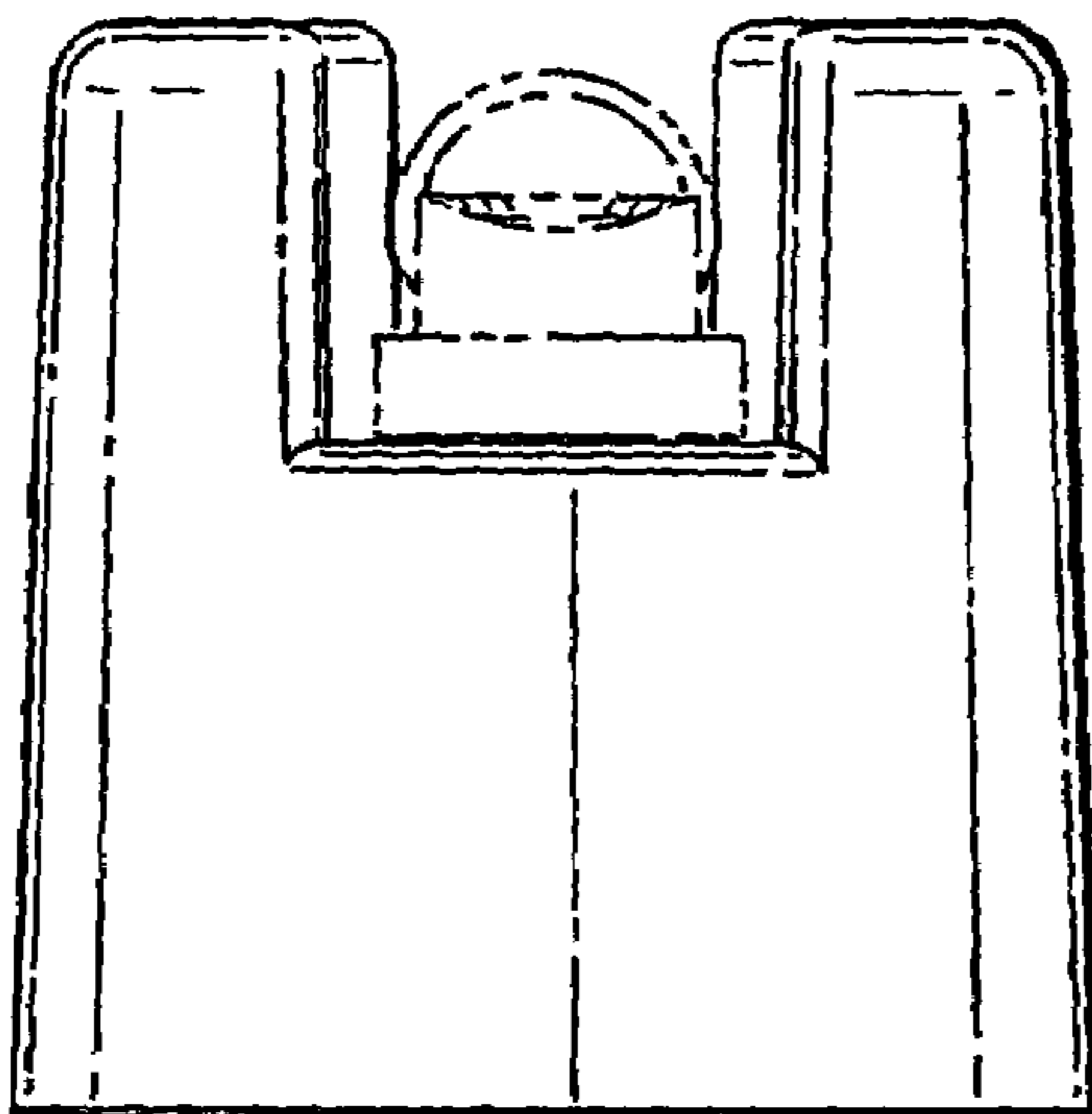

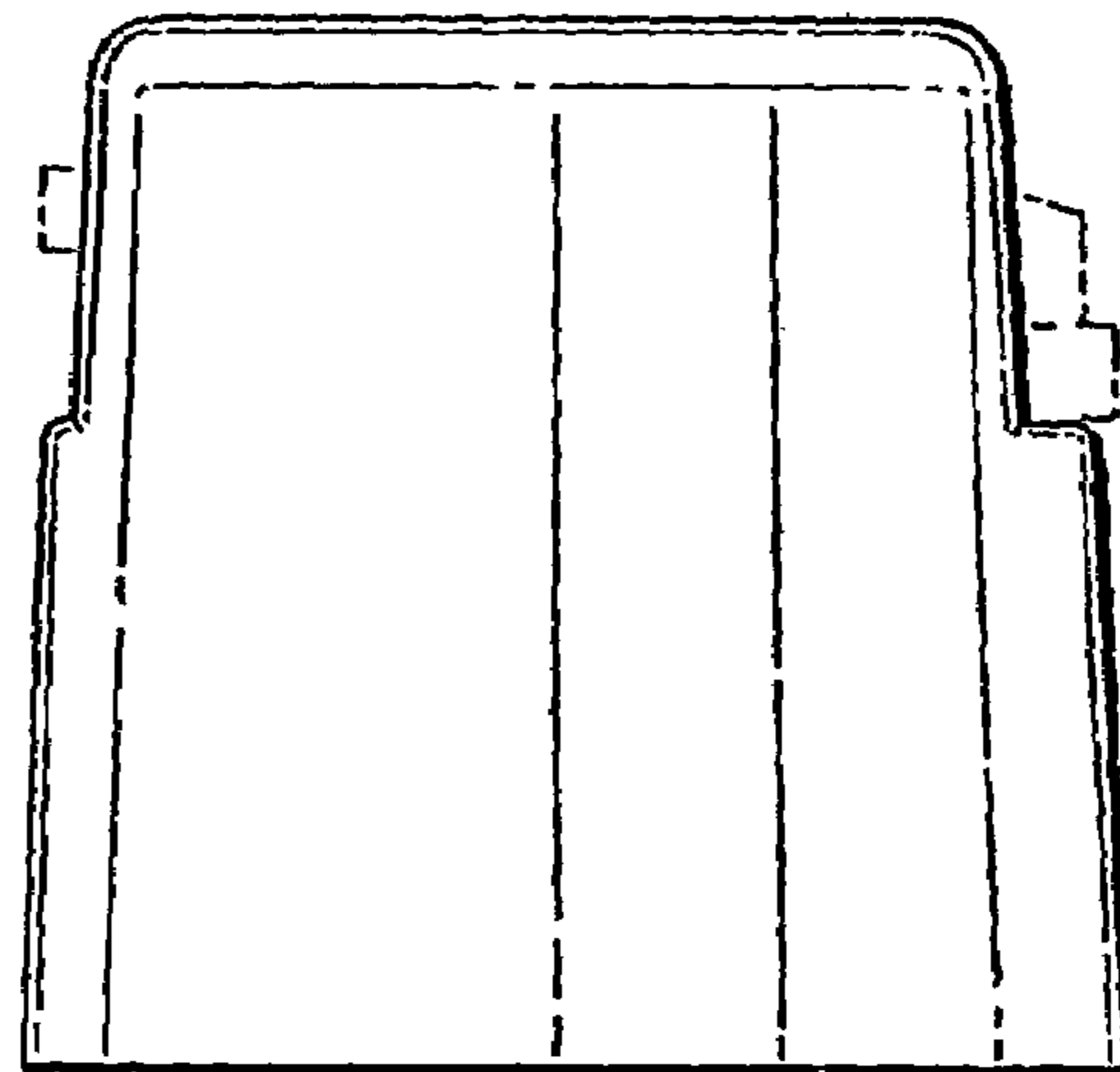

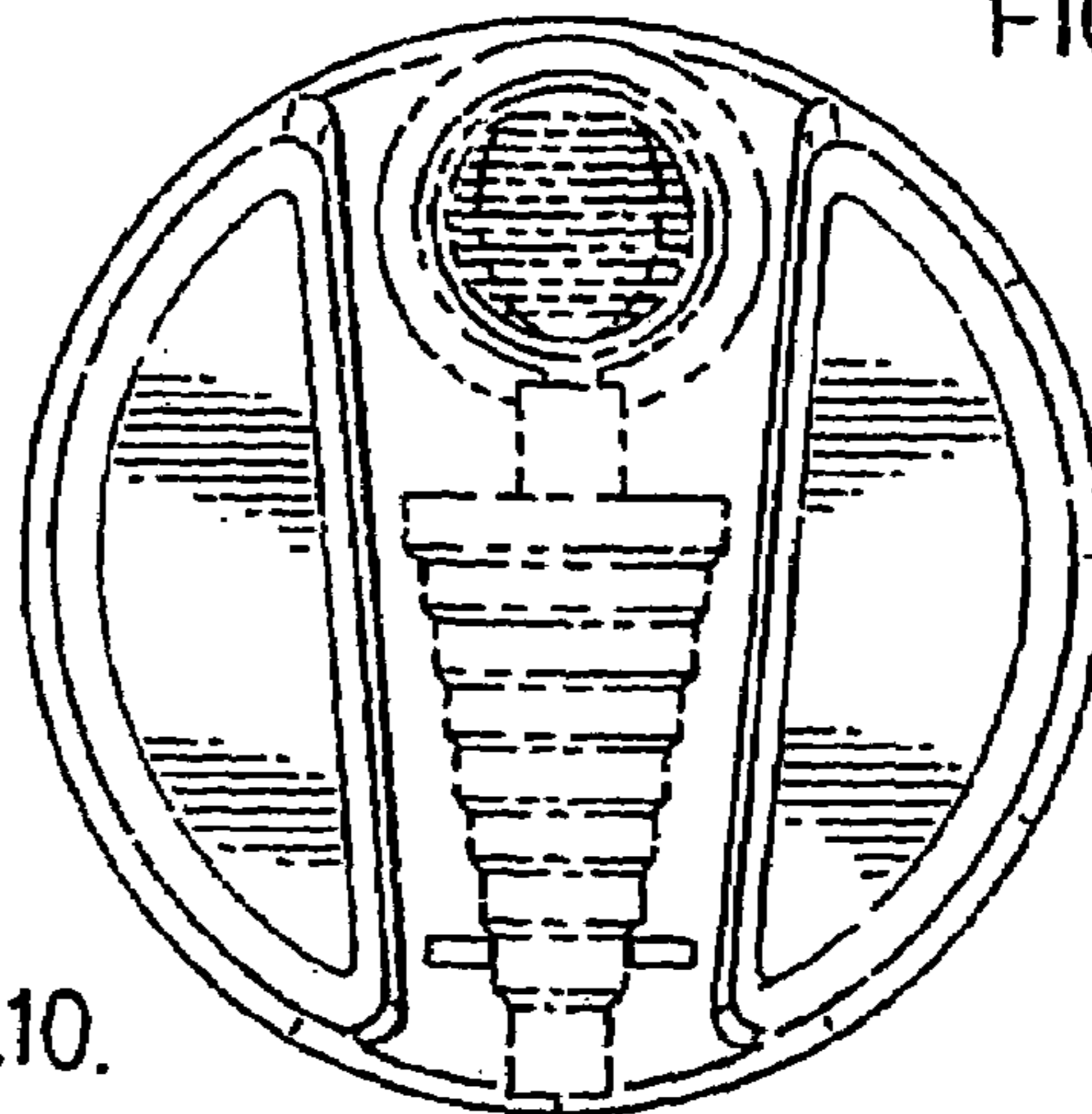
