**DESCRIPTION**

thereof;

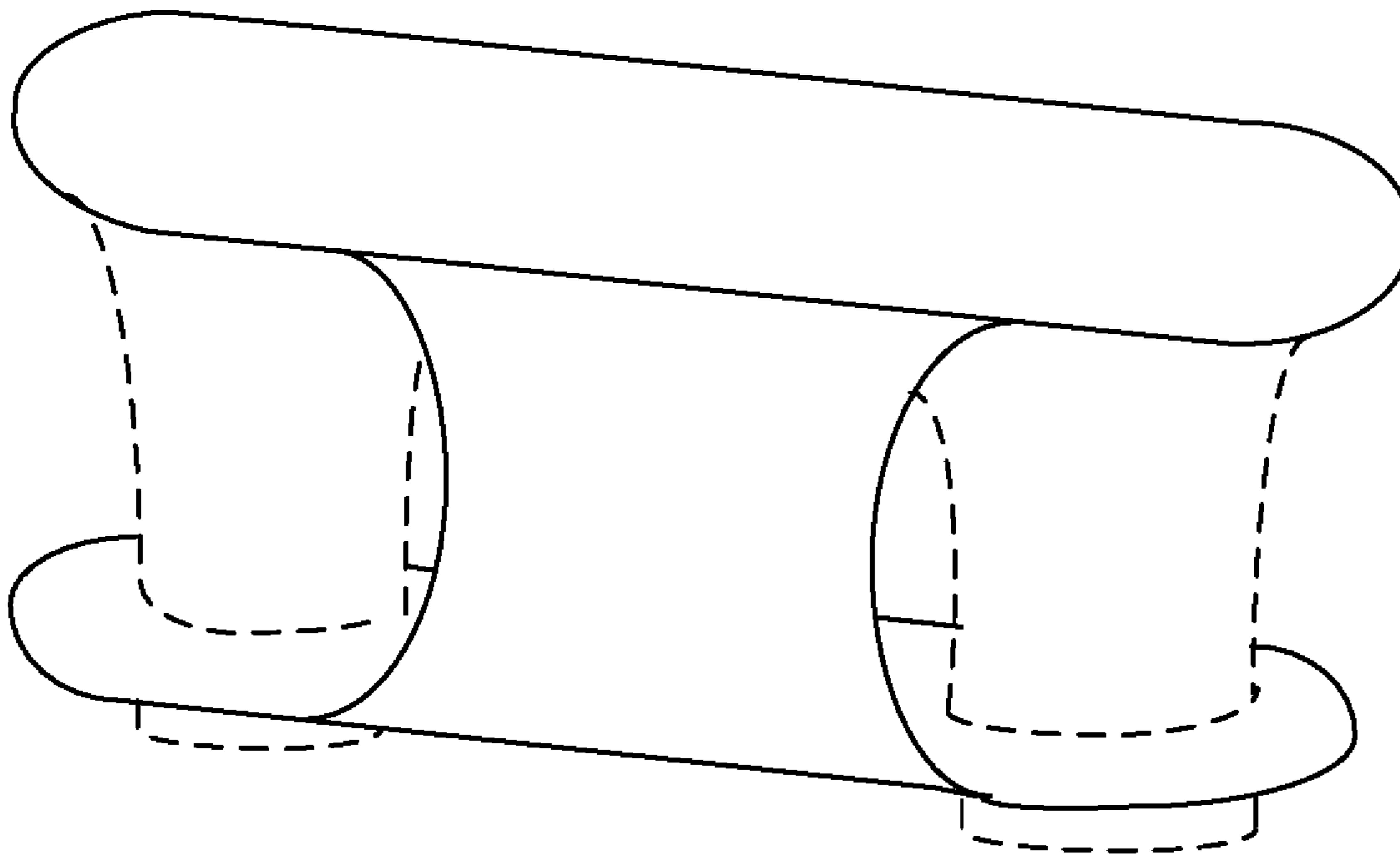
FIG. 3 is a side view thereof, the opposite side being a mirror

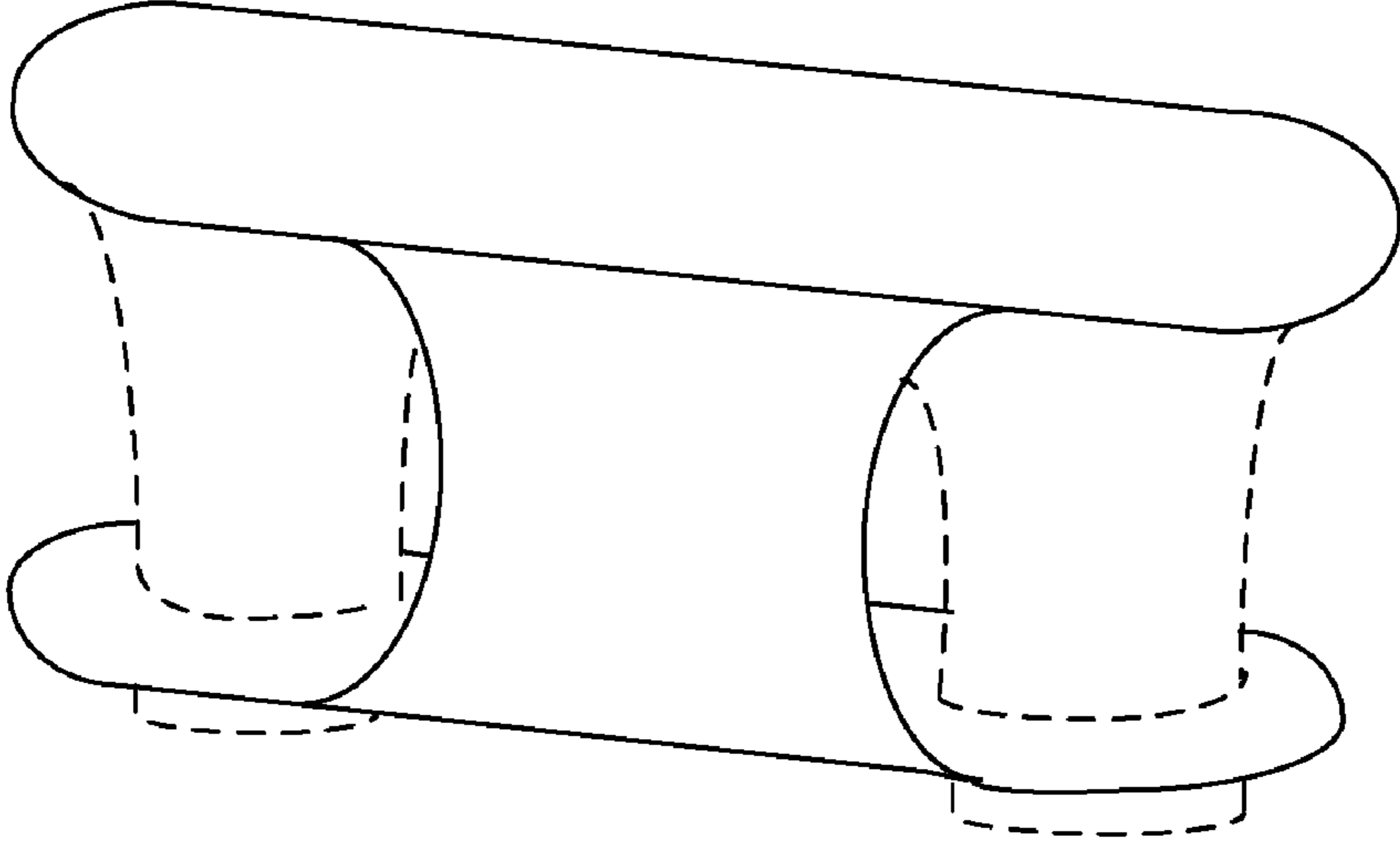

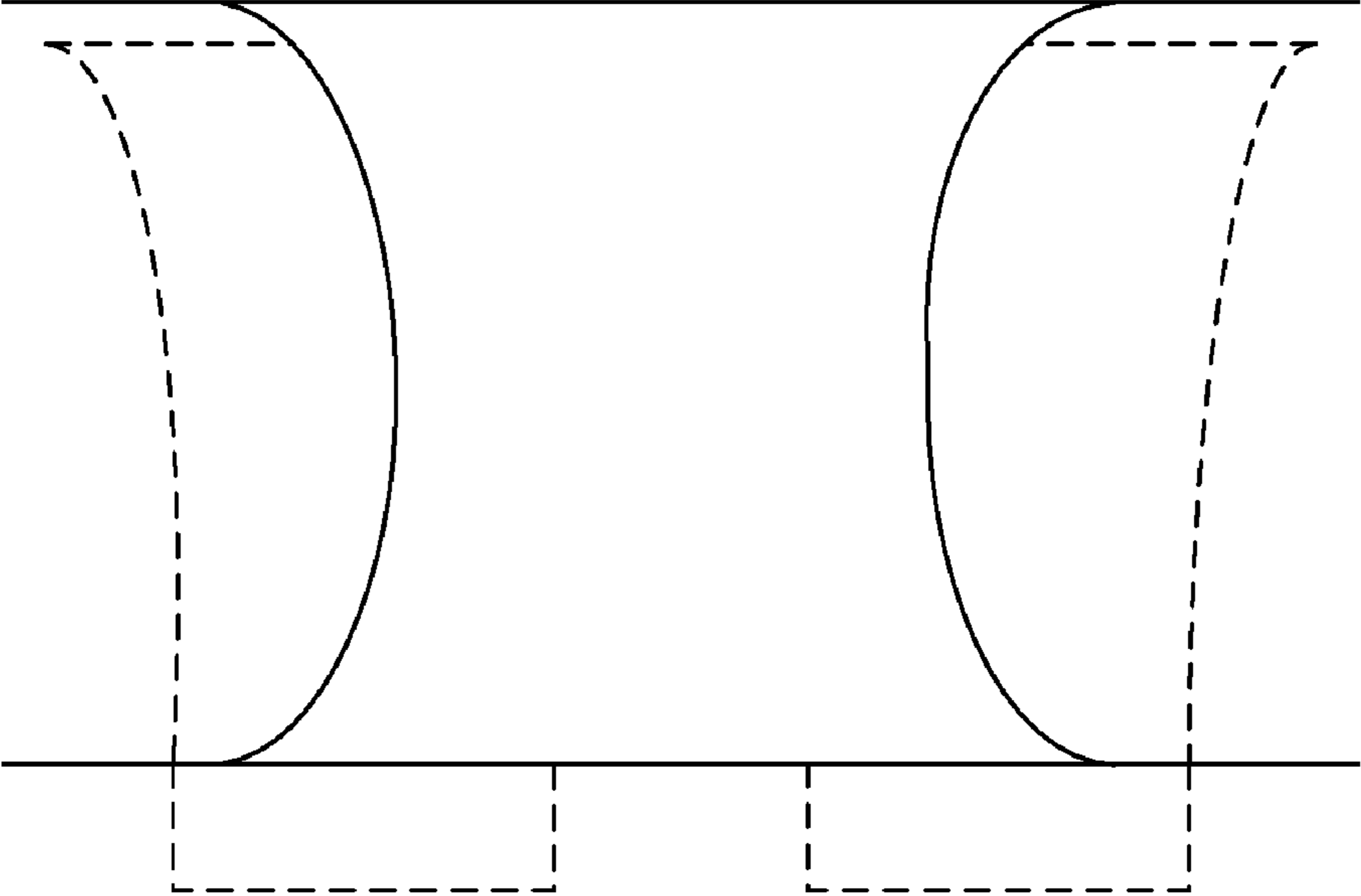

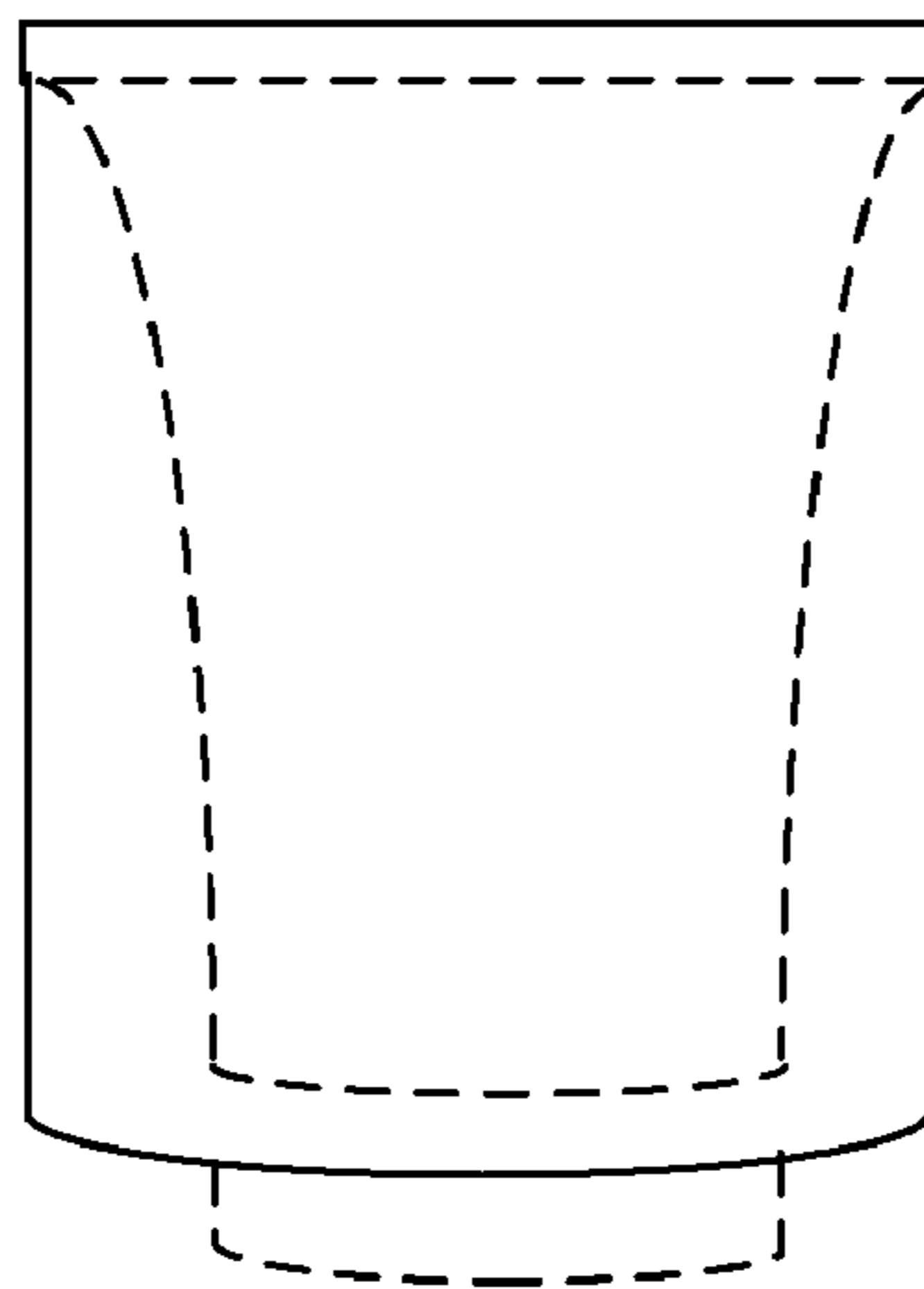

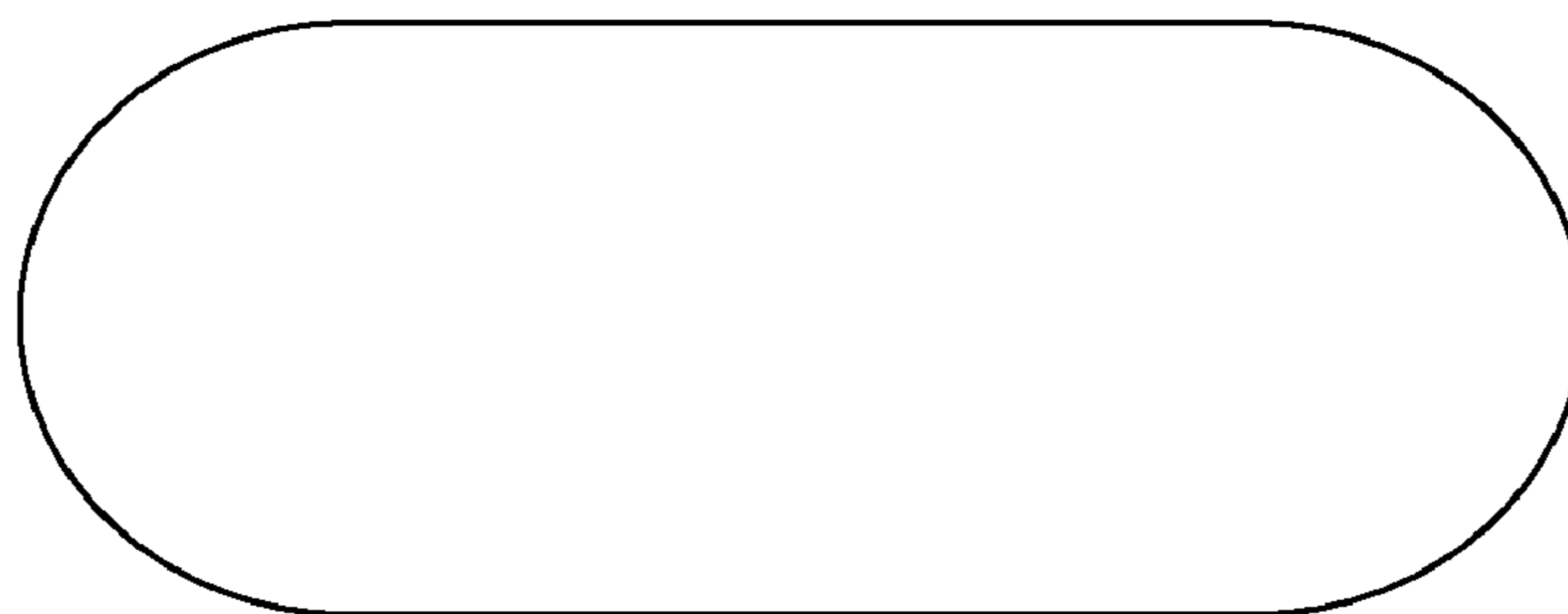

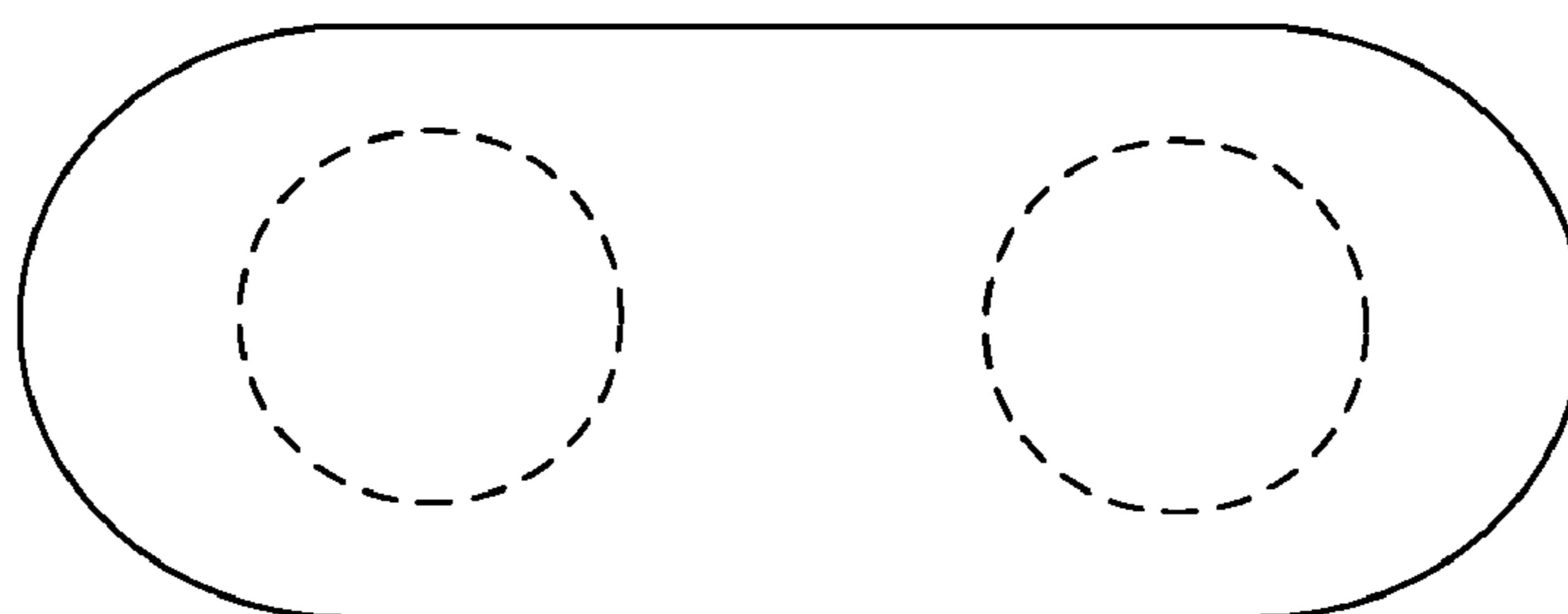
