(57) **CLAIM**

The ornamental design for a combined watch and pendant, as shown and described.

DESCRIPTION

The claimed combined watch and pendant can be used as a pendant watch for showing the time. If a chain is attached to it, it can also be used as a pendant.

FIG. 1 is a front elevational view of a combined watch and pendant showing my new design;

FIG. 5 is a top plan view thereof;

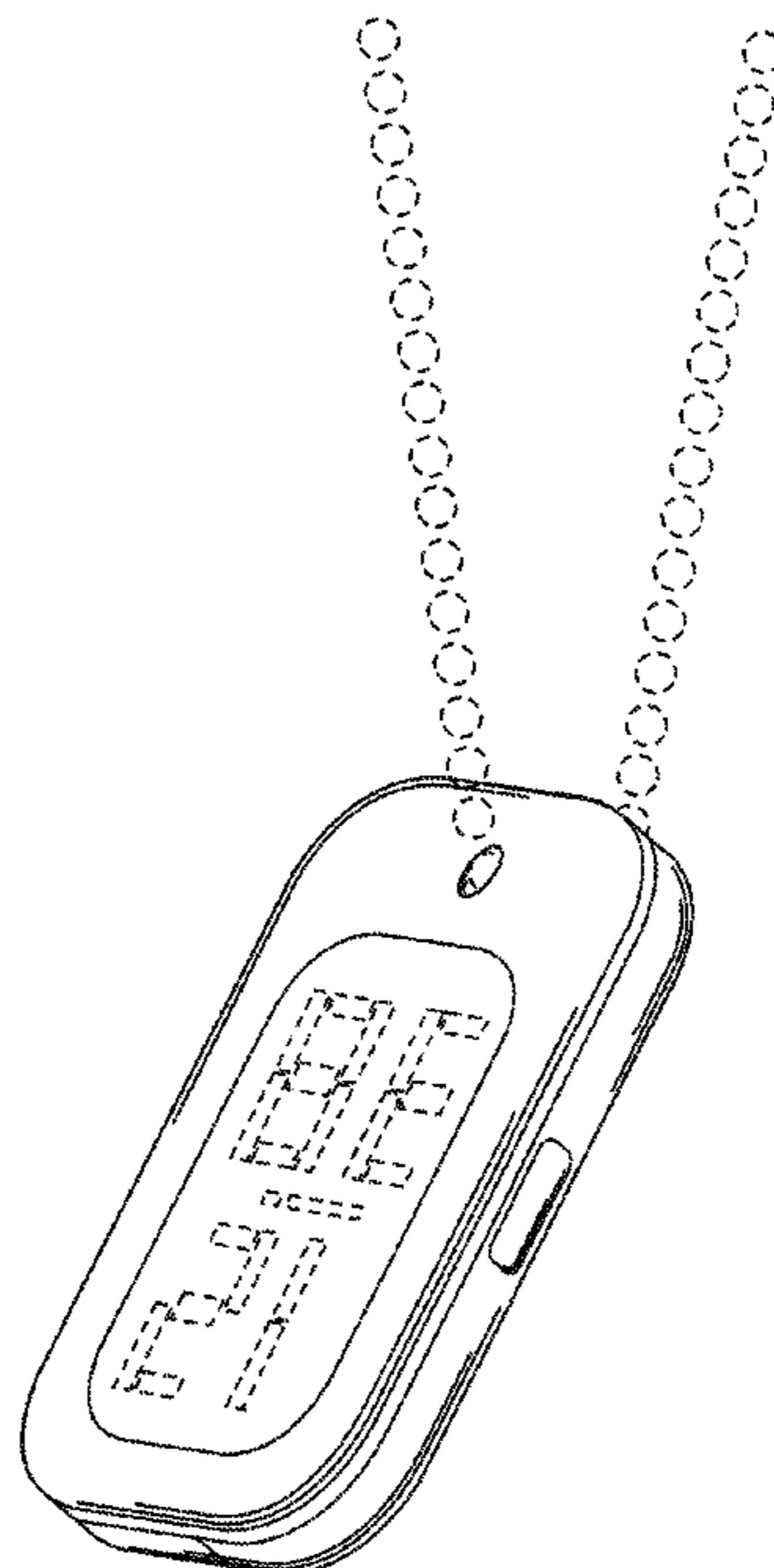
FIG. 6 is a bottom plan view thereof;

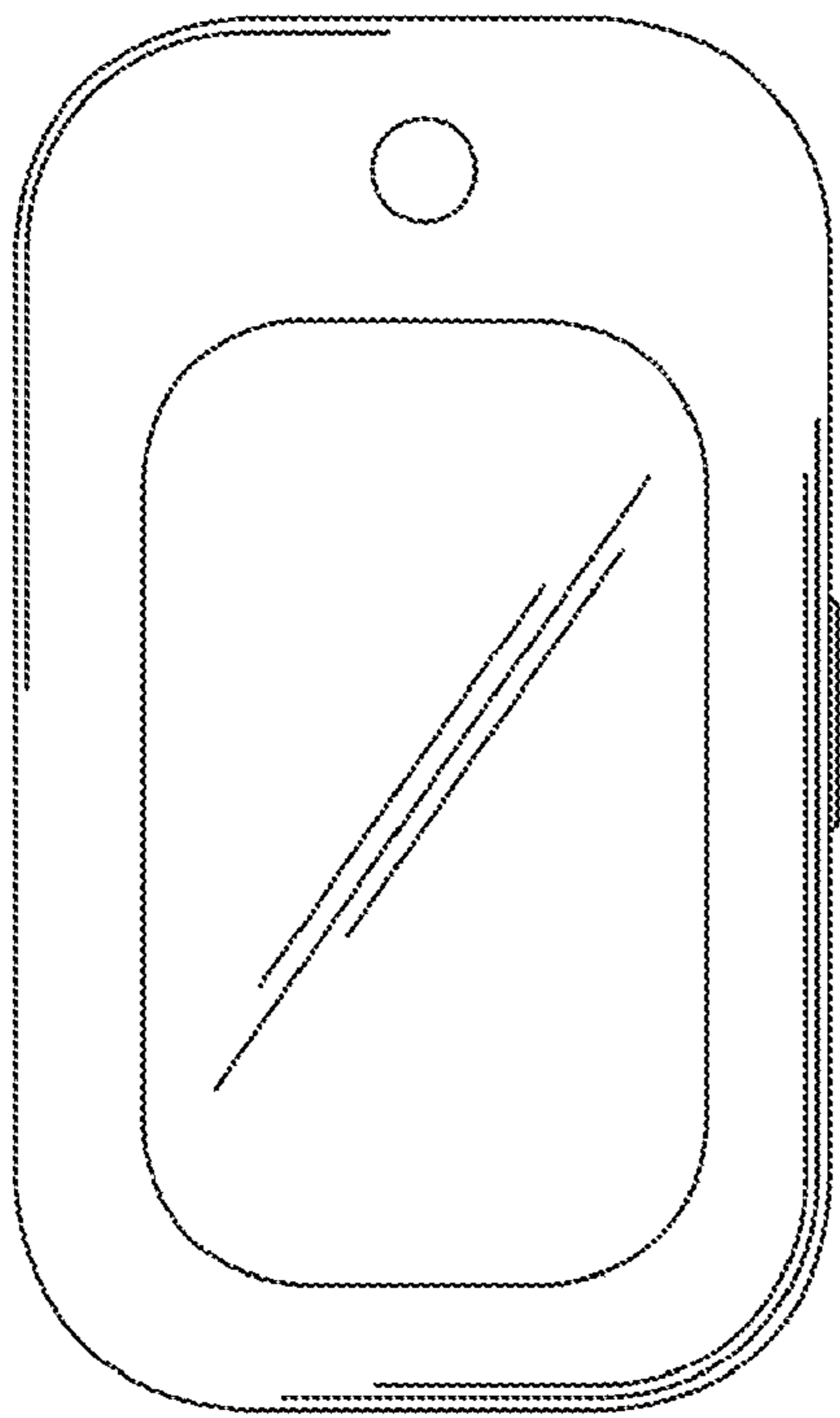

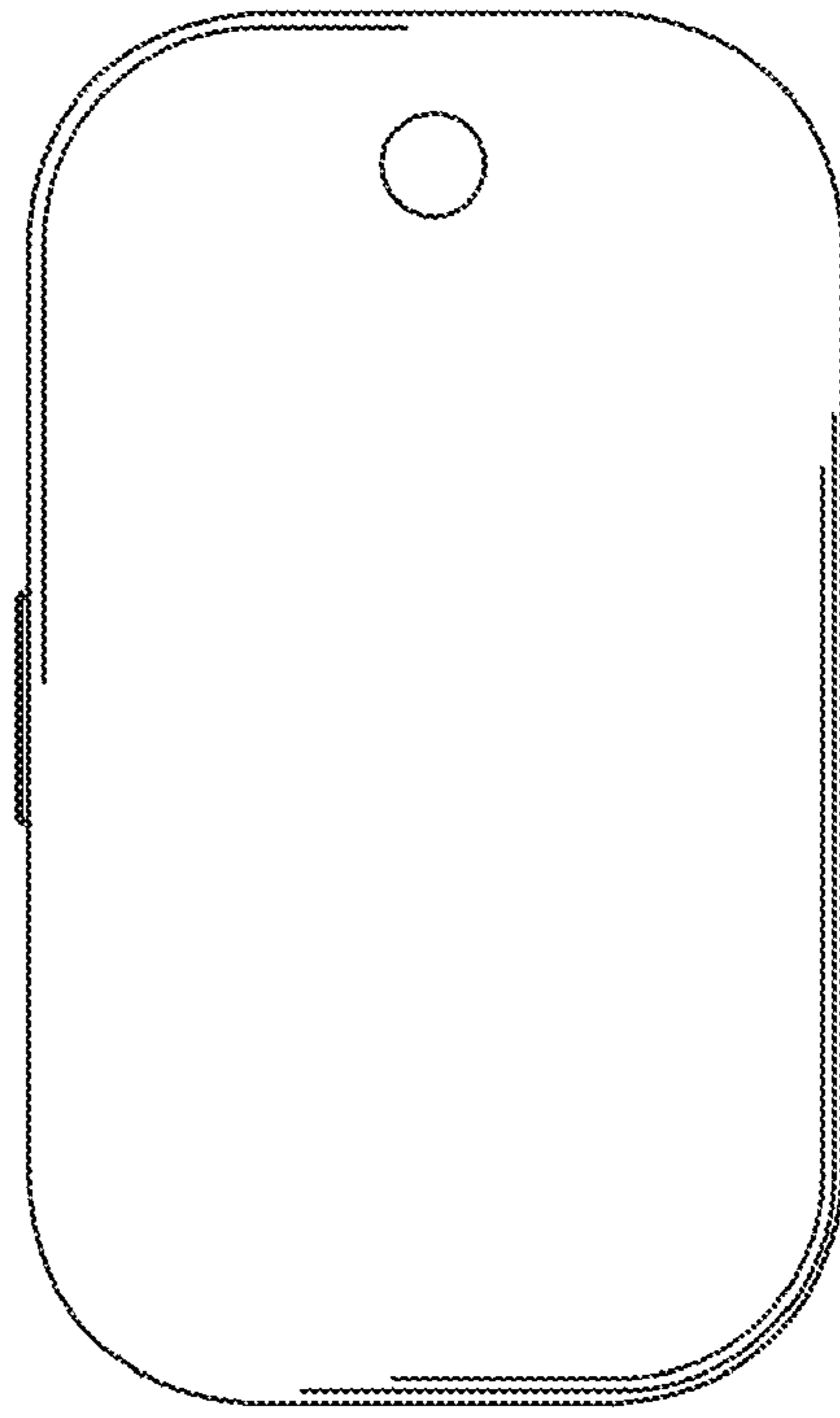

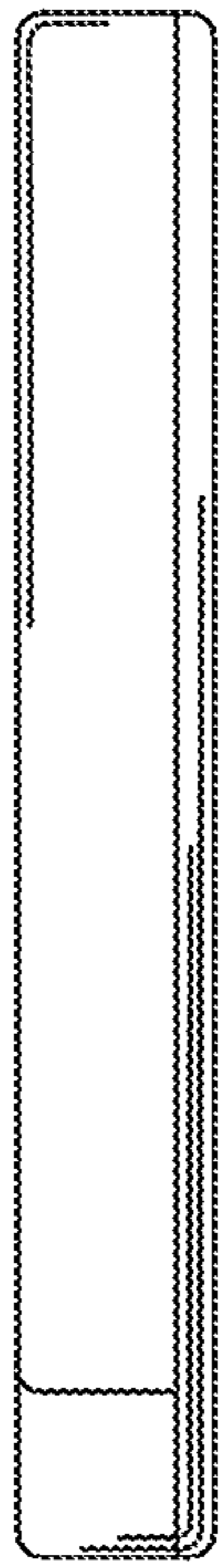

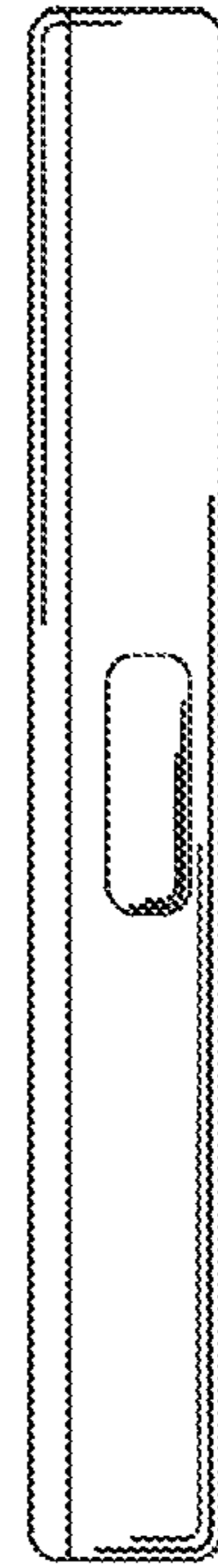

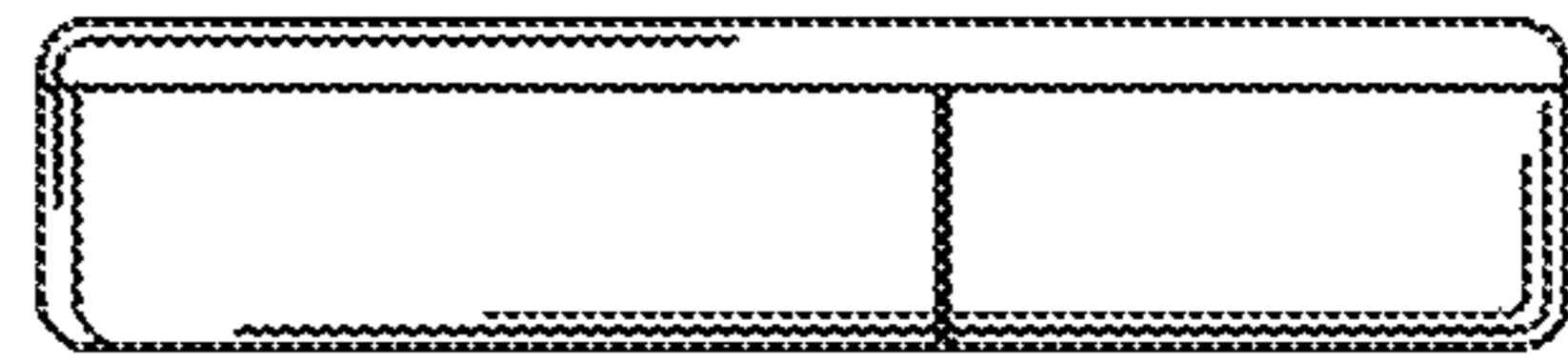

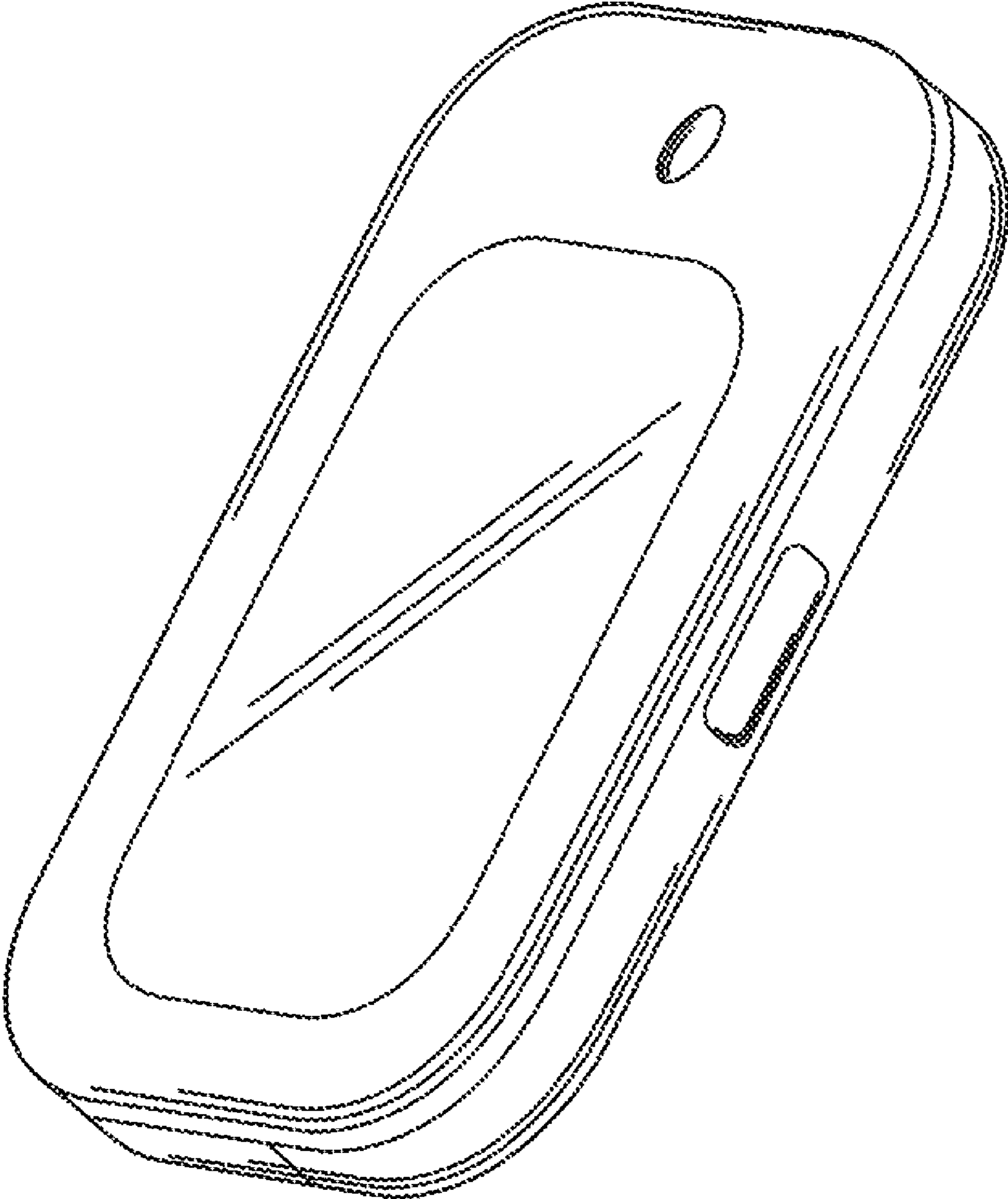

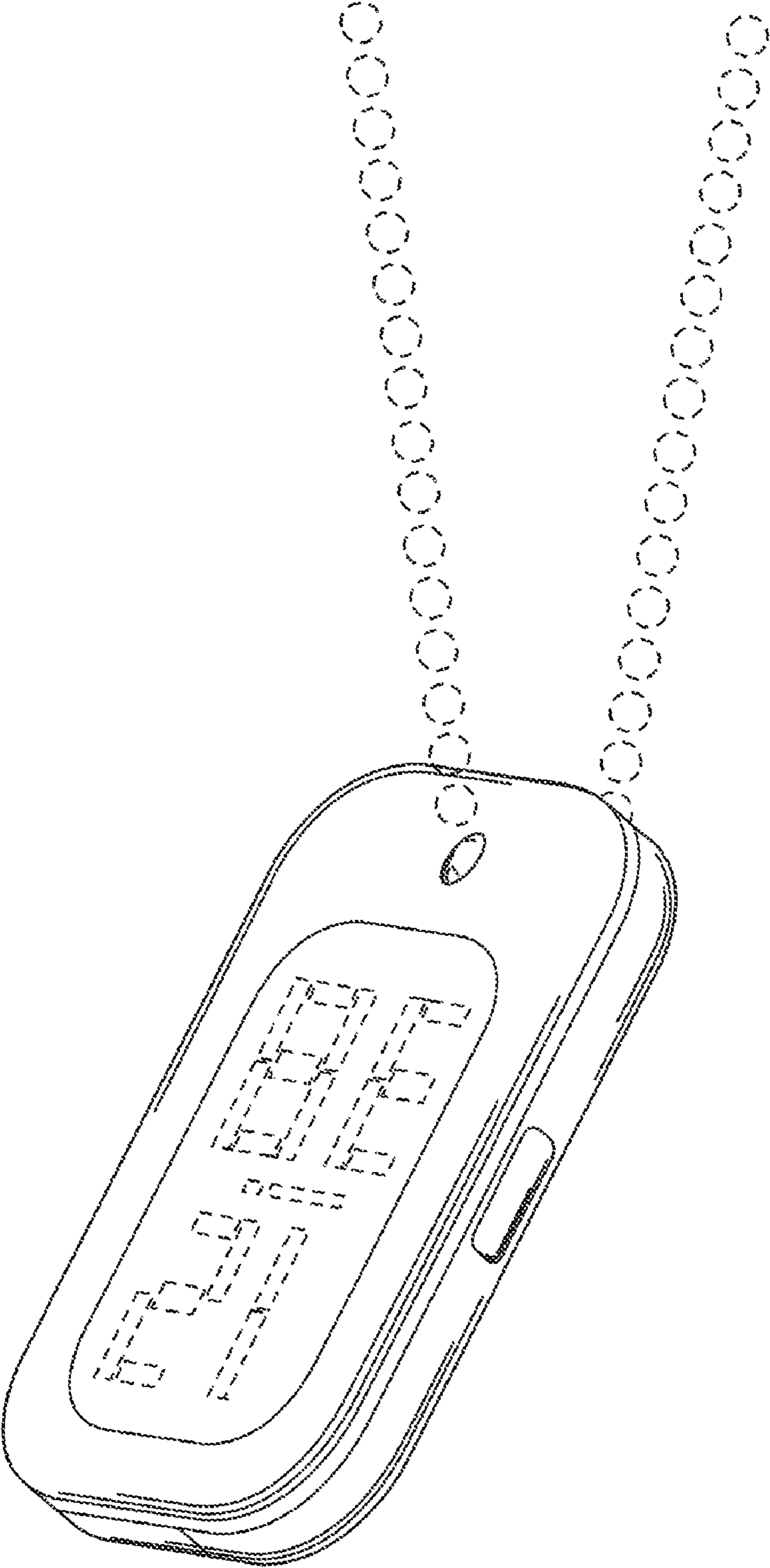
