FIG. 3 is a side view thereof

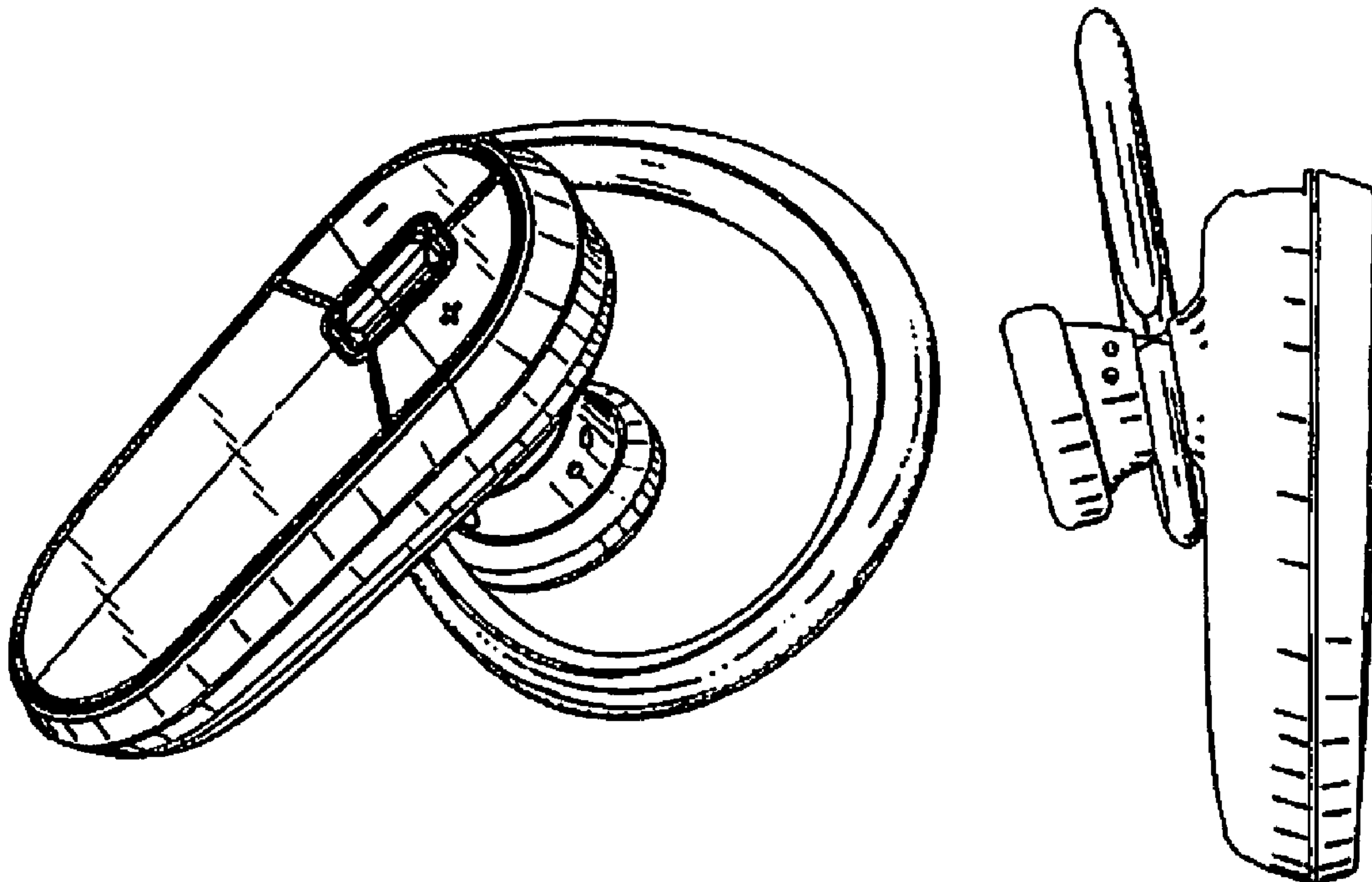
FIG. 4 is a top view thereof

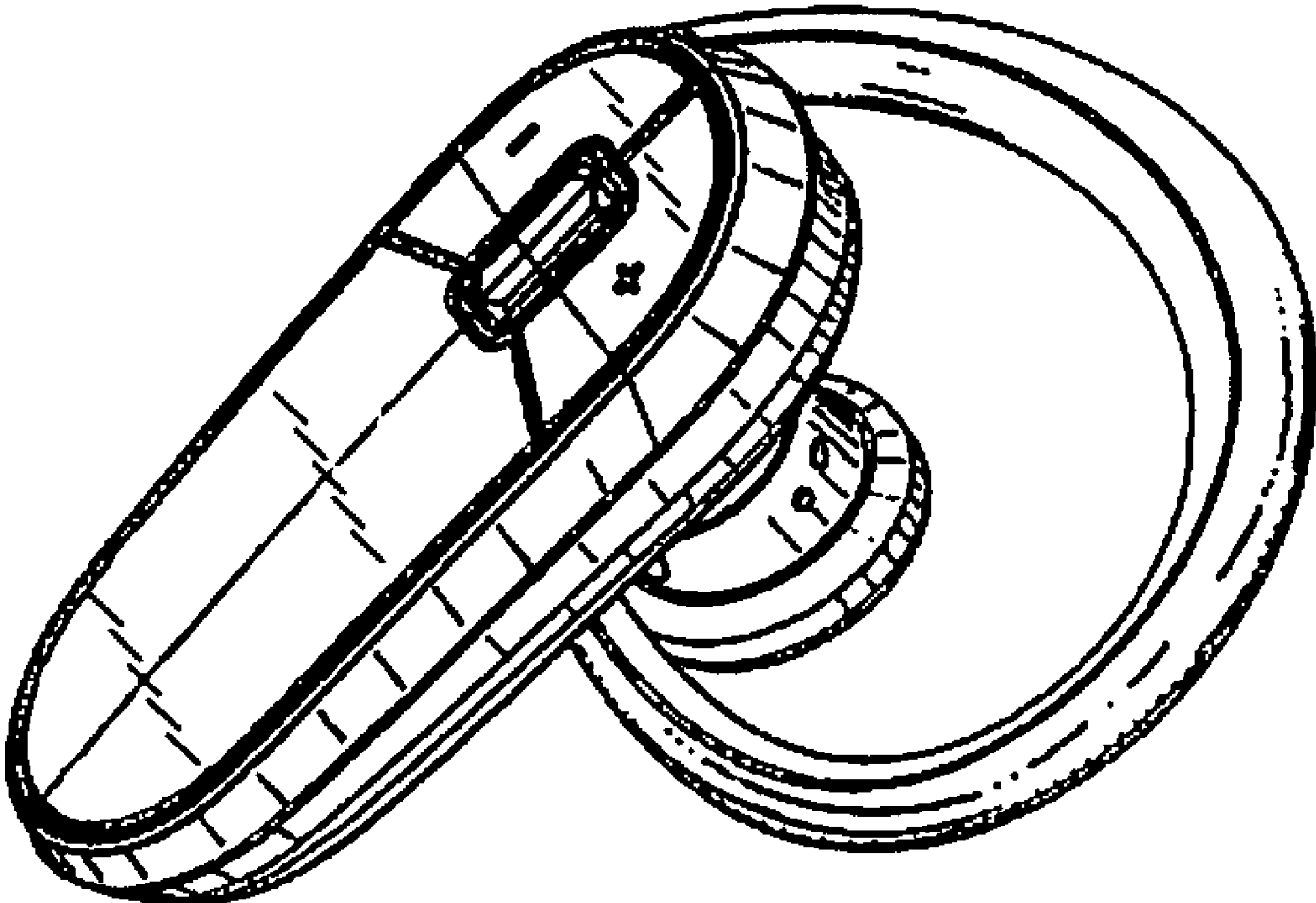

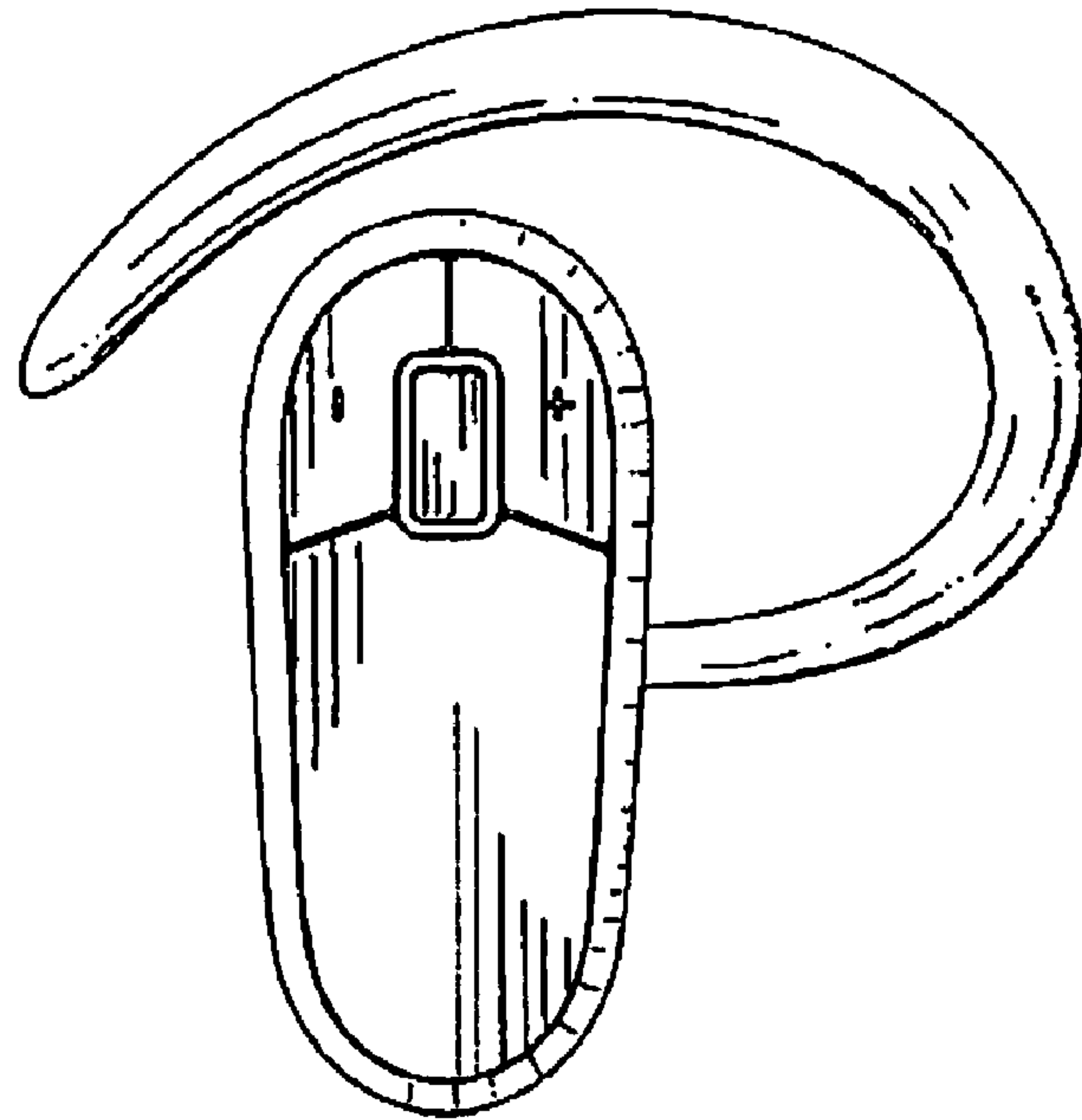

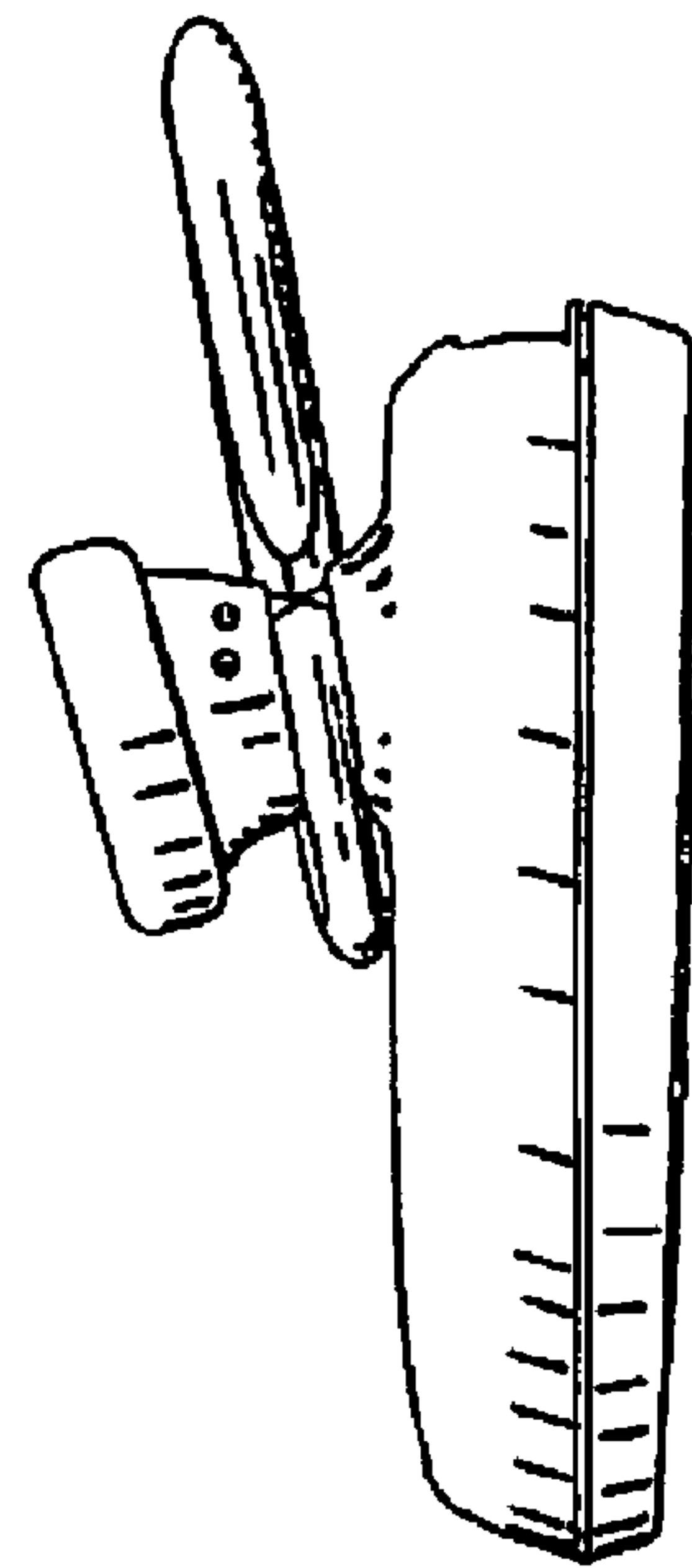

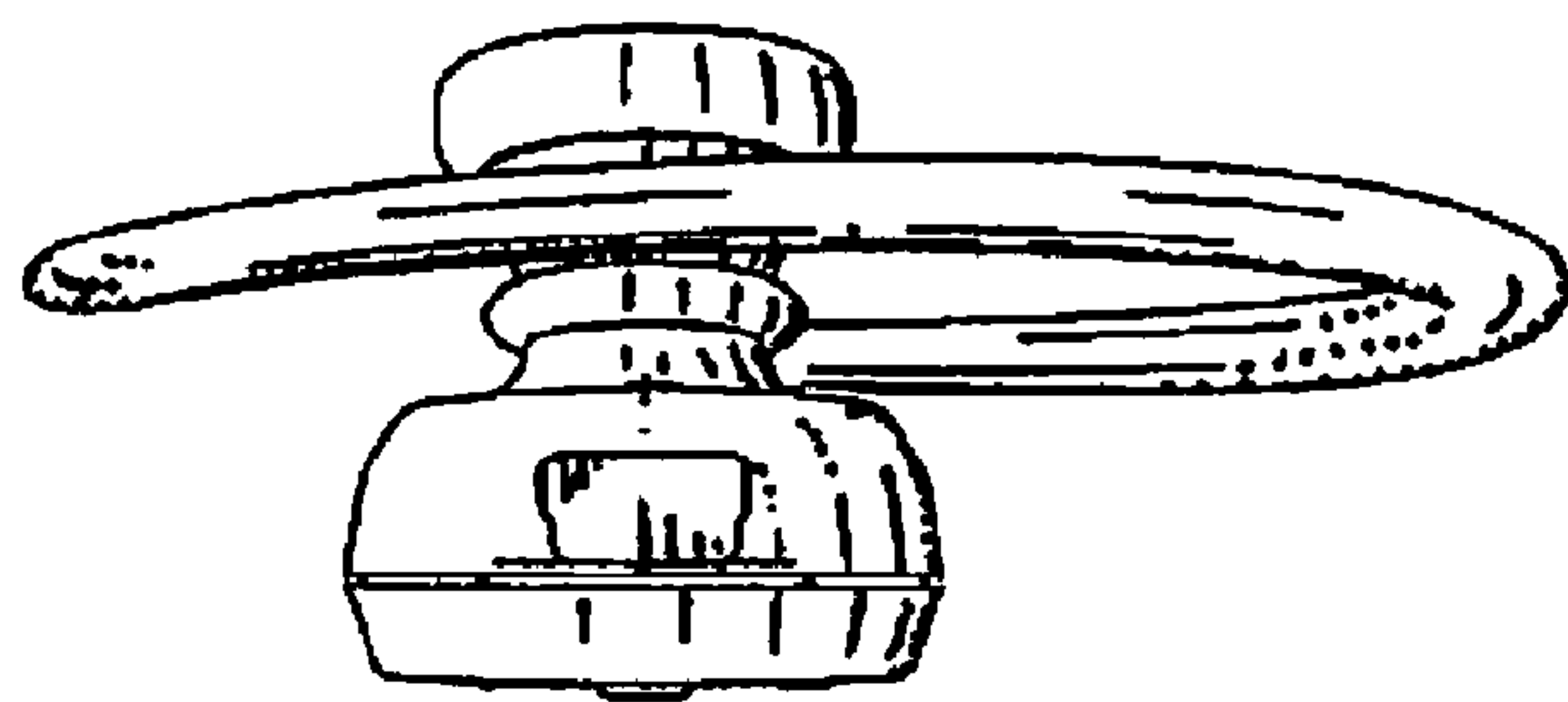

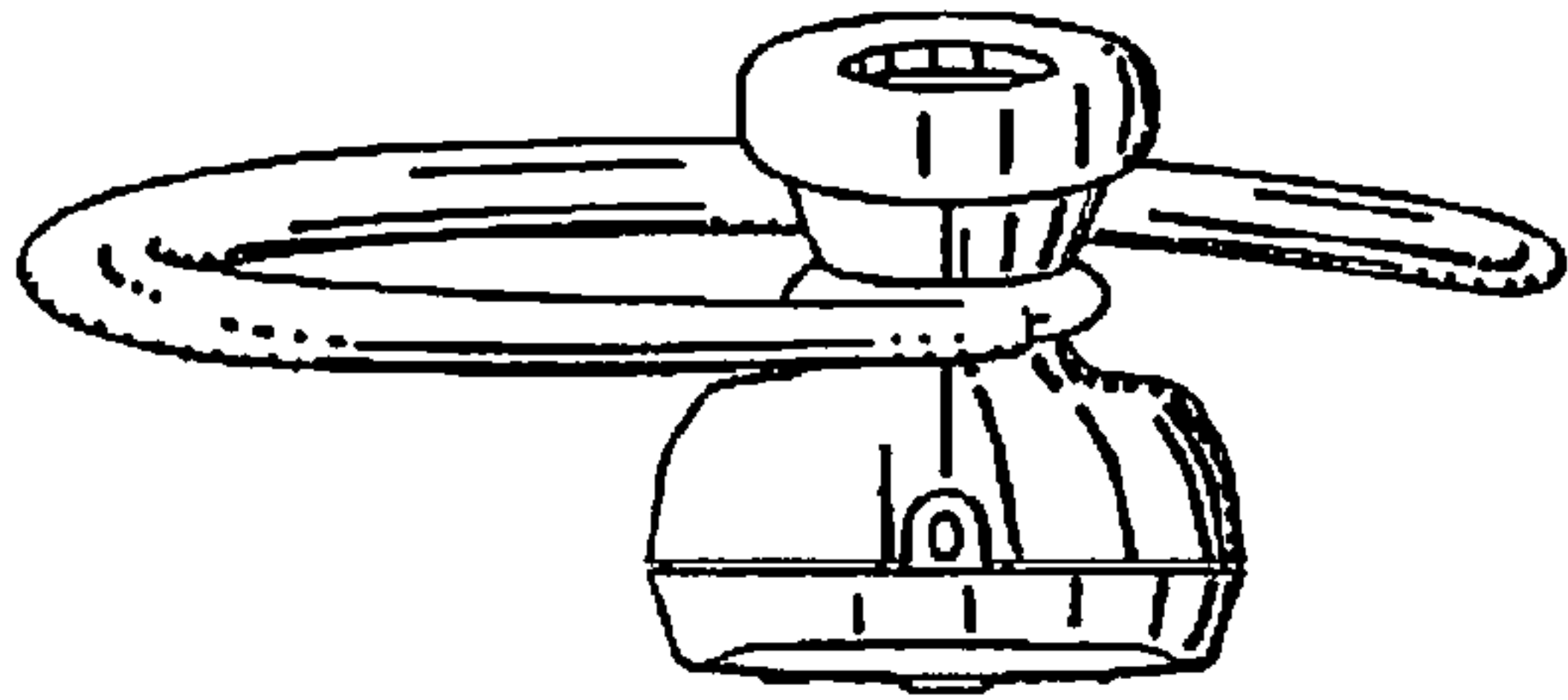

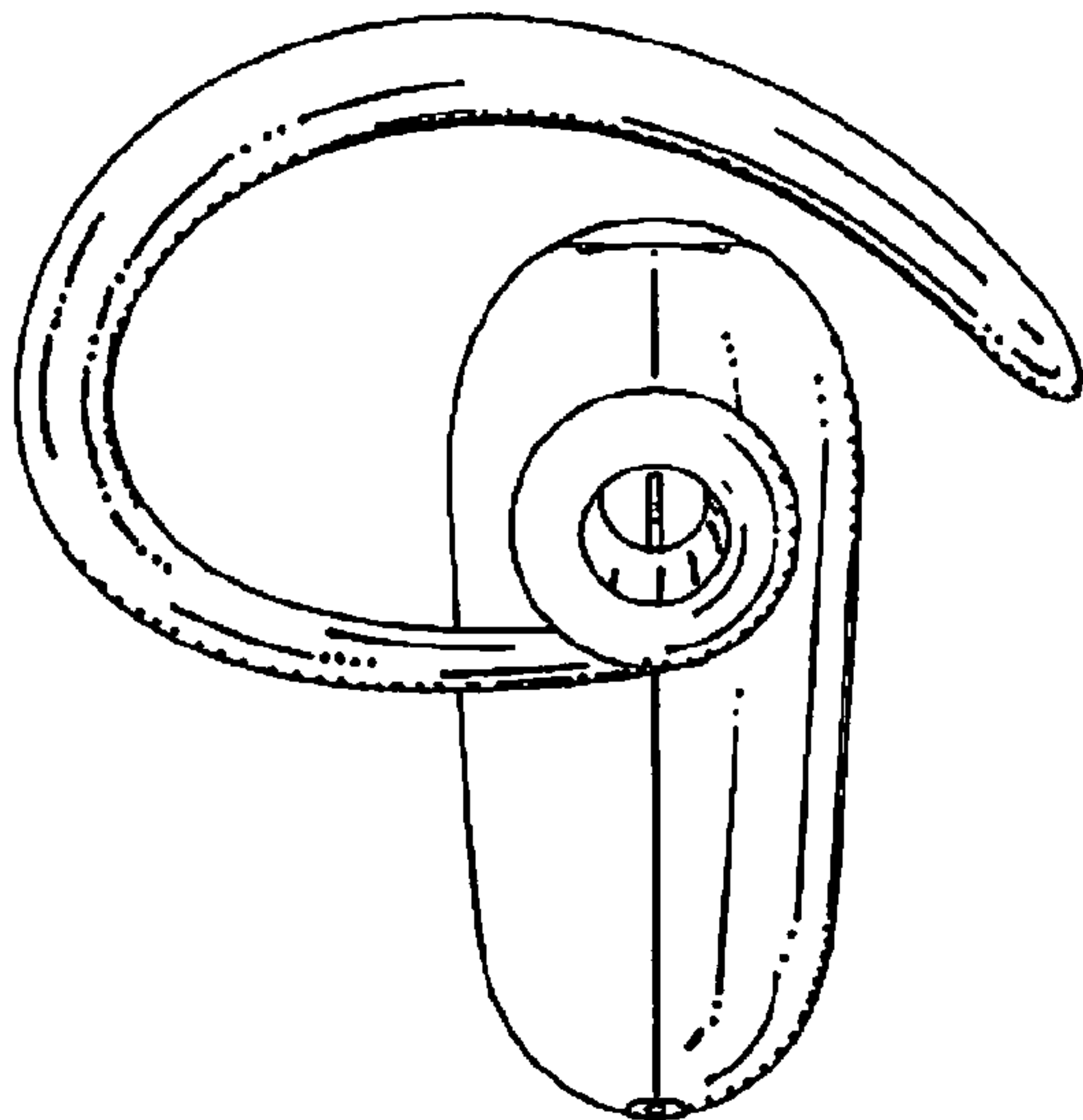

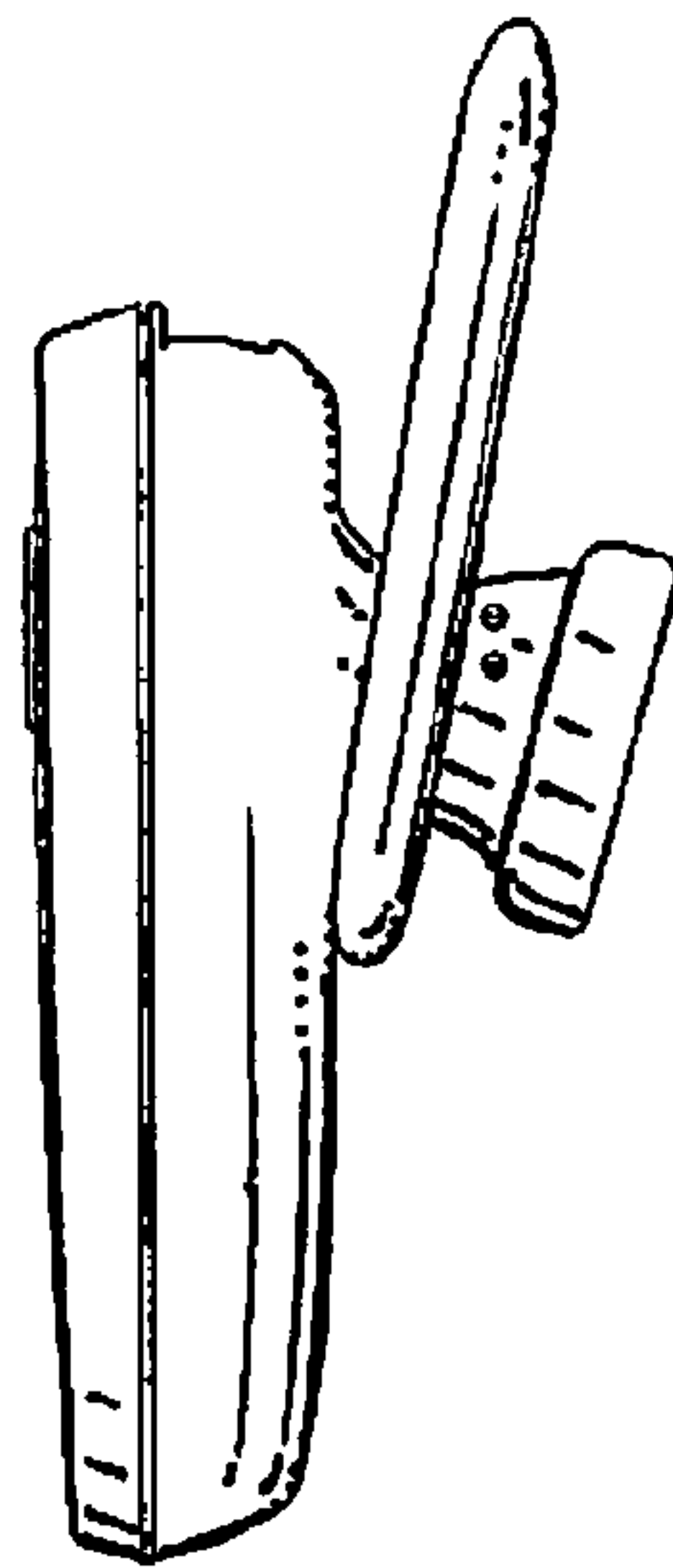
