DESCRIPTION

FIG. 1 is a top plan view of a money store showing my new design,

FIG. 5 is a left side elevational view thereof,

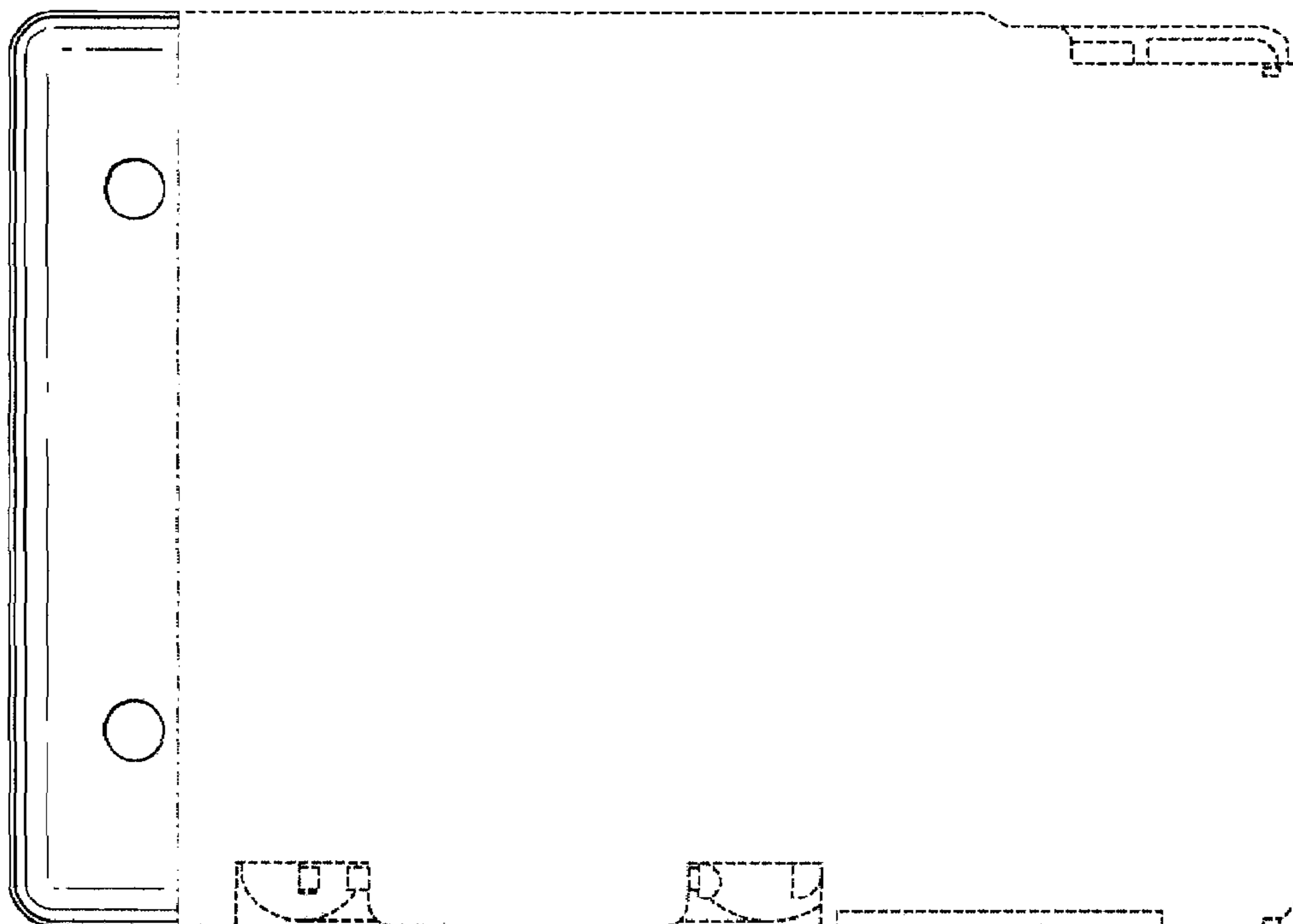
FIG. 6 is a right side elevational view thereof; and,

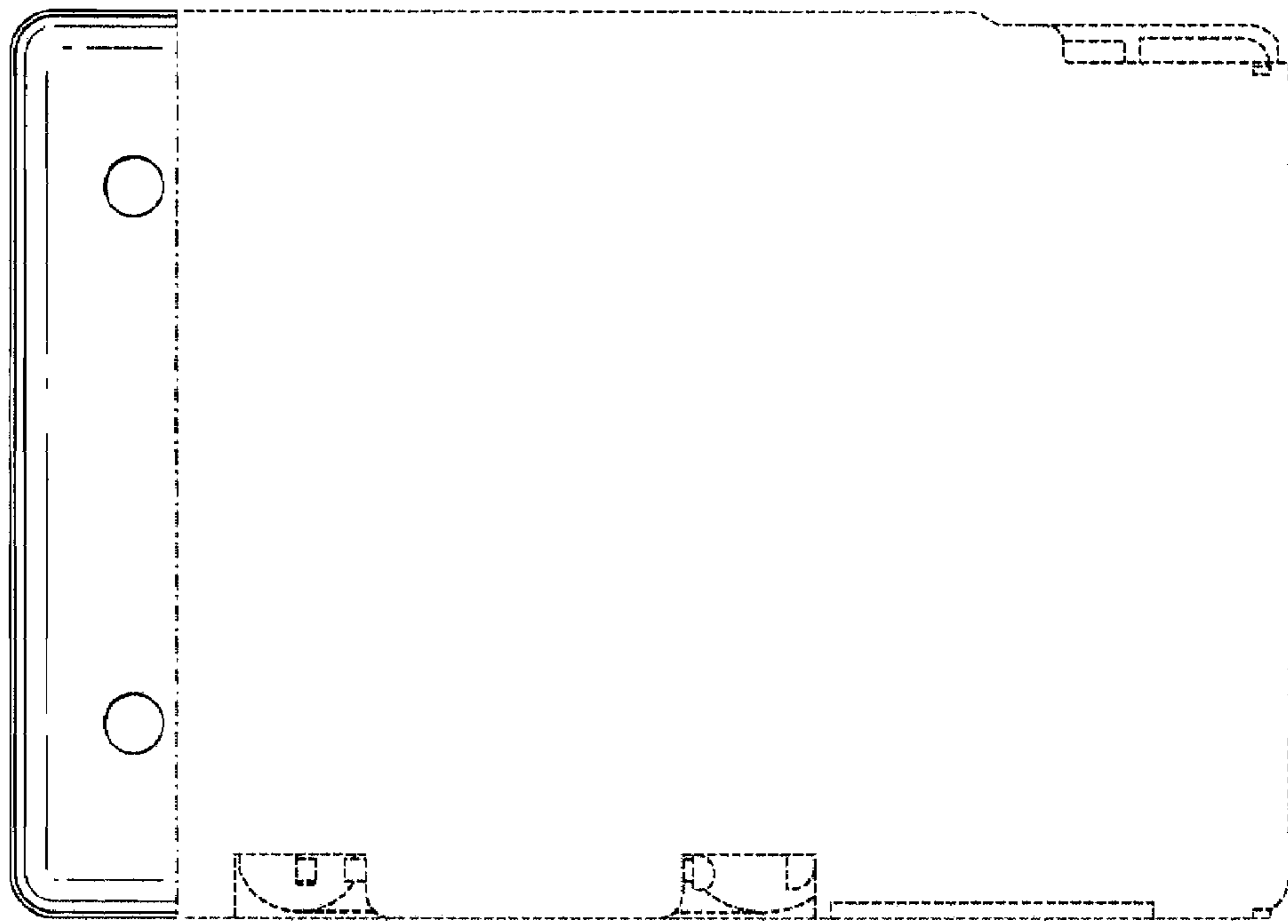

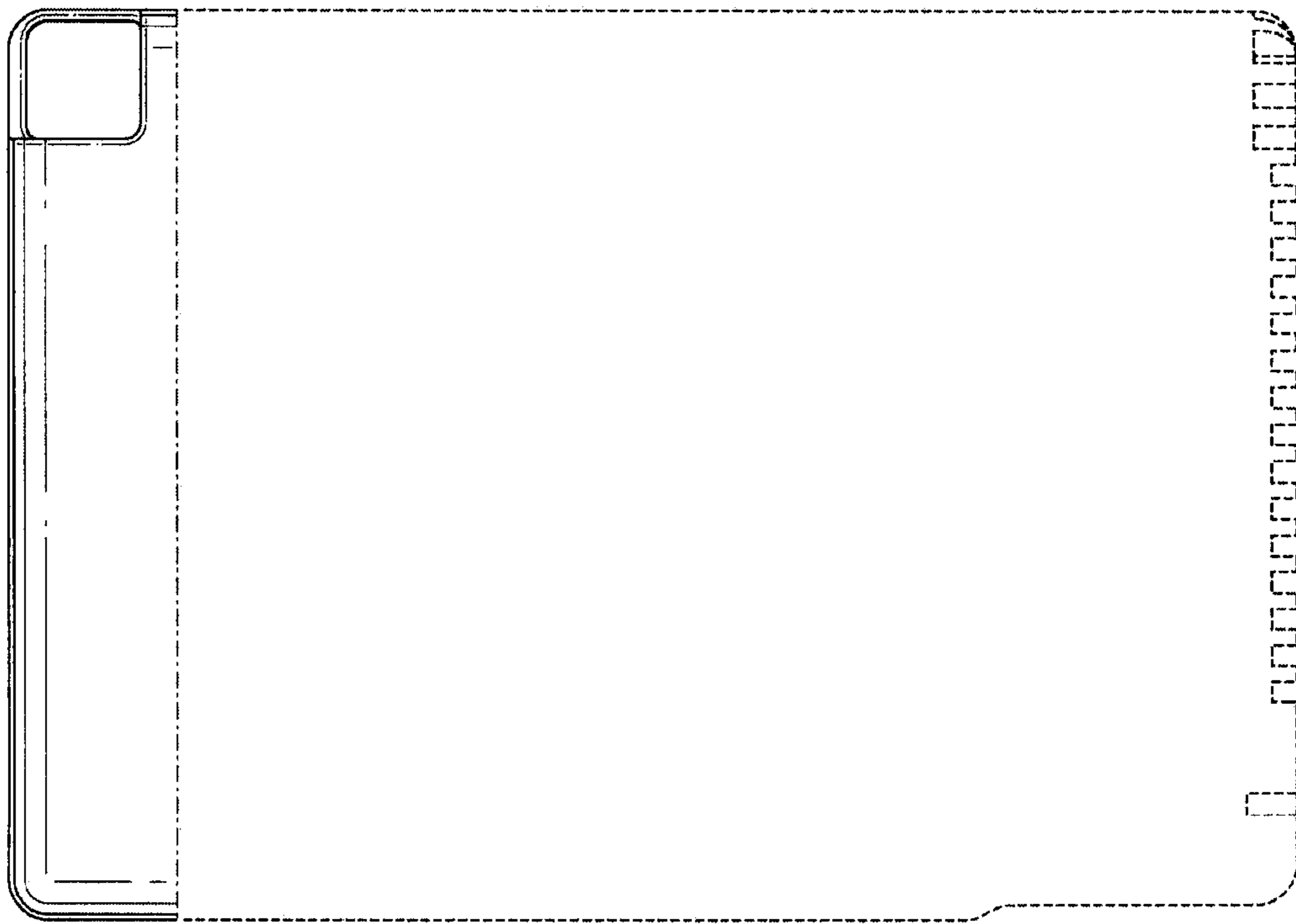

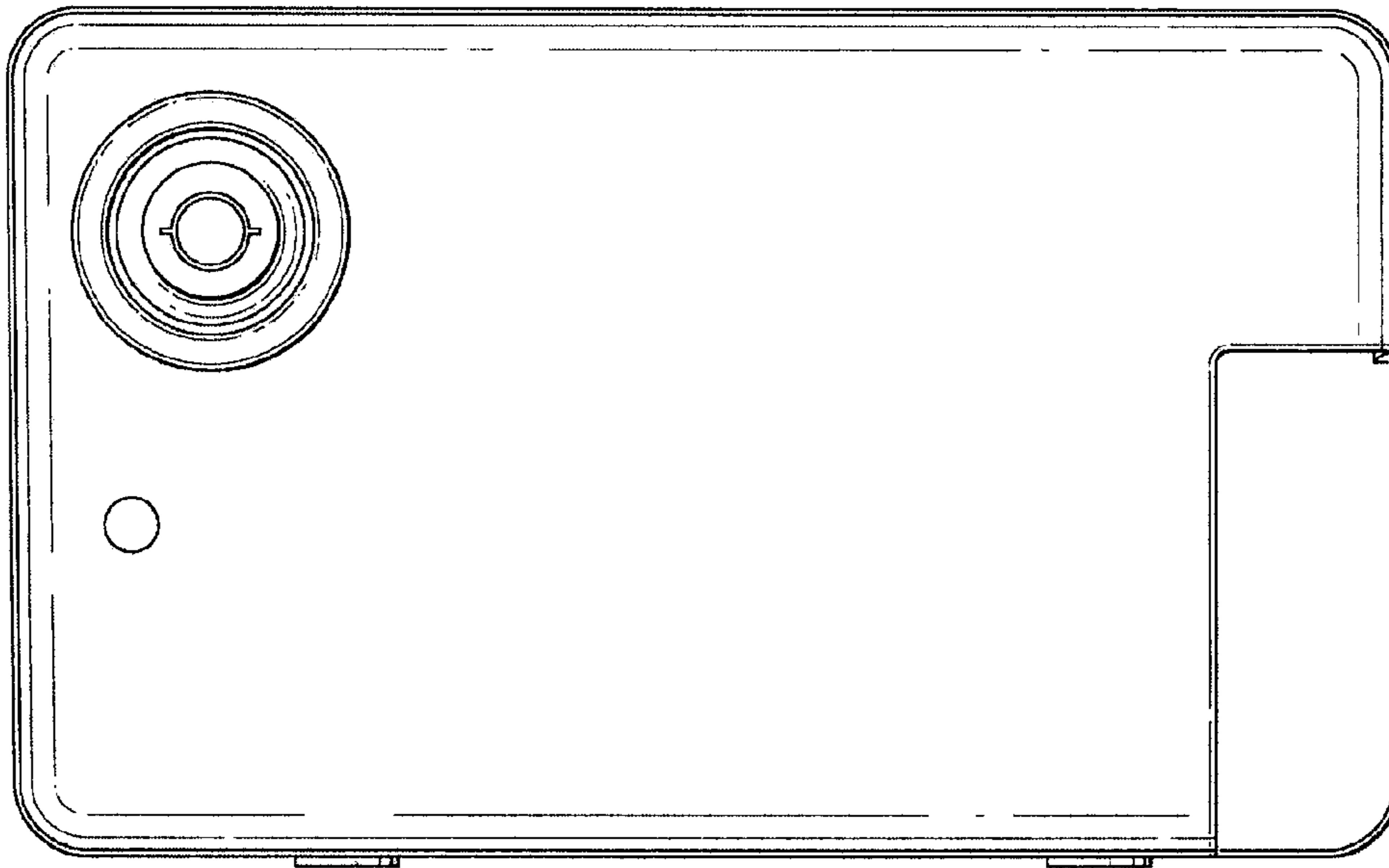

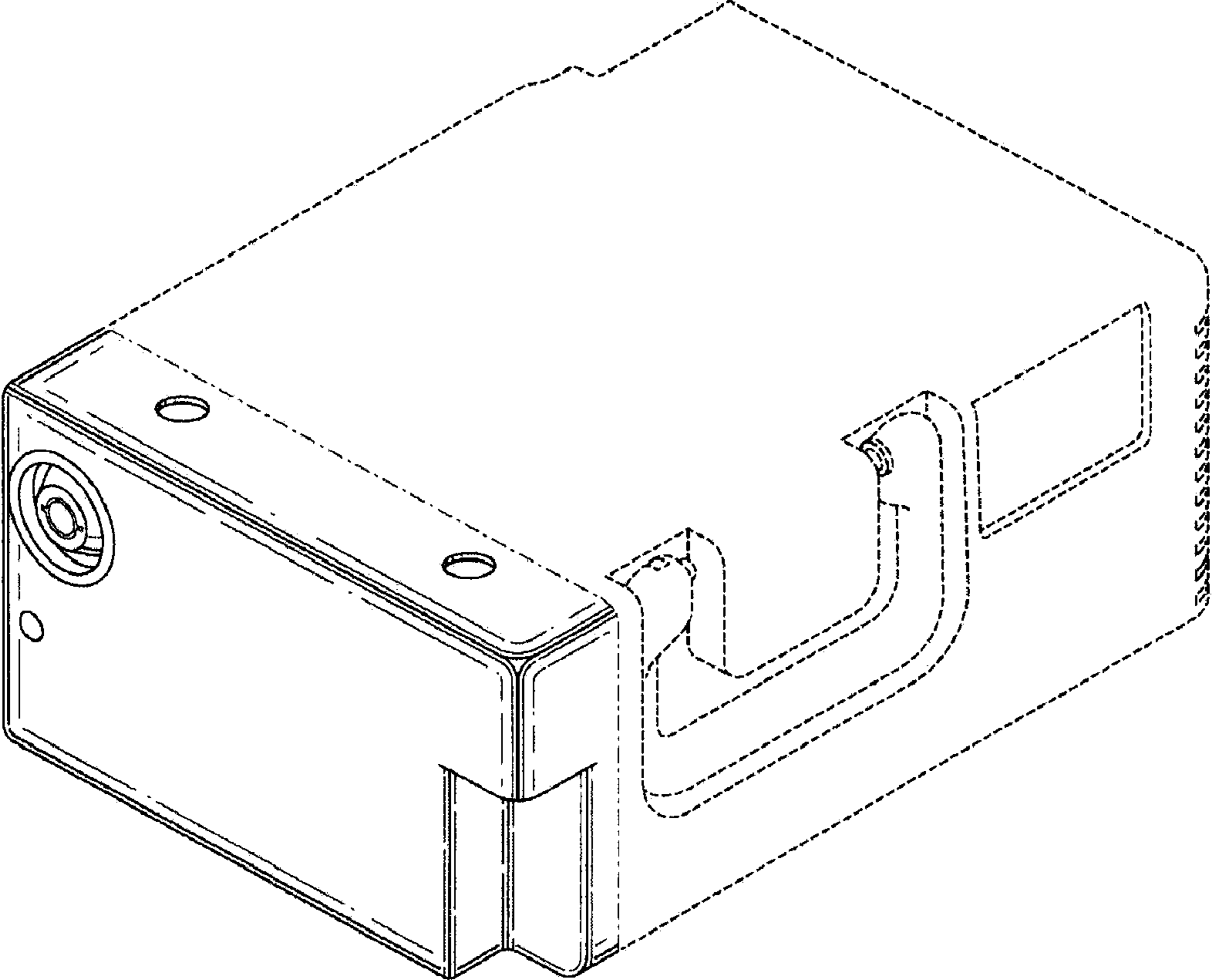

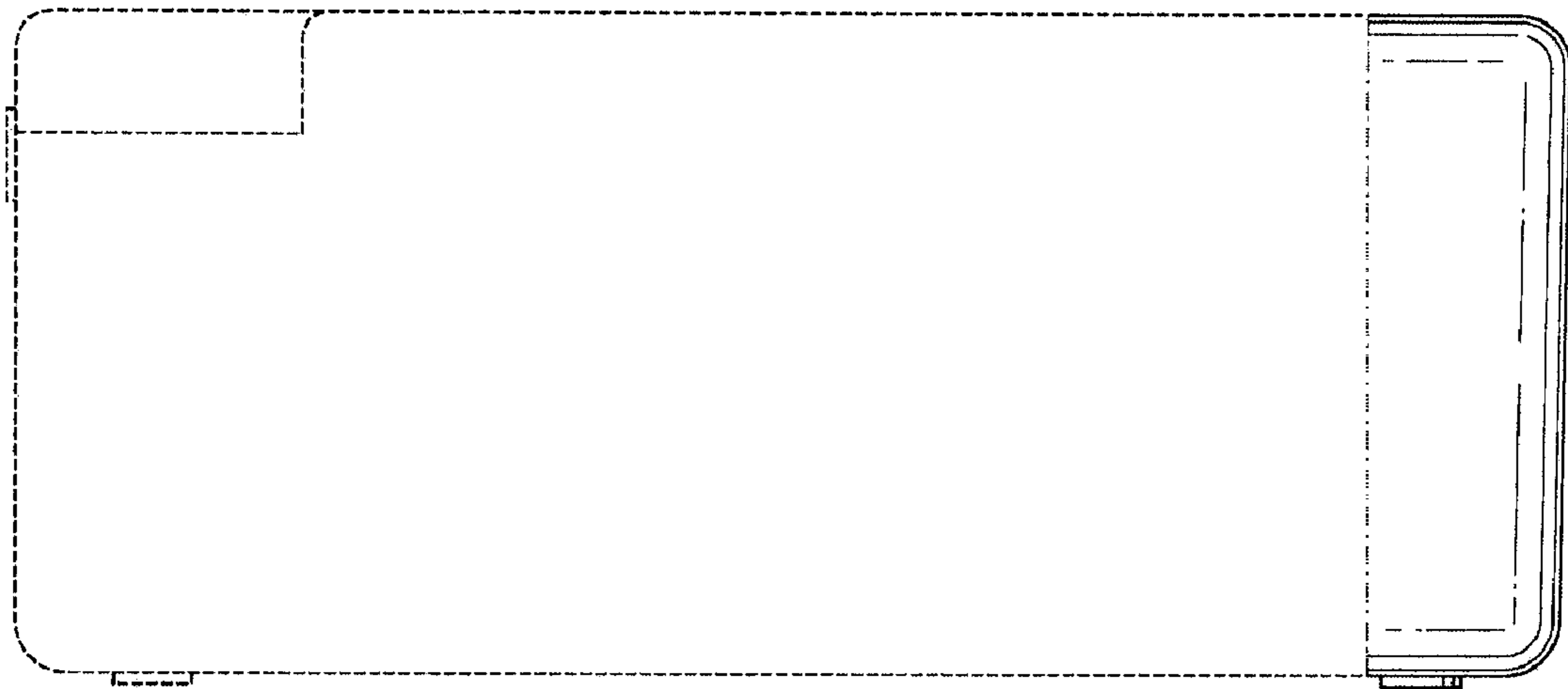

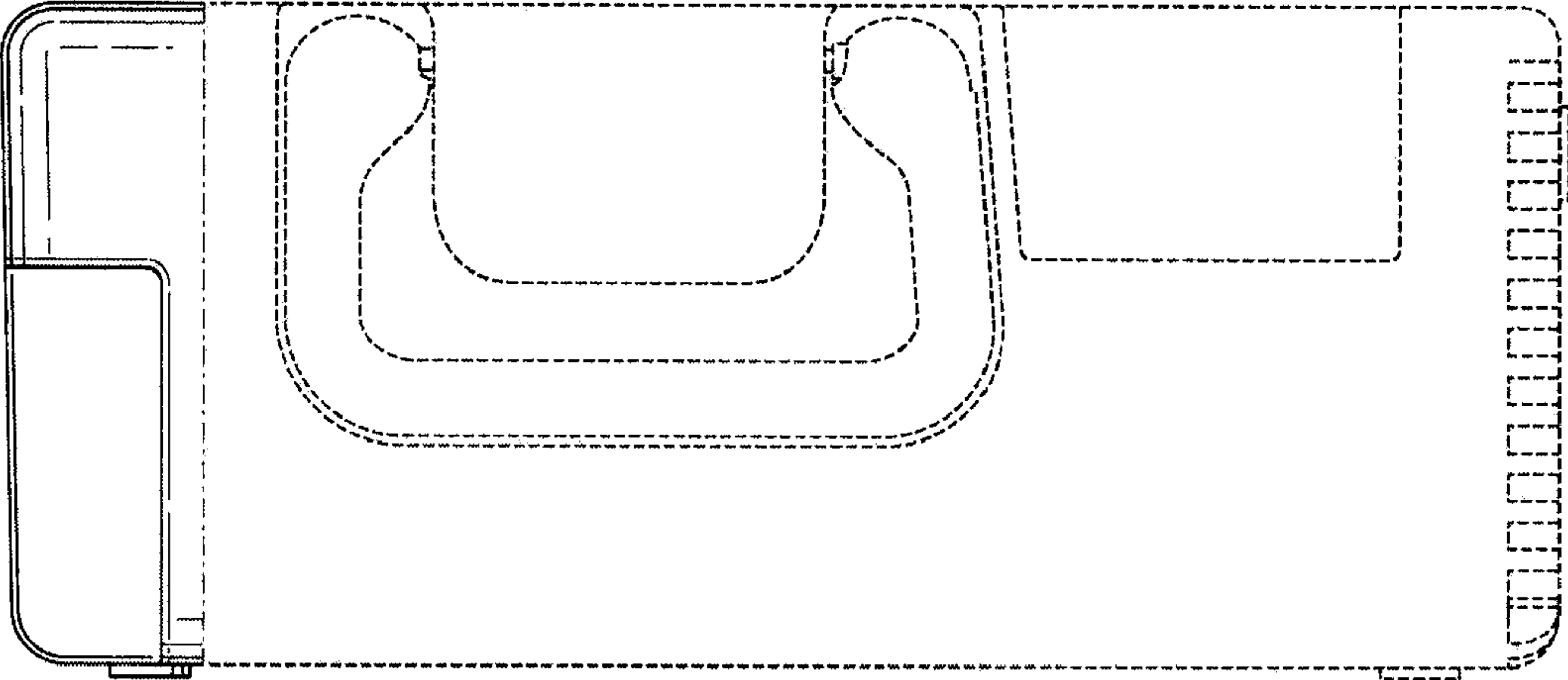

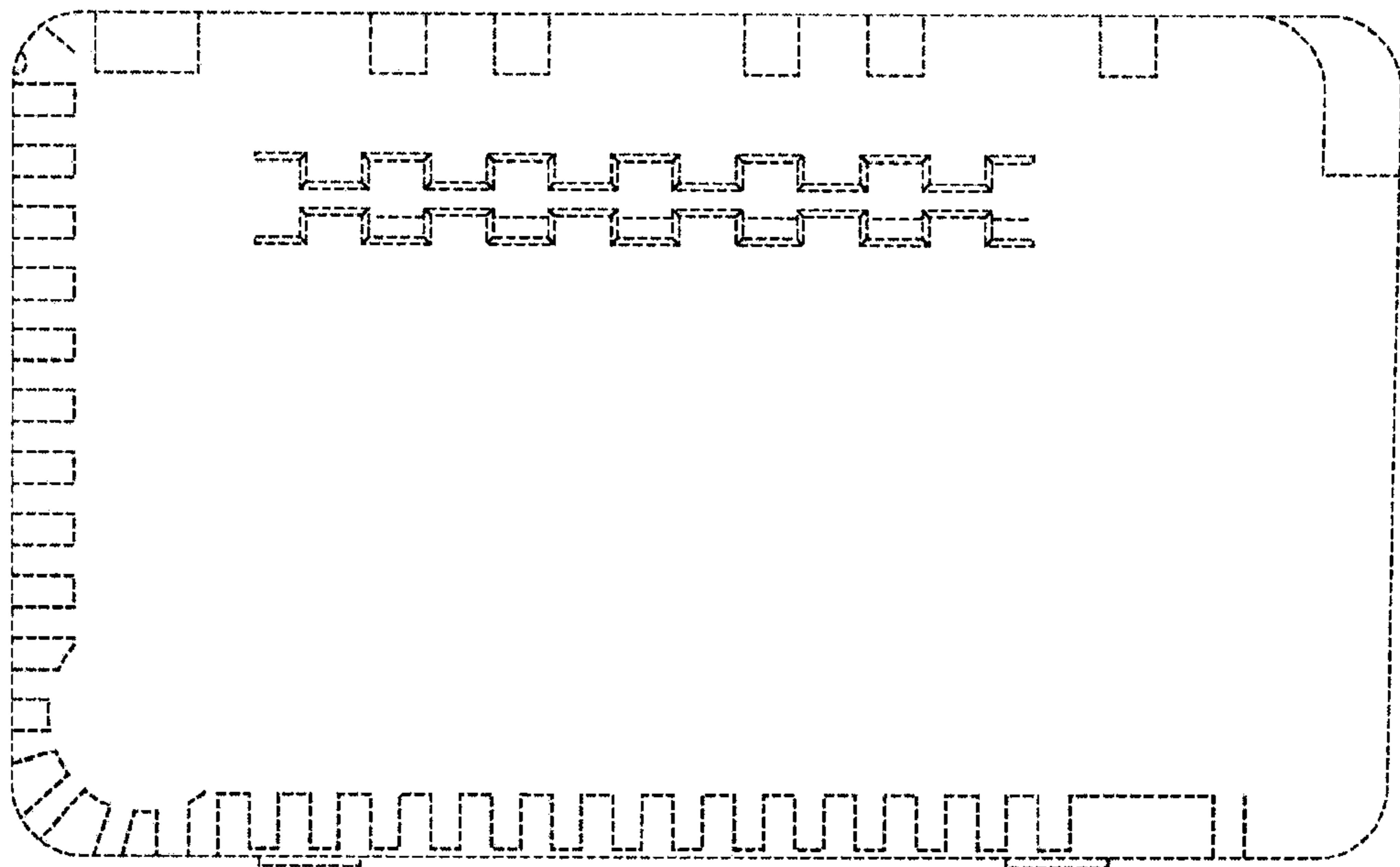
