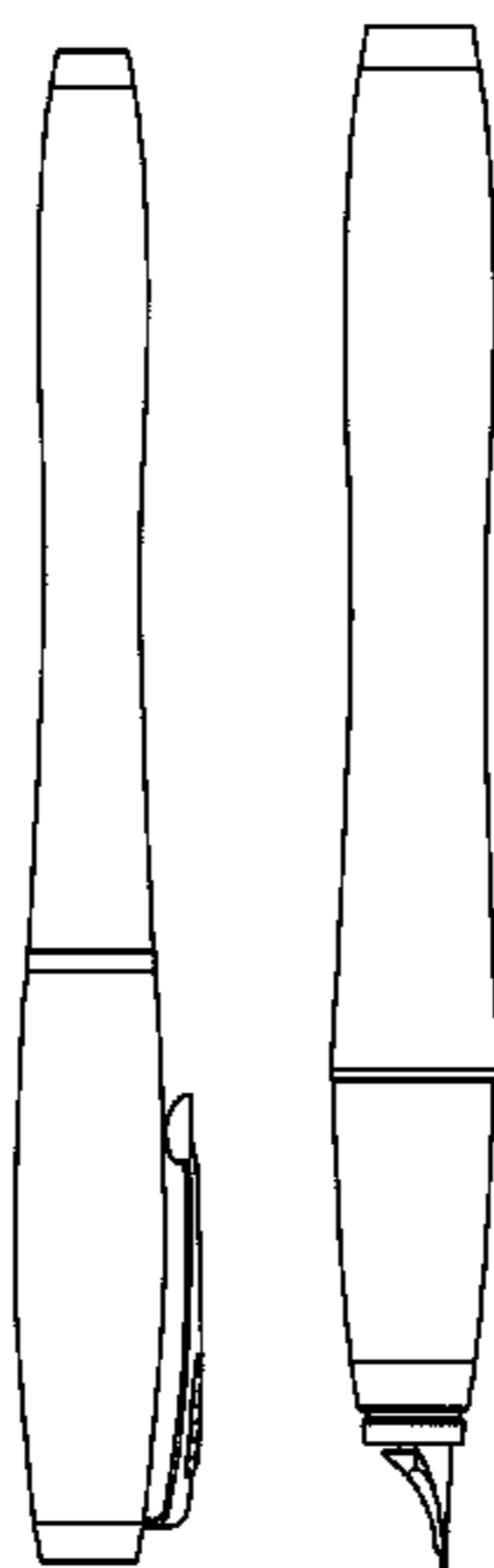
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the writing instrument of the first and second embodiments in closed condition showing my new design;

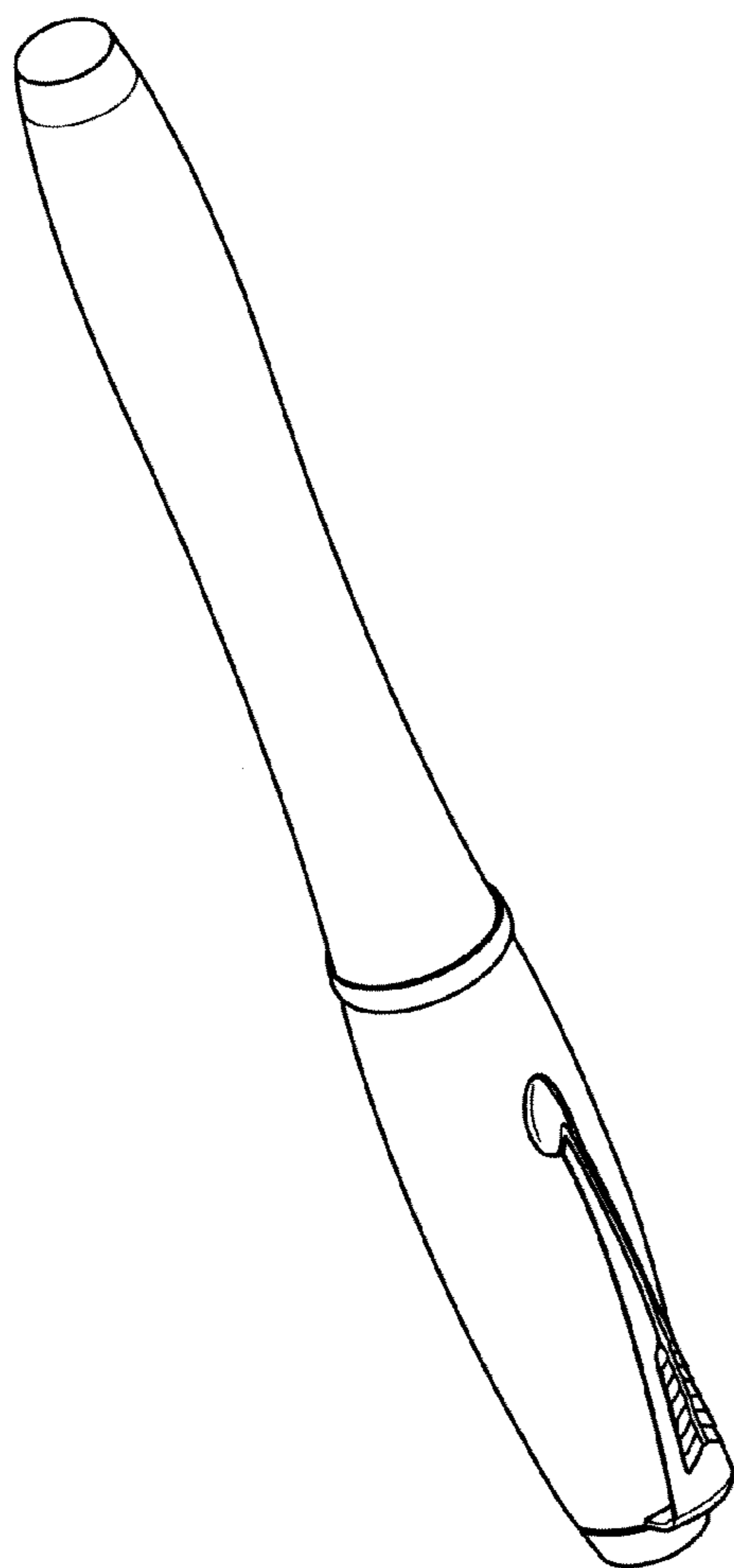

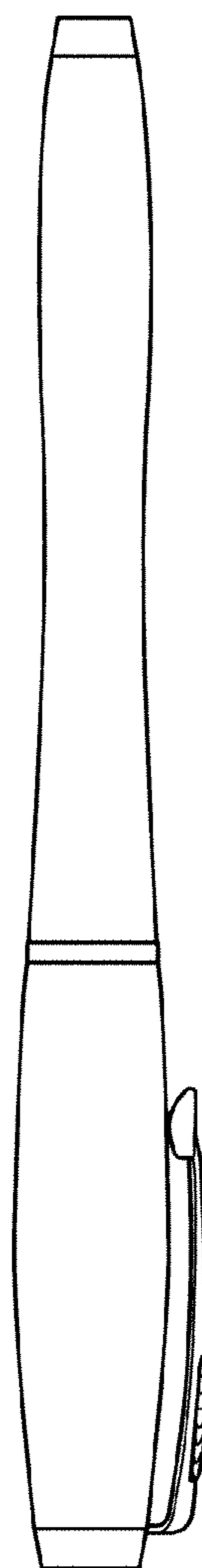

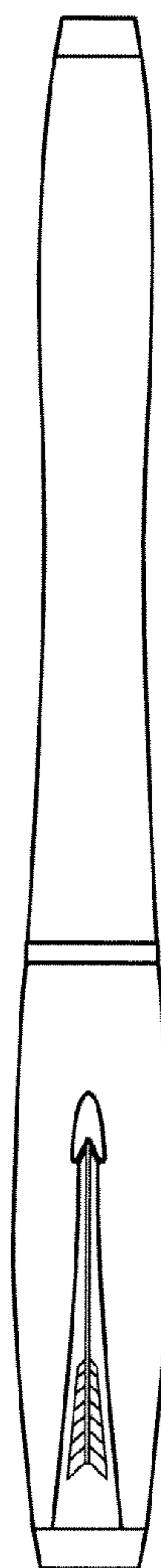

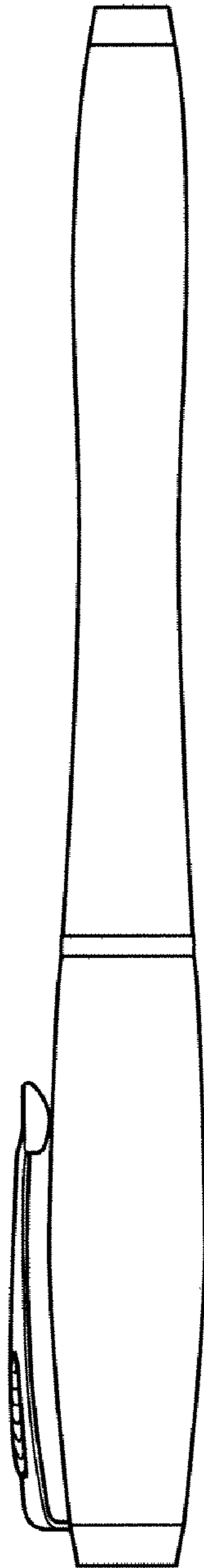

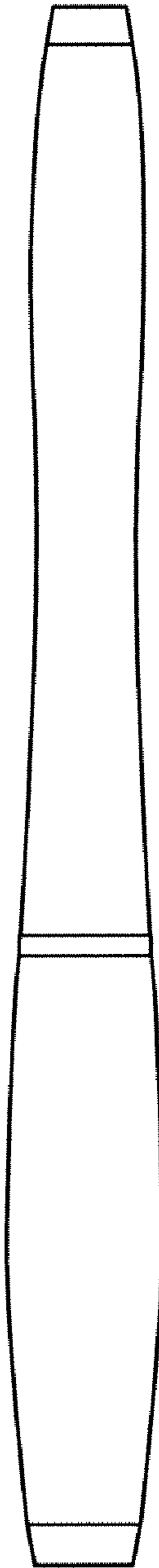

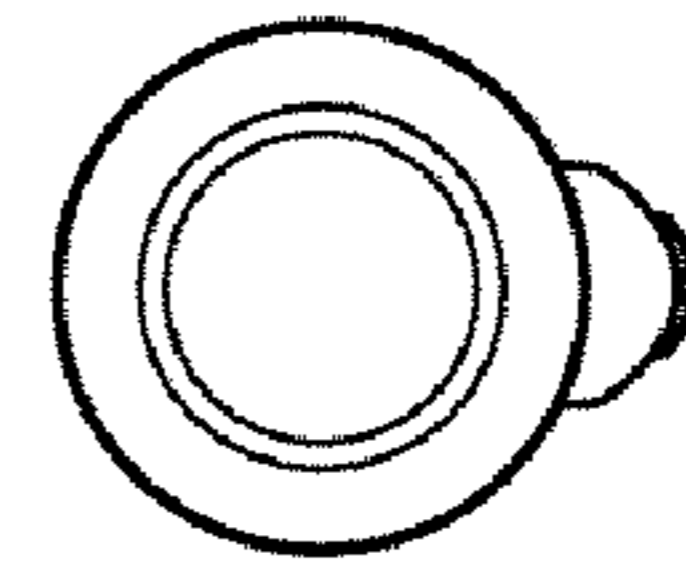

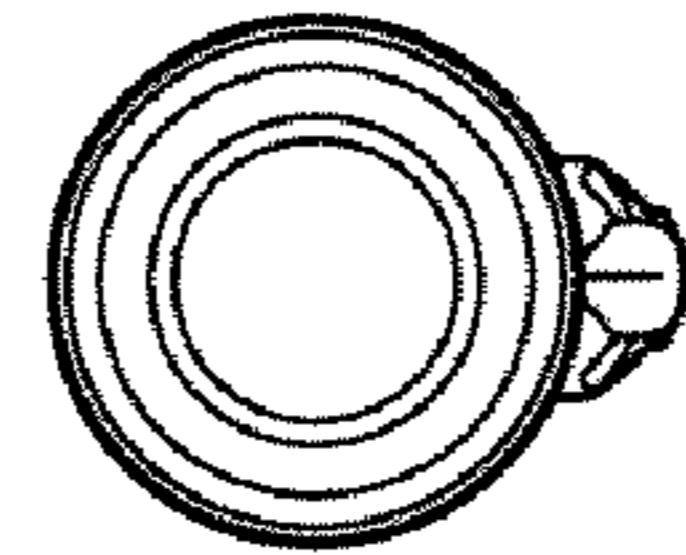

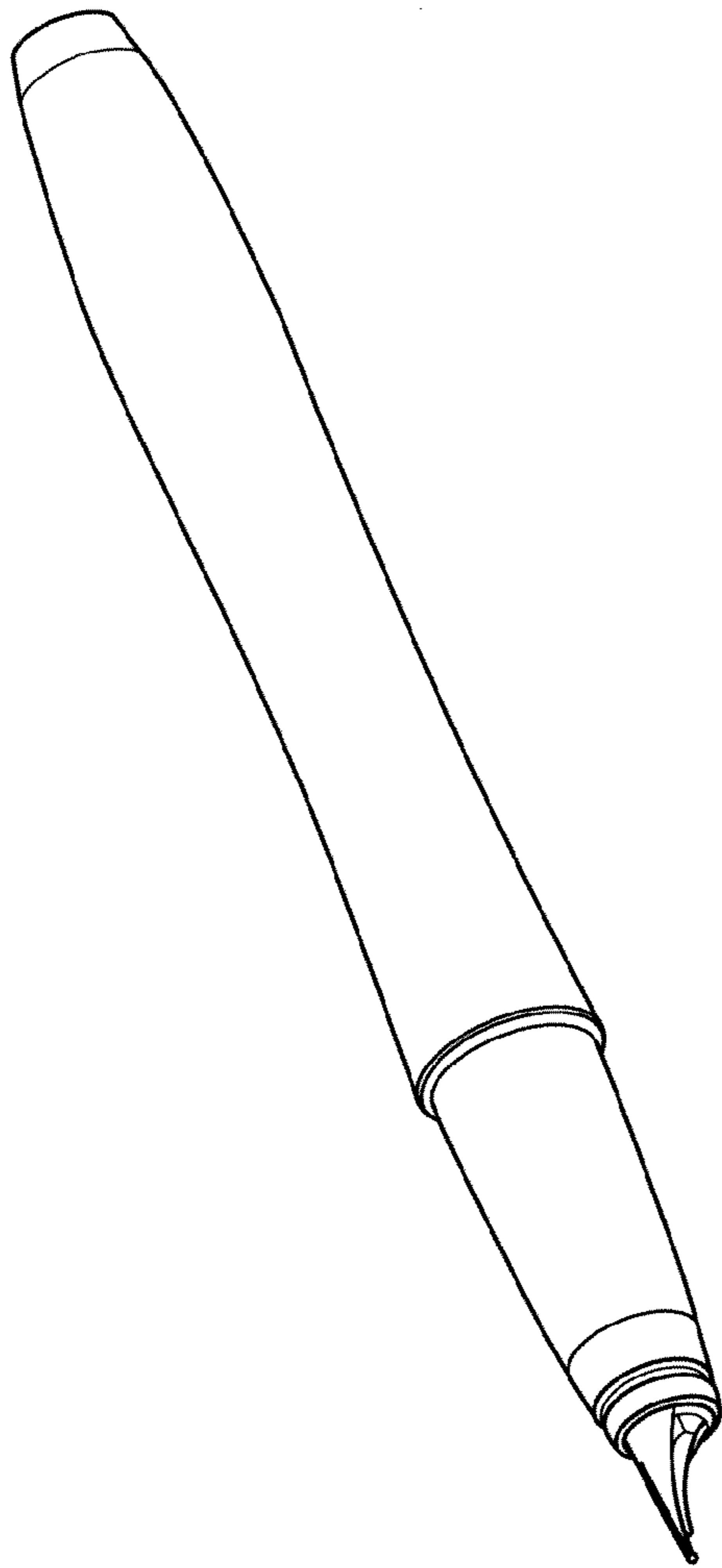

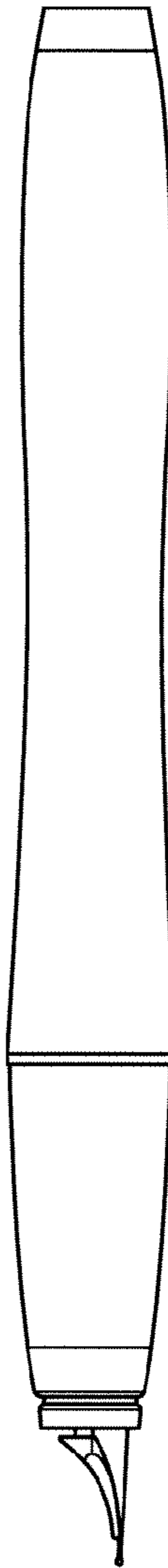

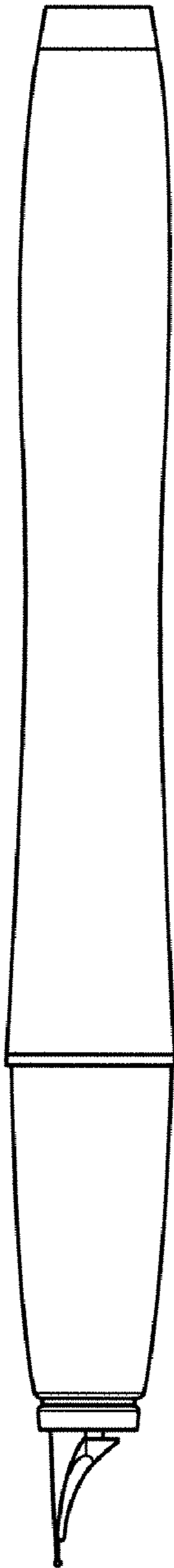

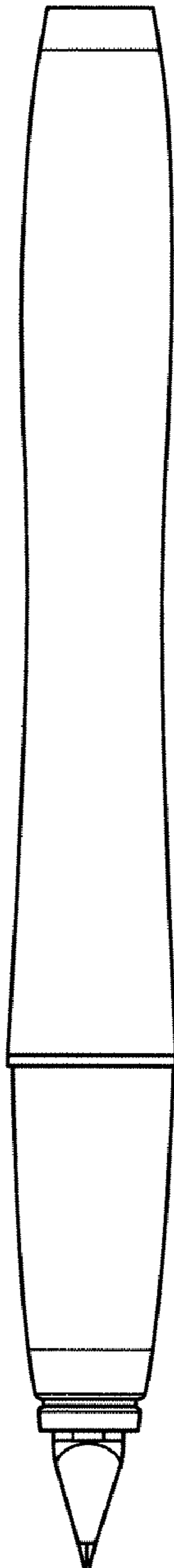

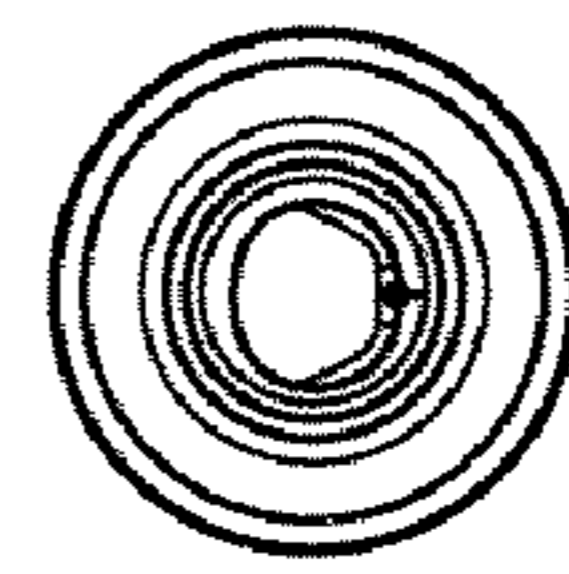

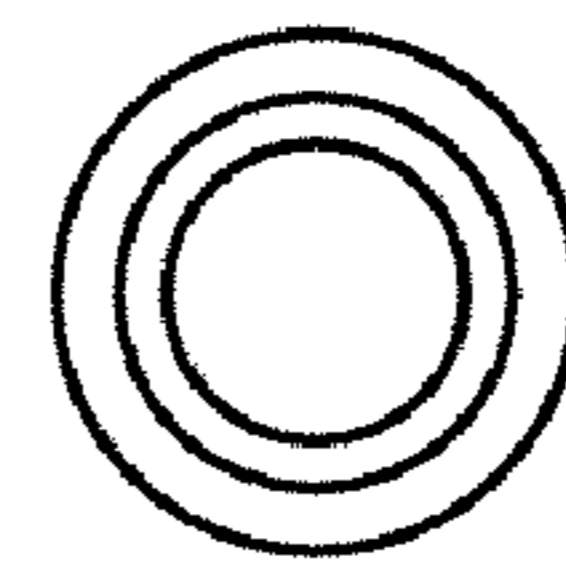

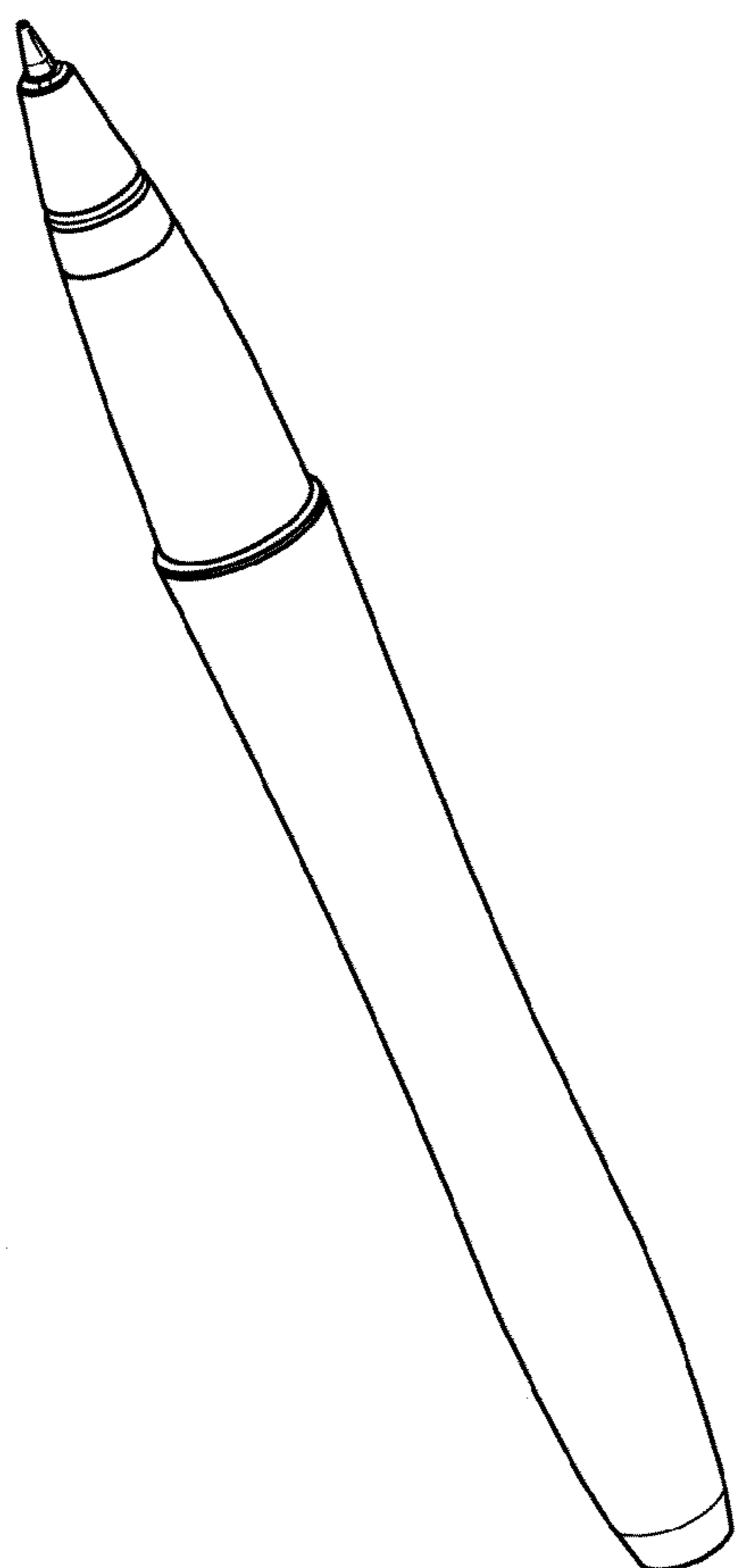

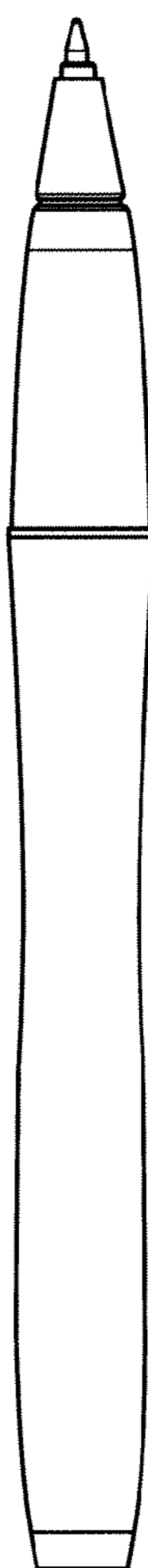

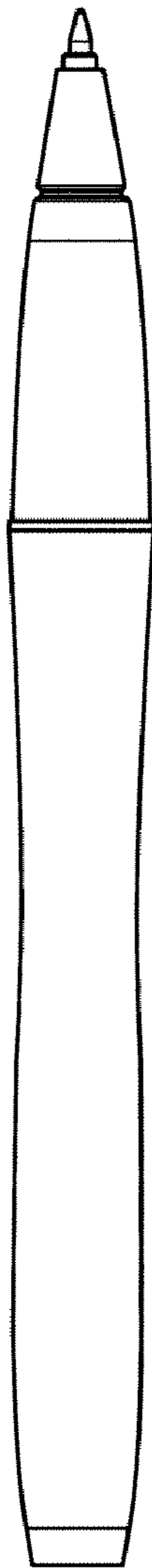

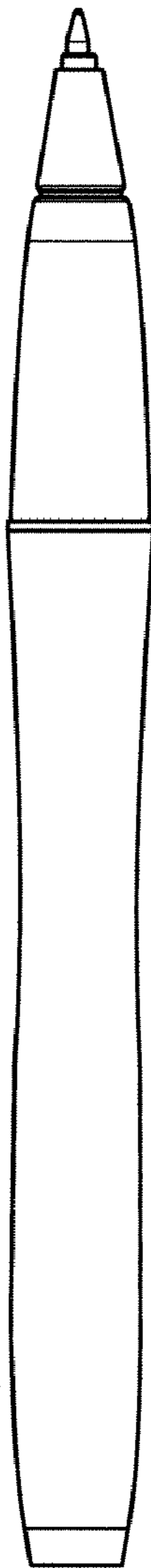

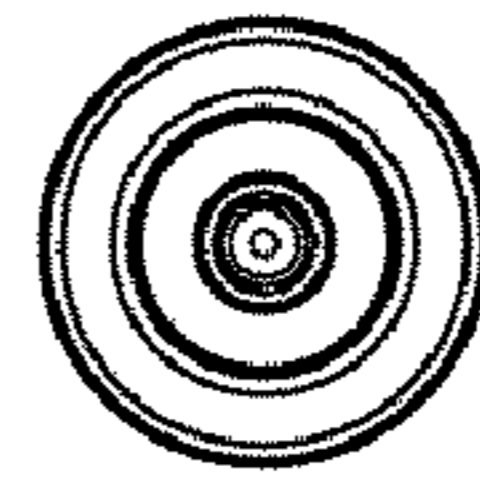
