**DESCRIPTION**

FIG. 1 is a perspective view of a nose protector showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side elevational view thereof, the opposite side being a mirror image;

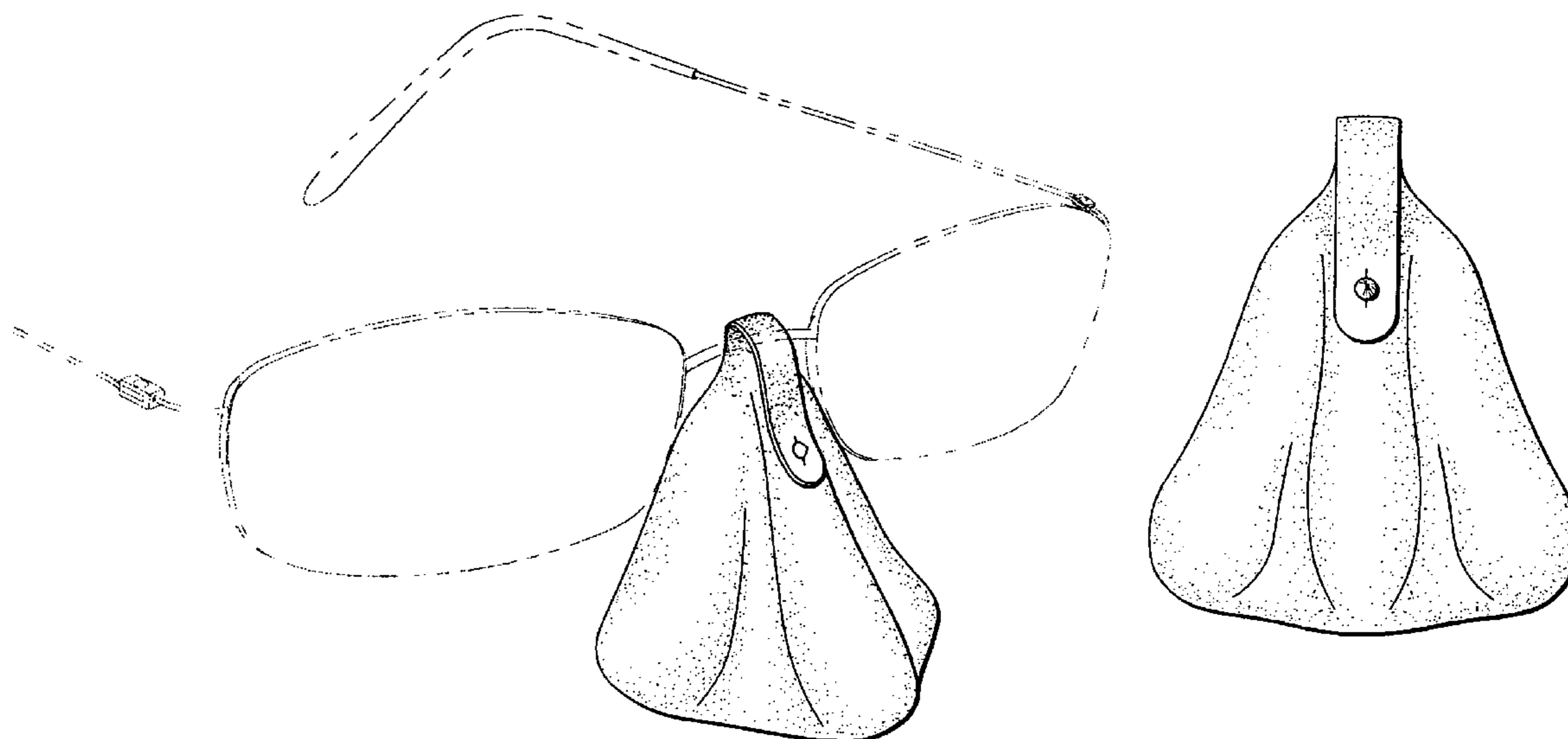
FIG. 4 is a rear elevational view thereof;

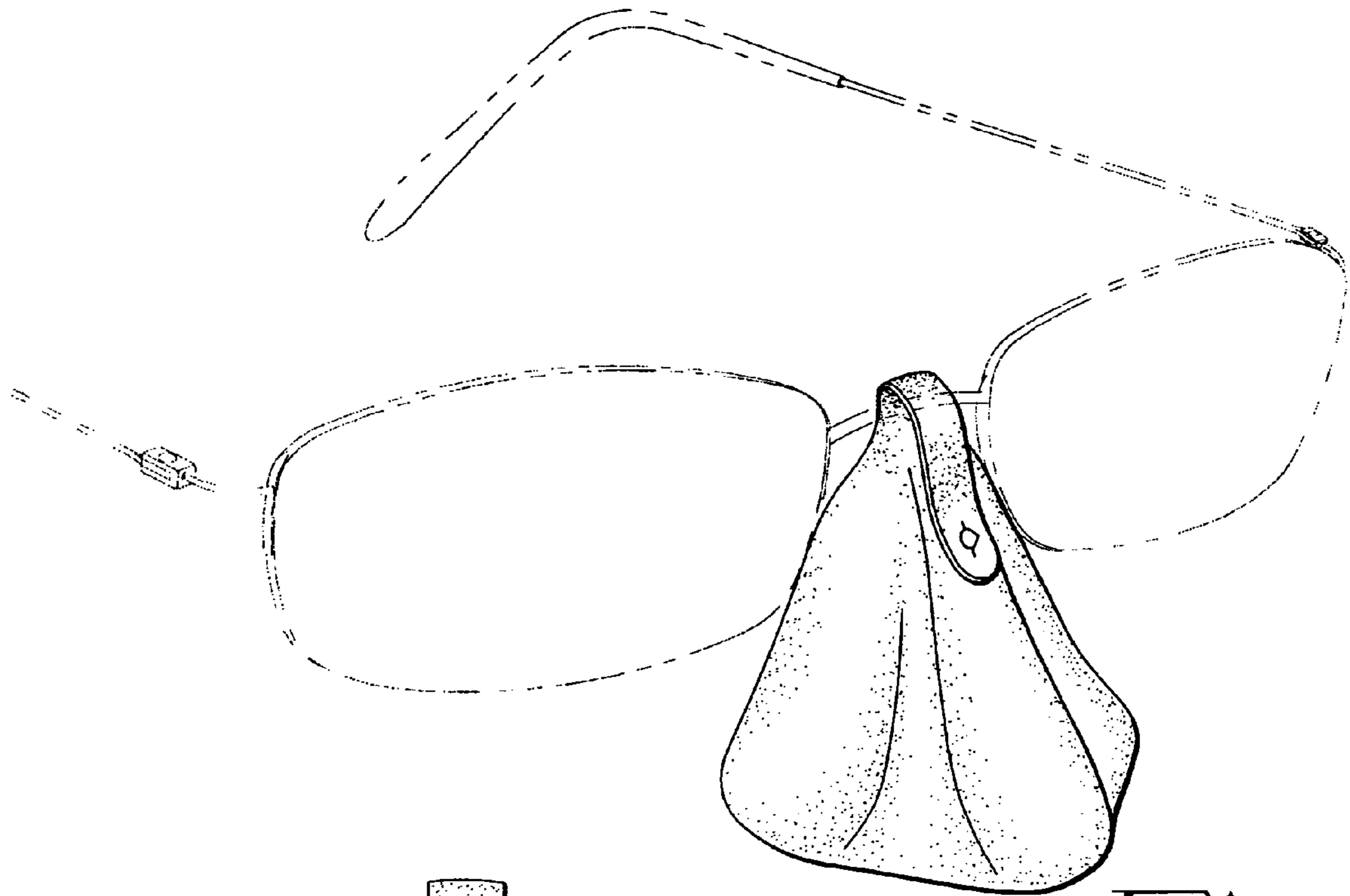

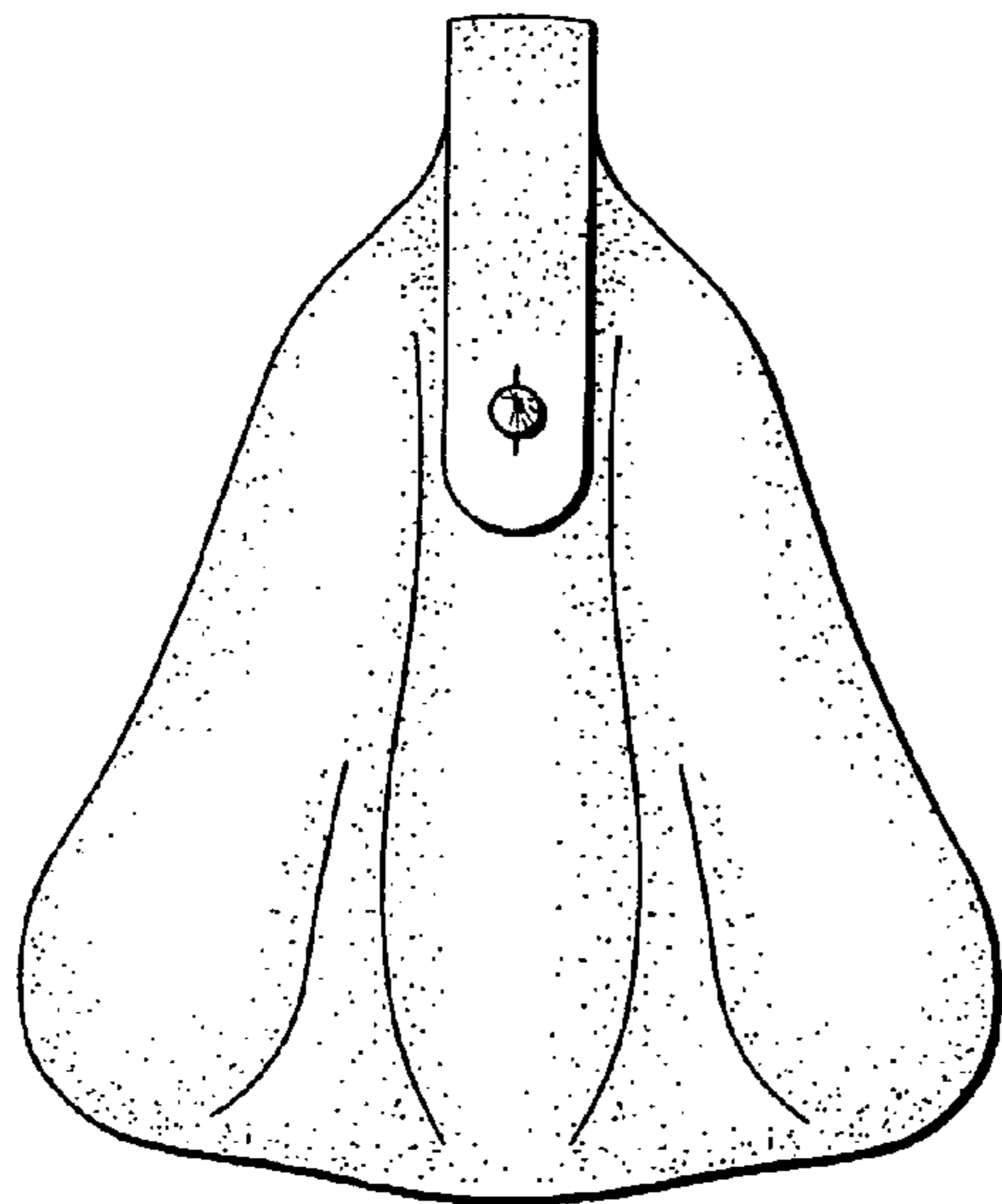

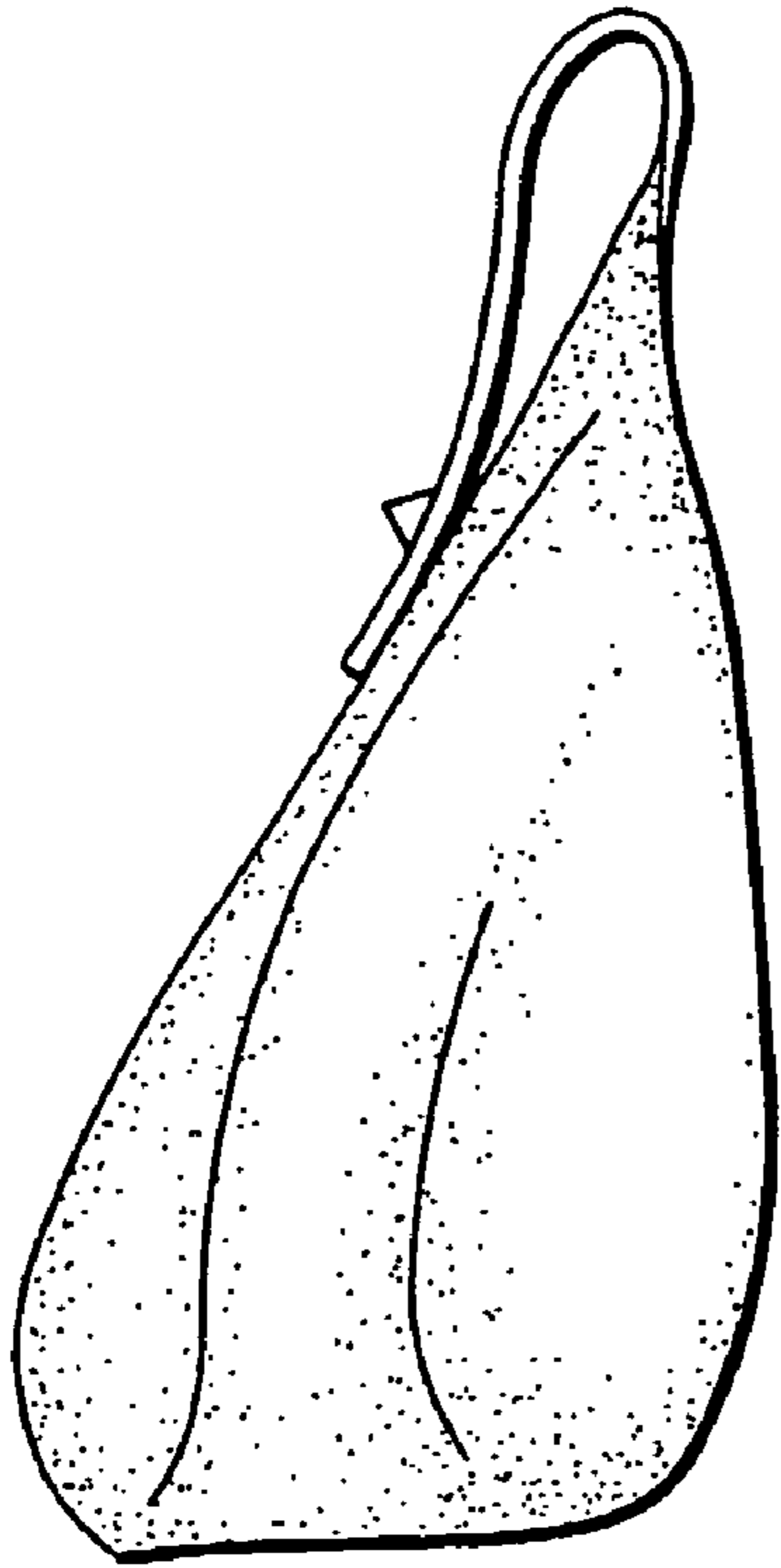

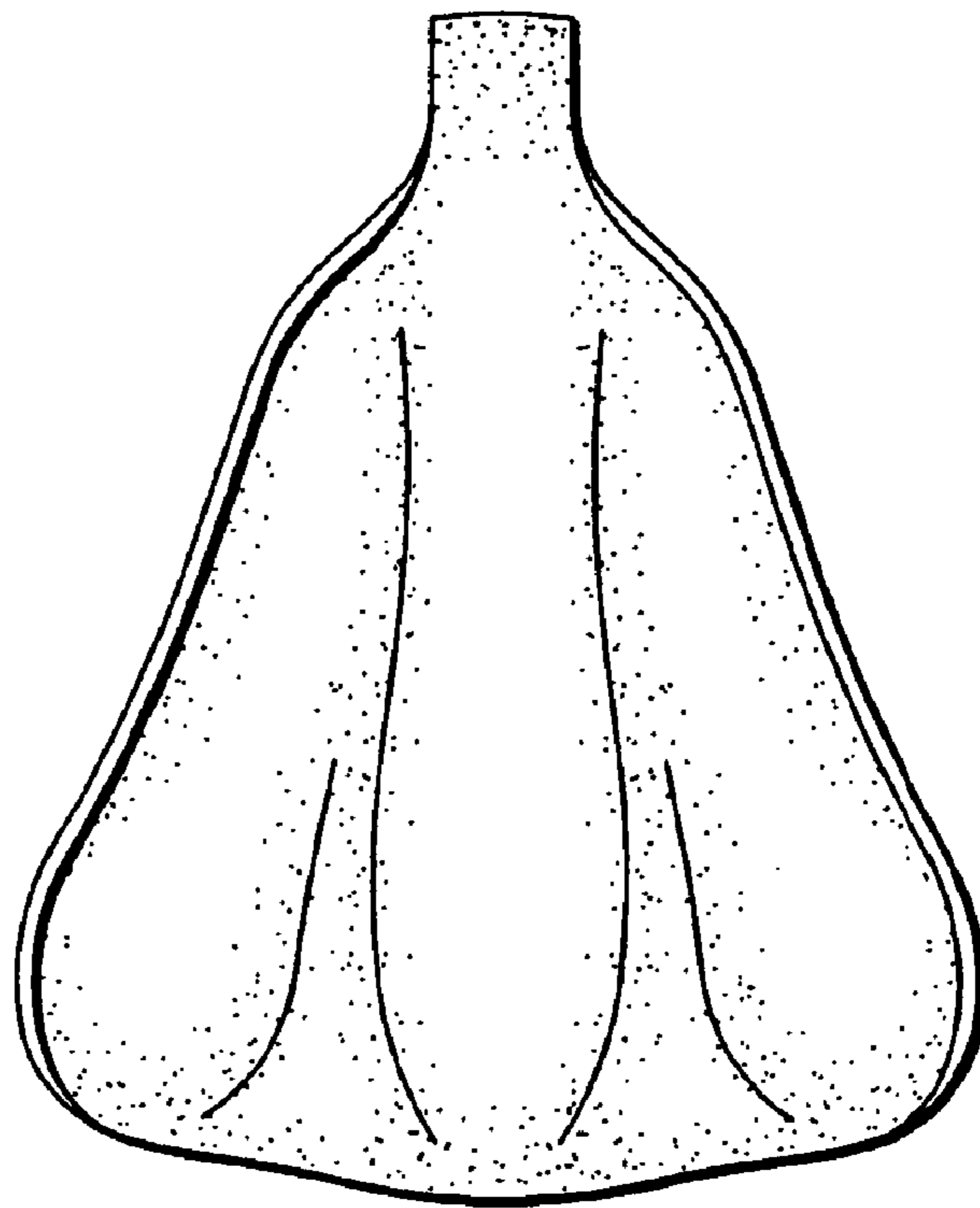

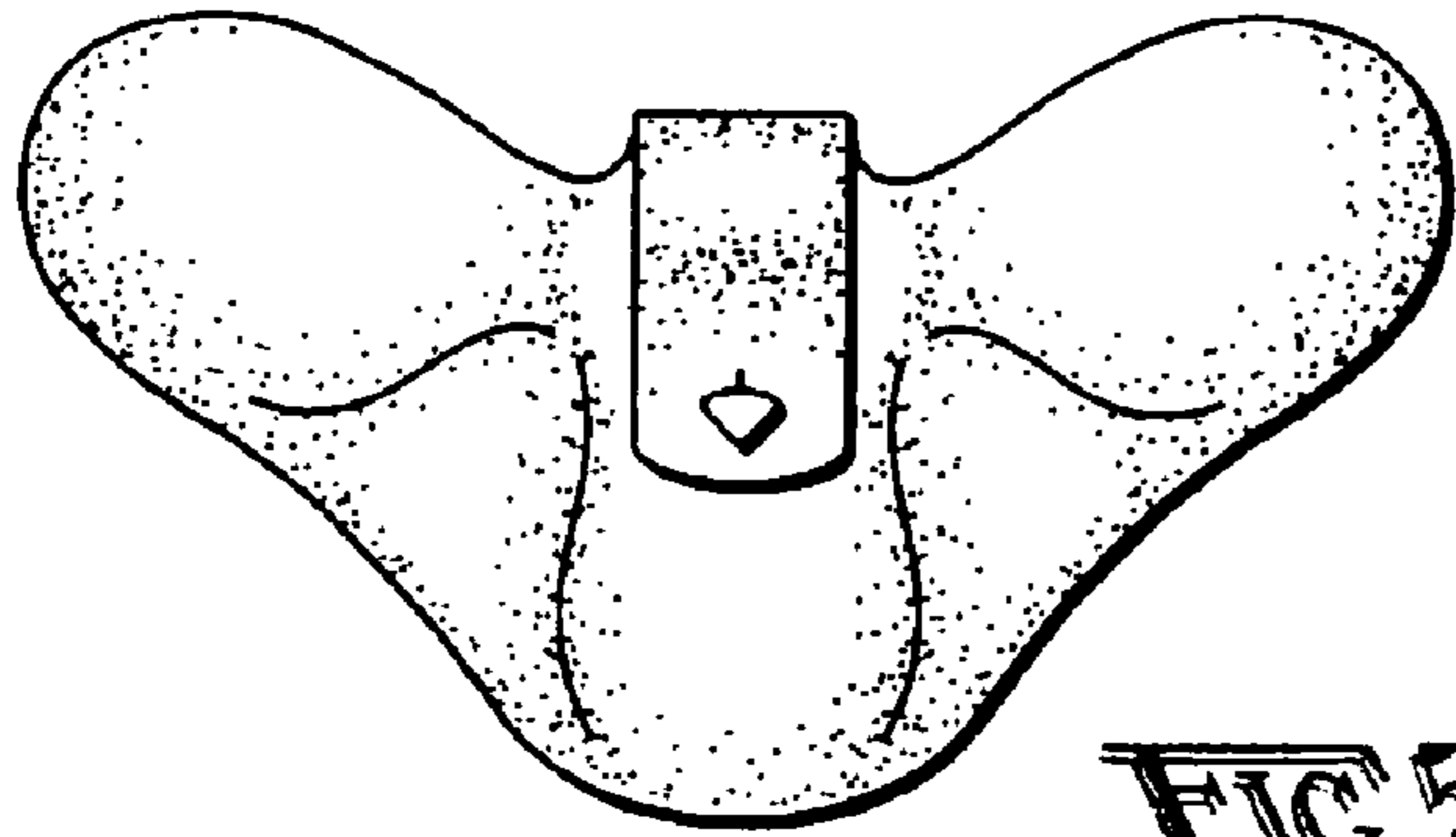

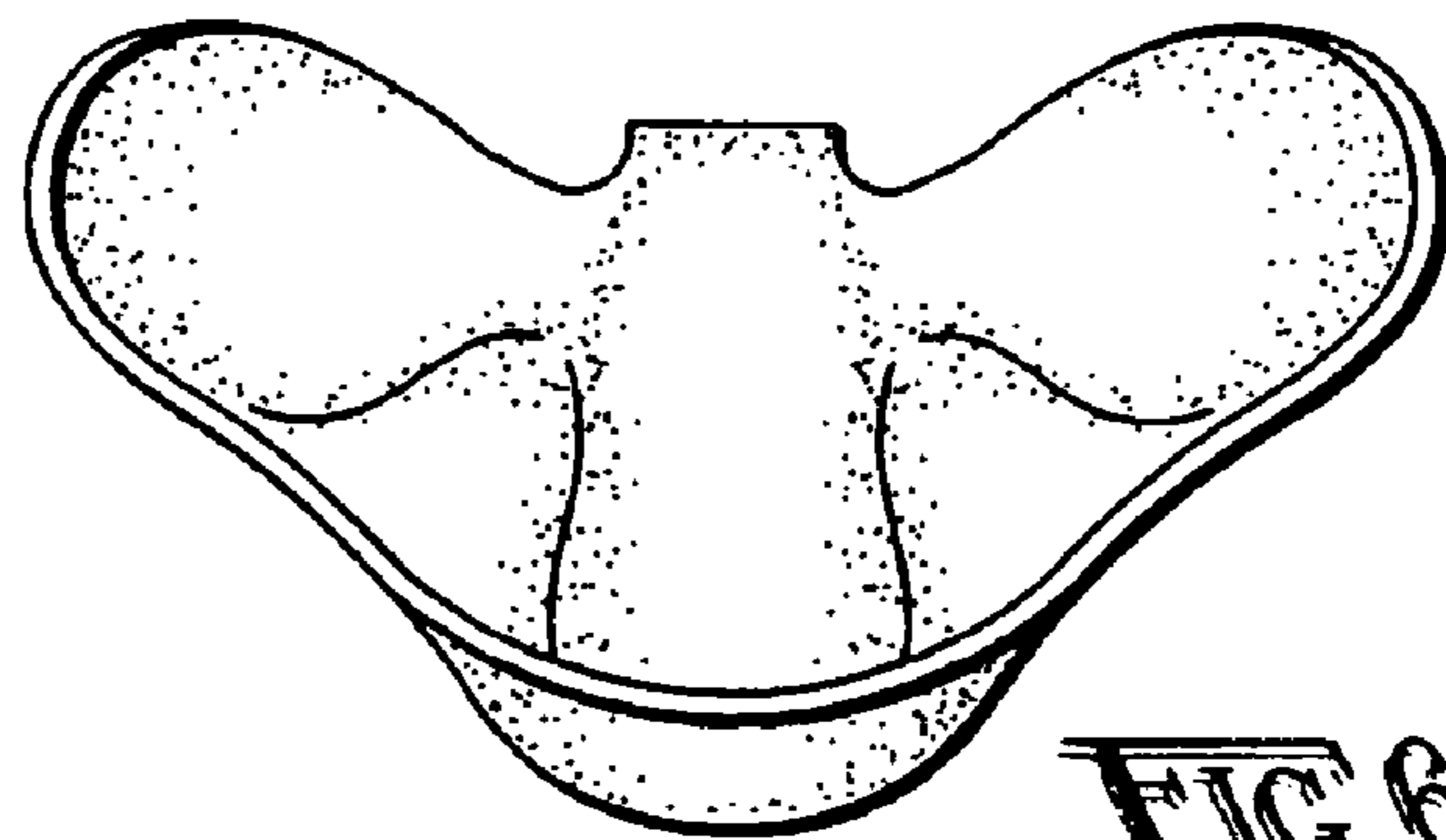
